Gentlemen:

A simplified stability test, witnessed by the U. S. Coast Guard in accordance with 46 CFR 170.175, was conducted on a "sister" vessel, MO8424ES in Branson, Missouri, on September 30, 2002. Results indicate, subject to the operating restrictions specified below, that the M/V MO 1448EJ has satisfactory stability for the carriage of 39 persons on a protected waters route, under all reasonable operating conditions. Since the passenger capacity and route are based on other criteria as well as stability and may be further limited thereby, you are cautioned that the maximum passengers allowed and total persons allowed shall be as specified on the Certificate of Inspection. The following restrictions shall be strictly adhered to:

- The superstructure shall not be altered without authorization and supervision of the cognizant Officer in Charge, Marine Inspection.
- Bulkheads and structure shall not be removed or altered without authorization and supervision of the cognizant Officer in Charge, Marine Inspection.
- No permanent ballast or other weights shall be added, removed, altered or relocated without authorization and supervision of the cognizant Officer in Charge, Marine Inspection.
- Bilges shall be kept pumped to a minimum content at all times.
- The Master should make every effort to determine the cause of any list of the vessel before taking action.
- Upon entering the water, the master must verify that the vessel's stern reference line is not submerged.

It shall be the responsibility of the licensed Master to maintain the vessel in a satisfactory stability condition at all times.
