Event Description: ABS SMC Intermediate audit resulted in the following finding being noted: A vessel Officer was not aware that portable CO2 fire extinguishers were available onboard.

Corrective Action: A "Basic Firefighting Quiz" has been developed for use as a training tool to be utilized during performance of vessel drills and training. They have been distributed to each Captain and the training was completed during recent vessel fire drills. This item has been included in the Safety Newsletter and will be added to Safety Meeting agendas. Periodic refresher training will be coordinated through the Port & Safety Office. The specific officer noted received additional training with his new bid crew and individual training with the SPC.

Event Description: FOM Audit resulted in the following "UNSAT" item: Entries in records of lube oil transfers conflicted between vessel and shoreside documents. Oil Record Book entries for slop transfers indicated 90 gallons transferred. The Slop Oil Lube Receipts (F-87) and other shore-side documents indicated 60 gallons transferred. SPE conducted on-site retraining with crew and will conduct additional training Fuel Facility personnel.

Corrective Action: SPE advised CME onboard of audit results and identified the need of ensuring making proper entries on vessel documents. Additionally, SPE discussed with Fuel Facility Supervisor, Tankerman and Oil Room staff to ensure all transfer forms are signed and completed properly.
