# INTERVIEW

- CWO Okay. So, if you'll just say and spell your
- 3 name real quick and help us out.
- 4 MS. CLETCHER: Joanna, J-o-a-n-n-a, Cletcher,
- 5 C-l-e-t-c-h-e-r.
- 6 INTERVIEW OF JOANNA CLETCHER
- 7 BY CWO

- 8 Q. And do you still live on,
- 9 A. I do.
- 10 Q. Okay. Good. And so, tell us a little bit about yourself,
- 11 your education and employment background.
- 12 A. Well, I've worked on boats for a year in February. It's
- 13 almost been 1 year. I worked at Publix before. Went to high
- 14 school.
- 15 Q. Okay.
- 16 A. Yeah.
- 17 Q. And on the 14th of January can you -- what was your position
- 18 on the *Island Lady*?
- 19 A. I bartend on the big boat.
- 20 Q. Okay. So you're a bartender. And what time did you get on
- 21 board the *Island Lady*?
- 22 A. 3:25.
- 23 Q. 3:25. What time did you get to work that day?
- 24 A. Like 3:16, 3:16.
- 25 Q. Okay. So, just before you got on the *Island Lady*?

- 1 A. Yeah, about 10 minutes.
- 2 Q. Okay. And so, walk us through the events from the time you
- 3 | got on board the *Island Lady*.
- 4 A. It was just a normal day. I got on the boat. We had a pre-
- 5 hire. Grabbed the money out of the chest. Got on the boat. I
- 6 was with Michelle and Alissa downstairs until we left. Then 1
- 7 | went upstairs. It was all pretty normal.
- 8 And then I saw Mike a little bit stressed out, and it just
- 9 all kind of went on from there. And -- well, we were in the
- 10 channel. Everything was good. He saw the sensor. He got on the
- 11 phone. We went through the channel a little bit. We got a little
- 12 bit close to marker 1. We turned the boat around. We came back
- 13 to the shore. We got everybody upstairs. I mean, obviously,
- 14 | there was like time in between, but the boat got back to the shore
- 15 and that was when people started jumping. Yeah.
- 16 Q. Okay. Can we back up to where -- what was the first instance
- 17 | where you --
- 18 FEMALE SPEAKER: It's okay. Relax.
- 19 MS. CLETCHER: I hate thinking about it.
- 20 BY CWO
- 21 Q. Yeah, there's no reason to be nervous.
- 22 A. I just don't like thinking about it. It's okay. I'm okay.
- 23 Q. Take us back to when did you first notice that there was an
- 24 | issue on board, there was an emergency, and how did you know there
- 25 was an emergency on board and where were you at?

- 1 A. Truthfully, I was on the bridge. I don't like sitting out in
- 2 the thing or being very social. Mike knows that, so he kind of
- 3 like has a heavy heart for me, doesn't want to ruin my hair. And
- 4 | I was sitting there just on my phone, normal day, drinking coffee,
- 5 minding my own beeswax.
- 6 Q. Where were you at on the bridge?
- 7 A. Just sitting in the back. Just --
- 8 Q. Behind the captain, to the right or to the left?
- 9 A. Yeah. I had just smoked a cigarette, came in, was on my
- 10 phone and, I don't know, he just looked up and he was talking to
- 11 himself. He goes uh-oh, and then he got on the phone and didn't
- 12 say anything else really. I'm minding my own business. I didn't
- 13 rush. I didn't want to like ask about the situation or anything
- 14 because it's not my business. It just kind of like escalated from
- 15 there.
- 16 Q. Okay. So could you hear what he said on the phone?
- 17 A. No. I wasn't listening.
- 18 Q. Did you know why he said uh-oh?
- 19 A. Well, I don't even think he really meant to. I think it just
- 20 kind of slipped. I think he was talking to himself. Maybe I
- 21 | misunderstood him; it just sounded like what he said. I don't
- 22 know, that was that. He didn't really say much. I didn't say
- 23 anything. I just minded my own business.
- 24 Q. Could you hear anything? Could you hear an alarm maybe or
- 25 | could you see an alarm?

- 1 A. No. Not at first. Not at first. I was sitting there -- I
- 2 was just looking at the little dashboard thing. There was one red
- 3 light and then that was when he got on phone, I think. And then
- 4 he got out some book, this big book. I don't know. He was
- 5 looking in a big book at something. And he was on the phone
- 6 talking to somebody, and we were going, and I remember the rock is
- 7 | in the middle of the channel so he didn't want to hit the rock.
- 8 And we got out of the channel -- not out of it, but we were
- 9 already to marker whatever the first one is, 1. And he turned the
- 10 boat around. It started smoking. That was that.
- 11 Q. Okay. Do you recognize this? This is Miller's Bayou.
- 12 A. Okay.
- 13 Q. This is Durney Key.
- 14 A. So this is the S-turn?
- 15 Q. Yes.
- 16 A. No. The --
- 17 Q. The S-turn would be right here.
- 18 A. Oh, right there?
- 19 Q. Yes. The boat is actually currently right about there.
- 20 A. Okay.
- 21 Q. So if you were to estimate, where would you say the farthest
- 22 down the channel you traveled on the boat?
- 23 A. Oh, not far. Here -- where's the end of the markers? Right
- 24 there?
- 25 Q. It would be right here.

- 1 A. Okay. Yeah, we didn't go that far. We were still --
- 2 Q. And here's Durney Key.
- 3 A. Durney Key. So we were probably like right here, not much
- 4 past it.
- 5 Q. So it looks like you're pointing to --
- 6 A. Maybe I exaggerated about marker 1. It wasn't that far.
- 7 Q. Marker -- looks like 5?
- 8 A. Yeah. It wasn't -- we weren't far away.
- 9 Q. Channel marker 5, okay. Good.
- 10 So I interrupted. So you -- Captain Mike was on the phone.
- 11 You were on the bridge. You could see a red light on the dash
- 12 | board. Then what happened?
- 13 A. Okay. He was on the phone. He was looking in a book. Then
- 14 the sensor started beeping, and that was when he found the
- 15 deckhand and then they went downstairs. The deckhands were
- 16 looking in the hole, whatever, the engine room compartment.
- 17 Q. Could you see them or were you still located on the bridge?
- 18 A. No. I was still upstairs.
- 19 Q. Okay.
- 20 A. And I just kind of like stuck my nose in my own business. I
- 21 didn't want to like ask any questions or show anybody out. So I
- 22 just kind of like just sat there quietly, listened, watched.
- 23 Q. Did you watch the closed-circuit TV?
- 24 A. What is that? The --
- 25 Q. The monitor with all the cameras?

A. Yeah. Um-hum.

- 2 Q. So what could you see?
- 3 A. Well, the monitor, it looked like it had like a mist on it,
- 4 | like a water mist, and I said something to Mike. I was like, I
- 5 | think there's water. And then I was like that was stupid because
- 6 | it's underneath the boat, so why would there be water. And that
- 7 | was the only thing -- I was like I think that there's smoke. And
- 8 he goes uh-oh. He goes, all right. And the guys came upstairs
- 9 and that was that from there. They tried to take a -- like handle
- 10 | the situation as best as they could.
- And Mike went downstairs because he wanted to see if there's
- 12 a fire because he had this weird feeling that there was fire. So
- 13 | he went downstairs. He didn't see a fire. And he said that he
- 14 just had a weird feeling. So he turned the boat around and we
- 15 started heading back. And the boat just starting going, got like
- 16 | -- and it was just like -- just smoking, not flames at that point.
- 17 And everybody was upstairs. Everything was fine. The guys
- 18 were downstairs doing what they had to do. There is one fire
- 19 extinguisher upstairs. Mike just said, you know, if there's a
- 20 | fire extinguisher somewhere, like, can you and Michelle go get
- 21 one? And so, me and Michelle went down the back stairs and we
- 22 opened up the back doors and we were just looking around. And we
- 23 went back upstairs and that was when Tyler went upstairs and said
- 24 that there was fire and -- yeah.
- 25 Q. Okay. So that's great. So when you transited down what

- 1 you're calling the back stairs --
- 2 A. Sorry. I don't know the technical names.
- 3 Q. No, no.
- 4 A. These.
- 5 Q. So these right here?
- 6 A. Yeah.
- 7 Q. Can you tell me where, if you looked, could you see the smoke
- 8 | coming from? Was there any smoke at that point? Did you see --
- 9 A. At that point no. But when everybody was up here, there was
- 10 a girl right here, because Mike had opened both of these doors --
- 11 Q. Okay. And you're pointing to the starboard bridge wing door.
- 12 A. Yeah, both of them.
- 13 Q. Okay.
- 14 A. Not these ones. The ones that actually go into the bridge.
- 15 Q. Yes.
- 16 A. Not these. Just like glass doors.
- 17 Q. Right. So you are pointing to both the port and the
- 18 | starboard bridge wing doors?
- 19 A. Yeah.
- 20 O. Got it.
- 21 A. So he opened those and everybody was on top and there was
- 22 this woman standing right in this little walkway right here by the
- 23 bridge door, and she had short brown like -- not brown, like gray
- 24 blonde, and she said, like, I don't want to freak anybody out but
- 25 | there's a lot of smoke like coming up from this side of the boat.

- 1 And like, obviously, Mike had seen it and he was trying to take a
- 2 | handle on it, but there was just a lot of people and they were
- 3 like really scared. So --
- 4 Q. So when you went to go get the fire extinguisher and you
- 5 transited down the stairs on the stern of the vessel, did you see
- 6 any smoke?
- 7 A. No. I went in this door. Michelle went in that door.
- 8 Q. Okay. And what's located inside these doors?
- 9 A. Right inside of them there is the bar and then there was all
- 10 the tables and the mirrors on the walls and everything. And then
- 11 | up here it was just like -- I guess you could call it another
- 12 little like bar counter thing, but not a bar. It was just the
- 13 counter for storage or something. I don't know.
- 14 Q. And did you have -- could you see the full passenger area in
- 15 | side of here?
- 16 A. When I opened the door, yeah.
- 17 Q. On the main deck?
- 18 A. Yeah. There was nobody inside there, though, except for the
- 19 deck hands.
- 20 Q. Could you see smoke?
- 21 A. No. No, it wasn't smoking at that point.
- 22 Q. Okay.
- 23 A. Like inside, like off the back and off of here a little bit,
- 24 | yeah, but it hadn't gone like crazy. Like it was still pretty
- 25 early.

- 1 Q. Okay. And then what did you do?
- 2 A. I just kind of started packing my stuff in my bag because I
- 3 was kind of bracing myself because, I don't know, I'm just like --
- 4 | I was just thinking of the worst. But it really wasn't that bad.
- 5 But I had myself all psyched up. So --
- 6 Q. Were you able to find a fire extinguisher?
- 7 A. I didn't, no.
- 8 Q. So then what did you do?
- 9 A. Michelle was still downstairs. I went upstairs because I
- 10 told Tyler and Shawn to go upstairs because I didn't know what to
- 11 do and I didn't know where the fire extinguishers were. And there
- 12 was like three or four guys downstairs. So two of them followed
- 13 me up. One of them followed me up and went and talked to the
- 14 captain.
- 15 And I remember Tyler ran back downstairs because Mike said to
- 16 open the hatch or do something, and he came back upstairs like
- 17 | just kind of frantic and he was like, there's fire. He goes like,
- 18 | there's a fire. And Mike said, all right, just calm down; take a
- 19 breath. He goes, it's okay. He goes, we're going -- he goes, we
- 20 | got it; we'll be all right. Okay, it's fine. And he said just
- 21 make sure everybody is away from there, like just keep everybody
- 22 | up here, like get ready because we are going to have to jump.
- 23 And Tyler went back downstairs and the next time I saw Tyler
- 24 was when he was jumping off the front of the boat.
- 25 Q. So the passengers, can you describe to me where you were at

- 1 | when all the passengers got off the boat?
- 2 A. Got off of the boat?
- 3 Q. Yes.
- 4 A. After they had -- when they jumped?
- 5 Q. Yes. Well --
- 6 A. I was -- I was off the boat. I was the third one off the
- 7 boat.
- 8 Q. As --
- 9 A. Because I was in the beginning. So if I wouldn't have jumped
- 10 off I would have held up everybody else. So I just -- I wanted to
- 11 get out of the way.
- 12 Q. So were you on the bow as the vessel came to shore or came
- 13 towards the beach?
- 14 A. Yes.
- 15 Q. In what location?
- 16 A. Well, I was up here, and then there's the front staircase
- 17 | right here, meeting from here to here. And I was going down here
- 18 when it was smoking. I had mine and Alissa's bags. And Alissa
- 19 was in the bridge. Mike was downstairs because he was trying to
- 20 | put out the fire thinking that it was smaller than it was.
- 21 Q. Was the boat on the sand, as far as you could tell, at this
- 22 point, or was it still traveling?
- 23 A. No, it was idling. Just like -- we were basically onto the
- 24 | beach, basically. But Mike tried to take control of the situation
- and he was trying to save everybody, so he just wanted to see if

- 1 he could put it out really quick.
- 2 Q. Do you know how he tried that?
- 3 A. I don't -- no. All I remember -- the last thing, I saw Mike
- 4 and then I closed my eyes to the smoke and -- my eyes are closed.
- 5 I tripped. I remember I put my hand out and I looked out and
- 6 | there was Mike again. I don't know how he got to me so quick, but
- 7 I remember he drug me through the smoke. And he shot back right
- 8 upstairs. Because I was too scared to jump; I said, no, I'm not
- 9 going to jump. He said, no, seriously you're jumping. Like
- 10 you're jumping, if I have to throw you off the boat. But I was
- 11 like, okay, like I guess I'm jumping.
- 12 And, yeah, I remember Tyler was the first one off the boat
- 13 and me and Alissa went down -- Tyler jumped off right here by the
- 14 flag, just straight off the front. I went off right here.
- 15 Q. Okay. And you're pointing to the starboard bow?
- 16 A. Like the nose.
- 17 Q. Yes.
- 18 A. Me and Alissa were both up on the nose. She went off this
- 19 side. I went off this side. We went at the same time. I
- 20 | remember before I went down I handed Tyler my bag so that he could
- 21 | save my phone so that we could call 911. I think mine and
- 22 Alissa's phone were the only survivors. But Alissa called 911
- 23 when we got to land, when we were in the water. It was crazy,
- 24 crazy.
- 25 Q. Did you ever look back at the boat and could you see where

- 1 | the smoke was coming from?
- 2 A. Well, the wind -- the wind was going that way, so it just
- 3 kind of like made it all -- it was kind of coming from everywhere
- 4 like when we -- like when I was off the boat, it had gotten to the
- 5 point that it was so big that it was just a little bit of
- 6 | everywhere. Like it just looked like it was just like on this
- 7 | whole side. It was coming out the front door. It was coming out
- 8 these back windows. It was just the underneath was on fire, like.
- 9 I think it was just this side though, I'm pretty sure. I want to
- 10 say it was just that side.
- 11 Q. So you're pointing just to the starboard side?
- 12 A. Because I remember looking out and the smoke was all like
- 13 just around the right side. But I don't know if it was the wind
- 14 blowing it that way.
- 15 Q. And there was a lot of wind?
- 16 A. Yeah, I wasn't really paying attention really.
- 17 Q. Okay.
- 18 A. I was just more worried about everybody like getting off
- 19 safely, you know.
- 20 | Q. So you wouldn't have been able to establish if the smoke was
- 21 coming out -- potentially if it was coming out of these vents or
- 22 | if it was coming out of the transom?
- 23 A. I have no idea.
- 24 Q. Okay. Did you take any pictures or a video after you jumped
- 25 off the boat or even before?

- 1 A. Truthfully?
- 2 Q. Yeah.
- 3 A. I took one.
- 4 Q. Okay. Can I see it?
- 5 A. Yeah. It's before everything really got like -- it's really
- 6 not, it's not anything super big.
- 7 MR. Just to give you a little background. I was
- 8 involved in another investigation where someone had a picture of
- 9 the vessel 2 months before it went down and it was a very
- 10 important picture. It was very significant because it showed
- 11 where certain instruments were. So don't diminish the importance
- 12 of the picture. You might have something --
- 13 CWO Yeah, you just never know.
- MR. Yeah.
- 15 MS. CLETCHER: I climbed on the land and that was the first
- 16 -- I just took one because my mom didn't believe me. I called her
- 17 | crying --
- 18 UNIDENTIFIED SPEAKER: So that's early.
- 19 MS. CLETCHER: -- and she said I don't believe you. I was
- 20 | like no, seriously. I was like, why don't you believe me?
- 21 UNIDENTIFIED SPEAKER: That's actually a good picture.
- 22 BY CWO
- 23 Q. We'll just have you text it to me and then that way we'll
- 24 have that picture for our files.
- 25 A. Okay.

- 1 Q. Okay. So the crew members, as the passengers were getting
- 2 off the boat, what did you hear, what did you see?
- 3 A. Well, after I was off the boat and on land, I was a little
- 4 bit traumatized. I didn't really want to look back. I remember I
- 5 was on the phone with my boyfriend and I was on the phone with my
- 6 mom, and I just kind of told my mom -- I was like, just come pick
- 7 | me up. Like I just don't really want to be here; I don't even
- 8 like really want to think about it. Yeah.
- 9 But I stayed. I stayed there until a couple hours later with
- 10 everybody else because I didn't want to just leave everybody,
- 11 because that would have been rude, not caring, you know. And I
- wanted to make sure that everybody was all right and that they
- 13 found Mike. And I just wanted to make sure everything was good
- 14 before I was allowed to leave.
- 15 Q. Okay.
- 16 A. At least decent. Not good, but -- you know. Yeah.
- 17 Q. Yeah. So how do you think the fire started?
- 18 A. I have no idea.
- 19 Q. Okay. No rumor, no speculation, even a quess?
- 20 A. I have no clue.
- 21 Q. Okay.
- 22 A. I am so non-mechanical. Anything like that I have no idea.
- 23 All I know is fire is fire.
- 24 Q. Okay. Anything else you feel I didn't cover you'd like to
- 25 share?

- 1 A. No. I think that was it. I think that's all of it.
- 2 CWO
- 3 BY MR.
- 4  $\mathbb{Q}$ . You said that you were the bartender on the big boat?
- 5 A. Yeah.
- 6 Q. What else do you do on the big boat, just bartending or do
- 7 you do anything else out there?
- 8 A. Oh, no, I just bartend. Unless they're teaching me how to
- 9 cook.
- 10 Q. On the transit out, you said Captain Mike was up on the
- 11 | bridge and you were up on the bridge too. Was anybody else on the
- 12 bridge?
- 13 A. No. He left the door open and I was sitting out on this side
- 14 thing smoking a cigarette. And then when it started getting
- 15 | really windy, I just kind of like sat down out of the wind trying
- 16 to protect my hair. The really means nothing, but --
- 17 Q. So you were smoking outside?
- 18 A. Uh-huh.
- 19 Q. Were you on the right side of the boat or the left side?
- 20 A. The left. Yeah, the left.
- 21 Q. When you're out there on the bridge, did you see anything,
- 22 | hear anything, smell anything that was abnormal that day?
- 23 A. Everything was totally normal. Mike made coffee. He's like,
- 24 | hey, girl, I made your coffee, girlie. I was like, all right,
- 25 thanks. Because it was cold that day. He was like, I figured

- 1 you'd be shaking like a leaf. I was like, well, thank you.
- 2 Q. When you came back in, did the door get closed?
- 3 A. No. No. That one he usually keeps open unless it's cold,
- 4 like really, really cold and he's freezing, which is not very
- 5 normal.
- 6 Q. So I think earlier you said you boarded the boat, I think, at
- 7 | 3:25, 3-ish. We'll just call it 3-ish.
- 8 A. Uh-huh.
- 9 Q. And you said Mike seemed a little stressed?
- 10 A. No.
- 11 Q. No?
- 12 A. No, no, nothing.
- 13 Q. What was going on the boat when you boarded? Was it a normal
- 14 day, everyone just preparing the boat?
- 15 A. Yeah, just normal. Yeah, normal. Me and Mike usually joke
- 16 around. Like, I don't know, we talk. So we're friendly, friends,
- 17 | whatever. He said he made coffee. So I went and got coffee.
- 18 Q. So when you boarded the boat, on the shuttle boat, do you
- 19 have any responsibilities on the shuttle boat as that boat goes
- 20 out?
- 21 A. To be on my best behavior.
- 22 Q. Okay. Anything else?
- 23 A. Not really.
- 24 FEMALE SPEAKER: She can't help it.
- 25 (Laughter)

- 1 BY MR.
- 2 Q. You said that a deck hand came to the bridge to talk to the
- 3 captain.
- 4 A. Tyler.
- 5 Q. It was Tyler?
- 6 A. Yeah. Tyler was up and down, up and down. Jon came up one
- 7 | time. I really can't even remember. Everything is so jumbled
- 8 really.
- 9 Q. So when Captain Mike left the bridge to go down and
- 10 | investigate in the engine room, was it just you left on the
- 11 bridge?
- 12 A. No. No, it was me and Alissa.
- 13 Q. Okay.
- 14 A. And Michelle.
- 15 Q. When did Alissa and Michelle get to the bridge?
- 16 A. Probably when they put everybody upstairs, and then they came
- 17 | straight to the bridge. Because there was a lot of people. It
- 18 was really congested. So they just kind of stayed out of the way,
- 19 came on the bridge to give everybody a little bit more space and
- 20 less crowded.
- 21 Q. Okay. So when Mike left the bridge to go look in the engine
- 22 room, it was you, Alissa and Michelle?
- 23 A. Uh-huh.
- Q. Okay. Who drove the boat when Mike left?
- 25 A. Well, he put the boat in idle and we were just kind of like

- 1 | idling into the water and Alissa just stood there and made sure
- 2 that we were going to be okay. Because we were really close, very
- 3 | close, like 10, 15 feet. But he just didn't want to beach the
- 4 boat and have everybody freaking out and then the fire start. I'm
- 5 guessing that now.
- 6 Q. Did Mike tell anybody drive the boat or did Alissa just walk
- 7 | over there on her own?
- 8 A. Truthfully, I don't even -- I was trying to grab all mine and
- 9 Alissa's stuff really. I was just trying to make sure that
- 10 everybody had their stuff and their bags. I didn't even think to
- 11 grab Mike's stuff really. I feel bad about that, because his
- 12 phone burned with the boat. But that was the only one I didn't --
- 13 I didn't even think. I didn't think to grab his phone or
- 14 anything.
- 15 Q. Okay. You said that you were unable to find a fire
- 16 extinguisher when you and Michelle went to the back of the boat.
- 17 Do you know if Michelle found one?
- 18 A. Truthfully, I don't know. I was so scared. Just like my
- 19 head was so jumbled. I was just like -- fire extinguisher. I was
- 20 | like a dog with a bone. I was like looking for a fire
- 21 extinguisher, but my head's like, well, so -- I was just a little
- 22 | bit like -- I was just a little bit everywhere, a little bit
- 23 scatterbrained. The blondness. What are you going to do?
- 24 Q. Do you know anywhere where firefighting equipment is on the
- 25 boat?

- 1 A. Me?
- 2 Q. Yes.
- 3 A. If I probably looked around a little bit I probably could
- 4 | find it. Truthfully, I never even thought like -- I don't know I
- 5 | just never really prepared myself for the worst. I guess I should
- 6 have, but --
- 7 Q. Tyler was number one off the boat. You were number three off
- 8 the boat.
- 9 A. Me and Alissa went at the same time.
- 10 Q. So you and Alissa?
- 11 A. Me and Alissa.
- 12 Q. Do you know who number two, number four, or anybody else?
- 13 A. It was Tyler, me and Alissa, two and three. After that I'm
- 14 not really sure.
- 15 Q. Okay. So who jumped -- was it you and Alissa at the same
- 16 | time or did --
- 17 A. Yeah. Because my feet were stuck in the mud. So she came
- 18 over to me. And Tyler was already off the boat.
- 19 Q. Okay. You don't know anybody else after that?
- 20 A. No. I wasn't really paying attention truthfully.
- 21 Q. Have you ever been in the engine room on that boat?
- 22 A. No.
- 23 Q. Ever been in the engine room of the big casino?
- 24 A. No.
- 25 Q. Okay.

- 1 BY CWO
- 2 Q. I had a couple follow-ups. So on the big boat, can you
- 3 explain what are your duties and responsibilities?
- 4 A. I just bartend. I take my rounds, see anybody wants a drink.
- 5 Q. Do you wear a uniform?
- 6 A. Yep.
- 7 Q. What does your uniform look like?
- 8 A. Well, I have two different shirts that I wear. I have a
- 9 black short-sleeve SunCruz shirt. Well, actually, I have three:
- 10 I have the black short-sleeve SunCruz shirt. I have long sleeve
- 11 purple SunCruz -- well, it says Tropical Breeze. And then I have
- 12 a flowered shit that I kind of like just tie, coming in, tied on.
- 13 It doesn't have any emblems, no nothing.
- 14 Q. Okay. And on the big boat, what are your responsibilities in
- 15 | case there were a fire?
- 16 A. To kind of like crowd control really. I'm quessing find a
- 17 | fire extinguisher and know where the fire extinguishers are. Just
- 18 to keep everybody like calm and collected a little bit, try and
- 19 like -- and not crowded and people getting violent or anything
- 20 | like that. Just because I'm like down by the door. And I'm
- 21 | guessing the deckhands would help out. I don't know.
- 22 Q. Okay. And have you ever conducted a fire drill --
- 23 A. Me?
- 24 Q. -- or been part of a fire drill?
- 25 A. Me personally?

- 1 Q. Yes.
- 2 A. No.
- 3 Q. Okay. And I think that's about it.
- 4 BY UNIDENTIFIED SPEAKER:
- 5 Q. So when you were hired on a year ago, what type of training
- 6 did you undergo, whether it was employee training, bartender
- 7 training, boat-specific training?
- 8 A. Bartender, just like dos and don'ts. I mean like -- I mean,
- 9 I don't know. I grew up on boats so I kind of know like a little
- 10 bit about boats, so -- I mean, not much, obviously, the technical
- 11 names. But just like what I'm supposed to do behind my bar
- 12 basically.
- 13 Q. Okay. So any training on boat operations or was it just all
- 14 related to bartender training?
- 15 A. Mostly bartender. I mean, the basics of like safety and
- 16 stuff like that. Like, if you can't swim, you need a life jacket.
- 17 I mean, just like basics and stuff like that. I mean, for the
- 18 most part the deckhands are on it. The deckhands are really good
- 19 about the drills and everything. They know everything about that.
- 20 Q. Do you know where the life jackets were on the boat or where
- 21 they are maintained or kept?
- 22 A. I only know that they were on the boat.
- 23 Q. Do you know where they're kept on the boat?
- 24 A. I think that they are downstairs in the front of the boat.
- 25 Q. Did anybody direct anyone or did anybody get any life jackets

- 1 out?
- 2 A. There wasn't really any time to pass out life jackets. I
- 3 | just remember Mike was driving, doing what he could. The
- 4 deckhands put everybody on top when they started getting a little
- 5 | bit worried. I mean, tried to keep everybody as calm and
- 6 | collected as possible, I mean, in that situation. But no, there
- 7 | was no time really for life jackets, and I don't know, in my
- 8 opinion you would have just been wasting your time with the life
- 9 jackets because we were in shallow water. And it's like what if
- 10 you got stuck downstairs or something trying to get a life jacket
- 11 for somebody, you know. I just feel like it was shallow enough I
- 12 think, in my opinion, I mean.
- 13 CWO Mr. Carlson, do you have any questions?
- 14 BY MR. CARLSON:
- 15  $\mathbb{Q}$ . How deep was the water when you jumped off?
- 16 A. When I jumped off? Like ankle deep. Not really -- not even
- 17 | past -- not even that deep. But I was in the very front though,
- 18 so I was in the shallowest part.
- 19 Q. You don't recall Mike giving any instructions to Alissa when
- 20 he went down below?
- 21 A. Well, he said, you know, like there's the front of the boat.
- 22 | Like there's the beach; you're really close. Like the boat is in
- 23 idle. Like we are not going fast. The motors aren't on. He
- 24 | said, just point it straight. He said, I'll be back. He said,
- 25 I'll be back. He said, I have to do something. He said, there's

- 1 | just something I have to do. And he tied his shirt around his
- 2 face and he went downstairs.
- 3 Q. Okay. Did he give her the helm or the wheel or just --
- 4 A. I mean, yeah, as much as he could. I mean, without taking it
- 5 out of the thing, I mean.
- 6 Q. What do you mean, without taking it out of the thing?
- 7 A. I mean, he just kind of said like don't turn the wheel, you
- 8 know, don't like 90-percent angle the wheel or anything, but like
- 9 just go straight. He said, really, you don't even have to touch
- 10 it because there's no power steering. So it's so steadfast it
- 11 | could basically drive itself, you know.
- 12 She just stood there, held onto it. She didn't turn it. She
- 13 just made sure that the boat went straight. And when the boat hit
- 14 the land you could feel it because your body kind of jolted a
- 15 little bit, and that was when people started jumping pretty much.
- 16 Q. And to the best of your recollection, how far from the beach
- 17 | was the boat when this happened?
- 18 A. Oh, when we were beached?
- 19 Q. When Mike put something around his face and --
- 20 A. We were probably like a set and a half of markers away from
- 21 the beach. We were like 15 feet, 20 feet, if that.
- 22 Q. And the boat was idling?
- 23 A. Yeah, we weren't going fast.
- 24 Q. And drifting?
- 25 A. Yeah. The wind could have honestly pushed us up there

- 1 | without Alissa. If Mike would have just left it totally like no
- 2 man, I think we would have been okay.
- 3 Q. Do you know what Mike did when he left?
- 4 A. I'm guessing he tried to save us by putting out the fire, but
- 5 I don't think that he realized -- it was probably worse then he
- 6 thought. He tried though. I'll give it to him, he tried. He did
- 7 everything he could. I mean, there was not really much else that
- 8 anybody could have done to like prevent it or really anything like
- 9 that. Like with the life jackets, that would just waste time
- 10 really, I mean. I would be more concerned about the people, like,
- 11 | at least getting off the boat instead of them having a life
- 12 | jacket, you know, because if they don't get off the boat, I mean,
- 13 why do you need the life jacket, you know.
- 14 Q. Okay. Have you sailed with Mike a lot in the past?
- 15 A. Yeah. He's my favorite captain.
- 16 Q. And why do you say that?
- 17 A. Because, in my opinion, he's the best captain. I think that
- 18 he's the most collected. I think that he -- I mean, other than
- 19 Willie G's. That's a hard one. I don't know. Mike is just more
- 20 of like a normal guy, you know. He's just like your average Joe,
- 21 | but he's Mike -- like, I don't know he's just a great guy. He's
- 22 (indiscernible). He knows a lot about boats. I mean, I don't
- 23 think that there's anything that he could have done to really
- 24 prevent the fire. I mean, we were already out in the water. I
- 25 mean, at least he turned the boat around and he -- at least we

- 1 were like on land instead of kind of keep going, you know. At
- 2 | least he thought about that. Probably would have been a way worse
- 3 situation if we would have kept going. Then we would have needed
- 4 the life jackets.
- 5 Q. How many trips do you think you have made back and forth
- 6 total to the Casino, 50, 100?
- 7 A. A lot.
- 8 Q. A lot?
- 9 A. 200.
- 10 Q. So when you're going out the channel, there comes a point
- 11 that, you know, someone is driving the boat and the boat will
- 12 start going faster and you can hear --
- 13 A. Like on planes?
- 14 Q. Yeah, you can hear the engine pitch change.
- 15 A. Yeah.
- 16 Q. So when you are transiting out of the channel did you get to
- 17 the point where you kind of got off an idle --
- 18 A. No. No.
- 19 0. -- started -- so on the --
- 20 A. The entire time before like we -- because we almost were at
- 21 | the rock and I remember him saying, I don't want to hit the rock;
- 22 | I don't want to hit the rock. And he just kind of like shifted as
- 23 far away from the rock as he could and just kind of hoped for the
- 24 best really.
- 25  $\mathbb{Q}$ . So the entire outbound transit was idle speed?

- 1 A. Yeah. I mean, he put it in reverse one time just to see if
- 2 | like it would stop overheating. Just to see if that was the
- 3 problem, I mean, but that -- not for long. I mean, he just did it
- 4 for point of a second, not even.
- 5 Q. So how do you know he put it in reverse?
- 6 A. I just watched him.
- 7  $\mathbb{Q}$ . Did he say that it was overheating or --
- 8 A. No. No. No. No. Noting like that ever really happened.
- 9 He was just trying to keep himself collected and to see if he
- 10 | could figure out if he could fix the problem himself or if he
- 11 | needed like assistance or -- he didn't know what he needed at,
- 12 like, at the time because he didn't know how serious it was. Like
- 13 he did, but he -- he just said like -- this is the point, like it
- 14 was so early like he just had that weird feeling, you know, like
- 15 the really weird feeling.
- 16 Q. So when you say he put it in reverse, how do you know that
- 17 he --
- 18 A. Not like in reverse like gun it in reverse or anything. But
- 19 like he just like backed up a little bit just so that the motors
- 20 were like -- the motors, you could just tell that they were in
- 21 | reverse, you know, like, they're like -- it's not that they bubble
- 22 or like that they do anything. But you can just tell, you know.
- 23 Q. Do you know how the boat moves -- what you have to do to put
- 24 the boat in motion?
- 25 A. Do the little --

- 1 Q. Okay. Can we call them throttles?
- 2 A. Yeah.
- 3 Q. Bingo.
- 4 A. Gas.
- 5 Q. So did you see Mike, did he pull back on the throttles when
- 6 | you say he put it in reverse?
- 7 A. I want to say it's back.
- 8 Q. Okay. Do you know how many throttle levers -- do you
- 9 remember how many throttle levers there are?
- 10 A. I think there's two. I don't think that they're connected.
- 11 Q. Okay.
- 12 A. I'm pretty sure.
- 13 Q. So if he pulled one back or when he went in reverse, did he
- 14 pull them -- do you remember if he pulled --
- 15 A. No.
- 16 Q. -- both back or one?
- 17 A. I don't even know. I have no idea really. It wasn't
- 18 anything even serious. It was just him trying to fix this little
- 19 motor skills.
- 20 Q. Was there any changes in pitch and engine that sounded
- 21 abnormal other than what you have witnessed on your approximately
- 22 | 200 trips?
- 23 A. No. Not really. There wasn't any -- like you couldn't tell
- 24 like -- like you really couldn't tell. Like there wasn't anything
- 25 | weird sounding, like any weird like -- I don't know it was just --

- 1 | it all happened really fast, really fast.
- 2 Q. Did Mike say he thought the boat was overheating?
- 3 A. I didn't even ask him because it wasn't my -- it wasn't my
- 4 | business. And I didn't want to be like that nosy like, hey, are
- 5 | we on fire? Hey, what's wrong like? You know, I didn't want to
- 6 stress him out and then he would be like, you know, what just get
- 7 out of here.
- 8 Q. Okay.
- 9 CWO In your 200 trips or so, have you ever had a
- 10 similar experience or one where the boat had to turn around or
- 11 | there was an issue that had to be fixed?
- MS. CLETCHER: Never. Never when I have been on the boat,
- 13 no.
- 14 CWO Never. Okay.
- 15 BY UNIDENTIFIED SPEAKER:
- 16 Q. I do have one follow-up. So you worked for how long? Coming
- 17 up on a year?
- 18 A. Yeah.
- 19 Q. How many days a week do you work?
- 20 A. It varies?
- 21 Q. Three, 5, 7?
- 22 A. Three, 4, 5, 6.
- 23 Q. Three, 4, 5. One to two --
- 24 A. As many as I can get.
- 25 Q. One or two trips a day?
