7 Q. And so, as we get started here -- do you still live on

- 9 A. Um-hum.
- 10 Q. In Holiday?
- 11 A. Yes.

- 12 Q. Okay. Great. And can you give me your background, education
- 13 | and work experience?
- 14 A. I've been working with Tropical Breeze for about 5 years. I
- 15 | do cook and I bartend. And then prior experiences, I worked at
- 16 SPC as a financial assistance and I worked at Target being a
- 17 | cashier.
- 18 Q. Okay. And your 5 years of employment with SunCruz, were you
- 19 always a cashier or bar assistance?
- 20 A. No. I was mostly their cook --
- 21 O. Cook.
- 22 A. -- for about 4 years and then I became a bar.
- 23 Q. So the bar has been the last year?
- 24 A. For about.
- 25 Q. Okay. On the morning -- or on your workday, on the 14th of

- 1 January, can you just walk us through your workday?
- 2 A. Like any other day, you sign in. You go onto the boat. And
- 3 that day was pretty chilly out, so I was in the little cubbyhole
- 4 and we were starting to ride out and, of course, I'm on my phone.
- 5 And I seen smoke, so I thought maybe it was because it was chilly,
- 6 | it was just a cold day and, you know, the exhaust was just a
- 7 little bit thicker that day.
- 8 And a few minutes go by and one of the deckhands come in and
- 9 just ask everybody to move upstairs. And so, we try and move as
- 10 many customers up to the upstairs, and I was one of the few that
- 11 was still downstairs trying to get the remaining passengers to go
- 12 upstairs. And we went upstairs and a lot of the customers were,
- 13 you know, kind of crowded around because we were upstairs. And
- 14 so, we were -- sorry. It's just kind of nerve wracking to relive
- 15 it.
- 16 O. I'm sure.
- 17 A. And so, we went upstairs and, you know, everybody was
- 18 | nervous, everybody was wanting to know. So we tried -- all the
- 19 employees tried to calm down. And I didn't really see much of
- 20 anything. I was mostly just concerned with whatever customers I
- 21 | could see and, you know, where my employees were that I work with.
- 22 Because down in the cubbyhole I was sitting next to three other
- 23 employees of mine.
- So we all kind of followed and tried to stay around each
- 25 other, trying to figure out what was going on. And I want to say

- 1 that we -- that somebody -- I forgot what deckhand it was that
- 2 | said that we had to go jump overboard. And so they tried to take
- 3 as many customers down first. And I remember there was this one
- 4 customer that was so, she was so -- like I don't even know how to
- 5 describe it. She was just so anxious and, you know, and she kind
- 6 of like tugged me. So I was like -- so it was -- another co-
- 7 | worker was in front of me so we allowed her to go.
- 8 And then the smoke was so thick at the time, so when I was
- 9 trying to go down the stairs -- I'm afraid of heights, so I was
- 10 going kind of slowly down the stairs to go to the bow and -- I
- 11 | forgot -- it was -- I don't know who did what that day, and I do
- 12 apologize for that. But I remember somebody opening the hatch to
- 13 -- for the boats to go -- I don't know what that's called.
- 14 Q. So this port right here?
- 15 A. Yes. Yes, sir.
- 16 Q. Okay. And so you're talking about the port side --
- 17 A. Port side --
- 18 Q. -- transfer port?
- 19 A. Yeah, yeah. So one of -- I don't know who opened it, but
- 20 somebody opened it so that more people can, you know, get off the
- 21 | boat safer. And, so I'm deadly afraid of heights, so I sat there
- 22 in shock and hyperventilating, not knowing what to do and not
- 23 knowing what was going on behind me, until I seen, you know, the
- 24 video. And so one of my co-workers came beside me and, you know,
- 25 to tell me that, you know, hey, it's safe; the water's okay to go

in.

So he goes in first and he's, you know, there trying to get me to go down. And like I said, I'm very scared and I accidentally kicked him. Didn't mean to kick him, but I did. And I don't know how many minutes this goes by. It wasn't very long and it felt like either somebody pushed me or I just finally got the nerve to go down, and then I finally hit the water and -- you know, it takes a few minutes to try to realize what you're doing.

So it took me a minute to try to get back and to see what I was doing. And I -- then I tried to go back onto shore and then trying to see who I can grab to try to help bring back on shore. And I seen -- everybody is -- you know, I hadn't -- I think Tyler was yelling at me to try to get out of the water, and so that -- you know, because we were all afraid that it could blow.

So I remember going -- taking my bag back to shore so that it wouldn't -- you know, the tide wouldn't take it away. And I put that -- and I tried going back to help whoever I could and I kept falling because of how muddy the water was. So I tried to help whoever I could. And I look back, and that's when I seen what actually happened and why we had to jump off the boat so quickly.

And so, I remember they were trying to like -- the ERs or whoever were there, the first responders, were trying to get us to go towards the houses and try to go more towards land. And I tried to help and tried to make sure that whoever was, you know, on the ground was at least okay and was able, you know, have a

first responder to respond to them.

And that's as much as I can remember.

I do remember helping the lady that passed up the stairs. She was on those walkways. We have a -- I don't know why she didn't take the stairs, but there is a path that was rocky and I helped her. And I remember she said, you can't handle my weight. I said I will handle your weight because I want you more towards land. You know, you need to get onto land. So I helped her and then we all ran to, you know, the houses and just tried to stay calm and try to get everybody -- whoever needed help, got help.

- Q. Who was the passenger? Who was the lady that said you couldn't handle her weight?
- A. The lady that passed away. I was just trying to help her come up the stairs so that she could get help from whoever. And I believe either a first responder was -- either her significant other was behind me or maybe a first responder, but somebody later grabbed -- like I tried helping her up wherever the rock way was and then somebody behind me came and got her.

And after that, I don't know what happened because I was trying just to, you know, find whoever I could and make sure they were okay. I think I made sure that whatever faces I could remember, just making sure that they were okay, if they needed anything. I even remember chasing our customer, Steve, with a towel. Like, you forgot your towel. Because I didn't want him to go to the ER without being cold. So that's as much as I can

- 1 remember.
- 2 Q. Okay. So what time did you get to work?
- 3 A. Well, my boyfriend does work with me, so I had to be there
- 4 | about -- I think he had to be there around 2:30 or 3, and then I
- 5 | don't have to be there until 3:30. Because we were taking the
- 6 Island Lady, so I didn't have to be there till 3:15.
- 7 So I was probably just in the waiting room just waiting to go
- 8 out and watching the customers come in the dockside. Just waiting
- 9 for them to come in and just waiting for myself to go out on the
- 10 boat. I believe I had a Chipotle. Me and Tyler wanted to go to
- 11 Chipotle's. I was eating in the dock, and I think I was eating on
- 12 | the boat too because I got hungry again.
- 13 Q. Okay. And you said that you were located in the cubby, which
- 14 is basically the forward passenger area of the boat on the main
- 15 deck. And, you said you saw smoke before the crew members came
- 16 down into the salon?
- 17 A. Yes. I just thought it was just the exhaust. It was pretty
- 18 | cold that day. I was pretty chilly. So I don't know anything. I
- 19 thought maybe it was just the exhaust blowing a little bit thicker
- 20 that day. I don't really know much about engines or even cars
- 21 | that much. So that's what my first instinct was. And so I went
- 22 to the bar and I think I asked whoever was behind the bar for a
- 23 glass of water because I didn't want to, you know --
- 24 O. This bar? To the stern?
- 25 A. Yeah.

- 1 O. To the aft bar?
- 2 A. Yeah, the bar area.
- 3 Q. Okay.
- 4 A. And then I asked whoever was behind the counter for a water
- 5 because I didn't want to, you know, freak anybody out. You know,
- 6 we have a lot of older customers on that boat that probably
- 7 | wouldn't do well with, you know, craziness and I didn't want to
- 8 get anybody upset or anything.
- 9 So I just went there and I could see that the other -- you
- 10 know, the customers were kind of getting -- you know, wanting to
- 11 know what was going on. And I seen, you know, deckhands -- you
- 12 know, we had I believe three or four that day, come on and they
- 13 were all over the place. I seen, I think, somebody went, you
- 14 know, off this way to go up the stairs to go see the captain. And
- 15 then, you know, we had the deckhands trying to figure out what was
- 16 going on.
- 17 And then, you know, I thought the reason why we were going
- 18 upstairs just so that, you know, if it was dangerous smoke, they
- 19 didn't want the customers, you know, inhaling that. So that's why
- 20 I thought we went upstairs. I didn't know that we had a fire
- 21 going on until I was off the boat.
- 22 Q. Okay. And so, the first time you saw the smoke, was it in
- 23 | the salon area or could you see it through the windows on the back
- 24 of the boat?
- 25 A. You could see it through the windows. Like I said, I thought

- 1 | it was the exhaust. At first, it was, I wouldn't say -- like a
- 2 | whitish grayish and, you know, I didn't think anything of it. I
- 3 seen exhaust. I've been on that boat so many times that I thought
- 4 | it was just the exhaust going on from that side of the boat. Not
- 5 really think anything of it.
- 6 Q. Could you tell which side of the boat it was originating
- 7 from?
- 8 A. Well, where I was sitting -- I was sitting up here, so where
- 9 I was sitting, it came off -- you know, because I was sitting down
- 10 and I just seen it come over the window. So I thought, because I
- 11 | -- there was like -- honestly, there was me and three other
- 12 people. And I remember what one of the employees -- like he's
- 13 like you are going to move -- he said -- he was too funny. He's
- 14 like, you're hogging up all the space. I'm like, I'm cold. And
- 15 | so, but I was on my phone so I didn't really think anything of it.
- We have some time going onto the big boat so, you know, a lot
- 17 of us, we just chit-chat. Employees, we chit-chat, catch up, and
- 18 all of us are on our phones and stuff like that. But where I was
- 19 sitting, I want to say -- I was sitting maybe over here, so I seen
- 20 | it come maybe out this window. But I just thought maybe it was
- 21 | the exhaust kind of going a little haywire that day.
- 22 Q. When you got on the boat, when you first approached it, was
- 23 | the exhaust heavy?
- 24 A. I honestly just went and sat down because it was just so cold
- 25 that day. I didn't really -- I wanted to go upstairs, and so I

- 1 just kind of sat down and -- then I believe I even went to go use
- 2 | the restroom before, you know, a lot of the customers came on.
- 3 And I just watch all the customers come on like any other day that
- 4 we're out there.
- 5 Q. Okay. And how long do you think it was from the time you saw
- 6 the smoke to the time everyone was asked to go up to the upper
- 7 deck? So did you have time to go get the water from the bartender
- 8 and --
- 9 A. I was able to drink it and then I believe I even asked him,
- 10 I'm like, you know, what's that from? Like is that from the
- 11 exhaust? And, you know, we didn't really understand what it was
- 12 from. And you could see some of the customers kind of getting
- 13 | nervous and stuff, so we tried calming them down and just trying
- 14 to tell them like, you know, if we know anything, we'll try to let
- 15 | you guys know as soon as we know something.
- And it wasn't shortly after, I believe maybe one -- because I
- 17 stayed after. Like, because we tried getting all the customers to
- 18 go and I was -- like I said, I was one of the last ones. Because
- 19 there was some -- we had some customers that were dangling still
- 20 down there, so I tried having them to go upstairs with me. And
- 21 | don't know if they went downstairs to check to see if anything was
- 22 okay. I can't really remember. But it wasn't shortly after, you
- 23 know, I seen the smoke, maybe 5 to 7 minutes later, they asked
- 24 everybody to move upstairs.
- 25 Q. Okay. And so, while everyone was moving upstairs and you

- 1 were located in the passenger area, what did you see? Did you see
- 2 | the crew members?
- 3 A. Oh, I seen every crew member go every which way, honestly.
- 4 Q. That's fine. Tell me.
- 5 A. I think I seen somebody go past me while I was still sitting
- 6 down, to go and talk with the captain. We still had one of the
- 7 deckhands, you know, still do the bar, if anybody needed anything.
- 8 I think we had maybe one or two other crew members still upstairs,
- 9 you know, just trying to figure out what was going on and looking
- 10 to see where it was coming from and all that.
- Because I can't remember -- because I was one of the last --
- 12 like I said, I was one of the last ones trying to get whoever
- 13 customers still downstairs. But if they were going in there, I
- 14 don't know, because the -- whoever the crew members were, they
- 15 kind of pushed everybody to go upstairs. If they went to go check
- 16 | the engine room, I can't --
- 17 Q. Okay. So you never saw a crew member enter the engine room?
- 18 A. I was trying to get whoever customers downstairs. You know,
- 19 we had two or three deck people that day, so I wanted to make sure
- 20 that they were upstairs and they were okay. And I remember we had
- 21 one customer and he is -- he's one of our regulars, and so I was
- 22 | trying to get him to come upstairs and I was trying to see whoever
- 23 my co-workers. Because, like I said, I sat with three of them and
- 24 I was trying to figure out where they went. So -- because I
- 25 didn't know what was going on and, you know, I get scared easily,

so I tried to figure out who was all upstairs.

And I sat -- I didn't really sit. I was standing. I was just trying to figure out what was going on. But you could see a lot of the customers like move over because they were just wanting to know what was going on and try to get any information that they could from any one of the employees that knew anything. And we were trying to calm them down the best we could.

And but, if -- I couldn't see, because they were just -- they were trying to figure out what was going on so, you know, you don't really see much. But they were everywhere and I was just trying to stand -- just trying to figure out what was going on and I kind of just stood in one place and just kind of, I guess, in shock about what was starting to go on. Because all of the sudden, you'll see the smoke go from what you think is just in the exhaust to a thicker gray to black smoke. So you kind of were like getting scared and you're not knowing what's going on until you could get onto land and you see what happened and why we had to go off the boat.

- Q. So when you left the passenger area, the salon, was there smoke inside that space?
- A. Not at that time, sir. Like I said, when I first saw it, I just thought maybe it was just thicker exhaust. And, you know, we -- I've been on that boat for so long that that's -- you know, it doesn't surprise me. I used to be a smoker, so I would go out there and, you know, watch the water and do that.

- But no, there was no smoke until you got to the upper deck and that's when you could see the smoke and smell the smoke.
- 3 Q. When you were up on the upper deck, could you physically --
- 4 or did you ever actually see where it was coming from on the boat?
- 5 A. No.
- 6 Q. Or you could just look out and see smoke?
- 7 A. I do recall that, I believe, like when the smoke started
- 8 getting thicker, you could see that the customers try to get where
- 9 the smoke wasn't so heavy just to, you know -- but where it
- 10 started, I can't really say.
- 11 Q. Okay. At what point did you know there was an emergency on
- 12 board?
- 13 A. Probably when we were asked to go upstairs. That's when
- 14 something kind of clicked and maybe something maybe wasn't right.
- 15 But then I didn't know, because I didn't really want to ask, you
- 16 know, any of our crew members because I didn't want to freak out
- 17 some of the other customers. Because, like I said, we had one --
- 18 | we had a few customers on the boat that were a little shaky and
- 19 nervous and, you know, she kind of like pushed me to try to go
- 20 down the stairs. And me and another co-worker were like, well,
- 21 | you know, if you want to go ahead of us, you're more than welcome
- 22 | to go ahead of us. And we -- but that's --
- 23 Q. Okay. So when you departed the vessel, you jumped off the
- 24 port side, you said. Do you recall who went in before you or who
- 25 | went in after you?

- 1 A. Stephen. He is one of our dealers.
- 2 Q. Longarello?
- 3 A. I don't know his last name.
- 4 Q. Okay. I think he's the only Stephen, right?
- 5 A. Yeah.
- 6 Q. Okay.
- 7 A. And he went in front of me. He was just, you know, trying to
- 8 calm me down and just say that, hey, you know, we're in good
- 9 waters, you know, nothing's going to happen. And I was
- 10 hyperventilating and scared, because I was sitting on wherever I
- 11 was sitting just because I wasn't sure how deep the water was. So
- 12 I was trying, you know, crawl my way down the stairs. Or not the
- 13 stairs, but just crawl into the water, not really thinking
- 14 anything of it. And -- who was behind me? Shelly? Shelly.
- 15 Yeah, Shelly. Her name's Michelle. She goes as Michelle, but she
- 16 goes as Shelly too.
- 17 | O. That's Ottinger or Nitz?
- 18 A. Nitz.
- 19 Q. Okay.
- 20 A. I remember her passing all of our bags to Stephen. And so --
- 21 and, like I said, I don't if somebody just finally pushed me or if
- 22 | I jumped myself off. And I want to say that -- well, Shelly,
- 23 finally jumped off, and I think shortly after her maybe another
- 24 employee. Because we all kind of -- whoever -- because we kind of
- 25 all stayed together, the ones that were in the cubbyhole; we all

- kind of stayed together.
- 2 And then we started to walk. And then we tried to -- well, I
- 3 tried walking back on shore and I kept falling, but I tried to
- 4 help whoever I could. So I was able to come back onto land and I
- 5 dropped my bag off, and then I went back into the water to try to
- 6 save whoever I could, but I kept falling. And I remember, was it
- 7 | -- somebody tried getting me to come out of the water because we
- 8 just wasn't sure if it was going to blow or not.
- 9 Q. Did you suffer any injuries that day?
- 10 A. No, sir.

- 11 Q. Oh, good. Did you take any pictures or video that day?
- 12 A. No, sir.
- 13 Q. And in your 5 years, had you ever had a reason where you got
- on either the casino boat or the shuttle boat, headed out off
- 15 | shore, and then had to turn around and come back?
- 16 A. No, not that I can recall. We've always just went out and
- 17 | had customers enjoy their day, and if there was a problem, I
- 18 | wouldn't know anything about it. So I would just go out. But
- 19 we've never had to turn around for, as far as I can recall, for
- 20 any type of reason.
- 21 Q. Okay. And as a cook for 4 years and then bar person, what
- 22 | are your responsibilities out on the *Tropic Breeze*?
- 23 A. I believe ours is to calm down the customers and hand out
- 24 life jackets.
- 25 Q. And have you had training in firefighting or abandon ship or

- 1 flooding?
- 2 A. Not that I can recall, no. But, I -- but we have booklets.
- 3 So I've read up on the booklets of what my duties were.
- 4 Q. Have you ever had a practice drill with the whole crew? And
- 5 that would be, the drill would be for firefighting, flooding or
- 6 | for abandon ship?
- 7 A. I did get where my emergency hatch is, like to try to escape
- 8 where the galley is. So that would probably be my only training.
- 9 And then I know where the life jackets are on the Tropical Breeze.
- 10 Q. So your training, did they -- was this egress? Like it would
- 11 | be called egress training, where if you're in the galley and you
- 12 had to get out quickly, someone showed you the path out of the
- 13 boat?
- 14 A. Yes, sir.
- 15 Q. I see. Okay.
- 16 CWO
- BY MR.
- 18 Q. When you boarded the boat, was it where the passengers
- 19 embark?
- 20 A. Were they coming -- were they on the boat already?
- 21 Q. I'm sorry. The vessel was located where the passengers
- 22 usually board? You didn't board it over at the other area?
- 23 A. No, sir.
- 24 Q. Were the engines running, do you remember, when you boarded
- 25 | the boat?

- 1 A. Yes, sir.
- 2 Q. Okay. When the vessel gets underway, is there any -- does a
- 3 crew member make a brief on safety?
- 4 A. Yes.
- 5 Q. Was that done that day?
- 6 A. Yes.
- 7 Q. Okay.
- 8 A. But I was on my phone. I really wasn't paying attention, and
- 9 I've heard that announcement so many times.
- 10 Q. Do you know who makes that announcement?
- 11 A. It depends on the deckhands that day. Or even, if the
- 12 entertainers happen to be out there, entertainers usually do it
- 13 too.
- 14 Q. When you first saw the smoke, what color was the smoke?
- 15 A. When I first seen it, it was about a white going into gray.
- 16 I didn't really think anything of it.
- 17 Q. And you were sitting in the cubbyhole. Who else was there
- 18 | with you?
- 19 A. It was me, Shelly, I believe Debbie, and then Stephen,
- 20 | because I had to make room. I was taking up too much space for
- 21 him. Do you want to know where we were all sitting?
- 22 Q. Sure.
- 23 A. I was sitting where you could go into that area, and then I
- 24 | believe Shelly was sitting next to me. Debbie was -- her back was
- 25 | towards -- we had like an area where they would put speakers and

- 1 on, so she had sat that way. And then Stephen was the one on the
- 2 very back.
- 3 Q. Okay. Do you recall where the vessel turned around? That's
- 4 okay.
- 5 A. I just know where I was able to go on, because that's where
- 6 | -- I believe that's -- because on video, that's where he's
- 7 starting to turn around. But we were so in motion that we
- 8 couldn't tell if we were -- you know, if the boat was moving on
- 9 lits own or if the wind happened. Because it was very windy that
- 10 day. So we didn't know if it was just the boat moving or the wind
- 11 moving. I couldn't tell either/or.
- 12 Q. How many trips back and forth on the shuttle do you think
- 13 | you've ever made?
- 14 A. On the *Island Lady*, oh my goodness.
- 15 Q. Ten, 20, 100?
- 16 A. I worked there for -- since we got the boat in -- probably
- 17 | like 2, 3 years, so probably 100 to 200.
- 18 Q. Suffice to say enough that it kind of gets to be repetitive
- 19 in nature?
- 20 A. Yes, sir.
- 21 Q. So just to help out, I don't want to try to lead your
- 22 questions or anything. But the boat goes out nice and calm and on
- 23 idle speed?
- 24 A. Yes, sir.
- 25 Q. Was it going out on idle speed that day?

- 1 A. Well, we only got to -- we only got to so far. So where we
- 2 | were, we were considered in the channel, so we were doing that
- 3 speed.
- 4 Q. Okay.
- 5 A. Nothing out of the ordinary that day as far as I can recall.
- 6 And, you know, all the customers were talking to one another,
- 7 | trying to catch up. A lot of our customers are -- well, all of
- 8 our regulars are pretty close and they always want to, you know,
- 9 check up how their grandkids are doing and stuff like that.
- 10 Q. So nothing out of the ordinary today?
- 11 A. Not that I can -- no.
- 12 Q. So on the way back was the vessel operating at the same speed
- 13 as it was going out, after you turned around and started heading
- 14 into shore?
- 15 A. I don't believe so because I kind of don't understand your
- 16 question.
- 17 Q. Okay. So if we call a boat moving at idle speed --
- 18 A. Yeah. It's just going --
- 19 Q. -- it's just kind of moving along at the normal --
- 20 A. Moving along with the waves.
- 21 Q. Okay.
- 22 A. But where we were, like we didn't really go out very far. We
- 23 | went -- I don't even know where the channel would be for that, for
- 24 those houses.
- 25 Q. So on the way back was the captain driving the boat faster

- 1 | than he was on the way out?
- 2 CWO This is the channel. This is Durney Key.
- MS. IRVIN: Well, we didn't go out very far. We only went
- 4 out until we had those houses, and then from there, we were asked
- 5 to leave the boat. So we -- so he, the captain could have tried,
- 6 you know, moving the boat -- I know he was trying to move the boat
- 7 closer to land. If that's what you're asking.
- 8 BY MR.
- 9 Q. No, did the boat seem like it was moving faster on the way
- 10 back than it was when it was going out?
- 11 A. No. He just -- because we were still considered in the
- 12 channel at that point so we have to go at idle speed.
- 13 Q. Okay. At any time did you go to the bridge of the vessel?
- 14 A. No, sir.
- 15 Q. And are you familiar with -- did the *Island Lady* make any
- 16 | trips or have any mechanical issues that you may have known?
- 17 A. I don't really ask questions. I just go to work.
- 18 Q. Don't know if anything popped up out of the ordinary that you
- 19 may have observed?
- 20 A. No.
- 21 Q. Have you ever been in the engine room of the vessel?
- 22 A. No, sir. Most of our employees are not allowed to be in the
- 23 engine room.
- 24 Q. Okay.
- 25 A. Only the deckhands and engineers and the captains.

- 1 Q. Did you see any of the crew go into the engine room at all?
- 2 A. If they did, I may have already been upstairs or trying to
- 3 get the last remaining couple.
- 4 Q. So you didn't see anybody?
- 5 | A. Not -- well, I'm not saying -- I didn't see -- they may have
- 6 | went down there, but I didn't see them physically, no.
- 7 Q. Okay.
- 8 MR. CARLSON: Thanks. Again, I'm Jim Carlson. I'm Port
- 9 Richey Casino's attorney, and I'm here representing them as a
- 10 party in interest. I have, I think, just one clarifying question.
- 11 BY MR. CARLSON:
- 12 Q. The lady you helped from the rocky path -- I'm not sure --
- 13 from the rocky path --
- 14 A. Well, it was a -- what they had was like a hill.
- 15 Q. Okay.
- 16 A. And it was rocky, and right next to it there was a flight of
- 17 | stairs. But I -- there was a, like there was -- I don't even know
- 18 | what they call, but they had -- I was trying to like lean on it so
- 19 I could grab her weight more, just to try to help her come up, you
- 20 know, to where land was.
- 21 Q. Okay. You said that she was the woman that passed out or --
- 22 | I'm sorry -- that passed away later.
- 23 A. I believe so, yeah.
- 24 Q. Why do you believe that?
- 25 A. Because she -- because I was trying to help whoever I could

- 1 and I remember helping a lady that looked just like her coming up
- 2 | the stairs. Because she was one of the last people to try to come
- 3 up the stairs.
- 4 Q. So did she -- you saw a picture of the lady that passed away?
- 5 A. I -- well, I -- yeah.
- 6 Q. Well, I didn't know that her picture was in the news. I only
- 7 saw one small picture. But you believe that the woman you helped
- 8 was that lady based on what you saw in news accounts?
- 9 A. Well, I know that it's the lady that I had -- that passed.
- 10 0. What's that?
- 11 A. I know it was the lady that passed.
- 12 Q. You know it was the lady that passed. Okay. Okay. That's
- 13 all I wanted to know. Thank you.
- 14 BY CWO
- 15 Q. I just had one follow-up. You said your boyfriend was Tyler?
- 16 And have you guys talked? Have you heard anything where you think
- 17 | maybe the fire came from? Any theories?
- 18 A. No, we kind of try to keep work and home life kind of
- 19 separate from one another. And that day, he was just so, you
- 20 know, doing -- helping and trying to figure out what was going on,
- 21 | that I just kind of just stayed to myself and let him do whatever
- 22 | he had to do and try to help whoever I could.
- 23 CWO Okay. Thanks for your time.
- MS. IRVIN: Thank you, guys.
