

2	CWO and this is He's also with the
3	U.S. Coast Guard. And we're going to ask you a couple questions
4	today regarding the vessel fire. We're going to tape record this
5	so we don't have to write everything down and we can listen to
6	your answers. Okay?
7	INTERVIEW OF DEBRA BLOOM
8	BY CWO
9	Q. Do you still live at ?
10	A. No. I'm on
12	Q. Okay. So to start off with, can you give me your background,
13	your educational background, and your work background?
14	A. Graduated from Bible Baptist Christian Academy in Shady
15	Hills. No criminal background. Work-wise, I used to work for the
16	casino boat a million years ago, and been back like 2 years. And
17	then I did a little bit of everything, tile, worked for the mall.
18	Everything's always been administrative, accounting.
19	Q. Okay. And your position at SunCruz?
20	A. Cashier.
21	Q. Cashier.
22	A. And bar manager.
23	Q. Okay. And how long have you worked for SunCruz?
24	A. I have been back pushing 2 years now, I think.
25	Q. Approximately 2 years?

2 Q. And always as a bartender cashier?

3 A. Always as a cashier.

4 Q. Okay, cashier. And so your previous employment with SunCruz,5 how long was that for?

A. Well, I did quite a few years. I don't know. It was a long
time -- I was gone for about 8½ years. I had medical problems so
I stayed shore side.

9 Q. Okay.

10 A. Just did local employment.

11 Q. Okay. So can you walk me through -- it was January 14th, 12 your workday?

Okay. I left the dock approximately 3:30. I was sitting 13 Α. 14 downstairs with a fellow cashier, Alesa, and noticed a little more 15 -- we get the white smoke off the back of the boat, which is It's the diesel, I quess. And I was getting ready to go 16 normal. 17 outside and smoke a cigarette, and we both kind of noticed it was 18 smoking a little bit more than it normally does, white smoke 19 though.

20 Q. Were you -- sorry to interrupt, but -- so were you in the 21 transom area?

22 A. We were -- so on that side of the boat.

23 Q. So on the port side?

24 A. Um-hum.

25 Q. Inside the vessel, though? You were within --

1 A. I was inside.

Q. Okay, great. So that would be -- do you have a name for this space? I keep calling it the passenger --

4 A. It is. It's the passenger area.

- 5 Q. Okay.
- 6 A. It's where all the passengers sit.
- 7 Q. All right. So from there you could see the engine exhaust?8 A. Yes. On the outside of the boat.

9 Q. Could you tell if it was coming from the right side or

10 starboard side of the boat or the left side, port side?

11 A. It -- no, you couldn't tell. It wasn't coming inside. It

12 was just -- it was coming out the outside while I was smoking.

13 Smoking a little bit more than it normally did. So at that point 14 Alesa and I went upstairs to go smoke, and we had seen -- we told 15 Captain Mike, you know, it's smoking a little bit more, and he

16 said it looks like the engine's overheating.

17 So he was turning at that point, because I think he already 18 knew what was going on with the engine overheating because the 19 bell was going off in the bridge.

20 Q. So you could hear an alarm on the bridge?

- 21 A. Yes.
- 22 Q. Okay.
- 23 A. And then we both stepped out.
- 24 Q. What did Captain Mike do at that point?
- 25 A. Captain Mike made the turn. He automatically just turned

1	back around. We were just past the stilt house on the left with
2	the red, white and blue American flag on it. And he proceeded to
3	start heading back towards the dock. And then he went downstairs
4	to check something. He had to maintain the course after he made
5	the turn. He just said stay on this, and then he went downstairs.
6	And then he came back up.
7	Q. Who did he have maintain
8	A. Alesa.
9	Q. Okay.
10	A. She just stood at the wheel and just held it where he had it
11	pointed.
12	Q. Were you in the pilothouse at this time?
13	A. No, I was standing on the outside smoking.
14	Q. Okay.
15	A. And then he came back up and he said that it looked like it
16	was overheating so we were going to head back to the dock. And he
17	said to go get one of the deckhands. So I went downstairs and got
18	one of the deckhands, and at that point he went ahead and had
19	everybody evacuate to the top deck.
20	And he asked me to go check on the deckhands, because they
21	had the fire extinguishers just in case because I think I
22	wasn't there for like that conversation, but he just said, you
23	know, go relay a message, any one of the deckhands up here. So I
24	went down and said, hey, Captain Mike needs you upstairs. And I,
25	at that point, since all the customers were up top, I went out and

1	cleared the bathrooms to make sure nobody was in the bathrooms.	
2	Q. Um-hum. Can you	
3	A. The bathrooms are right here.	
4	Q. Okay. That's what I suspected. Okay. Could you see	
5	anything when you cleared the bathrooms?	
6	A. No.	
7	Q. No?	
8	A. Nothing.	
9	Q. Smoke was the same?	
10	A. Smoke, yeah, and it was still white smoke, and then it just,	
11	within a matter of moments, you know, it went black smoke.	
12	Q. I'm curious, do you know where the smoke was coming from?	
13	Was it still coming from the exhaust ports or	
14	A. At this point	
15	Q could it have been coming from the vent?	
16	A it was on the side. At that point the black because	
17	the black smoke never I didn't see it on the left side.	
18	Q. Um-hum.	
19	A. The white smoke was coming out outside more. You know,	
20	that's how I had noticed it. But when it went from white to	
21	black, it was coming out this side.	
22	Q. This vent right here?	
23	A. Um-hum.	
24	Q. Okay. So that's the starboard side, looks like engine room	
25	vent? Okay.	

A. And then, you know, from the time that I cleared the two
 bathrooms and went back up the stairs, the flames were shooting up
 on this side.

4 Q. Oh, wow.

5 A. So, and everybody was being exited to the front of the vessel6 from the left side.

7 Q. Okay.

8 A. So I couldn't get through there, so I went this way into the
9 bridge and across, because at that point they were already
10 starting to evacuate.

11 Q. Jump overboard?

12 They were starting to bring them down to -- the front of the Α. 13 boat has a staircase or steps, and they were bringing them down to 14 the front to start the evacuation. So from there, when I cut 15 across, they already had majority of them off and the only people 16 that were up top -- Captain Mike was coming back up from down, 17 because he was unloading passengers. John Crowe, and two young 18 boys, two young passengers, they were going down the stairs. And 19 I lost track of John Crowe at that point because I was on the 20 first to second step when I felt the heat from the glass behind 21 So I just kind of -- I jumped over the railing onto the bob me. 2.2 And then from there I exited off that left passenger and tack. 23 side because it was open.

24 Q. At the transfer port?

25 A. Um-hum.

1	Q. Okay. So you were on the upper deck, the open deck.
2	A. Um-hum.
3	Q. And then you, like, climbed over the rail and then jumped
4	down to the main deck?
5	A. The arm railing that you would hang onto to go down the
6	steps
7	Q. Yes?
8	A I was stepping onto the second step and I just jumped over
9	the arm rail.
10	Q. So you like hopped it?
11	A. Yeah, I hopped it.
12	Q. Okay. Do you remember who went in front of you into the
13	water or who was behind you? Do you recall an order?
14	A. I know they were exiting I know Izzy went off the side,
15	the left side that I jumped off of. I believe John Crowe came
16	from above. I assisted a customer into the water by kicking him
17	into the water, because he was in the left door space and he
18	wasn't jumping.
19	Q. He wouldn't move?
20	A. He wouldn't move. So I kind of kicked him into the water and
21	I jumped over him. I was the last person off that left side.
22	Q. Okay.
23	A. He kind of went off at the same time. So
24	Q. How deep was the water?
25	A. Waist deep.

1	Q. Waist deep, okay. Did you suffer any injuries or
2	A. Minor bruises.
3	Q. Did you ever hear instructions from the crew on what was
4	going on or
5	A. Just that they were they had everybody in a single line to
6	exit them off the front, and it was they were very organized,
7	which was awesome, you know. Very organized, keeping everybody
8	calm. They talked them through everything. They were lowering
9	people down, you know. I know one of the deckhands got in the
10	water and they were lowering down literally to him, and then
11	that's how they were they had a really good system and reeled
12	them down from either the left or from that front side.
13	Q. Okay.
14	A. Because the flames were coming from the right side, more so.
15	Q. Okay. So I'm going to shift a little bit. So what are your
16	duties and responsibilities on the Tropic Breeze?
17	A. Open and close, balancing, cashiering. Just all money and
18	numbers and slot checking. I work on machines.
19	Q. Oh, you work on machines too? Okay. In the event of
20	emergency, what would you do?
21	A. I always clear bathrooms. It's always to assist from the
22	cashier space to help clear all the way out to wherever they've
23	been instructed to depart the vessel.
24	Q. That's an important job, though, clearing bathrooms and
25	making sure the guests know where to go.

- 2 Q. And training, did you have firefighting or abandon ship 3 training?
- 4 A. No. I have -- I scuba drive, so I've been through CPR
 5 certification and rescue diving. So --
- 6 Q. Do you recall the last drill that you performed that you were 7 a part of?
- 8 A. No.
- 9 Q. Okay. In the 2 years, do you ever recall a drill?
- 10 A. I know the deckhands do them, but the cashiers I haven't.
- 11 But it's in my protocol to check bathrooms.
- 12 Q. And do you wear a uniform?
- 13 A. I do.
- 14 Q. Can you describe it?
- 15 A. I wear black pants, black socks -- well, sometimes black
- 16 socks -- black shoes and a black button-up shirt.
- 17 Q. Okay. Did you ever take any photos or videos that day?
- 18 A. No.
- 19 Q. None? Okay.

In your experience have you ever gotten on either the *Tropic* Breeze or the Island Lady and started to make a trip out and then had to turn around due to a casualty or --

- A. I know we had something stuck in the propellers once and wehad to --
- 25 Q. Were you on board for that?

- 1 A. Um-hum.
- 2 Q. Do you recall when that was?
- 3 A. Three weeks, 2 weeks -- 2, 3 weeks ago. A scuba diver went
- 4 in, got something out and we were back on the water by 7.
- 5 Q. Do you recall who the captain of the boat was?
- 6 A. I want to say it was Captain Willie.
- 7 Q. Captain Willie? And do you recall what boat it was?
- 8 A. Yes, it was the *Tropical Breeze*.
- 9 Q. Okay.

- CWO You got something,

- 12 Q. When was the first time you saw the smoke?
- 13 A. I wouldn't know time. I would just know like where we were 14 at.

- 15 Q. Whereabouts?
- 16 A. Probably right around -- it was past Durney Key. So between
 17 Durney Key and the stilt house.
- 18 Q. When you first saw it, what color was it?
- 19 A. White.

20 Q. Do you know where the engine room is located on the vessel?21 A. Below.

- Q. I have to phrase that question better. That's the second time that I got that answer. Let me ask this. Have you been inside of the engine room?
- 24 Inside of the engine roo
- 25 A. No.

1	Q. Do you know how to get in there?
2	A. I know how they would get in there, but
3	Q. Have you ever seen anybody going in there?
4	A. I've seen the captain and I have seen deckhands.
5	Q. On the day of the accident did you see anybody going into the
6	engine room?
7	A. I saw two deckhands. One was getting ready to go into it.
8	Q. Do you remember their names?
9	A. I think Shawn was standing near there and Tyler was in there.
10	He wasn't in the it didn't look like he was going down, but I
11	think Jon was going down there. He had the fire extinguisher in
12	his hand.
13	Q. You mean Shawn?
14	A. Jon, J-o-n. He was tying a bandana around his mouth. But
15	nobody was actually in it yet.
16	Q. Were you injured?
17	A. Just bumps and bruises from departing the vessel or dragging
18	Harold, one of the other just bruises on the left side.
19	Q. So one point you said Mike Captain Mike said the vessel
20	was overheating and told you to get a deckhand. Do you remember
21	which deckhand you got?
22	A. No. No, I just they were standing together so I just said
23	Captain Mike needs one of you upstairs.
24	Q. When you got underway on the vessel was there any
25	announcements about to any of the passengers or anything?

1	
1	A. They do a departure announcement: Welcome to the Island
2	Lady, and it explains where life jackets are located and the
3	lockers and I should have it memorized, but
4	Q. Is that recorded or
5	A. No. They announce it every single time.
6	Q. Do you know who made the announcement?
7	A. One of the deckhands.
8	MR. Mr. Carlson, do you have any questions, sir?
9	MR. CARLSON: I'm Jim Carlson. I'm Port Richey Casino's
10	attorney, and they're a party in interest, so that's why I'm here
11	to assist in the investigation. But no, I do not have any
12	questions. Thank you.
13	CWO Thanks for your time. Appreciate it.
14	MR. Thank you.
15	MS. OTTINGER: Yeah.
16	(Whereupon, the interview was concluded.)
