- 3 MR. LARUE: Okay, good morning. It is about 11:30 on
- 4 Friday, July 9th. This is Liam LaRue from the NTSB, and we're
- 5 here today to interview one of the passengers from the DUKW. Her
- 6 name is -- could you say your name?
- 7 MS. HORVATH: Reka Horvath.
- 8 MR. LARUE: Okay, Reka Horvath. And then I'm just going
- 9 to have everybody go around the table and introduce themselves, so
- 10 we have it on the record, starting to my right.
- MR. BLUMENTHAL: Greg Blumenthal from Ride the Ducks.
- 12 MR. LAWRENCE: Captain John Lawrence from K-Sea
- 13 Transportation.
- 14 CWO LAWS: Chief Warrant Officer Shane Laws with the
- 15 Coast Guard in Philadelphia.
- 16 LCDR FINE: Lieutenant Commander Matt Fine, Coast Guard.
- 17 MS. JANOWITZ: Susan Janowitz to help translate.
- MS. KONYA: Adrienn Konya.
- MR. HOLCHAP: Tom K. Holchap (ph.) for the Red Cross.
- MR. LARUE: Okay, great.
- 21 INTERVIEW OF REKA HORVATH
- 22 (Whereupon, Ms. Horvath answered assisted by an
- 23 interpreter.)
- 24 BY MR. LARUE:
- Q. First question is how old are you?

- 1 A. I'm sixteen.
- Q. Sixteen years old, great. And so, we know that you were
- 3 on the boat on Wednesday. What I'd like you to do is just walk us
- 4 through what happened once you got on the boat and once the boat
- 5 entered the water and -- as best as you can remember, and then
- 6 I'll follow up with some questions after that.
- 7 A. So, when we were still on the land, we felt that there
- 8 was hot air coming out of the boat. That was strange. And when
- 9 we got into the water, first everything was okay, and then we
- 10 turned, and we saw the smoke, and we stopped. And the other
- 11 captain or I don't know who went to the nose of the boat, and he
- 12 brought him a life jacket, and I don't know why he did that.
- The captain was talking on the radio, but I didn't hear
- 14 exactly what he said. And first we thought it just a joke. And
- 15 we were just sitting and waiting for another ship. And another
- 16 DUKW boat came next to us, and they said nothing, but I thought
- 17 they had to see the big barge.
- 18 Then the time passed, and I just remember the captain
- 19 said whoa, whoa, whoa, and I looked back, and I saw that the barge
- 20 is coming and then crashed. And I tried to take a life jacket,
- 21 but I couldn't, and then the water came, and I don't know. Yeah,
- 22 I took a deep breath, and I opened my eyes and I saw nothing. I
- 23 just tried to swim to the surface. And yeah, I don't remember
- 24 exactly what happened. And I got to the surface, and I got a life
- 25 jacket from a guy, and then I tried to swim as fast as I can

- 1 because I saw another ship, and I thought it's not far.
- Q. How did you get to shore? How did you get onto land?
- 3 A. I swam to a DUKW and three men were there, and they
- 4 helped us.
- 5 Q. Okay, that's great. Thank you very much. I'm just
- 6 going to go back with a couple more specific questions. Did --
- 7 when you got on the boat, did the --
- 8 A. I'm sorry, sir. I forgot that the younger captain
- 9 jumped into the water, and I just realized that, hey, he is in the
- 10 water and -- yeah.
- 11 UNIDENTIFIED SPEAKER: That was before the barge hit --
- MS. HORVATH: Yeah.
- 13 UNIDENTIFIED SPEAKER: -- you saw him jump in?
- MS. HORVATH: Yeah. And we just read that someone said
- 15 that she heard that this captain said we have to jump, but I
- 16 didn't hear anything.
- 17 BY MR. LARUE:
- 18 Q. I've got a seating chart, so that's the front of the
- 19 boat, the back of the boat. Do you remember where you were
- 20 sitting?
- 21 A. Here.
- Q. This seat right here?
- 23 A. Yeah.
- 24 Q. Okay. So, she indicated number 5, which is on the
- 25 starboard side. Who was sitting next to you?

- 1 A. She was.
- 2 MR. LARUE: And what was your name again?
- 3 MS. KONYA: Adrienn.
- 4 MR. LARUE: Adrienn, okay, and we'll be talking to you
- 5 next, so --
- 6 BY MR. LARUE:
- 7 Q. Were you on the outside seat or the inside seat?
- 8 A. Inside seat.
- 9 Q. You were on the inside. Okay, great. So, you were
- 10 pretty close to the front?
- 11 A. Um-hum.
- 12 Q. And I know it's difficult to remember, but do you
- 13 remember anything that the captain was saying when he was talking
- 14 on the radio?
- 15 A. Maybe he said we need help, but I don't know exactly
- 16 what he said.
- Q. Okay, was he talking on the radio just before the barge
- 18 hit you?
- 19 A. He talked and then after 10 minutes, he just said whoa,
- 20 whoa.
- Q. Do you remember if there were any like a horn or a sound
- 22 like from the boat?
- 23 A. No.
- Q. Okay. Did anyone tell you to grab a life jacket?
- 25 A. No.

- 1 Q. No, okay. And so, you didn't get a life jacket until
- 2 after you came up?
- 3 A. Yeah.
- 4 Q. Okay. Did you have any injuries?
- 5 A. No.
- 6 Q. No. Okay, good. Can you swim?
- 7 A. Yes.
- 8 Q. Okay. Do you remember did you get a chance to look at
- 9 the barge as it was coming at you?
- 10 A. Um-hum.
- 11 Q. Do you remember the tug alongside, the tugboat?
- 12 A. Yeah.
- Q. Did you see -- did you happen to see anybody on the tug?
- 14 A. Uh-uh.
- Q. Okay. And do you remember anything that the other DUKW
- 16 said when they came next to you?
- 17 A. Uh-uh.
- 18 Q. No, okay. That's the basic questions I had. We'll just
- 19 go around. We'll start next with you, Greg.
- BY MR. BLUMENTHAL:
- Q. How long do you think you were at anchor, how many
- 22 minutes after anchor?
- 23 A. Right after the water -- when it stopped?
- Q. When they put the anchor down.
- 25 A. Ten or 15.

- 1 Q. Do they -- did it feel like they were in a stable
- 2 position? Did the anchor keep them anchored in one spot?
- 3 A. Yes, but because there was --
- 4 (Through interpreter) There was a current.
- 5 Q. Right, right. So, the boat got pulled into the flow of
- 6 the water but then stayed in that position? That's a question.
- 7 A. Around the point it did sway.
- Q. Okay. And in that, do you remember if the captain used
- 9 the radio before or after anchoring, or both, the emergency radio?
- 10 A. Just after.
- 11 (In English) But I'm not sure.
- 12 Q. Do you recall maybe how many times she saw him try to
- 13 use that radio? Was it more than once?
- 14 A. I don't --
- 15 Q. Okay, okay. I don't have any other questions.
- 16 MR. LARUE: Just identify yourselves for the tape.
- 17 BY LCDR FINE:
- 18 O. Matt Fine with the Coast Guard. You said at the
- 19 beginning you saw -- when the boat first stopped, you saw the
- 20 captain get a life jacket? So, he went and got one for himself?
- 21 A. All of the life jackets are orange, but his was blue.
- Q. Okay. Now, he put it on?
- 23 A. No, he put it --
- 24 (Through interpreter) Put it on a mirror on the boat.
- Q. Right next to him though? So, he put it next to him?

- 1 A. (In English) Yeah.
- 2 Q. And then did you see him use his cell phone or just the
- 3 radio?
- 4 MS. KONYA: Yes.
- 5 MS. HORVATH: She said yes, but I don't remember.
- 6 BY LCDR FINE:
- 7 Q. No, that's okay. There's no right answer. There's no
- 8 right answer.
- 9 A. Oh, sorry.
- 10 Q. This is the last question. Was -- when it hit the boat,
- 11 do you remember what it did to the boat? So, did the front of the
- 12 boat go up? Did the front of the boat go down? Do you remember?
- 13 A. I thought the boat turned like this, but everyone said
- 14 it's turned like to its left side.
- 15 Q. Okay. But it didn't feel like it went straight up in
- 16 the air?
- 17 A. No. No, no, no.
- 18 Q. Okay.
- 19 BY CWO LAWS:
- Q. Shane Laws for the Coast Guard. When you first got on
- 21 the boat, do you remember a point, did the master ever explain
- 22 where the life jackets were, how you get them, how you put them
- 23 on?
- A. He just pick one from the floor, and he was smiling, and
- 25 so it was not --

- 1 (Through interpreter) It wasn't an exact instruction on
- 2 how to use it.
- 3 Q. Okay.
- 4 BY LCDR FINE:
- 5 Q. Matt Fine from the Coast Guard. When you said you
- 6 couldn't reach it, was it because it was too high, was it stuck?
- 7 INTERPRETER: She was able to reach it, but there was a
- 8 snap that was too hard to open.
- 9 LCDR FINE: Thank you.
- 10 MR. LARUE: Did you have any more questions, Shane?
- MR. LAWRENCE: John Lawrence, K-Sea. You've answered my
- 12 questions. That was very good.
- 13 BY MR. LARUE:
- Q. Okay. Just two more little things I remembered. This
- 15 is Liam from NTSB. You said before you went in the water, you
- 16 felt hot air?
- 17 A. (In English) Yeah.
- 18 Q. Where was the hot air coming from, and could you just
- 19 describe --
- 20 A. From the motor -- from the nose.
- 21 Q. Okay. Did the captain say anything about it, or --
- 22 A. No.
- Q. And then how long after you were in the water, how long
- 24 was it until you saw smoke?
- A. I don't know.

- 1 Q. That's fine. That's fine. So, just a last question
- 2 from me, did you -- what made you reach for the life jacket?
- 3 A. Because I just thought it's safer if I got one.
- 4 Q. Sure. Well, was it because you turned around and saw
- 5 the barge, or did somebody yell grab a life jacket, or --
- 6 A. Both.
- 7 Q. Both? Okay. No, that's great.
- 8 MR. LARUE: Did you have --
- 9 UNIDENTIFIED SPEAKER: No.
- 10 CWO LAWS: Actually, (indiscernible) about this smoke.
- 11 BY CWO LAWS:
- 12 Q. Shane Laws with the Coast Guard. When he turned the
- 13 boat off, when he stopped the boat, did the smoke go away right
- 14 away?
- 15 A. The smoke came from this end. We all smelled it. So,
- 16 it came through the boat.
- MR. LARUE: So she's -- for the record, she's pointing
- 18 at the front of the boat, and it went back.
- MS. HORVATH: Um-hum.
- MR. LARUE: Okay.
- 21 BY CWO LAWS:
- Q. Did you see smoke coming from anywhere other than the
- 23 front of the boat?
- 24 A. No.
- 25 Q. What color was the smoke? Do you remember that?

- 1 A. Gray or white.
- Q. Gray or white. Not black?
- 3 A. No.
- 4 MR. LARUE: Great. Well --
- 5 UNIDENTIFIED SPEAKER: Can I ask one question?
- 6 MR. LARUE: Sure.
- 7 UNIDENTIFIED SPEAKER: How tall are you?
- 8 MS. HORVATH: 163 or 5.
- 9 BY MR. LARUE:
- 10 Q. Do you have anything that you can think of that you
- 11 think that we didn't ask you about that might be useful for us to
- 12 know?
- 13 A. No.
- 14 Q. I do have one other question, actually. This is Liam
- 15 still. It might be a difficult question, but do you know where
- 16 your two friends were sitting that were missing?
- 17 A. Yeah. Yeah. Before us.
- 18 Q. They were sitting in front of you? But were they
- 19 sitting together?
- A. Um-hum.
- Q. And so they were in seat 3? Okay.
- Did anybody have time to move or try to do anything when
- 23 the boat hit?
- A. I don't know, because I just stood up, and everybody
- 25 was -- I think everybody stood up and --

- Q. Okay.

 A. What I last see, that was Dora, Dora's face. I saw it and she just looked back and she was screaming, and that was the
- 5 Q. So, they were definitely both sitting right in front of
- 6 you? Okay.

last I remember.

- 7 All right, that's great. I don't have any other
- 8 questions. So, thank you very much for talking to us today. And
- 9 then just, could you just say for the record that you know that we
- 10 were -- you're okay with us recording?
- 11 A. Yeah.
- 12 Q. Okay, thank you.
- 13 (Whereupon, at 11:47 a.m., the interview was concluded.)
