## 1 INTERVIEW

- (11:51 a.m.)
- 3 MR. LARUE: Okay. Good morning. It's 11:51 on Friday,
- 4 July 9th. This is Liam LaRue from NTSB. I'm here with the same
- 5 group. We won't go around the table again. We're just missing
- 6 Greg from the Ducks, but he'll be back in a minute.
- 7 INTERVIEW OF ADRIENN KONYA
- 8 (Whereupon, Ms. Konya answered assisted by an
- 9 interpreter.)
- 10 BY MR. LARUE:
- 11 Q. And we're going to talk to Adrienn Konya. Is that said
- 12 correctly?
- 13 A. Yes.
- Q. Okay, great. And we'll just start with how old are you
- 15 again?
- 16 A. Sixteen.
- 17 Q. Sixteen. Okay, great.
- 18 Okay. And so, the same as the last interview, we'll
- 19 just go through, and if you could just tell us the story from --
- 20 you know, start with when you got on the boat and tell us what
- 21 happened as best as you can remember.
- 22 A. And then we were on the boat and the motor was smoking
- 23 and we stopped. And the man, the captain, was funny and kidding
- 24 all the time, so we just think it is a joke. And then he was
- 25 talking on radio, and I didn't understand what he said. Somebody

- 1 said to me that the barge coming, and I couldn't look back,
- 2 because I'm afraid that it's too close for us. And then the
- 3 captain said, "whoa, whoa, it's coming." And he was talking on
- 4 the radio, "stop the barge, stop the barge." And I looked back
- 5 and I saw the barge, which was so big, and I was screaming that
- 6 "Oh, my God." So, yeah, and then --
- 7 (Through interpreter) -- it pushed us.
- 8 (In English) Yeah. And I don't remember what happened
- 9 then. I was under the water. And --
- 10 INTERPRETER: Somebody grabbed her foot and pulled her
- 11 down. She doesn't know who. Then she came up from under the
- 12 water.
- MS. KONYA: (In English) And they reach out for me, and
- 14 he said -- he gave me a life jacket. And he said that go, swim.
- 15 And I'm just swimming. Two men help me. And that's all I
- 16 remember.
- 17 BY MR. LARUE:
- 18 Q. Okay. Who helped you and gave you the life jacket? Did
- 19 you say it was a name?
- 20 A. David.
- 21 Q. David. Is he another member --
- 22 A. Yeah, my friend.
- Q. Okay. So, he gave you a life jacket?
- 24 A. Yeah.
- 25 Q. And did you swim to shore? How did you get onto land?

- 1 A. (Through interpreter) Swam out.
- 2 BY MR. LARUE:
- 3 Q. Okay. And then so you climbed out yourself?
- 4 INTERPRETER: They put something down in the water for
- 5 her to grab onto and pulled her out.
- 6 BY MR. LARUE:
- 7 Q. Okay. Did you hear any horn or anything on the boat?
- 8 Did the captain use a horn?
- 9 A. (In English) No.
- 10 Q. No horn? Okay. I just want to confirm again where you
- 11 were seated, where you were sitting.
- 12 A. Five.
- 13 Q. So, seat number 5? And you were sitting next to --
- 14 A. (indiscernible)
- Q. All right, great. Did anyone say that you should grab a
- 16 life jacket --
- 17 A. No.
- 18 O. -- before the boat hit?
- 19 A. No.
- Q. Okay. Did the captain give you any instructions at all
- 21 as the barge was coming towards you? Did he tell anybody to do
- 22 anything?
- 23 A. No.
- Q. He was just on the radio?
- 25 A. Yes.

- 1 Q. Okay. Before you left, did the captain talk about
- 2 safety and life jackets and things like that?
- A. (No audible response.)
- 4 Q. Do you remember what he said?
- 5 A. No.
- 6 Q. Okay. Did you have any injuries?
- 7 A. Yes, my arm.
- 8 Q. And what happened?
- 9 A. (Through interpreter) It got scratched.
- 10 Q. Okay.
- 11 A. (In English) And I don't know how.
- 12 Q. Did you go to a hospital?
- 13 A. Yeah.
- Q. Do you remember what hospital you went to?
- 15 INTERPRETER: Hahnemann?
- MS. KONYA: Yes.
- 17 BY MR. LARUE:
- 18 Q. How long did you stay there?
- 19 A. Maybe four hours, (indiscernible) maybe.
- 20 Q. Okay. So did you go in an ambulance or --
- 21 A. (No audible response.)
- 22 Q. Yeah? Can you swim?
- 23 A. Yeah.
- Q. Okay. Did you get a look at the tugboat that was
- 25 pushing the barge?

- 1 A. No.
- Q. No, not at all? And then how long from the time you
- 3 were anchored -- did you see the captain put the anchor down in
- 4 the water?
- 5 A. Yes, I saw.
- 6 Q. Okay.
- 7 A. Maybe 10, 10 minutes maybe.
- Q. Okay. And then what was everybody doing while you were
- 9 sitting there?
- 10 A. We were joking and sitting.
- 11 Q. Just talking amongst yourselves?
- 12 A. How Titanic feeling.
- Q. And there was another DUKW stopped by. Did you hear the
- 14 conversations between the two captains?
- 15 A. No. No.
- 16 Q. No? Okay. And then I just wanted to also confirm that
- 17 where you remember the two people that were missing where they
- 18 were sitting?
- 19 A. In 3.
- Q. Okay, so they were definitely in seat number 3. Okay.
- 21 That's the basic questions that I had, and then I'll pass it off
- 22 to Greg here on my right.
- BY MR. BLUMENTHAL:
- Q. So, when the DUKW went in the water, about how much time
- 25 passed before you stopped?

- 1 A. Half hour maybe. I don't know. Maybe half hour.
- Q. And when the smoke started, was there -- did you feel
- 3 more heat or just -- initially, you had described you felt heat
- 4 coming from in front of you?
- 5 A. Yes.
- 6 Q. It felt hotter to you or the same?
- 7 A. Hotter.
- 8 Q. Okay. And what color was the smoke? Do you recall?
- 9 A. Gray or white.
- 10 Q. Okay. Have you -- do you have a -- did it smell like
- 11 anything that you could describe?
- 12 A. (Through interpreter) Just smoke.
- MR. BLUMENTHAL: Okay.
- MR. LARUE: Okay. We'll go now next to --
- 15 BY MR. LAWRENCE:
- 16 Q. John Lawrence. Just to clarify one thing you said, you
- 17 heard the captain say "stop the barge, stop the barge." Was it on
- 18 a radio or on a telephone?
- 19 A. On the radio.
- Q. On the radio. (indiscernible) radio. Did you ever hear
- 21 any response or anything? Did he get any answer back on the radio
- 22 to him?
- A. No. That was (indiscernible).
- Q. Okay. That's all I have.
- BY MR. LAWS:

- 1 Q. Shane Laws with the Coast Guard. You mentioned earlier
- 2 that you didn't hear a horn or a bell or sound from the DUKW boat.
- 3 Did you hear a horn or anything like that from the towboat or the
- 4 barge?
- 5 A. No.
- Q. No. When the captain was using the radio, could you see
- 7 the radio?
- 8 A. Yes.
- 9 Q. Do you remember looking at the radio while he was doing
- 10 that?
- 11 A. Um-hum.
- 12 (Through interpreter) Came out of the boat. It was a
- 13 wired, like a microphone.
- 14 BY CWO LAWS:
- 15 Q. So, you could just see the microphone part?
- 16 A. (In English) Um-hum.
- 17 Q. You couldn't see the other part?
- 18 A. Um-hum.
- 19 Q. Okay. Thank you.
- BY MR. LARUE:
- Q. Back to Liam again. Just two more quick questions. Did
- 22 the crew make you move when the engine was smoking, or did you
- 23 just stay in your same seats the whole time?
- A. We stayed.
- Q. Okay. And then your friends that were in the seat in

- 1 front of you, was Dora on the outside or the inside?
- 2 A. Dora outside.
- 3 Q. Okay, great.
- 4 MR. LAWS: Shane Laws with the Coast Guard. Can I
- 5 clarify when you're saying outside or inside, aisle seat and
- 6 outboard seat?
- 7 MR. LARUE: Outboard/inboard, yeah.
- 8 BY MR. LAWS:
- 9 Q. I did have one little question. Did you try to get a
- 10 life jacket before you found yourself in the water?
- 11 A. No.
- 12 Q. You didn't try. Okay.
- 13 A. No.
- MR. LARUE: All right. Anybody else?
- 15 BY MR. LARUE:
- 16 Q. All right. Do you have anything else you can think of
- 17 that we didn't ask you that might be useful?
- 18 A. Uh-uh.
- 19 Q. Okay. Well, thank you very much for talking to us. And
- 20 is it okay that we recorded this?
- 21 A. Yes.
- Q. Okay, great. Thank you very much.
- 23 (Whereupon, at 12:03 p.m., the interview was concluded.)
