1 INTERVIEW

- (1:30 p.m.)
- 3 MR. LARUE: Okay, good afternoon. It is about 1:30 on
- 4 Friday, July 9th. This is Liam LaRue, and we're here today
- 5 talking with Krisztian Mike. Did I pronounce it correctly?
- 6 MR. MIKE: Yes.
- 7 MR. LARUE: Okay, and same crew as before, so we won't
- 8 go around.
- 9 INTERVIEW OF KRISZTIAN MIKE
- 10 (Whereupon, Mr. Mike answered assisted by an
- 11 interpreter.)
- 12 BY MR. LARUE:
- 13 Q. And how old are you?
- 14 A. Sixteen.
- 15 Q. Sixteen. And if you could, please, just walk us through
- 16 the boat ride and tell us what you remember, and then we'll follow
- 17 up with some questions.
- 18 A. Okay. Okay, the engine stopped, engine stopped, I
- 19 smelled something strange, and then we saw the smoke. And the
- 20 captain who was driving on the land and not on the river, but
- 21 because there was two captains, he stopped the boat and sat down,
- 22 and they, I don't know, made something on the nose of the boat.
- 23 And then we were waiting. He used the radio to spoke.
- Q. Was it a radio or a cell phone?
- 25 A. A radio, like a walkie-talkie.

- 1 Q. Okay, walkie-talkie.
- 2 A. Yeah.
- 3 Q. Okay, so continue.
- 4 A. I think first someone answered, but then we saw the
- 5 barge coming, and he put nervous begin to --
- 6 (Through interpreter) Okay, he spoke very excitedly,
- 7 yes. The captain spoke excitedly.
- 8 (In English) But when the barge was near, and no one
- 9 answered. And there was chaos.
- 10 (Through interpreter) There was chaos. There was chaos.
- 11 (In English) And younger captain jumped into the water.
- 12 I wanted to catch a life jacket. When I tried first, they
- 13 didn't --
- 14 (Through interpreter) Yeah, it wasn't successful when he
- 15 first tried.
- 16 (In English) My second time, I got one, and then the
- 17 barge hit us, and I turned back, and I saw that we are --
- 18 (Through interpreter) -- sinking.
- 19 (In English) Yeah, and the water was -- and I lost my
- 20 life jacket. I think that roof follow me, because my head hurts
- 21 on the boat, and, I don't know, somehow I fall in the water.
- 22 (Through interpreter) You got in the middle of a lot of
- 23 different boats.
- 24 (In English) Yeah, I wasn't able to get out of there.
- 25 And I just saw light, and the water. And there I found the life

- 1 jacket. I put it on my arm, and I began to swim to the dock.
- Q. How did you get to land? Did you climb out?
- 3 A. Someone gave his arm and told me --
- 4 Q. Someone on shore?
- 5 A. Yeah.
- 6 (Through interpreter) Oh, a pier, a pier.
- 7 (In English) From a pier.
- 8 Q. From a pier. Okay, great. When you got on the boat,
- 9 did the captain teach you how to use the life jackets and try to
- 10 get off the boat?
- 11 A. He just put on his head. And when the barge hit us, I
- 12 wasn't able to put on my head.
- Q. Okay, do you know how to put it on and secure it?
- 14 A. He showed how to --
- 15 (Through interpreter) -- how to open --
- 16 (In English) But we had no time. He didn't say we
- 17 should put on this jacket.
- 18 (Through interpreter) He didn't demonstrate how to
- 19 actually put it on.
- Q. Right. So, you saw smoke, and then the captain stopped
- 21 the engine?
- 22 A. (In English) Yes.
- Q. Did the smoke continue?
- A. No, it stopped by the time.
- 25 Q. Okay.

- 1 A. And then we --
- 2 (Through interpreter) -- he sounded the horn -- oh,
- 3 heavy, something was heavy.
- 4 (In English) That heavy --
- 5 Q. Anchor?
- 6 INTERPRETER: Oh, oh, yeah, yes.
- 7 BY MR. LARUE:
- 8 Q. Okay, so he dropped the anchor?
- 9 A. Yeah.
- 10 INTERPRETER: Sorry, I --
- MR. LARUE: No, no problem.
- 12 BY MR. LARUE:
- Okay, right here in front of you, we've got a picture of
- 14 the boat. So, this is the front of --
- 15 A. Yes.
- 16 Q. -- the front.
- 17 A. Yes, I was here. I was here by the window.
- 18 Q. You were seat 8, okay, on the window. And I think we'll
- 19 just get all of you to contribute to this, so we don't have to do
- 20 it three times. Let's see, seat 8 window, okay, who was sitting
- 21 next to you?
- 22 A. Gabor.
- MR. LARUE: How do you spell your name?
- MR. MIHALCSIK: Gabor, G-A-B-O-R.
- MR. LARUE: So, you were sitting seat 8 on the aisle?

- 1 MR. MIHALCSIK: On the 8, there is a -- yeah.
- MR. LARUE: Okay, all right. Where were you sitting?
- 3 MR. STROBL: In front of them.
- 4 MR. LARUE: In front of them?
- 5 MR. STROBL: Yeah.
- 6 MR. LARUE: And what was your name? What's your name?
- 7 MR. STROBL: David.
- 8 MR. LARUE: David?
- 9 MR. STROBL: Yeah.
- 10 MR. LARUE: David, so you were in front of them?
- 11 MR. STROBL: Yeah.
- MR. LARUE: So, you were in seat 6?
- MR. STROBL: Yeah.
- MR. LARUE: On the window?
- MR. STROBL: No, on the aisle.
- MR. LARUE: Okay. Who was sitting next to you?
- 17 MR. STROBL: Barbara.
- MR. LARUE: Barbara, 6 window.
- Okay, do you remember who else was nearby? So, you
- 20 were --
- 21 MR. STROBL: Then was Jackie's daughter, Laura.
- MR. LARUE: So, Laura was 10, window?
- MR. STROBL: Yeah.
- MR. LARUE: Okay, who was next to her?
- MR. MIHALCSIK: I think Amanda, but not sure -- a girl.

- 1 INTERPRETER: Amanda, but he's not sure.
- 2 BY MR. LARUE:
- 3 Q. All right, so Amanda 10 aisle, maybe. Okay, what about
- 4 on the other side? Do you remember? No?
- 5 A. Reka and Adrienn sat here.
- 6 Q. Okay, so who was on the aisle?
- 7 A. Adrienn was at the window.
- 8 Q. Five window, okay, Audrienn.
- 9 A. And there was Szaboles and Dora.
- 10 Q. The two missing?
- 11 A. Yeah.
- 12 Q. Okay, all right.
- 13 MR. MIHALCSIK: Dora was at the window.
- 14 BY MR. LARUE:
- 15 Q. Okay.
- 16 A. I think that these three seats there were Americans. We
- 17 don't know who they are.
- 18 Q. Okay. Americans in 1, 2, and 4?
- 19 A. Yeah.
- Q. Okay, great. Thank you for that. So, you said the
- 21 first time, you couldn't get the life jacket. Why couldn't you
- 22 get the life jacket?
- 23 A. I tried to pull the --
- 24 (Through interpreter) Yeah, he tried to pull it with the
- 25 belt.

- 1 MR. MIKE: Yeah.
- 2 INTERPRETER: Yes.
- 3 MR. MIKE: It was shut. Can I draw it?
- 4 BY MR. LARUE:
- 5 Q. Yeah. Here, draw it on this.
- 6 A. There were two life jackets on there, and that was a
- 7 belt.
- 8 Q. Okay, with a snap, like a --
- 9 A. Yeah, and I tried to --
- 10 Q. Oh, you pulled on that?
- 11 A. Pulled here down, but it didn't open, and then I tried
- 12 to do that.
- 13 Q. And then you pulled the snap the second time?
- 14 A. Yeah.
- Q. And that came open? Thanks. Okay, so the first time,
- 16 you pulled on the strap itself. The second time, you pulled on
- 17 the snap
- 18 A. Yeah.
- Q. And it came down? Okay, okay, what made you grab a life
- 20 jacket? Did someone tell you to, or --
- 21 A. No, no one did.
- Q. No one told you to?
- 23 A. No.
- Q. So, what was the reason?
- 25 A. That I saw that the barge was coming.

- 1 Q. Okay, was that the first time you saw the barge?
- 2 A. No, I saw it before, like when it was far.
- 3 Q. You saw it when it was farther away?
- 4 A. Yeah, but I thought that it was stopped.
- 5 Q. Yeah. And then you looked back and saw it again when it
- 6 close and grabbed the life jacket?
- 7 A. Yeah.
- 8 Q. Okay, did you have any injuries? Were you hurt?
- 9 A. Just on my head.
- 10 Q. Did you go to a hospital?
- 11 A. No, I realized that yesterday.
- 12 Q. Okay, can you swim?
- 13 A. Just a bit. If I swim too much, I become tired.
- Q. Me too. So, you -- so the life jacket you had came away
- 15 from you as you were -- as the boat hit you, but you found it on
- 16 the surface again?
- 17 A. I think it was another one.
- 18 O. A different one?
- 19 A. Yes.
- Q. How long from the time the boat stopped until the boat,
- 21 the barge, hit you?
- 22 A. Ten minutes.
- Q. Ten minutes. Did you stay in your seat the entire time?
- 24 Did you stay --
- 25 A. I mean, while we were stopping or when the barge came?

- 1 I was sitting, but when I saw the barge too close, I stood up
- 2 and --
- Q. Okay. And your friends that are missing, do you know if
- 4 they were able to swim, if they could swim well?
- 5 A. I think Szabolcs was able to, because he was sport.
- 6 Q. Um-hum. Athletic?
- 7 A. Um-hum, yeah.
- 8 Q. Okay, and don't know about Dora?
- 9 A. No, I think she's a good swimmer. I think, but she
- 10 never said.
- 11 Q. Okay, that's the questions I have. We'll start with
- 12 Greg and see if he has any.
- MR. BLUMENTHAL: Not any additional questions.
- MR. LARUE: Okay.
- MS. MIKE: Can I ask?
- MR. LARUE: You can ask.
- MS. MIKE: What about the specialist who will see the
- 18 tape in my camera?
- MR. LARUE: I haven't had a chance to call him yet. I'm
- 20 going to -- if we take a break, I want to get through everyone
- 21 quickly, so you guys can be finished, and then I'll make a call
- 22 after that, okay?
- MS. MIKE: Okay.
- 24 BY CWO LAWS:
- 25 Q. After your boat went into the water, you know, you drive

- 1 it on the land, and then you -- then he drove it into the water,
- 2 who was driving the boat when it was in the water?
- 3 A. The younger captain.
- 4 O. The whole time?
- 5 A. Yes. Just when we stopped, he climbed on the nose of
- 6 the boat.
- 7 Q. Okay. And what was the other -- before anything
- 8 happened, so what was the other captain doing?
- 9 A. He was --
- 10 (Through interpreter) He got up to --
- 11 (In English) He got up on the boat just when we were at
- 12 the (indiscernible).
- 13 (Through interpreter) Okay, okay. The other captain
- 14 came on the boat just as they were leaving.
- 15 BY CWO LAWS:
- 16 Q. But he didn't drive, the older captain didn't drive?
- 17 A. When we went in --
- 18 O. Went into the water?
- 19 A. Yeah, he was, and then the younger.
- Q. Oh, so he drove it into the water?
- 21 A. Yes.
- 22 Q. And then the other, the younger one, then he drove the
- 23 rest of the time?
- 24 A. Yes.
- 25 Q. Until the engine stopped, and then they switched again?

- 1 A. Yes.
- 2 Q. Okay.
- 3 A. And the older captain (indiscernible) him because he
- 4 wasn't really talented.
- 5 Q. Okay. By the way, Shane Laws for the Coast Guard,
- 6 sorry.
- 7 MR. LARUE: Oh, I thought you said that.
- 8 BY CWO LAWS:
- 9 Q. You said earlier that you had seen the barge far away
- 10 earlier. If you could picture where you were when you saw it,
- 11 were you looking backward when you saw it earlier far away?
- 12 A. It wasn't so far. I don't know. The others saw that.
- 13 Can you give me this one?
- 14 Q. Oh, sure.
- 15 A. This is the bridge.
- 16 (Uninterpreted discussion between Mr. Mike and the
- 17 interpreter.)
- 18 MR. MIKE: The others saw the barge, and I turned to
- 19 see.
- 20 INTERPRETER: He turned back to see. I guess the others
- 21 were saying a barge, and he turned back to see.
- MR. MIKE: Yes.
- 23 BY CWO LAWS:
- Q. I'm trying to be clear that -- I know you saw the barge
- 25 right before the barge hit. But you indicated that he had seen it

- 1 before that time later -- or earlier. How much earlier?
- 2 A. The engine was stopped when I saw that first.
- 3 Q. Oh, okay. So, five minutes?
- 4 A. Yeah, five -- no, less, less. Three or two. It came
- 5 very fast.
- 6 Q. Okay. But -- and so, we're talking -- when was the
- 7 first time you saw the barge?
- 8 A. I think two minutes before.
- 9 INTERPRETER: Less.
- 10 BY CWO LAWS:
- 11 O. Two minutes before it hit?
- 12 A. Or less.
- UNIDENTIFIED SPEAKER: That's what he was saying, yes.
- 14 CWO LAWS: I'm just trying to get a feel for where it
- 15 was when he saw it that first time. Was it off to one side of the
- 16 boat or another and what it looked like.
- 17 BY MR. LARUE:
- 18 Q. Was it straight behind? Was it over here? Was it over
- 19 here?
- 20 A. Here.
- 21 Q. Here. Okay. Pretty straight behind?
- 22 A. Straight behind, yeah.
- MR. LARUE: Is that what you were looking for?
- 24 CWO LAWS: Okay. Yeah, this is the first indication
- 25 that somebody saw it right -- other than right before it happened,

- 1 so I -- okay. Did you ask about any sound signals?
- 2 MR. LARUE: I don't know if I did.
- 3 BY CWO LAWS:
- 4 Q. Before the collision, did you hear your boat, the boat
- 5 you were on, did you hear it make a horn sound or bells or
- 6 whistle?
- 7 A. No, nothing.
- 8 Q. Nothing.
- 9 A. I -- it was my not correct to make, but it was very
- 10 quiet.
- 11 Q. The towboat and barge, did you hear them sound their
- 12 horns, make any horn sounds or bells or whistles?
- 13 A. No, no, nothing.
- Q. No, nothing, okay. You indicated, you said before you
- 15 went in the water that there was water in the DUKW, in your boat.
- 16 Had the boat -- was it tipping one way or another? Which way was
- 17 it tipping?
- 18 (Through interpreter) There was no water in the boat
- 19 before we jumped.
- Q. Okay, so I misunderstood. I'm sorry. Thank you.
- 21 That's all I have.
- 22 BY MR. LARUE:
- Q. Did you say you -- this is Liam LaRue from NTSB -- did
- 24 you say you actually jumped, or you -- it just --
- 25 A. I don't remember really. I think I fall with the boat

1 in the water. 2 Q. Okay, okay. 3 Matt, did you have any questions? MR. LARUE: 4 LCDR FINE: No. 5 BY MR. LARUE: 6 Q. So, do you have anything else that you can think of that 7 we didn't ask you about that might be important for us to know? 8 You already mentioned you got videos, and hopefully we can get 9 that. 10 Yeah, I had a video. Α. 11 Q. Okay, is it okay that I recorded this? Is it okay with 12 you? 13 Α. Okay. 14 Q. Great. 15 (Whereupon, at 1:50 p.m., the interview was concluded.) 16 17 18 19 20 21 22 23
