- 3 MR. LARUE: All right, good morning. It's 11:23 on
- 4 Monday, July 12th. This is Liam LaRue from NTSB and we are here
- 5 today to speak to Lieutenant Andrew Napoli.
- 6 Could we just get you to spell your last name for us to
- 7 make sure --
- MR. NAPOLI: Sure. N-A-P, as in Paul, O-L-I.
- 9 MR. LARUE: Great.
- 10 And also here conducting interviews today?
- 11 MR. FINE: (Indiscernible) Commander Matt Fine, U.S.
- 12 Coast Guard.
- MR. LAWRENCE: And, Captain John Lawrence, K-Sea
- 14 Transportation.
- MR. FITZGIBBONS: John Fitzgibbons, Ride the Ducks.
- MR. LARUE: All right.
- 17 INTERVIEW OF ANDREW NAPOLI
- 18 BY MR. LARUE:
- 19 Q. And, Andy, what's your current position here?
- 20 A. Lieutenant.
- 21 Q. All right. How long have you been working for the
- 22 Marine Police?
- 23 A. Five and a half years.
- Q. Five and a half years. All right. And if you could --
- 25 I understand you took part in the rescue on -- after the DUKW

- 1 collision?
- 2 A. Yes.
- 3 Q. If you could just walk us through --
- 4 A. Sure.
- 5 Q. -- the whole scenario please?
- A. At around 2:45 p.m., we were notified initially by
- 7 Monica Santorum (ph.) from the Penn -- or the Delaware River
- 8 Waterfront Corporation now -- that a DUKW boat had been hit and
- 9 there were people in the water. Immediately after that, we also
- 10 were notified by our -- by police radio, and we also heard the
- 11 Coast Guard's SAR alarm go off. Myself, along with Police Officer
- 12 Costello, Kuback (ph.), and Curley (ph.), immediately responded,
- 13 using Boat Numbers 1 and 3, and proceeded to Penn's Landing, where
- 14 we observed the RiverLink Ferry, and then just past the RiverLink
- 15 Ferry, or behind them, we noticed numerous people in the water
- 16 both with and without life vests.
- 17 Q. Okay.
- 18 A. All right. At that point, we proceeded to pull out as
- 19 many people as we could and, at the same time, we then noticed
- 20 that the Navy had responded with a small boat, inflatable boat,
- 21 and assisted in the rescue efforts. At some point after we got
- 22 everybody out of the water that we could visually see, we took
- 23 them to shore and offloaded them at the RiverLink Ferry's dock.
- 24 So in -- with -- I had a conversation with the DUKW boat
- 25 captain, trying to ascertain the amount of passengers that were

- 1 onboard and he, unfortunately, did not know the exact amount, so I
- 2 went on shore to get, to try to get -- facilitate a count of the
- 3 people that were pulled out of the water. That was done inside
- 4 the Seaport Museum. After obtaining that count and then getting
- 5 the count of people that were supposedly on the DUKW boat at the
- 6 time of the accident, at that time, there were four people still
- 7 missing. At a certain point later, we then narrowed it down to
- 8 two people that were missing.
- 9 So search operations continued and, at the same time,
- 10 location efforts were then started to try to find where the DUKW
- 11 boat was laying at the bottom of the river. And with the help of
- 12 several agencies, including the New Jersey State Police and the
- 13 Army Corp of Engineers, and along with our sonar, we located the,
- 14 what we believed to be the DUKW boat at the bottom of the river.
- 15 Q. Okay, got it.
- 16 A. Okay. So at, then at approximately -- I'm going to
- 17 guess and say it was approximately 5 p.m. -- we started diving
- 18 operations to positively identify the DUKW boats and to mark it
- 19 with a buoy for salvage efforts in the future, which we then did.
- 20 Q. I'm just going to step back through.
- 21 A. Okay, uh-huh.
- 22 Q. Let's see. You guys went out on Boats 1 and 3. What
- 23 boat were you on?
- A. I was on Boat 1.
- Q. Okay. And who was with you?

- 1 A. That would be Police Officer Rhuman (ph.).
- Q. Okay. And how long did it take you to get out to
- 3 this --
- A. Actually, Police Officer Runey (ph.) and Police Officer
- 5 Crowley (ph.). I'm sorry.
- 6 Q. Okay.
- 7 A. They're all --
- 8 Q. About how long did it take you to get there from here?
- 9 A. Less than three minutes.
- 10 Q. All right. And you said you saw the RiverLink Ferry and
- 11 what other response assets on the scene?
- 12 A. That's it.
- 13 Q. That's it?
- 14 A. That was all that was there.
- 15 Q. So you were number 2?
- 16 A. We were -- at (indiscernible), see we were number 1.
- 17 Q. Okay.
- 18 A. We were the only car that was there because that's where
- 19 they are.
- Q. And then it was you and then Boat 3 following behind, or
- 21 were you guys at the same time?
- 22 A. We were at the same time, yeah.
- Q. All right. And let's see. Do you remember how many
- 24 people you pulled out specifically?
- 25 A. I don't have an exact number. I'm going to say we

- 1 probably pulled on our boat, I'm going to say, a half a dozen
- 2 people, six, I believe, and they had probably around the same
- 3 number on Boat 3 --
- 4 Q. All right.
- 5 A. -- give or take.
- 6 Q. You don't remember any of them, you know --
- 7 A. Their names, no.
- 8 Q. -- males, females, anything like that?
- 9 A. Probably a mix of -- you know, half and half. There
- 10 were adults, as well as children.
- 11 Q. All right. You said you did get the DUKW?
- 12 A. We did get it, yes.
- 13 Q. You did?
- 14 A. The DUKW captain was on -- was recovered. He was picked
- 15 up on Boat 3.
- Q. Okay. And you talked to him?
- 17 A. Yes.
- 18 Q. Anything unusual about his demeanor or anything?
- 19 A. No, he was very upset, understandably.
- Q. Did he describe what had happened to you at all?
- 21 A. I don't even know if I asked at that point. We were so
- 22 concerned about just getting everybody, you know, accounted for --
- 23 Q. Uh-huh.
- 24 A. -- I quess. I did ask, I know I did ask -- as a matter
- 25 of fact, when we got everybody out of the, finally out of the

- 1 water and we were going back to dock, I asked him where his boat
- 2 was because at the time, I still didn't know what had happened. I
- 3 asked him where his boat was and he said it was at the bottom of
- 4 the river.
- 5 Q. Uh-huh. You said he wasn't sure what the total count
- 6 was for --
- 7 A. That's correct, yes.
- 8 Q. -- people on board?
- 9 A. Yes.
- 10 Q. And you said you finally got it when you got on shore.
- 11 How did you --
- 12 A. We finally got on shore. I think we sent somebody to --
- 13 because there were problems with communicating back with loading,
- 14 where they load DUKW boats. So we said -- actually, I believe
- 15 Monica Santorum volunteered to go to the DUKW boat loading area to
- 16 find out what the number of passengers and crew were.
- 17 Q. So that was where -- that's where you got the official
- 18 count?
- 19 A. Yeah.
- Q. Okay. I think that's pretty much all the questions I've
- 21 got.
- MR. LARUE: Do you have any questions?
- UNIDENTIFIED SPEAKER: I don't have any.
- MR. LARUE: No?
- UNIDENTIFIED SPEAKER: Nothing.

- 1 BY MR. LARUE:
- 2 Q. Anything else that you think might be important for us?
- 3 You know, we're just trying to document any of the --
- 4 A. No, sir. No.
- 5 Q. -- response things and --
- 6 A. No, I really can't -- no --
- 7 Q. It seems like you guys were the ones that pulled out the
- 8 most people, you and Boat 3.
- 9 A. Probably. We -- yeah, we were the -- we worked with our
- 10 two boats there. There were a number of people in the water, but
- 11 there were a lot of people already on land --
- 12 Q. Uh-huh.
- 13 A. -- that had already gotten out from various ways --
- 14 Q. All right.
- 15 A. -- various means.
- 16 BY LCDR FINE:
- 17 Q. The captain's mental state -- Matt Fine, Coast Guard.
- 18 The captain's mental state, was it --
- 19 A. He was very upset --
- 20 Q. Right.
- 21 A. -- I guess is the best way to describe it. Just, I
- 22 guess like just almost a state of shock.
- Q. All right.
- BY MR. LARUE:
- Q. All right. Well, appreciate you taking the time to talk

2	Α.	Absolutely.
