1 INTERVIEW

- 2 (1:09 p.m.)
- 3 MR. LARUE: Okay, good afternoon. It is about 1:09 in
- 4 the afternoon on Friday, July 9th. This is Liam LaRue from NTSB.
- 5 And we're going to be talking to Virag Bella.
- 6 INTERVIEW OF VIRAG BELLA
- 7 (Whereupon, Ms. Bella answered assisted by an
- 8 interpreter.)
- 9 BY MR. LARUE:
- 10 Q. And, Virag, how old are you?
- 11 A. Eighteen.
- 12 Q. Eighteen, okay. And just like with your friend, if you
- 13 could just walk us through the whole event and tell us anything
- 14 that you can remember that might be useful.
- 15 A. When we went on board, we took seat, and the captain
- 16 went along, and he introduced himself and said some fun thing.
- 17 And then he demonstrated his life jacket, and he showed how to use
- 18 it, but it wasn't correct because -- it just was my mind, I can
- 19 remember, that I didn't understood why he didn't have it on to
- 20 show us how to use it. Because he just had it in her [sic] hand
- 21 and said that here you have to put your head, and this is the
- 22 (indiscernible) that you have to -- I don't know what to do with
- 23 that. But he didn't get -- he didn't do it himself. And then we
- 24 were on dry land, and everything went all right.
- 25 And then we went on the -- into the river, and he asked

- 1 whether we want to have a big slash or -- splash or a small
- 2 splash, and we had a big splash. But it was all right. And then
- 3 we had a -- we made the circle, and then we were turning.
- 4 Immediately, we smelled the smoke and saw the smoke. It was -- I
- 5 think it was white or gray, white and gray, a big smoke. And the
- 6 captain was -- the older captain who drove on the --
- 7 (Through interpreter) -- on the dry land, who drove us.
- 8 (In English) Yes. He was sitting -- he was facing us,
- 9 and he was just telling stories. And the other captain, the
- 10 young, he was driving.
- And when they saw the smoke, they jumped up and stopped
- 12 the engine. And then the smoke wasn't there anymore after the
- 13 engine was stopped. And yeah, the young captain went outside the
- 14 boat, and I don't know what he did. I saw only his legs, I think.
- 15 And some of us said, oh, it's part of the show, because they were
- 16 both all funny and so, we didn't realize that it's serious. But
- 17 then we did, because there was another DUKW boat, and as far as I
- 18 can remember, but I'm not sure, I think they didn't pass us to
- 19 that, near us.
- 20 (Through interpreter) They weren't near.
- 21 (In English) But I think they --
- 22 (Through interpreter) They came a little bit closer when
- 23 they saw that something was not right.
- 24 (In English) Perhaps the captain shouted something. I
- 25 don't know. I don't know.

- 1 And I think at least five minutes passed then when we
- 2 saw the barge. But it was -- everything, everybody was pointing
- 3 to the barge, and that's why we turned, and we saw it. And I
- 4 think we had a minute until we were -- we collapsed, collided.
- 5 And in the first 10 seconds, everybody was shocked, and then I
- 6 heard somebody crying that we actually have to use the life
- 7 jackets. And everybody was standing up and jumping up. And I'm
- 8 not quite sure, but I think that it was either -- I don't know his
- 9 last name. He was with our group. He's in a -- she's an
- 10 American.
- 11 INTERPRETER: Barbara?
- 12 BY MR. LARUE:
- 13 O. Hohner?
- 14 A. (In English) No. No, she's the Hungarian teacher,
- 15 Anderson, Barbara Anderson. I think she was who had us to grab
- 16 the life jacket, because there was a belt. The life jackets were
- 17 on --
- 18 (Through interpreter) Above their heads.
- 19 (In English) And there was a belt holding it, and she
- 20 took the belt so that we could grab them. I was close to these
- 21 jackets, so I could grab one, and I just put it in my -- I put my
- 22 head on it, but I couldn't fasten it, fasten the badge, because I
- 23 didn't know how. And then in two minutes -- two seconds after --
- 24 in two seconds after I have put the life jacket on me, we
- 25 collided, and I don't know how many minutes I spend under surface,

- 1 but somehow I came out.
- 2 (Through interpreter) She got up above the water.
- 3 (In English) And I saw another life jacket floating next
- 4 to me, and I grabbed that too. And my bag was floating right next
- 5 to me, and I grabbed that as well. And should I -- so, I saw my
- 6 teacher Timea Mereticzki who was -- she was just --
- 7 (Through interpreter) -- came up from under the water
- 8 onto the surface.
- 9 (In English) And she reached -- so, she --
- 10 (Through interpreter) She reached towards her and told
- 11 her that she couldn't swim.
- 12 (In English) And then I pushed one of the life jackets
- 13 to her, towards her, but then Jackie Kennedy was right next to her
- 14 and grabbed her, and so she was already safe. And I was with that
- 15 group, with Jackie's group, for about three minutes, and then I
- 16 saw that some of us are swimming to the bank. And then I started
- 17 to swim as well with Laura Kennedy and her friend. And then we
- 18 managed to get on our --
- 19 (Through interpreter) And they got out onto the shore.
- Q. How did you get out?
- 21 A. There was a --
- 22 (Through interpreter) It was like a floating dock.
- 23 (In English) And there were some men who --
- 24 (Through interpreter) -- put a rope down, a thick rope.
- 25 (In English) And we grabbed them, and they had us --

- 1 (Through interpreter) They pulled them out.
- Q. Okay. Yeah, from where you were sitting, did you see
- 3 the captain talking on the radio?
- 4 A. (In English) Yes, I saw, but I don't know what -- but we
- 5 cannot move, and so -- but I saw he was talking on the radio.
- 6 Q. Could you hear anything?
- 7 A. Something I could hear, but I didn't pay so much
- 8 attention, because we were just -- we were a little bit worried by
- 9 the --
- 10 Q. Did you hear any other sounds from the -- from your
- 11 boat? Did they sound a horn or a bell or anything?
- 12 A. (No audible response.)
- Q. No? Did you hear anything from the tug?
- 14 A. No.
- 15 Q. Okay. And so, we already went through the seating last
- 16 time, so we don't need to go through that again. The only
- 17 question I was going to ask you, you said that Barbara Anderson
- 18 was the one that undid the snaps for all the life jackets?
- 19 A. As far as I can remember, yes, but I am not certain. I
- 20 think.
- Q. Was she sitting near you?
- 22 A. No, she was sitting -- I think, she was sitting in the
- 23 front of the boat, but she came.
- Q. Okay, came back.
- 25 A. And there was Jackie Kennedy as well who helped.

- 1 Q. Okay. When she undid the snaps, did the life jackets
- 2 fall down, or they were still up there?
- 3 A. No, still up.
- 4 Q. So, did you have to -- you had to pull it down?
- 5 A. Yeah.
- Q. Were there no problems pulling it down?
- 7 A. No.
- 8 Q. Okay. So, you got the life jacket over your head but
- 9 not strapped, but not secured?
- 10 A. Yes. So, I had it on my head, around my neck, but when
- 11 I came on surface, and I tried to -- not to hold it, it went.
- 12 (Through interpreter) She had to hold it, because if she
- 13 let go, it would float off of her. She couldn't strap the belt.
- Q. Okay. Were you hurt at all? Any injuries?
- 15 A. No, some black --
- 16 (Through interpreter) Black and blue.
- 17 Q. Bumps and bruises?
- 18 INTERPRETER: Bumps, bruises.
- 19 BY MR. LARUE:
- Q. Did you go to a hospital?
- 21 A. (In English) No.
- Q. And you can swim?
- 23 A. Yes.
- Q. Okay. And where -- you know, you already told us that
- 25 you thought that the other two missing could swim, so we won't

- 1 go -- I think you answered most of the questions just in what you
- 2 said. So, thank you very much.
- 3 MR. LARUE: Shane, do you have any questions?
- 4 BY CWO LAWS:
- 5 Q. Shane Laws with the Coast Guard. Did the other DUKW
- 6 boat that came by, did it have passengers in it also?
- 7 A. Yes, I think it had.
- 8 Q. It had passengers, okay.
- 9 A. The other DUKW boat, yes, yes.
- 10 Q. Thank you very much.
- 11 BY MR. LARUE:
- Q. Okay. We're going to finish up. Is there anything else
- 13 you can think of?
- 14 A. No.
- 15 Q. No? Okay. And it's okay that we recorded?
- 16 A. Yes.
- 17 Q. All right. Thank you very much.
- 18 (Whereupon, at 1:23 p.m., the interview was concluded.)
