- 2 (1:50 p.m.)
- 3 MR. LARUE: All right, it is 1:50 in the afternoon.
- 4 This is Liam LaRue from NTSB. Friday, July 9th. And we're
- 5 talking to David Strobl.
- 6 INTERVIEW OF DAVID STROBL
- 7 BY MR. LARUE:
- 8 Q. David, how old are you?
- 9 A. I'm sixteen.
- 10 Q. Sixteen, good. And just like your buddy, if you could
- 11 just walk us through the events as best you remember, and we'll go
- 12 from there.
- 13 A. So, when we wanted to go back to the dock, yeah, the
- 14 engine stopped, and it started to smoke. And the captain started
- 15 to repair it or handle it. He tried to start it up again. Yes,
- 16 the captain tried to start up the boat again.
- 17 Q. Was he able to start up the boat?
- 18 A. No. And after a while, the smoke stopped, and we -- so,
- 19 the captain called out, called for help, but I didn't remember --
- 20 I don't remember that somebody answered to him. And I think we
- 21 waited about two or three minutes. Then somebody shouted that
- 22 there comes a boat, barge. And then we got nervous. And after
- 23 that, the captain tried again to call help, but it wasn't
- 24 successful again. And I didn't see, but I think then the younger
- 25 captain jumped into the water.

- 1 And maybe before the crash only ten minutes, we wanted
- 2 to catch life jacket. And but it was hard to get them, because
- 3 the bags had them. It was being held by that strap that was
- 4 described before. So, after maybe five seconds, I could pull one,
- 5 yeah, and I had a hold in my hand, because I didn't have time for
- 6 pull it onto my head. And then was the crash. And we started to
- 7 sink. After that, I saw the roof. Okay, it broke, it broke
- 8 apart, the roof.
- 9 Q. The roof of your boat?
- 10 A. Yeah, yeah, and it came down, it started coming down.
- 11 And we started to turn left to the shore or to the dock. But we
- 12 gone to the water, and we was -- we were under the water about ten
- 13 or twenty seconds, I think. And after that, somehow we came out
- 14 the water, and I saw that ship, the barge go past. And we tried
- 15 to -- we tried to climb out of the boat, because we were in the
- 16 boat.
- 17 O. You were still in the boat at that time?
- 18 A. Yes, we went under water halfway. But the boat was full
- 19 of, pulled down the water, so under the water. Then I could climb
- 20 up, and I jumped into the water again. And I helped my classmate
- 21 to climb out, and I gave her a life jacket. And then we started
- 22 to swim out to the dock.
- Q. And how did you get out of the water?
- 24 A. Gabor climbed up, and --
- Q. Was it a rope, a ladder?

- 1 A. Oh, he climbed up with the ladder, I think, the fire --
- 2 O. It was a ladder?
- 3 A. Or a hose, a fire hose. Yeah, the fire hose.
- 4 O. Oh, it was a fire hose?
- 5 A. Yeah.
- 6 Q. So, someone dropped a fire hose down?
- 7 A. Yeah, he climbed up, and I had my bag and my life jacket
- 8 in my hand, and we then -- I couldn't climb up, so I started to
- 9 swim to a lower dock. And then the man and Gabor helped me to
- 10 climb up.
- 11 Q. Okay, so someone else helped you to climb at a lower
- 12 dock?
- 13 A. Yeah.
- Q. Okay, can you tell us what you remember about when you
- 15 got on the boat what the captain told you about how to put on a
- 16 life jacket and that type of thing?
- 17 A. Yeah, he, he tried to explain us how to use the life
- 18 jacket in the air, but it wasn't very good. And I think that was
- 19 all he explained.
- Q. Did you know how to put on a life jacket?
- 21 A. Not really.
- 22 Q. Okay.
- 23 A. But the main reason I hadn't, I couldn't pull the life
- 24 jacket was that we hadn't -- we didn't have enough time.
- Q. Not enough time, okay. You said that after the engine

- 1 stopped, you heard the captain call for help on the radio?
- 2 A. Yes.
- 3 Q. Did you ever hear anybody reply?
- 4 A. No.
- 5 Q. And do you remember exactly what he said? Do you
- 6 remember?
- 7 A. No.
- 8 Q. No, okay. Could you hear him talking?
- 9 A. The captain?
- 10 Q. Yeah.
- 11 A. Yeah.
- 12 Q. Okay, did you -- did you hear any sound signal, like a
- 13 horn or a bell?
- 14 A. No, nothing.
- 15 Q. No? On your boat or the tug or barge?
- 16 A. Nothing.
- 17 Q. Let's see. So, the life jacket that you grabbed, you
- 18 were able to hold onto it the whole time?
- 19 A. Yeah.
- Q. Okay, did you get hurt at all? Do you have any
- 21 injuries?
- 22 A. Yes, on my head.
- 23 Q. You hit your head?
- A. Yeah.
- Q. Did you go to the hospital?

- 1 A. No.
- 2 Q. Are you feeling okay now?
- 3 A. Yes.
- 4 Q. Okay, good. Can you swim?
- 5 A. Yes.
- Q. What was the first time that you saw the barge?
- 7 A. About ten minutes before the crash, about two or three
- 8 minutes before the crash.
- 9 Q. So, it was pretty close by then?
- 10 A. Yeah.
- 11 Q. Okay, let's see. You said you saw smoke. What color
- 12 was the smoke?
- 13 A. It was gray.
- 14 Q. The person that you saw on the radio, the captain, was
- 15 that the young captain or the old captain?
- 16 A. The old captain.
- 17 Q. The old captain. And you said that you heard someone
- 18 shout here comes the barge or here comes a boat. How far away was
- 19 the boat when they said that?
- A. About 100 meters, yeah.
- 21 Q. And how long after they shouted did the boat -- did it
- 22 take for the barge to hit you?
- 23 A. The time?
- Q. The time.
- 25 A. About one-and-a-half minutes.

- 1 Q. Do you -- were you in your seat all the way up until the
- 2 accident? You didn't move around?
- 3 A. Yes.
- 4 Q. Okay, I feel like I have one more question, but I can't
- 5 think of it right now, so I'm going to pass it around the room.
- 6 Okay, next is Greg.
- 7 MR. BLUMENTHAL: I'm not sure if I have any more. We
- 8 covered, I think, most of the ground that we need to.
- 9 MR. LARUE: Okay.
- MR. BLUMENTHAL: So, if I have anything else, I'll ask.
- 11 Thank you.
- 12 BY CWO LAWS:
- 13 Q. Shane Laws for the Coast Guard. After the captain shut
- 14 the engine off and you were sitting there, did he explain what was
- 15 going on, what you were sitting there for?
- 16 A. No.
- 17 Q. He didn't provide any explanation of why he shut the
- 18 engine off?
- 19 A. No.
- Q. You said you saw the captain using the radio. Could you
- 21 hear anything coming back over the radio? Could you hear other
- 22 people talking to him?
- 23 A. No.
- Q. No? Okay, that was all I had.
- 25 BY LCDR FINE:

- 1 Q. I'm Matt Fine with the Coast Guard. Did you see the
- 2 captain go get his life jacket?
- 3 A. No.
- 4 Q. Yes?
- 5 A. No.
- 6 Q. No, okay.
- 7 A. The younger captain?
- 8 Q. Either one.
- 9 A. No.
- 10 Q. Neither one?
- 11 A. Maybe, yes, I saw that older captain catch a life
- 12 jacket, but that was about fifteen minutes before the crash.
- Okay, it might have been already asked, but what color
- 14 was the smoke?
- 15 A. Gray.
- 16 Q. Gray, it was asked. Thank you.
- 17 BY CWO LAWS:
- 18 Q. Shane Laws with the Coast Guard again. One more
- 19 question. Did you hear anybody in English or in Hungarian shout
- 20 out that people should put their life jackets on?
- 21 A. Actually, yeah, but they couldn't pull it down.
- 22 Q. Okay.
- BY MR. BLUMENTHAL:
- Q. I did have one question. This is Greg. Was the captain
- 25 during most of the anchored time, the stopped time, on the radio

- 1 trying to, you know, talking and talking and talking?
- 2 A. Yeah.
- 3 Q. Or was he just sitting there without --
- A. He tried a bit, and he sat down. And again he tried.
- 5 Q. Okay. How many times would you say that he made
- 6 attempts to talk?
- 7 A. About three times.
- 8 Q. Three, okay. Thank you.
- 9 BY MR. LARUE:
- 10 Q. Is there anything else that you can think of that we
- 11 didn't ask you?
- 12 A. No.
- 13 Q. Okay, good. And if you think of something, you can
- 14 always get in touch with us later. We'll be finished now. Is it
- 15 okay that we recorded?
- 16 A. Yeah.
- Q. Okay, thank you very much.
- 18 (Whereupon, at 2:07 p.m., the interview was concluded.)
