1 INTERVIEW

- 2 (12:10 p.m.)
- 3 MR. LARUE: Okay, good afternoon. It is 10 after 12:00
- 4 on Friday, July 9th. This is Liam LaRue from the NTSB. We have
- 5 the same group from earlier, minus Lieutenant Commander Fine. And
- 6 we have two new additions, so let's have you say your name.
- 7 MS. JONAS: I'm Agnes Jonas (ph.).
- 8 MR. LARUE: And who do you represent?
- 9 MS. JONAS: I'm the American Red Cross, and I also can
- 10 interpret.
- MR. LARUE: Okay, great.
- MS. TORREY: I'm Barbara Torrey (ph.) from the Red
- 13 Cross.
- 14 INTERVIEW OF JUDIT SZUTS
- 15 (Whereupon, Ms. Szuts answered assisted by an
- 16 interpreter.)
- 17 BY MR. LARUE:
- 18 Q. Okay, great. And we're going to be interviewing Judit.
- 19 And how do you pronounce your last name?
- 20 A. Szuts.
- 21 Q. Szuts?
- 22 A. Szuts.
- 23 Q. Szuts, okay, thank you very much. Start off with just
- 24 how old are you?
- 25 A. Sixteen.

- 1 Q. Great. So, what I'd like you to do is to just kind of
- 2 walk us through what happened on Wednesday. You can just start
- 3 from when you got on the boat and just tell us what you remember.
- 4 And then we'll follow up with some questions.
- 5 A. Okay. The smoke came out, and I remember we just
- 6 thought that it was just part of the show. And we were laughing
- 7 at it. And we after 10 minutes, we saw the barge, and we thought
- 8 nothing really happen. And then everybody started to scream. And
- 9 I took off a life jacket, and it was in my hand, I think. I --
- 10 INTERPRETER: She let go of her bag.
- MS. SZUTS: Then the barge stand like this, and I felt
- 12 water. And the other thing I remember, I was in the water, the
- 13 light coming, and I was --
- 14 INTERPETER: She opened her eyes. She was above the
- 15 water.
- 16 BY MR. LARUE:
- Q. What happened next?
- 18 A. I saw my teacher, Victor, and I swim to my bag, and I
- 19 carry it and I swam out. And someone in my -- classmate Peter,
- 20 helped me to came out the water.
- 21 Q. Peter helped you get out of the water?
- 22 A. And were some other people that were there.
- Q. Did you swim to the shore?
- 24 A. Yeah. I swim to the --
- 25 INTERPRETER: She swam to shore.

- 1 BY MR. LARUE:
- Q. Okay. So, it wasn't a boat? You didn't get on a boat?
- 3 A. No.
- 4 Q. Okay, I've got a seating diagram here. So, this is the
- 5 front of the boat; this is the back. Do you remember where you
- 6 were sitting?
- 7 A. There.
- 8 Q. So, definitely -- okay.
- 9 INTERPRETER: Yeah. 13.
- 10 BY MR. LARUE:
- 11 Q. Definitely 13? Okay. So --
- 12 A. That's the right number.
- 13 Q. All right. Which -- were you sitting on the out -- the
- 14 aisle seat or outside?
- 15 A. The aisle.
- Q. Sitting on the aisle, okay. And who was sitting next to
- 17 you?
- 18 A. Katalin.
- MR. LARUE: Okay, what's your name?
- MS. TAKACS: Kata.
- MR. LARUE: Kata. All right. Well, we'll be talking to
- 22 you next too.
- BY MR. LARUE:
- Q. Great. Do you remember who was sitting near you?
- 25 A. The big guy was sitting there.

- Q. Who's the -- do you remember his name?
- 2 A. No. I don't know him.
- 3 INTERPRETER: He was not part of the group.
- 4 BY MR. LARUE:
- 5 Q. Okay.
- 6 A. Rachel and Amanda were sitting there.
- 7 Q. So, Rachel and Amanda were sitting in 15?
- 8 A. Yeah.
- 9 Q. All right. How about in front of you?
- 10 A. Maybe Jackie was sitting there, I think.
- 11 Q. Maybe Jackie?
- 12 A. Jackie, Jackie Kennedy.
- 13 Q. In front of you in 11? Was she sitting next to anyone,
- 14 or --
- 15 A. Yeah, a woman that I don't know.
- 16 Q. Okay. Someone not from the group?
- 17 A. Yeah.
- 18 Q. Okay. Do you remember hearing the captain talking on
- 19 the radio, or --
- 20 A. No. No, I don't -- didn't hear that.
- 21 Q. Okay. You were too far back?
- 22 A. Yeah.
- Q. Do you know if the DUKW boat that you were on, if they
- 24 had a horn? Did they use a horn?
- 25 A. No, no, I don't remember hearing horn. No, I

- 1 (indiscernible).
- Q. Okay. Do you remember if the tug and the barge made any
- 3 noises?
- 4 A. No, no, I think.
- 5 Q. You said that you were able to grab a life jacket?
- 6 A. Yeah.
- 7 Q. Did someone tell you to grab a life jacket, or did you
- 8 do that on your own?
- 9 A. I --
- 10 INTERPRETER: She saw that others were. Nobody told
- 11 her, but she saw that others were taking. She couldn't pull it
- 12 over her head.
- 13 BY MR. LARUE:
- Q. Okay. So, that was my next question. So, you didn't
- 15 actually get it on, but you were holding it?
- 16 A. No, I can't put it.
- Q. Okay. And you managed to hold it the entire time?
- 18 INTERPRETER: She's not sure if it was with her the
- 19 whole time or just on top of the water when she grabbed it.
- BY MR. LARUE:
- 21 Q. Okay. Was it easy or hard to get the life jacket? Were
- 22 there any troubles getting the life jacket?
- 23 A. Yeah. Yeah, I think it --
- Q. Okay. So, you swam to shore. Did you have any
- 25 injuries? Were you hurt at all?

- 1 A. (Through interpreter) A little black and blue.
- 2 Q. Did you go to a hospital or anything?
- 3 A. No, no.
- 4 Q. Can you swim?
- 5 A. Yes, I can.
- Q. When you looked back and you saw the barge, did you see
- 7 the tug that was pushing the barge? Did you see anyone on board?
- 8 A. No.
- 9 Q. No? So, you said you saw -- I'm going to back up
- 10 further. When you were in the water, you saw smoke?
- 11 A. No.
- 12 UNIDENTIFIED SPEAKER: No, on the boat. When you were
- 13 on --
- 14 BY MR. LARUE:
- Q. When you were on the boat.
- 16 A. Yeah, that I saw.
- 17 Q. So, yeah, what did the smoke look like? Color.
- 18 A. Gray.
- 19 Q. Okay. How long from the time the boat stopped until the
- 20 barge came and hit the boat?
- 21 A. Ten minutes.
- 22 O. Ten minutes. And were you in your seat the entire time,
- 23 or did you move around the boat, or did you stay in your seat?
- A. I stay there, but then the others jump and I jump too,
- 25 jumped there (indiscernible).

- 1 Q. Okay. So, you stood up?
- 2 A. Yeah.
- 3 Q. Okay. Did the captain give you any instructions at any
- 4 time before the barge came?
- 5 A. No.
- 6 Q. Okay. All right. That's it for me. Thank you. I'm
- 7 going to let everyone if they have any questions, they'll follow
- 8 up. We'll start with Greg.
- 9 BY MR. BLUMENTHAL:
- 10 Q. This is Greg from Ride the Ducks. Did -- could you see
- 11 the captain from your location on the boat, what he was doing?
- 12 A. Yes.
- 13 INTERPRETER: He just talked on the --
- 14 BY MR. BLUMENTHAL:
- 15 Q. On the emergency radio or a cell phone? A microphone?
- 16 A. (Through interpreter) It was part of the boat. The
- 17 younger one was up on the front. Just on the radio, not on a cell
- 18 phone.
- 19 Q. And do you recall if he had made more than one time or
- 20 multiple attempts to use the radio? Over the course of ten
- 21 minutes, right?
- 22 A. (In English) I don't know.
- Q. Okay. Could you see the deckhand? And that's the
- 24 person that went out and dropped the anchor.
- 25 A. No.

- 1 Q. Were you able to see what he did during the whole time?
- 2 Were you able to hear anything that he said?
- 3 A. I didn't hear anything.
- 4 Q. When did you first notice the barge, after anchor or
- 5 before?
- 6 INTERPRETER: She didn't see when the anchor went down,
- 7 but when people started screaming, a few seconds before that, she
- 8 saw the barge.
- 9 BY MR. BLUMENTHAL:
- 10 Q. Okay, okay. How much time did you -- passed, do you
- 11 think, before -- after the DUKW boat stopped until the collision?
- 12 A. Ten minutes.
- 13 Q. Thank you.
- MR. LAWRENCE: No questions.
- 15 BY CWO LAWS:
- 16 Q. Did -- I'm sorry. Shane Laws with the Coast Guard. Did
- 17 you see the captain or the deckhand try to open the engine
- 18 compartment to look into it at all?
- 19 INTERPRETER: The younger one stood on something up
- 20 front, but that's all she -- and looked at something, but that's
- 21 all she --
- 22 CWO LAWS: Did he open --
- 23 INTERPRETER: She doesn't know.
- 24 BY CWO LAWS:
- Q. Did either of them use a fire extinguisher or bring one

- 1 up front?
- 2 A. No.
- 3 Q. No. After they turned the boat off, how quickly did the
- 4 smoke go away?
- 5 A. (Through interpreter) About a minute for the smoke.
- 6 Q. Where was the smoke coming from?
- 7 A. Somewhere in the front, on the side.
- 8 MR. LARUE: Do you remember which side? The side that
- 9 you were sitting on? From the starboard side?
- 10 MS. SZUTS: (In English) Yeah.
- MR. LARUE: Okay.
- 12 BY CWO LAWS:
- 13 Q. You didn't see any other smoke from any other part of
- 14 the boat?
- 15 A. No, just this.
- 16 Q. I don't recall if this was asked. Do you remember when
- 17 you first got on the boat, maybe even before it went in the water,
- 18 was there ever a time where the captain explained where the life
- 19 jackets were and how you put them on?
- 20 A. Yes, he showed us, but on his own life jacket, not the
- 21 orange.
- 22 (Through interpreter) Not the orange, but the blue.
- 23 INTERPRETER: And she said if she would have to, she
- 24 wouldn't know how to put it on.
- 25 BY CWO LAWS:

- 1 Q. What -- he demonstrated with a blue life jacket?
- 2 A. (In English) Yeah, something.
- 3 Q. What did the blue life jacket look like?
- 4 INTERPRETER: Similar to the -- to theirs.
- 5 BY CWO LAWS:
- 6 Q. Square block, like a rectangle, or more like a jacket
- 7 you would put your arms through?
- 8 UNIDENTIFIED SPEAKER: Did it look like this?
- 9 MS. SZUTS: (In English) Yes.
- 10 UNIDENTIFIED SPEAKER: And it comes apart, your head
- 11 goes in?
- 12 CWO LAWS: Just the blue vest. Okay. That was all I
- 13 had. Thank you.
- 14 UNIDENTIFIED SPEAKER: Just one quick question. When
- 15 the boat was hit, do you remember if it rolled over, went up in
- 16 the air?
- 17 MS. SZUTS: (Through interpreter) The back was down
- 18 further.
- 19 BY MR. LARUE:
- Q. Just one more question from me. This is Liam from NTSB.
- 21 Do you remember where your two friends that are missing, do you
- 22 remember where they were sitting?
- 23 A. (In English) Maybe there or there.
- MR. LARUE: She's pointing at seats 5 and 3.
- BY MR. LARUE:
