15	paddlewheel right now. It was a full boat.

17	CALLER: Okay.

19	partners can see it. I've already yelled at them all.
20	CALLER: Yes, ma'am. Yes, ma'am.
21	911 OPERATOR: What's a phone number in case I get
22	disconnected from you, okay?
23	CALLER: Okay.
24	911 OPERATOR: What's your phone number in case I get in
25	case I lose you?

They are about 10 feet from the paddlewheels 4 CALLER: Yes. 5 that are spinning due to the wind. 6 911 OPERATOR: Okay. 7 CALLER: Like going at a high rate of speed. It is extremely 8 windy. 9 911 OPERATOR: Okay. I'm going to stay on the line with you. 10 I want you to give me updates while my partners get this 11 dispatched out, okay? 12 Okay. Yes, ma'am. CALLER: 13 911 OPERATOR: You said only about 10 have come up? Only about 10. Yes, ma'am. And half of them don't 14 CALLER: 15 have life rafts on them. 16 911 OPERATOR: Okay. Are you an employee? 17 CALLER: I am, ma'am. 911 OPERATOR: 18 Okay. Can you still see it? 19 I cannot see a boat or any people now. CALLER: 20 911 OPERATOR: Okay. 21 CALLER: They have all gone towards the paddlewheel. I see 22 one person about to go to directly under the paddlewheel -- she 23 looks to be pregnant -- upside down. 24 911 OPERATOR: Okay. CALLER: 25 She's wearing white capris pants. She is laying on

1	her back, but she is going under the paddlewheel now.
2	(To third party) How many have come up (indiscernible)? How
3	many come up? How many have come up?
4	(To 911 Operator) If you can still hear me, ma'am, we've got
5	about three that have come up on the boat.
6	911 OPERATOR: They're on the Belle?
7	CALLER: Yes. They're like ramming into our boat right now.
8	Our deputy is trying to get them right now. They're trying to do
9	water rescue from the boat.
10	911 OPERATOR: The deputy is?
11	CALLER: There's one face down. We have got one face down.
12	911 OPERATOR: Okay.
13	CALLER: We've got one it's the pregnant lady who's face
14	down.
15	911 OPERATOR: Okay. Is she on the boat? Is that one
16	they've pulled out?
17	CALLER: No. She is face down in the water. It looks to be
18	an elderly lady. White capris pants, black shirt.
19	911 OPERATOR: Okay. And the deputy is there?
20	CALLER: Yes.
21	911 OPERATOR: Okay.
22	CALLER: And he is trying to get a life jacket on right now,
23	trying to pull some people up the side.
24	911 OPERATOR: Okay.
25	CALLER: He's got about four people, about four people that

1 we're pulling up the side. 2 911 OPERATOR: Okay. 3 CALLER: Oh, my God. Someone's about to jump in to try to 4 save somebody. She has gone --5 911 OPERATOR: Can -- do you have life jackets? 6 She is not wearing a life jacket. CALLER: 7 911 OPERATOR: No, do you have life jackets on the boat? 8 CALLER: Some -- yes, we have life jackets on the boat and 9 the marine crew is trying to pass them out, down to --10 911 OPERATOR: Okay. All right. Good. 11 Okay. Okay. Tell me what's going on, okay? 12 I'm just going to get to the better side. CALLER: 911 OPERATOR: Yeah. You're fine. 13 (To third party) How many guys (indiscernible) 14 CALLER: 15 (To 911 Operator) Okay. We have got approximately 10 people 16 aboard. We've got 10 people aboard. 17 Ten people aboard the Belle? 911 OPERATOR: 18 Yup, (indiscernible). We got another one face down. CALLER: 19 911 OPERATOR: Okay. But there's 10 people aboard the Belle 20 right now that you've pulled out? Is that what you're telling me? 21 CALLER: Yes, (indiscernible). The ones that were water 2.2 rescue, they've got to attend to them right now. 23 Okay. 911 OPERATOR: 24 CALLER: I'm going to try to face out of the wind just so you 25 can hear me.

1 911 OPERATOR: Yeah, I -- that's fine. 2 CALLER: A second one is face down now. 3 911 OPERATOR: Okay. CALLER: The first one that was face down --4 5 911 OPERATOR: Okay. 6 CALLER: -- (indiscernible) one they start CPR --7 911 OPERATOR: I can't --8 CALLER: -- still in progress. 9 What 911 OPERATOR: CPR in progress? Is that what you said? 10 did you say? 11 CALLER: CPR in progress on one. She's unconscious, not 12 breathing. 13 911 OPERATOR: Okav. 14 CALLER: CPR in progress on one. 15 911 OPERATOR: All right. And that was -- the one that CPR is in progress on is on the boat with you, correct? 16 17 One's on (indiscernible), one's still in the water. We are trying --14 911 OPERATOR: Okay. 15 CALLER: -- to keep everyone out of the water. 16 911 OPERATOR: Okay. 17 CALLER: It's about 7- -- I don't know if you can hear it, 18 but --19 911 OPERATOR: Yeah, I can hear it. 20 -- it's 70-mile-an-hour wind, so --CALLER: 21 911 OPERATOR: All right. Hold on just a second for me. I'm 2.2 going to talk to my fire department, okay? 23 CALLER: Okay. 24 They are still doing chest compressions on her right now. 25 The EMT is trying to get an airway started or something. He's not

1 taken over yet. Oh, God. I still have the one underwater. 2 (Background noise/conversation.) 3 CALLER: (To third party) I'm on 911 (indiscernible) --4 Okay, just keep -- you're doing fine. 5 (Background noise/conversation.) 6 911 OPERATOR: (To colleaque) tried to call a while ago 7 before this happened. 8 CALLER: I'm sorry. What? 9 (Background noise/conversation.) 911 OPERATOR: I'm just logging in here that you're making 10 11 notification, and I'm just -- yeah. 12 CALLER: Okay. I am trying currently to get a life jacket on 13 because the wind's picking up. 14 911 OPERATOR: Okay. Can you hear me? 15 I'm trying to open one of these --CALLER: 16 911 OPERATOR: (To colleague) I think called 17 everybody. We've got Western Taney. 18 (To caller) Are you there? 19 (End of recording.) 20 (File: AVMerged 07-19-2018 07.19.11.3p - 1016 -.avi) 21 911 OPERATOR: Stone County 911. What's the address of your 2.2 emergency? 23 CALLER: I was just speaking with your partner. I'm watching 24 (indiscernible) the Showboat. I was the one giving updates on the 25 CPR in progress.

T	911 OPERATOR: Okay
2	CALLER: We still have CPR in progress on the one. The
3	second one that we've been trying to get up out of the water for
4	about 10 minutes, is now up out of the water. We've got a small
5	child unconscious.
6	911 OPERATOR: A small child unconscious?
7	CALLER: (Indiscernible) unconscious. Yes, 6 years old,
8	unconscious. We just got him out of the water.
9	911 OPERATOR: Okay.
10	CALLER: They are pulling him up onto the boat right now.
11	There is CPR in progress. He's got the EMT with him and the
12	deputy. They're going inside.
13	911 OPERATOR: They're what?
14	CALLER: They're going inside the boat to do CPR because the
15	winds have picked up extremely.
16	911 OPERATOR: Okay. We've got multiple units on the way.
17	CALLER: Yes, ma'am. She told me to stay on the line with
18	you guys because I was giving (indiscernible) CPR in progress.
19	911 OPERATOR: Right.
20	CALLER: Because I am (indiscernible) as well.
21	911 OPERATOR: Right.
22	CALLER: So not very many people have called and talking to
23	you guys?
24	911 OPERATOR: Yeah. We're, we're getting calls all over the
25	place.

1 CALLER: Yes, ma'am. The (indiscernible) I was talking to that I was (indiscernible) updates on CPR. They're still number 2 3 one, the (indiscernible) they're trying to start I guess mouth to 4 mouth. I'm not sure (indiscernible) stopped CPR on the one, the 5 first one that they've been doing CPR --6 911 OPERATOR: Right. Okay. 7 CALLER: They've stopped their attempts on that one. 8 911 OPERATOR: Okay. (Background noise/conversation.) 9 10 (End of recording.) (File: AVMerged 07-19-2018 07.21.13.4p - 1016 -11 .avi) 12 (Background noise/conversation.) 13 The second one that was pulled up out of the water CALLER: 14 is awake. The first one is still unconscious. I -- another one 15 on the far end, unconscious. They're all (indiscernible), got 16 three so far. 17 Your, your phone is breaking up. I can't 911 OPERATOR: 18 understand what you're telling me. 19 CALLER: Okay. We've got three currently unconscious. Onlv 20 one has CPR in progress. That is a small child. 21 911 OPERATOR: Okay. The small --22 CALLER: At least four. We have one underwater still. 23 911 OPERATOR: The child is the one that has CPR in progress? 24 All did at one point, but they're trying to pull CALLER: 25 others out of the water still, so the EMT is working on the child.

1 911 OPERATOR: Okay. We've only got on EMT. We've still got one 2 CALLER: 3 underwater. 4 911 OPERATOR: Okav. 5 (Background noise/conversation.) 6 Okay. We're making sure we got plenty of people on the way, 7 okay? 8 Yes, ma'am. I'm just staying on the line so I can CALLER: 9 keep you updated. 10 911 OPERATOR: Okay. 11 If you need me to stop, just let me know. CALLER: 12 911 OPERATOR: Okay. 13 CALLER: Because I completely understand you're probably getting bombarded with calls. 14 15 Yes. 911 OPERATOR: 16 There's one going underneath the boat now. CALLER: Thev 17 passed the paddlewheel. They're underneath the boat. 18 911 OPERATOR: Okav. 19 CALLER: It is a female. Looks to be about -- I'm not even 20 sure if it's a female, honestly. It's a larger female, possibly. 21 911 OPERATOR: Okay. 22 With (indiscernible) --CALLER: 23 911 OPERATOR: Hold on a second for me. 24 CALLER: Okay. 25 (To third party) Can you grab that and send it up to my hand?

1 Thank you. 2 (To 911 Operator) It sounds like we do have first responders 3 approaching the scene. 4 911 OPERATOR: Okav. 5 (To colleague) Yes, my last caller said everybody was safe, 6 but they may --7 CALLER: No. Ma'am, they are not --8 911 OPERATOR: -- probably still need to go check on them. 9 CALLER: -- they're not (indiscernible). 10 911 OPERATOR: No, ma'am, ma'am. I'm sorry. I was talking 11 about a totally different call, not yours. 12 CALLER: Okay. 13 911 OPERATOR: I apologize for that confusion. No, they're, they're (indiscernible) the boat. 14 CALLER: Woo. 15 Yes, ma'am. No, face down. 16 (Background noise/conversation.) 17 CALLER: And I don't know if it's Western or you guys 18 responding, but if they have water rescue boat coming down, 19 they're going to need to access the ramps that is to the side of 20 the boat that is on the dam side. I believe that's going to be to 21 the west if you're looking at the map. 22 911 OPERATOR: Access the ramp on the west side? Okay. 23 The one that's going to be closest to the dam, CALLER: between the dam and the boat. It's like -- I can see it right 24 25 here.

2	CALLER: That's the ramp they use.
3	(Background noise/conversation.)
4	911 OPERATOR: 60-65.
5	CALLER: The only (indiscernible) I can okay.
6	(Background noise/conversation.)
7	CALLER: I thought that they were going to make it, and then
8	they turned.
9	(Background noise/conversation.)
10	911 OPERATOR: Okay. Are you seeing people getting there?
11	I'm people telling me
12	CALLER: Yeah.
13	911 OPERATOR: that they're getting there.
14	CALLER: We have two first responders not in uniform with
15	absolutely nothing with them, no kind of medical equipment or
16	anything, have approached the boat. The others, I can see them
17	pulling down the roadway. We've got one Western vehicle and
18	are you guys a red truck? Is Stone County red? If so, then we
19	got Stone County. If not, then it's Branson. But we got someone
20	in a red truck and we've got a Western truck.
21	911 OPERATOR: Okay.
22	(Background noise/conversation.)
23	CALLER: Okay. We've got one water rescue boat
24	911 OPERATOR: Hold on, hold on. Hold on, please.
25	(End of recording.)
