2 MR. COLLINS: There is an Asner, I think was his name. He's  
3 a marine Coast Guard investigator.

4 SGT. [REDACTED] Okay. Has he been by to talk to you?

5 MR. COLLINS: Well, no, he hasn't. So I was wondering if you  
6 all have talked to him or what's going with that.

7 SGT. [REDACTED] No. Haven't talked to him.

8 MR. COLLINS: And then, I guess, NTSB is here.

9 SGT. [REDACTED] Yeah.

10 MR. COLLINS: But I -- so --

11 SGT. [REDACTED] They're going to do a different side than what  
12 the Highway Patrol is going to do.

13 MR. COLLINS: Got you.

14 SGT. [REDACTED] The Highway Patrol is looking at the  
15 -- one section of it. They're looking at --

16 MR. COLLINS: So we won't have to talk to NTSB or do you --  
17 okay. I was just wondering how this is going to play out.

18 SGT. [REDACTED] I'm not sure --

19 MR. COLLINS: I don't care. I just was --

20 SGT. [REDACTED] Yeah.

21 MR. COLLINS: Okay.

22 SGT. [REDACTED] Yeah, I'm not --

23 MR. COLLINS: All right.

24 SGT. [REDACTED] I'm not sure if you'll need to talk to them or  
25 if they'll contact you or not.

1 MR. COLLINS: Okay. Got you. I got you.

2 SGT. [REDACTED] We're doing two different things.

3 MR. COLLINS: Yes, sir.

4 SGT. [REDACTED] They're doing a certain side of it while we're  
5 doing another side of it.

6 MR. COLLINS: I understand.

7 INTERVIEW OF SHAYNE COLLINS

8 BY SGT. [REDACTED]

9 Q. So the -- just to make sure I have your name and date of  
10 birth. What is your date of birth?

11 A. Shayne Collins, S-h-a-y-n-e, Collins, C-o-l-l-i-n-s, and it's  
12 [REDACTED].

13 Q. Okay, and just -- let's just start by you just kind of  
14 telling us what happened?

15 A. Okay. Well, real quick, originally we went to the Titanic --  
16 God, how crazy that -- went to the Titanic Museum. We decided to  
17 get tickets for the Ride the Ducks there. We had (indiscernible)  
18 tickets. We finished the Titanic. We went over to Ride the Ducks  
19 sometime around 5:30, maybe a little after. We got in line for  
20 that as well as the family of 11. I don't know their names. They  
21 were black. But the family of 11, they were in line too to go to  
22 the 6:00 one, ducks. Their tickets were for -- there's two Ride  
23 the Ducks. I don't know if they do something different, but  
24 there's one down on the strip, and then one that's off on the  
25 river.

1 Q. Okay.

2 A. So there's -- their tickets for off on the river, which  
3 wasn't a big deal. They said you just need to go to the ticket  
4 booth over there, and you'll have to get your tickets adjusted so  
5 that it's for here. So they got out of line to go do that.

6 Right after that we were in line, and we had the tickets from  
7 the Titanic. And my sister-in-law had asked them, hey, does it  
8 matter what -- you know, I guess she asked the wrong person, but  
9 somebody said, no, you can just get in line. So we got in line.  
10 But our tickets were generic, which means we had to go and do the  
11 same thing, take them up there, and say we need these and get them  
12 for a time or whatever. So we got ours done like that. And so  
13 ours as well as the other family was --

14 Q. So you --

15 A. -- made for 6:30. So --

16 Q. So you had to get out of line also?

17 A. Yes. And they were real nice about it. They said, hey, you  
18 know, sorry. So we got out of line, and then we waited until the  
19 6:30 time. And so that happened. We got in line. They took our  
20 picture. We got, we got inside the duck, amphibian boat, whatever  
21 you want to call it. And I remember they were doing -- one of the  
22 ladies came over, and told the driver, the black gentleman driver,  
23 not the captain or whatever you want to say, but the driver, the  
24 one that drives to the water area.

25 Q. Captain.

1 A. Captain talks the whole time. I don't know what else to -- I  
2 mean, he was the -- we'll call him the captain. But he talks the  
3 whole time, and then when they get to the water they switch.

4 Well, I remember she had said, hey, we got your check. And  
5 he said, well, you know, I'll be back. I ain't going nowhere.  
6 So, and so he didn't bother with the check.

7 I do remember they gave a count. I don't know if it's soft  
8 count, hard count, but they said, hey, we got 29. And I'm taking  
9 that was the 29, not to include the two crew members, which would  
10 be 31.

11 We took off down the road, made it over the dam, whatever,  
12 and got to the lake part of -- if you have a pen and paper I can  
13 draw the -- I don't know if I can draw, but I can show you how it  
14 went around and what, about what point I knew it was getting bad.

15 Q. Right here.

16 A. I mean, so see, I haven't done it yet, but I think -- because  
17 it's hard for me to explain it.

18 Q. Yeah.

19 A. And obviously this is not going to be --

20 Q. Nope, that's quite all right.

21 A. -- perfect. So here's the lake.

22 Q. Yep.

23 A. You have an island out here. We have the steamboat somewhere  
24 around here, let's say, the paddles here. The duck comes out  
25 somewhere through here. There were -- I know I said there was two

1 ducks, but there was actually four ducks.

2 Q. Okay.

3 A. Two ducks ahead of us. There might have actually been three  
4 ducks ahead of us. Two ducks went around. I know for sure  
5 actually two ducks went around the island.

6 Q. Yeah.

7 A. The captain was letting the kids drive this and that. And we  
8 knew -- let me start off also by -- they knew there was a storm  
9 system coming in, and that's why they decided to go and do the  
10 lake first. There wasn't any issues.

11 Q. Okay.

12 A. All the way through here everything was nice and calm. As we  
13 began to slowly turn off here, you could see on the lake the  
14 weather coming down. You could see the clouds out ahead. But I  
15 could see where it was just -- it was fogging up. And this was  
16 quite a distance away, and I --

17 Q. So this is on this side of the island still? You're on this  
18 side of the island?

19 A. Right through here. Right getting close to the island. But  
20 we -- I could see -- and I think that's maybe why they -- the guy  
21 decided to do this. The other duck, I don't remember if the other  
22 duck was ahead of us, but it came around and started trying to cut  
23 through here. So it's here. As we're getting here, this, and  
24 this is where they want to dock back.

25 Now these tugboats have gotten pretty close. I don't know.



1 I couldn't tell you at what point. But as we're coming around  
2 here, this boat is getting pretty close to this. Now the paddle  
3 boat, I guess, I thought it maybe had just docked because the  
4 paddles were moving, but I think, I -- well, I guess what I read  
5 was that the steamboat didn't go anywhere because of the rain or I  
6 don't know if they had finished dinner or if they were going to  
7 have dinner and they didn't. I don't know what the case was.

8 I do know at some point through here, and we were getting up  
9 here close here, I told my wife, I said, something's not right.  
10 This boat was chugging along. And that's when it started getting  
11 -- that's when the waves started coming in. This boat looked like  
12 it was almost getting pulled in, and I was like, I was like, oh, I  
13 said. And the captain had went from, you know, talking jolly to  
14 not saying anything, not saying anything. So somewhere through  
15 here I knew things were going bad.

16 And we kept chugging and going along. And I don't know, it  
17 seemed like we were pretty much directly -- I'm guessing this is  
18 -- I don't know if this is north or south of the boat. I'm  
19 guessing this is probably north of the boat, but we were on the  
20 back side of it. I -- from here to here, I'm surprised we made it  
21 as far as we did. Things started getting bad. I knew as we were  
22 making our way -- this boat had came in, and was in front of us,  
23 somewhere through here and was making it up there. Through here  
24 had fucked up because --

25 Q. Okay.

1 A. Because, I mean, I knew shit was bad. And I saw the captain.  
2 Everybody was just laughing. My kids are screaming. Everybody's  
3 going, oh, whoa. And I told my wife, something's wrong,  
4 something's wrong.

5 The preservers are at the top, and I should have just started  
6 throwing stuff out. But I was thinking, well, the captain's not  
7 saying anything, but he's not worried. I mean, I don't know that  
8 he's worried. He looked like he might be a little worried. I  
9 should have read better. But I should have just started throwing  
10 preservers out. But I'm thinking I don't know anything about  
11 these amphibious boats. They do this 100 times, I mean, every day  
12 it seems like. So I'm just trying to keep cool, but I'm  
13 stressing, and I should have just, I should have started throwing  
14 the preservers out. I should have started throwing preservers  
15 out, and I didn't, because I knew shit was wrong.

16 And at some point through here around the back side, and I  
17 couldn't tell you where, it just -- the back just started going.  
18 The guy that was in the very back -- because they -- well, they  
19 call it the soggy bottom back there because they knew sometimes it  
20 gets a little -- but it just started getting bad. At that point  
21 when it started getting up to people's knees, yeah, I knew, I knew  
22 we were screwed. I don't know. I --

23 Q. Where was the driver at, at that time?

24 A. Okay. So the driver was up front.

25 Q. With the captain?

1 A. Okay, no, the driver was directly behind the captain.

2 Q. Okay.

3 A. Because so he was here when we get off -- when he goes in to  
4 go in the water, the driver got out and got on the back. It  
5 was -- I don't know if he was sitting down, because he was just  
6 kind of, he was kind of chilled back behind where the driver is.  
7 And he was letting the kids -- the captain was over here on this  
8 seat talking and letting the kids do the little driving, get up  
9 there for a few minutes, not even that. Maybe about 20, 30  
10 seconds, little (indiscernible) a few questions, get them out and  
11 let another kid get in there.

12 I don't know -- I never really paid attention. I don't know  
13 -- the driver was there. He was behind him. He never got up to  
14 do anything. I don't think he had any clue what was going on  
15 either. The captain, look, I'll tell you this, he didn't say  
16 anything to anybody. I didn't even know the top released. As we  
17 were going down and we're going under water -- I've got eight  
18 family members.

19 Q. Yep.

20 A. And I don't, I mean, I've never felt so helpless. And I'm  
21 like thinking at this point there's nothing I can do. I can't get  
22 them out anyway. The sides had been brought -- you know, the  
23 plastic sheeting, the screening had been brought down. The top's  
24 coming down. And I was just resigning to -- because what am I  
25 going to do? Pick one over the other, try to fight it out? I

1 didn't -- I just said forget it.

2 Captain, if you want to call him that, hit some release. I  
3 don't know if it's a release or what he did, but he was going up.  
4 I thought maybe it was release. Maybe it just does it on its own.  
5 But he never said shit. He was up here, and he shot out. And  
6 that's the top, just disappeared, and that's when -- had I known  
7 that, I would have been telling, I would have been telling  
8 everybody. I didn't say, hey, we need to just get ready. Swung  
9 the top back. I had no idea. I saw that, and we were already  
10 going, and then we started -- I --

11 Q. So were you going down like this?

12 A. Like this, but at some point it almost seemed like it kind of  
13 evened out.

14 Q. Okay.

15 A. But it might not have. We were here --

16 Q. Okay. So the front was up --

17 A. I mean, we're --

18 Q. -- back was down?

19 A. -- standing up, and I'm holding here, and I know -- I  
20 remember as we were going down, that's where it started. But it  
21 was going down. Now, whether it went like this, I don't think so.  
22 It could have after we -- as we were going, as I saw the top  
23 release, we were probably still -- we were angled, but it wasn't,  
24 it wasn't straight back. Because yeah. I mean, because I was  
25 here and I was holding on, then I saw it go. I was like, fuck.

1           And so now I'm going up, and I'm just thinking my family. So  
2 I'm making my way up, and I'm sure more than likely I was maybe 10  
3 feet from the top but, you know, you've got the force of that boat  
4 probably pulling us somewhat down. So as we're working our way up  
5 it's taking a while. And I'm not -- had it just have been me, I  
6 wouldn't have been worried about it. I'm calm enough I would have  
7 been -- but every -- I was so helpless for my family. I just, I  
8 was worried. And I'm getting up and I'm -- I get up to the top.  
9 The waves were coming up high.

10           I know so I've got, I've got I know my three kids, my oldest  
11 can swim fine. My son [REDACTED] -- they're both my steps, my oldest  
12 and my youngest, my stepdaughter and my son, they're fish. And I  
13 know if they get up, they'll be fine, but I don't know where  
14 they're at, at this point.

15           I come up. The waves are here. I see the captain probably  
16 at least 10 to 15 -- no, I'd say about 15 feet -- I don't know, 10  
17 to 15 feet from where I'm at, and he's going -- so, okay, so  
18 here's the steamboat. And -- god dang it. So it looks like, and  
19 I show when it dropped further. So it looks like there's a brace  
20 that comes out, and I think there's one over here somewhere, and I  
21 think there's piping system under here, and there's a -- it almost  
22 looks like a walkway, but I think it's -- I don't know. I think  
23 they just have it there for the piping system. But as you're  
24 going out to here, there, you know, there's like -- it's not a  
25 boat, but it's like a little buoy system or -- right here, and

1 then the paddle is here. So I see this guy going this way. I'm  
2 looking around. My daughter said she saw me. My -- not my  
3 stepdaughter but my daughter, and she's not a strong swimmer. So  
4 I saw her. She said, dad, dad, dad.

5 Q. Take your time.

6 A. We were probably somewhere up here. And this is probably  
7 further out maybe over here, but, you know, this is a quick  
8 drawing. We might have been somewhere through here. But the  
9 closest might have been the paddles. But when I was coming around  
10 I saw paddles slightly moving, and I didn't know what to expect  
11 for there.

12 Q. Yeah.

13 A. I knew over here, you know, the waves are hitting, but  
14 there's no chance of getting sucked in by paddles. I didn't --  
15 the paddles were barely moving, but I didn't want to take a  
16 chance. I don't know much about that system. I knew it was just  
17 a wall here. I mean, you had this scaffolding going. So I -- my  
18 daughter's coming up, and she keeps -- she's panting. She's like  
19 dad, dad, and she grabs me, and it was the hardest thing, but I  
20 had to yank away from here. And I'd pull away and say, [REDACTED]  
21 come on, we got to go, we got to go. You're okay. You can do it.  
22 You can do it.

23 Because I mean we teach survival swimming and stuff like in  
24 the Border Patrol. I, and I teach it at the academy. I'm not the  
25 greatest swimmer, but we do teach that. And the number one thing

1 is if somebody is moving, I mean, unless you're, you know, really  
2 good at what you do, I know my daughter, and she's going to pull  
3 me in and we're both going down. So I pull away from her, and I  
4 talk to her, got to go, we got to go. I swim out, and I'm like  
5 come on, come on, just like you would a kid, you know. You swim  
6 -- come on, come on. And she said dad, dad, I'm scared, I'm  
7 scared. I said, well, you're doing good, you're doing good. And  
8 we get up, and we get going, and we start making our way here.  
9 She tried to grab me again. I pulled away from her again, and we  
10 got up here where this little buoy system is or whatever.

11 It almost looks, it's just like I don't know. It's -- that,  
12 this is coming out, and then I don't remember what this is. It  
13 almost looks like a little boat, but it's not. But it's kind of  
14 shaped out, and I don't know what it is. It might be for a brace  
15 for the steamboats or what -- I mean, for the boat or whatever.  
16 But we're here, and so we're trying to hold on.

17 The freaking ledge is right there. That's the only thing  
18 that the waves were -- had it not -- had it been calm, I wouldn't  
19 have been so worried. But with the waves, my daughter kept -- you  
20 know, it was making her panic more. But when we did get there the  
21 waves are what helped us because the steamboat crew was  
22 everywhere, but they didn't know what to do. The ledge was going  
23 up to the top. I grabbed the ledge, and I'm like one more, one  
24 more and I'll be able to get it. Well, I lost it. It's over  
25 here; I'm here. I'm waiting for that freaking (indiscernible) the

1 way that gets.

2 I get both hands, and I told [REDACTED] just wait,  
3 wait, wait. I get -- and it luckily caught -- there's still cable  
4 there, right there, and I grabbed it, and I pulled -- said help  
5 us; over here, help us, help us. And I'm trying to get her. And  
6 I don't remember, she said she was holding onto something wooden.  
7 But I was getting her, and I hold onto her for a minute, and then  
8 let go, and hold on. And then when they came up, we got two  
9 people here and one person here on her. And it's -- where she's  
10 at is real hard. I mean, it's a little more tight area. I mean,  
11 I don't know how to describe it. I could take you out to exactly  
12 where it was, but it was a tight area for her, and this -- I don't  
13 remember if it was a woman or a man, and they're holding onto her.  
14 And so I'm like, [REDACTED] calm down, calm down.

15 And, yeah, so I'm trying to hold onto her, and this guy is  
16 here, and then another guy shows up and they're trying to pull me  
17 up. I said, look. I said, just get my foot, get my foot. And at  
18 this time the woman's got her -- or the man's got her or it might  
19 be both, but she's good. She's just freaking out. He gets my  
20 foot up, and I said, just yank me up, yank me up. So he pulls on  
21 my foot, and I use his -- he used the back, I used the back of my  
22 heel to pull up on him, and I get up. So I'm up, and I get up,  
23 and I'm worn out. This, like I said, had it not been for  
24 everything else, I should have been able to keep my composure, but  
25 I didn't. I was worn. I was worn. My daughter just had drained



1 it from me because I was so scared that something was going to  
2 happen. And I was just, I was done.

3 I got up. I took a breather. I came around here, got behind  
4 the man and woman, and tried to find something to grab onto. I  
5 don't remember if it was a cable or some kind of ledge. I grabbed  
6 onto that, and I tried to get under [REDACTED]'s shoulder, under her  
7 armpit. We got her. Let's just go, let's just go, and we just  
8 started pulling. And I don't know if I was even helping, but I  
9 tried, and I pulled, and I finally, I got to a point where I had a  
10 little more leverage, and I just started yanking. She got up. We  
11 put her up on top of this, and I said, [REDACTED] just lay there,  
12 lay there. And she's spasming out.

13 The only thing I'm worried about is her into some kind of  
14 shock and her standing up. So I'm just worried about her getting  
15 -- doing something dumb, but I don't think she's going to. So I  
16 didn't want to leave her too far. [REDACTED] you have to calm down.  
17 Stay there. We have to find everybody else. Just calm down, calm  
18 down. And she's like, dad, dad, I'm scared, I'm scared, I'm  
19 scared. I look, and so here just down the way my wife is just  
20 laying there on the -- on this -- on whatever this is, this old  
21 scaffolding, this walkway. It's not a walkway, but you can walk  
22 on it. It's very, very -- from what they're telling me it's very,  
23 very --

24 Q. (Indiscernible)?

25 A. Yes. Now the problem with between there and where we were on

1 this big metal dock thing, where the water was hitting this dock  
2 thing was going down and up. So it was causing a scissor effect  
3 right here at the dock between the freaking scaffolding and that.  
4 So I wanted Tiffany to come that way, but I was afraid -- I could  
5 tell she was out of it. I was afraid if she started walking that  
6 way she might get cut by it. So I was saying, Tiff, just crawl,  
7 just crawl this way, crawl this way.

8 Another guy showed up, and he was there, and he had his hand  
9 there. He didn't even realize -- sir, sir, watch out, watch out.  
10 And he moved his hand. Tiffany made her way this way. I got her  
11 and [REDACTED] and I think that -- I got her and [REDACTED] and that  
12 man helped us, and we got them into the steamboat. We got in  
13 here, right here [REDACTED] saw the -- more of the black kids face  
14 down, and man, I tell you what, dude, I -- God. And I kept my  
15 composure -- not had been worried about [REDACTED] I would have had  
16 a little more, but I didn't have anything, man. I didn't have  
17 anything.

18 And I'll mention this. When I was here, and I was coming up,  
19 there was a man here with a radio, and I did tell him I saw people  
20 on -- in the paddle. Because I just happened when I came up, I  
21 said there's people in the paddle; there's people in the paddle.  
22 And he got on the boat, and said, there's people in the paddle. I  
23 don't know if there's already people over there, but he was  
24 letting him know. Because I just happened to look over there. So  
25 I did -- I will mention that. And I don't know if there's people

1 in the paddle -- I don't know if they already had workers going  
2 that way or not, but he saw it, and he radioed, thank God.

3 We got inside, and I started, I started going back and forth.  
4 I'm mainly around here. I started looking around here. I made my  
5 way on top, and I was looking down, and I kept on trying to get  
6 down to the paddle system, but the lady was, like, sir, you can't  
7 go down there. I said, well, how do I get there? And she goes,  
8 just go up here. And I don't know if it was just being tired or  
9 what, but I could not find the paddle system.

10 When I came back through here, Talyssa, my oldest, was here  
11 and [REDACTED] my nephew. So at that point we're missing my son, my  
12 mother-in-law, my sister-in-law, and my niece. And so they're  
13 freaking out. I'm saying, hey, don't worry about it. There's  
14 people in the paddle. There's people in the paddle that's  
15 probably -- I come back, I go back out here, and I'm talking to  
16 people here, and I finally make my way around down -- downstairs  
17 somewhere somebody brought the child in there, the black kid in  
18 there, and they were trying to resuscitate him.

19 I went around there, and came back out, and I started asking  
20 people, look, I'm missing people. I said, do you have names of  
21 anybody that's made it? She goes, well, some people made it up  
22 shore. She goes, I know at least one or two made it up shore. I  
23 said see if, please, just find out who, just find out who.  
24 Talyssa said that she was -- I guess she was up here somewhere  
25 close to the captain as well as my wife. My wife had saw [REDACTED]

1 make it to shore, but she was despondent. She was -- she couldn't  
2 -- she never voiced to me -- she didn't realize that we didn't  
3 know that [REDACTED] was there.

4 So I didn't know that. So I'm -- I get back, and I see [REDACTED]  
5 and then Tomlyn. And that's my niece and my --

6 Q. And nephew.

7 A. And they were together at that point. And I told them  
8 [REDACTED]'s over here, this and that, and that happens. God, it was  
9 a mess. Like I said, I was worthless. I was going back and  
10 forth, and just trying to look out at the freaking, out at the  
11 lake, and just looking out. And it was finally at some point  
12 starting to calm down. Yeah.

13 So I knew we were just missing Nan and [REDACTED] And Tiffany  
14 was more worried about Nan, got more worried about Nan, but she  
15 knew [REDACTED] made it. She was like my mom, my mom. I said, well,  
16 I can't find [REDACTED] either, but she just -- she couldn't yell.

17 Q. She couldn't get it out.

18 A. So this lady came and said, they're -- your son is at the --  
19 is on shore. I said, are you sure? What's the name? And she  
20 said, what's his name? She asked me. I said his name's [REDACTED]  
21 and she said, yes. So like, thank God. So we were just missing  
22 Nan.

23 And so we're here. At some point we make it up here, and I'm  
24 looking around. I still haven't found [REDACTED] I don't know where  
25 he's at, who's dead. The woman that had talked to me earlier

1 said, your son's upstairs with the lady. He's eating a cookie.  
2 He's blanketed up. He's fine. I said, okay. I said, we still  
3 have to find my mother-in-law. That's when they brought her up.  
4 That's when they brought her up the, up the actual walkway system.

5 Q. Yep.

6 A. And so I knew we had everybody together, and that was --

7 (Phone ringing.)

8 Q. Your phone, is that somebody you need to answer?

9 A. Oh, it's Talyssa.

10 (Mr. Collins having phone conversation.)

11 MR. COLLINS: It's a mess. The kids have been going crazy  
12 today. Sorry. I kind of went all over the place.

13 BY SGT. [REDACTED]

14 Q. No, that's fine.

15 A. I tell you, I --

16 Q. At the beginning, what happened at the beginning when they  
17 gave you instructions and all that stuff?

18 A. There wasn't any. He talked about the life preservers being  
19 up there, blah, blah, this and that.

20 Q. Did he --

21 A. But there was nothing -- there was no, there was no really  
22 kind of safety briefing that I remember, no. I mean, as I'm  
23 thinking about it, I don't remember any kind of a safety briefing.

24 Q. Okay. Did he explain where you guys were going? Did he  
25 explain that they were going to do the water first?

1 A. Yeah, they did say -- they had told us that they were going  
2 to get the water first out of the way so I guess that storm system  
3 could go through.

4 Q. Okay. And those racks that held the life preservers, how  
5 were they?

6 A. They're above our heads. I believe the adults were on this  
7 side kind of right -- if you look at where we are in the picture,  
8 we're like in the middle to maybe just they're, you know, the back  
9 middle.

10 Q. Yeah.

11 A. Life preservers are here. I believe adults. And then up not  
12 adjacent, but just up ahead on the left side looked like the  
13 children's. So --

14 Q. Did they tell you those were the adults and the children or  
15 did you just see that they were adult and children?

16 A. I looked up. You could just tell from the size. I believe,  
17 I remember on the life jackets, I don't know if I saw SM like  
18 small or what --

19 Q. Yeah.

20 A. -- but if there was something to distinguish, but you could  
21 tell the difference.

22 Q. Yeah.

23 A. And I should have -- I just kept thinking, you know what,  
24 these guys do this all the time, and I just, I was worried about  
25 it, because everybody's having fun, and I'm just here telling, I'm

1 telling Tiffany, this ain't good; something's not right. And I'm  
2 watching out of the boat, and it's just -- it looks like it might  
3 go under, like with the steamboat there, and I'm like, something  
4 ain't right, something ain't right. And when he turned, I don't  
5 know, I almost think we might have been better had we just not  
6 tried to --

7 Q. Stayed straight?

8 A. -- had we just let it just coast. I don't know that for  
9 sure, but had we just gone with it, but -- I don't, honestly, I  
10 don't think these guys are trained to really deal with -- you  
11 know, it's a leisurely cruise thing. I don't think they're  
12 trained for something like that. And those winds came in hard,  
13 and I don't blame him for what happened there. The only thing is  
14 that son of a bitch didn't say anything to anybody and he scurried  
15 out like a rat, and I just remember, yup and I'm looking at that  
16 -- I'm looking at him, and I felt sorry for him. At the same time  
17 it was like, man, you know.

18 Q. Did you see him --

19 A. I was just --

20 Q. Did you see him pull a latch or anything like that to release  
21 the top?

22 A. I thought it looked like he pulled something, but it might  
23 have just been that he knew it was going to break at some point.  
24 Because I guess they're made -- I don't know if it's made to break  
25 or if you have to push something or what. He was here, and we're

1 going down, and as we're going down, I just remember he's up at  
2 the -- like up in the top middle of this boat, and I don't know if  
3 he's standing on the seat or what he's doing, but he's either  
4 pushing it off or releasing something or he knows it's going. But  
5 as soon as it happens, he shoots out. He doesn't say shit. He  
6 looks back a couple of times, and at the point when it started  
7 sinking down, and I saw him, and he wasn't saying anything, I'm  
8 just like thinking, whoa, we're screwed.

9       Because I didn't know if I -- number one, I should have had  
10 everybody put the life preservers on as soon as I saw those -- I  
11 should have said, hey, everybody put these on, and I didn't. I  
12 failed to do that. And then as -- yeah, and when that popped up,  
13 I would have said everybody just get ready to shoot up. I mean,  
14 but I didn't know. As it was going down, I saw him. It was  
15 almost like he just disappeared, and I -- we just started going --

16 Q. Well, I take it you're with the Border Patrol; is that what  
17 you said?

18 A. Yes.

19 Q. You know as well as I do hindsight is 20/20, and --

20 A. Right.

21 Q. -- you can beat yourself up all day long about that stuff.

22 A. I know.

23 Q. And it's -- you do it 9 times out of 10 you're going to do it  
24 the exact same way that you did it the first time because you just  
25 don't think, hey, that's going -- this is what's going to happen.



1 A. I think having family in here really just -- I think that's  
2 the detriment. Like as we were going down, like I, you know, I'm  
3 thinking that top, I mean, that's holding us all in, and I'm not  
4 even -- I'm just like thinking, you know what, I'm not going to  
5 find it. There was too many people around, and it's like, it is  
6 what it is. I know I'm going to start suffocating this and, I  
7 mean, I was resigned. I mean, I didn't want to, and I knew I was  
8 going to be freaking gagging and gasping and everything else, but,  
9 you know, everything -- (indiscernible) heard that pop top, I'm  
10 like -- so I'm thinking, I'm thinking I'm -- you know, this is  
11 ridiculous.

12 I know, I mean, you know -- and I can't see anyone. I don't  
13 see anyone except that guy, and he stubbed his shoe down, I don't  
14 -- I don't remember seeing anybody in the background, but of  
15 course I looked. [REDACTED] said she saw me looking around, and she  
16 hollered for me, and that's when I started talking to her.

17 SGT. [REDACTED] [REDACTED] you got anything that --

18 MR. COLLINS: I'm sorry I'm not more -- I mean, it's playing  
19 in my head, but that's a mess. I mean you know what I'm saying?

20 SGT. [REDACTED] Shayne, I'll tell you, you've been through a  
21 traumatic, traumatic experience, and I'm telling you I'm very  
22 happy your family made it out, and everything like that. It's  
23 just one of those things that you, you get back, and you need to  
24 talk to somebody, and you don't want to talk to anybody at home,  
25 call me.

1 MR. COLLINS: Thank you. Thank you, thank you. I appreciate  
2 it. Like I said, I just -- I feel like this all could have been  
3 avoided. And I'm not talking about this storm system and stuff  
4 because these guys do this all the time. I think that came in  
5 hard and fast, but I think -- and it just --

6 BY SGT. [REDACTED]

7 Q. But just not saying anything is --

8 A. Yeah.

9 Q. -- what's bothering you?

10 A. Yeah. And then him just going -- like, it was almost, like,  
11 I'm done, I'm out of here. And he was panicking. Like I saw him  
12 in the, I saw him in the water. He was panicking. Evidently he,  
13 where he ended up going, he made it there a lot quicker because  
14 I'm with [REDACTED] and she's doggie paddling and I'm just doggie --  
15 I'm thinking at this point she's not going to make it, and I'm  
16 going to have to go in for her, and I'm thinking if she doesn't go  
17 unconscious -- she's not going to go unconscious going under, and  
18 I'm going to go after her, and she's going to pull us both under,  
19 and that's going to be it. But she kept doggie paddling. She  
20 said, I'm scared, I'm scared, dad, help me dad, won't you help me,  
21 dad? And I'm like, [REDACTED] I can't. You've got to come. You've  
22 got to go. Just keep going, keep going. Because if she would  
23 have brought me in -- she's a big girl, I mean we wouldn't have  
24 been -- I wouldn't have been able, I mean, there's no way. If she  
25 had been unconscious, yeah, you know.

1 Q. Yeah.

2 A. It would have been much easier. I could have, I could have  
3 got her out of there a lot easier.

4 Q. Turned around and float her out. Yeah.

5 A. Yeah, exactly. Even in the breaks, but -- I mean, even with  
6 the waves. But, yeah. So that was the hardest thing to do. But  
7 I didn't see -- I don't remember seeing anybody else until we were  
8 -- until I was up. And I remember seeing a couple people hanging  
9 on that, but it looked like there was -- it looked like the guy or  
10 two that were up there or -- I didn't notice it was my wife, but  
11 it looked like they knew what they were doing. They were doing a  
12 good job. Yeah.

13 So, I mean, it was -- I mean, yeah. If it wouldn't have been  
14 for the people on the shore and the people on the steamboat we'd  
15 have been done. Because I was spent trying to get my daughter  
16 over there. I don't know if I could have -- I really don't know  
17 if I could have got up and held onto her with the way I was  
18 thinking at that point. So, yeah, if they wouldn't have showed  
19 up. They made all the difference. I mean, thank God.

20 Q. Have you talked to your superiors?

21 A. Yeah. I've had people call. Because I lost my phone, so  
22 I've been using my son's, and, you know, I've got a class going on  
23 over there at the Academy. I'm an instructor. I have a class  
24 going on in the Academy. And so I touched with my -- I touched  
25 down with my boss there, hey, this happened; I don't have a phone.

1 So if anybody is calling me about it, whatever, just let me know.  
2 And, of course, I guess they -- at the time I knew it was big  
3 news, but I hadn't really checked anything out until at that time.  
4 I knew it was big, like, before I called him, but I said, well,  
5 you know, I'd better say something. And, yeah, and then so, yeah,  
6 I've been getting calls from the whole team.

7 BY SGT. [REDACTED]

8 Q. Well, [REDACTED] and I both have been in shootings over our  
9 careers, and stuff like that, and you get to where you're  
10 struggling --

11 A. Yes.

12 Q. -- look for help.

13 A. Thank you. No, like I said, I can handle -- you know, I'd  
14 much rather be getting shot at and everything else, but --

15 Q. Yeah, it's your family.

16 A. But, yeah, no, I -- yeah, I don't know how it happened, all I  
17 know is -- and then that poor family of 11, you know.

18 Q. That's a bad deal.

19 A. And it could have been avoided at least, but, you know, like  
20 I said, that guy, the only thing I can fault him for is him not  
21 saying, you know, hey, the life -- get the life jackets. This  
22 thing is going to pop off, if it goes down. He just -- he didn't  
23 say nothing. And then he, you know, it wasn't no man going down  
24 with the ship because he jettied. And I'm not trying to put him  
25 down or anything, but I saw that. I saw the fear in his eyes.

1 Like I said, I feel sorry for him, but I also hold contempt.

2 But I hold contempt for myself too because I mean, you know,  
3 I saw it, and I knew it, and I was telling my wife. But I saw I  
4 was getting her worked up, and I was thinking, well, you know,  
5 what if this happens? We get up there, you know, and instead I  
6 was fighting myself instead of just saying everybody put these  
7 things on. At least half of us could have had them on, if not  
8 more.

9 Q. You said that they had you all leave early because of the  
10 storm. Did they say that?

11 A. No, no. We left on time. We left on the time --

12 Q. I'm sorry.

13 A. -- we were supposed to.

14 Q. Do the water first. What was --

15 A. Yes, yes, yes.

16 Q. Explain that part of it.

17 A. The guy, what was his name? He has a strange name. It might  
18 have been like Little John or Billie Willie or something like  
19 that. The guy that was there doing the tickets and stuff. I  
20 thought he was the -- one of the captains. But he was taking the  
21 tickets. There was a woman that was going to take our pictures,  
22 and that's the pictures you all got as we're leaving, and also the  
23 pictures in front of the life preserver. He was saying, yeah,  
24 there's a storm system coming in. So we're going to go ahead, you  
25 know, just to be -- take precaution, you know, we're going to take

1 you out there first.

2 And, like I said, as we, we were coming around everything was  
3 blue skies. You saw the dark clouds off to here, but I mean these  
4 guys deal with this stuff all the time. You know? I mean, they  
5 know this stuff. I mean, that's what you think. So I'm sure they  
6 didn't expect for that to happen. Those waves came in, like I  
7 said, it went like -- yeah. But when we started, when we -- that  
8 island that was here --

9 Q. Yeah.

10 A. -- when we came around that island it started getting choppy.  
11 Oh, yeah.

12 Q. So did you guys go around the island?

13 A. No, no, no. He --

14 Q. This is your path, right?

15 A. Yes, yes, yes, yes, yes.

16 Q. Did you see where these two boats went during this?

17 A. They're up in front of us. They're already up in front of  
18 us.

19 Q. They had already made it out?

20 A. This was the boat that was struggling, and at some point they  
21 were up ahead of us, I mean, but it didn't look like they were  
22 going to make it out.

23 Q. And how far is the distance from where you guys entered to  
24 where you guys exit?

25 A. I wouldn't know. I wouldn't even want to estimate because

1 this is, this is a lot further out from the front of this  
2 steamboat than to where it looked like the other -- the other  
3 ducks made it over here. Because the direction we were traveling  
4 was, I'm guessing, where we were supposed to come up at, where we  
5 were supposed to go out at. Now I don't know if that's the  
6 normal.

7 Q. Had you been on the water quite a while before you got out to  
8 here or was that you just came off --

9 A. Well, you know, we came on, you know, through here. Hey, who  
10 wants -- I'm tired of driving or whatever, and that's when the  
11 kids come on. The kids are here, this and that. And at some  
12 point, I think he realized -- I don't know if their radio contact  
13 or what but they're noticing it's getting bad. Can't really see  
14 anything, but somewhere through here as this is -- and I don't  
15 know, this obviously isn't a perfect turn. But somewhere through  
16 here I'm seeing way off here not just the clouds, but I can see it  
17 hitting the water. I mean, you can just tell from afar. Almost  
18 looks like fog the way it's hitting, and you can just tell out in  
19 the distance. And I think, I don't even know if all the kids went  
20 through. Because I think he realized --

21 Q. Yeah.

22 A. And so they got in there. So, I mean, but, yeah, it started  
23 getting really choppy and really bad, and he looked back every now  
24 and then, but he never said anything. I looked back, the soggy  
25 part, there was a kid back there -- I say a kid. I don't really

1 know how old he was. He could have been anywhere from, I don't  
2 know, it seemed -- I didn't remember seeing him before that, but  
3 it looked like he might have been around 18, 19, 20, 21. I could  
4 be completely wrong about that. But I remember him just jumping  
5 up surprised as could be, go whoa, and he came up a little because  
6 the water was going back. And I think everybody was just  
7 expecting it to come back up. At that point it was, it was just  
8 kind of doing this, and everybody up here is just kind of laughing  
9 still. My kids are going crazy, you know, woo, yeah, oh, my gosh,  
10 and I'm just, I'm just white knuckling it and, yeah.

11 But I, like I said, I didn't know what the boat's capability  
12 was. I think about all that it can go through and stuff. I  
13 didn't really think this is a big deal. That was my --

14 Q. You said one of the guys was white -- the captain and the  
15 driver, one was white and one was black.

16 A. Yeah. The one that drove there, actually drove it on the  
17 road, the pavement, was a black gentleman.

18 Q. Okay.

19 A. When we got down to where it departs down at the water at  
20 some point they switched out, and then he drove it down into the  
21 water.

22 Q. Okay. One more question. I know you want to go see your  
23 family. Did the boat have sides on it? Like windows along the  
24 side?

25 A. When they started, they started at some point, and I believe



1 it was the black gentleman -- at some point when, you know, it  
2 started getting raining and coming down before the water got  
3 really choppy, the water was just coming -- they came and closed  
4 those sides down.

5 Q. Is it just one full length of a side or is it --

6 A. I don't think so. I think it's like -- that's a good  
7 question. Because you have bars every so often.

8 Q. Yeah.

9 A. And I don't know if it comes down like blinds or whatever  
10 because I wasn't really paying attention to that at that point.

11 Q. Yeah.

12 A. But it's just like they pulled down -- I don't know if it was  
13 one side or if it was like in sections. I really don't know.

14 Q. Okay.

15 A. I really don't remember that part. Yeah, but I mean it was  
16 almost like we're enclosed at that point. So there's no -- like I  
17 said, I didn't want to -- I mean, I was just like, what's the  
18 point in me trying to get out. I mean, how guilty am I going to  
19 feel trying to get out and my family goes down?

20 Q. Yeah.

21 A. I was like, I was like, fuck it. I mean, I didn't -- you  
22 know, it's like -- because I'm thinking we're just enclosed, we're  
23 going down, and what's the point? So we're going down. And then  
24 that pop topped. I'm thinking, well, you know, we -- I don't know  
25 what I was thinking, but I'm just thinking live.

1 Q. Sure.

2 A. And so go up. And that's when it turned into -- just yeah,  
3 it's all bad. It's all bad. I was scared. Like I said, I've  
4 never been through -- like I said, I'd rather be getting shot at,  
5 anything else. I mean, you take a bullet, you take a bullet, you  
6 know, but to go under and your kids, your family are there, you  
7 know, God.

8 Q. It's rough.

9 A. Yeah. No, yeah, I can't, I can't fathom the day, the -- just  
10 the fear that was like nothing I ever felt ever, and hope to God  
11 never fear again -- it never happens again.

12 Q. You all have been through a lot.

13 BY SGT. [REDACTED]

14 Q. How long are you guys down here?

15 A. Well, you know my -- I guess you know my mother-in-law's --

16 Q. Yeah.

17 A. I don't, I really don't know.

18 Q. What was your plan? Though this next week?

19 A. Leave here on the -- I believe we're going to try to leave  
20 late 23rd or early 24, probably early on the 24th.

21 Q. Okay.

22 A. And then try to get back some --

23 Q. In case we have any other questions, I've got your cell  
24 phone, your boy's cell phone number. He'll get a hold of you that  
25 way or your wife?

1 A. Yes, sir. Sir, like I said, I talked -- this is the first  
2 time I've actually talked about this. I know it's a jumbled mess  
3 what I'm telling you, but it's the first time I've actually -- I  
4 mean, I see it in my head how it happened, but it's kind of just,  
5 it's still surreal.

6 Q. Yeah.

7 A. And it was a mess. Like I said, I, yeah, I don't know, I  
8 don't know. After I heard my daughter there really wasn't no,  
9 there wasn't no trying to get anybody else or do anything else.  
10 What are you going to do? Had she been a swimmer, a strong  
11 swimmer like Talyssa and [REDACTED] I'd have been like, hey, go  
12 towards the shore, go towards the, you know, towards the barge or  
13 whatever over there. But being [REDACTED] --

14 (Phone ringing.)

15 (Mr. Collins having phone conversation.)

16 MR. COLLINS: I'm getting all confused. See, dad, I'm  
17 thinking my dad. You know, that's my stepson; it's his. So I'm  
18 like what, who? I've been doing it all day, man. I see them all  
19 -- oh, gosh, it's my life. I'm like, man, it's a mess. Who the  
20 heck is this? So, yeah, I'm sorry.

21 Hang on a second. We weren't that far, but the waves is  
22 what's causing the issue. And my daughter --

23 BY SGT. [REDACTED]

24 Q. No, I have to tell you, I'm a --

25 A. -- she is not a strong swimmer.

1 Q. I'm impressed that you recognize not --

2 (Phone ringing.)

3 (Mr. Collins in phone conversation.)

4 BY SGT. [REDACTED]

5 Q. I have to say I'm impressed with you just talking through it.

6 I mean --

7 A. No, no, I fucked up, man. I -- these people could have, I  
8 mean, you know, I don't know how Tomlyn and her kids made it.  
9 They're not the greatest swimmers, but, you know, they're not bad.  
10 But I, like I said, I knew if Talyssa and [REDACTED] made it up,  
11 they'd be fine, and if Tiffany didn't -- Tiffany was a strong  
12 enough swimmer. But I figured, I figured they were all lost until  
13 I saw Tiffany. And then, see, I mean, I just thought everybody  
14 was gone. It just kind of, oomph, here's one, here's one. It's  
15 like Easter egg hunting. That was insane. So if her mother-in-  
16 law makes it, I mean, we all somehow freaking blessed. But I  
17 mean, yeah, I just can't -- you know, nine of us live, and nine of  
18 the other family died. It just doesn't seem. I mean, I'll take  
19 it, but it's not fair. I don't know.

20 Q. You're together and they're together. God takes care of us  
21 in strange ways.

22 A. Yeah. I agree with you there. I agree with you there.

23 Q. Really does.

24 A. Yeah.

25 Q. Shayne, what's your address?

1 A. [REDACTED] (ph.) [REDACTED]

2 Q. Okay.

3 A. And that's at [REDACTED] [REDACTED].

4 Q. [REDACTED]?

5 A. No, [REDACTED]. And that's [REDACTED] and the ZIP is [REDACTED]

6 Q. Okay. Shayne, can I keep this drawing?

7 A. Yeah. Sorry, man.

8 Q. It was good.

9 A. Yeah. It's kind of -- thinking in my head. And I know it  
10 would be so much easier to walk out there, and just say this is  
11 what happened, this is what happened, but, you know, I just -- I'm  
12 not a great drawer. And it, obviously, I'm sure if I looked at  
13 it, it wouldn't look near like that, but it just seemed like it  
14 was -- it seemed like that, those systems kind of ran out like at  
15 an angle and where we were at. But, yeah, I don't know.

16 MR. [REDACTED] Okay. Well, we'll get at it. I'm going to  
17 leave you my number too --

18 MR. COLLINS: Yes.

19 SGT. [REDACTED] -- just in case you don't get a hold of [REDACTED]  
20 You know you got a brother anywhere you go in law enforcement.

21 SGT. [REDACTED] I appreciate it. Thank you. Believe me, I  
22 appreciate.
