1 INTERVIEW (8:42 p.m.) 2 3 Today is July 20th, 2018. SGT. It is about 8:42 4 in the evening, 20:42 hours. With me is 5 6 INTERVIEW OF 7 BY SGT. What's your middle initial, 8 Q. 9 Α. 10 And how old are you? Q. 11 Α. 12 , just like huh? 13 Yes, sir. Α. 14 That's not bad, huh? Q. 15 Yeah. 16 SGT. And dad, and you're dad, stepdad, right? 17 MR. COLLINS: 18 SGT. All right. Just with him here. And how 19 would I get a hold of -- I mean, how, I get a hold of you, how 2.0 would I get a hold of you? 21 MR. COLLINS: Yeah. I'm actually using his phone right now. 22 Yeah. We don't have too many left after the incident. So --23 SGT. Sure. 24 MR. COLLINS: But he knows his number. You need to know my 25 name?

1 SGT. Stepdad. Yeah. 2 It's S-h-a-y-n-e, S-h-a-y-n-e, and G, Collins, MR. COLLINS: C-o-l-l-i-n-s. 3 4 SGT. All right. 5 BY SGT. 6 So, tell me a little bit about what you remember Q. 7 yesterday. 8 Do you want his cell number, before I forget? MR. COLLINS: 9 SGT. Yeah. Go ahead and give it to me. 10 So, I remember --11 MR. COLLINS: give him your cell number --12 SGT. Give me your cell number. 13 MR. COLLINS: -- so we don't forget. 14 SGT. 15 [sic]. Okay. 16 BY SGT. 17 So, tell me, what do you remember about yesterday getting on Q. 18 the Ducks? Do you -- tell me what you recall when you got there. 19 Well --2.0 Start from there. 21 -- as soon as we got on the boat, the -- I didn't --Do you remember them talking, anything about the weather or 22 Q. 23 anything? 24 Yeah. I know, I heard them talking about them delaying it. 25 But then they said it should be fine and stuff. They said they

- 1 were just going to hit the water first, and try to avoid it.
- 2 Q. All right.
- 3 A. And then --
- 4 Q. Because it -- was there a storm coming?
- 5 A. Yeah, there was --
- 6 Q. Is that what they said?
- 7 A. There was, like -- yeah, they were saying there's a storm
- 8 coming, so we're just going to hit the water, we should miss it,
- 9 and then we'll do the land tour next. Because --
- 10 Q. All right.
- 11 A. -- usually we're supposed to the tour, land tour first.
- 12 Q. All right. Where were you sitting out on the, on -- or do
- 13 you remember? Were you on the --
- 14 A. Third row. I was right in the middle. There was two seats
- 15 | in front, and two seats behind me.
- 16 Q. And were the black family kind of sitting in front of you?
- 17 | Is that right?
- 18 A. They were sitting, I think, in the top, they were sitting in
- 19 one of the first rows on the left of me.
- 20 Q. Who were you sitting with?
- 21 A. Cayden, my cousin.
- 22 Q. Cayden. And were you on the left side or the right side if
- 23 | you're looking at the back of the driver? You know?
- 24 A. No. I don't remember.
- 25 Q. All right. But you're sitting with Cayden, then?

- 1 A. Yeah.
- 2 Q. So you remember driving out there in the water. Is that
- 3 | right? Driving to the water?
- 4 A. Yeah. I remember we were all driving out there. And then
- 5 | the waves started getting high and it started hitting to the,
- 6 like, the window. I don't know if there was like a crack through
- 7 | it at the bottom or something, but it -- all the -- when the
- 8 waters came in --
- 9 Q. And you didn't have a life jacket on or anything like that,
- 10 right?
- 11 A. No. He didn't really tell us what to -- he told us how to
- 12 put it on. But he didn't really tell us --
- 13 Q. In the -- was that in the beginning?
- 14 A. Yeah. He --
- 15 Q. When you were --
- 16 A. -- did in the beginning.
- 17 Q. -- driving out there? Yeah?
- 18 A. Yeah. He was telling us how.
- 19 Q. But when you got into the water, you didn't have -- put a
- 20 | lifejacket on, you didn't have anything, they didn't tell you to
- 21 put it on?
- 22 A. Uh-uh. He, we didn't know when he popped the roof, really.
- 23 Or if --
- Q. Okay. And even when things, the water started coming in
- 25 there, nobody said anything to you about putting a life jacket on.

- 1 Is that right?
- 2 A. Uh-uh. They just -- no one really told me, you know, what to
- 3 do.
- 4 Q. Okay. All right. So what do you remember when the water
- 5 started kind of coming through the window?
- 6 A. Well, when it was probably about like this, right here, to my
- 7 foot --
- 8 Q. Uh-huh.
- 9 A. -- we all thought it was just fun and games. Everyone was,
- 10 like, oh, yeah, this is probably just part of the ride. It's all
- 11 fun. And then it started getting a little under my knee, like
- 12 about right here. And then they all -- we all started panicking.
- 13 And then after that, it just went down really fast. And I don't
- 14 know if the roof came off because the pressure or that, but I know
- 15 as soon as we went under, I was swimming up, because I thought
- 16 there might be a little air at the very top. But I just kept
- 17 | swimming, looking for the top of the boat. And I finally just
- 18 swam up to the air.
- 19 Q. Okay. And then you swam up to the top. Is that right?
- 20 A. Yeah.
- 21 Q. Did you have flip flops on, too?
- 22 A. No, I was --
- 23 Q. Did you lose your shoes?
- 24 A. I was wearing shoes. So --
- 25 Q. You had tennis shoes?

- 1 A. Um-hum.
- 2 Q. So you could swim -- are you a pretty good swimmer?
- 3 A. Oh, yeah. We have a pool in our backyard.
- 4 Q. Okay. So you're a pretty good swimmer, and you had tennis
- 5 | shoes on, then. Is that right?
- 6 A. Yes. It was -- made it a lot harder.
- 7 Q. Yeah. What -- so you swam up to the top. And then what
- 8 happened?
- 9 A. Well, I was trying to swim, and I, I couldn't really swim and
- 10 I kind of realized that. So I just tried to stay above water.
- 11 Q. Okay.
- 12 A. And I let the waves throw me. Because they were throwing me
- 13 a pretty good distance. So finally --
- 14 Q. So you kind of like dog -- kind of like floating? You just
- 15 | trying --
- 16 A. Yeah.
- 17 Q. -- to float, float?
- 18 A. And then finally I flew -- I tried to get big boa but the
- 19 waves kept pushing me to the side. And finally there was people
- 20 | throwing things, throwing life preservers out, and lifesavers. So
- 21 I kept trying to swim to that as fast as I could. And finally the
- 22 | wave threw it enough to me where I could get on. And then I
- 23 | floated to the little thing.
- 24 Q. So you grabbed the life preservers then?
- 25 A. Yeah. And then I got to the little bar. There was like a

- 1 | metal bar coming from the boat to shore, kind of. And someone
- 2 pulled me up. And then a different person helped me --
- 3 Q. So you didn't, you didn't go to the boat. You went kind of
- 4 to the bank, and held onto --
- 5 A. I got separated from everybody.
- 6 Q. Okay. And then somebody pulled you up, then. Is that right?
- 7 A. And then they took me out and they gave me a cookie, dry
- 8 | clothes -- well, I didn't get dry clothes till after. They just
- 9 gave me a blanket, and then just water and stuff.
- 10 Q. All right. You remember seeing anybody else and, when you
- 11 | came up or anything?
- 12 A. I saw -- when I looked back to see if I could see my mom and
- 13 stuff, and I saw -- I don't know if he was -- they were trying to
- 14 save him or he was dead, but I'm pretty sure he was wearing a
- 15 green shirt. And like his legs were hanging. I don't know if
- 16 they were pulling him up and he was just like laying like that or
- 17 he was just dead.
- 18 Q. All right. All right. Well, I'm really sorry that this
- 19 happened to you.
- 20 MR. COLLINS: Tell him who all -- tell him all you saw when
- 21 you were up at (indiscernible).
- 22 Well, I saw -- I didn't see the green boy get up.
- 23 There was a kid in a green shirt. It was just green or something
- 24 like that. But I did see him in a wheelchair when they were, when
- 25 we finally got out.

1 MR. COLLINS: Who did you see on the wall up here? 2 Oh, the wall? I didn't -- I saw my sister. 3 captain was right between my sister and me and my mom. And that's 4 all I was really focusing on was my sister and my mom. And the 5 captain, he was -- I was trying to crawl over there to the bar to 6 like get close to them, but the captain was in between me and my 7 sister and my mom. So I kept trying to get over there, but the 8 waves just kept throwing me against the bar. And then finally 9 someone pulled me up. 10 BY SGT. 11 Okay. All right. Is there anything else that I'm not asking 12 that you'd like to tell me or anything? 13 Uh-uh. Α. 14 All right. Well, I think that's all I've got then. Okay. 15 Okay? I'm really sorry this happened to you. All right? 16 Thanks. 17 SGT. All right. I'll go ahead and I'll stop this. 18 And I'll let you get back. Okay? 19 All right. 2.0 SGT. All right. 21 (Whereupon, the interview was concluded.) 22 23 24 25
