17	Q. Well, hold on just a second. I want to write some names
18	down, make sure I have everybody's address, ma'am.

- 2 MS. McKINLEY: Yeah.
- 3 JACKIE: -- right near --
- 4 MS. McKINLEY: This is my daughter-in-law, Jackie.
- 5 BY MSHP TROOPER:
- 6 Q. Basically -- and let me make sure I have your date of birth
- 7 before I get there.
- 8 A. Um-hum.
- 9 Q. And, basically what everybody's been doing, just kind of
- 10 giving us a narrative of what happened --
- 11 A. Okay.
- 12 Q. -- and what you saw, everything. But, and then we'll, if we
- 13 | see something that we want to ask questions about, we'll ask
- 14 questions about it. If that helps you out, where you can kind of
- 15 just go through it. If it's difficult for you, just say this is
- 16 difficult for me and we can take a break, or anything like that.
- 17 Okay?
- 18 A. We bought out ticket that -- at someplace?
- 19 O. The *Titanic*?
- 20 A. Yeah. And they didn't tell us that we had to turn the
- 21 | tickets in when we went to the boat ride, or to -- okay? Because
- 22 | we were in line for the 6:00 one. Well, till we got up there to
- 23 get on the 6:00 one, and they said we had to turn those tickets
- 24 in. So by the time that happened, we missed the 6:00 boat.
- 25 Q. So which boat --

- 1 A. So we went on the --
- 2 Q. 6:30?
- 3 A. We went on the 6:30 boat. And so we took off, and we went, I
- 4 don't know, up the hill, and then we went straight to the water.
- 5 And the guy said we're going to go to the water first because the
- 6 | weather's going to get bad. So he took us in the water first.
- 7 And then it just got bad.
- 8 He did do the little video for the life vests. He didn't ask
- 9 anybody if they wanted them. He didn't pass, they didn't pass
- 10 them out. And we were parents and we didn't grab them either.
- 11 | So -- and the way the boat's designed, they're all up front. We
- 12 were in the middle of the boat, and the -- we were by the baby
- 13 life jackets.
- And so, the water just started coming in. And seemed like he
- 15 was okay with it, you know? He kind of acted like it's okay. And
- 16 then put those side -- the plastic shields down.
- 17 Q. How did they put those down?
- 18 A. I don't know if they push a button or not.
- 19 Q. I mean, is it something automatically comes down?
- 20 A. Yeah. I guess he pushed a button. I don't know. But the
- 21 sides came down to keep the water from coming in, I guess, and
- 22 getting us wet. I don't know.
- 23 And then we were kind of going this-a-way and that big
- 24 steamship boat was there. And I thought that boat was going and I
- 25 | thought it was going to run into us. But I guess it wasn't

- moving. They just had the propeller things on.
- 2 And then the next thing you know, the boat was just filling
- 3 up with water. We all kind of floated up, couldn't get out
- 4 because the roof was on. Of course, we couldn't grab a life
- 5 jacket because those were all on a shelf, and you couldn't see
- 6 anything. And then finally, I guess, it burst, or he let it go.
- 7 I don't know how the roof came off. I don't know if the water
- 8 pressure pushed it off. I don't know any of that. And then it
- 9 was everybody for themselves, and I know how to swim and tread
- 10 water. And I couldn't see any of my family. All I could see was
- 11 the --

- 12 Q. The swells?
- 13 A. No. The -- what are those -- the front of the boat, those
- 14 big things that go round.
- 15 Q. Oh --
- 16 JACKIE: On, on steamboat.
- 17 MS. McKINLEY: On that steamship.
- 18 BY MSHP TROOPER:
- 19 Q. The paddle wheel?
- 20 A. Yeah. The paddle wheel. And I thought, well -- and they
- 21 | were running. And I said, well, that's the only thing I see so
- 22 I'm going to head for that. And luckily they turned those off. I
- 23 | got there and I just hung on as long as I could. And that's about
- 24 it. I don't remember how I got out.
- 25 Q. When you said that you watched the video, what was -- where

- 1 did you guys watch the video at? On the boat? Or was it --
- 2 A. We didn't watch a video.
- 3 Q. Oh, they said he showed a video of the --
- 4 A. No. He just demonstrated --
- 5 Q. Oh, okay.
- 6 A. -- how to use the life vest.
- 7 Q. So he actually demonstrated. Did he put one on?
- 8 A. No.
- 9 Q. Okay. What did he do?
- 10 A. He just said it opens up, you put it over your head, you
- 11 bring the strap around, and you click it in the front.
- 12 Q. And this was --
- 13 A. And then he said but you won't need one, so don't worry about
- 14 lit.
- 15 Q. Yeah. Okay. And --
- 16 A. So we didn't worry about it.
- 17 Q. But he never took one off the rack and showed you guys how to
- 18 use it or anything?
- 19 A. He did have one in his hand. You know, like an airline
- 20 stewardess kind of thing.
- 21 Q Okay. All right. When did he say that you were going to go
- 22 to the water first? Was that before you guys left? Or was
- 23 | that --
- 24 A. That was after we were going up the hill.
- 25 Q. All right. From leaving the --

- 1 A. Yeah, from leaving the thing.
- 2 Q. From leaving the beginning?
- 3 A. Uh-huh. We went by some big hotel mansion thing that costs a
- 4 lot of money to stay there. I mean --
- 5 Q. Chateau on the Lake?
- 6 A. Yeah. Maybe that's what it was. And then we went to the
- 7 water, and went in it.
- 8 Q. So, and that -- he told you, did he say why you guys were
- 9 going to the, to the --
- 10 A. Yeah. He said a storm's coming, and it's going to get bad
- 11 and so we're going to go to the water first. So we went to the
- 12 water first.
- 13 Q. Was that -- say that he was trying to beat the storm or what
- 14 was -- or he just said that?
- 15 A. I guess he was just telling what was going. I guess he'd
- 16 been a captain for a long time or something. I don't know. Of
- 17 | course, we had trust in him. We thought he knew what he was
- 18 doing, so -- you know, even an airplane has the life jackets, you
- 19 sit on them.
- 20 O. Yeah.
- 21 A. And if you're going to fall in an airplane, you're probably
- 22 not going to survive but at least your life jacket is handy.
- 23 Q. Yeah.
- 24 A. It was just terrifying.
- 25 Q. I imagine. I imagine that was just --

- 1 A. And there were older people on there, so I assume that's why
- 2 | they couldn't get out, or they didn't know how to swim. I don't
- 3 know.
- 4 Q. Yeah.
- 5 A. There were people trying -- you know, grabbing onto people to
- 6 try to --
- 7 Q. Stay afloat?
- 8 A. -- stay -- but, I mean, you got to kind of -- if you can't
- 9 | hold them up, you got to go do your own thing, so --
- 10 Q. Absolutely.
- 11 A. And then, and that's sad too. So --
- 12 Q. Yep. Your son-in-law told us the story about his daughter
- 13 was coming up to him and trying to grab him, and he just kept
- 14 having to push her away and say paddle with me, paddle with me.
- 15 Don't grab onto me --
- 16 A. Yeah.
- 17 Q. -- or we'll both go down. And he said --
- 18 A. Yeah.
- 19 Q. -- he would go a little ways and then just tell her come on,
- 20 come on, come on. And I told him, I said -- he said that was the
- 21 hardest thing he ever did. So --
- 22 A. Yeah.
- 23 Q. It was bad.
- 24 A. That was bad.
- 25 Q. Listening to him tell the story was, was rough.

- 1 A. Well, he's a talker.
- 2 Q. Yeah. He likes to talk. So --
- 3 A. This is my son, Todd.
- 4 Q. Okay.
- 5 TODD: Hi.
- 6 MSHP TROOPER: Nice to meet you.
- MS. McKINLEY: They weren't there, but they came to see me.
- 8 MSHP TROOPER: Well, I would expect a son to come see you.
- 9 MS. McKINLEY: It's a long ways away.
- 10 TODD: Yeah, it is.
- MS. McKINLEY: hours.
- 12 BY MSHP TROOPER:
- 13 Q. Yeah. Traumatic deal. But I tell you what, we appreciate
- 14 you guys talking to us, and we're glad that you guys are still
- 15 here, and all that good stuff. So --
- But if you think of anything or you have questions, you have
- 17 | my card. And your son-in-law and your daughter have my cell phone
- 18 number, my personal cell phone number.
- 19 A. Okay.
- 20 Q. So if you need to call us and ask any questions, don't
- 21 hesitate. And is there anything else that you can think of
- 22 | that --
- 23 A. Well, I don't think he should have gone on the water if he
- 24 knew the storm was coming in. He shouldn't have done that.
- 25 O. Yeah. Yeah.

JACKIE: And he should have warned the people that boat was taking on water, I think. You know, all of them keep saying he didn't say that boat's taking on water, like --

- Q. Well, and that's a question I had for you. Do you ever remember him saying anything about -- once he -- I know that kids were going up, from what I understand, were the kids going up and kind of driving the the boat for a little bit. And then that stopped. And what happened after that? Did he just not say
- A. Well, like I said, the water was coming in. He put those things down. And, of course, there was no direction on what we should do. So we just assumed, you know, you ride a boat,
- 17 O. Yeah.
- A. So but then it got more bumpy and more bumpy, and it was
 over. You know, I don't know that he had -- I don't know. But,
 when he knew the water was bad, he should have said put a life
 jacket on or something, I guess. But then we would have been
 stuck, in there with a life jacket on. So I don't know if that
 would have helped us or not. It might have just pushed us down
 further. So I don't know.
 - MSHP TROOPER: Les, do you have anything?

- 1 BY MR. LEDET:
- 2 Q. Just one question for you, Ms. McKinley -- it is
- 3 Ms. McKinley, right? You said that you were sitting about the
- 4 middle --
- 5 A. Uh-huh.
- 6 Q. -- of the boat?
- 7 A. Uh-huh.
- 8 Q. Do you -- can you recall what the seating of the vessel, what
- 9 -- do you remember if more people were on one side than the other?
- 10 A. Well, I think some people were -- well, we were leaning like
- 11 this. So the people that were over here probably, as they slid
- 12 over to here, probably helped make the boat sink. I don't know.
- 13 Q. So when you all first went into the water, was it kind of
- 14 evenly sitting, or --
- 15 A. Yeah. Uh-huh.
- 16 Q. It was evenly spread?
- 17 A. It was fine when we went in.
- 18 Q. I got you.
- 19 A. And then the family of 11 that had 9 people die, they were
- 20 all up front. And then we were kind of in the middle, and then
- 21 the others were behind us.
- 22 Q. Any recollection of hearing the captain or who -- anyone
- 23 telling everyone to sit down?
- 24 A. My son-in-law.
- 25 O. Pardon me?

- 1 A. My son-in-law.
- 2 Q. Yeah? Your son-in-law?
- 3 MSHP TROOPER: Your son-in-law said sit down?
- 4 MS. McKINLEY: Yeah, he said, he said you all need to quiet
- 5 down, and you need to settle down and -- and then that's when we
- 6 | floated to the top, because the thing got full.
- 7 BY MR. LEDET:
- 8 Q. Right. It was that quick, huh? Yeah.
- 9 And do you recall anybody, like, getting up and moving around
- 10 in those less than seconds?
- 11 A. Everybody was in their seats --
- 12 Q. Everybody in seats.
- 13 A. -- except the boat went like this, so you kind of -- it was
- 14 kind of hard -- I was on this side --
- 15 Q. Yes, ma'am.
- 16 A. -- so it was hard to stay in our seats. And I was like out
- 17 | in the, in the aisle.
- 18 O. Yes, ma'am.
- 19 TODD: My sister said when it did that, she said she noticed
- 20 | water was up to her, coming up on her legs and she went to tell
- 21 everybody the water's coming in. And so, she said everybody
- 22 was --
- 23 MSHP TROOPER: Is that Tiffany?
- TODD: Yeah. Was trying to push up. And by the time they
- 25 pushed up, it was already under water.

1 MSHP TROOPER: Yeah, that's what -- she told us that, yeah. 2 MR. LEDET: Yeah. That's all I have. Thank you very much. 3 MSHP TROOPER: Steve, you got anything to follow up on? 4 BY UNIDENTIFIED SPEAKER: 5 Did you hear any alarms sounding or any type of buzzing or 6 anything? 7 Uh-uh. I was looking for help. I didn't see any. So, I don't know, I guess the -- I don't know where it was. I'm sure it 8 9 was there, but I didn't ever see any help. There was a guy on the 10 boat, steamship that saw me. And he threw me a life jacket, but I 11 was holding on for dear -- there was no way I could get the life 12 jacket on at that point. And it just kind of floated away from 13 me. 14 MSHP TROOPER: All right. We sure appreciate your time. 15 MS. McKINLEY: Well, tell everybody, the responders and 16 everybody, that we appreciated their help. 17 MSHP TROOPER: Well, that has been relayed many times, and we 18 appreciate that, too. So that's -- we'll just go ahead and 19 conclude, Steve. 2.0 (Whereupon, the interview was concluded.) 21 22 23 24 25
