- MR. KARR: Mr. Depasquale, I appreciate you letting us
- 3 record this interview. I just started the tape device. So I am
- 4 Michael Karr with the NTSB, and present on my side of the phone is
- 5 Lenny Kinnear of the U.S. Coast Guard and Max Green of the
- 6 National Transportation Safety Board. And we're interviewing
- 7 Mr. Depasquale, who was on board the Staten Island Ferry Barberi
- 8 on the morning of, Saturday morning, May 8th.
- 9 Mr. Depasquale, we're conducting an NTSB investigation,
- 10 which is a safety investigation. The reason I'm talking to you
- 11 is, you know, we're trying to look at how your injuries may have
- 12 been prevented and how they occurred, you know, so that we can put
- 13 together some facts and maybe draw some conclusions to make -- to
- 14 improve transportation safety.
- MR. DEPASQUALE: I'll help you out as best I can.
- 16 INTERVIEW OF PHILIP DEPASQUALE
- 17 BY MR. KARR:
- 18 Q. All right. I'd like you to do most of the talking, so
- 19 tell me the story about -- you know, start out by telling me what
- 20 you were going to do that day when you boarded the Staten Island
- 21 Ferry and then tell me what you observed, and if you can
- 22 intermingle, you know, your actions with your observations of
- 23 where the vessel was.
- 24 A. Sure. I was -- I work for the New York City Department
- 25 of Sanitation. I'm a sanitation worker. And I had reported to

- 1 Manhattan that morning to the Department of Sanitation, New York
- 2 City, to a medical clinical and I was just leaving there and
- 3 getting on the ferry to come back to Staten Island.
- 4 And basically, the ride was, you know, uneventful up
- 5 until I would say the last few minutes of docking. And as far as
- 6 I -- I was actually on my cell phone and just as we were coming
- 7 into the dock -- I was up front maybe, I would say, 10 feet, maybe
- 8 15 feet, the most, from the front of the ship -- well, both ends,
- 9 front or rear, I don't know, you know, what terminology you would
- 10 use to describe the front or rear.
- 11 Q. They use -- they call them the Manhattan end and the
- 12 Staten Island end.
- 13 A. Oh, I see, okay. So, yeah, I would say that I was on
- 14 the Staten Island end of the ferry, like I said, about 10, 15 feet
- 15 from the front of the ship. There were several people around me
- 16 and I was right near the staircase leaning -- pretty much trying
- 17 to lean against the wall.
- 18 Excuse me one second? Excuse me one second, I'm sorry.
- 19 Q. Sure.
- 20 (Pause.)
- 21 MR. DEPASQUALE: And I just, like I said, I was on my
- 22 cell phone and was talking to a friend of mine, and I heard a few
- 23 people scream and I sort of like got a peripherals and my body, I
- 24 felt the vessel accelerate. It seemed not to slow down but to
- 25 accelerate and sort of -- when I turned around, I noticed that,

- 1 you know, we were coming in faster and faster and faster. And
- 2 there was really not much time to react.
- And next thing I know, I was up in the air, on the
- 4 floor, hit the wall with my head. I rolled down the stairs and I
- 5 don't really remember much after that except that the paramedics
- 6 were asking me information, my name and whatnot, and I was trying
- 7 to, you know, help them out as best I could.
- Next, I was on a -- when I woke up, I was on a
- 9 stretcher. They had my neck strapped. I couldn't move. I was
- 10 wondering why I couldn't move, and, you know, I woke up in the
- 11 hospital and I was pretty much there for about, I don't know, 7 to
- 12 10 hours. And I guess they ran a series of tests and whatnot, you
- 13 know. I'm not really sure exactly what the story was there. I
- 14 was initially very dizzy. I had a lot of blurred vision and, you
- 15 know, I was just nervous about the whole thing. I didn't know
- 16 exactly what took place. And that's pretty much it.
- 17 Q. I'm thinking of some follow-up questions for you.
- 18 A. Sure.
- 19 Q. Tell me about exactly where you were when you were on
- 20 the cell phone? I'd like to position you on the vessel. I've got
- 21 a sketch.
- 22 A. Schematic?
- Q. I've got a schematic of the vessel. Were you by chance
- 24 -- well, no, let me --
- 25 A. I was more to the left side of the vessel on the Staten

- 1 Island end near the -- pretty much right near the doors that
- 2 opened to the, you know, the exit way.
- 3 MR. KARR: Was that --
- 4 MR. KINNEAR: Right near the top.
- 5 BY UNIDENTIFIED SPEAKER:
- 6 Q. Were you on the main deck or were you by the ramps?
- 7 A. I believe it was the main deck.
- 8 Q. Okay.
- 9 BY MR. KARR:
- 10 Q. All right. I'm writing this down so that -- I'll be
- 11 with you in just a second.
- 12 A. Sure, sure.
- 13 O. I know you told me that you were unconscious. Let me
- 14 walk -- let me try and figure out exactly when that was. When you
- 15 rolled down the steps, were you still conscious?
- 16 A. I felt myself in motion, yes. Of course, there was a
- 17 lot of people flying in different directions. I saw people -- my
- 18 eyes were open, and like I said, I sort of -- after that, I
- 19 remember the fire department was all over me and, you know, asking
- 20 me questions and there was actually one -- I think she was with
- 21 the ferry personnel there. She stayed with me most of the time.
- 22 She was actually trying to speak to me, and I don't know if I
- 23 answered all her questions. At the time, like I said, I don't
- 24 really remember much of what happened after we hit.
- 25 Q. Could you describe her for me?

- 1 A. She just -- I mean, she seemed like a nice lady. She
- 2 had a pleasant voice. She told me that she was with the -- she
- 3 said something about being -- you know, I'm here to help; I'm with
- 4 the crew, something like that. And she was trying to reassure me
- 5 that, you know, everything's going to be okay. You're not alone
- 6 and everything's going to be taken care of, you know, pretty much
- 7 that's what she kept repeating the same thing over and over again.
- 8 Q. I interviewed who I think you are talking about. Car
- 9 you describe what color hair she had?
- 10 A. Brunette. I think, brunette. Tall, I think.
- 11 Q. All right. And are you pretty sure, are you very sure
- 12 that it was the fire department people that assisted you?
- 13 A. That's what I heard, yeah. That's what I heard and,
- 14 like I said, I opened my eyes a few times and I had seen, you
- 15 know, clearly that it was -- you know, they were dressed in full
- 16 fire, you know, fire department equipment.
- Q. Do you remember how you left the vessel?
- 18 A. Not entirely. I woke up and I was being carried by
- 19 several fireman, and they were strapping me in tight and they were
- 20 telling me -- they put oxygen -- I had an oxygen mask on. You
- 21 know, like I said, I couldn't move, so I was -- I woke up startled
- 22 as to what's going on. I don't know, you know, where am I going;
- 23 what am I doing? Of course, they were -- you know, it was just a
- 24 mad -- it was chaos, actually, for a few minutes that -- when I
- 25 woke up, it seemed chaotic.

- 1 (Phone rings.)
- 2 BY MR. KARR:
- 3 Q. Can you excuse me for a second, sir?
- 4 A. Sure.
- 5 MR. KARR: Safety Board, Michael Karr speaking.
- No, he left me a voicemail --
- 7 MR. GREEN: He'll right back with you Mr. Depasquale.
- MR. DEPASOUALE: Sure. Sure.
- 9 BY MR. KINNEAR:
- 10 Q. Oh, while he's on the phone, I have a quick question for
- 11 you. You said you were on a cell phone and you heard screaming.
- 12 Was it the passengers screaming or did you think it was crew
- 13 members screaming?
- 14 A. From all I can see, there was an elderly couple that
- 15 were outside the -- they were actually outside the doors on the
- 16 front, and I think they were the ones -- either they were
- 17 screaming or someone near them was screaming and -- just to my
- 18 left that was.
- 19 Q. Okay. You didn't hear any horn blowing or anything from
- 20 the ferry, did you, or any alarms or any bells going off before
- 21 the hit?
- 22 A. You know, I'm not really sure. I mean, it's possible.
- 23 I might have heard something. I'm not really sure if there was a
- 24 horn. I don't think so.
- 25 Q. Okay. And you felt the ferry gaining speed? You felt

- 1 it kind of going a little faster than normal?
- 2 A. Oh, yeah. No, it definitely seemed to accelerate
- 3 rapidly rather than slow down. I don't know, I mean, I watched
- 4 the news. They said it was mechanical failure or something, the
- 5 engine braking system wasn't -- didn't work properly. They said
- 6 that, you know, it was the same ship that had crashed several
- 7 years ago, I think 2003, so --
- 8 BY MR. KARR:
- 9 Q. This is Mike Karr. Do you take the ferry often?
- 10 A. Yes, I do. And, you know, it's -- that's what that -- I
- 11 never expected it to crash again after what happened in 2003.
- 12 Q. Well, let me -- you're a good person to ask this
- 13 question for, ask this question of. What would you recommend that
- 14 the Staten Island Ferry people do, based on the fact that they did
- 15 have the 2003, they now had this, I mean, how can they protect
- 16 people like you from, you know, falling down stairs and stuff like
- 17 that?
- 18 A. I don't know, create an airbag system throughout the
- 19 entire ship that inflates prior to impact that senses -- I don't
- 20 know.
- 21 Q. All right. Anything else?
- 22 A. No, that's about it. I mean, that's about the best I
- 23 can tell you. I mean, the stairs are hard, the walls are hard. I
- 24 don't know, pad the whole ship.
- 25 Q. Now, were you on the stairs or you were at the bottom of

- 1 the stairs?
- 2 A. I was just at the top of the stairs just before the
- 3 doors, like I said.
- 4 Q. All right. How would you feel about -- how would you
- 5 feel if the Staten Island Ferry people implemented a safety rule
- 6 that said no one could be forward of the ramps or stairs?
- 7 A. Yeah, I mean, that's up to you as far as implementing,
- 8 you know, new safety measures or whatever. But me personally
- 9 after that, I'd rather not take the ferry ever again.
- 10 Q. Oh, really?
- 11 A. Yeah.
- 12 Q. Now that's interesting.
- 13 BY MR. KINNEAR:
- 14 Q. From what you remember, do you remember the deckhands
- 15 being helpful? Did they -- or it's just that woman that stayed
- 16 with you?
- 17 A. It was just the one woman that seemed to be, you know,
- 18 concerned about me. Maybe she saw me fall and hit the wall. I
- 19 don't know. I don't recall exactly, but she seemed to -- not only
- 20 myself, but I guess she was probably trying to help everybody. I
- 21 don't know. She wasn't with me the entire time, that I remember
- 22 anyway.
- Q. I just got one more. You take the ferry a lot and I
- 24 take -- and I'm usually a good ferry -- I'm on there too. Do you
- 25 remember hearing the warning about the stairs that they always

- 1 play?
- 2 A. I'm sorry, what was that? I didn't --
- 3 Q. You know the warning that comes on after they leave a
- 4 dock to stay off the stairs? Did you ever hear that? It comes on
- 5 right after they leave a dock and it says warning stay off the
- 6 stairs?
- 7 A. Yeah. No -- yeah, they have the audible warning that,
- 8 you know, they want no one on the staircase or landing. I've
- 9 heard it myself, yeah.
- 10 Q. Okay. I mean, on that day, you didn't happen to hear it
- 11 before that, did you?
- 12 A. You know, I don't know if they played the -- usually
- 13 that's -- there's a -- I know what you're talking about. It's
- 14 like a pre-recorded message that says the ferry is docking --
- 15 Q. Right.
- 16 A. -- and, you know -- it's more -- you know, it's
- 17 either -- usually -- it's a male voice or a female voice, but I
- 18 know exactly what you're talking about. I don't actually know if
- 19 that went off to tell you the truth. I don't think I heard any
- 20 message that morning.
- Q. Okay. And like you said before, you didn't hear any
- 22 alarms, no bells?
- A. No. I don't recall any alarms or any bells or any
- 24 warning system or any information whatsoever, you know. And, you
- 25 know, it's funny because I was on my phone so if there was, I

- 1 probably wouldn't have been able to continue the call because it's
- 2 so loud you usually can't speak on the phone, you know, while it's
- 3 going off.
- 4 Q. Okay.
- 5 BY MR. KARR:
- 6 Q. So that's an interesting fact. So you were able to
- 7 continue your cell phone conversation right up until the accident?
- 8 A. Yes. And I know from the past that when the thing goes
- 9 off, you know, the audible message that's sent, I usually say,
- 10 listen, I'll call you back, whoever I'm talking to, because you
- 11 can't hear yourself; it's that loud.
- 12 Q. Would you mind giving us the name or having your friend
- 13 call us that you were talking to?
- 14 A. Oh, sure. I mean, I'd have to ask him if that's okay
- 15 with you. I mean, that's fine, but --
- 16 Q. I would like to do that. I think it would be
- 17 interesting to talk to him to see if he recalls anything unusual,
- 18 you know, on your end.
- 19 A. Yeah, the last thing I said to him was I said, oh, shit,
- 20 you know, the ferry's crashing, you know, as -- and I turned
- 21 around and that was -- you know, he said, what, you know. And
- 22 that was, you know -- that was like my -- like I said, it happened
- 23 real quick. So that's about the only thing he's going to be able
- 24 to testify to or, you know, explain is my last words to him.
- 25 Q. Well, and what I'd ask him is if he heard a ship's

- 1 whistle in the back or a ship's horn.
- 2 A. All right. I mean, yeah, I could ask him. I could give
- 3 him your information --
- 4 Q. Yeah.
- 5 A. -- and have him call you.
- 6 Q. Oh, yeah. Because I'm thinking, you know, he's -- you
- 7 know, if I was talking to someone and all of a sudden I heard a
- 8 loud noise, I would recall that.
- 9 A. Yeah. No, I definitely -- I'll definitely ask him. And
- 10 like I said, if he did, I'll have him call you. That's no problem
- 11 at all. I mean, I don't think -- you know, now in recollection, I
- 12 really don't think that I heard anything because, you know, it was
- 13 just so sudden and there was really nothing else, no other noises
- 14 that I heard, you know, that would have, you know, interfered with
- 15 my conversation.
- MR. KARR: All right. Anything else?
- MR. KINNEAR: No, I'm through.
- MR. KARR: All right. I'm good too.
- MR. DEPASQUALE: Well, I hope, I could have been helpful
- 20 to, you know, to your investigation and, you know, I just -- it's
- 21 unfortunate that the whole thing happened. It really is.
- 22 BY MR. KARR:
- Q. No, it is. No, you've been helpful. You've given us
- 24 facts. You know, what we're looking at is, we're looking at, you
- 25 know, how the police, firemen and the ship's crew responded.

- 1 We're documenting where people got hurt, you know, so you've given
- 2 us the position of where you were, so --
- 3 A. You know, I mean, of course, I hope to God that, you
- 4 know, no one got hurt, I mean really seriously and -- you know, I
- 5 mean, as far as the crew and everything else, I'm sure, you know,
- 6 from what they were saying on TV, I'm sure it was just mechanical
- 7 failure. I don't think anybody -- you know, negligence on the
- 8 crew's part. I don't think that was the case from everything I
- 9 watched afterwards.
- 10 Q. Yeah. Well, one of the things -- understanding that
- 11 accidents do happen, you know, one of the things we're looking at
- 12 is how people respond to that.
- 13 A. Yeah.
- Q. You know, you got to think that if you're on a ship or,
- 15 you know, you're going to lose -- you're going to lose propulsion,
- 16 so how do you respond to that.
- 17 A. What do mean, as far as the accelerating you mean?
- Q. Oh, well, yeah, or something -- yes. Yeah, if something
- 19 unusual happens like you can't stop the ferry in time?
- 20 A. Yeah, I mean, it's -- you know, as far as my own
- 21 personal, you know, response, you know, you feel hopeless.
- 22 There's nothing you can do. You know, there's not enough time to
- 23 react and, you know, like here it comes basically. I mean, that's
- 24 my own personal feelings. There's nothing I could do to stop it.
- 25 Q. All right. Is there anything else you'd like to tell us

- 1 about that we have not asked for?
- 2 A. No. I mean, other than that, you know, I mean, the
- 3 whole thing was very -- you know, it scared the shit out of me,
- 4 I'll be honest with you.
- 5 Q. Well, I -- you're not the only one that we've talked to
- 6 that said that.
- 7 A. Okay. Well, you know, I mean, that's got to the be the
- 8 overall consensus because, you know, I never -- you know, of
- 9 course, you know, you never expect something like that to happen
- 10 and it took me completely by surprise.
- 11 Q. All right. Do you have Mr. Green's phone number so you
- 12 can call him back with that other cell phone number?
- 13 A. Yes, I do, yes.
- Q. Okay, good. So, I'd really appreciate it if you could
- 15 reach out to your friend and ask him to give us a call.
- 16 A. I will. I will definitely.
- Q. Okay. Well, we're going to say goodbye to you then. We
- 18 appreciate your time and hope you get better.
- 19 A. Thank you so much. No problem. I hope I was helpful.
- Q. You were. And let me give you my office number in case
- 21 you want to talk to me again.
- 22 A. Sure. Sure. Go ahead.
- 23 Q. My number is 202-314-6455.
- 24 A. 6455.
- 25 Q. But that's -- when I get back to Washington, that's my

1 office number. But when you get that information about your 2 friend, have -- you know, give Max Green a call, and you've got 3 his cell phone. 4 Α. Okay. 5 MR. DEPASQUALE: All right, gentlemen, thank you. 6 MR. KINNEAR: Thank you very much. 7 MR. GREEN: All right, Mr. Depasquale, thank you very 8 much for your time. We appreciate it and you hold on to my 9 contact information so if there are any questions or anything comes up, don't hesitate to call me, all right? 10 MR. DEPASQUALE: All right, Max, take care. 11 12 MR. GREEN: All right, take care. 13 MR. DEPASQUALE: Take, care bye-bye. 14 MR.
