1 INTERVIEW

- 2 MR. KARR: Good afternoon, Mrs. Martinez. This is
- 3 Mike Karr of the National Transportation Safety Board, and I just
- 4 started my recording device, so I'm going to introduce everybody
- 5 again.
- 6 With me on this end of the telephone is Lenny Kinnear of
- 7 the United States Coast Guard, and Max Green of the National
- 8 Transportation Safety Board. And we're going to interview
- 9 Mrs. Martinez, who was on board the Andrew J. Barberi on the
- 10 Saturday morning, May 8th. And the purpose of our investigation
- 11 is to look for safety recommendations that we can do to make
- 12 things safer, and so everything you tell me will become part of
- 13 our factual record and we'll look at those facts to see if we can
- 14 come to any analysis or conclusions about what we might be able to
- 15 do to make vessel transportation safer.
- 16 INTERVIEW OF MS. MARTINEZ
- 17 BY MR. KARR:
- 18 Q. And with that, I'd like to listen to you tell us your
- 19 story and then I'll, you know, make a note of questions I may have
- 20 for you. Then when you're done, I'll ask you some questions to
- 21 get the information we're looking for. I'm mainly concerned with,
- 22 you know, how -- you know, tell me a little bit about why you were
- 23 on the ferry that day, what you observed, anything unusual you
- 24 observed, you know, where you were. We're particularly interested
- 25 about where you were on the vessel --

- 1 A. Uh-huh.
- 2 Q. -- and then, you know, we'll -- you know, walk me all
- 3 the way through to going to the hospital, if you did go to the
- 4 hospital.
- 5 A. Okay.
- 6 Q. All right? So, please begin. And we appreciate you
- 7 talking with us.
- 8 A. Okay. No problem. It was me and my godson, and we were
- 9 on the ferry because we were going to be weekend warriors. It's
- 10 basically volunteer time. We were going to go to one of the parks
- 11 in Staten Island and pick out weeds. It was a fight against
- 12 weeds. And so that's why we were on the ferry.
- We were on the lower deck, in the front, of course, and
- 14 we were -- first it was just us and a couple to the side, and then
- 15 halfway through the ride the couple went inside because it was, it
- 16 was really cold. And then it kind of started drizzling. But
- 17 we -- me and my godson stuck it out right in the front.
- 18 And when we were nearing the port or the whatnot, the
- 19 people that open the gates, they came outside. And it was a
- 20 female on, on the side that we were on. And when you can see --
- 21 we could see the pier coming like very near us, stuff like that, I
- 22 felt the boat kind of like slow down, like almost to a stop, but
- 23 it was like gliding really smoothly. Like basically the engines
- 24 went off. It kind of felt like there was nothing from the engine
- 25 anymore.

- 1 And then this part happened really fast. It, it just
- 2 got closer and closer. She noticed right away and she yelled at
- 3 us to go inside. And she grabbed us and she said get inside, get
- 4 inside. And then she told us to quickly get down. And she
- 5 grabbed us. She covered my godson from the other side. Basically
- 6 we cradled him on the floor. And then we just crashed.
- And, let's see, I guess we both opened our eyes and then
- 8 we checked our -- my godson. We both asked him if he was okay.
- 9 She kept asking him. I kept asking him. And then we took a seat,
- 10 and then there was smoke inside the vessel, the boat. There was
- 11 some smoke. And there were some people with like -- you could,
- 12 you could see that some people were like holding their legs or
- 13 whatnot. There were -- some people were hurt.
- And then we just waited for a while, not long at all,
- 15 until we started seeing police officers coming inside, checking up
- 16 on everybody, seeing if everybody was okay. The -- also, the crew
- 17 members, they were also walking around just asking everybody if
- 18 they were all right. Then we saw some of the workers -- well, I
- 19 saw some of the workers getting like ladders, the ones that
- 20 basically we use to get out of the boat.
- 21 And at first I started like walking with my godson like
- 22 away from the incident, but then I started feeling pain. And then
- 23 I'm like, okay, this doesn't feel right, and so I went back and I
- 24 started talking to a police officer, an EMS, and I told him that I
- 25 was feeling pain, nothing severe but just pain. That's about it.

- 1 Q. Can you remember hearing anything else just before the
- 2 allision occurred?
- 3 A. Okay. Well, since we were the only ones outside and
- 4 then the doors were closed, we didn't hear anything. I can tell
- 5 you that maybe a second before we hit the floor the alarm went
- 6 off.
- 7 Q. Could you describe the --
- 8 A. It was so instantly. It happened right away.
- 9 Definitely the alarm wasn't sounding before. There was one door
- 10 open where the lady that was going to open the gates, she left
- 11 that door open. And, so I didn't hear anything until we were
- 12 already inside and we hit the floor. The alarm went off. The
- 13 crash happened. It was really fast, that part right there.
- Q. What did the alarm sound like?
- 15 A. You know, I couldn't describe it. I can't describe it.
- 16 Q. I'll give you -- I'll make a suggestion and say yes or
- 17 no, and -- but don't -- you know, be positive.
- 18 A. Okay.
- 19 Q. Did it sound like ship's horn or whistle? You know, if
- 20 you do not -- if you don't remember that's fine.
- 21 A. No, I don't remember right now.
- 22 Q. Okay.
- 23 A. Unfortunately, I'm a fire safety director so when I hear
- 24 an alarm I keep thinking about -- I go back to my job and I think
- 25 about that alarm. So, I don't want to confuse it with something

- 1 else.
- Q. Wow, this is -- where are you a fire safety director?
- 3 A. I work at a hotel.
- Q. Do you mind telling me what hotel that is?
- 5 A. The Herald Square Hotel.
- 6 Q. Okay. I'm going to put you on the spot. I'm going to
- 7 ask you what part of your job can you tell me about that would,
- 8 you know, make me understand you definitely would understand about
- 9 fire signals?
- 10 A. Uh-huh.
- 11 Q. I mean, is there any -- are you responsible for the fire
- 12 drills?
- 13 A. Yes.
- Q. Okay. Can I ask you how you qualified for that job?
- 15 A. I was sponsored by my other hotel job. I was there for
- 16 quite a few years and they needed a fire safety. And since I had
- 17 the time served, I knew the building well, they -- the owners
- 18 sponsored me to get my license.
- 19 Q. And did you -- and to get that license did you have to
- 20 go to any training in fire safety?
- 21 A. Yeah, of course.
- 22 Q. Okay.
- 23 A. Yes.
- Q. Okay. Very good. Well, this -- what you've just told
- 25 me, you know, paints a picture of you as a witness that can speak

- 1 well to alarms and things. So, that's good information. I
- 2 appreciate that.
- 3 A. No problem.
- 4 Q. Did you hear any broadcasts over the public address
- 5 system prior to the accident?
- 6 A. Yeah, there was an automatic, like, announcement. There
- 7 was an announcement before, like maybe halfway on our ride,
- 8 getting closer to the pier though (indiscernible) to the port,
- 9 yeah.
- 10 Q. And what did that announcement say, in general?
- 11 A. Something to the effect of thank you for riding the
- 12 south ferry -- let me see -- you know, I don't remember the rest.
- 13 I don't remember.
- Q. I'm writing down some notes. I'll be right with you.
- 15 A. No problem.
- Q. When you heard that announcement, were you inside or
- 17 outside?
- 18 A. No, outside. We were -- we didn't move from the front.
- 19 Q. Okay.
- 20 A. Yeah. Even though it started drizzling we refused to,
- 21 because we were like -- well, I was yelling at Mother Nature. You
- 22 know, I wanted it to stop raining because I wanted to really, you
- 23 know, make this time worthwhile with my godson. So, I wanted it
- 24 to stop raining. So, I'm like, Mother Nature, stop raining, even
- 25 if for a few hours.

- 1 Q. I got you. I got you. Were the doors opened or closed
- 2 at that time?
- 3 A. No, they were closed.
- 4 Q. Okay.
- 5 A. They were closed. Because it was breezy out. It was
- 6 getting -- it was very cold, and that's when the couple went
- 7 inside. Because in the middle of the ride, it was just getting
- 8 very windy. So, it -- we ended up being the only two in the
- 9 bottom deck.
- 10 Q. You described some people had leg injuries, some people
- 11 were hurt. Can you give me -- you know, maybe pick out two people
- 12 you saw and just tell me what you actually saw that made you
- 13 conclude that?
- 14 A. Okay. There was a Puerto Rican lady of a certain age,
- 15 maybe like in her forties, and she -- crew members were like
- 16 checking on her because she's like "my leg, my leg," but it was
- 17 like she was complaining of pain and then she was really upset,
- 18 like yelling. And she's like, excuse my language, "The same
- 19 fucking boat, the same fucking boat from last time." And then the
- 20 crew members were like trying to calm her down, like, "Are you
- 21 okay?" She's like, "Don't check on me; check on the kid," which
- 22 is -- she was pointing at my godson.
- 23 And she was sitting next to a person -- I don't remember
- 24 who they looked like -- what they looked like, but she was sitting
- 25 with somebody else who was hurt also. They were holding their,

- 1 their arm and their -- and the side of their leg as well.
- 2 Q. And do you remember where exactly this lady was sitting
- 3 when she was talking, you know, using the F word?
- 4 A. Yeah. Okay. Me and my godson was sitting on the very
- 5 corner where if you look to the left the door is right there.
- 6 Because if we were -- we were on the floor right there. I just
- 7 got up. I didn't want to walk too much because I didn't know what
- 8 was wrong with my godson at the time. So, I just turned around,
- 9 got up on seats very near to the door, the exit. So we were
- 10 sitting there, and basically we would be looking at the -- we
- 11 would be looking forward to the rest of the boat, where you could
- 12 see all the people on the opposite side. She was sitting on the
- 13 middle aisle on the right -- on my right. On the right.
- Q. All right. I'm getting -- I'm sorry, I -- my spatial --
- 15 I have a hard time putting verbal things with the picture I have
- in my mind, especially on the Staten Island Ferry.
- 17 A. Yeah. Okay.
- 18 Q. So, which way were you facing?
- 19 A. Okay.
- 20 Q. Were you facing Manhattan or were you --
- 21 A. Faced away from the accident, basically out. Basically,
- 22 I was looking towards the water and not towards the accident.
- 23 Does that make it better?
- Q. Well, we're grabbing a -- we're going to grab a diagram
- 25 so we can have it on this end. Let's see, so here is the Staten

- 1 Island end and she was on the main deck.
- 2 A. On the bottom.
- 3 Q. The bottom deck. All right.
- 4 UNIDENTIFIED SPEAKER: This deck.
- 5 MR. KARR: Yes.
- 6 MS. MARTINEZ: Okay, the bottom --
- 7 BY MR. KARR:
- 8 Q. So, which --
- 9 A. The bottom deck is like a semi-circle.
- 10 Q. Yes.
- 11 A. And we were -- if you're looking at the semi-circle,
- 12 we're on the left. But coming back into it we're on our right
- 13 side. Do you understand what I'm saying? We're not --
- 14 UNIDENTIFIED SPEAKER: She left on the left and came in
- 15 on the right. So, this is where she was sitting.
- 16 MR. KARR: Okay. I'm --
- 17 UNIDENTIFIED SPEAKER: In other words, she's over here.
- MS. MARTINEZ: The, the chairs on the side, not on the
- 19 middle, not the aisle seats --
- 20 UNIDENTIFIED SPEAKER: Right there.
- MS. MARTINEZ: -- but on the side, on the wall. You
- 22 could say the closest chairs next to the doors.
- 23 That's when the girl grabbed -- the lady, the worker,
- 24 she told us to get down. We fell right there near that -- near
- 25 those doors. So, on my right side it was some chairs and I took

- 1 my godson to sit there.
- It's on the right side. I would be able to -- I was
- 3 closest to the water on the right side.
- 4 MR. KARR: Now she's talking about --
- 5 MR. KINNEAR: No, the right side of the boat coming in.
- 6 MR. KARR: -- I thought you said --
- 7 MR. KINNEAR: You're on the right side of the boat
- 8 coming into Staten Island?
- 9 MS. MARTINEZ: Okay, let me make sure I'm -- yeah, if
- 10 I'm coming into Staten Island, we were on the left side then.
- MR. KINNEAR: Okay. She was over here.
- MS. MARTINEZ: You guys are -- okay, I'm confusing you.
- 13 I'm sorry. When we're coming in, we were on the left side of the
- 14 boat.
- MR. KINNEAR: Right there.
- MS. MARTINEZ: But sitting down, I'm looking towards the
- 17 back of the boat.
- 18 MR. KINNEAR: Yes, these seats right here.
- MR. KARR: Okay.
- 20 MR. KINNEAR: She was looking that way.
- MR. KARR: Got you.
- 22 BY MR. KARR:
- 23 Q. And do you remember where that -- and where was that
- 24 lady sitting that had the leg injury?
- 25 A. Okay. She was sitting on the -- there's like some

- 1 seatings in the middle, like a middle aisle.
- 2 Q. Yes.
- 3 A. She was on the left to us in the middle aisle.
- 4 Q. Okay.
- 5 A. Yeah. She -- like I was in a clear view kind of like
- 6 diagonally, like towards an angle. I could see her in front of
- 7 me, you know, and she was yelling and upset and she was holding
- 8 her leg.
- 9 Q. No, this is good, because we have some security video,
- 10 so from what you tell us we can match up with that person. And it
- 11 helps piece together where all the injuries occurred.
- So, let's see, more questions. How did you and your
- 13 godson get off the boat?
- 14 A. Okay. Just let me -- okay, I hope I don't confuse you
- 15 some more. Well, from where we were sitting, when the crew
- 16 members and -- the crew members, how do I say this, they were like
- 17 walking around, checking on everything, trying to see -- you know,
- 18 there was a little bit of smoke inside. We were all inside, so
- 19 there's a little bit of smoke. So they're like walking around
- 20 checking on everybody, just walking around and checking.
- 21 And they said -- oh, no, let me make sure. Then some
- 22 police officers came in first, and then they were like if you can
- 23 move and you can walk, please go to the left. Please go to the
- 24 left side of the boat. And I could see everybody, practically
- 25 everybody from what I can see, moving towards the left and like

- 1 making a line to exit. And I sat back down and I just, you know,
- 2 sat down with my godson and I just waited for the crowd to, you
- 3 know, just start moving because we were just standing there. And
- 4 the crew members -- that's when I saw more like ladders, or stair
- 5 looking things, and they were like bringing it towards outside.
- And then between the upper level and us and the lower
- 7 level we were taking turns trying to exit out. And the -- we
- 8 climbed over a ladder and it was like from the boat to the pier --
- 9 to the port, I mean. And they were telling us to watch our heads.
- 10 There was like some kind of pipe above our heads. And that's how
- 11 we got off; we had to climb on two different ladders actually.
- 12 Q. Were these ladders -- did they look more like stairs or
- 13 like a ladder a painter might use?
- 14 A. More like stairs.
- 15 Q. Okay.
- 16 A. Yeah. Yeah.
- 17 Q. Do you remember about how wide they were? Just an
- 18 estimate.
- 19 A. About two feet, a little over two feet. It wasn't
- 20 narrow at all. It was comfortable, you know.
- 21 O. Good.
- 22 A. I'm not a fan of ladders or stairs at all, especially if
- 23 I can see the bottom. I can't -- I get nervous about them. But I
- 24 felt comfortable. This was pretty sturdy.
- 25 Q. And what was it made of?

- 1 A. Metal.
- 2 Q. Metal? Okay.
- 3 A. Yeah.
- 4 Q. And about how far do you think you had to climb from the
- 5 deck you were on to the dock?
- 6 A. Oh, not much at all, actually.
- 7 Q. Was it, you know, your height, half your height?
- 8 A. Well, I had to duck down. I'm 5'8", so I had to duck
- 9 down. My godson barely had to. But I had to duck down, let's
- 10 see, like a foot or two, maybe -- a foot. I had, you know --
- 11 Q. You had to duck down -- what I'm envisioning you told me
- 12 is that the boat was lower than the dock and you had to climb up
- 13 to the dock. So, with those steps you went up, I'm wondering what
- 14 was the distance that you had to climb.
- 15 A. No, I'm sorry. I don't understand.
- Q. Oh, well, you mentioned that there was a ladder or there
- 17 were steps.
- 18 A. Yeah, that -- the ladder.
- 19 Q. The ladder?
- 20 A. Yeah.
- Q. So, were those ladders used to climb up or was that just
- 22 to connect the boat --
- 23 A. Not -- like climb up maybe like three steps.
- 24 O. Okav.
- 25 A. And then we were walking across.

- 1 Q. Oh, then they set up -- okay, you climbed up three
- 2 steps --
- 3 A. Uh-huh.
- 4 Q. -- and then you walked --
- 5 A. We were walking across.
- 6 Q. And how wide was that?
- 7 A. About the same thing.
- 8 Q. Wow. Was there water underneath you?
- 9 A. No.
- 10 Q. Okay. All right.
- 11 A. No.
- 12 Q. So, it's like they made a little bridge to get you off
- 13 the ferry?
- 14 A. Yeah, they did.
- 15 Q. Okay.
- 16 A. But the boat was really stuck on the port. It wasn't
- 17 moving.
- 18 Q. Okay.
- 19 A. You know how you can feel the rocking? No, no, there
- 20 was no rocking here.
- Q. All right. Do you travel on the Staten Island Ferry
- 22 often?
- 23 A. It's been a while. Me and my godson did the ferry two
- 24 -- about two weeks ago, or three weeks ago. We did the million
- 25 trees sponsored by Bloomberg. We planted some trees at a park.

- 1 And that was his first time.
- 2 MR. KARR: Do you -- Lenny, do you have any questions?
- 3 UNIDENTIFIED SPEAKER: Why don't we get (indiscernible)
- 4 the godson's name --
- 5 MR. GREEN: Okay.
- 6 UNIDENTIFIED SPEAKER: -- (indiscernible).
- 7 MR. GREEN: All right.
- 8 MR. KINNEAR: Because I don't know if we have him.
- 9 MR. KARR: Okay.
- 10 BY MR. KARR:
- 11 Q. Ms. Martinez, we do not have any information on your
- 12 godson. Could we get his name and any injuries that he may have
- 13 had?
- A. My godson's name is Bruce, B-R-U-C-E, Mayfield. He
- 15 didn't suffer any injuries that -- I mean, just a few cuts. When
- 16 he was told to go down there, we fell -- at the same time we were
- 17 going down, he just like -- I checked on him and all he said is
- 18 that his -- like he banged up his knee. I lifted his pant leg to
- 19 check his right side, I think it was, and it looked like barely a
- 20 scrape but no bleeding or no skin, no nothing. It was just like
- 21 you could tell that the pants rubbed on the skin hard. That's it.
- 22 So, he was good, thank God.
- Q. Would you mind giving us personal information on him
- 24 that we have on our list?
- 25 A. I would have to speak to the mom first.

- 1 MR. KARR: Well, let's see, what information are you
- 2 looking for?
- 3 MR. KINNEAR: Oh, the injury is --
- 4 MR. GREEN: So, if they went to --
- 5 BY MR. KARR:
- 6 Q. Did he go to a hospital?
- 7 A. Yeah, he came with me. They checked him, yes.
- 8 Q. Okay. All right. And which hospital was that?
- 9 A. The University --
- 10 Q. Richmond University Medical Center. Okay.
- 11 A. Yeah.
- MR. KINNEAR: Well, I guess, we can always -- we always
- 13 know we can get -- we can always contact --
- MR. GREEN: Yeah. Do you have a phone number for his,
- 15 for his mother?
- 16 BY MR. KARR:
- 17 Q. Would you like to give us the phone number to his mom?
- 18 A. Sure. Hold on for a second. Let me get that, okay?
- 19 Q. Okay. Thanks.
- 20 MR. GREEN: That's good, because it just kind of gives
- 21 us an idea of who is who. It might make sense that
- 22 (indiscernible) kids --
- MR. KINNEAR: Yes. Yeah. Yeah, yeah, yeah.
- 24 MR. GREEN: -- minors, minors that were traveling.
- 25 Makes sense.

- 1 MR. KINNEAR: Yeah, I know there was three kids with one
- 2 lady.
- 3 MS. MARTINEZ: Hello?
- 4 BY MR. KARR:
- 5 Q. Yeah, we're back.
- 6 A. Okay. The number is
- 7 Q. Okay.
- 8 A. And mom's name is Alleina Benjamin.
- 9 Q. Thank you.
- 10 A. Uh-huh.
- 11 Q. It's A-R-L-E-N-E?
- 12 A. No, A-L-L-E-I-N-A.
- 13 Q. All right, thank you. Alleina Benjamin?
- 14 A. Yeah.
- 15 Q. Okay.
- 16 A. We're -- we don't have any more questions for you,
- 17 except to ask you if you've got anything for us that you'd like to
- 18 tell us about that we didn't ask you, you know. And is there
- 19 anything you can recommend that might be able to prevent, you
- 20 know, things from happening. And, you know, I know there was a
- 21 mechanical failure that they're investigating but, you know,
- 22 sometimes stuff happens. Is there anything that the ferry could
- 23 do differently with regard to crowd control to prevent accidents
- 24 from happening or, you know, from injuries occurring?
- 25 A. Honestly, no. If -- everything was great. The lady

- 1 that opens the gate was the lady that was there for us. She acted
- 2 tremendously. She was great. I wish I can find her and thank her
- 3 because she was -- she acted really quickly. It's like she picked
- 4 up on it really quickly, saw that we weren't slowing down at all
- 5 and she just yelled at us to get in and get down. She was
- 6 amazing. She did great.
- 7 As far as safety, everything seemed great. We -- as a
- 8 fire safety director, all the aisles were neat and clean. Nothing
- 9 in the way, you know, nothing that could have caused somebody to
- 10 have an accident unless they, you know, tripped over like they did
- 11 in an accident, in the crash.
- 12 Q. Are you one of those persons that always keeps an eye
- 13 out for those things no matter where you go?
- A. Out of habit, yeah.
- Q. Okay, good. That's a good thing to know.
- 16 A. Okay. But, like I said, no, I couldn't -- right now,
- 17 no.
- 18 Q. Okay. How would you feel if they had rules that kept
- 19 people -- let's say, you know, maybe five minutes before they
- 20 landed that they kept people inside, like off the stairs, prior to
- 21 arrival?
- 22 A. Off the stairs definitely, because you can slip, you
- 23 know. Sometimes it's not a smooth landing, let's just say. So,
- 24 off the stairs, yes. I mean, if you're on solid ground, I mean,
- 25 stable ground, I -- that's okay. To stay inside, I would hate for

- 1 my godson not to experience what I experienced when I used to ride
- 2 the ferry, you know. He loved the ferry. Like, he loved planting
- 3 trees when we went two weeks ago --
- 4 Q. Uh-huh.
- 5 A. -- but he spoke a lot about the ferry. He really liked
- 6 it a lot. And so I wouldn't want him to miss out on standing
- 7 outside if, you know, the weather is right and experiencing that,
- 8 you know. And I'm happy he did experience it because he -- that's
- 9 all he talked about besides planting trees.
- 10 Q. Yes. Well, what about if you could stand outside until
- 11 about five minutes before landing and they ordered everybody off
- 12 the open deck and away from the steps?
- 13 A. It would be a little time consuming, but I -- for safety
- 14 precautions I wouldn't complain at all, you know.
- 15 Q. Okay. All right. So, your godson would miss being out
- 16 there right in front when they land, which I think is pretty
- 17 neat --
- 18 A. Uh-huh.
- 19 Q. -- but he could live without that?
- 20 A. It's five minutes, you know.
- Q. Okay. All right. Well, you've been -- thanks, and I
- 22 really appreciate learning about your fire safety interest and
- 23 career because that makes you a very interesting witness for us.
- 24 So, we appreciate that. And I'm going to turn it over to -- oh,
