Wednesday October 17, 2012

Tracie 9:32am: OK. Tell him to shut down the old one. I will wait 10 minutes before I start to make sure its o
Robin 9:34am: I'll turn off old phone now. We have backed it up on iTunes for transfer to new phone.
Tracie 9:35am: Perfect
Robin 12:40pm: Picture accompanied with text (boat off the rails). Text: One month. We could actually leave tonight if we needed to. Nasty weather. Departure for Sunday.
Tracie 1:10pm: Ok. Will you be hanging around at the shipyard or the whottons wharf?
Robin 1:41pm: Shipyard wottons cost money
Tracie 1:42pm: Oh ok.
Robin 4:02pm: Yes. Did you get the picture I sent you.
Tracie 4:12pm: Of the boat out of the water? Yes
Tracie 4:13pm: In april we bought 2 types of racor filters. 2 micron and 30 micron. I am calling Hamilton to make sure they stock both.
Tracie 4:30pm: Hamilton has 15 of the 2 micron filters and will have 10 by tomorrow of the 30 micron filters.
Tracie 4:31pm: I can order them online and have them to you by Friday if you tell me which one.
Robin 4:38pm: 30 micron two cases would be great
Robin 4:39pm: we have the two
Tracie 4:39pm: ok I will order and ship direct
Robin 5:00pm: Thx
Tracie 5:01pm: A case has 12. So do still want two cases
Robin 6:46pm: Two cases would be great

Thursday October 18, 2012

Tracie 2:01pm: Did David Wyman call you yet?
Robin 2:04pm: Yes he did. Be down in the morning.
Tracie 2:05pm: Perfect. Insurance company has agreed to in water survey

Saturday October 20, 2012

Robin 10:46am: We have not seen the rancor filters
Tracie 11:57am: They should have been delivered to the shipyard yesterday.
Tracie 12:03pm: Let me try to track them. Did David Wyman come yesterday I thought I had the tracking info in my emails and I don't. I know it shipped via Fedex. The supplier sent us the tracking info on Thursday.
Tracie 12:21pm: Having Reese do something and track it. Give me a few minutes.
Tracie 12:27pm: Fedex is showing it on the truck for delivery today. Is there anyone at the shipyard to take delivery
Robin 3:56pm: Bob should be happy with the bill. 84,000 Down from 87,000
Tracie 4:51pm: Oh he will be thrilled...NOT
Robin 5:02pm: Seen no filters. I will check again but no one is in the yard
Tracie 5:03pm: I tried to track it a half hour ago and it still says on truck for delivery
Tracie 5:04pm: I don't know what else to do. It shipped out Thursday next day delivery that obviously didn't get there
Tracie 7:11pm: Fedex attempted to deliver pkg today at 1:30 but no one was there

Tracie 9:49am: ok

Monday October 22, 2012

Tracie 10:24am: He got the pic. Thanks
Tracie 4:00pm: Havent been able to get in touch with the dock master in new London. Emails and messages left to let them know your coming in tomorrow at 7ish. Harbor master has been told too

Tuesday October 23, 2012

Robin 9:07am: We are here. Lura and Dan will be on the 12:00 ferry
Tracie 9:27am: ok
Tracie 10:32am: Do you know where they need to go once we pick them up at ferry? Rob is having Dana pick them up and bring them to the doctor but she doesn't know where to go
Robin 12:27pm: No I don't. Bob is suppose to know. Have Danna call Joe White

Wednesday October 24, 2012


Robin 8:13am: Bring over a flash drive tomorrow. I will get pictures ready today
Tracie 8:14am: Ok. I am picking up stoves today
Robin 8:15am: Thx. You will make the galley happy
Robin 9:35am: Can you find out if bob can bend 1-1/2" pipe
Tracie 9:36am: Bob id in Baltimore today

Thursday October 25, 2012

Robin 7:20am: Good morning miss Tracie are you and Ron doing the sail with us or are you just kissing us good bye and leaving
Tracie 7:26am: We are doing the sail...
Robin 7:41am: Great. This will be fun even if there is no wind
Tracie 7:41am: Looking forward to it...
Robin 7:45am: Can you take Jessica to the store for last minute shop. We have no idea where there might be a store
Tracie 7:49am: Does she need a lot of stuff
Tracie 7:57am: How long do you think the sail will be?
Robin 8:37am: No she needs probably less then 10 items. I was going to ask you how long a sail. If up to me about 4 hours.
Robin 8:37am: We could send you a list of items
Tracie 8:38am: No I was trying to figure out what ferry I can catch home
Robin 8:39am: Okay
Robin 8:40am: I think you should be out of here by five. I would like to the shop before the sail
Tracie 8:41am: Are you going to bring the stoves on first or after the sail?
Robin 8:43am: We are talking about that right now. Probably before. When we get back I want to leave
Tracie 8:43am: Ok. We just got off the ferry. Heading your way
Robin 8:45am: I am going to take the old ones off the boat right now so we can put the new ones on when you get here.
Tracie 8:47am: Ok. I will google a supermarket. I will also need tables set up for the food.
