## 1 INTERVIEW

- MR. NICHOLSON: Good afternoon. Today is Thursday, July
- 3 17th, 2014. My name is Matthew Nicholson. I am an investigator
- 4 with the National Transportation Safety Board in Washington, D.C.
- 5 We are at the Law Firm of Cory, Watson, Crowder and DeGaris in
- 6 Birmingham, Alabama for the interview of Antuan Mabry. This is
- 7 case number DCA-14-MP-001.
- 8 This interview is being recorded and may be transcribed
- 9 at a later date. A copy of the transcript will be provided to the
- 10 interviewee for review prior to being entered into the public
- 11 docket.
- We'll now go around the room. I'll ask that each person
- 13 introduce themselves. Please state your name with spelling, your
- 14 title, and the agency or organization you are representing. I
- 15 will start and we'll proceed to my right.
- 16 My name is Matthew Nicholson, spelled M-a-t-t-h-e-w,
- 17 N-i-c-h-o-l-s-o-n. I am an investigator with the National
- 18 Transportation Safety Board.
- 19 MR. CHHATRE: I'm Ravi Chhatre. That's R-a-v-i,
- 20 C-h-h-a-t-r-e. I am pipeline accident investigator with National
- 21 Transportation Safety Board.
- MS. McATEE: I'm Nancy McAtee, N-a-n-c-y, M-c-A-t-e-e.
- 23 And I'm a fire and explosion specialist with the National
- 24 Transportation Safety Board.
- 25 MR. ALLEN: My name is Mitch Allen, A-1-1-e-n. I'm one

- 1 of the attorneys representing Antuan Mabry.
- 2 MR. BLACKWOOD: I'm Keith Blackwood, K-e-i-t-h,
- 3 B-l-a-c-k-w-o-o-d, pipeline safety investigator, Alabama Public
- 4 Service Commission.
- 5 MR. GARDNER: Bob Gardner, G-a-r-d-n-e-r, Director of
- 6 Quality Assurance and Compliance for Alagasco and party
- 7 representative.
- 8 MR. DiGIORGIO: Rick DiGiorgio, spelled D-i-G-i-o-r-g-i-
- 9 o, attorney for Antuan Mabry and his family.
- MR. MABRY: I'm Antuan Mabry, A-n-t-u-a-n, M-a-b-r-y.
- 11 MS. WATSON: My name is Leila Watson. I'm one of the
- 12 lawyers representing Antuan Mabry. L-e-i-l-a is my first name.
- MR. NICHOLSON: Okay. To begin with Antuan, I thought
- 14 I'd start with just some background information.
- 15 INTERVIEW OF ANTUAN MABRY
- BY MR. NICHOLSON:
- 17 Q. If you could, can you tell us your age, how old you are?
- 18 A. Nineteen.
- 19 Q. Nineteen. And will you confirm for me the address and
- 20 unit number where you lived in Marks Village?
- A. My address is \*\*PII\*\* .
- MS. WATSON: No, that's -- he wants to know the address
- 23 in Marks Village.
- 24 MR. NICHOLSON: Yeah. Do you recall --
- 25 MS. WATSON: Not the \*\*\*\*\*\*\*\*\*\*\*\*\*\*\* address.

- 1 MR. MABRY: I don't remember.
- 2 BY MR. NICHOLSON:
- 3 Q. That's fine. Do you remember the unit number?
- 4 A. No.
- 5 Q. Okay. That's fair enough. Was --
- A. Yes, yes, I remember the unit number. The unit number
- 7 was 80. I'm sorry.
- 8 Q. 80. That's perfectly all right. Okay, 80.
- 9 And was Unit 80 in Marks Village your permanent address?
- 10 Did you live there full time?
- 11 A. Yes.
- 12 Q. Okay. Are you in -- were you in school --
- 13 A. Yes.
- Q. -- at the time of the accident? Okay.
- 15 Can you tell me a little bit just what your daily
- 16 schedule was, not necessarily -- just make it the day before the
- 17 accident. What's a typical day of that week for you, your
- 18 schedule?
- 19 A. After I came from school?
- 20 Q. When you got up in the morning, what time did you get up
- 21 usually?
- 22 A. Oh, 7, 7:15 maybe.
- Q. Okay. And then what time would you head out to school
- 24 or eat breakfast or --
- 25 A. I will head out to school at 8:15.

- 1 Q. Okay.
- 2 A. And I will walk to Woodlawn, which is like down the
- 3 street.
- 4 Q. Okay.
- 5 A. And I don't usually eat breakfast at school.
- 6 Q. Okay.
- 7 A. So -- and go about my regular day at school and, you
- 8 know, everything. Just come home, maybe go in my room.
- 9 Q. What time would you get home?
- 10 A. Watch a little TV. Well, I'd get home about, maybe
- 11 about 4, 4:30-something.
- 12 Q. Okay.
- 13 A. It's a long walk.
- 14 Q. Is it? Okay.
- 15 A. Yeah. So I might go in my room and watch a little TV.
- 16 Q. Sure.
- 17 A. And then I'll go in my studio.
- 18 Q. Okay.
- 19 A. Which is like the next room over from my room.
- 20 Q. Okay.
- 21 A. And it's like I'll be doing music all day.
- Q. Okay. Cool.
- 23 A. That's basically it.
- 24 Q. That sounds like a decent schedule there.
- I'm going to ask you now -- actually, before I ask you

- 1 to draw on those, those maps in front of you, can you just tell me
- 2 how long you've lived at Marks Village until the time of the
- 3 accident?
- 4 A. Maybe about 4 years.
- 5 Q. Four years? Okay.
- 6 Okay. So you've got in front of you two layouts of Unit
- 7 80, which should be Unit 80, the first floor and second floor.
- 8 And what would help us out is if you could just kind of label
- 9 where -- you can start on the first floor and maybe label where
- 10 the door that you used the most, what was the front door or the
- 11 back door, any large appliances that were in the apartment.
- MS. WATSON: See where these are -- these are
- 13 (indiscernible) --
- 14 BY MR. NICHOLSON:
- 15 Q. So I'm asking you to draw on --
- 16 A. Oh, okay. These are the walls.
- 17 O. Those are the walls.
- 18 A. These are walls -- these are --
- 19 Q. Yeah, exactly.
- 20 A. -- doors.
- 21 Q. Yep.
- 22 MS. WATSON: And this, this is the bathroom.
- MR. MABRY: Bedroom.
- 24 MS. WATSON: That's the downstairs.
- MR. MABRY: The laundry room.

- 1 MS. WATSON: Yes.
- MR. MABRY: The kitchen. Okay.
- 3 BY MR. NICHOLSON:
- 4 Q. Excellent. That it?
- 5 A. Yeah.
- Q. Yeah. So if you could just label it, like you said, if
- 7 you could write whose room this was and where the bed was and the
- 8 dressers and all that stuff.
- 9 A. There's a bed here, dresser here.
- 10 Q. And then, Antuan, when you draw the beds, show me where
- 11 the pillows were, where the head of the bed would be. Excellent.
- 12 A. I don't know why that's there because she's never laid
- 13 that way. There's the TV right here.
- Q. Okay. Can you write TV in there, too? Sorry. And then
- 15 was that a dresser next to that TV?
- A. Um-hum, a small little dresser, right in the middle over
- 17 here.
- 18 Q. Oh, this box here, the dresser?
- 19 A. Yes, sir. Um-hum.
- Q. Can you write dresser or just a D? Yeah, that's fine.
- 21 And were there any little heaters or little fans or
- 22 anything in --
- 23 A. She had a fan.
- 24 Q. Okay.
- 25 A. And she always had it right here, and a little trash can

- 1 right here. Trash can. That's it in her room.
- Q. Okay. That's perfectly fine. That's great. I'll just
- 3 ask you one question about this, Antuan. Was this -- was her bed
- 4 really like this or was this -- was it up against the wall?
- 5 A. It was against the wall.
- 6 Q. Oh, okay. Can you just draw an arrow from that to the
- 7 wall so I know? There. Perfect. Okay.
- 8 A. I guess it's kind of against the wall.
- 9 Q. Okay.
- 10 A. That dresser was long.
- 11 Q. Okay.
- 12 A. I remember that. And the living room, there was
- 13 a -- yeah. She moved the living room around a lot. So, I
- 14 remember there being a sofa here. Sofa here. There's a sofa
- 15 here. There was a table here, a table here. A little, a long
- 16 table here. There was a table in the middle, right here. There
- 17 was a carpet here. There was a big carpet here.
- 18 Q. Okay.
- 19 A. It was a stand here where her radio sit on. It was
- 20 like a -- it had a mirror in it too.
- 21 O. It was like a what?
- 22 A. It was like a, like a -- something like, you know, a
- 23 radio sit on.
- 24 Q. Okay.
- 25 A. And this is a table, too, but the table's like a open

- 1 table, like you slid your --
- 2 O. Oh, it had shelves?
- 3 MS. WATSON: Like a shelf? Bookshelf?
- 4 BY MR. NICHOLSON:
- 5 Q. A bookshelf? Okay.
- 6 A. That's a bookshelf.
- 7 Q. Okay.
- 8 A. Bookshelf. She had a lamp. She had a lamp. There was
- 9 a lamp here. There was another lamp -- there was a lamp there.
- 10 Q. What's that you put there?
- 11 A. A lamp.
- MS. WATSON: A lamp.
- MR. NICHOLSON: Oh, a lamp. Okay.
- MR. MABRY: And that's it in the living room.
- 15 BY MR. NICHOLSON:
- 16 Q. Okay. What about a kitchen?
- 17 A. The kitchen, over here somewhere. Refrigerator was
- 18 here. There was a deep freezer here right next to the fridge.
- 19 Q. Okay.
- 20 A. Deep freezer.
- O. Microwave?
- 22 A. There's a counter, a counter here.
- Q. That's right. There actually is a counter. You're
- 24 right.
- 25 A. Counter. Counter here. There's a table that sat here.

- 1 Table. The washer was here. Washer. Dryer was beside. There
- 2 was a bookshelf like, like a bookshelf -- a cabinet.
- 3 Q. Yeah. Okay.
- 4 A. And there was a cabinet here. And that's in the
- 5 kitchen. And there was a microwave sitting right here.
- 6 Q. Okay.
- 7 A. Yeah. That's it.
- 8 Q. Okay. And then as far as the doors, was this the door
- 9 that was most commonly used by the family or was it the -- this
- 10 other door?
- 11 A. Well, me and my brother used it to, like, go to school,
- 12 like we used it to go to school.
- 13 Q. This one here, on the north?
- 14 A. Um-hum.
- 15 Q. Okay. So you considered this maybe the front door?
- 16 A. Um-hum.
- 17 Q. Okay. Can you write --
- 18 A. No, this is the back.
- 19 Q. Call it the front -- well, label them however you would
- 20 have --
- 21 A. Okay.
- Q. And you say you and your brother used the back door?
- 23 A. Used the back door.
- 24 Q. Okay.
- A. Um-hum.

- 1 Q. And did -- does that mean your --
- 2 A. And to come to school we used the front door.
- 3 Q. You did?
- 4 A. Come home from school.
- 5 Q. Oh, okay. And you'd come back the other way. Okay.
- 6 Okay. Terrific. All right. So you think we got everything
- 7 there?
- 8 A. Yeah.
- 9 Q. How about the second floor? Label the rooms the same --
- 10 same exercise.
- MS. WATSON: Stairs coming up.
- MR. NICHOLSON: Well, yeah.
- MS. WATSON: Here -- yeah.
- 14 BY MR. NICHOLSON:
- 15 Q. So this is how you go down the stairs. That way, right?
- 16 A. Going down.
- 17 Q. Yep.
- 18 MS. WATSON: And there's the bathroom and then the hall
- 19 down the middle.
- MR. MABRY: Yeah. Okay. This Corey's room, front of --
- 21 his bed sat here. His bed sat here. That was, that was twin bed.
- 22 He set them like on top.
- BY MR. NICHOLSON:
- Q. Sort of like bunk beds, or --
- 25 A. Beside each other.

- 1 Q. Oh, okay. Okay.
- 2 A. And make it a full one.
- 3 Q. Yeah, okay. And where are the pillows on that one?
- 4 A. Pillows were here.
- Q. Okay.
- 6 A. Okay. And he had a desk here. Drawer -- dresser. And
- 7 he had a TV sitting on this dresser. And he had another one
- 8 beside. He had a TV set on this one. TV -- I'm sorry.
- 9 Q. That's all right.
- 10 A. That's all of them by his bed.
- 11 Q. No fans or space heaters or air-conditioning ducts?
- 12 A. No.
- This was my studio room.
- 14 Q. I'm sorry? Studio room?
- 15 A. Studio room.
- 16 Q. Okay.
- 17 A. I called it my studio room because my studio was in
- 18 there. I had a long black table here, which my computer sat on.
- 19 Computer. I had another laptop where I had the desktop, and then
- 20 I had the laptop with just a little screen.
- 21 Q. Okay.
- 22 A. I had just a screen, the monitor.
- Q. A monitor?
- A. I had the monitor.
- 25 Q. Okay.

- 1 A. So monitor. And it was connected out -- I had a table
- 2 here, catty-corner. It had a piano on, sitting on top of it. My
- 3 mic was in the closet.
- 4 Q. Is that a piano or like a keyboard or --
- 5 A. It was a, it was a keyboard.
- 6 Q. Okay.
- 7 UNIDENTIFIED SPEAKER: Electric, plug-in?
- 8 MR. MABRY: It was a microphone. And --
- 9 BY MR. NICHOLSON:
- 10 Q. What was -- what's that you were just drew? I'm sorry?
- 11 Oh, microphone? Oh, okay.
- 12 A. That's the microphone. It was in the closet. That's
- 13 all I had.
- Q. Can you just write studio on there and on the --
- 15 Antuan's studio.
- 16 A. Okay. And my room, I had a tall dresser here. My bed
- 17 sat here. I had a small dresser here. That's it for my room, a
- 18 bunch of clothes in the closet.
- 19 UNIDENTIFIED SPEAKER: Did you have a TV in your room?
- MR. MABRY: Yeah, I had a TV on the dresser, sitting on
- 21 top of the dresser.
- BY MR. NICHOLSON:
- Q. Antuan, that's a dresser with a TV?
- 24 A. Um-hum.
- Q. What's this, another dresser?

- 1 A. Um-hum, a small dresser.
- 2 Q. Okay.
- 3 A. And that's a tall dresser with a TV set on top.
- 4 Q. Okay. Sure. So two dressers. All right.
- 5 A. Do I do like the storage, too?
- Q. If you know what's in there. Was there anything big in
- 7 there or what kind of stuff was kept in that storage area?
- 8 A. Just a bunch of junk.
- 9 O. Junk. Yeah. Like mine.
- 10 A. All their stuff. I only know there was a bed in here
- 11 because I never went in her room. I know she had a heater, a
- 12 little heater.
- 13 Q. Okay.
- 14 A. Kept it like here. She had a little bucket and it sat
- 15 near the --
- 16 Q. A little what?
- 17 A. A bucket. Like a --
- 18 MS. WATSON: Those plastic storage bins.
- MR. NICHOLSON: Oh, yeah.
- MS. WATSON: One of those bins, right.
- 21 BY MR. NICHOLSON:
- Q. Yeah, right. Okay. Kind of like a bucket. Okay. I
- 23 get it. All right.
- 24 A. She had the TVs. I don't remember what they sat on.
- 25 That's -- I don't remember her having a (indiscernible), but --

- 1 Q. Okay. We'll just say TV stand or something. How about
- 2 that?
- 3 UNIDENTIFIED SPEAKER: Just put TV there in that spot.
- 4 MR. MABRY: TV here on this spot. Yeah.
- 5 BY MR. NICHOLSON:
- 6 Q. Okay?
- 7 A. Yeah.
- 8 Q. You like it? Can you, down in the corner, just put your
- 9 name, Antuan, and the date? It's the 17th of July. Just so I
- 10 don't confuse your drawing with someone else's.
- 11 A. It's the 17th, you said?
- 12 Q. Yeah. I've got July 17. Excellent. Can you do it on
- 13 that, too?
- 14 A. This one?
- 15 Q. Perfect. Okay. Thanks, Antuan. I appreciate that. It
- 16 helps.
- 17 MR. NICHOLSON: And, Ravi, do you want to go ahead and
- 18 ask --
- 19 BY MR. CHHATRE:
- 20 Q. Hello.
- 21 A. Hi.
- 22 Q. Thanks for coming by. Condolences on your loss.
- Can you tell me who else was living in the house besides
- 24 you?
- 25 A. My grandmother.

- 1 Q. Okay.
- 2 A. My little brother, my mom, and my stepdad.
- 3 Q. Okay. And you say you had been living there about
- 4 4 years?
- 5 A. Um-hum.
- Q. Did your grandma live there for that period, or she came
- 7 and joined you later?
- 8 A. No, she came and joined. She was there for about
- 9 2 years.
- 10 Q. Two years. Okay. And what about your stepdad?
- 11 A. I don't remember. I don't remember how long he been
- 12 there.
- Q. Like year or 2 years? Okay. If you don't --
- 14 A. I don't remember.
- 15 Q. -- remember, you don't remember.
- And do you know, primarily focusing on the day of the
- 17 accident -- and when I say day, the accident happened at night,
- 18 like 2:30 at night. So day would be a Monday. So if I use the
- 19 word day, that is Monday. And before I even go to that day, can
- 20 you tell me what grade you are in?
- 21 A. I'm in Lawson State. I go to Lawson State now. But
- 22 what grade I was in before was the 12th grade.
- Q. Twelfth grade. Okay.
- MR. DiGIORGIO: Lawson State is a college. So you'll
- 25 know what that is.

- 1 MR. NICHOLSON: What is it? I'm sorry.
- 2 MR. DiGIORGIO: It's a college here in town. He's going
- 3 to be starting in the fall.
- 4 BY MR. CHHATRE:
- 5 Q. And what is the name of the college?
- 6 A. Lawson State.
- 7 Q. How do you say it?
- 8 A. Lawson State.
- 9 Q. Okay, Lawson State. Okay.
- MS. WATSON: L-a-w-s-o-n.
- MR. CHHATRE: Okay.
- BY MR. CHHATRE:
- Q. Okay. Now, do you know if your stepdad was working when
- 14 the accident happened? I mean employed.
- 15 A. No.
- 16 Q. He was not. Do you know how long he has been
- 17 unemployed?
- 18 A. No, I don't.
- 19 Q. Okay. Antuan, do you remember smelling gas odor inside
- 20 the house?
- 21 A. Yes.
- Q. And can you tell me when did you smell the gas odor
- 23 inside the house?
- 24 A. It was like a couple weeks before.
- Q. A week before?

- 1 A. Um-hum. Like a week before. But it wasn't, like,
- 2 strong, like strong; it's like kind of like a swiff and pass by
- 3 and then it's gone.
- 4 Q. Okay.
- 5 A. And, you know, like that.
- 6 Q. Okay. And do you remember where you smelled the gas?
- 7 A. In the kitchen.
- 8 Q. In the kitchen.
- 9 A. Um-hum.
- 10 Q. And is your oven or range gas pilot or it was electric?
- 11 A. Repeat.
- 12 Q. Your range or stove, is it gas or electric?
- 13 A. It was gas.
- 14 Q. It was gas.
- 15 A. Um-hum.
- 16 Q. And so could you tell me if it was -- do you feel it was
- 17 coming from the range or the range was off when you smelled the
- 18 gas?
- 19 A. The oven was off.
- 20 Q. Off. It was off?
- 21 A. Yes, it was off.
- Q. Now, do you smell gas -- besides that day, do you smell
- 23 gas before that?
- A. The night, the night of the accident, when I came in the
- 25 house, I was coming in with a friend, and I smelled it when I was

- 1 coming in the door. But it wasn't that strong, you know, so I
- 2 just didn't pay it no mind. So I went in the house and went up to
- 3 my studio.
- Q. Okay. So which door you used, the front?
- 5 A. The back door.
- 6 Q. Oh, the back door?
- 7 A. Right.
- 8 Q. Because earlier you say you come home from front door.
- 9 A. I was at a friend's house that night and --
- 10 Q. Okay. So you came from the back door.
- 11 A. Right.
- 12 Q. And as you entered the house, you smelled gas?
- 13 A. Right.
- MR. NICHOLSON: So that would be the door at the
- 15 kitchen?
- MR. MABRY: Right.
- 17 MR. NICHOLSON: Okay.
- 18 BY MR. CHHATRE:
- 19 Q. Do you smell -- did your friend smell gas?
- 20 A. I asked him. He said he didn't smell it.
- Q. Okay. Did you mention that to anybody in the house,
- 22 that you smelled gas?
- 23 A. No. My mom said something about it. She warned us
- 24 about it. But, you know, other than that, I ain't say nothing to
- 25 anybody because it -- you know, it wasn't as strong so I didn't

- 1 think too much of it. So --
- 2 Q. And you said your mom told you about the gas odor?
- 3 A. Yeah. She -- it was one day when we was in the kitchen
- 4 and we was playing a little board game, and she was like, you all
- 5 smell that? And I was like, no, I don't smell it. And then a
- 6 swiff hit my nose and I was like, well, I smelled it. And, you
- 7 know, and I was like, well, okay, it's gone now.
- 8 Q. Okay. And do you recall when was it before the
- 9 accident?
- 10 A. Repeat.
- 11 Q. Can you tell me when do you smell the gas or your mom
- 12 smell the gas?
- 13 A. She smelled it first.
- Q. Okay. But when was it? How long before the accident?
- 15 A. Like a week before.
- 16 Q. Okay. Did you smell gas outside of your home when you
- 17 go to school?
- 18 A. No. It was just that night when I was walking in the
- 19 house.
- Q. Okay. And that was the night before the house exploded?
- 21 A. Right.
- Q. Okay. Do you know what to do if you smell a gas odor?
- 23 A. I just tell my mom.
- Q. Okay. Do you remember seeing anything with your bills
- 25 that your mother paid for the gas company that says what to do

- 1 with a gas odor?
- 2 A. No.
- 3 Q. Okay. Did anybody with your friends living -- any of
- 4 your friends, did anybody complain about a gas odors outside?
- 5 A. Not that I know of.
- 6 Q. Okay. Now, could you tell me if you had any problems
- 7 with toilets in the house?
- 8 A. Just the downstairs one.
- 9 Q. Okay. And can you tell me what the problem was?
- 10 A. It always overflowed and that's about it.
- 11 Q. And this problem of flooding the toilet, when did it
- 12 start, from the day you had moved in 4 years ago or it was
- 13 recently?
- 14 A. It was -- I don't actually remember the day it started.
- 15 Q. Not the date, but roughly, 6 months, a year, 2 years?
- 16 A. Couple of months.
- 17 Q. Couple of months?
- 18 A. Couple of months.
- 19 Q. I don't want you to guess. If you don't know, tell me
- 20 you don't know. That's fine.
- 21 UNIDENTIFIED SPEAKER: So a couple of months after he
- 22 moved in or a couple months from before --
- BY MR. CHHATRE:
- 24 O. Yeah. Well -- before the accident?
- 25 A. Oh, wow. I think it was after -- after we moved in.

- 1 Q. After you moved in, a couple of months after you moved
- 2 in?
- 3 A. Right.
- Q. Okay, good. And what happened? How did it get fixed?
- 5 A. I don't think it ever got fixed because it did it again
- 6 after, I guess, the people came, something like that.
- 7 Q. Okay. So it always kept flooding?
- 8 A. Yeah.
- 9 Q. Even before -- the day before the accident, on Monday,
- 10 until that day, was it flooding?
- 11 A. I don't remember.
- 12 Q. Okay.
- MR. NICHOLSON: Or did you just stop using it? Was it
- 14 just not used?
- MR. MABRY: I'm pretty sure if it was flooded, then no
- 16 one used it at the time it was flooding. But, you know, if it
- 17 wasn't, then I think it was used.
- 18 BY MR. CHHATRE:
- 19 Q. Okay. And no problem on the bathroom upstairs?
- 20 A. No.
- Q. Okay. So everybody used the bathroom upstairs?
- A. Who used it?
- Q. No, did everybody use the bathroom upstairs?
- A. Yeah.
- Q. Pretty much?

- 1 A. Not everybody didn't use the bathroom upstairs. Whoever
- 2 was upstairs used the upstairs bathroom.
- 3 Q. Okay.
- A. And when we was downstairs, we --
- 5 Q. Okay. Do you remember if any repair work was done
- 6 outside your house to fix the bathroom or?
- 7 A. There was some guys that dug in the back where the
- 8 bathroom was on the outside. And then the part where the grass
- 9 never grew back at, on the outside, when you first walk out the
- 10 back door, like right here on the --
- 11 Q. Um-hum.
- 12 A. -- it was some workers there digging, you know, the hole
- 13 and stuff. But I don't --
- Q. Do you know who were doing that? The gas company, sewer
- 15 company, housing authority?
- 16 A. I think it was the housing.
- 17 Q. Housing people?
- 18 A. Um-hum.
- 19 Q. Okay. Do you know remember if any water line work was
- 20 done outside your home in the 4 years you guys are there?
- 21 A. No.
- Q. No. Okay, that's fine.
- 23 And do you -- can you tell me, on the day of the
- 24 accident, what time you ate in the evening?
- A. What time --

- 1 Q. This will be Monday evening.
- 2 A. What time did I leave?
- 3 Q. No, what time you ate at home.
- A. I don't even remember eating that night.
- 5 Q. Oh, you did not eat at home?
- 6 A. Eat at night. I didn't eat that night.
- 7 Q. Okay. Do you remember if anybody used the oven that
- 8 night?
- 9 A. The only time we used the oven when my mom cooked. But
- 10 she didn't cook that night, so --
- 11 Q. Okay.
- 12 A. -- we didn't eat that night.
- 13 Q. She wasn't feeling good or?
- 14 A. I don't know.
- 15 Q. Okay. Now, can you tell me what time you went to bed
- 16 that night?
- 17 A. Maybe about 1--- I want to say about 1:30.
- 18 0. 1:30?
- 19 A. Something like that.
- Q. Okay. So you were just studying or playing music until
- 21 that point?
- 22 A. Yeah.
- Q. Okay. Did you look at the watch, clock or something?
- 24 How do you know it's around 1:30?
- 25 A. My computer has the time on it.

- 1 Q. Oh, computer. Okay. Has accurate time.
- Now, do you remember smelling any gas odor when you went
- 3 to bed?
- 4 A. No.
- 5 Q. No. So were you asleep when the house explosion
- 6 occurred or you were still kind of semi-awake?
- 7 A. No. I was asleep.
- 8 Q. You were asleep.
- 9 Can you tell me what you recall? Do you remember
- 10 hearing an explosion? Just walk me through, if you remember. If
- 11 you don't remember --
- 12 A. I don't remember hearing the explosion. When I woke up,
- 13 I was on the ground outside. So --
- 14 Q. You were on the ground?
- 15 A. Outside. But that's all I remember.
- 16 Q. That's all you remember. Okay.
- 17 Thank you so much for helping us.
- 18 MR. NICHOLSON: Nancy?
- MS. McATEE: All right. This is Nancy McAtee, NTSB.
- BY MS. McATEE:
- 21 Q. You said your mom was the only one who ever used the
- 22 stove and oven?
- 23 A. Well, she's probably the only one that used it.
- 24 Q. Okay.
- 25 A. But, you know, when she cooked, you know, then it was

- 1 used.
- Q. Okay. Did she ever have any -- if anybody used it, do
- 3 you know if there was any problems with it or did it always seem
- 4 to work right?
- 5 A. I don't know.
- Q. The heater in the front room, did you ever use that?
- 7 Did you ever turn it on, turn it off?
- 8 A. It had a problem staying lit.
- 9 Q. Okay.
- 10 A. My stepdad used to light it, but it always went off on
- 11 its own.
- 12 Q. Do you remember if it was on the night before? Do you
- 13 remember if it was cold just before the explosion, it had been
- 14 cold?
- 15 A. I think it was warm.
- 16 Q. Kind of warm?
- 17 A. Warm.
- 18 MS. McATEE: That's all I have for the moment.
- 19 MR. NICHOLSON: Keith?
- 20 MR. BLACKWOOD: This is Keith Blackwood with the PSC.
- BY MR. BLACKWOOD:
- Q. Do you know if anybody used the stove for a heating
- 23 source other than cooking? Was it ever used to heat the
- 24 downstairs area?
- 25 A. No. My grandma had a heater upstairs.

- 1 Q. Okay. And did anyone in the house smoke?
- 2 A. I think my mom, she smoked cigarettes.
- 3 Q. Okay. Thank you.
- 4 MR. NICHOLSON: Bob?
- 5 BY MR. GARDNER:
- 6 Q. You mentioned earlier there was some work done in the
- 7 yard maybe by the housing authority --
- 8 A. Right.
- 9 Q. -- that was related to -- I just want to make sure I
- 10 understand -- that was related to the toilet backing up; is that
- 11 right? About that time?
- 12 A. I guess. I never asked them what it was for.
- 13 Q. Right.
- 14 A. I just know they was out there working.
- 15 Q. Okay. Okay. Do you recall ever seeing any Alagasco
- 16 vehicles out there around the -- before the accident?
- 17 A. No.
- 18 Q. Okay. That's all I have. Thank you.
- 19 BY MR. NICHOLSON:
- Q. Okay. Antuan, I want to revisit some of the timeline,
- 21 if I could. You said you get home from school around 4:30, I
- 22 thought I heard you say. And so on the Monday before the
- 23 accident, you would have gotten home at roughly 4:30 like normal?
- 24 A. Um-hum.
- Q. Okay. And you said you went to your studio?

- 1 A. Yeah.
- 2 Q. Okay.
- 3 A. I went to my room first and watched some TV.
- 4 Q. Oh, okay.
- 5 A. I watched TV, and then I go to the studio.
- 6 Q. Okay.
- 7 A. Yeah.
- 8 Q. But you were up till --
- 9 A. I went to my friend's house.
- 10 Q. And you went to your -- when did you leave for your
- 11 friend's house; do you remember?
- 12 A. I left from my friend -- to go to my friend house, maybe
- 13 about 7-something.
- 14 Q. Okay, 7 p.m.?
- 15 A. And I was over there with him until maybe about 9, maybe
- 16 10-something, and we came back. And after we came back, we went
- 17 up to the studio.
- 18 Q. Okay.
- 19 A. Maybe till about 11-something.
- 20 Q. Okay.
- 21 A. And my stepdad was up there. He didn't stay too long.
- 22 He maybe left out around about -- I'd say we got up there about
- 23 11:15, somewhere around that time --
- 24 Q. Okay.
- 25 A. -- and he left out 11:30-something.

- 1 Q. Okay. Where did he go, do you know?
- A. He went downstairs, back in the room.
- 3 Q. To his room?
- 4 A. Uh-huh. You know, to my mom --
- 5 Q. Yeah, right. Right.
- 6 A. -- my mom's room.
- 7 Q. And then I believe you said that was the -- when you
- 8 came back with your friend, that was the night you smelled the
- 9 gas.
- 10 A. Um-hum.
- 11 Q. Okay. And you came in this door on the south.
- MS. WATSON: No.
- 13 BY MR. NICHOLSON:
- 14 Q. You came in the back door that time, okay.
- 15 Can you tell me, do you remember where everyone else was
- 16 when you were in the studio; I mean, where your brothers were?
- 17 A. My brother was in his room. My grandma was in her room.
- 18 And my mom, I think she was in her room.
- 19 Q. Okay.
- 20 A. On the computer.
- 21 Q. So were you the last one to go to bed, as far as you
- 22 know, or? No one was in the kitchen at the time you went to bed?
- 23 A. I don't know.
- 24 Q. Okay.
- 25 A. My room is upstairs, so I don't know --

- 1 Q. You didn't go downstairs; is that right?
- 2 A. After my friend left, I didn't go downstairs. I went in
- 3 my room and laid down and went to sleep.
- 4 Q. Okay. And it sounded like -- I heard you say earlier
- 5 when you smelled the gas, what would you do? You would tell your
- 6 mother, is that --
- 7 A. Like, when I was coming in the house that night, I
- 8 didn't say anything to her.
- 9 Q. Okay.
- 10 A. Because a week before, like a week or so before she had
- 11 already said something about it, you know, and so I didn't report
- 12 it. And, plus, it wasn't -- you know, it wasn't as alert at all,
- 13 so I just left it alone the second time.
- Q. It didn't alert? What do you mean by it didn't alert
- 15 you?
- 16 A. Like it didn't -- it wasn't strong.
- 17 Q. Oh, okay.
- 18 A. Like it wouldn't -- you know, for me to report it to my
- 19 mom again.
- Q. Okay. But if it were strong enough to make you worried,
- 21 you would -- who would you report it to?
- 22 A. My mom.
- Q. Your mom. Right. Okay. So your mom took care of those
- 24 sorts of things in your household?
- A. Um-hum.

- 1 Q. Okay. And if the toilet backed up, did you tell your
- 2 mom?
- 3 A. Yeah.
- 4 Q. Okay. Thank you.
- 5 Was your mom working at the time of the accident? Did
- 6 she have a job?
- 7 A. She was in school.
- 8 Q. She was in school?
- 9 A. Um-hum.
- 10 Q. Okay. So what was -- I didn't hear much about her
- 11 schedule. When would she leave the house and when would she
- 12 return?
- 13 A. She never really left the house.
- 14 Q. She never really -- okay.
- 15 A. She would go to school, it was online.
- 16 Q. Oh, okay.
- 17 A. That's why she stayed on the computer a lot.
- 18 O. I see.
- 19 A. Yeah, you know, that's --
- Q. So it was normal for her to be in the house all day?

- 5 attention.
- 6 Q. Even when you came home and you walked through the
- 7 kitchen door?
- 8 A. It wasn't -- it was up.
- 9 Q. Okay.
- 10 A. It was closed.
- 11 Q. Everything was normal?
- 12 A. Um-hum.
- 13 Q. Okay. That's all I have.
- MR. NICHOLSON: Ravi, anything else?
- 15 MR. CHHATRE: If I may. I have a couple of questions.
- BY MR. CHHATRE:
- 17 Q. When did your friend leave?
- 18 A. He left after my stepdad went downstairs, so it was
- 19 about -- my stepdad left around 11:30-something. So he had -- it
- 20 wasn't that long he stayed after my stepdad. So it was maybe
- 21 around like 12.
- Q. Okay. Until he left?
- A. 12-something, yeah.
- Q. Did you go downstairs to close the door or he just
- 25 closed the door?

- 1 A. No, he left by himself.

- 17 Q. Everett. Okay. And was she's studying what?
- 18 A. Criminal justice.
- 19 Q. Criminal justice. Okay.
- 20 And do you have any other relatives besides your
- 21 grandmother and your younger brother? Do you have any other
- 22 relative, brother or sisters?
- 23 A. That was staying in there or the people who --
- Q. No, not staying there. Just relatives.
- 25 A. I have a sister.

- 1 Q. Okay.
- 2 A. And a brother, a older brother.
- 3 Q. So you have a sister and an older brother. And where do
- 4 they live?
- 5 A. My sister now, she live in \*\*\*PII\*\* .
- 6 Q. I'm sorry?
- 7 A. In \*\*PII\*\* . My sister.
- 8 Q. Can you spell it?
- 9 A. Her name?
- 10 Q. Her name and where she lives.
- 11 A. Brittany, B-r-i-t-t-a-n-y; Mabry, M-a-b-r-y.
- 12 Q. Okay.
- 13 A. She stays in
- 14 Q. \*\*PII\*\* . Okay.
- Do you believe she works part-time in McDonald's or some
- 16 other fast food?
- 17 A. She used to work. I think it was at Bradley's (ph.).
- 18 But I don't -- I really don't know.
- 19 Q. Okay. And what about your older brother; do you know
- 20 what he does or where he is?
- 21 A. I know where he is, but I don't -- you know.
- Q. No contact?
- 23 A. Yeah.
- 24 MS. WATSON: \*\*PII\*\*
- MR. CHHATRE: Okay. That's fine. Okay.

- 1 That's it. That's all I have. I really appreciate your
- 2 helping us out. It's very valuable help.
- 3 MR. NICHOLSON: Nancy, anything else?
- 4 MS. McATEE: No other questions. Thank you.
- 5 MR. NICHOLSON: Keith?
- BY MR. BLACKWOOD:
- 7 Q. This \*\*\*PII\*\* where your sister stays, would it be
- 8 over in the Centerpoint/Roebuck, Roebuck area?
- 9 A. No. It's in the North Birmingham area.
- 10 Q. Okay. Thank you.
- MS. WATSON: Behind the old \*\*\*PII\*\* .
- 12 UNIDENTIFIED SPEAKER: Old \*\*PII\*\*
- MR. BLACKWOOD: Okay. Thank you.
- MR. NICHOLSON: Is that anywhere -- that's not near
- 15 where you were asking about?
- MR. BLACKWOOD: No, it's not.
- 17 MR. NICHOLSON: Bob?
- 18 MR. GARDNER: I have nothing else. Thank you.
- 19 BY MR. NICHOLSON:
- Q. Just one last question, Antuan. After the explosion --
- 21 you had been asleep -- where did you find yourself after the
- 22 explosion?
- 23 A. I was in the -- on the back, near the parking lot on the
- 24 ground.
- Q. In the back. So this side of the house?




