         All right. First of all, I'm Det. Commodore from the Major

    Crash Unit. And I'm actually investigating the crash that just

    took place on Georgia Avenue. All right. And my reason for

    bringing you here is to basically find out exactly what happened

         But before you do that, can you just basically introduce

    yourself: your name, your date of birth, your home address, and

    your age?

         Sure. My name is Miguel R-A-M-O-S, is the last name, Ramos.

    And I am 26, and I live very close to here,

- 2 ASL INTERPRETER: Do you want the exact date of birth?
- 3 DET. COMMODORE: Yes.
- 4 MR. MIGUEL RAMOS-AYALA:
- 5 BY DET. COMMODORE:
- 6 Q. Okay. Thank you.
- 7 First of all, tell me exactly where you all were before --
- 8 where did you all go this evening and who went with you?
- 9 A. I'm not sure the name of the place exactly. It's kind of
- 10 like a restaurant, and it's like a bar that kind of has like a
- 11 party happening there at it.
- 12 Q. Okay. Who were you with?
- 13 A. I was with my older brother and his friend.
- 14 Q. Names?
- 15 A. Well, my brothers, I know their name.
- 16 Q. Okay. Name the brother that you were with.
- 17 A. Okay. The oldest brother's name is -- it's spelled
- 18 H-E-B-E-R-T-H, Herberth [sic].
- 19 Q. Okay.
- 20 A. Jonathan, Erick, E-R-I-C-K. So those are my -- so those are
- 21 | the three brothers. And then my oldest brother had some friends
- 22 | with him. One of his friend's name was Cesar, C-E-S-A-R.
- 23 Q. Okay. So Herbert?
- 24 A. Uh-huh.
- 25 Q. And what's the name of the driver of the car?

- 1 A. Erick, E-R-I-C-K.
- 2 Q. Okay. And what's the name of your brother that was hit?
- 3 A. Jonathan.
- 4 Q. Jonathan. Okay. Exact -- so tell me what happened inside of
- 5 the club.
- 6 A. Oh, we were just having fun, having some drinks because it
- 7 was my older brother's birthday.
- 8 Q. It was Herbert's birthday?
- 9 A. Yes, um-hum.
- 10 Q. Okay.
- 11 A. Yeah, his birthday.
- 12 Q. Okay. What else happened inside the club?
- 13 A. Oh, just having fun, just hanging out, you know, talking,
- 14 drinking. Nothing really. Just having fun. And then we left.
- 15 Q. Okay. Did you see Erick and Jon have an argument?
- 16 A. Let's see. I can't really explain. Well, okay.
- 17 O. To the best he can.
- 18 A. Erick tried to get them to calm down, tried to get him to
- 19 calm down because he had drank too much.
- 20 0. Who had drank too much?
- 21 A. Yeah, Jonathan had drank too much and so Erick was trying to
- 22 get him to calm down, but he wasn't listening. And he was trying
- 23 to get him to go home and he didn't want to go home.
- 24 Q. Erick was trying to get Jonathan to go home?
- 25 A. Right. Yeah. And I don't know exactly what they were saying

- 1 because they were, they were talking. But Erick was trying to get
- 2 | Jonathan to calm down and to go home, and Jonathan didn't want to
- 3 go home. He wanted to stay.
- 4 Q. Okay. And Jonathan is the driver of the car, correct?
- 5 A. No.
- 6 Q. Okay. Erick is the driver of the car. I'm sorry. Erick was
- 7 | the driver of the car?
- 8 A. Right.
- 9 Q. Okay. And he was trying to get Jonathan to calm down.
- 10 Right?
- 11 A. Yes. Right. Um-hum.
- 12 Q. At any point do they start fighting or pushing and shoving?
- 13 A. Yeah. They were both mad and they made contact. And then I
- 14 don't know exactly what they were saying, but yeah, there was
- 15 definitely an argument.
- 16 Q. What about physical --
- 17 A. But then they were separated. They didn't hit each other,
- 18 just like kind of shoved each other or got in their face, like in
- 19 the chest area. Yeah, and again, they obviously were upset or
- 20 angry, I could tell from their facial expressions, but I don't
- 21 know exactly what they were saying.
- 22 Q. Was Erick drinking a lot?
- 23 A. No.
- 24 Q. Okay. Now Erick --
- 25 A. Because he was the driver.

- 1 Q. Okay. Erick has a tear on his shirt. His shirt is ripped.
- 2 A. Oh, I didn't see that.
- 3 Q. Okay.
- 4 A. I didn't see the shirt tear or anything, so I don't know.
- 5 Q. Okay.
- 6 A. Yeah, and I was, I was kind of pissed about the situation,
- 7 too. So I don't know.
- 8 Q. Okay. Who left the establishment first?
- 9 A. I didn't see exactly what happened, so I don't know who left
- 10 first.
- 11 Q. Okay. Did you leave with Erick?
- 12 A. Yes. And then they got mad again at each other.
- 13 O. Inside or outside?
- 14 A. Right outside of the bar.
- 15 \mathbb{Q} . And what happened when they got mad outside the bar?
- 16 A. I was trying to separate them and just say, "Come on, come
- 17 | on, let it go," but they kept getting in each other's face and
- 18 were obviously upset. But I kept trying to intervene and trying
- 19 to separate them, but I wasn't able to.
- 20 Q. Okay. How did it end?
- 21 A. That was just for a minute or two and then everyone got in
- 22 the car and left.
- 23 Q. Okay. Who got into Erick's car?
- 24 A. Me and Erick were in the front and then my older brother and
- 25 another one of his friends were in another car behind us.

- 1 Q. Okay. Where did Erick park his -- well, where Erick car is
- 2 | right now, where is the club in regard -- in reference to -- in
- 3 | relation to it?
- 4 A. I don't know the name of it or even the street name. It's or
- 5 | the same street but it's just you -- where the car is, it's just
- 6 | right down almost if you just go straight -- I think it's on
- 7 Georgia Avenue.
- 8 Q. Okay.
- 9 A. Just a little bit farther down on the right. And I don't
- 10 know the name of the place, but -- I don't know, it's kind of --
- 11 | it's like a bar and party there, and kind of lit up.
- 12 Q. All right. Can you explain to me exactly how is it that Jon
- 13 | end up getting hit?
- 14 A. So I got in the car with Erick. And then we saw that it was
- 15 our brother Jonathan and -- so I saw him coming from the left side
- 16 somewhere, walking, and then next thing I knew, the car just hit
- 17 | him, and I don't know how that happened.
- 18 ASL INTERPRETER: And I clarified as the interpreter whether
- 19 | it seemed to be intentional or accidental, and he said it was not
- 20 | intentional, it just -- we saw him come from the left and then we
- 21 hit him.
- BY DET. COMMODORE:
- 23 Q. How far, how far away were you in the car when you first saw
- 24 Erick? I mean, Jon. I'm sorry.
- 25 A. Really close, like 2 feet. All of a sudden we saw him, he

- 1 was right there, and then hit him. It was very close, 1 or 2
- 2 | feet, not far at all.
- 3 Q. Were there a lot of cars on the street?
- 4 A. I mean, there were a few cars, but not a lot.
- 5 Q. Okay. Now are you sure it was only 2 feet?
- 6 A. Yeah, yeah, it was really close. I saw him, he's so close,
- 7 | right there, and then -- saw him, and then he was hit.
- 8 Q. All right.
- 9 A. And I couldn't stop myself from being so mad and crying and
- 10 everything. You know, I wanted to, you know, make sure he's okay
- 11 and what was going on.
- 12 Q. How far was -- how long was Erick driving before this, this
- 13 crash happened?
- 14 A. I'm not really sure about that.
- 15 \mathbb{Q} . Did he make a U-turn or was he driving straight down the
- 16 street?
- 17 A. He went to make a left, and that's when Jonathan came. And
- 18 | that's how he hit him. We were making a left onto a different
- 19 street, and that's when we saw him and hit him.
- 20 Q. Left on a different street? But the car's in the middle of a
- 21 street not close to an intersection. I'm not understanding.
- 22 A. I don't know.
- 23 Q. All right. So right now, like I said, you're just a
- 24 passenger in a car, and you did your best you could to break them
- 25 up from, from fighting each other, all right, which is, which is

- 1 | commendable. All right? The only issue is, because you are on
- 2 Georgia Avenue, there are a lot of cameras along that street. And
- 3 when we do pull the cameras, we're going to actually see what
- 4 happened. And we just wanted to make sure -- if it was something
- 5 intentional because the two of them were mad at each other, please
- 6 make it known now. Because if we see that it's something
- 7 different, you know, we may have to come back and talk to you in
- 8 a, you know, in a different manner.
- 9 A. Okay. No.
- 10 O. No?
- 11 A. No, there's nothing else.
- 12 Q. Okay. When, when -- the car was parked, I guess, on Georgia
- 13 Avenue while they were at the club. When he left in the car,
- 14 exactly how many turns or did the car just go straight? Or did
- 15 | the car make any like turns to -- what car -- which way was the
- 16 | car facing?
- 17 ASL INTERPRETER: When he --
- 18 BY DET. COMMODORE:
- 19 Q. When he was inside -- when he went to the club, was the car
- 20 | facing towards Silver Spring or down towards Howard University?
- 21 A. So the club is on the right if you're looking this way down
- 22 at it. And so this is the car. And the car was across the street
- 23 | facing this way, which would be north towards Silver Spring.
- 24 Q. All right. So the way the car is facing right now, it's
- 25 south on Georgia Avenue. That's the way the car is facing.

- 1 A. Um-hum.
- 2 Q. When you were at the club, was the car faced the opposite way
- 3 from the way it's faced right now?
- 4 A. Right.
- 5 Q. Okay. So it's facing northbound?
- 6 A. So it was, and we turned.
- 7 Q. Okay. So if you were to get out that car right now, the way
- 8 | it's parked right now, how far would you have to walk to get to
- 9 | the actual bar?
- 10 A. It's close. I think maybe 3 or -- it was just a few feet.
- 11 Like we're just right by there.
- 12 Q. Oh, okay. Okay. So the club's right across the street?
- 13 A. Yeah.
- 14 Q. Where the car is right now?
- 15 A. Um-hum.
- DET. COMMODORE: Okay. All right. All right. Okay, well, I
- 17 greatly appreciate it and we're going to let you go so you can go
- 18 be with your brother.
- Did you see his brother outside? Okay.
- 20 MR. MIGUEL ANGEL RAMOS-AYALA: Okay.
- 21 DET. COMMODORE: And I'm going to call the detective to come
- 22 | in there to escort you down so we can get you back out to your
- 23 brother.
- MR. MIGUEL ANGEL RAMOS-AYALA: Okay.
