3	MR. ERICK RAMOS-AYALA: Okay.
4	DET. CLAXTON: We'll be with you in just a minute.
5	(Detective Claxton exits.)
6	(Detective Commodore speaking at the door.)
7	DET. COMMODORE: Erick?
8	MR. ERICK RAMOS-AYALA: Yeah.
9	DET. COMMODORE: Okay. Are you comfortable speaking your
10	first language or
11	MR. ERICK RAMOS-AYALA: Yeah, English is fine.
12	DET. COMMODORE: English is fine?
13	MR. ERICK RAMOS-AYALA: Yeah.
14	DET. COMMODORE: Okay.
15	(Detectives Commodore and Claxton enter.)
16	DET. COMMODORE: Where's your phone be at? I need to take
17	your phone from you.
18	MR. ERICK RAMOS-AYALA: My brother's phone (indiscernible)
19	DET. COMMODORE: Hum?
20	MR. ERICK RAMOS-AYALA: My brother's (indiscernible)
21	DET. COMMODORE: Say it again.

- MR. ERICK RAMOS-AYALA: Yeah, I guess, and then I just got it
- 14 from him.
- 15 DET. COMMODORE: All right.
- 16 INTERVIEW OF ERICK RAMOS-AYALA
- 17 BY DET. COMMODORE:
- 18 Q. All right. I'm Detective Commodore from the Major Crash
- 19 Unit.
- 20 A. Hum?
- 21 Q. Okay. I'm Detective Commodore --
- 22 A. Okay.
- 23 Q. -- from the Major Crash Unit. This is Detective Claxton.
- 24 All right. And I'm actually investigating this crash that took
- 25 | place. So basically all I want to do is find out exactly what

- 1 happened --
- 2 A. Um-hum.
- 3 Q. -- what happened like inside the club, what happened outside
- 4 | the club. But before I do that, I'm just going to write your info
- 5 down real quick because I didn't, I didn't have --
- 6 So all of you brothers?
- 7 A. Yeah.
- 8 Q. You're the youngest of all those?
- 9 A. Right.
- 10 BY DET. CLAXTON:
- 11 Q. So four brothers?
- 12 A. One sister. Yeah.
- 13 Q. Four brothers and one sister. Where's your family from?
- 14 A. Salvador.
- 15 Q. El Salvador?
- 16 A. Yeah.
- 17 Q. Were you born here or you were born in El Salvador?
- 18 A. Over there.
- 19 O. Over there?
- 20 A. But we came when I -- I came when I was 5. The one that went
- 21 to the hospital came when I was 5, as well.
- 22 Q. Okay.
- 23 A. My sister same thing. My two older brothers came when I was
- 24 11, 12.
- 25 Q. Okay.

- 1 DET. COMMODORE: Okay. One second.
- 2 BY DET. CLAXTON:
- 3 Q. Do you all live together?
- 4 A. The one who, the one who's in the hospital, I think he lives
- 5 with his baby mother.
- 6 Q. Right.
- 7 A. And then the rest of us live with my mother.
- 8 Q. With your mother?
- 9 A. Yes.
- 10 (Detective Commodore phone call.)
- BY DET. COMMODORE:
- 12 Q. All right, Erick. What's your telephone? Your cell phone?
- 13 A.
- 14 Q. That's your cell phone?
- 15 A. Yeah.
- 16 Q. Here you go, sir. All right. I had to have some information
- 17 (indiscernible).
- 18 All right. All right. Can you tell me exactly -- basically
- 19 what happened the moment you all walked into the actual club?
- 20 What was the name of the club you all went to?
- 21 A. I forgot. I can't get it out from my head.
- 22 Q. Okay.
- 23 A. Yeah, it's some -- P something.
- 24 Q. Okay. Where is the club?
- 25 A. Right there on Georgia and Kennedy Street.

- 1 Q. Hum?
- 2 A. Georgia and Kennedy Street.
- 3 Q. Okay. Is it right by where your car is right now?
- 4 A. I believe so. Yeah, it's right there.
- 5 Q. Okay. All right. So what actually happened at the -- who
- 6 | went to the -- first of all, who went to the club?
- 7 A. It's all four of us.
- 8 Q. Who's four of us?
- 9 A. My brothers and another friend. And we were at a different
- 10 club around there, the same part. And after that, we leave there.
- 11 Then we went over there to -- you know, we were celebrating my
- 12 older brother's birthday basically. And we're just drinking there
- and having fun, whatever. And then my brother and I, we got into
- 14 a disagreement. And it started off when we're paying the bill.
- 15 Q. How did your brother get there?
- 16 A. Which brother?
- 17 Q. All your brothers? Who rode with who?
- 18 A. Okay. So my older brother, he was already at the other club.
- 19 Q. Okay.
- 20 A. And then --
- 21 Q. You can say -- that's your older -- Herbert?
- 22 A. Herbert, yeah. Herbert, he was already there. And then
- 23 Jonathan, he took a Uber to --
- 24 O. Oh, he took a Uber?
- 25 A. Yeah. He came out of work.

Q. Okay.

- 2 A. He came (indiscernible). I wasn't planning on going, but
- 3 then I end up going. And he took Uber there and I met them with
- 4 my other brother, at the place. And then we all -- we all met up
- 5 at the other place, the one that this thing happened. And like I
- 6 said, we were there drinking beers. We took one shot each, all of
- 7 us just one. And after that, the bill came up to like 170 or
- 8 something. We were just like -- our other friend, I guess he, I
- 9 quess he was kind of mad because like he kept paying each time.
- 10 This is only like my first time going there and -- or barely
- 11 | hang out with them going out. And like I said, I've heard them
- 12 speaking or whatever. My brother saying that, well, he was kind
- of like pissed or -- pissed that he always pay, he always pay
- 14 everything. He kept saying that.
- 15 Q. This is your brother's friend?
- 16 A. Yeah. He kept saying that, yeah, you guys haven't paid or
- 17 something. You know, he just wanted cooperation, you know, to put
- 18 some money so he don't have pay. So whatever, we all joined, we
- 19 all put up.
- 20 Then my older brother, he gave me -- he gave Jonathan his
- 21 card. Yeah, then (indiscernible) and then I paid him. He had
- 22 | just -- you know, Herbert paid it. And then like Jon was just
- 23 talking to, well, our friend, I guess, telling him that, you know
- 24 -- I guess he was just pissed the fact that he kept bragging about
- 25 he always pay, he always pay, and whatever. And like I guess he

- 1 was trying to make it seem that we don't have money to put up or
- 2 anything.
- 3 And Jonathan just kind of like -- I don't know. They were
- 4 | talking, but -- and I just kept saying, Jon, just drop it. Jon,
- 5 Jonathan, and then (indiscernible).
- 6 Q. Inside the club?
- 7 A. Yeah.
- 8 Q. You and Jonathan?
- 9 A. Yeah. But then I guess we bumped into each other and then
- 10 (indiscernible) like got into it, like, physically like that, but
- 11 | we just pushed each other out and then just started separating the
- 12 us. That's when they took us out. And then I guess I was waiting
- 13 for my brother outside. And then my other brother went over there
- 14 | with my other brother, hunted him down.
- 15 Q. Which other brothers?
- 16 A. Herbert (indiscernible) Miquel, hunted him down because we
- were ready to, you know. And then I was making sure my brother,
- 18 | he was good, Jonathan. Make sure he was good. And then -- yeah,
- 19 I mean, I was mad at, you know. I'm like, look, why are we doing
- 20 | this for? And then that's when we got both in each other's faces.
- 21 O. Outside?
- 22 A. Yeah, outside. And then that's when we both fell. Like
- 23 | that's when we was falling down and he grabbed my shirt. That's
- 24 | how (indiscernible) --
- 25 Q. How did he fall down?

- 1 A. He got (indiscernible) or anything.
- 2 Q. So any punches or just grabbing --
- 3 A. No, not any punches. Because we fell and then like after
- 4 | that my older brother came and tried to separate us.
- 5 Q. Okay.
- 6 A. So that's when, you know, when he was going down, he had a
- 7 hold of my shirt. That's how my shirt ripped. And then after
- 8 that, he -- after about (indiscernible) to try to make a scene
- 9 here at the club. And I told him, you go ahead, I got you down.
- 10 You know, you can go home now.
- 11 And then I tell my other brother I was going to take him
- 12 home. And then as I get in my car, I drive up and then try to
- 13 make a U-turn. And then I didn't see my brother and that's when I
- 14 hit him.
- 15 Q. Okay. You drove up where?
- 16 A. Up Kennedy. Then I made a U-turn.
- 17 Q. Back to Georgia?
- 18 A. Yes, (indiscernible) towards New Hampshire, in the street.
- 19 Q. So as soon as you made a U-turn -- because you're still
- 20 Georgia, right?
- 21 A. Right.
- 22 Q. Where -- how far was it, how far --
- 23 A. It's essentially the same block. Like so if the club's here,
- 24 we went that way. It's (indiscernible) --
- 25 Q. Like how far were you driving before you hit your brother?

- 1 How much driving were you doing?
- 2 A. Like how far is --
- 3 Q. Right. So you made a U-turn, right?
- 4 A. Um-hum.
- 5 Q. Where exactly -- what side --
- 6 A. Right there in the middle.
- 7 Q. So as soon as you make the U-turn, your brother's right
- 8 there?
- 9 A. No, no, no. Like I drove down --
- 10 Q. Okay.
- 11 A. -- and then I didn't see him walking by.
- 12 Q. Which way did he walk from?
- 13 A. From the -- this side to that side.
- 14 Q. So he's walking -- so from -- he's crossing left side of the
- 15 street?
- 16 A. Yeah.
- 17 Q. Okay. He's crossing left side to the right side?
- 18 A. Right.
- 19 Q. Okay. At what point did you see him?
- 20 A. I didn't see him, so I hit him.
- 21 Q. Okay. Do you know how fast you were going?
- 22 A. I didn't look.
- 23 Q. Is this right after you made your turn?
- 24 A. No, it was like -- I kept going.
- Q. Okay. So do you think you know how fast you were going?

- 1 A. No (indiscernible).
- 2 Q. Okay. All right. Okay.
- 3 BY DET. CLAXTON:
- 4 Q. Where was your vehicle parked? When you came out of the
- 5 | club, where was your vehicle parked?
- 6 A. On the street. The same block.
- 7 Q. On Kennedy Street or on Georgia?
- 8 A. It was on Georgia. It was on Georgia.
- 9 Q. Georgia?
- 10 A. I just kept saying Kennedy because the block was right there
- 11 (indiscernible) Street.
- 12 Q. Was it parked -- was your vehicle parked south -- was it
- 13 parked south of the club or north?
- 14 A. South.
- 15 Q. South of the club?
- 16 A. When you get out, you're down there like the same block.
- 17 Down there.
- 18 Q. Okay.
- 19 BY DET. COMMODORE:
- 20 Q. So was your car -- your car is facing south right now on
- 21 Georgia Avenue. All right? If you were to get out of your car
- 22 and walk to the club, how far would you have to walk?
- 23 A. Like less than 30 seconds.
- 24 Q. So the club was basically right there?
- 25 A. Yeah.

- 1 Q. Okay.
- 2 A. So I was parked like -- let's say going from that way.
- 3 Q. Um-hum.
- 4 A. The car is right here; the club is right here.
- 5 Q. Okay. So you just walk on and go right across the street?
- 6 A. Walk down and then --
- 7 Q. Okay. Right. So you passed the club to turn around?
- 8 A. Yeah.
- 9 Q. Okay. All right. So do you know -- I'm just trying to, I'm
- 10 just trying to, trying to get an estimate. Once you made your
- 11 U-turn -- right? You made a U-turn?
- 12 A. Um-hum.
- 13 Q. How far do you say you drove? Not how fast, but how far?
- 14 A. Like halfway. Like so the club is like right in the middle.
- 15 Q. Um-hum.
- 16 A. I made a U-turn, let's say, half the whole block; I did it
- 17 halfway.
- 18 Q. Okay.
- 19 A. Before the light.
- 20 Q. Okay.
- 21 A. There was a alley right there, a (indiscernible) there.
- 22 Q. Um-hum.
- 23 A. Around there.
- 24 Q. Okay. All right.
- 25 UNIDENTIFIED SPEAKER: I can't get the printer to work.

- 1 (Detective Claxton exits.)
- 2 BY DET. COMMODORE:
- 3 Q. Because you were in a crash that caused, you know, injuries
- 4 and stuff, we have to actually get a urine sample from you.
- 5 $\|A$. I mean, I don't really have to use the bathroom now, right.
- 6 Q. Try your best.
- 7 A. All right.
- 8 Q. Yeah. Are your brothers going to be waiting for you or --
- 9 A. I don't know. I overheard that they said that my sister and
- 10 | brother was downstairs. So I'm not quite sure what they're --
- 11 Q. All right.
- 12 A. And I got to remember like my windshield being foggy and I
- 13 didn't see him.
- 14 Q. You say your windshield was foggy?
- 15 A. Yeah, it was kind of foggy.
- 16 DET. COMMODORE: All right. All right. Let me see what he's
- 17 | going to do with you real quick because, like I say, we need to
- 18 get a sample from you. So just hang tight.
- 19 (Det. Commodore exits.)
- 20 (Det. Claxton returns.)
- DET. CLAXTON: Okay, sir. As standard procedure, we're going
- 22 to have you take a urine sample, okay?
- MR. ERICK RAMOS-AYALA: Uh-huh.
- 24 DET. CLAXTON: Is that all right?
- MR. ERICK RAMOS-AYALA: Yes, sir.

- 1 DET. CLAXTON: (To Officer) Any, anything special that needs 2 to be done? Anything --3 Okay. Come on. 4 UNIDENTIFIED OFFICER: Got to go? 5 MR. ERICK RAMOS-AYALA: I really don't. 6 DET. CLAXTON: You really don't? You drank some water, 7 right? 8 MR. ERICK RAMOS-AYALA: I did. 9 DET. CLAXTON: All right. Let's see. Let's try. 10 To the left. 11 (Everyone exits.) 12 (Mr. Erick Ramos-Ayala and the detectives return.) BY DET. COMMODORE: 13 14 We're almost done. All right. Let me just ask All right. 15 you a question. At what point did you see your brother before you hit him? 16 17 Again, right there when we were -- I had been screaming and 18 we were fighting. 19 No, like when you, when you hit him with the car? The last time I saw him? 2.0 21 No, where exactly was he? You said he was crossing the

- 24 Q. Right.
- 25 A. So I was on the left lane --

- 1 Q. Um-hum.
- 2 A. -- road and then that's when I hit him. I just saw him like
- 3 falling like that.
- 4 Q. You couldn't see him from a distance?
- 5 A. I couldn't.
- 6 Q. Okay. So do you see him before, like right before you hit
- 7 him?
- 8 A. No. Like I --
- 9 Q. Did you see him walk across the street?
- 10 A. I did not, no.
- 11 Q. Okay. So you just -- so how do you know he was walking from
- 12 | the left to the right?
- 13 A. Because he was coming this way.
- 14 Q. How do you know that if you didn't see him?
- 15 A. Because I hit him, he was right there. Because if I would
- 16 have hit him on the other side, he would have been on the right
- 17 | side laying down.
- 18 Q. Okay. Or, I mean, he, he could have, you know, darted all
- 19 | the way out. I mean, what I'm saying, we, we just need to make
- 20 sure.
- 21 A. Right.
- 22 O. You know what I mean?
- 23 A. Yeah.
- Q. And you couldn't see anything in front of you?
- 25 A. Right.

- 1 Q. Okay. All right. Well, unfortunately your brother didn't
- 2 survive the injuries. He passed away.
- 3 And did you know that already?
- 4 A. (Shakes head)
- 5 Q. So right now we have some investigating to do. I'm -- you
- 6 know, you're not going to like get locked up in here right now.
- 7 Because we have to investigate. We have to see everything that
- 8 happened. And I have to be honest with you, we have to make sure
- 9 he -- you weren't in your feelings that you actually hit him for
- 10 real or you were upset. We have to make sure of that because, you
- 11 know, you're fighting inside, you're fighting outside, and all of
- 12 a sudden he's hit, and now killed. Okay. So we have some work to
- do. And I'm going to, you know, I'm going to be reaching out to
- 14 you.
- 15 Where was your phone when all this happened? Someone else
- 16 had it?
- 17 A. Yeah, my brother.
- 18 O. Hum?
- 19 A. Yeah, my brother has it. Or (indiscernible), I guess.
- 20 Q. All right. So --
- 21 DET. COMMODORE: Is his brother still downstairs?
- 22 DET. CLAXTON: Yes.
- DET. COMMODORE: They're waiting for him?
- DET. CLAXTON: Yes.
