Dear Mr. Lindberg,

Shortly after the accident, Mr. Meegolle discontinued flying with our school. Because he is a foreign national on a visa, we transferred his M-1 to Florida Flyers Flight Academy in St. Augustine, Florida.

According to our records, Mr. Meegolle began taking lessons and obtained his Private, Instrument rating and was working on his Commercial certificate when the accident occurred. His pilot time with us was 210 hours with 3.9 hours of that being in the Seneca.

I have attached copies of his most recent pilot certificate and passport which should provide you some of the information you need.
