11 some relay tests at the crossing here. The crossing might -- may
12 go up and down a couple times without being any (indiscernible).
13 It won't affect any train traffic. I thought you might get a
14 call, you know what I'm saying, the gates are going up and down
15 out in the field. Just, just to let -- you know, just giving you
16 a heads up in case somebody calls, that kind of stuff.

17 DISPATCHER: All right. Thanks. So doing some tests in at
18 25th Street, up there at milepost SX968.2, and if anybody calls
19 in, it's because they're testing it.

20 MR. PEREZ: Yeah, that's all.

21 DISPATCHER: All right. Just let me know when you're done.
22 That way if somebody does call in and you're done, you know, we
23 know --

24 MR. PEREZ: All right.

25 DISPATCHER: -- to treat it. All right. Thanks, Al.

1 MR. PEREZ: Thanks a lot, Rodney.

2 DISPATCHER: Thank you.

3 MR. PEREZ: Bye.
