## 1 INTERVIEW

- 2 MR. NICHOLSON: Good morning. Today is Thursday,
- 3 July 17, 2014. My name is Matthew Nicholson. I'm an investigator
- 4 with the National Transportation Safety Board in Washington, D.C.
- 5 We are at the Glenda Cochran & Associates law firm in Birmingham,
- 6 Alabama, for the interview of Mr. Darryle Brown. This is case
- 7 number DCA-14-MP-001.
- 8 This interview is being recorded and may be transcribed
- 9 at a later date. A copy of the transcript will be provided to the
- 10 interviewee for review prior to being entered into the public
- 11 docket. We'll now go around the room and have each person state
- 12 their name with spelling, title, and an agency or organization
- 13 that you're representing. I will start and we'll proceed to my
- 14 right.
- My name is Matthew Nicholson, spelled M-a-t-t-h-e-w, N-
- 16 i-c-h-o-l-s-o-n. I'm an investigator with the National
- 17 Transportation Safety Board.
- 18 MR. CHHATRE: Ravi Chhatre. That's R-a-v-i,
- 19 C-h-h-a-t-r-e. I'm an accident investigator in Pipeline Division,
- 20 National Transportation Safety Board.
- MR. GARDNER: Bob Gardner, Alagasco. Last name spelling
- 22 G-a-r-d-n-e-r. I'm the director of quality assurance and
- 23 compliance for Alagasco and also the party representative.
- MS. McATEE: Nancy McAtee, N-a-n-c-y, M-c-A-t-e-e. I'm
- 25 a firearm explosion specialist with the National Transportation

- 1 Safety Board.
- 2 MR. BLACKWOOD: Keith Blackwood, K-e-i-t-h,
- 3 B-l-a-c-k-w-o-o-d, pipeline safety investigator, Alabama Public
- 4 Service Commission.
- 5 MR. MONEYHAM: Matt Moneyham, M-a-t-t, M-o-n-e-y-h-a-m,
- 6 with Glenda Cochran & Associates. I'm an attorney for Mr. Darryle
- 7 Brown.
- 8 MR. BROWN: My name is Darryle Brown, D-a-r-r-y-l-e.
- 9 MS. COCHRAN: And I'm Glenda Cochran, G-l-e-n-d-a,
- 10 C-o-c-h-r-a-n, Glenda Cochran Associates.
- MR. NICHOLSON: Okay. Terrific.
- 12 INTERVIEW OF DARRYLE BROWN
- 13 BY MR. NICHOLSON:
- Q. So, Darryle, just to get started, I think we'd start
- 15 with some basic background information, if we could. Can you just
- 16 tells us what your -- the address was and unit number at Marks
- 17 Village that you were staying on December 17, 2013?
- 18 A. I don't remember the address. I know it's unit 80.
- 19 Q. Okay. And can you tell us approximately when you moved
- 20 into the Marks Village complex?
- 21 A. No, I can't tell you right offhand.
- Q. Okay. Do you know a year?
- A. No. I've been there 2 years.
- Q. Oh, you've been there about 2 years?
- A. Um-hum.

- 1 Q. Okay. Two years prior to the accident?
- 2 A. Um-hum.
- 3 Q. Okay. And was Marks Village your permanent address?
- 4 Was that where you stayed -- your primary address of --
- 5 A. (No audible response.)
- 6 Q. Okay, residence. Okay.
- Okay, can we -- I'd like to go to the layout, if we
- 8 could, that you've got in front of you, and maybe have you -- can
- 9 you identify for us -- I just want to kind of capture where some
- 10 of the appliances would have been in that apartment unit, as you
- 11 recall, to the best of your recollection. Maybe could you label
- 12 on that diagram like bedrooms, who was staying in which bedroom,
- 13 where the beds were in your bedroom, and I think there were some
- 14 other appliances in the kitchen. I believe there was a freezer?
- 15 Can you identify where those, those types of equipment were for
- 16 us?
- 17 A. With the pen right here?
- 18 Q. Yeah, feel free to mark on that, please.
- 19 MR. MONEYHAM: You want to move your --
- 20 MS. COCHRAN: Well, it's -- Darryle was right-hand
- 21 dominant so --
- MR. NICHOLSON: Or I can do it for you or --
- MS. COCHRAN: Are you going to try to do this with your
- 24 left hand?
- MR. BROWN: Yeah.

- 1 MS. COCHRAN: Or let Matt do it for you?
- MR. MONEYHAM: You point to me and I'll do it. Is that
- 3 okay with you all?
- 4 MR. NICHOLSON: That's fine. That's perfectly fine.
- 5 Yeah.
- 6 MR. BROWN: You want to know where the furniture was,
- 7 all the furniture?
- 8 MS. COCHRAN: What do you want to know?
- 9 MR. NICHOLSON: Well, any large appliances, bedroom --
- 10 where the beds were oriented in the bedrooms and who was staying
- 11 in each of the bedrooms, would be helpful information for us. So
- 12 we could start with the kitchen --
- MS. COCHRAN: Start with this --
- 14 BY MR. NICHOLSON:
- 15 Q. -- or your bedroom. That's fine.
- 16 A. It was a oven here, a stove right here.
- 17 Q. Okay. I think we have --
- 18 A. A sink right here. It's a deep freezer right here by
- 19 the door right here.
- MR. MONEYHAM: Refrigerator?
- MR. BROWN: Um-hum.
- MS. COCHRAN: A freezer did you say?
- MR. BROWN: A deep freezer.
- 24 MR. NICHOLSON: Deep freezer. Yeah, okay.
- MR. BROWN: The deep freezer and the refrigerator were

- 1 next to each other.
- MS. COCHRAN: Okay.
- 3 MR. MONEYHAM: Which one was which?
- 4 MR. BROWN: This the deep freezer right here.
- 5 MR. MONEYHAM: Okay.
- 6 MR. NICHOLSON: Okay.
- 7 MR. BROWN: The kitchen table right here.
- 8 MR. MONEYHAM: Here?
- 9 MR. BROWN: Yeah, right here, by the back door.
- 10 MR. MONEYHAM: Okay. Was it square or round?
- 11 MR. BROWN: Square. And the other side had a dryer.
- MR. MONEYHAM: Was there a washer?
- MR. BROWN: Was there what?
- MR. MONEYHAM: Was there a washer?
- 15 MR. BROWN: Yeah. A washer and a dryer.
- MR. MONEYHAM: Were they all on top of one another?
- 17 MR. BROWN: Uh-uh. The washer was on -- the washer was
- 18 over this way.
- MR. NICHOLSON: That sounds right, because he did have
- 20 water connections there.
- MR. BROWN: And the dryer was over this way.
- MR. MONEYHAM: Okay.
- MR. NICHOLSON: And that's a clothes washer, not a
- 24 dishwasher, correct?
- MR. BROWN: Um-hum.

- 1 MR. NICHOLSON: Okay. Can you put clothes under --
- 2 MR. MONEYHAM: Um-hum.
- 3 MR. NICHOLSON: -- right on --
- 4 BY MR. NICHOLSON:
- 5 Q. And what about the living room, was there anything else
- 6 in there?
- 7 A. In the living room, it was a heater right here. I
- 8 think, a sofa right here.
- 9 MR. MONEYHAM: Against the --
- 10 MR. BROWN: Um-hum. The front of the table was in front
- 11 of the window. No. Let's see. It was a sofa right over -- yeah,
- 12 that's right, that's right, because the couch was right there.
- 13 BY: MR. NICHOLSON:
- 14 Q. Um-hum.
- 15 A. I don't know, I think the other one on the wall.
- MS. COCHRAN: The what, Darryle?
- 17 MR. BROWN: The other little, whatever, what they call
- 18 it?
- 19 MR. MONEYHAM: Love seat?
- 20 MR. BROWN: Yeah. The love seat's on the wall.
- MR. MONEYHAM: Okay. Over here?
- 22 MR. BROWN: Um-hum, on the wall. And she had some table
- 23 that was so tall (indiscernible).
- BY MR. NICHOLSON:
- 25 Q. Yeah. It doesn't have to be exact. We're just trying

- 1 to get some of the bigger pieces. Was there a TV in there
- 2 Darryle, anywhere?
- 3 A. Uh-uh.
- 4 Q. Okay.
- 5 A. Uh-uh. No, there wasn't no TV in there.
- 6 Q. Any space heaters or fans?
- 7 A. The heater, the heater was right there.
- 8 Q. Okay.
- 9 MR. MONEYHAM: Any tables?
- 10 MR. BROWN: Yeah. It was like, let me see. I think it
- 11 was one or -- it was two. I think it was one right there and one
- 12 right here.
- MR. MONEYHAM: I'll just write "tab."
- MR. NICHOLSON: Yeah, I think -- if you want to
- 15 abbreviate.
- MR. BROWN: That's about it for the living room. That
- 17 was it.
- 18 BY MR. NICHOLSON:
- 19 Q. That's all for the living room? Okay.
- 20 A. There was a table in the middle.
- 21 Q. Oh, okay.
- 22 A. That was it though.
- 23 Q. How was the bed oriented in the bedroom?
- 24 A. Dresser right here.
- MR. MONEYHAM: Dresser?

- 1 MR. BROWN: Yeah. A dresser and the TV was on top, on
- 2 top -- the TV was on top of it. And she had one with the mirror
- 3 on right beside it.
- 4 MR. MONEYHAM: Sorry. It's getting a little turned
- 5 around. And the dresser?
- 6 MR. BROWN: Um-hum. Right in front of the bed. A bed
- 7 over that way. And then a bed right here.
- 8 MR. MONEYHAM: This way?
- 9 MR. BROWN: Um-hum. And there was a, what do you call
- 10 it, like dresser like what you put cups on top of.
- MS. COCHRAN: A nightstand?
- MR. BROWN: Yeah. A nightstand right there on the side
- 13 of --
- MS. COCHRAN: It was close to the bed, I think.
- 15 MR. NICHOLSON: Yeah. Wouldn't it be closer --
- 16 MS. COCHRAN: To the bed, Matt. Yeah.
- MR. MONEYHAM: Okay.
- MS. COCHRAN: Just put NS.
- 19 MR. NICHOLSON: That's it. That'll work.
- 20 MR. BROWN: Closet. And then that was it. Yes, that's
- 21 it in the bedroom.
- BY MR. NICHOLSON:
- Q. That's it for that bedroom? Okay. Thanks. So, no fans
- 24 or anything else in that room?
- A. Um-hum. What's a fan now?

- 1 Q. Like, you know, like a little portable fan?
- 2 A. I think a fan was on the floor. Yeah, the fan was on
- 3 the floor.
- 4 Q. Okay.
- 5 MR. MONEYHAM: Where was it? That way?
- 6 MR. BROWN: Yes, sitting on the floor though.
- 7 BY MR. NICHOLSON:
- 8 Q. Okay. And then it was winter. No heaters, little
- 9 portable heaters, other than the -- okay. Good.
- 10 MR. CHHATRE: Was that a ceiling fan or portable fan?
- MR. BROWN: One of them plug-up fans.
- 12 BY MR. NICHOLSON:
- Q. Plug-in fan?
- 14 A. Yeah.
- 15 Q. Okay. Terrific. Good. So this was your bedroom?
- 16 A. Um-hum.
- 17 Q. Is that everything on the first floor?
- 18 A. Um-hum.
- 19 Q. Could we do the second floor as well?
- MS. COCHRAN: This is where the stairs come up.
- MR. MONEYHAM: Um-hum.
- MR. NICHOLSON: Yeah.
- MR. BROWN: Okay. That was a kids' room.
- BY MR. NICHOLSON:
- Q. Okay. Which kid's room, is that?

- 1 A. Corey.
- 2 Q. Corey's?
- 3 A. Um-hum.
- 4 Q. Okay. Okay.
- 5 A. Denise, her mother, that's her room right there.
- 6 Q. Did you say Denise?
- 7 A. Um-hum.
- 8 Q. Okay.
- 9 A. Antuan, his studio right there.
- 10 Q. Oh, studio? Is that what -- okay. Terrific. And then
- 11 as far as furnishings, can we just rough-in maybe where the beds
- 12 where and if they were any little electronic equipment, if they're
- 13 large furniture pieces as best, you can remember?
- 14 A. He had a dresser, a long dresser, right there.
- MR. MONEYHAM: Right here?
- 16 MR. BROWN: Um-hum. And a little nightstand up here.
- 17 Let me see. Okay, closet.
- MS. COCHRAN: No, there's the closet.
- 19 MR. BROWN: Yeah. Let me see. I forget --
- MR. MONEYHAM: Where was his bed?
- MR. BROWN: His bed was like right here in the middle.
- BY MR. NICHOLSON:
- Q. Well, was it in the middle or did it touch the wall like
- 24 he shows?
- 25 A. It was like in the middle touching the wall, like --

- 1 Q. Oh, okay. So he's got it correct there? Okay.
- 2 A. Okay. And then these beds was right there. The TV was
- 3 right there.
- 4 MR. MONEYHAM: Which direction?
- 5 MR. BROWN: Right here when you come from -- when you
- 6 come in right here.
- 7 MS. COCHRAN: But did it stick out this way?
- 8 MR. MONEYHAM: Did it, did it --
- 9 MR. BROWN: Um-hum.
- 10 MR. MONEYHAM: Okay. If it was long-ways, did it go
- 11 like this?
- MR. BROWN: It was long-ways.
- MS. COCHRAN: You mean this way?
- MR. NICHOLSON: Towards the center of the room?
- MR. BROWN: She didn't have no backboard.
- 16 MS. COCHRAN: Yeah. It went just like this.
- 17 MR. BROWN: Yeah.
- 18 MR. MONEYHAM: Okay.
- MR. BROWN: And her TV right here. In Corey's room he
- 20 had, let me see -- yeah. His bed right here.
- MR. MONEYHAM: In the corner?
- MR. BROWN: Um-hum.
- 23 MS. COCHRAN: Where was the head of the --
- MR. MONEYHAM: Running in this way or?
- 25 MR. BROWN: He didn't have no headboard either, so -- it

- 1 was right there by the door.
- MS. COCHRAN: But, I mean, was it running this way or
- 3 sticking --
- 4 MR. BROWN: It was --
- 5 MS. COCHRAN: -- sticking into the room?
- 6 MR. BROWN: Okay. You walk in his room, it's like to
- 7 the left.
- 8 MS. COCHRAN: But was it like this or like this?
- 9 MR. BROWN: It was like this.
- MS. COCHRAN: Okay.
- 11 MR. MONEYHAM: I can't -- I couldn't -- like --
- MS. COCHRAN: That way.
- MR. BROWN: Um-hum, like --
- MS. COCHRAN: Yeah.
- MR. NICHOLSON: So which side was -- where does his head
- 16 go when he slept?
- MS. COCHRAN: Here, right?
- MR. BROWN: Um-hum.
- 19 BY MR. NICHOLSON:
- Q. Okay. So it came out into the center of the room?
- 21 A. Um-hum.
- 22 Q. Okay.
- 23 A. That was one of them old, big old beds.
- Q. King size?
- A. Um-hum.

- 1 MR. CHHATRE: I thought he said this way.
- 2 MR. NICHOLSON: I thought he did too, but he's --
- MR. BROWN: Well, that's wrong. It's this way.
- 4 MR. NICHOLSON: But he said it's a very large bed.
- 5 MR. BROWN: Um-hum.
- BY MR. NICHOLSON:
- 7 Q. So the headboard's here. Is that what we're saying?
- 8 A. Um-hum.
- 9 Q. His head was there and his feet were out here?
- 10 A. Um-hum.
- 11 Q. Okay. So that's accurate. And --
- 12 A. He had a dresser and a TV on top of it, and that would
- 13 be right -- should have been right there by the bed.
- MR. MONEYHAM: Right here?
- MR. BROWN: Um-hum. And that's it.
- BY MR. NICHOLSON:
- 17 Q. Okay. What was in that studio?
- 18 A. A computer.
- 19 Q. Okay.
- 20 A. It was a computer, a lot of recording stuff. It was a
- 21 computer, speakers, equipment in a box -- a speaker, a computer.
- 22 I forgot the name of that little box that we had all the -- to
- 23 open up a program.
- 24 MR. MONEYHAM: Where, was it on a table?
- MR. BROWN: Um-hum.

- 1 MR. MONEYHAM: Where was that?
- 2 MR. BROWN: No. Like everything was on like a long
- 3 table like this right there in the front of the window.
- 4 MR. NICHOLSON: Okay.
- 5 MR. MONEYHAM: Right here?
- 6 MR. BROWN: Um-hum.
- 7 MR. MONEYHAM: So like this?
- 8 MR. BROWN: Yeah.
- 9 BY MR. NICHOLSON:
- 10 Q. So it was a computer and some microphones maybe, mixing
- 11 equipment?
- 12 A. Um-hum.
- 13 Q. Okay. So electronics?
- 14 A. Um-hum.
- MR. MONEYHAM: I wrote, with computer and recording
- 16 equipment.
- MR. NICHOLSON: Yeah, that works.
- 18 MR. BROWN: And a couple of chairs. I think that was
- 19 about it.
- 20 MS. COCHRAN: Okay. Is that where the chairs were?
- MR. MONEYHAM: Like pulled up to the table?
- MR. BROWN: Um-hum.
- MR. MONEYHAM: Okay.
- MR. BROWN: That was it.
- BY MR. NICHOLSON:

- 1 Q. Okay. And then up on this level were there any other
- 2 little portable fans or little space heaters or any other kind of
- 3 portable electronic?
- 4 A. (No audible response.)
- 5 Q. Okay. Terrific. How about in the storage, what were
- 6 you guys keeping in the storage, anything?
- 7 A. Oh, she had --
- 8 Q. Just clothes?
- 9 A. -- it was a bunch of -- a mattress and I think AC units.
- 10 Q. I'm sorry, what unit?
- 11 A. AC units.
- 12 Q. Sure. A little AC, like a air conditioning unit?
- 13 A. Um-hum.
- MR. NICHOLSON: What did you write there, Matt?
- 15 MR. MONEYHAM: Mattress and AC unit.
- 16 MR. NICHOLSON: Oh, a mattress and an AC unit. Okay.
- MR. BROWN: Yeah, that was it.
- 18 MR. NICHOLSON: Okay. I appreciate it. Thank you.
- 19 MR. CHHATRE: On the master bedroom, which way was the
- 20 head and which way were the feet?
- MR. BROWN: Right here?
- MR. MONEYHAM: Um-hum.
- MR. BROWN: The bed, right -- this the head right here.
- MR. MONEYHAM: Okay. Do you want me to put --
- 25 MR. NICHOLSON: Yeah, we can mark that.

- 1 MR. MONEYHAM: Okay, that's --
- 2 MR. CHHATRE: That's good enough, yeah.
- 3 MR. NICHOLSON: Wonderful. Good. Thank you. That's
- 4 very helpful, Darryle. I appreciate that.
- 5 MR. BROWN: Um-hum.
- BY MR. NICHOLSON:
- 7 Q. If you could, can you tell us your age?
- 8 A. Thirty-four.
- 9 Q. Thirty-four. Okay. Excellent. And your relationship
- 10 to --
- 11 A. Fiancé.
- 12 Q. You were the fiancé of Ms. Mabry? Okay.
- And then, going back to this map a little bit, we -- I'd
- 14 like to label, just to be sure, what was the front door and what
- 15 was the back door as far as exterior doors, and which one you used
- 16 most frequently or people used most frequently to enter and exit?
- 17 A. The back.
- 18 MR. MONEYHAM: This is the back?
- 19 BY MR. NICHOLSON:
- 20 Q. Yeah. So parking would have been out here.
- 21 A. Um-hum.
- Q. The cars? Okay. Calling that the back. Okay.
- MR. MONEYHAM: And this is the front?
- MR. BROWN: Um-hum.
- BY MR. NICHOLSON:

- 1 Q. And can you tell us which, which of the two would have
- 2 been used most frequently by the kids and --
- 3 A. (No audible response.)
- Q. Okay, the back. Can you make a note of that somehow,
- 5 most frequent? Okay, terrific.
- 6 MR. NICHOLSON: Okay, Ravi, you want to --
- 7 BY MR. CHHATRE:
- 8 Q. Yeah. Can you walk us through on the day of the
- 9 accident how the day started in the morning and then walk us
- 10 through until you went to bed?
- 11 A. I always get up -- they had to leave for school at like
- 12 7. I get, I get up about like 6:30 or 6:45 and wake them up.
- Q. Okay. And then what happened?
- 14 A. Then she'll get up. I get her up around about like 7,
- 15 7:30.
- 16 Q. You know what time you left for work?
- 17 A. I leave, I leave for work around about like 7:45.
- 18 Q. 7:45 you left for work. Okay. Now, did you smell any
- 19 gas odor in the morning?
- 20 A. In the morning?
- 21 O. In the house?
- 22 A. In the house? No, sir.
- Q. Okay. Now, in the morning if you use bathroom, did you
- 24 smell any gas odor there in the bathroom?
- 25 A. (No audible response.)

- 1 Q. Now, when you -- which door you use to go out of the
- 2 house?
- 3 A. The back.
- 4 Q. Back door. Do you -- and you walked over the lawn to
- 5 the curb? Where was your car parked?
- 6 A. In the back.
- 7 Q. Back. Did you smell any gas odor outside the house?
- 8 A. Outside? Once or twice.
- 9 Q. That day?
- 10 A. Yeah.
- MS. COCHRAN: No, he's asking you about that day.
- MR. BROWN: Oh, he talking about that day?
- MS. COCHRAN: He's asking you about a specific -- the
- 14 day of the explosion.
- 15 MR. CHHATRE: The day of the explosion.
- 16 UNIDENTIFIED SPEAKER: Day prior.
- 17 MR. NICHOLSON: Well, I, I think it would be the day
- 18 prior, actually.
- MS. COCHRAN: I'm sorry.
- MR. CHHATRE: Yeah.
- MR. NICHOLSON: Because it -- the accident happened
- 22 around 2:30 in the morning, I believe?
- 23 UNIDENTIFIED SPEAKER: Right.
- MR. NICHOLSON: It was very early. So we're asking
- 25 about the day prior, December 16th. I think it was a Monday.

- 1 When you left for work on Monday morning, the day before the
- 2 accident, did you smell any gas, either inside or outside?
- 3 MR. BROWN: Not when I left there. When I went in the
- 4 afternoon I get a whiff of it.
- 5 MR. NICHOLSON: In the afternoon?
- 6 MR. BROWN: Um-hum.
- 7 MR. NICHOLSON: The day before. Okay. And so where
- 8 would that have been? Outside the house, is that what you're
- 9 saying? Take your time. I know we're going back a-ways, so --
- 10 I've got a map that shows the house and the outside if you want to
- 11 kind of refresh your memory. I don't know if we can scooch this
- 12 closer.
- MS. COCHRAN: Okay.
- MR. NICHOLSON: And if you could point to where you
- 15 thought you had --
- 16 MS. COCHRAN: What did you ask him? Which --
- 17 MR. CHHATRE: I was asking did he smell any gas odor
- 18 outside the house as he left for work.
- MS. COCHRAN: At any time or that -- or the day before?
- 20 MR. CHHATRE: No. That morning when --
- 21 UNIDENTIFIED SPEAKER: I'm confused as to whether you're
- 22 talking about the day of or --
- BY MR. CHHATRE:
- Q. Okay, Monday morning, Monday morning when you left for
- 25 work, did you smell any gas odor on the outside?

- 1 A. I don't know. I mean, when are we talking about?
- 2 O. No?
- 3 A. I don't know.
- 4 Q. Okay. What time will you come back from work?
- 5 A. What time what?
- 6 Q. What time do you --
- 7 A. What time?
- 8 Q. What time did you come back from work on Monday evening?
- 9 A. It depend, all depends. It depend on what kind of stuff
- 10 we have to do at work. I might get off 3:30 sometime.
- 11 Q. No, on that day, on that Monday?
- 12 A. On a Monday?
- MR. MONEYHAM: The day the explosion happened?
- MR. BROWN: I wasn't working at the time that I can
- 15 remember.
- BY MR. CHHATRE:
- 17 Q. Okay. You do not work Mondays?
- 18 MS. COCHRAN: He wasn't working, he said.
- MR. BROWN: I wasn't working.
- MR. NICHOLSON: On Monday, okay.
- MR. CHHATRE: Okay.
- MR. NICHOLSON: So you were at home all day?
- MR. BROWN: Well, I wasn't working at the time.
- MR. NICHOLSON: Okay.
- BY MR. CHHATRE:

- 1 Q. I'm sorry. Can you repeat that?
- 2 A. I wasn't working at the time.
- 3 Q. Okay. You're not working at the time. So were you home
- 4 on Monday all day?
- 5 A. What he saying, all day?
- 6 MS. COCHRAN: Were you in the house all day the day
- 7 before the explosion? Because the explosion happened early in the
- 8 morning, Darryle.
- 9 MR. BROWN: Um-hum.
- MS. COCHRAN: So you were home?
- MR. CHHATRE: You're at home.
- MR. NICHOLSON: He's shaking his head, yes, just for the
- 13 record. Okay.
- BY MR. CHHATRE:
- 15 Q. So what kind of work you do?
- 16 A. The kind of work I was doing?
- 17 Q. What --
- 18 MS. COCHRAN: Yes. He can't work now, obviously.
- MR. CHHATRE: No, no, I mean at --
- MS. COCHRAN: Where were you working before the
- 21 accident, is what he's asking you?
- MR. BROWN: Birmingham Recycle.
- MR. MONEYHAM: Birmingham Recycling.
- MR. CHHATRE: Birmingham Recycling. Okay.
- BY MR. CHHATRE:

- 1 Q. And what are your normal work hours before the accident?
- 2 A. Mostly like an 8, 9-hour shift.


