UP 7029: "UP 7029 with a release when you're ready, over."

Dispatcher: "I am ready. Go ahead, over."

UP 7029: "Both the Engineer and Conductor agree we are clear of track warrant number 3008 to the UP 7029, Terra Cotta to YL 187.7. Limits reported clear by Johnson and no switches used, over."

Dispatcher: "Understand no switches used. Both Conductor and Engineer do agree to release track warrant number 3008, that's three thousand eight, addressed to UP 7029, limits of Terra Cotta to YL 187.7 on main track Sharon Springs Sub. These limits are reported clear and released, midnight fourty-four, that's zero zero four four. Dispatcher TJB released by Johnson, over."

UP 7029: "Track warrant number 3008, limits reported clear at midnight fourty-four, zero zero four four, TJB and Johnson, over."

Dispatcher: "UP 7029, that is correct, over."

UP 7029: "That is correct. Thanks, out."

Dispatcher: "And just so you know you'll be protecting this, ah, CWEAQ that's ah, at Hayes siding right now, over."
