- 3. I have my firehouse fire reports and that is what we have for CAD as it lists the addresses and times,, but I will tell you because of the overwhelming amount of calls times are wrong and we did not capture all calls. People would grab a crew when they were at a call and have them check many homes at the same time, not captured. If you want those reports we can try and work something out. Beyond my IT capabilities, but I will get someone who can do it.

Hello Rachael

I will attempt to answer all you questions.

- 1. Yes I still have 4 FF injuries in law. But there were some in other towns. North Andover told me 1 FF injury and Andover told me 2 FF injuries
- 2. Our numbers have not changed
- 3. Our numbers are 24 is the minimum on duty. We have a total of 125 positions at the time. I had 6 vacancies and 3 on injury leave. During the emergency I had a full department recall. So the vast majority of the department responded that day. But I did not go back and count how many showed up. If it is extremely important I will have my secretary go back in the books and see the paid numbers. I do believe that day we were at minimum of 24.
- 4. I do not currently have an after action report. One is being created. It is not completed yet. I will have to search the last date of training at CG. We had yearly facility training but had never trained for this type of event. They also used to come to the station once a year for gas safety training. But again I would have to research those dates if you need them.
- 5. Yes we have many fire reports but many of them are the same as we were just documenting damage to structures and my officers were not at every fire.
- 6. Shelters- Partham school at east Haverhill and Marston streets 250 each, Arlington school on Arlington St. both schools on the north side of the city, 1 night at central catholic high school because the others were at capacity and the electricity had not been turned on. Stafford St in Methuen/Lawrence line off Broadway this shelter was a FEMA organized shelter that was set up with the trailer parks for the cold, not on the initial 4 days.
