**SUBJECT:** Response, Remediation, and Restoration Work in Regard to the  
Discharge of Oil to Talmadge Creek and Kalamazoo River in Calhoun and  
Kalamazoo Counties, Michigan, on July 26, 2010

As Enbridge Energy, LP (Enbridge) approaches the endpoints for required response actions under the Removal Administrative Order issued by the U.S. Environmental Protection Agency (U.S. EPA) pursuant to Section 311(c) of the Clean Water Act on July 31, 2010, it is critically important that Enbridge's remediation work continues and that progress is sustained.


With the emergency phase of response to the oil spill into Talmadge Creek and the Kalamazoo River winding up, the Michigan Department of Natural Resources and Environment (DNRE) will be assuming the lead in ensuring that affected water and soils comply with state criteria that are protective of the public health, safety, welfare, and the environment, and also ensuring that the river environment, as well as plant and animal life supported by the river, are restored to the fullest extent possible.

It is the DNRE's understanding and expectation that Enbridge will continue to comply with the requirements of the U.S. EPA Removal Administrative Order, including those responsibilities that continue after completion of the required work at and near the spill site. It is the DNRE's further understanding and expectation that Enbridge will comply with the requirements of Michigan law, including but not limited to the remediation and restoration activities required by the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, MCL 324.101 *et seq.* The DNRE anticipates entry into an order within approximately 90 days that will provide a framework for achieving compliance with the law, and appreciates Enbridge's stated willingness to work cooperatively with the DNRE and other state authorities in the meantime. The DNRE also hopes to work with Enbridge and the U.S. EPA to transition seamlessly from the emergency response work to the more focused cleanup aimed at remediating and restoring a safe environment.
