- 24 DISPATCHER 8: Okay.
- 25 CALLER: All right.

- 2 gotten a couple other calls.
- 3 CALLER: All right. Thank you.

- 13 UNIDENTIFIED SPEAKER: (Indiscernible) for 833.
- 14 DISPATCHER: Go ahead.
- 15 UNIDENTIFIED SPEAKER: (Indiscernible). I need an
- 16 address check on Division Drive please.
- 17 DISPATCHER: The address on Division is 16240 Division
- 18 Drive, 1-6-2-4-0 Division Drive. Stand by for a cross street.

- 17 DISPATCHER: Okay. Will do. Do any of their flags
- 18 there have their TX on it?
- 19 (Talking Clock: July 26, 2010, 11:48:42.)
- 20 UNIDENTIFIED SPEAKER: No, but they're on Gulf and
- 21 South Kalamazoo. Hang on a minute. I've got --
- 22 (Talking Clock: July 26, 2010, 11:48:58.)
- 23 UNIDENTIFIED SPEAKER: Disregard that. I've got one of
- 24 the employees here.
- DISPATCHER: Excellent. Thank you.
