1 INTERVIEW

- 2 MR. NICHOLSON: This is Matt Nicholson conducing
- 3 interviews on the Marshall, Michigan-Enbridge Crude Oil Leak of
- 4 July 25th, 2010. We are here interviewing Rick Bonney of the
- 5 Marshall Township Fire Department.
- 6 MR. BONNEY: Yep.
- 7 MR. NICHOLSON: Okay.
- 8 MR. NICHOLSON: Rick, if you would, introduce yourself,
- 9 give us some contact information and is it okay if we record you?
- 10 MR. BONNEY: Yes.
- 11 MR. NICHOLSON: Okay. Take it away.
- 12 MR. BONNEY: My name is Rick Bonney. I'm the Captain of
- 13 the Marshall Township Fire Department. Cell phone number is 269-
- 14 ----or you can contact me through the Township.
- 15 MR. NICHOLSON: Okay. My name's Matthew Nicholson. I
- 16 am a mechanical engineer with the NTSB investigating this
- 17 accident. My contact number -- my contact -- I can be contacted
- 18 at Matthew.Nicholson@ntsb.gov and I will give you a card.
- 19 Actually, it's probably easier that way. Can you introduce
- 20 yourselves, please?
- 21 MR. JOHNSON: Jay Johnson. I'm a senior compliance
- 22 specialist for Enbridge Pipelines and I'm hoping that -- I think
- 23 I'm out of cards. I am. So I can be contacted, cell phone which
- 24 is -- Jay as in J-a-y Johnson, (218) -----and my email is
- 25 Jay. Johnson -- J-a-y dot Johnson I should have said that @Enbridge

- 1 which is E-n-b-r-i-d-q-e dot com.
- MS. SANZO: My name is Dana Sanzo. I'm an investigator
- 3 with the NTSB, office telephone number (202) 314-6534.
- 4 MR. PIERZINA: And I'm Brian Pierzina with the Pipeline
- 5 and Hazardous Materials Safety Administration or PHMSA. My cell
- 6 phone number is (816) -----and my email is Brian, B-r-i-a-n

- 8 INTERVIEW OF RICK BONNEY
- 9 BY MR. NICHOLSON:
- 10 Q. Okay. So the reason we're here is -- I know you've
- 11 given a statement and --
- 12 A. I just find one mistake on the statement.
- 13 Q. Oh, did you? We'll clarify that.
- 14 A. At the top it said July 26th and it should say July
- 15 25th.
- 16 O. Oh, that's critical so --
- 17 A. Yeah.
- 18 Q. Did you type that statement?
- 19 A. Yes.
- Q. Okay. So you might walk us -- you want to just walk us
- 21 through your statement a little bit about what time you got there,
- 22 who you were with?
- 23 A. I didn't have approximate times because I didn't have
- 24 the report in front of me so approximately 2200 we got a call for
- 25 an odor investigation. It may have been a few minutes before

- 1 2200. We were dispatched to our station but dispatch
- 2 misunderstood Marshall City when they requested us.
- 3 Q. How'd that happen? Did they dispatch you to your
- 4 station?
- 5 A. (No audible response.)
- 6 Q. Okay.
- 7 A. For an odor investigation.
- 8 Q. How did they get that wrong?
- 9 A. Well, when Marshall City made the request they said that
- 10 they needed to send Marshall Township because it was coming from
- 11 their station and then we said the pipe that comes out of the
- 12 ground and she just --
- 13 Q. Okay.
- 14 A. -- misunderstood completely and put it down as our
- 15 station.
- 16 O. Okay.
- 17 A. I was listening on the (indiscernible) side so I heard
- 18 that side of the conversation so I knew it was out at Old 27 and
- 19 Division Drive where the actual, you know, incident was.
- Q. It was a residence?
- 21 A. No. He was wanting us to look at the pumping station
- 22 that's out there. There's two natural gas stations out on
- 23 Division Drive which is what I thought he was talking about and
- 24 then there is the Buckeye Terminal's pumping station for the
- 25 gasoline that comes into the tank farm.

- Q. When you say what he was talking about, the dispatcher?
- 2 A. No. Jeff --
- 3 Q. The caller.
- 4 A. Jeff Rhoades (ph.) with Marshall City.
- Q. Okay.
- 6 A. 1231 initially responded out there on an odor
- 7 investigation.
- 8 Q. What's 1231? Is that a --
- 9 A. That's --
- 10 Q. -- police?
- 11 A. No, that's Marshall City's --
- 12 Q. Oh, I see.
- 13 A. -- pumper.
- Q. Okay. Okay.
- 15 BY MR. JOHNSON:
- 16 Q. Just to get you to go a little slower.
- 17 A. Okay.
- 18 Q. It's really, so Marshall City, that's their pumper.
- 19 A. Yes.
- Q. And who responded first?
- 21 A. They responded first and that was Jeff Rhodes that was
- 22 on it at that point.
- MR. JOHNSON: Okay. I'm sorry.
- MR. NICHOLSON: Was he by himself?
- MR. BONNEY: Yes.

- 1 MR. NICHOLSON: Okay.
- 2 BY MR. JOHNSON:
- 3 Q. Can you just, maybe -- so based on location who does the
- 4 locate sort of the odor complaints issues (indiscernible)?
- 5 A. They originally dispatched it as out at the airport so
- 6 he got down in the area of the airport which is in Marshall City,
- 7 determined it wasn't coming from the airport, went down a little
- 8 bit said it was coming from the other side of the road which would
- 9 be Marshall Township. So he said go ahead and get Marshall
- 10 Township coming this way, you know, it's going to be coming from
- 11 their station and that's where the dispatcher dispatched it for us
- 12 to come to our station rather than out to Old 27 and Division
- 13 which is where he was sitting.
- Q. Oh, okay. Yeah, that's a pretty easy mistake.
- 15 A. I contacted them a couple times on the radio asking for
- 16 a little bit more clarification and asking if they were going to
- 17 be standing by. They did not standby. They already left. He
- 18 felt it was coming from the pipeline station there and so --
- 19 BY MR. NICHOLSON:
- 20 Q. They were at Division Drive.
- A. Yeah.
- 22 Q. Okay.
- 23 A. Yeah and I am so primed for -- because they said it was
- 24 a natural gas, I'm so primed for those other two stations that are
- 25 down on Division Drive that that's where we had the two first.

- 1 0. Okay.
- 2 A. So we came down 16 Mile Road to Division and then we
- 3 headed east on Division to where those two pumping stations are.
- 4 O. Uh-huh.
- 5 A. And I got out of the truck --
- 6 Q. I'm sorry. I want to back up. You said we. How may
- 7 are with you at this time?
- 8 A. Me and Dave Austin.
- 9 Q. Okay.
- 10 BY MR. JOHNSON:
- 11 O. Maybe I'll back up just a little bit, too. So you got
- 12 the call from Jeff Rhoades.
- 13 A. We got the call from alarm office. They toned us after
- 14 talking, you know, with Marshall City, Jeff Rhoades.
- 15 Q. So Jeff called you and/or them? Sorry.
- 16 A. Jeff called dispatch.
- 17 MR. NICHOLSON: Oh, so he called dispatch, said --
- 18 MR. BONNEY: After the Marshall Township sent --
- 19 BY MR. JOHNSON:
- 20 Q. Called up Marshall Township, they put in that address.
- 21 A. Yes.
- 22 Q. Okay. So you -- okay, now it's clicking.
- 23 A. And there's two separate radio systems. There's the VHF
- 24 system that we're, you know, that County fire's on and then
- 25 there's the 800 side that they're trying to switch over to but

- 1 isn't working real well. So I had an 800 radio and I heard their
- 2 half of the traffic so I knew that the incident was going to be
- 3 out in that area and not at our fire station. Had I not of heard
- 4 that we'd a come to our fire station and said there's no odor here
- 5 and we'd a cleared and went home.
- 6 MR. NICHOLSON: Yeah. Okay. Okay. So we interrupted
- 7 you. You were -- there's two of you and you were heading to the
- 8 natural gas stations on 15.
- 9 MR. BONNEY: Yes. No, I'm on Division Drive.
- 10 MR. NICHOLSON: Division, I'm sorry.
- 11 BY MR. JOHNSON:
- 12 Q. So where did you meet Dave? I mean, where did he come
- 13 from?
- 14 A. He came from home and met me here.
- 15 Q. Okay.
- 16 A. And we responded from here in 1371 which is -- the
- 17 truck's not here right now and that's the truck we use to take out
- 18 on odor investigations.
- 19 Q. What was the number again?
- 20 A. 1371.
- 21 UNIDENTIFIED SPEAKER: I don't think it makes a
- 22 difference which it is.
- BY MR. NICHOLSON:
- Q. What -- why is that truck used for odor investigations?
- 25 What's --

- 1 A. It's just a smaller truck. We don't have to take the
- 2 big trucks out if we don't have to.
- Q. Oh, okay.
- 4 A. And --
- 5 Q. It's not got any special equipment or anything?
- 6 A. No.
- 7 Q. Okay.
- 8 A. We don't have any gas detectors at this time. The ones
- 9 that we did have are out of service.
- 10 Q. Is that truck here in the shop? Did I see it?
- 11 A. No.
- 12 Q. Okay.
- 13 A. That truck is sitting down at 15 and A.
- 14 Q. Oh, right.
- 15 A. And the empty bay we were standing in, that's where it
- 16 goes.
- 17 Q. Okay. All right.
- 18 A. So we stopped in front of the Panhandle pipeline station
- 19 that's right there. Now, those are up -- you walk up a little
- 20 hill to get where the fenced-in area is and that's up about four
- 21 feet, you know, or probably about four feet, you know, off from
- 22 the road.
- BY MR. JOHNSON:
- Q. One question, the Panhandle is that on the north side of
- 25 Division or --

- 1 A. The north side.
- 2 O -- the south side? North side of Division.
- 3 A. Yeah.
- 4 Q. Okay.
- 5 A. And the north side would be Marshall Township and the
- 6 south side is Fredonia.
- 7 UNIDENTIFIED SPEAKER: Great.
- 8 BY MR. JOHNSON:
- 9 Q. Can get confusing there.
- 10 A. Yeah. So we stopped at the Panhandle station on the
- 11 north side of the road, we walked up the hill. There was odor
- 12 down in the road but it didn't smell like natural gas. It smelled
- 13 like more of a petroleum.
- 14 BY MR. NICHOLSON:
- 15 Q. Okay.
- 16 A. So the smell --
- 17 Q. So you could readily smell this?
- 18 A. Yes. You could smell it there in the road. When we
- 19 walked up to the fence there was -- you could still smell it but
- 20 there was less of an odor up there.
- 21 Q. Okay.
- 22 A. So we decided to walk across the road kitty-corer from
- 23 where that substation is. It was the other one for Michigan Gas
- 24 Utilities, I think, is what it's -- yeah, Machine Gas Utilities.
- 25 It's on the south side of the road in Fredonia Township. And we

- 1 did the same thing. We actually could hear some noise coming from
- 2 the, you know, the pipeline.
- 3 Q. (Indiscernible.) Okay.
- A. Yeah. But again, as we walked up to the area where the
- 5 fence was the smell was less, at that point. So we got back in
- 6 the truck and we continued down Division Drive heading towards Old
- 7 27 so we were going east and Division.
- 8 Q. I'm sorry so you returned to Division and you went to
- 9 East.
- 10 A. We were on Division.
- 11 O. You were on Division.
- 12 A. Yeah. We just continued east --
- 13 O. Oh, okay.
- 14 A. -- we were already going east we just continued in that
- 15 direction.
- 16 BY MR. JOHNSON:
- Q. So I'm -- you parked or you smell it when you parked
- 18 your truck, you walked up the hill, got less and less, I don't
- 19 want to put words in your mouth, Chief, and it was like, okay,
- 20 it's less here. So then you walked back and you went across to
- 21 the south side which is Fredonia and that's where the other --
- 22 that's where Michigan's --
- A. Yeah.
- 24 Q. Okay. Then --
- 25 A. And the same situation down the road because the road's

- 1 sort of down in like a gully kind of thing -- down in the road it
- 2 was stronger. You got out to where the fence was and it was less.
- Q. Okay.
- 4 A. Because our normal procedures are is if it's coming from
- 5 that, you know, we get the phone number off the fence, call the
- 6 pipeline company, have them come out and check things out. But we
- 7 determined it was neither one of those two stations.
- 8 Q. And you go in there without gas detectors?
- 9 A. Yes.
- 10 Q. Okay.
- 11 A. If we need a gas detector then we'll call Marshall City
- 12 and have them bring theirs out.
- BY MR. NICHOLSON:
- Q. So it's just a sniff test?
- 15 A. Yeah.
- 16 Q. Okay.
- 17 A. You could tell that there was something in the air.
- 18 Now, our normal is wintertime those O rings where they screw the
- 19 little mercaptan bottles on there --
- 20 Q. Okay.
- 21 A. They shrink up a little bit --
- 22 O. Uh-huh.
- 23 A. -- and then that leaks out --
- 24 Q. Yeah.
- 25 A. -- and you get the odor with no gas.

- 1 O. Um-hum.
- 2 A. And that's very common for us. When it gets to be about
- 3 ten degrees out and no wind we start getting all sorts of calls
- 4 and that's normally at the substation at Tar (ph.) Road and 15%
- 5 Mile Road which is the other side of 69 and that's Consumer
- 6 Station. So we got a bunch of pipelines that run through there.
- 7 Q. Yeah we found out. Okay.
- 8 A. So we continued east down Division and we came to
- 9 Division and Old 27. Since it was sort of an oily smell we turned
- 10 south and went to Walters-Dimmick.
- 11 O. So that, you're saying, was an oily smell and you
- 12 somehow determined it wasn't gas it was more of a --
- 13 A. Yeah, it was a petroleum kind of smell --
- 14 Q. Okay.
- 15 A. We could tell that it wasn't a natural gas kind of smell
- 16 at that point.
- 17 Q. Okay.
- 18 A. And now we're just trying to figure out where the odor's
- 19 coming from. So the first place we thought about was Walters-
- 20 Dimmick.
- 21 BY MR. JOHNSON:
- 22 Q. Okay. So you -- and I know you gotta be going, jeez,
- 23 these people. You went down Division and came to Old 27 that's
- 24 when you said okay, now we smell it so is that an interaction you
- 25 go which --

- 1 A. It's across.
- 2 O. So --
- A. You can go across. It turns to Oliver Drive on the
- 4 other side of Old 27.
- 5 Q. Okay. Or you turn.
- 6 A. Or you can left or right and that'd be Old 27.
- 7 Q. And so you turned --
- 8 A. Turned right which would be south.
- 9 Q. Okay.
- 10 A. And then --
- 11 O. Off of Old 27 on to --
- 12 A. Off of Division on to Old 27.
- 0. Okay. Okay. Sorry.
- A. Division's run east and west. Old 27's north/south. We
- 15 pulled in. It was real heavy on in the road in front of Walters-
- 16 Dimmick. We pulled into the --
- 17 MR. NICHOLSON: I'm sorry. What's Walters-Dimmick?
- 18 UNIDENTIFIED SPEAKER: It's a --
- MR. BONNEY: It's a Shell -- they own a bunch of gas
- 20 stations across southern Michigan.
- 21 BY MR. JOHNSON:
- 22 Q. Oh, okay.
- 23 A. They've got a warehouse there that's got a bunch of oil
- 24 in it but it's all refined oil and then all their products for
- 25 the -- that they take off to the gas station itself.

- 1 0. Okay.
- 2 A. Like I said out by the road it was real strong. As we
- 3 drove to the back of the complex which would be going back west it
- 4 got less and less to the point of at the back corner of the
- 5 building the odor went away. So we turned around and went back
- 6 out to Old 27. Due to the, you know, petroleum nature of the
- 7 smell we went down to Buckeye Terminals which is the tank farm on
- 8 Old 27. So we went back north on Old 27, pulled in there, drove
- 9 around. We didn't have any odor there at all. So we came --
- 10 BY MR. JOHNSON:
- 11 Q. Can I just stop right there. I don't have a question
- 12 I'm just trying to catch up here.
- 13 A. Okay.
- 14 Q. So you went back which direction on Division to --
- 15 A. North. No, we went back north on Old 27.
- 16 MR. PIERZINA: And I had a quick question just to
- 17 clarify. So when you were at Walters-Dimmick as you went west
- 18 towards the back of the building the smell got less and less?
- MR. BONNEY: Yes.
- MR. PIERZINA: Okay.
- 21 MR. BONNEY: To the point where we got to the very back
- 22 corner of the building we didn't detect any odor.
- MR. PIERZINA: Okay. Okay.
- 24 BY MR. JOHNSON:
- Q. So back side of the building no odor then you went back

- 1 north on Old 27 to the Buckeye Terminal
- 2 A. Yeah.
- Q. Okay. I'm up to speed, sorry.
- 4 A. We drove through there, didn't have any odor there.
- 5 Came back out of there, went back down to Division, turned left
- 6 which would have been going east again which turns into Oliver
- 7 Drive and, you know, it was still real heavy in that area. We got
- 8 in front of the Bostik Corporation there and it was real heavy in
- 9 that area. I called Marshall City, their station, at that time to
- 10 ask for a wind direction and speed to see if we could figure out
- 11 where it was coming from.
- 12 BY MR. NICHOLSON:
- 0. The Marshall City --
- 14 A. Yeah.
- 15 Q. -- Fire?
- 16 A. Yeah.
- 17 Q. Oh, okay. And what was the wind direction.
- 18 A. It was calm. So that didn't help us any trying to
- 19 figure out, you know, if it was coming from the south then we'd
- 20 know to head south farther, you know, whatever but being reported
- 21 as calm it's a little more difficult to figure out, kind of, where
- 22 we -- which direction do we go?
- BY MR. JOHNSON:
- Q. Just for -- I mean, I got all that but so when you
- 25 drove -- you drove around the terminal and you found no odor then

- 1 you went back down Division and turned --
- 2 A. Went back down 27, turned left on Oliver Drive which
- 3 is -- they changed the name of Division to Oliver Drive at that
- 4 point so it's --
- 5 Q. Okay.
- 6 A. -- like the same road.
- 7 MR. NICHOLSON: Yeah, it's --
- 8 BY MR. JOHNSON:
- 9 Q. Turned left on Oliver --
- 10 A. Yeah. If you go straight across Old 27 from Division,
- 11 you know, it turns from Division to Oliver drive.
- 12 Q. Okay. So you went back on Division -- went back down
- 13 Old 27 --
- 14 A. Turned left --
- 15 Q. -- left on Oliver.
- 16 A. Yes.
- 17 Q. And then you called the fire -- or --
- 18 A. Got out in front of --
- 19 O. Oh, the --
- 20 A. -- the Bostik Corporation which is like the second
- 21 business in on the south side of the road. It was real heavy in
- 22 that area so we called and asked for a wind direction and speed
- 23 from Marshall City.
- Q. Okay. Now, I'm up to speed, anyway.
- 25 A. They said it was calm. We -- I told them that it was a

- 1 petroleum kind of smell, seemed like it was stronger in front of
- 2 Bostik. We were going to drive around a little more trying to
- 3 figure out if we could find more specific and at that point we
- 4 went down a few different roads in that area and that's what I've
- 5 got on here. Wait. I missed one. After we came out of Walters-
- 6 Dimmick we went around behind on -- what's the name of that road?
- 7 MR. PIERZINA: Brooks Drive?
- 8 MR. BONNEY: Yep. We went down Brooks Drive and -- to
- 9 see if there was any smell down that way and we didn't get
- 10 anything. Well, we did. We'd get -- did get an odor down there
- 11 but it wasn't as heavy as it was out on Old 27. So after Bostik
- 12 we went down Adams and Pratt Drive. We stopped at Old 27 and
- 13 Wooley Drive. There's a company there called Advanced Fuel
- 14 something or another then we walked around.
- 15 BY MR. NICHOLSON:
- 16 Q. Where is that?
- 17 A. On the corner --
- 18 Q. That's on Pratt Drive?
- 19 A. No that's on the corner of Wooley Drive and Old 27.
- 20 Q. That's Advanced --
- 21 A. Advanced Fuel something.
- 22 Q. Okay. All right.
- A. We walked around that building, had a real faint odor,
- 24 almost nothing at that point. Marshall City called us and I told
- 25 them that we were walking around that building. He said he was

- 1 heading back in, you know, heading back to our location and I told
- 2 him, you know, we were going to try to figure out where things
- 3 were. We left that location, went back up to Oliver Drive to
- 4 Bostik and now the smell was gone from Bostik. So we turned
- 5 around and came back to the corner of Oliver and Old 27. It was
- 6 real heavy at that point so we pulled in there and that was the
- 7 McElroy Metal something or another, that plant right on the
- 8 corner. And that's where we met up with Marshall City and at that
- 9 point --
- 10 Q. And who's the -- who is Marshall City?
- 11 A. That guy was John Travis.
- 12 Q. Oh, okay.
- 13 A. He was in 1231 at that point.
- MR. JOHNSON: So I -- you know, Marshall City called and
- 15 said they were going to head to your location and then you drove
- 16 to where before he met you?
- MR. BONNEY: McElroy Metal right on the corner of Old 27
- 18 and Oliver.
- MR. JOHNSON: McElroy Metals.
- MR. BONNEY: Yeah. I believe that's the name of the
- 21 company.
- 22 BY MR. NICHOLSON:
- Q. So he met you at McElroy Metals. Okay.
- 24 A. Yeah. The smell was real heavy there.
- 25 Q. Yep.

- 1 A. I had him get his gas detector out so we walked around
- 2 the area. It got less towards the back of the -- their building
- 3 so going south on 27 the back corner of their building it got less
- 4 but it was still, you know, you could still smell it. He even
- 5 stuck his sniffer down in the storm drains to see if it was coming
- 6 out of the drains or something like that.
- 7 Q. Did he get a hit?
- 8 A. Nope. Got nothing any time. We didn't pick up anything
- 9 at all as far as the flammables go.
- 10 Q. Oh, you're just checking all the oil stuff?
- 11 A. Yes.
- 12 BY MR. JOHNSON:
- Q. What type of detector? I'm not -- not that you know it
- 14 but just a gas check or --
- 15 A. Yeah, just a gas detector to see if there's any
- 16 flammables in the area. So it would pick up the natural gas if
- 17 that was there. If gasoline was there it would pick those up.
- 18 Q. Okay. So as a group you checked McElroy Metals site and
- 19 on the backside where did it get weaker?
- 20 A. Towards the back of that, to the south end of their
- 21 building. It was still, you know, you still had a smell to it but
- 22 it wasn't strong on the backside. So we headed back towards
- 23 Oliver Drive, you know, we were on foot at this point. We were
- 24 walking around in front there where the smell was a little heavier
- 25 and that's when the fellow in the white pick-up truck pulled up.

- 1 MR. NICHOLSON: So you're back at Oliver and --
- 2 MR. BONNEY: Old 27.
- 3 MR. NICHOLSON: -- 27. You're at that corner?
- 4 MR. BONNEY: Yep.
- 5 BY MR. JOHNSON:
- 6 Q. Walking?
- 7 A. Yep.
- 8 Q. From there you walked to --
- 9 A. We had been walking around the building on foot.
- 10 BY MR. NICHOLSON:
- 11 Q. Which way are you facing? Where are you headed? On 27
- 12 or towards Division?
- 13 A. We were heading back from the south side of the building
- 14 so we were heading back towards Oliver Drive.
- 15 Q. Okay.
- 16 A. And we got back out towards the road. David started
- 17 going east on the front of the building. I stopped to talk to
- 18 John for a minute and then this fellow in the white pick-up truck
- 19 pulled up.
- 20 Q. So he was traveling down Oliver?
- 21 A. He was traveling -- he came across Division or across
- 22 Old 27 from Division and --
- 23 Q. So he had been down at Division --
- 24 A. Yeah. And he saw our truck sitting there --
- MR. JOHNSON: Okay. So it was --

- 1 MR. BONNEY: -- so he decided to stop.
- 2 MR. JOHNSON: -- Steve? Steve. Did you say Steve was
- 3 the guy from Marshall City?
- 4 MR. BONNEY: John Travis.
- 5 MR. NICHOLSON: No, John Travis.
- 6 MR. JOHNSON: Sorry.
- 7 MR. BONNEY: That's all right.
- 8 BY MR. NICHOLSON:
- 9 Q. But you had just been down at Division and you didn't
- 10 see a white truck down there before?
- 11 A. No.
- 12 Q. Okay.
- 13 A. But this has been probably 15, 20 minutes since we were
- 14 down Division because when we now, you know, start going around
- 15 the area up around Old 27 where the smell was heavier at that
- 16 point --
- 17 O. So did he cross 27 and came to the Oliver side?
- 18 A. Yep. Saw our trucks so he pulled in there to talk to
- 19 us. He had a white truck --
- Q. White pick-up truck? I want you to be as specific as
- 21 possible.
- 22 A. Yeah.
- 23 Q. Okay.
- A. A white pick-up truck. I believe it had a cap on it.
- 25 It had a yellow, one of those federal signal mini light bars on

- 1 it.
- Q. What's that?
- 3 A. It's --
- 4 O. Like on the front?
- 5 A. On top of the roof.
- 6 Q. Oh, it had a light bar. So it wasn't --
- 7 A. Yeah. It was a --
- 8 Q. -- a single light it was a light bar?
- 9 A. Yeah. It had two rotators on it.
- 10 Q. Okay.
- 11 A. So -- one of the mini bars it's about that big.
- 12 Q. Okay. And was it yellow or what -- was it flashing?
- 13 A. Yeah. He had his lights on.
- BY MR. JOHNSON:
- 15 Q. So it had two?
- 16 A. Yep.
- 17 Q. Two strobes?
- 18 A. No, two rotators.
- 19 Q. Two rotators, sorry. So you think it had a topper?
- 20 A. I think it had a cap on it.
- MR. NICHOLSON: What's -- you're calling that the piece
- 22 that goes over the --
- MR. BONNEY: The bed.
- MR. NICHOLSON: -- the bed. Okay.
- 25 BY MR. JOHNSON:

- 1 O. The full like not a (indiscernible) but the full cap.
- 2 A. Yeah.
- Q. Okay.
- 4 A. I believe so. I didn't pay a whole lot of attention to
- 5 the truck.
- 6 Q. And it came from -- the truck came from --
- 7 A. From Division Drive across on to Oliver Drive. So he
- 8 was heading eastbound.
- 9 Q. From Division onto Oliver heading east?
- 10 A. Yeah.
- 11 q. Perfect.
- 12 A. He pulled up. Got out of his truck. Said that he was
- 13 also investigating an odor and he said he thought it was coming
- 14 from across the road where the little trucking company is right on
- 15 that corner of Division and Old 27 which would be the northwest
- 16 corner. And then there was some discussion about, you know, it
- 17 now smelling like natural gas.
- 18 Q. It came from --
- 19 A. -- (indiscernible) --
- 20 Q. -- (indiscernible). So you said he thought it came from
- 21 the little what?
- 22 A. There's a, like, a trucking company or something, I
- 23 don't know exactly.
- Q. That's close enough for me. Thanks.
- 25 A. Right on the northwest corner of Old 27 and Division.

- 1 O. Northwest.
- 2 BY MR. NICHOLSON:
- 3 Q. So let's just clarify here. This is just a white pick-
- 4 up not a big industrial type with the --
- 5 A. No.
- 6 Q. -- the built in tool chest. It's --
- 7 A. No.
- 8 Q. -- something you'd buy -- any of us would buy and just
- 9 put an extended shell on it or --
- 10 A. Yeah.
- 11 O. Okay.
- 12 A. It had -- I don't remember the name on the side of it.
- 13 I do remember the little orange squiggly --
- Q. Um-hum.
- 15 A. -- you know, symbol on the side there. And he had the
- 16 same kind of symbol on his shirt.
- 17 O. White shirt, blue shirt?
- 18 A. It was dark out.
- 19 Q. Okay.
- 20 A. So I'm not --
- 21 Q. Okay.
- 22 A. I would think it would be a blue shirt but I'm not 100
- 23 percent sure.
- Q. The squigglys, what color?
- 25 A. Yellow. Yellow/orange.

- 1 MR. JOHNSON: Not sure on the color, maybe blue, of the
- 2 shirt?
- MR. BONNEY: Like I said we were standing in the dark,
- 4 not close to the street lights.
- 5 MR. PIERZINA: If you had to guess would you say it
- 6 seemed like a work type uniform?
- 7 MR. BONNEY: Yeah.
- 8 MR. PIERZINA: Okay.
- 9 BY MR. NICHOLSON:
- 10 Q. How else was he dressed, then. Jeans? Boots?
- 11 A. I don't recall.
- 12 Q. You don't recall. Okay.
- MR. PIERZINA: Hard hat?
- MR. BONNEY: No.
- 15 BY MR. NICHOLSON:
- 16 Q. Does he -- did he have any equipment? Did he have
- 17 natural gas testing sniffers or --
- 18 A. He didn't have anything when he got out of the vehicle.
- 19 I don't know if he had anything on the vehicle that would be doing
- 20 sniffing or anything like that.
- 21 Q. Can you describe him? I know he's been described before
- 22 but not -- (indiscernible) --
- 23 A. About --
- Q. Glasses? No glasses?
- 25 A. -- five-eight, five-ten, short hair. I don't recall if

- 1 he had glasses on or not.
- 2 O. Short. Dark hair? Blond?
- 3 A. Either a grayish or a salt and pepper, you know, kind of
- 4 thing.
- 5 Q. Can you guess an age or --
- 6 A. If I had to guess it would be probably 50's.
- 7 O. So we've heard from --
- 8 MR. JOHNSON: So at the time when he got out of the
- 9 truck he had no equipment with him at that time?
- MR. BONNEY: Right.
- 11 BY MR. NICHOLSON:
- 12 O. Someone else has made the statement that it was an
- 13 Enbridge truck. You can't go that far? You don't --
- 14 A. I couldn't testify in court and say that it was or --
- 15 Q. Okay.
- 16 A. -- it wasn't. I wasn't really paying that close of
- 17 attention to that.
- 18 Q. Okay.
- 19 A. As he was talking I was sort of looking around trying to
- 20 see if there was any other buildings the smell could be coming
- 21 from.
- 22 Q. Did you -- who was he -- did he come and talk to you or
- 23 did he talk to one of the other two guys?
- A. He came up and he talked to me and Dave.
- 25 Q. Okay.

- 1 A. I think John was walking around with his gas detector at
- 2 that point still doing some sniffing and he walked up and away a
- 3 couple times during that.
- 4 O. What was it you guys were talking about?
- 5 A. He said that he got called out for an odor
- 6 investigation, too, but it didn't smell like natural gas.
- 7 Q. Who did he get called out by?
- 8 A. From his company. And that's when he made the statement
- 9 that it smelled more like number 8 oil than natural gas. And we
- 10 all agreed that it smelled, you know, sort of a more of a
- 11 petroleum kind of smell than natural gas.
- MR. PIERZINA: Any other small talk that you can recall?
- 13 You know?
- MR. BONNEY: Just where he felt that it was, you know,
- 15 coming from, possibly the area across at that trucking company and
- 16 that's about the point that we decided to split up again. I had
- 17 John go up Brooks Drive again so he could use his gas detector
- 18 back there. We were going to go across to that trucking company
- 19 and, you know, sort of walk around the area and see if we find,
- 20 you know, where it was coming from and --
- 21 BY MS. SANZO:
- Q. Could you describe the -- sorry.
- A. Go ahead.
- Q. Could you describe the shape of the symbol or logo that
- 25 you saw on the truck?

- 1 A. It was all squiggly swirly --
- Q. Circular, because you're making a circular motion with
- 3 your hand? That's why I want to make --
- 4 A. Yeah.
- 5 MR. JOHNSON: So you sent John back up Brooks with the
- 6 gas detector?
- 7 MR. BONNEY: Yep.
- 8 MR. JOHNSON: And then you guys --
- 9 MR. BONNEY: We went across to the trucking company and
- 10 then he was -- the fellow in the pick-up was going to go back down
- 11 Division.
- MR. JOHNSON: Okay.
- 13 BY MR. NICHOLSON:
- Q. The -- we'll go back to the symbol on the car. So you
- 15 said there was a squiggly and there's no writing?
- 16 A. There was a name there but I don't remember what it
- 17 said.
- 18 Q. One word? Two words?
- 19 A. Just one word.
- Q. One word name?
- A. Yeah.
- 22 O. No sense of what color that text would have been?
- 23 A. Either red or a darker, you know, color. It wasn't
- 24 black but, like I said, we were standing in an area that had poor
- 25 light --

- 1 0. I know.
- 2 A. -- to begin --
- Q. Yeah.
- 4 A. -- with and that's why I can't be --
- 5 Q. Sure.
- 6 A. -- 100 percent positive.
- 7 Q. But he's left his car running.
- 8 A. Yeah.
- 9 Q. So that the lights are going off so --
- 10 A. Yeah.
- 11 O. -- there's some ambient light or some light there.
- 12 A. Yeah. His -- the yellow lights on top were going. His
- 13 headlights were still on. None of the fire trucks had their
- 14 overheads on --
- 15 Q. Okay.
- 16 A. -- and we were pointed in towards the building. He
- 17 pulled up out by the road, you know, just like in the driveway out
- 18 by the road sort of parallel to the road.
- 19 Q. Okay. So he was called out to do testing is what he
- 20 told you.
- A. Yeah.
- Q. He was called out for odor complaint?
- 23 A. Yes.
- Q. To do testing? Did he say to do testing?
- 25 A. He was supposed to be looking for what -- the source of

- 1 the odor. I believe he said he was looking for natural gas
- 2 because that's when we started talking about it not smelling like
- 3 natural gas --
- 4 0. Okay.
- 5 A. -- which is what we were dispatched to also. You know,
- 6 even though the 911 tapes, you know, they said it was more of a
- 7 petroleum, oily smell --
- 8 Q. Yeah, we heard that on several of the calls. Yeah.
- 9 MR. PIERZINA: Rick do you think if we were able to
- 10 provide you, you know, symbols, you know, of the different company
- 11 trucks that you'd be able to pick, you know, I know there's a lot
- 12 of them around here but if we laid them all out, like company
- 13 logos, do you think you'd be able to pick out the one that was on
- 14 the truck?
- 15 MR. BONNEY: I've been looking at the different ones
- 16 that I've seen. I've seen the Enbridge ones.
- 17 MR. JOHNSON: There's a bunch of them, I bet, huh?
- 18 MR. BONNEY: A few of them. It does seem similar to
- 19 that but, you know, I'm probably 80 percent sure that that was the
- 20 symbol on there. But --
- 21 BY MR. NICHOLSON:
- 22 Q. Okay.
- 23 A. -- but I can't be 100 percent sure and I don't want to
- 24 say --
- 25 Q. I understand.

- 1 A. -- this is what it was.
- Q. That's perfectly all right. If I go down Division, I
- 3 haven't been down there, is it a dead end if I keep going? Does
- 4 Division go anywhere?
- 5 A. Division comes -- well, if you come down 16 Mile Road to
- 6 Division --
- 7 O. Yeah.
- 8 A. -- it's an L. You have to go east.
- 9 Q. Okay.
- 10 A. And then it turns in -- 16 Mile Road turns into Division
- 11 when it makes that sharp right -- or left-hand turn.
- 12 Q. Okay. I know what you're talking about that side.
- 13 A. So that would be --
- Q. So it does continue through. There's -- it doesn't just
- 15 terminate at the two gas --
- 16 A. No. It --
- 17 Q. Okay.
- 18 A. -- it goes -- when you -- when it turns into Division it
- 19 goes through Old 27 and into Brooks Drive and then it does
- 20 eventually dead end.
- 21 Q. Okay.
- 22 A. But it doesn't dead end until, you know, quite a ways
- 23 into it.
- Q. Okay. And what else -- what do you run into down there
- 25 once you get past some of the industrials --

- 1 A. It's all industrial.
- Q. It's all industrial down there? Okay.
- A. Yeah, that's an industrial park. That was part of our
- 4 discussion being an oily smell, you know, we were thinking it was
- 5 coming from one of the factories in the area --
- 6 Q. Okay.
- 7 A. -- you know, Fenton (ph.).
- 8 Q. That's what sent you down that way --
- 9 A. Right.
- 10 Q. -- because you knew it was industrial. Does that -- I
- 11 haven't been out there. Is that how you would get to Marshall
- 12 Pump Station, Division Drive?
- 13 MR. PIERZINA: Yes.
- MR. NICHOLSON: Okay.
- 15 BY MR. NICHOLSON:
- 16 A. Yeah, the -- your guy's pipeline is -- if you continue
- 17 down 16 Mile Road where it turns there's a driveway right there --
- 18 Q. Um-hum.
- 19 A. -- and then you go south into Fredonia.
- 20 Q. Okay.
- 21 A. And that's where that pumping station is.
- Q. Did you go down to the pumping station?
- 23 A. No. Dave said --
- Q. Did you know there was pumping station?
- 25 A. I knew there was a pumping --

- 1 O. All right.
- 2 A. -- station there. The last I knew we hadn't been back
- 3 there for training in probably -- it's probably been at least ten
- 4 years or more. And when we were there before I believe they were
- 5 pumping gasoline through that because I remember them talking
- 6 about the pigs that they put in the line to separate the different
- 7 types of fuels and stuff.
- Q. Uh-huh.
- 9 A. But we haven't been back there in many years.
- 10 Q. And it didn't occur to you that evening to go check that
- 11 out?
- 12 A. It did.
- 13 O. Okay.
- 14 A. But then Dave said that the fellow in the white pick-up
- 15 truck said that he'd been back there so --
- 16 O. Hmmm.
- 17 A. -- I almost, you know, as we were on our way back to the
- 18 station we went back that way and I almost said, well, let's turn
- 19 back down there anyway but then, you know, the guy said that he
- 20 had already been back there so --
- 21 BY MR. JOHNSON:
- 22 O. When you say back there it's --
- 23 A. Back down to that pumping station right at the corner of
- 24 Division and 16 --
- 25 Q. So he said he came from that corner or --

- 1 A. He said he'd been down -- now, I didn't hear him say
- 2 that. Dave said he heard him say that.
- Q. Okay.
- 4 A. Because there was discussion between us when we were
- 5 going back whether we should stop there or not and he said, no,
- 6 that guy said he was already down there. I said, all right.
- 7 Q. Okay.
- 8 A. So, you know, that's why we didn't turn down and go into
- 9 that area.
- 10 MR. NICHOLSON: But okay, just to clarify, he did not
- 11 say that directly to you, though. That was a conversation he had
- 12 with Dave.
- 13 MR. BONNEY: Yeah.
- MR. NICHOLSON: Okay.
- 15 BY MR. JOHNSON:
- 16 Q. Did the -- that guy in the truck have a gas detector?
- 17 Did you guys work with him at all at --
- 18 A. I didn't see a gas detector that he had and when he got
- 19 out of the truck he just got out.
- Q. Yeah, you said that I didn't know if he went back and
- 21 grabbed one to go with you guys. Did you work together at all
- 22 or --
- 23 A. No. We talked for just a brief couple minutes and he
- 24 got back in his truck and went back down Division Drive and that's
- 25 when we split up and I sent John down Oliver or, no, down Brooks

- 1 Drive and then we went across to the trucking company there.
- MR. NICHOLSON: So I'm sorry, the guy in the truck, when
- 3 he left he went back down Division Drive?
- 4 BY MR. JOHNSON:
- 5 Q. Which -- towards which direction?
- 6 A. West, towards 16 Mile.
- 7 O. Not a clue where we are here.
- 8 A. Back towards where that pumping site is.
- 9 Q. Okay.
- 10 MR. JOHNSON: I wish I was -- I didn't think -- if we
- 11 had a map to do this.
- 12 MR. PIERZINA: Ah, ask and you shall receive.
- MR. BONNEY: I was going to say I think we got a big
- 14 aerial map if you don't have a good one here.
- 15 MR. JOHNSON: I think we even talked about we would do
- 16 that. I guess we dropped the ball.
- 17 MR. PIERZINA: What.
- 18 MR. JOHNSON: I said I already -- I said maybe we should
- 19 do this but we did so we're okay.
- 20 MR. PIERZINA: (Indiscernible.)
- MS. SANZO: (Indiscernible.)
- MR. NICHOLSON: Why are we whispering?
- MR. PIERZINA: Are we recording?
- MR. NICHOLSON: It's all right.
- MR. JOHNSON: Yeah, what are you going to hear me talk,

- 1 Brian?
- 2 BY MR. JOHNSON:
- 3 Q. When he headed away from you what direction did he go?
- 4 A. He went Old 27 --
- 5 Q. Just give me a second so I can write here.
- 6 A. He went west down this way.
- 7 BY MR. NICHOLSON:
- Q. Okay. So this is what you're talking about so Division
- 9 comes down here and turns --
- 10 A. And that's 16 Mile Road.
- 11 Q. That doesn't dead end, though.
- 12 A. No. And that runs into A Drive.
- 0. Oh, okay. So where is the -- I don't even know.
- 14 Where's the Marshall Pump Station on here? You said it's at 16.
- 15 A. Right there.
- 16 Q. Oh, okay.
- 17 A. So if you come down 16 there's a driveway right here
- 18 that --
- 19 Q. Oh, okay.
- 20 A. -- comes all the way down. These are the two natural
- 21 gas stations that I was telling you about.
- 22 O. Where are the two? This and this?
- A. No, these two gray boxes here.
- Q. Oh, okay. I see. Gotcha.
- 25 A. Those are like white stone around all their stuff. And

- 1 then the other one we have an issue with is right there.
- 2 O. That's another --
- 3 A. That's Consumer's --
- 4 O. -- (indiscernible)?
- 5 MR. PIERZINA: West of 69 and --
- 6 MR. BONNEY: Yeah.
- 7 MR. PIERZINA: -- and just --
- 8 MR. BONNEY: South of town.
- 9 MR. BONNEY: Yeah.
- 10 BY MR. NICHOLSON:
- 11 Q. So you watched the guy -- you were on Oliver -- Oliver I
- 12 thought was --
- 13 A. Well, they -- this map is wrong.
- 14 Q. Oh, I see.
- 15 A. This isn't Oliver Drive here.
- 16 Q. The split is up at 27.
- 17 A. Yeah. Which is just over here. This is Walters-Dimmick
- 18 here.
- 19 Q. Okay. And here's Brook. You talked about Brooks.
- 20 A. Yeah. We went down here -- down to this area in this
- 21 cul-de-sac here, walked around a little bit trying to, you know,
- 22 get a good, you know, detection for the odor and stuff.
- 23 Q. Okay.
- A. At that point you could smell it back here but it was a
- 25 little less than it was out here.

- O. Okay. So when you all three split up you were back at
- 2 27 so --
- 3 A. Yeah.
- 4 O. -- right? Did you watch this man in the truck go away
- 5 or --
- 6 A. I didn't pay -- he went back down this way and I didn't
- 7 pay attention --
- 8 Q. And you went which way? Which way --
- 9 A. We went here.
- 10 O. So you followed him for a short while?
- 11 A. He went -- he left before we did. We had to walk back
- 12 over to where our truck was.
- 13 Q. Oh, okay.
- 14 A. We went over here. We parked behind this building back
- 15 in this area. This is the Buckeye Pumping Station for the --
- 16 O. Okay.
- 17 A. -- gasoline. It's all fenced in. I walked the whole
- 18 perimeter of that. There was a little bit of odor there --
- 19 Q. So you had to walk to your car, I'm sorry. I want to
- 20 just put (indiscernible) -- you walked to you car, he's already
- 21 headed down this way, right?
- 22 A. Right.
- 23 Q. You get in your car, you come back down 27, take a --
- A. No, we were right straight across Old 27 --
- Q. So you were also --

- 1 A. -- on this corner.
- 2 O. -- Oliver.
- 3 A. We were on Oliver, yeah.
- 4 Q. Okay. So you cross 27, get in your car and you came
- 5 back this way.
- 6 A. We were already across 27.
- 7 Q. Okay.
- 8 A. This company is, like, directly across from this
- 9 printing company right here.
- 10 Q. So where did -- where -- you just had to cross one
- 11 street?
- 12 A. Yeah. We got back in our truck, turned around in the
- 13 parking lot, came back out and crossed --
- 14 Q. Oliver --
- 15 A. -- over 27 --
- 16 Q. How long did that take you? Three minutes?
- 17 A. Yeah. Two, three minutes.
- 18 Q. Okay.
- 19 A. So by the time we got in our truck and turned around and
- 20 came back he was gone.
- Q. You did not see headlights?
- A. Taillights?
- Q. Or taillights, sorry.
- 24 A. No.
- 25 Q. Okay.

- 1 A. Because that's when we talked to John and I told him to
- 2 go down Brooks Drive to check down here with his gas detector.
- 3 Q. You -- okay that's where John went.
- 4 A. Yup.
- 5 Q. And did he leave before you?
- 6 A. He left about the same time we did.
- 7 Q. Okay.
- 8 A. And then I told him were going over here.
- 9 Q. So you saw his taillights as he went down to Brooks
- 10 Drive.
- 11 A. Yeah.
- 12 Q. Okay. But you saw nothing beyond his --
- 13 A. Right.
- 0. It seems odd that you wouldn't be able to see -- I guess
- 15 you just weren't looking because it looks --
- 16 A. Yeah.
- 17 Q. -- fairly level, right. You'd think you could see the
- 18 guy if he was --
- 19 UNIDENTIFIED SPEAKER: (Indiscernible.)
- 20 MR. JOHNSON: Well, I'll let Rick speak for himself.
- MR. PIERZINA: It's not that easy.
- MR. NICHOLSON: Okay.
- BY MR. NICHOLSON:
- 24 A. Yeah. It's not. I think it's a little hilly there
- 25 not --

- 1 0. Okay.
- 2 A. -- too terribly much but --
- Q. Okay.
- 4 A. And like I said, I wasn't looking for him either --
- Q. Okay.
- 6 A. -- and, you know. We walked around here, didn't smell
- 7 anything. John walked around in this area with his detector. He
- 8 came back and met us here in the parking lot because we were still
- 9 walking around trying -- that's after I had already got done
- 10 walking around the Buckeye Terminal's pumping station. There was
- 11 a semi parked here. We walked around that seeing if there was
- 12 anything coming from that. John pulled back up. He got out with
- 13 his gas detector again, told me what he found on Brooks Drive,
- 14 that he hadn't registered any flammables at any point, you know,
- 15 during the time he was running his detector which was probably
- 16 about 20 minutes.
- 0. So -- but from the time you got here it's been about 20
- 18 minutes?
- 19 A. No, from the time --
- Q. (Indiscernible.)
- 21 A. -- he pulled up at the McElroy Metal --
- 22 O. Um-hum.
- 23 A. -- and he got out with his gas detector --
- 24 Q. Okay.
- 25 A. From that time until we met back over here it was about

- 1 20 minutes.
- Q. Okay. That it? I know it was --
- A. Approximately.
- 4 BY MR. JOHNSON:
- 5 Q. Did -- I -- not that you speak for him but the other --
- 6 the guy from Marshall City --
- 7 A. John?
- 8 Q. -- John. Was he with you at all when the white truck
- 9 was there?
- 10 A. Yes.
- 11 O. Okay.
- 12 A. Yup.
- 13 Q. And you maybe said that I just wasn't hearing
- 14 (indiscernible) --
- MR. NICHOLSON: Did he speak to the guy in the truck or
- 16 not?
- MR. BONNEY: I don't recall. And I know he walked away
- 18 from us a couple times, you know, while --
- 19 BY MR. JOHNSON:
- 20 Q. John, or --
- 21 A. Yeah, John Travis.
- 22 Q. With his -- so he walked up with his gas detector.
- A. Yeah.
- 24 BY MR. PIERZINA:
- Q. But it sounds like he -- I know you said that he was

- 1 away from you guys checking with his gas detector when the fellow
- 2 in the white truck first pulls up, right?
- 3 A. Yep. And he went back up to see what was going on.
- 4 Q. Okay. And then checked some more and --
- 5 A. Yep.
- 6 Q. And he -- once, twice maybe --
- 7 A. Yeah. He was probably in and out of the group a couple
- 8 times.
- 9 Q. A couple times, okay.
- 10 A. And this is that Buckeye Terminals we were talking about
- 11 where the -- all the tanks full of gas are.
- 12 BY MR. NICHOLSON:
- Q. Right and I'm familiar with that, okay. Good. And
- 14 there's the -- another (indiscernible) facility.
- 15 A. Um-hum.
- 16 Q. Okay. So you were there, you said it was 20 minutes --
- 17 A. From the time --
- 18 Q. -- since you did --
- 19 A. Yeah.
- 20 Q. -- since you were there and then what? Did you leave
- 21 or --
- 22 A. Well, at that point is when we, you know, we talked
- 23 about we weren't finding any flammables, we were unable to
- 24 pinpoint the source, you know, because one minute we'd have real
- 25 strong smell and we'd come back to the same spot and it would be

- 1 gone.
- Q. Yeah.
- 3 A. And we decided we -- since we didn't have any flammables
- 4 we thought it was coming from one of the industrial buildings out
- 5 there we just didn't know which one.
- 6 Q. Um-hum.
- 7 A. That we would go ahead and clear until we got a better,
- 8 you know, location on what it was.
- 9 Q. Now clear meaning return to your --
- 10 A. Return to station.
- 11 Q. -- your station. So in that time you were here
- 12 discussing you never say any -- you never noticed traffic, any
- 13 other cars coming up?
- 14 A. No.
- 15 Q. Okay.
- 16 A. I didn't. There may have been cars go up through there
- 17 I just didn't pay attention. I know there was cars up and down
- 18 27.
- 19 Q. Sure. That's a main thoroughfare. Is Division very --
- 20 A. No.
- 21 Q. -- it shouldn't be busy at all right, at that time of
- 22 night?
- 23 A. No.
- Q. Is this a home here?
- 25 A. Yep.

- 1 Q. So there's a little group of homes there?
- 2 A. Yeah, I think --
- 3 Q. Are there any homes over here?
- 4 A. I don't think so. I think there's one more, yeah,
- 5 there's another one up here and there's one right there. So
- 6 there's a few homes down Division Drive.
- 7 MR. PIERZINA: Do you know if Fredonia was on at all
- 8 responding to any odor complaints?
- 9 MR. BONNEY: I do not know. They weren't out at this
- 10 time that we were --
- 11 MR. PIERZINA: Okay.
- 12 MR. BONNEY: -- and then when I go home I turn mine on
- 13 private so unless my tone goes off I don't hear anything. That
- 14 way I can sleep.
- MR. PIERZINA: Okay.
- 16 BY MR. NICHOLSON:
- Q. So you don't know how the complaint came in, right?
- 18 A. Right.
- 19 Q. You don't know where it came from other than it was
- 20 assigned to -- well, it came in near the airport. Because it was
- 21 assigned to the Marshall --
- 22 A. Marshall City first. I -- and I heard that on the 800
- 23 side.
- 24 Q. Okay.
- 25 A. And when they went out there, you know, that's when they

- 1 said that it's coming from Marshall Township.
- 2 Q. Okay. And --
- 3 A. And he was --
- 4 O. -- where was the division line -- is it --
- 5 A. -- the --
- 6 Q. -- Division Road's you division line, right?
- 7 A. Right.
- 8 Q. Okay. So if this home had called it in it would have
- 9 gone -- well, it would have gone to Marshall City.
- 10 A. No, that would have gone to us.
- 0. Oh, that's you. Okay.
- 12 A. Yeah, Marshall City is across the street here. They're
- 13 over in here. I think they take all of this, actually. They chop
- 14 a lot of the township.
- 15 Q. Okay. It's not a nice --
- 16 A. Yeah. So it's a little choppy around through here.
- 17 This corner is ours back into here somewhere and then it drops
- 18 back into Marshall City again.
- 19 Q. Okay.
- 20 MR. JOHNSON: Is Marshall City volunteer also or --
- 21 MR. BONNEY: Volunteer and full-time. I think they've
- 22 got two or three guys on the station all the time. That's why I
- 23 called them for wind direction so --
- MR. JOHNSON: Uh-huh.
- 25 BY MR. NICHOLSON:

- 1 O. So it sounds like Dave Austin did the majority of the
- 2 interface with the man in the truck.
- 3 A. Yes.
- 4 0. Okay.
- 5 BY MR. PIERZINA:
- 6 Q. And you had mentioned earlier that you said he was
- 7 responding to a gas odor from his -- report from his company.
- 8 A. Yes.
- 9 Q. Okay. Okay. And also you mentioned the training that
- 10 you had, you know, ten or more years ago at the pumping station,
- 11 was that the company contacts the fire department for training or
- 12 do you know --
- 13 A. It was --
- Q. -- why that was?
- 15 A. It was set up with Fredonia Township because that's
- 16 their area.
- 17 Q. Okay.
- 18 A. This is the division between us and Fredonia.
- 19 O. Right.
- 20 A. So that was actually in Fredonia's area and they invited
- 21 us down.
- 22 O. Oh, okay. So it was a --
- 23 A. Because it was right on the line.
- 24 Q. Right so --
- 25 A. But like I said, that was probably ten-plus years ago

- 1 that we went out there.
- BY MR. NICHOLSON:
- 3 Q. So Fredonia still has responsibilities for this?
- 4 A. Yes.
- 5 Q. Okay.
- 6 A. Yeah, anything south of this road this gas -- natural
- 7 gas pipeline station there, the Michigan --
- Q. Um-hum.
- 9 A. -- Gas Utilities, that's Fredonia's.
- 10 Q. So if the man were checking on this he would have
- 11 been -- on the Marshall Pump Station he would have been called
- 12 from Fredonia Fire Department?
- 13 A. I don't know how he got his call.
- 14 O. Okay.
- 15 A. He didn't say. He just said, you know, he got a call
- 16 through his company to come out and check an odor.
- 17 O. But it -- so there are two of these stations, right? I
- 18 thought one was -- yeah, one's on one side of the road so and
- 19 they're two different companies --
- 20 A. Correct.
- 21 Q. -- so Michigan would have to call -- is this Michigan on
- 22 the south --
- A. Yeah.
- q. -- Michigan would call who, City or Township?
- 25 A. If it was that then it would be Fredonia Township.

- 1 O. That'd still be Fredonia.
- 2 A. Yeah.
- Q. Okay.
- 4 A. This one would be Marshall Township.
- 5 MR. JOHNSON: And that's -- we talked about this this --
- 6 MR. NICHOLSON: Okay.
- 7 BY MR. JOHNSON:
- 8 Q. -- morning a little bit. That's kind of a -- must be a
- 9 little confusing for the folks up in the 911 center how it's --
- 10 right in that neck of the woods.
- 11 A. Yeah.
- 12 Q. So they get a call and do they -- is it common to send a
- 13 few of you guys out or --
- 14 A. Well, initially they got a call at the airport so that
- 15 was over here.
- Q. Um-hum. Yeah, actually that's about the only thing I
- 17 remember. That and the PLM Shop.
- 18 A. Yeah. So the airport's Marshall City so they sent them.
- 19 Marshall City came out, got an odor there but as they drove south
- 20 it got stronger and he thought -- and the facility he was talking
- 21 about was the Buckeye pumping station --
- 22 O. Okay.
- 23 A. -- here that he thought was natural gas. So that's why
- 24 he called us out. When I got the call and he said natural gas
- 25 pumping station I automatically thought these here so that's where

- 1 we went first.
- 2 MR. PIERZINA: Okay. And did --
- 3 MR. JOHNSON: Did he stay in sight until you got there?
- 4 MR. BONNEY: No. He left. That was one of the calls
- 5 that I made to him. Are you still -- are you standing by or have
- 6 you cleared. He said no he had cleared.
- 7 MR. JOHNSON: And I think you said that earlier so I
- 8 apologize if I asked it again.
- 9 BY MR. PIERZINA:
- 10 Q. And as far as you know, like, neither you or John Travis
- 11 or nobody kind of reached out to Fredonia Township to check that
- 12 south area --
- 13 A. No.
- Q. -- but you guys looked around --
- 15 A. Right.
- 16 Q. -- as much as you did, I guess.
- 17 A. Right. We checked out a little bit. We felt that the
- 18 odor was coming from the industrial park area because it was
- 19 stronger here than it was down here.
- 20 Q. Okay. The Adams Drive and Pratt Drive some of the --
- A. Yeah.
- 22 Q. -- the ones that you mentioned as long as we got a map
- 23 in front of us.
- MR. JOHNSON: This is helpful. Thanks, Rick.
- 25 BY MR. PIERZINA:

- 1 A. This map's cutting of just before Old 27.
- 2 O. Okay. So --
- A. If this map continued across, Adams Drive runs across
- 4 here off of Oliver going north. Pratt Drive goes back and around
- 5 behind and connects with that Wooley Drive.
- 6 Q. Okay.
- 7 MR. JOHNSON: (Indiscernible.)
- 8 MR. BONNEY: And they're both --
- 9 MR. JOHNSON: (Indiscernible.)
- 10 BY MR. PIERZINA:
- 11 O. They're both east of Old 27?
- 12 A. Yes.
- 13 O. Okay.
- 14 BY MR. JOHNSON:
- 15 Q. And we -- and just -- the smell was over there or you
- 16 just were just looking anywhere.
- 17 A. The smell was over in that area.
- 18 Q. Also?
- 19 A. Yeah.
- Q. Hmmm.
- 21 A. That's why were concentrating over there more. It was
- 22 right in that area of Old 27 and Division. At times, like I said,
- 23 it -- at the Bostik Corporation which is two companies in on
- 24 Oliver on the south side of the road it was real heavy there.
- 25 When we first came in there and then when we came back to it, it

- 1 was almost gone, you know, there was hardly any odor there at all
- 2 anymore.
- 3 Q. That's -- you know, it, you know, if it was the spill it
- 4 just seems weird that that's where the smell would be. That's --
- 5 I, you know, that really helped me. I don't understand it in the
- 6 least.
- 7 A. Me too.
- 8 MR. NICHOLSON: Well, let's look at that real quick
- 9 because the break was -- the break's somewhere in here right? The
- 10 break's right there.
- 11 MR. JOHNSON: I don't know where the break is.
- MR. NICHOLSON: I think the break's approximately there.
- 13 MR. JOHNSON: Is it?
- MR. PIERZINA: I think you're right, Matt, because the
- 15 oil kind of migrated --
- 16 MR. NICHOLSON: Didn't it go kind of through the woods
- 17 there --
- 18 MR. PIERZINA: Yeah. And back through the creek.
- 19 MR. JOHNSON: Oh, then it does -- then --
- 20 (indiscernible).
- 21 MR. NICHOLSON: So if the break is there --
- MR. JOHNSON: I'm looking at the --
- MR. NICHOLSON: You were --
- 24 MR. JOHNSON: -- yellow dot over here.
- MR. BONNEY: Well, we were here -- twice.

- 1 MR. NICHOLSON: You were --
- 2 MR. BONNEY: -- twice.
- 3 MR. NICHOLSON: Yeah.
- 4 MR. JOHNSON: And?
- 5 MR. BONNEY: It was -- there was odor there but it was
- 6 less than what it was out at Old 27.
- 7 MR. NICHOLSON: Which is there.
- 8 MR. BONNEY: Yeah. And like I said --
- 9 MR. NICHOLSON: You were all around it. You --
- 10 MR. JOHNSON: What's that one facility there, Joyce?
- 11 MR. BONNEY: Walters-Dimmick.
- MR. JOHNSON: No, the one --
- 13 MR. PIERZINA: Down on Brooks Drive.
- MR. JOHNSON: Oh, down on Brooks Drive, yeah.
- MR. BONNEY: What is --
- 16 MR. PIERZINA: Is that a residence or is --
- MR. BONNEY: No, that's two companies down there and I
- 18 don't recall what the name of either one of them are. We went
- 19 into the cul-de-sac, pulled around, got out and actually walked
- 20 around outside.
- 21 MR. NICHOLSON: I'm surprised that's --
- 22 MR. BONNEY: And then we pulled around to Walters-
- 23 Dimmick. We went all the way to the back of the facility, you
- 24 know, this back corner here and it was less there than it was out
- 25 here.

- 1 MR. JOHNSON: I just -- I want to --
- 2 MR. NICHOLSON: It was -- (indiscernible) it was less --
- 3 MR. JOHNSON: -- put words in your mouth.
- 4 MR. NICHOLSON: -- there.
- 5 MR. BONNEY: Right.
- 6 MR. NICHOLSON: Which is actually closer --
- 7 MR. BONNEY: Closer.
- 8 BY MR. JOHNSON:
- 9 Q. So twice you were down Brooks drive but the odor was
- 10 stronger east of Old 27 than there?
- 11 A. Yep. And I was down -- we were down -- me and Dave were
- 12 down Brooks Drive once and Marshall City, John Travis was down
- 13 Brooks Drive once.
- Q. You were down once. They were down once.
- 15 A. Right.
- 16 MR. NICHOLSON: Where's the creek? Oh, here --
- 17 MR. BONNEY: Right here.
- 18 MR. NICHOLSON: That's it, yeah. Okay.
- 19 MR. BONNEY: It goes into the woods. Yeah, too bad they
- 20 didn't make that map this way just a tad longer.
- 21 MR. JOHNSON: It still, from my standpoint, it pulls it
- 22 together. I --
- MR. NICHOLSON: Yeah, because I think we all know where
- 24 27 -- Old 27 (indiscernible).
- MR. BONNEY: Um-hum. The thing that was real confusing

- 1 for us was --
- 2 BY MR. JOHNSON:
- 3 Q. Now, did John Travis, that was down Brooks Drive once,
- 4 him, too?
- 5 A. Yep.
- 6 Q. And he had the gas detector.
- 7 A. Yep.
- 8 MR. NICHOLSON: You must have been called back out,
- 9 though. That wasn't your --
- MR. BONNEY: No, we were never called back out. Well, I
- 11 left at nine o'clock in the morning to head up north and, you
- 12 know, from that time until nine o'clock in the morning we hadn't
- 13 got called out again. Now, I do know that listening to the 911
- 14 tapes the cleaning lady for here called at 11:30 so that would
- 15 have been a half hour after we cleared.
- 16 MR. PIERZINA: That's Walters-Dimmick?
- MR. BONNEY: Yep.
- 18 MR. PIERZINA: Cleaning lady. That was 11:30.
- 19 BY MR. JOHNSON:
- 20 Q. So in general, Marshall Township was not called again.
- 21 A. No. At least not before --
- 22 O. Did they --
- 23 A. -- nine o'clock, you know, when I left town.
- Q. Oh, yeah. I don't want to make an assumption.
- 25 A. Because I didn't take my radios with me or anything. I

- 1 was going to Traverse City. So as of nine o'clock when I drove
- 2 out of my driveway we hadn't been called.
- 3 MR. PIERZINA: Given that, you know, that the cleaning
- 4 lady called in the odor complaint at 11:30 do you know who was
- 5 dispatched to --
- 6 MR. BONNEY: Nobody was.
- 7 MR. PIERZINA: Nobody was.
- 8 MR. NICHOLSON: Why?
- 9 MR. BONNEY: I don't know.
- 10 BY MR. JOHNSON:
- 11 Q. So Monday morning you left at 9:00 a.m.
- 12 A. Yeah, I left town at 9:00 a.m. Monday morning.
- 13 Q. Yeah, and I just -- I want to be really careful. You
- 14 know, you said we were not called again. I want to make sure
- 15 that --
- 16 A. Right.
- 17 O. -- if you got called in at 9:30 you were out of town
- 18 so --
- 19 A. Right, and I didn't know it.
- 20 Q. Yeah. (Indiscernible.)
- 21 A. Okay.
- 22 MR. NICHOLSON: Yeah, so it's not that you weren't
- 23 called back out it's just you weren't part of it.
- 24 MR. BONNEY: Right. After --
- 25 MR. NICHOLSON: And you wouldn't have known about it.

- 1 MR. BONNEY: After nine o'clock I didn't know.
- 2 MR. JOHNSON: (Indiscernible.) And --
- 3 MR. PIERZINA: Eleven-thirty --
- 4 MR. JOHNSON: -- you --
- 5 MR. PIERZINA: Oh, I'm sorry.
- 6 BY MR. JOHNSON:
- 7 Q. -- you -- from listening to the tapes, and you said this
- 8 Brian, I just want to repeat -- you listened to the tapes after
- 9 the fact. You --
- 10 A. I just listened to the tapes on --
- 12 A. -- on --
- 13 Q. -- but you didn't hear --
- 14 A. Friday.
- 15 Q. Yeah, so you didn't hear any -- I mean you got your
- 16 radios on and stuff --
- 17 A. They -- they never called us and --
- 18 Q. No one else was called out. Nothing like overlap in the
- 19 radios?
- 20 A. No.
- 21 Q. Is that a kind of decent way to say that overlap on the
- 22 radio?
- A. Well, they're on the same channel we are.
- 24 Q. Okay.
- 25 A. So we would have heard them if they went out. Now, I

- 1 wouldn't have heard it after I got back home because I turn my
- 2 pager to private --
- 3 O. Um-hum.
- 4 A. -- at night. So unless my tone goes off I don't hear
- 5 the general radio traffic that's going across there because it
- 6 gets busy at night and I wouldn't get any sleep. So personally I
- 7 just turn mine to private so when my tone goes off I get woke up.
- 8 If my tone doesn't go off I don't get woke up.
- 9 Q. Does anyone from Marshall Township need to leave theirs
- 10 on?
- 11 A. No, because the only time we go anywhere is when we get
- 12 toned.
- 0. Okay. I didn't how that worked. My neighbor was a
- 14 (indiscernible) on call or is and he always was wearing it and so
- 15 I just didn't know what --
- 16 A. Yeah, when they drop our tone that's when our response
- 17 starts.
- 18 Q. Um-hum. Okay.
- 19 A. Now, sometimes if you have it open, like, during the day
- 20 I leave mine open and I can listen to it and if somebody else
- 21 calls for us, another department, you can hear that start getting
- 22 going.
- Q. Before you even get toned.
- A. Right. But, you know, at night I just turn that off
- 25 that way I don't have to listen to everybody in the county.

- 1 BY MR. NICHOLSON:
- Q. So you guys met up here and then that was it, you
- 3 cleared.
- 4 A. Yeah.
- 5 Q. You and Dave went back to your place.
- 6 A. Yeah we went this way back to our place.
- 7 Q. Okay. You went down Division to 16 --
- 8 A. And up to 15 back to here.
- 9 Q. Any observations as to smell as you went down.
- 10 A. No.
- 11 Q. Did you have your windows open or --
- 12 A. Yep. We left our windows open. We still had odor down
- 13 there. It wasn't any stronger here than it was before.
- 14 Q. Okay.
- 15 A. But there was definitely an odor.
- 16 Q. Okay. Never saw the truck again? Never saw --
- 17 A. No.
- 18 Q. -- the car on that road.
- 19 BY MR. PIERZINA:
- 20 Q. Just to -- I just want to make sure the cleaning lady
- 21 was at this building.
- 22 A. This building.
- Q. Walters-Dimmick, right?
- 24 A. Yep.
- Q. Is it D-e-m -- well, they spell that somewhere.

- 1 A. Yeah, it's in here somewhere.
- 2 Q. Okay.
- 3 MR. JOHNSON: D-i-m-m-i-c-k.
- 4 MR. PIERZINA: Okay.
- 5 MR. NICHOLSON: Oh, it's Dimmick.
- 6 BY MR. PIERZINA:
- 7 Q. And so she called in a odor complaint at 11:30 p.m.
- 8 A. Yep.
- 9 Q. And that went into --
- 10 A. To central dispatch.
- 11 O. To -- so she called 911.
- 12 A. Yeah.
- 13 Q. Okay.
- 14 A. And they told her the fire department's been out and
- 15 checked it and they gave the all clear or whatever. I don't
- 16 remember the --
- 17 BY MR. NICHOLSON:
- 18 Q. They realized that you had cleared?
- 19 A. Yes.
- Q. Before they got the call.
- 21 A. Right.
- 22 Q. Okay.
- 23 A. And then they didn't -- I don't know what their protocol
- 24 for that is.
- MR. JOHNSON: Actually, you know, (indiscernible) we

- 1 shouldn't (indiscernible) make assumptions.
- 2 BY MR. NICHOLSON:
- 3 Q. Yeah, we've got some tapes we still need to hear it.
- 4 A. We never heard that there was multiple calls, you know,
- 5 from different areas. I don't know what -- where each of these
- 6 calls were. I know one of the calls was from down here somewhere
- 7 because they said they lived right down by one of these pumping
- 8 stations so it must have been one of these houses in here. She
- 9 said there was a heavy smell.
- 10 Q. Yeah. Okay. What time was that? Do you --
- 11 A. I don't remember.
- 12 Q. But it's not the call you responded to.
- 13 A. No.
- 14 Q. Your were response was from some guy who --
- 15 A. Yeah.
- 16 Q. -- a passerby.
- 17 BY MR. PIERZINA:
- 18 Q. That's down at the airport.
- 19 A. The airport.
- Q. Right?
- 21 A. Yep.
- 22 Q. And did you say -- is this Marshall City jurisdiction
- 23 or --
- 24 A. Yeah.
- Q. -- Fredonia? Where is --

- 1 A. It's Marshall City's.
- 2 Q. -- where is the line between Fredonia and Marshall City
- 3 going this way, if you know?
- 4 A. I'm not sure.
- 5 Q. All right.
- 6 A. I believe all of this is Marshall City's.
- 7 Q. Okay. So Marshall City has Brooks Drive and the
- 8 Walters-Dimmick --
- 9 A. Yeah.
- 10 O. -- and stuff and west of that somewhere starts Fredonia.
- 11 A. Right.
- 12 BY MR. JOHNSON:
- Q. Did you -- let's see how I want to word this -- I don't
- 14 want to lead you. Do you have any interaction or even -- I know
- 15 you talked about ten years ago you got invited to an Enbridge --
- 16 do you --
- 17 A. I don't even recall what company it was.
- 18 Q. You -- or -- oh, (indiscernible) but it was at a
- 19 company?
- 20 A. Yeah, it was here so I --
- 21 Q. Okay. So you got called out there and you didn't know
- 22 who it was you just got to do --
- 23 A. Well, I probably did at the time.
- Q. But you just -- it was an exercise.
- 25 A. Right.

- 1 O. And that's perfectly fine.
- 2 BY MR. PIERZINA:
- 3 Q. You know what? I might be able to help with this. Do
- 4 you remember a company called Lakehead?
- 5 A. Um-hum.
- 6 Q. Lakehead Pipe Line?
- 7 A. Yeah.
- 8 Q. Okay.
- 9 MR. JOHNSON: That's our old name.
- 10 BY MR. PIERZINA:
- 11 A. Maybe it was them. Yeah.
- Q. Yeah, they're --
- MR. JOHNSON: Nothing changed except the name. And
- 14 these guys are trying to change it too, some of their coworkers
- 15 but you -- is there any extra -- any other type of -- boy -- does
- 16 Enbridge invite you to anything? Other than training exercise did
- 17 you have any interaction with Enbridge for training or
- 18 (indiscernible) --
- 19 A. No, I was training officer for years and I don't
- 20 remember Enbridge inviting us out for anything. I know that once
- 21 a year in the spring we get invited out for a gas line safety for
- 22 the natural gas.
- MR. NICHOLSON: By who? (Indiscernible) it's one of the
- 24 utilities?
- MR. BONNEY: Yeah --

- 1 MR. NICHOLSON: Okay.
- 2 MR. BONNEY: -- one of the utilities does.
- 3 MR. JOHNSON: Do you attend those or have you or --
- 4 MR. BONNEY: I have in the past. I haven't, probably,
- 5 in the last couple years. They always seem to land on our
- 6 training night. That, you know, makes it difficult for --
- 7 BY MR. PIERZINA:
- Q. I used to do some of that stuff and that was always the
- 9 issue, you know, we and sometimes it works out because that can be
- 10 you training --
- 11 A. Right.
- 12 O. You know.
- 13 A. It depends on what you got planned.
- Q. Right. Do you recall in -- you know, when you get those
- 15 invitations or -- is it always one company that invites you out or
- 16 do -- is it ever like a group invitation from a number of pipeline
- 17 companies?
- 18 A. I don't recall. It may be a group or may be just one.
- 19 Q. Okay.
- 20 A. And they're doing more general, you know, pipeline, you
- 21 know, safety kind of stuff, you know, what to do if the natural
- 22 gas pipeline ruptures, who to call.
- 23 Q. Um-hum.
- 24 A. You know, evacuation distances and all that kind of
- 25 stuff.

- 1 Q. Do you remember the last meeting like that that you may
- 2 have attended?
- 3 A. It was probably been three or four years ago.
- 4 O. Okay. And that would have been --
- 5 MR. JOHNSON: So what -- go ahead, Brian.
- 6 MR. PIERZINA: No, go ahead.
- 7 BY MR. JOHNSON:
- 8 Q. I just -- so you just said and I don't want to word --
- 9 put words in your mouth. You kind of put down that you do know
- 10 that you get invited each spring to a what kind of a --
- 11 A. Natural gas pipeline safety.
- 12 Q. Safety what? Dinner --
- 13 A. Yeah. It's a dinner.
- Q. Dinner? I always joke about that night.
- 15 A. They do a dinner and then a little --
- 16 O. We call it rubber chicken dinners.
- 17 A. -- little training thing afterwards.

- Q. Nice. Another question about that driver. He didn't

- 1 have a radio? Was he -- did he have one of those radios strapped

- 3 A. He didn't have it on him, no.
- 4 O. Okay. You heard anything in the truck? Chatter? You

- 6 A. (No audible response.)
- 7 MR. NICHOLSON: Okay. Any other questions. We got

- 21 MR. NICHOLSON: Who is this? Who is talking?
- MR. JOHNSON: Jay Johnson.
- BY MR. JOHNSON:
- Q. The Marshall Township Incident Chief is --
- 25 A. Yes.

- 1 O. I'm just kind of curious how that's created. Is that
- 2 like from the one call or --
- 3 A. Yep, that would be the call that we got --
- 4 O. Is it coming on the fax or --
- 5 A. No, we fill that out here.
- 6 Q. So okay. So it's on every call.
- 7 A. Every call we have.
- 8 Q. Yeah, and I was curious now then on this one, now, do
- 9 you -- is it normal to close one out or I'm not sure -- because I
- 10 got this in conjunction with it.
- 11 A. Yeah. That was Steve's -- I think that's what he wrote
- 12 in after, you know, because they wanted a statement from us what
- 13 happened.
- MR. NICHOLSON: Who's they?
- MR. BONNEY: Somebody made the request of the chief and
- 16 this is our chief.
- BY MR. JOHNSON:
- 18 Q. Oh, because that's -- the only thing that confuses me
- 19 here a little bit and I -- I'll ask you and if you don't know
- 20 we'll go to the chief because it's got a date on there like it was
- 21 written the same date as the -- your call out and it seemed kind
- 22 of strange to me.
- 23 A. Well, I think the date of the report which would be for
- 24 the date of this.
- Q. So that's when it was.

- 1 A. Yeah.
- Q. All right. Thank you.
- 3 A. (Indiscernible) so --
- 4 MR. JOHNSON: And I don't know if you -- any -- you have
- 5 a copy of that.
- 6 BY MR. NICHOLSON:
- 7 Q. We do have a copy but you're saying you weren't there
- 8 when that was written. He didn't consult you before he wrote
- 9 that?
- 10 A. No. He might have talked to Dave before he wrote that.
- 11 Q. Okay.
- 12 A. I was gone. I wasn't back until Thursday evening, late
- 13 in the evening.
- 0. Well, wait -- when was this written?
- MR. JOHNSON: I don't know that it says it on there.
- 16 That's what threw me the date.
- 17 MR. BONNEY: Yeah, the date is the date of the response.
- 18 BY MR. NICHOLSON:
- 19 Q. Right. So you --
- 20 A. -- (indiscernible) --
- 0. -- don't know when this was written.
- 22 A. No.
- Q. So you -- how do you know you weren't here when it was
- 24 written?
- 25 A. I'm guessing.

- 21 a statement from you?

- 23 looked at it just a minute ago but --
- 2.4 Q. Okay.
- 25 MR. NICHOLSON: Do you want to read it? In case there's
