- 3 MR. NICHOLSON: This is Matt Nicholson with the NTSB
- 4 performing interviews with John Travis regarding the Enbridge
- 5 crude leak on July 25th, 2010 in Marshall, Michigan.
- 6 John, do I have your permission to record you while we
- 7 interview you?
- 8 MR. TRAVIS: Yes, sir.
- 9 MR. NICHOLSON: Okay.
- 10 INTERVIEW OF JOHN TRAVIS
- 11 BY MR. NICHOLSON:
- 12 Q. Please state your name and contact information for us.
- 13 A. Lieutenant John Travis, Marshall City Fire Department.
- 14 I can be reached either here, which is (269) 781-3922. My cell
- 15 phone number is (269)-----
- 16 O. Okay.
- 17 A. And I can give you a card also that has my e-mail
- 18 address if that will help out any.
- 19 Q. That would be perfect. Thank you. My name is Matt
- 20 Nicholson, NTSB Investigator, matthew.nicholson@ntsb.gov.
- 21 MS. SANZO: Dana Sanzo, an investigator with NTSB,

- MR. PIERZINA: Brian Pierzina with the Pipeline

- 1 MR. JOHNSON: Jay Johnson, Enbridge Energy, cell phone
- 2 (218)----. It's jay.johnson@enbridge.com.
- 3 BY MR. NICHOLSON:
- 4 O. So the reason we're here is not so much emergency
- 5 response today but really kind of get a grip on what happened on
- 6 the 25th. We know there was a call that came in around 9:20 and
- 7 that you responded and that you met up with some other fire
- 8 responders --
- 9 A. Correct.
- 10 Q. -- that night, so if you could just kind of take us back
- 11 to that evening, start at the beginning when you got the call and
- 12 tell us kind of -- walk us through the night?
- 13 A. Well, I -- we received the call for an order of
- 14 investigation in the area of Brooks Airfield.
- 15 Q. What time was that?
- 16 A. Being -- it was roughly 9:30ish.
- 17 Q. Okay.
- 18 A. Somewhere around there. I'm not real -- I can't
- 19 remember the exact time. We had one engine out on a medical call
- 20 at that time, who was Assistant Chief Jeff Rhodes. He called me
- 21 on the radio stating that he was stuck and needed me to come down
- 22 to his location before proceeding to the odor investigation.
- 23 As I stopped there and discussed what we were going to
- 24 -- how we were going to get that truck --
- Q. Where was that? Where did he call you to?

- 1 A. He called me to Fairway Meadows Apartments, which is
- 2 about a quarter mile, half mile south -- or north of the
- 3 intersection of Division and Old 27.
- 4 MR. JOHNSON: I don't think I -- could you say that
- 5 location again, please? I'm sorry.
- 6 MR. TRAVIS: Fairway --
- 7 MR. JOHNSON: Old 27?
- 8 MR. TRAVIS: Yes. It was actually South Kalamazoo
- 9 Avenue is where he was at.
- 10 MR. JOHNSON: That's close enough. Thank you.
- 11 MR. PIERZINA: And you said he was stuck?
- MR. TRAVIS: Yeah. The fire truck -- he backed up and
- 13 went off the edge of the road.
- MR. PIERZINA: Okay.
- MR. TRAVIS: And got the back end of the fire truck
- 16 stuck.
- 17 MR. PIERZINA: And that was your chief?
- 18 MR. TRAVIS: Yes, assistant chief.
- 19 MR. PIERZINA: Assistant chief.
- MR. TRAVIS: I stayed with 51, our rescue truck at that
- 21 time. He proceeded to the call -- the original call.
- BY MR. NICHOLSON:
- Q. You're saying, I'm sorry, Jeff proceeded to the original
- 24 call?
- 25 A. Yes. He had been gone 15 minutes approximately and

- 1 called me on the radio, said he was calling the township in
- 2 because he believed it was natural gas, so we turned it over to
- 3 them at that time. He then proceeded back to my location. We got
- 4 51, our rescue truck, unstuck, got it back to the station and
- 5 about a -- I'm guessing a half hour later we received a call from
- 6 Marshall Township stating that they believed it was back in our
- 7 area. So I then proceeded to go back out to double-check --
- 8 Q. What time did you receive that call?
- 9 A. That was some time after 10:00, I believe.
- 10 Q. Okay, so I don't think that came up before. After 10:00
- 11 you got a call from --
- 12 A. Marshall Township.
- 13 Q. -- Marshall Township saying that they felt it was
- 14 your --
- 15 A. Yes, they felt it was back in our location. They had
- 16 checked the -- from what Rick Bonney had told me, he -- that they
- 17 had checked the natural gas stations out in their area and could
- 18 not locate anything, but they could smell it back in our area,
- 19 industrial area there.
- Q. Yeah, okay.
- 21 A. So I then proceeded back out to the scene with Marshall
- 22 Township, was met by Rick Bonney and the one other fire fighter
- 23 there, Steve Austin, I believe his name was.
- MR. JOHNSON: David Austin, it would be, just for --
- MR. TRAVIS: Dave, okay, yeah. As I got there I could

- 1 smell something. I didn't know what it was. It didn't smell like
- 2 natural gas to me, but it -- I've never had -- you know, later
- 3 finding out it was crude oil, I'd never had a run-in with crude
- 4 oil before, so but it was -- the way the air was, it was very
- 5 light and variable winds that night and if you stood in one spot,
- 6 you could take a step to the left and not smell it any more, which
- 7 was odd to me. But I did a -- in my eyes I did a thorough
- 8 investigation. I got our gas meter. It's a Eagle gas monitor.
- 9 BY MR. NICHOLSON:
- 10 Q. Okay, yeah.
- 11 A. Was checking air quality. I -- after talking with Rick
- 12 Bonney, we decided that we were going to check the fuel storage
- 13 tanks over there. He and Mr. Austin were going t go check those.
- Q. I'm sorry, where are you at this point?
- 15 A. Still on 27 --
- 16 Q. You want the great map here?
- 17 A. -- the fuel tanks, the storage facility --
- 18 Q. You're at the -- which storage facility is this?
- 19 A. We --
- Q. Is this the Buckeye?
- 21 A. Yes, the Buckeye terminal.
- 22 O. Okay.
- 23 A. Is what he was going to check, which is just right just
- 24 south of Division, and we were actually parked right at Industrial
- 25 at the Division and Old 27 there.

- 1 MR. PIERZINA: Uh-huh.
- MR. TRAVIS: We were parked in McElroy Metal's parking
- 3 lot --
- 4 BY MR. NICHOLSON:
- Q. Okay.
- 6 A. -- at that time.
- 7 Q. And that's where you were checking the air quality?
- 8 A. Yes.
- 9 Q. Okay.
- 10 A. After talking with him we -- he decided he was going to
- 11 go check the storage facility there, Buckeye, and I told him I'm
- 12 going to go over to Brooks Drive, which is the extent of our
- 13 coverage area. So I then proceeded over there with our engine and
- 14 the gas monitor from that engine, parked on the road and could
- 15 smell it in certain areas, just like over at McElroy Metal, but
- 16 couldn't pinpoint anything. And --
- 17 Q. You're still detecting with the Eagle? What --
- 18 A. Yeah, I'm still using the --
- 19 O. What --
- 20 A. -- Eagle --
- 21 Q. What's the Eagle? What do you detect? LELs or --
- 22 A. LELs and upper levels, carbon monoxide and, you know,
- 23 explosives, you know --
- 24 Q. Okay.
- 25 A. -- certain explosive stuff. Just -- I couldn't pick

- 1 anything up on the monitor and after meeting back up with Mr.
- 2 Bonney --
- 3 Q. Okay, I'm sorry --
- 4 A. Oh, I'm sorry.
- 5 Q. You're by yourself, right? Okay.
- 6 A. Yeah.
- 7 Q. Okay.
- 8 A. I was by myself.
- 9 Q. Okay. And where is Bonney and --
- 10 A. He was at the Buckeye terminal area.
- 11 O. He was still at the plant?
- 12 A. He was still at that area. I did a walk around of -- as
- 13 much as I could of most of the buildings out in that area.
- MR. JOHNSON: At Brooks Drive area?
- 15 MR. TRAVIS: Yes, Brooks Drive area. Could not detect
- 16 it in some areas but in, like I said, in some areas I could.
- BY MR. NICHOLSON:
- 18 Q. Oh, you're actually getting -- hit something?
- 19 A. I could -- no, I --
- 20 Q. Oh, just your --
- 21 A. -- not -- just my nose.
- 22 O. Okay.
- 23 A. Just what I was smelling. The Eagle monitor never
- 24 registered anything.
- 25 Q. Okay.

- 1 A. We then met back up with Rick Bonney --
- 2 MR. JOHNSON: Hold on just a second, I'm sorry, because
- 3 this --
- 4 MR. NICHOLSON: That's why we bring the recorder.
- 5 MR. TRAVIS: Yep.
- 6 MR. NICHOLSON: That's where I want to (indiscernible).
- 7 MR. JOHNSON: All right, so then you met with -- you met
- 8 back up with Rick?
- 9 MR. TRAVIS: I met -- yeah, met back up with Rick and -
- 10 let me back track for a second. Before we left McElroy Metal
- 11 the first time there a gentleman pulled up in a Michigan Utilities
- 12 truck and said that he was coming from a call somewhere south of
- 13 town.
- MR. JOHNSON: What -- okay. I'm going to --
- MR. TRAVIS: I'm sorry.
- 16 MR. JOHNSON: No, that's okay. It's just tough to --
- BY MR. NICHOLSON:
- 18 Q. Just -- I am -- since we're back tracking, what time are
- 19 we talking about?
- 20 A. We're still at -- I don't think it was eleven o'clock at
- 21 that time.
- 22 Q. Okay, so -- okay, before 11:00.
- MR. JOHNSON: So 10:30ish, but you -- so at about -- and
- 24 shall we -- I don't want to put -- 10:30, 11:00 or --
- 25 MR. NICHOLSON: Between 10:30, 11:00?

- 1 MR. TRAVIS: Yeah.
- 2 MR. NICHOLSON: You don't have to be exact.
- 3 MR. TRAVIS: I'd say between --
- 4 MR. JOHNSON: Ball park.
- 5 MR. TRAVIS: The thing was is I wasn't keeping track of
- 6 the time.
- 7 MR. JOHNSON: No?
- 8 MR. NICHOLSON: No, okay.
- 9 MR. TRAVIS: So it was in between 10:00 and 11:00.
- 10 MR. JOHNSON: In between 10:00 and 11:00.
- 11 MR. TRAVIS: Yeah.
- 12 MR. JOHNSON: I can -- yeah, that's perfectly fine.
- MR. TRAVIS: I didn't keep track of the times because I
- 14 was not finding anything.
- MR. JOHNSON: Okay.
- MR. TRAVIS: I mean, you know --
- MR. JOHNSON: No, that's perfectly fine.
- 18 MR. TRAVIS: -- and that I could pick up or register
- 19 anything.
- MR. JOHNSON: So in between 10:00 --
- 21 MR. NICHOLSON: But you knew it was there. It's so
- 22 frustrating because you know it's there.
- MR. TRAVIS: I knew something was there, yeah. It was
- 24 very frustrating on my part because there -- I knew there was a
- 25 problem there but I couldn't pinpoint it to say this is what we

- 1 need to do.
- 2 MR. NICHOLSON: Okay --
- 3 MR. JOHNSON: So --
- 4 MR. NICHOLSON: -- so I'm sorry, you were -- you said you
- 5 met back up with --
- 6 MR. JOHNSON: But before that --
- 7 BY MR. NICHOLSON:
- 8 Q. -- Rick.
- 9 A. Yeah. Before that --
- 10 Q. Yeah, before that --
- 11 A. At --
- 12 O. At --
- 13 A. -- when we were sitting in McElroy Metal's parking lot a
- 14 pick-up truck with the name Michigan Gas Utilities on it pulled
- 15 up.
- 16 Q. Michigan Gas --
- 17 A. Yep.
- 18 Q. And who are they?
- 19 A. They are the ones that operate the natural gas line, I
- 20 believe, out there in that area. I believe it used --
- 21 O. In what area?
- 22 A. Division -- there's a pump station in -- where they add
- 23 the scent to the --
- 24 Q. Oh, okay.
- 25 A. -- natural gas.

- 1 O. Yeah.
- 2 A. Out on Division.
- Q. Okay.
- 4 A. So he said that he had come from south of town, didn't
- 5 -- did not say where, but he could smell something and he had gone
- 6 down and checked the -- what he called the dripper that adds the
- 7 odor to the natural gas and said that that was working properly
- 8 and the natural gas -- nothing was leaking up there.
- 9 MR. JOHNSON: Okay, I'm just going to slow you down
- 10 here.
- MR. TRAVIS: Yep.
- 12 MR. JOHNSON: And I know what he's talking about there
- 13 too.
- MR. NICHOLSON: I don't.
- MR. JOHNSON: Where they add the odor in to natural gas.
- MR. NICHOLSON: Oh, that's what they call the dripper?
- 17 That's the --
- 18 MR. TRAVIS: That's what he called it.
- 19 MR. NICHOLSON: Okay. So he said he just came --
- 20 MR. JOHNSON: Yeah --
- 21 MR. NICHOLSON: -- from down south.
- MR. JOHNSON: He came from --
- MR. TRAVIS: And he had come from south of town which in
- 24 this area down here.
- 25 BY MR. NICHOLSON:

- 1 Q. But we don't know from where, okay.
- 2 A. No, I don't know. He didn't give me an address of where
- 3 he was coming from.
- 4 0. Okay.
- 5 A. But he was coming from the F Drive South area. But
- 6 he --
- 7 O. From 27?
- 8 A. Yes. He was heading north on 27.
- 9 Q. Okay.
- 10 A. And I believe he said he got just past B Drive South
- 11 near the Moonraker restaurant out there --
- 12 O. Uh-huh.
- 13 A. -- when he could smell it, and then he seen us and he
- 14 had gone down and checked that to make sure it wasn't that which
- 15 was leaking.
- 16 MR. JOHNSON: Two -- did -- two of them? I want -- I
- 17 just want to --
- 18 MR. TRAVIS: There was only one guy in the truck.
- MR. JOHNSON: No, no, no, no.
- MR. TRAVIS: Oh.
- MR. JOHNSON: You said the drippers?
- 22 MR. TRAVIS: The drippers and the, I guess the pump
- 23 that's there.
- MR. JOHNSON: No, but he had checked the drippers, so in
- 25 my mind it -- and I'm not trying to confuse you. Did he -- like

- 1 was there two locations where there were drippers or were there
- 2 maybe two drippers at one? And if you don't know that, we'll talk
- 3 to this guy.
- 4 MR. TRAVIS: I don't. I don't know.
- 5 MR. JOHNSON: Okay.
- 6 MR. TRAVIS: And I never got his name.
- 7 MR. JOHNSON: No, that's okay.
- 8 MR. TRAVIS: Because that was --
- 9 MR. JOHNSON: No, the call outs will have that log and
- 10 everything.
- 11 MR. TRAVIS: Yeah.
- MR. NICHOLSON: But --
- MR. PIERZINA: Well, in fact, do you know -- did he
- 14 happen to say why he, you know, was he call -- responding to an
- 15 odor complaint or was he in the area?
- 16 MR. TRAVIS: He didn't say. He said he was heading back
- 17 from a call south of town and that's all he gave me.
- 18 MR. PIERZINA: Okay.
- MR. TRAVIS: And he talked to Rick Bonney and I for just
- 20 a few minutes and then left.
- 21 BY MR. NICHOLSON:
- 22 Q. Okay, just a second here. So, okay, you went -- you
- 23 were down at Brook.
- A. Uh-huh.
- Q. You -- or no, we're back in time, I'm sorry.

- 1 A. Yeah. We're back in time.
- Q. When did you meet the --
- 3 A. McElroy Metal.
- 4 O. When did you meet the gentleman in the Missouri (sic)
- 5 Gas Utilities?
- 6 A. Michigan Gas.
- 7 Q. Michigan Gas Utilities truck?
- 8 A. Oh, I -- that was --
- 9 Q. That was before you ever --
- 10 A. That was before I went to Brooks Drive.
- 11 Q. Okay. So he was already there?
- 12 A. Yeah, he said he had just come from there and checked
- 13 them, and I didn't call him on scene. I don't know if Marshall
- 14 Township called him on scene or --
- Q. But he was stopped when you pulled up?
- 16 A. Yes.
- 17 Q. Oh, okay.
- 18 A. Well, I got there before he did. He pulled up after I
- 19 had already showed up on scene.
- 20 Q. Okay.
- 21 A. So, but --
- 22 Q. But, so when he showed up he was traveling north on 27?
- 23 A. Yes. He said he was --
- Q. And you -- but you -- what -- where were you parked.
- 25 A. I was parked in the McElroy Metal.

- 2 A. On Oliver and Old 27.
- Q. Okay, so he came up --
- 4 A. Right at the corner.
- 5 Q. -- 27, he's -- for some reason he saw you guys there.
- 6 Were your lights on or --
- 7 A. Yeah. Well, we didn't have the emergency lights on, but
- 8 we had, you know, the headlights and everything. You could tell
- 9 that they were fire trucks.
- 10 Q. Oh, okay.
- MR. JOHNSON: So you just said, and I'm trying to write
- 12 -- so the guy from Michigan Gas showed up at Oliver and Old 27 by
- 13 McElroy Metal?
- MR. TRAVIS: Uh-huh.
- MR. PIERZINA: And was there anybody else there with you
- 16 -- what you said -- he talked to you and Rick Bonney?
- 17 MR. TRAVIS: And Dave Austin.
- 18 MR. PIERZINA: Dave -- and Dave Austin?
- 19 MR. TRAVIS: Yes.
- MR. PIERZINA: Okay.
- MR. NICHOLSON: Well --
- MR. PIERZINA: And so -- and were you doing anything
- 23 else at the time?
- MR. TRAVIS: I was still testing the air quality. It --
- 25 while we were talking to him because, like I said, you could take

- 1 a -- I walked up next to McElroy Metal, the building, and could
- 2 not smell anything the entire way around the building. But you'd
- 3 walk 10 feet away from it and you could smell it like crazy. And
- 4 then you'd take another couple steps and you couldn't smell it.
- 5 And I checked the buildings in the area and couldn't find
- 6 anything.
- 7 BY MR. NICHOLSON:
- 8 Q. So that's -- that's frustrating.
- 9 A. Yeah.
- 10 Q. Did you -- so here's a guy from Michigan Gas, didn't --
- 11 did you say to him hey, you got any equipment or can you take a
- 12 reading and --
- 13 A. He said that he couldn't figure out what it was is what
- 14 he told me.
- 15 Q. So he was having the same problem, you assume?
- 16 A. Yeah.
- MR. JOHNSON: He said he had no readings or just
- 18 couldn't figure it out? I --
- 19 MR. TRAVIS: He just said he couldn't figure it out.
- 20 From what I heard him say to Mr. Bonney.
- 21 MR. PIERZINA: Can you describe this guy?
- 22 MR. TRAVIS: I didn't pay too close of attention.
- MR. PIERZINA: And that -- and that's fine, and we're
- 24 not, you know --
- MR. TRAVIS: Yeah, well I'm trying to do a memory recall

- 1 --
- MR. PIERZINA: We're not hunting for him, but you know,
- 3 we just want to try and get a good description so --
- 4 MR. TRAVIS: Right.
- 5 MR. PIERZINA: -- you know --
- 6 MR. TRAVIS: He was probably in his 50s. I'm guessing,
- 7 late 40s, early 50s.
- 8 BY MR. NICHOLSON:
- 9 Q. So all -- you've got your headlights on in your truck
- 10 and --
- 11 A. Yeah.
- 12 Q. -- it's plenty -- it's pretty well lit so you can see
- 13 his truck says Michigan Gas?
- 14 A. Yeah.
- 15 Q. So you're pretty certain?
- 16 MR. JOHNSON: Was he in a company uniform or anything?
- MR. TRAVIS: It looked -- he was wearing work clothes.
- 18 MR. JOHNSON: He was wearing work clothes?
- 19 MR. TRAVIS: Yeah. I didn't look for a name tag or
- 20 anything.
- 21 BY MR. NICHOLSON:
- 22 Q. Did he have the name of the company on his shirt
- 23 anywhere?
- A. No. I didn't see it.
- 25 Q. Okay.

- 1 MR. JOHNSON: Yeah, probably 10:30, 11:00 you been
- 2 running around for a while.
- MR. TRAVIS: Yeah. Yeah. That was a busy day for us,
- 4 so it was --
- 5 MR. JOHNSON: Was it?
- 6 MR. TRAVIS: Yeah. That was a -- actually that was our
- 7 last call for the day but I think we did -- we turned five calls
- 8 that day.
- 9 MR. JOHNSON: Okay.
- 10 BY MR. NICHOLSON:
- 11 Q. So after you spoke with this gentleman --
- 12 A. That's when I proceeded down to Brooks Drive.
- Q. Where did he go? Did he leave at that point?
- 14 A. He left the scene?
- 15 Q. Where did he leave? 27 down Oliver?
- 16 A. I actually didn't see where he went when he left. I had
- 17 walked away and left him talking with Rick Bonney to do some more
- 18 checking around the buildings.
- 19 O. Okay.
- 20 A. With the gas monitor.
- 21 Q. So he left before you?
- 22 A. Yes.
- 23 Q. Oh, okay.
- A. Yeah.
- Q. And then you went where? Back down to the --

- 1 A. I went down Division to Brooks Drive.
- Q. Again -- oh that's when --
- 3 A. And then that's when I originally --
- 4 0. Okay.
- 5 A. -- went --
- 6 MR. PIERZINA: Were you at, gosh, what was the place the
- 7 other guy said where they had such a strong odor?
- 8 MR. JOHNSON: Oh, yeah --
- 9 MR. NICHOLSON: In the windbreaker --
- 10 MR. JOHNSON: -- Walters-Dimmick
- 11 MR. PIERZINA: Yeah.
- MR. NICHOLSON: Oh, Walters-Dimmick? Yeah, Walters-
- 13 Dimmick.
- MR. TRAVIS: I walked up to the back side. I was
- 15 actually on the back side of Walters-Dimmick and I believe it's
- 16 Marshall Building Components.
- 17 BY MR. NICHOLSON:
- 18 Q. Well, okay.
- 19 A. Which --
- Q. What time -- this would have been now after 11:00
- 21 possibly?
- A. Probably close to 11:00 yeah.
- 23 Q. Okay.
- A. By the time I got down there.
- 25 Q. So close to 11:00?

- 1 A. Yeah.
- Q. Okay. Go ahead. I'm sorry.
- 3 A. I walked down into -- behind -- Walters-Dimmick is
- 4 Marshall Building Components and I walked down into like a -- it's
- 5 almost like a ravine right down in there, low-lying area, and I
- 6 walked down into there, lost the scent completely and got up to
- 7 the back side of Walters-Dimmick.
- Q. Uh-huh.
- 9 A. And I could smell it somewhat but it must have either
- 10 dissipated or the air moved it just a little bit.
- 11 O. So --
- 12 A. I don't know --
- 13 Q. You stepped out of the paved area --
- 14 A. -- because -- yes. I walked down into the grass.
- 15 Q. Okay.
- 16 A. And up the back side to Walters-Dimmick.
- 17 Q. Okay.
- 18 A. Along the fronts of Marshall Building Components.
- 19 MR. JOHNSON: I missed something here, and I apologize
- 20 for that.
- 21 MR. TRAVIS: That's all right.
- MR. JOHNSON: You said a truck pulled up, said it was
- 23 Michigan Gas Utilities? Was he at that location or did it say on
- 24 his truck or --
- MR. TRAVIS: It said -- it -- that's what it said on the

- 1 side of his truck.
- 2 MR. JOHNSON: Oh, okay.
- 3 MR. TRAVIS: Was Michigan Gas Utilities.
- 4 MR. JOHNSON: All right. And I've been -- sorry, I get
- 5 a little over loaded and didn't want a mistake it.
- 6 MR. TRAVIS: That's all right. I have a tendency to
- 7 talk fast sometimes. I'm sorry.
- 8 MR. NICHOLSON: Well --
- 9 MR. JOHNSON: I listen slow.
- 10 BY MR. NICHOLSON:
- 11 Q. Well, did you -- can you describe -- we -- there has
- 12 been some talk about that truck. Did it have -- was there
- 13 anything you could tell us about it? I mean can you --
- 14 A. It was white. Like I said, it had the name Michigan Gas
- 15 Utilities on the side. It had a yellow light on top. It also had
- 16 one of -- like a work light.
- 17 O. Oh, like a --
- 18 A. A movable work light.
- 19 Q. -- spotlight or something?
- 20 A. Yeah. It had a tool box area in the back. I believe it
- 21 was fully covering the bed, if I remember correctly.
- 22 MR. PIERZINA: The -- was there any logo? You know, did
- 23 -- does -- did it just say Michigan Gas Utilities?
- 24 MR. TRAVIS: It just said Michigan Gas Utilities.
- 25 MR. PIERZINA: No little picture of a --

- 1 MR. JOHNSON: Gas drip?
- 2 MR. PIERZINA: -- you know a --
- 3 MR. JOHNSON: Because some of them have that, a gas
- 4 drip. I'm not saying Michigan do.
- 5 MR. PIERZINA: Oh, yeah. Yeah, like a tear, you know
- 6 a --
- 7 MR. JOHNSON: Teardrop or something?
- 8 MR. PIERZINA: -- a little flame, you know?
- 9 MR. TRAVIS: Yeah, no, it didn't. Not that I noticed
- 10 anyway.
- MR. PIERZINA: Not that you, okay, not that you noticed.
- BY MR. NICHOLSON:
- 13 O. The -- you said it's a tool chest that covers the back?
- 14 A. Yeah, it was like --
- 15 Q. Was it the same color as the truck or --
- 16 A. -- it was the same color as the truck so it was really
- 17 hard to --
- 18 Q. Okay --
- MR. JOHNSON: So a cap?
- MR. TRAVIS: Yeah, well, no, it wasn't a cap.
- MR. NICHOLSON: A cap --
- 22 MR. TRAVIS: It wasn't a full cap. It was more like a -
- 23 almost like a tool box that fit down inside the bed of the
- 24 truck.
- MR. JOHNSON: A -- well a utility side --

- 1 MR. TRAVIS: So that it came --
- 2 MR. JOHNSON: -- or a pick-up with something in it?
- MR. TRAVIS: It was a utility truck.
- 4 MR. JOHNSON: There we go.
- 5 MR. TRAVIS: Like a utility truck with a tool box that
- 6 came level with the top of the bed.
- 7 MR. JOHNSON: Okay. And we'll -- we won't hold you to
- 8 that.
- 9 MR. TRAVIS: Well --
- MR. JOHNSON: But it's, you know, a general description.
- 11 MR. TRAVIS: I -- yeah, I'm trying to --
- 12 BY MR. NICHOLSON:
- O. So it was like a tandem axle?
- 14 A. No, it was --
- MR. JOHNSON: No. No, no they --
- MR. TRAVIS: -- a single axle.
- 17 MR. NICHOLSON: Single axle?
- 18 MR. JOHNSON: -- would be like -- so in the side of the
- 19 box, and if you don't remember, you could open things?
- MR. TRAVIS: No.
- MR. JOHNSON: Oh, no?
- MR. TRAVIS: No. It was -- you would have to open
- 23 everything from the top, almost like a -- doors.
- MR. PIERZINA: Is it one of those that opens like from
- 25 each side if you're standing, you know, behind the cab, you can

- 1 open up this side or go around the other side?
- 2 MR. TRAVIS: Yeah, but it was almost --
- 3 MR. PIERZINA: Okay.
- 4 MR. TRAVIS: -- it was like it took up the entire bed.
- 5 And from what I --
- 6 MR. JOHNSON: Oh, this stick up --
- 7 MR. PIERZINA: Oh.
- 8 MR. JOHNSON: -- about this far above the side of the
- 9 bed?
- 10 MR. TRAVIS: It may not have even have stuck up over the
- 11 bed. I think it was pretty much --
- MR. JOHNSON: Okay.
- 13 MR. TRAVIS: -- just like a Tonto cover with a bunch of
- 14 doors in it or something.
- 15 MR. JOHNSON: With -- okay.
- 16 MR. NICHOLSON: But you lift them up --
- 17 MR. TRAVIS: I --
- 18 MR. NICHOLSON: You have to be over the bed --
- 19 MR. TRAVIS: Yeah, you have to be over the bed to lift
- 20 them up.
- MR. NICHOLSON: Oh.
- 22 MR. JOHNSON: Okay. So no doors on the side --
- MR. TRAVIS: If I'm remembering correctly, that's what
- 24 it --
- MR. JOHNSON: Yeah, that's really pushing you. Holy

- 1 smokes.
- MR. NICHOLSON: Well, we're asking a whole lot, but --
- 3 MR. TRAVIS: Yeah.
- 4 MR. NICHOLSON: -- that's good news. Yeah, that's good
- 5 news.
- 6 MR. JOHNSON: Okay, I'm sorry.
- 7 MR. TRAVIS: That's fine.
- 8 MR. PIERZINA: Do remember what make of truck it was?
- 9 MR. TRAVIS: I believe it was a GM model. I don't know
- 10 if it was Chevy or GMC.
- MR. JOHNSON: As long as it's Chevy, I'm okay with that.
- 12 MR. PIERZINA: Yeah.
- MR. TRAVIS: Well, so am I.
- MR. JOHNSON: So you're a Chevy guy?
- MR. TRAVIS: Yes, I am.
- 16 MR. JOHNSON: So it -- okay. That's -- and the reason I
- 17 say that because usually Chevy guys are going to know what kind of
- 18 truck it is.
- 19 MR. TRAVIS: Yeah.
- MR. JOHNSON: So, because otherwise they've probably got
- 21 some broken down Ford.
- 22 MR. PIERZINA: Yeah, what kind of truck got stuck?
- 23 MR. JOHNSON: Oh, careful. What was stuck?
- MR. TRAVIS: It's that Luverne that we've got out there.
- MR. JOHNSON: The big one, oh, okay.

- 1 MR. TRAVIS: Rusky truck.
- 2 MR. JOHNSON: All right, thanks.
- 3 MR. PIERZINA: All right, sorry to --
- 4 MR. TRAVIS: That's all right.
- 5 MR. PIERZINA: -- digress.
- 6 BY MR. NICHOLSON:
- 7 Q. So we left it you were walking back around Marshall.
- 8 You went out in some low-lying areas?
- 9 A. Uh-huh.
- 10 Q. Took some readings?
- 11 A. I didn't -- I couldn't pick anything up in the low-lying
- 12 areas, which was really baffling to me. I figured, you know, the
- 13 stuff, the way it was smelling to me is heavier than air, and it
- 14 seemed to be like it would lay in lower areas. And I didn't pick
- 15 any -- I couldn't smell nothing.
- 16 O. Okay. Yeah.
- MR. TRAVIS: So --
- 18 MR. JOHNSON: Go -- were you done, Matt, I didn't want
- 19 to interrupt.
- MR. NICHOLSON: Yeah, go ahead.
- 21 MR. JOHNSON: Were -- have you been trained for anything
- 22 like that?
- MR. TRAVIS: I've only been trained to --
- MR. JOHNSON: I mean, you seem to --
- 25 MR. TRAVIS: -- operations level and HAZMAT. That's all

- 1 I -- the training I have, so --
- MR. JOHNSON: Which was enough that you, it's like you
- 3 know --
- 4 MR. TRAVIS: Which is --
- 5 MR. JOHNSON: -- if you see something go up and some
- 6 down and what to look for?
- 7 MR. TRAVIS: Yeah, you know what you're -- generally I
- 8 can tell if it's heavier than air.
- 9 BY MR. NICHOLSON:
- 10 Q. I'm sorry, your training was in what?
- 11 A. Operations level.
- 12 Q. What is that?
- 13 A. It's --
- 14 O. Operations level HAZMAT?
- 15 A. HAZMAT.
- 16 Q. Okay.
- 17 A. HAZ training.
- MR. PIERZINA: Is that the 40-hour?
- 19 MR. TRAVIS: It's the lowest class, yeah. That's -- but
- 20 that's all they give us in the --
- 21 MR. JOHNSON: It's like an eight hour course?
- MR. TRAVIS: Something like that.
- MR. JOHNSON: Okay.
- MR. TRAVIS: If I remember right. It's been years since
- 25 I took it, but we do train on hazardous material, but you know,

- 1 I'm not a technician or anything when it comes to it.
- 2 MR. PIERZINA: Yeah. So do you get like annual
- 3 refreshers?
- 4 MR. TRAVIS: Yes.
- 5 MR. PIERZINA: In that? To keep your operations level,
- 6 I suppose?
- 7 MR. TRAVIS: We have to train in certain areas every
- 8 year, yes. I believe that's one of them.
- 9 BY MR. NICHOLSON:
- 10 Q. Do you -- do the utilities -- utility companies do any
- 11 training with you for like emergency response or --
- 12 A. Lakehead Pipeline has done trainings on -- unfortunately
- 13 I've been out of town when they've done them.
- Q. That is unfortunate. Where are they or who are they?
- 15 Where are they?
- 16 A. They've done them at Cedar Crest out on the east end of
- 17 town. It's a banquet facility, and I can't remember the other
- 18 place that they've done it.
- 19 Q. And so they -- you get mailings from them for training?
- 20 A. Yes.
- 21 Q. Okay. What about gas utilities? Do they notify you
- 22 or --
- 23 A. I don't know if they do or not.
- 24 Q. Okay.
- 25 A. I haven't been --

- 1 Q. So you haven't attended any --
- 2 A. No.
- 3 Q. -- kind of gas utility --
- 4 A. No.
- 5 Q. -- training or --
- 6 A. Just what we've had in the fire academy.
- 7 Q. Oh, okay.
- 8 A. Which was very minimal.
- 9 Q. So, no utilities. Okay.
- 10 MR. PIERZINA: How many folks do you have on your
- 11 department?
- 12 MR. TRAVIS: There's your captain's (indiscernible).
- 13 MR. PIERZINA: Oh.
- MR. NICHOLSON: Oh. Hey.
- MR. TRAVIS: We have seven full-time employees.
- 16 BY MR. PIERZINA:
- 17 Q. Seven full time?
- 18 A. Yep. And that's counting our chief.
- 19 Q. Okay.
- 20 A. And 25, I believe, part paid fire fighters.
- 21 O. Are -- volunteer? Part time?
- 22 A. We call them part paid.
- Q. Part paid?
- 24 A. Yeah.
- Q. Part paid?

- 1 A. They're on call.
- 2 MR. JOHNSON: Paid on call?
- 3 MR. TRAVIS: Paid on call.
- 4 MR. JOHNSON: Ah. My neighbor was. That's weird.
- 5 MR. TRAVIS: Yeah.
- 6 MR. JOHNSON: That's why I was talking to the other guy.
- 7 MR. TRAVIS: And it's very rare to find a full volunteer
- 8 department any more.
- 9 MR. PIERZINA: So when those opportunities come --
- MR. JOHNSON: Whoa, whoa, do we need to wait, I think?
- 11 I -- I'm sorry.
- MR. PIERZINA: They -- oh. Actually it was just kind of
- 13 a general discussion, when the opportunity comes up to go to those
- 14 meetings, is like the whole --
- MR. JOHNSON: Oh.
- 16 BY MR. PIERZINA:
- Q. -- whole department invited --
- 18 A. Yes.
- 19 O. -- or just a few -- select few?
- 20 A. No, the entire department does -- they set up a sign-up
- 21 sheet if you can attend it, you can.
- O. Okay. And sometimes --
- MR. JOHNSON: Sorry, Brian.
- MR. TRAVIS: Our chief --
- 25 BY MR. PIERZINA:

- 1 O. Sometimes only a few select can go or whatever?
- 2 A. Yeah, no. For the most part, most of the trainings like
- 3 that that come up we let everybody in on. I do recall now that I
- 4 did attend a -- I believe it was a propane training where we
- 5 learned how to use the fire screens to cool down tanks and get up
- 6 and shut them off with using hose lines.
- 7 Q. Oh, okay.
- 8 MR. JOHNSON: You're talking to someone who's had his
- 9 Suburban burn down by a runaway 20-pounder.
- 10 MR. TRAVIS: Oh, boy.
- 11 MR. JOHNSON: It wasn't my runaway 20-pounder. It
- 12 was --
- 13 MR. PIERZINA: Bit it was your Suburban.
- MR. JOHNSON: It was Terry's -- who we worked with this
- 15 morning? It was her husband's.
- MR. PIERZINA: Oh.
- 17 MR. JOHNSON: Sitting in Bristol, Tennessee. Hmm. Lose
- 18 more Suburbans that way.
- 19 MR. PIERZINA: Oh, gosh. Yeah, we're kind of --
- 20 MR. JOHNSON: That's some -- yeah. Maybe we should put
- 21 this on pause or something while we're waiting for Matt?
- 22 MR. PIERZINA: What do you think Dana?
- MR. JOHNSON: We could just --
- MR. PIERZINA: Or can we just -- he probably doesn't
- 25 care. It might even be better to just show the recording

- 1 continue.
- 2 MR. JOHNSON: Okay.
- 3 MR. PIERZINA: As long as we have --
- 4 MR. JOHNSON: Well, I just -- I -- right.
- 5 MR. PIERZINA: As long as we don't badmouth him or
- 6 something like that, huh.
- 7 MR. JOHNSON: Okay, I won't.
- 8 BY MR. JOHNSON:
- 9 Q. Maybe moving ahead or whatever, so then you were -- you
- 10 -- the smell was there but you --
- 11 A. I couldn't pin point it.
- 12 Q. -- couldn't find it. I mean, you were around, I know
- 13 you have the training and then when you -- so you cleared or leave
- 14 or --
- 15 A. Yes.
- 16 Q. -- I just don't know how that goes.
- 17 A. Oh, I actually contacted Assistant Chief Rhodes and
- 18 discussed it with him over the radio and explained to him what I
- 19 found, what I didn't find, and asked him, I said I can't pinpoint
- 20 it. I don't know what the problem is. I don't -- I said I really
- 21 don't know what to do, and, you know, I've never run into this
- 22 situation before. And he said well, if you can't find the problem
- 23 I guess you just go ahead and come back and after talking with
- 24 Rick Bonney, we both came to the same conclusion, just go ahead
- 25 and clear because we couldn't pinpoint anything. And I had

- 1 checked, you know, if -- it would have been probably a different
- 2 story for me had I picked something up on the gas monitor.
- 3 O. Oh, I don't doubt that at all.
- 4 A. That would have been a totally different situation.
- 5 Q. Then you call in someone and say help me find this,
- 6 yeah.
- 7 A. We would have been calling everybody.
- Q. Yeah.
- 9 A. At that point. But I could not pick up anything on the
- 10 gas monitor, and if you'd like I can show you the gas monitor when
- 11 we get done so you know what I was working with.
- 12 Q. No, actually -- well I don't need to see that. Maybe
- 13 Dana does, but we, you know, our company has the same one --
- 14 A. I -- right, I'm sure --
- 15 Q. -- and they're all recordable. I mean, that's just --
- 16 A. Yeah.
- 17 Q. -- makes your life easier.
- 18 A. At times, yes.
- 19 Q. At times, yes. Okay.
- MR. PIERZINA: Have you ever seen, you know, I -- I'm
- 21 not sure, you know, probably your chief has some manuals and stuff
- 22 or you guys -- you know, your department has some manuals. Have
- 23 you ever seen the Pipeline Emergency Response Manual? Or anything
- 24 that --
- MR. TRAVIS: I don't remember seeing one, though.

37

- 1 MR. PIERZINA: Anything like that?
- MR. JOHNSON: So when you clear it, what do you -- how
- 3 do you clear it? I mean, when --
- 4 MR. TRAVIS: We --
- 5 BY MR. JOHNSON:
- 6 Q. So when you talked to the chief and maybe Rick, I don't
- 7 know, maybe take that from when you called the chief and maybe
- 8 walk me to when you're like came back, what are your steps?
- 9 A. When we clear a scene, basically what we do is we put
- 10 away all of our equipment that we used and get the truck -- check
- 11 the truck, make sure everything's on it that we had off it and we
- 12 call on the radio to alarm office, tell them that we're clearing
- 13 the scene and returning to quarters.
- Q. So the alarm office is where?
- 15 A. Right across the street from the county building.
- 16 O. Is that the 911?
- 17 A. Yes.
- 18 Q. Is that what you mean by the alarm office?
- 19 A. Yes.
- 20 Q. Okay.
- 21 A. We call it the alarm office. Some places call it
- 22 dispatch center. This one's got a new name, it's Calhoun County
- 23 Consolidated Dispatch. But we've -- I've always called it the
- 24 alarm office and pretty --
- Q. Yeah, it's not problem, we're just --

- 1 A. -- everybody here has.
- Q. -- hearing a lot of different things, so I just --
- 3 A. Yeah.
- 4 Q. -- wanted to make sure in my mind what that was.
- 5 A. Yep.
- Q. So I'm going to write this down and then ask you if I've
- 7 simplified it too much.
- 8 A. And then the next step in -- after that process is when
- 9 we get back to the station we call alarm office and report that
- 10 we're back in -- back at the station and off the air.
- 11 O. So you cleared the site?
- 12 A. Uh-huh.
- 0. Returned to base.
- 14 A. Right.
- Q. Check the truck, call the alarm office and say that you
- 16 -- what do you, I mean, do you close the call, close the loophole,
- 17 what do you --
- 18 A. Clear the scene means that we have determined that we
- 19 cannot find anything or that the scene, as far as we're concerned,
- 20 is over.
- 21 Q. Okay.
- 22 A. At that time.
- 23 Q. So you notify them --
- 24 A. Yep.
- Q. -- that the scene is clear?

- 1 A. Uh-huh.
- Q. Okay.
- 3 BY MR. PIERZINA:
- 4 O. Is there any paperwork involved in that?
- 5 A. We do a brief report unless it's something like a
- 6 structure fire where it -- where we get much more entailed,
- 7 especially, you know, when it comes to like Monday morning we had
- 8 a structure fire that we were on for approximately six hours. So
- 9 that was a pretty rough day for us there too.
- 10 Q. Is that the name of the report, brief report, or is it
- 11 just a short, you know --
- 12 A. No, actually we do a -- it's about a four-page report
- 13 when we print it out.
- 0. Oh, the big one? Yeah. On a big one. Or when you do
- 15 your brief report that's a --
- 16 A. Any report. It's -- we have a section --
- 0. Okay, so that's kind of a misnomer?
- 18 A. We have a section that we put our notes in and sometimes
- 19 it's very brief notes depending on what the call was.
- Q. Okay, I'm sorry.
- 21 A. So it's the same report for any call, but it --
- 22 depending on the call is how it makes -- determines how many notes
- 23 that we add to it.
- Q. Okay. So do -- and do you do that as soon as you're
- 25 back at the shop or --

- 1 A. Yes. In that case Assistant Chief Rhodes did the
- 2 report. He had it done by the time I got back.
- 3 Q. Oh.
- 4 A. So, after speaking with him, you know, he knew what we
- 5 had done and he was just -- actually he was finishing up the notes
- 6 as I got back to the station, so --
- 7 Q. That's -- is that how that kind of works or do you --
- 8 A. For the most part if only one of us goes out the guy
- 9 that stays back will do the report and when the -- if I talk to
- 10 him on the radio or if he talks to me on the radio, sometimes
- 11 we'll, if it's in just a cut and dry call, we will -- we know what
- 12 the other person is doing or should be doing and we do the notes
- 13 and then when they get back we have them over -- double-check
- 14 them and if it's okay then we print it out.
- 15 Q. Huh.
- 16 A. But --
- 17 Q. Oh, so you actually do it on the computer and --
- 18 A. Yes.
- 20 A. A data base.
- 21 O. -- file or some --
- 22 A. Yep.
- Q. -- data base? Okay. Good.
- 24 A. Yeah. We use, I think it's called Fire Programs.
- 25 Q. Okay.

- 1 A. Is the reporting system that we use.
- Q. Is that exclusive to just Marshall City Fire Department,
- 3 or does Marshall Township Fire Department use it?
- 4 A. I believe some -- most of the other departments around
- 5 do the same -- use the same reporting system.
- 6 Q. Okay. I guess I was kind of curious if it was a -- you
- 7 know, if it all went into a Calhoun County --
- 8 A. No.
- 9 Q. -- system? No?
- 10 A. I -- I'm not real sure how that works.
- 11 O. Okay.
- 12 A. Greg McComb, he's assistant chief here, he's the one
- 13 that deals with the fire programs. He'll -- if we have a problem
- 14 with it he'll contact Fire Programs and get it sorted out, you
- 15 know, and if it's not working properly or we, you know, something
- 16 like that, he takes care of that.
- 17 Q. So -- and what time were you cleared by?
- 18 A. I don't know. I can't remember the exact time.
- MR. JOHNSON: They'll get the report, though, if you
- 20 want.
- 21 MR. TRAVIS: Yeah, I could look at the report and tell
- 22 you what time I cleared.
- MR. JOHNSON: Okay.
- MR. PIERZINA: Okay.
- MR. JOHNSON: And I don't have anything yet, but that's

- 1 in -- we'll leave that optional, but --
- 2 MR. TRAVIS: Yeah.
- 3 MR. JOHNSON: We kind of proceeded without you. We
- 4 didn't get in -- heavily in any details.
- 5 MR. NICHOLSON: Oh, that's all right.
- 6 MR. JOHNSON: More on how they clear the site --
- 7 MR. NICHOLSON: So let's --
- 8 MR. JOHNSON: -- when they get back and --
- 9 MR. NICHOLSON: Oh, okay. Okay. Need more information
- 10 on --
- 11 MR. PIERZINA: Just to back --
- 12 MR. NICHOLSON: -- trucks?
- MR. PIERZINA: So and that was your last -- of course it
- 14 was pretty close to the end of the day anyhow, huh?
- 15 MR. TRAVIS: Well, I didn't get out until 7:30 the next
- 16 morning, so --
- 17 MR. PIERZINA: Okay.
- 18 MR. TRAVIS: We work 24-hour shifts.
- 19 MR. JOHNSON: And that was your last call, though?
- MR. TRAVIS: And I'm pretty sure that was our last call,
- 21 yes.
- MR. PIERZINA: And did you have, you know, prior to this
- 23 one were there any calls -- well, you said your --
- MR. TRAVIS: I think we ran five calls that day if I
- 25 remember correctly.

- 1 MR. JOHNSON: In that neck of the woods or all around?
- 2 MR. TRAVIS: No, all over the city.
- 3 MR. JOHNSON: Okay.
- 4 MR. TRAVIS: Sorry.
- 5 MR. NICHOLSON: No, that's okay.
- 6 BY MR. PIERZINA:
- 7 Q. Any recent calls, you know, any other calls in that
- 8 area, say, you know, the rest of Sunday, or, you know, earlier on
- 9 Sunday?
- 10 A. Not that I'm recalling. I could look at the run log and
- 11 tell you whether -- where they were located at, but I don't know
- 12 off the top of my head. I don't believe so.
- 13 O. Okay. It's --
- 14 A. Other than the call at Fairway Meadows, which is down
- 15 right across from the golf course.
- 16 Q. Okay.
- 17 A. But that's, like I said, about a quarter to a half mile
- 18 down the road.
- 19 Q. Now, was that your assistant chief that was on that one?
- 20 A. Yes.
- 21 O. Okay. And that was Assistant Chief Rhodes?
- 22 A. Yes. And like I said he got the fire truck stuck and
- 23 when I was down there, I couldn't smell anything in that area.
- 24 Q. Uh-huh.
- 25 A. Relating to anything.

- 1 O. What -- and what kind of call was he on? I --
- 2 A. He was on a medical.
- 3 O. A medical call?
- 4 A. Yes.
- 5 Q. And besides -- okay, so --
- 6 MR. NICHOLSON: So he was on a medical call and he got
- 7 stuck?
- 8 MR. TRAVIS: After the ambulance already had the patient
- 9 loaded.
- 10 MR. NICHOLSON: Oh, okay. All right.
- MR. TRAVIS: Because he was --
- MR. JOHNSON: Go ahead. I knew where you were going.
- MR. TRAVIS: -- he was backing up.
- 14 MR. JOHNSON: But there's bad luck.
- 15 MR. TRAVIS: He was backing the fire engine up and it -
- 16 the road stops and it turns to dirt.
- 17 MR. PIERZINA: Okay.
- 18 MR. TRAVIS: And with all the rains that we've had here
- 19 recently the back end of the truck just sank, so --
- BY MR. PIERZINA:
- 21 Q. And I, you know, I think maybe my head's saturated so
- 22 stuff goes out -- did you say that you guys had talked about the
- 23 odor? Did he smell an odor at all?
- 24 A. He said he smelled --
- 25 BY MR. JOHNSON:

- 1 O. Oh.
- 2 A. -- something but he was putting it off as natural gas is
- 3 what he told me.
- 4 O. Okay, because you -- now, I'm going from earlier now.
- 5 A. Uh-huh.
- Q. I think it's -- now it's -- in my mind it's clear,
- 7 Brian, but so you got the call -- or he got the call, said you
- 8 need to go, I got stuck.
- 9 A. Uh-huh.
- 10 Q. So but yet you went to him --
- 11 A. He had me --
- 12 Q. He left you with the --
- 13 A. He had me --
- Q. He -- you got the stuck truck.
- 15 A. Yeah. And he went out there originally.
- 16 O. And then he went to the airport. To Brooks Field?
- 17 A. He went to Division and Old 27.
- 18 Q. Okay, Division and Old 27.
- 19 A. And he was -- he told me and -- that it was, he thought
- 20 it was natural gas, so he called the Township in.
- 21 Q. Okay.
- MR. PIERZINA: That's what you said, and it just left.
- MR. NICHOLSON: Except you're -- the call came in at the
- 24 airport, right? It --
- MR. TRAVIS: We were -- the way dispatch gave it out, I

- 1 believe, was that it was in the -- at the airport. But as he was
- 2 going, he couldn't smell anything at the airport, I believe.
- 3 MR. NICHOLSON: Oh, okay.
- 4 MR. TRAVIS: Is what he told me. You -- I can get you
- 5 his phone --
- 6 BY MR. JOHNSON:
- 7 Q. So he kept --
- 8 A. -- number.
- 9 Q. -- going until he smelled it?
- 10 A. Yeah, I believe --
- 11 O. Got that smell?
- 12 A. -- that's what he did.
- 13 Q. Determined that you switched --
- 14 A. I don't know for sure.
- 15 Q. Yeah, you have to -- asking you to talk for somebody
- 16 else, but okay.
- 17 BY MR. PIERZINA:
- 18 Q. So if, by now I ought to -- but he was just finishing up
- 19 with the medical call --
- A. Uh-huh.
- 21 Q. And got --
- 22 A. We got a --
- Q. -- dispatched --
- A. Yeah, we got --
- Q. -- dispatched to --

- 1 A. -- dispatched to the odor investigation while he was on
- 2 the call.
- 3 O. And --
- 4 A. And the reason that he had me come to him was because he
- 5 had the truck stuck, so --
- 6 Q. All right.
- 7 BY MR. NICHOLSON:
- 8 Q. And the Enbridge truck that you saw was when you were
- 9 meeting up with --
- 10 A. No, I didn't see an Enbridge truck.
- 11 O. Or the Michigan -- who was it?
- 12 A. Michigan Gas Utilities.
- 13 Q. That was when you were meeting up with Dave and --
- MR. JOHNSON: He didn't say Enron.
- MR. TRAVIS: And Rick Bonney.
- 16 MR. NICHOLSON: And Rick. Any other questions?
- MR. PIERZINA: Well, I guess, just, John, if there's
- 18 anything you can think of just in general, you know, that might
- 19 help us, you know, in our investigation, we'd -- we'll take
- 20 anything you might offer.
- MR. NICHOLSON: I've got a couple. I just wanted to --
- MR. PIERZINA: Oh.
- BY MR. NICHOLSON:
- Q. Who else is interviewed about those incidents that
- 25 night?

- 1 A. Who else has been interviewed from here?
- 2 Q. Who else has interviewed you?
- 3 A. No one.
- 4 O. Oh. Your chief or township chief?
- 5 A. I talked to my Assistant Chief about it today.
- 6 Q. Okay.
- 7 A. Bill Hinkinson (ph.) but I just told him what I did, you
- 8 know, and my -- the steps that I took while I was out there.
- 9 Q. Okay. And you were talking -- I think it was before I
- 10 got that tape going. I wanted to hear -- your experience, you
- 11 said, you were talking about your family and how long you'd been a
- 12 fire -- can you just give me some of your experience?
- 13 A. I've been on full time for three and a half years.
- 14 Before that I was on for just about six years as a part paid.
- 15 Q. And I thought it was a rather interesting --
- 16 A. Third generation in my family to be on the department
- 17 full time. My dad served here for 31 or 32 years.
- 18 Q. Third generation at this place, but it was five?
- 19 A. Five -- the fifth --
- Q. Family members?
- 21 A. The fifth family member to be here. And I grew up
- 22 around this -- in the fire service and it's the only thing I've
- 23 ever wanted to do.
- MR. NICHOLSON: Okay. Anything else, guys?
- MR. PIERZINA: Unh-unh.

- 1 MR. JOHNSON: Just a general guestion. You know, now
- 2 I'm starting to be like you, Brian.
- 3 BY MR. JOHNSON:
- 4 O. In -- I don't think it's to do with the investigation,
- 5 if you want to shut the recorder off, and it has nothing to do
- 6 with the response, but how do you interact, I mean, with the 911,
- 7 I mean, it's next door or anything else, do you have any sessions
- 8 where you learn what they do or they talk to you or --
- 9 A. No --
- 10 Q. -- I don't know what I'm trying to get at there.
- 11 A. -- not really. With the way that the 911 center is set
- 12 up now, being a consolidated dispatch, they have a governing board
- 13 and our chief goes to the meetings for that, but I don't attend
- 14 them personally.
- 15 Q. Okay. So really no interaction there?
- 16 A. Not on a personal basis. Our chief will come back to us
- 17 and tell us what's going on if it's anything pertinent.
- 18 Q. Okay.
- 19 MR. PIERZINA: I -- I'm sorry. I also have another
- 20 question.
- 21 BY MR. PIERZINA:
- 22 Q. Just, you know, in kind of that whole coordination
- 23 thing, so you guys brought Marshall Township Fire Department in
- 24 because you thought it was --
- 25 A. In their area.

- 1 O. -- on the west side of Old 27 or --
- 2 A. Right.
- Q. -- you know, in their area. Did you call Fredonia
- 4 Township or --
- 5 A. No.
- 6 Q. It was -- maybe -- do you ever work with Fredonia
- 7 Township when you --
- 8 A. Yeah, we work in --
- 9 Q. -- when you get into that border kind of thing where --
- 10 A. We've -- we work with them on occasion.
- 11 Q. Okay.
- 12 A. We run any PI accident in their area, a known personal
- 13 injury accident. We run on those. Sometimes they call us for
- 14 structure fires. But we don't -- other than that we don't really,
- 15 you know, work with them on a day to day basis or anything unless
- 16 they call for us or we call for them, which we have several times
- 17 in the past.
- Q. Do you hear on your radio or anything when, you know,
- 19 like if Fredonia Township was being paged, would you hear that?
- 20 A. I would if I had it with me, yes, I would hear it.
- 21 Q. Okay.
- 22 A. The morning that that -- that they were toned out for
- 23 this I was already on a structure fire.
- 24 Q. Oh.
- 25 A. So I did not -- I didn't hear anything.

- O. Okay. And you didn't hear anything -- you didn't hear
- 2 Fredonia Township getting paged out at all Sunday night?
- 3 A. I don't remember, honestly.
- 4 0. Okay.
- 5 A. Sometimes the radio goes nonstop all day.
- 6 O. Yeah.
- 7 A. And you tune it out unless you hear, you know, your area
- 8 or something that you might possibly have to respond on.
- 9 Q. Okay. Great. Thank you much.
- 10 MR. JOHNSON: Thanks for your time.
- MR. TRAVIS: Hey, not a problem. And like I said if I
- 12 come up with anything more or remember anything else I can give
- 13 somebody a call and --
- MR. JOHNSON: Did we, just to -- and I remember you
- 15 talked about it, and I think you were gone then, Matt. You do a
- 16 small follow-up to the call out?
- 17 MR. PIERZINA: The brief report, right?
- 18 MR. JOHNSON: Well --
- 19 MR. TRAVIS: Well we -- alls we do is a report,
- 20 depending on --
- 21 MR. JOHNSON: So there you would have said went to site,
- 22 smelled, you know, did this with the gas detector, cleared?
- MR. TRAVIS: Right. Used gas detector, cleared the
- 24 scene, returned to quarters.
- 25 MR. JOHNSON: Okay. So I mean if for some reason Matt

- 1 wanted to get a copy of that for the records you could?
- 2 MR. TRAVIS: He'd have to fill out a FOIA request, I
- 3 believe, but I'd have to check with my assistant chief on that. I
- 4 don't know. As far as I know anyone needing a --
- 5 MR. NICHOLSON: This would be on the --
- 6 MR. TRAVIS: -- report --
- 7 MR. NICHOLSON: -- like a sheet we got from --
- 8 MR. JOHNSON: Very --
- 9 MR. NICHOLSON: Yeah.
- 10 MR. JOHNSON: -- yeah, kind of where they close the
- 11 loop, they got called out, they get a sheet, they call them out,
- 12 and then they close the loop.
- MR. PIERZINA: Yeah, except they do theirs right on the
- 14 computer.
- MR. NICHOLSON: Oh, yours are on the computer?
- MR. TRAVIS: Uh-huh.
- 17 MR. NICHOLSON: Okay. Okay. That's good to know. If I
- 18 need it, I'll come talk to you. Okay. Any other questions?
- 19 MR. TRAVIS: And I just -- I briefly looked over the
- 20 notes, like I said, I didn't type them out, so --
- 21 MR. JOHNSON: I got a pad here. An extra pad. Would
- 22 you like it?
- MR. NICHOLSON: I just was going to leave my --
- MR. PIERZINA: Oh, you --
- MR. JOHNSON: Okay.

- 1 MR. NICHOLSON: -- contact information. I forgot my
- 2 cards. I'm sorry. Was trying to travel light today.
- 3 MR. TRAVIS: I don't know if each one of you want a
- 4 card?
- 5 MR. JOHNSON: I think if you give it to the chief here.
- 6 MR. TRAVIS: Okay.
- 7 MR. JOHNSON: Our chief.
- 8 MR. NICHOLSON: Thank you.
- 9 MS. SANZO: And with an extra one if I can have one too,
- 10 please?
- 11 MR. TRAVIS: Certainly.
- MS. NICHOLSON: Yeah, Dana, my --
- MR. JOHNSON: Oh, I -- we got two reasons for those.
- 14 MR. NICHOLSON: -- she'll be talking to you again
- 15 probably on another --
- MR. TRAVIS: Okay.
- 17 MR. NICHOLSON: -- subject.
- 18 MR. JOHNSON: Okay.
- 19 MR. NICHOLSON: Okay. I guess this concludes the
- 20 interview with John Travis.
- 21 (Whereupon, the interview was concluded.)
