## **Engine Entries**

- · Performed 100 hour inspection with reference to FAR 43 appendix D.
- Compressions: #1/76, #2/72, #3/76, #4/72, #5/76, #6/72. Master orifice is 42/80.
- Performed boroscope inspection of cylinders and exhaust valves. No discrepancies noted.

Spark plugs removed, cleaned, resistance checked, inspected, gapped, function checked and reinstalled with new gaskets p/n AN4017-2.

Drained oil sump and took sample for analysis. Removed filter and opened for inspection with no discrepancies noted. Reinstalled drain plug with new gasket p/n M\$35769-18. Serviced engine with 10 quarts of Aeroshell W100 and installed a new filter p/n AA48110-2. Engine ground check run satisfactory.

- Fuel control inlet screen removed, inspected, cleaned and reinstalled. Leak checked satisfactory.
- Pressure checked exhaust system wiht no defects noted.
- Installed new Helicoil thread repair for oil cooler lower center stud mount. Reinstalled adapter and oil cooler with new gaskets.
- Installed new #3 cylinder push rod seals p/n 534610, p/n 630286 and gasket p/n 65528. Repositioned fuel control inlet fitting to prevent chaffing after tensioning alternator belt.
- · Checked and torqued all turbo waste gate banjo fittings and hoses. No leaks noted on post maintenance run.
- Installed grommet on fuel vapor return line to prevent chaffing on baffle.
- Installed new #6 cylinder spark plug p/n URHB32E.

Installed magnetos after 500 hour magneto inspection/repair left p/n 6320 s/n 05030427 and right p/n 6320 s/n 08101396, and timed to engine at 22 degrees BTDC per engine data plate. See FAA CRS #QYIR334Y work orders #WO1170007700.002 Left and #WO1170007700.001 Right for details of magneto repairs.
