

Preliminary* OES Chronology - Bay Area Spill November 7, 2007:

- O942 Petroleum spill was reported to California State Warning Center (CSWC) Reporting party (Shipper O'Briens Group) said that incident occurred at 0830. Ship struck Bay Bridge, Location Oakland, Alameda County, "near US Naval Station." Quantity unknown.
- 0950 Spill update from Caltrans No damage to Bay Bridge
- National Response Center (NRC) spill report received by CSWC NRC reports that vessel struck the Delta Tower of the Bay Bridge, incident location Oakland, Alameda County. Fuel has been transferred to minimize leakage; vessel is anchored at this time, no location of anchorage stated.

Spill Notifications 1 initiated by OES: Oakland Fire Department, Alameda County Environmental Health Department, Department of Fish and Game (DFG) – Oil Spill Prevention and Response (OSPR), Department of Toxics Substances Control (DTSC), State Regional Water Quality Control Board, United States Environmental Protection Agency (USEPA), US Fish and Wildlife, Coastal Commission, State Lands Commission, Department of Parks and Recreation, US Coast Guard (USCG), SF Bay Conservation and Develop Commission, California Department of Public Health (CDPH) and Department of Water Resources (DWR). OES Executive Duty Officer, Coastal Duty Officer and Fire Duty Officer briefed.

- 1028 CSWC Notified by OSPR Spill approximately 10 bbls (barrels)
- OES Initial Flash Report sent to Governor's Cabinet and Senior Staff, Agency Secretaries/Undersecretaries, Department Director's, 24 hour State Operations Centers and Duty Officers (ie: CHP ENTAC, CALFire EOC, CDHP DO), and FEMA IX Duty Officer and the federal Dept of Homeland Security NOC.
- 1540 CSWC notified by OSPR Spill approximately 10 bbls, added known impacted areas (San Francisco shoreline from the bridge to Chrissy Field and the west side of Treasure Island) and are placing containment boom in the Bay off the Chrissy Field area to implement the planned protection strategy for that site

Spill Notifications/briefings 2 initiated by OES - see notifications list, above

- 1610 OES Updated Flash Report sent to see Flash Report list, above.
- 1740 CSWC notified by OSPR Spill approx 1,840 bbls

Spill Notifications/briefings 3 initiated by OES (see above list)

- OES Updated Flash Report sent. In addition to CSWC notification of the OES Coastal Duty Officer (CDO) and OES Fire Branch (includes Hazmat Section) the EDO also followed-up with the CDO and Fire Branch to determine their current actions and to gather any further intelligence.
- Legislative Flash Report sent 1820 Legislators representing Alameda, Contra Costa, Marin, Napa, San Francisco, San Mateo, Santa Cruz, Solano, Sonoma that have sign-up for these notifications.
- 1830 (Approx)CDO makes initial contact with San Francisco Duty Officer and Marin OES Manager
- 1930 (Approx) CDO contacts OSPR representative to discuss incident
- 1947 OES Fire and Rescue representative enroute to Bay Area spill scene
- 2000 (Approx) CDO re-contacts San Francisco Duty Officer to advise of conference call and initiates contact with other Op Areas through Public Safety Answering Points (PSAPs).
- OES Coastal Duty Officer conducts conference call with Operational Areas (OAs): Alameda, Contra Costa, Marin, San Francisco, San Mateo, Solano, and Sonoma to discuss the current status of the Bay spill incident. OES EDO, USCG and OSPR participated.

November 8, 2007:

- 0832 OES Updated Flash Report sent see Flash Report list, above.
- 1000 CDO conducts conference call at 1000 hours for Operational Area (County) (OA) emergency managers to report any significant emergency management issues and for the OES Region to share information about the event.
- 1330 CDO conducts an additional conference call with OAs that included OSPR and USCG to provide specific information about the incident.
