On 9-22-01 at approx. 1943hrs. I Deputy J.M. Waananen was working north county patrol when I heard over CDF dispatch of a vehicle accident on Humboldt Rd. Butte Meadows, CA. While enroute to assist, CDF reported that Enloe helicopter had crash landed.

I arrived on scene at approx. 2034hrs. and observed that Enloe flight care helicopter had crashed into the ground to the south of Humboldt Rd. near the "baseball field" cross of Skyway Rd. Medical personnel were attending to the injured pilot. CDF had wet down the area due to fire hazard. No fire had started. The pilot was transported out by helicopter and pronounced dead at Enloe hospital. (see report # C01-15657)

Sgt. Burdine arrived and assisted in securing the scene. Crime scene tape was put up and the only people into the crash scene were CDF personnel, Enloe ambulance personnel, CHP and Enloe flight care pilot safety officer Tom Schaub with Jerry Tennison, maintenance director Enloe flight care. Tom and Jerry told me that Richard Contie from FAA Sacramento advised them to secure any flight info papers that may have been in the debris.

While on scene I spoke with wit. Dan DelCarlo, wit. Tom Neverkovec, and wit. Pam Adams. All witnesses stated that they were at the "baseball field", a common landing zone for Enloe flight care. They stated that Enloe flight care helicopter circled above and then started to land facing to the east. As the helicopter came close to the ground a cloud of dust rose that was so thick they could not see the helicopter. All witnesses said the helicopter lifted away and drifted to the south above Humboldt Rd. and went into the trees near the edge of the road.

I secured the scene until relieved by Pride Security Officer, ( 6000 Lindhurst Ave. Marysville, CA, Ph # [REDACTED] ) Tim Holdaway at approx. 2245hrs.
