Subject: Dekalb county Plane Crash Eye Witness On Friday, May 8th, at approximately 10:00 A.M., I headed down to our lower lot to take pictures of a vehicle that we were offering for sale. I stopped and spoke with Eddie Cushing for a few moments at the exit of our service drive. After a brief conversation, Eddie around to the front of the building to deliver a vehicle. A few seconds later, I heard the loud sound of a airplane engine coming from the Southwest. After working in this location for more than ten years, I have become accustomed to planes coming from that general direction, which is towards PDK Airport. This sounded different than normal and I immediately scanned horizon for the plane and did not see it for a few seconds. It appeared just to the right, from my perspective, of the tree you see in the center of the background in the picture I included(FAA 001). The engine sounded very loud, as if it was turning very high RPMs. The plane's attitude was normal, but the altitude was extremely low. I would estimate it to have been around 100 feet which is extremely unusual. The area I was standing in is on a downslope from the path the plane was flying. He was heading in a NorhEasterly direction which was to my right and at a distance of 50 to 60 feet. His path was directly parallel to Peachtree Industrial Blvd. It also mirrored the front drive of our dealership. I observed the pilot and another person sitting in the front of the plane, and the silhouette of someone in the back. I could see the pilot's hands on the yoke and observed both front passengers working controls on the dash. The right passenger reached forward a laid something on top of the dash. When I saw this happening, I could hear a "Clak clack" sound coming from the plane. It is important to note that the RPMs did not change, the throttle sounded wide open. The engine sounded like a car that neutral and revving to the limit. I can not recall the number of times I heard the
