uh and it looks like you'll begin to get ah ah some scattered to broken at three thousand to four thousand beginning around edenton or little washington pitt greenville and that vicinity ah westward and then we'll see ah ah thickening clouds mostly overcast at three thousand to four thousand feet and for around the destination rowan county has some light rain and drizzle as well as ah gastonia ah down there ah and that's were we begin to see i f r conditions down there ah e h o automated report wind zero four zero at three the visibility two miles and mist with fourteen hundred scattered and eighteen hundred overcast temperature twelve dew point eleven now the airmet for occasional i f r conditions is in effect right just to that vicinity from there westward and southward they'll probably move it eastward to cover at least central north carolina at ten a m when the new terminals or the new ah ah airmets will be issued um and ah also turbulence a factor ah west of the mountains and that will probably move eastward as well with moderate turbulence below twelve thousand feet forecasted now that is all in response to an intense low pressure center rotating just in the central part of the country ah with ah fronts extending south and eastward from there ah down into ah oh as far east as western tennessee and mississippi and then off shore it looks like the cold front and from arkansas eastward across virginia then really a stationary front that's going to put most of north carolina in a warm zone in advance of that cold front ah so we'll see an increased chance of rain rain

showers as the day progresses but it's a very slow mover ah so you know i think it will impact operations over the next couple of days but very slow making its appearance in north carolina now manteo reporting wind zero five zero at five knots the visibility ten miles with a ceiling at five thousand broken sixty five hundred overcast temperature twelve dew point nine now i don't see any pilot reports at this time now the forecast for eastern north carolina is for um four thousand to five thousand broken tops at seven thousand higher scattered to broken cirrus that's through four p m this afternoon in the mid part of the state by that time you'll see twenty five hundred overcast layered to thirty four thousand feet with occasional light rain and for around the destination ah it looks like the forecast is for ah four thousand to five thousand overcast layered to thirty four thousand feet occasional visibility three miles to five miles in light rain and mist the outlook for later today is for i f r continuing and a chance of thunderstorms as well now the winds aloft today if we look at six thousand feet starting out at two seventy at about twenty knots at raleigh two fifty at fifteen and around the destination two hundred at about eighteen knots temperature ten degrees celsius now checking notices to airmen currently in effect i don't see anything effecting operations at ah manteo and at the destination just an unlit tower not very tall and well away from the airport and enroute why it looks like navaids are all operating as published at this time and there are no t f rs in effect across that route at this time
