### SERVICE BULLETIN

#### B. Reason

This Service Bulletin is being issued because Raytheon Aircraft Company (RAC) has received two (2) reports of tire disintegration during takeoff in which pieces of tire struck the main landing gear retraction jack, resulting in separation of the servo block from the cylinder. Separation of the servo block resulted in loss of normal and emergency hydraulic pressure. This Service Bulletin is being issued to install main landing gear jack P/N AIR48502-7 and P/N AIR48503-7 with improved servo block mounting for improved resistance to tire debris.

#### C. Description

This Service Bulletin provides instructions for replacing the existing main landing gear retraction jacks with P/N AIR48502-7 and P/N AIR48503-7.

#### D. Compliance

Raytheon Aircraft Company recommends that this Service Bulletin be accomplished at the next retraction jack overhaul or replacement.

#### NOTE

APPH LTD has Service Bulletins to upgrade Main Landing Gear jacks to AIR48502-7 and AIR48503-7.

#### E. Approval

- (2) Refer to Aircraft Maintenance Manual (AMM) Chapter 32-30 and accomplish the following:
  - (a) Remove the existing left hand and right hand main landing gear jacks as detailed.
  - (b) Install the new left hand main landing gear jack P/N AIR48502-7 and the new right hand main landing gear jack P/N AIR48503-7 as detailed.
- (3) Reconnect the airplane batteries, remove warning notices and restore power.
- (4) Ensure all work areas are clean and clear of tools and miscellaneous items of equipment.
- (5) Return airplane to service.
