1 INTERVIEW

- (11:40 a.m.)
- MR. BRAGG: Today's date is February 5th. The time is
- 4 11:40 a.m. My name is Kenneth Bragg. I'm a human performance
- 5 investigator with the NTSB. We're going to start off, do an
- 6 introduction. We'll start to my right.
- Would you please state your name, spell your last name,
- 8 and your organization?
- 9 MS. KIRSCH: Anne Kirsch, K-i-r-s-c-h, with MTA Metro-
- 10 North Railroad. I'm the chief safety officer.
- 11 MR. GREEN: Richard Green, I'm a chief inspector with
- 12 the Federal Railroad Administration.
- MR. BRAGG: And state your name.
- MR. HOPE: Richard Hope. I live in Yorktown Heights.
- MR. RIZZITELLI: John Rizzitelli, R-i-z-z-i-t-e-l-l-i.
- 16 detective sergeant, MTA police.
- MR. CONNOLLY: Sean Connolly, C-o-n-n-o-l-l-y,
- 18 detective, MTA police.
- DR. BARTH: Tom Barth, I'm a survival factors
- 20 investigator, B-a-r-t-h.
- 21 INTERVIEW OF RICHARD HOPE
- BY MR. BRAGG:
- Q. Okay. Mr. Hope, let's go ahead and start off. I'm just
- 24 going, go ahead and let you describe for us what you witnessed and
- 25 we'll begin there.

- 1 A. Okay. Because of the accident on the parkway, I was
- 2 taking a avoidance route, if you will, down, and ended up coming
- 3 through the cemetery. And after I crossed -- I think it was
- 4 Lakeview or Lakeside, to start heading down towards the train
- 5 crossing, and then I was going to get on the Taconic Parkway
- 6 northbound.
- 7 And as I came down, the traffic -- it seems like other
- 8 people were doing the same thing that I was doing, and the traffic
- 9 was very slow. And I got to the point -- it got slow right at
- 10 the -- around the bend. And I was just -- we were just inching
- 11 along, and before -- I'm just inching along, nothing out of the
- 12 ordinary, and then all -- the lights started flashing for the
- 13 train crossing and the arm came down on the car in front of me.
- 14 It was a black Mercedes. And it came down and it hit the top of
- 15 the car at the very back of the roof. It almost bounced off the
- 16 top and then slipped down a little bit so it was maybe -- I mean,
- 17 it's on an angle now. So on one side it was probably a foot and a
- 18 half down and the other side it might have been -- you know, at
- 19 that point, it was coming out over the top of the roof. So it
- 20 never went horizontal. It was still always that way.
- So sensing what's going on, I look in my rearview
- 22 mirror. There's nobody behind me, so I immediately back up.
- 23 Because I'm assuming she's going to -- I don't know at the time it
- 24 was a she. I figured that car was going to back up. So I back up
- 25 a good car length and I'm waiting for that car to back up, and a

- 1 woman gets out of the car and walks to the back, looks at the arm,
- 2 goes to the arm, touches it, never tries to move it. It was just
- 3 a very soft kind of touch, almost -- I don't know, maybe to see
- 4 what it was or how hard was it against the truck. I don't know.
- 5 But she just kind of did this for a second, and then as she turned
- 6 back, she turned and looked at me.
- 7 And I'm -- and now I'm waiting like, you better do
- 8 something. I'm waiting, and so I go -- I went and I kind of go
- 9 like this, just real quick, and I -- and I was still in reverse,
- 10 so I went back more. While I went back, I was waving. Kind of
- 11 the indication was, you know, do what I'm doing; I'm going back,
- 12 you need to come back. And what I meant -- I wasn't thinking
- 13 enough, I just think -- sorry.
- 14 Q. It's okay. Take your time.
- 15 A. The worst part is looking at me. And so, you know, part
- 16 of me -- but I knew that she wasn't on the train tracks. I knew
- 17 that she -- at least from what I could see, she was parked and --
- 18 and she gets out and -- I know I said before that she was calm,
- 19 but she was probably calm because she wasn't on the tracks. The
- 20 front of the car seemed to me like just barely making it.
- 21 And I'm thinking to myself, well, just walk away from
- 22 the car and then, you know, get back if it's -- and so anyway,
- 23 back -- I wave to her. I'm backing up. She just kind of keeps
- 24 spinning around that way. Like she turned towards me, just kind
- 25 of looked at me. And then I did that, and then she turns around

- 1 and gets back in the car. I said, okay, she's coming back. She's
- 2 going to come back any minute. I'm thinking the arm's going to
- 3 break, and I remember in my mind, I'm saying, okay, the arm's
- 4 going to break and hopefully won't hit my car, but --
- 5 And then, there was a slight pause. She gets in the
- 6 car, a slight pause, and then she just moves forward. And she
- 7 moves forward the length of the car, and at that instant, the
- 8 train came and hit her.
- 9 And the proximity of the vision that I could see from
- 10 where I was, it wasn't like here comes the train. I see the
- 11 train, it's coming, and you're -- you know, you're running out --
- 12 it was just instantaneous (snaps fingers). There was no time at
- 13 all. And I don't know what she could see. I know what I could
- 14 see, and there -- it was just -- I don't even know, I didn't go
- 15 back to look, but something was -- all I know, you know, I see 15
- 16 feet of the train when it hit her car and it was just
- 17 instantaneous. And the car, it just took the car right away. It
- 18 was gone.
- 19 Q. So did you witness her driving onto the track?
- 20 A. Yes.
- Q. Let me back up. Did you witness her approach the
- 22 crossing?
- 23 A. Yes, because I was behind her.
- 24 Q. And was there traffic directly in front of her?
- 25 A. Couldn't see.

- 1 Q. You couldn't see? Okay.
- 2 A. Because it's around a bend and her car was big. It was
- 3 a -- you know, and it was dark. It was really dark. So I didn't
- 4 notice that or I wasn't paying attention. I don't know. I just
- 5 don't know.
- One would assume the way the car was, the cars were
- 7 backed up, that that light -- I'm very familiar with the light
- 8 because I travel that road every day. But I'm sure the car -- I
- 9 mean, because it was all the traffic backed up.
- 10 Q. So you just couldn't see what was directly in front of
- 11 her?
- 12 A. But I don't.
- Q. Okay. And when you -- when she approached the crossing,
- 14 you were directly behind her; is that correct?
- 15 A. Correct.
- Q. And how fast were you traveling? Were you inching
- 17 along, was it --
- 18 A. Five -- yeah, inching along.
- 19 Q. Okay.
- 20 A. Correct.
- Q. When she got out of the car, were you aware at that time
- 22 that the train was coming?
- 23 A. Yes. Because the gate was down.
- Q. Okay. So you were aware that the gate was down and the
- 25 bells are going and the lights are going, but could you tell a

- 1 train was actually coming?
- 2 A. I can't -- I couldn't see down the tracks.
- 3 Q. Okay. Could you hear a train horn?
- 4 A. No.
- 5 Q. At any time, did you hear the train horn?
- 6 A. Um --
- 7 UNIDENTIFIED SPEAKER: I'm sorry, what was that answer?
- 8 MR. HOPE: No.
- 9 UNIDENTIFIED SPEAKER: No.
- MR. HOPE: But that -- to be honest with you, I don't --
- 11 I didn't hear the dinging either.
- 12 BY MR. BRAGG:
- Q. So you didn't --
- A. But I wasn't paying attention to that aspect of it, and
- 15 so --
- 16 Q. So at that point, you were in your car?
- 17 A. Yes.
- 18 Q. And I assume, because it's winter, your windows were up?
- 19 A. Actually, I had my window open a little bit, because I
- 20 remember when I started out, I was thinking that she's going to
- 21 turn -- I'm thinking she's going to turn and walk towards me. And
- 22 I remember that I was, that I -- I had to get the window open more
- 23 to say come here. But I didn't -- it didn't work.
- Q. So, and it was the driver --
- 25 A. It was open like this much -- driver's window was open

- 1 this much.
- 2 Only the driver's window?
- 3 A. Only the driver's.
- Q. So when did you first become aware of the train itself?
- 5 Was it when it struck the car?
- 6 A. Yeah, right then.
- 7 Q. Okay. When she got out of the car, what was her
- 8 demeanor? Did she seem hurried, was she panicked, or was she --
- 9 A. She was not hurried at all.
- 10 Q. So, in your --
- 11 A. Which caught me -- like, you got to hurry up. You got
- 12 to hurry up because this is coming -- it's coming. I don't know
- 13 how long, but it's coming and, you know, and I know it's not a
- 14 real long time. And yeah, it was -- I didn't even have time to
- 15 panic, but I said -- I think part of me was that it was going
- 16 to go by and it was going to be really close. But I thought that
- 17 that -- I never in my -- thought that that would -- you know, I
- 18 just assumed she was going to back up. I just -- that's all I
- 19 did.
- 20 Q. Was there anything unusual about her appearance? I
- 21 mean, did she appear to be under an influence?
- A. Absolutely not.
- Q. Was she staggering, was she --
- A. Not at all.
- Q. -- falling down, anything like that? In your opinion,

- 1 was she aware of the train? Not necessarily the crossing gate
- 2 coming down -- I mean, we can assume she got out of the car
- 3 because of that, but was she aware that an actual train was
- 4 coming?
- 5 A. I don't know.
- 6 Q. Okay. And did she seem panicked at all?
- 7 A. No.
- 8 Q. Did she --
- 9 A. She didn't look -- she looked -- she turned around, she
- 10 looked at me, and like I said, that was that brief gesture -- no
- 11 gesture, just that brief contact that I made with her. And then
- 12 she just turned around and got right back in the car and didn't,
- 13 you know, look down the tracks or up the tracks. And I don't know
- 14 whether she -- what would -- that was -- I don't know where she
- 15 was looking.
- If I can go back to where the gate, when she touched it,
- 17 it was almost like she was touching to see if it was on the --
- 18 like touching the truck kind of thing. More of a not can I move
- 19 it; more of a -- I don't know, is there room to back up type of --
- 20 you know, is it touching it; is it not touching it? That's kind
- 21 of the way it was --
- 22 Q. So did she seem maybe she was concerned with whether or
- 23 not the gate damaged her vehicle? Is that -- was that her focus?
- A. I -- no, I don't know.
- Q. You don't know, okay.

- 1 A. Maybe she was concerned that she didn't want to damage
- 2 the gate by backing up.
- 3 Q. Okay.
- A. Because she absolutely would have broken it. And that
- 5 was something I'm thinking of.
- 6 Q. So at the -- at that point, the gate --
- 7 A. Of course, I had too much time to think --
- 8 Q. -- the gate was touching her vehicle, but it was more
- 9 touching the back of the --
- 10 A. Touching the back.
- 11 Q. Not the top?
- 12 A. Not the top.
- 13 Q. The back, okay.
- 14 A. It was against the back window.
- 15 Q. Okay.
- 16 A. On an angle.
- 17 Q. All right. So, after -- and after the train impacted
- 18 the vehicle, what did you see?
- 19 A. The train, the train just came to a stop and -- like,
- 20 there was no -- well, let me back up a little bit. Like who ran
- 21 up to me and stuff like that?
- 22 O. Yes.
- 23 A. When -- so the train hits the car. I'm still in my car
- 24 and I'm just in utter shock, and -- I know that I sat in the car
- 25 for, you know, a second or two, because then I got out and I

- 1 remember turning around because now there's cars behind me. So I
- 2 turn around to the cars behind me and I go like this. And I go
- 3 like, what did she do? She did this, you know.
- And so, I'm just like this, and the guy's running up to me,
- 5 the second guy -- the first guy runs up to me and he goes, you
- 6 know, the same kind of disbelief. And then the third guy was --
- 7 he was already on his cell phone. He was calling, and I heard him
- 8 -- what he was doing; he was calling it in. And then he said that
- 9 he was an off-duty policeman, and he -- and that -- and I know he
- 10 was talking to people.
- And then we were trying to converse where we were. He
- 12 was trying to relay where we were. He was trying to relay where
- 13 we were, Commerce -- we saw the sign there and we -- you know,
- 14 Commerce Street. And just kind of, you know, bantered back and
- 15 forth. And the train stopped right at the end of the -- the train
- 16 was right at the crossing. And the people in the car seemed
- 17 unaware of anything. I mean, they just --
- 18 Q. People in what car?
- 19 A. In the train car. Sorry.
- 20 Q. Okay.
- DR. BARTH: When you say the end of the train car, you
- 22 mean the back end of the train car stopped at the crossing?
- MR. HOPE: Right. The last car, right. It was the end
- 24 of the train, so, you know. Actually I walked around the back of
- 25 the train at one point without leaving the -- because leaving the

- 1 crossing, you know, where the -- where there's no third rail.
- 2 So he was, he was on the phone, he called it in, and
- 3 then the conductor stuck his head out. You know, we couldn't talk
- 4 to the people in the train because of the windows are sealed. And
- 5 then someone opened -- I guess it was the conductor -- opened --
- 6 there was a little window in the back. He opened, slides the
- 7 window open, and says, where are we? And so, we're saying,
- 8 Commerce Street, Commerce Street. Then I read him the ID number
- 9 on the crossing. I said, do you want the ID number? You want the
- 10 ID number? And so then he got that.
- 11 And then we just kind of waited then. It was nothing --
- 12 we commented -- I remember the guy making a comment that there was
- 13 no parts of the car there that we could -- you know, it was dark,
- 14 but we still said there's nothing -- there's not even any pieces
- 15 of the car here. It's just gone. The whole -- I mean, it was
- 16 dead center right on that car.
- 17 BY MR. BRAGG:
- 18 Q. And you didn't call -- you didn't call 911, but you were
- 19 aware that someone had called 911?
- A. Absolutely.
- Q. And how long did it take someone to respond? And
- 22 it's certainly understandable if you --
- 23 A. Yeah.
- 24 Q. -- if you're, you know, if you're unaware.
- 25 A. It's hard to gauge, I mean, but, you know, 5 minutes --

- 1 Q. 5 minutes.
- 2 A. -- 3 minutes.
- 3 Q. And which -- from which direction did they respond? Did
- 4 they respond from behind you?
- 5 A. Yes, they came down Commerce.
- Q. Okay.
- 7 BY UNIDENTIFIED SPEAKER:
- 8 Q. What were the -- can you describe what you remember
- 9 about first response, what type of vehicles, how they entered?
- 10 A. It was police cars, at least two police cars. We were
- 11 in the -- in our lane, our proper lane. So they came down, you
- 12 know, the opposite lane on the other side and they parked next to
- 13 where we were. And they got out, and I remember them saying to
- 14 each other that we can't walk down -- you know, and I -- you know,
- 15 we quickly said this, and they said, well, we can't -- don't walk
- 16 down there, there's probably -- we don't walk down there until we
- 17 get confirmation that the third rail is off.
- 18 So they just stood around with us while they were
- 19 waiting. Because that was when I walked around the back of the
- 20 train and they yelled at me for the third rail. And I said, no,
- 21 the third rail -- this is a crossing, there is no third rail. And
- 22 of course, then I -- it came to me that, oh, yeah, it can hit the
- 23 train rail and -- so I quickly got off. But, you know, they were
- 24 good in that respect.
- Q. Do you remember any other types of emergency vehicles,

- 1 besides the police?
- 2 A. Well, then, the police were there for a little while
- 3 and, you know, it was more of a -- then the people -- if I can
- 4 just comment in what I saw? The people in the train car just were
- 5 kind of looking out the window at us and we're going, you know,
- 6 like this, why'd she go? And I'm -- she didn't have -- why did
- 7 she go? And we're doing this, but they can't hear anything. But
- 8 they're just kind of looking, and they're looking and then all of
- 9 a sudden, they're figuring out that there's a lot of people
- 10 outside and now they're paying more attention out the window.
- And so then they made an announcement on the train that
- 12 some -- I couldn't make out the first announcement, but I made the
- 13 second one, that a policeman would be coming through the train,
- 14 and tell him if you're injured, or something to that effect. Tell
- 15 the police officer if you're injured.
- So -- but I remember mouthing to the guy, he was kind of
- 17 looking out -- there was one guy, you know, on that same height
- 18 almost. And I said, the train hit a car. And then he goes, oh,
- 19 okay, like, okay. And then that's all I -- that was my -- and now
- 20 -- whatever time that took, I don't know, but now the fire truck
- 21 came, at least one fire truck -- one or two, came down and on the
- 22 same side of the street. And --
- 23 Q. They approached the same way --
- 24 A. Well --
- 25 Q. -- that the police did?

- 1 A. Well, let me back up one second. Before I noticed that
- 2 the fire trucks were there, we looked down the -- to the front of
- 3 the train, and now is the first time we saw fire. Because we said
- 4 to ourselves, that the -- look, the car is on fire. Never
- 5 imagining what really happened, but we just thought the car was on
- 6 fire, and it looked to us like a small fire. It was quite a
- 7 distance, and I think that maybe it was a little bend, I don't
- 8 know. But that's what we saw.
- 9 And then almost simultaneously, the fire department came
- 10 and they started accessing the same thing, and I remember the
- 11 policeman saying, we don't have confirmation that the third rail's
- 12 off yet. So they kind of waited and the police -- the off-duty
- 13 officer went to one of the police officers and said that he saw
- 14 everything, he's an off-duty cop, and he could do a deposition,
- 15 and he could do this and that, and do you want his name, and so he
- 16 took his name. And then I saw who he talked to, so I went over
- 17 and told him that I was the car right behind, do you want my name?
- 18 And he said, okay, I'll take your name. So, he took my name and
- 19 then he said there's going to be a lot of vehicles coming here, if
- 20 you want to get out of here, you better get out. So, we all
- 21 turned -- got in our cars and left.
- Q. Did you see any passengers of the train exit the train
- 23 or did they all remain on?
- A. They all remained on.
- Q. Could you hear -- so you saw at least one fire truck

- 1 approach the same direction as the police. On the other side of
- 2 the road, could you tell anything about activity on the other side
- 3 of the road, other vehicles coming in from that side, or was it
- 4 not able to understand what was happening on that side?
- 5 A. No, I know that the firemen had a discussion on our side
- 6 saying that they had to get to the other side. So I think they
- 7 were thinking about either relocating the rigs that they had there
- 8 or they were making a call in to tell them, you know, don't come
- 9 down this side because it won't do you any good. And that -- but
- 10 I remember that logistically, you know, and I said, yeah, that
- 11 makes sense. So that -- I don't know what was happening over
- 12 there, but it wasn't like anybody arrived over there and walked
- 13 over to us from the other side, so --
- 14 Q. So the end of the train was blocking the road? You
- 15 couldn't get a vehicle around there, so --
- 16 A. They could not. That's correct. Just barely with
- 17 the -- you know where it ended up, but the very end of it was
- 18 right at the --
- 19 BY MR. BRAGG:
- 20 Q. I have a question about the point where she was standing
- 21 outside the vehicle and she entered the vehicle. How long did it
- 22 take her to move the vehicle once she entered the vehicle? I
- 23 mean, did she jump in and just immediately drive off?
- A. No, there was -- it was almost like she was putting on
- 25 her seatbelt.

- 1 Q. Okay.
- A. I mean, that much time. I mean, you get in and you say
- 3 -- and especially me, I'm a little anxious. Like okay, okay,
- 4 she's coming back, she's coming back, you know. And it struck me
- 5 that, okay, come on, come on, come on; how come you're not coming?
- 6 And then boom. So there was a little pause in there and -- I
- 7 mean, again, I think about it too much now, but putting on her
- 8 seatbelt, just instinct.
- 9 Q. Could you -- how clearly could you see her when she got
- 10 back in the car? I mean, could you clearly see which way she was
- 11 looking?
- 12 A. No. No, you couldn't.
- 13 BY UNIDENTIFIED SPEAKER:
- Q. Oh, and I -- if I could ask, so you gave your name and
- 15 they said, look, if you want to -- you know, unless you want to be
- 16 stuck here, you can leave. So, you then left. Did you -- before
- 17 that, before you left, can you estimate the number of police cars
- 18 and fire or -- and other EMS or first response vehicles that you
- 19 saw, fire -- when you're leaving or, you know, or when you're --
- 20 A. If I'm estimating, I'm estimating four police officers,
- 21 two cars; and one fire truck, and some firemen I didn't, I don't
- 22 know.
- Q. And when you were driving away from the scene, did you
- 24 see if there were any more vehicles coming in as you drove away,
- 25 or --

- 1 A. Yeah, but none on -- I drove up the same road I came, I
- 2 made a left on Lakeside or Lakeview, whatever it's called, and
- 3 crossed over to Taconic and went up that road. And on that road,
- 4 I noticed emergency vehicles going down. And what struck me was
- 5 -- I was actually on the phone with my wife and I said, there's
- 6 lots of ambulances going down the hill, I don't know why you would
- 7 need more than one, just in my own stupid thought that people
- 8 don't normally get hurt when a car -- obviously person, occupant.
- 9 But I said I didn't think -- I just thought it was a precautionary
- 10 thing, but I said, there's a lot of vehicles going down --
- 11 O. Yeah.
- 12 A. -- for one injury, is literally what I said.
- 13 Q. And do you remember what time it was or approximate time
- 14 frame between, you know, the time the accident happened and the
- 15 time that you left? It's hard to estimate.
- 16 A. It is, it's very hard. And usually I'm good at that,
- 17 but -- 15 minutes?
- 18 Q. Okay.
- 19 A. Because it was a long time that no one was there, it was
- 20 just us, me and the other two guys.
- 21 Q. Right.
- 22 A. You know, and waiting, and then they came. And I -- it
- 23 would be interesting to know what that actual time was,
- 24 (indiscernible).
- 25 Q. Okay. Is there any -- is there anything they --

- 1 A. The car was not stopping any way, shape, or form. I
- 2 mean, you know, when she stepped -- when she went forward, the
- 3 tires didn't spin, nobody was stuck anywhere like that. There
- 4 was --
- 5 BY MR. BRAGG:
- 6 Q. And so the car was moving, actually moving forward when
- 7 it was struck --
- 8 A. Absolutely.
- 9 Q. -- is that correct? Okay.
- 10 A. It was in the process. You know, it was -- you know,
- 11 you can think faster. I said, she's trying to get across, you
- 12 know, she's trying to get across. And then right -- her car was
- 13 moving and it was -- had gone that 15, 16 feet, whatever that
- 14 distance is. And right -- it was -- you know, it's a millisecond
- 15 that -- but no, she was moving it and didn't hesitate. Once she
- 16 started moving, she went. And I was there; I saw everything, what
- 17 it looked like. It wasn't -- I just read that, that's why I'm
- 18 telling you that. She wasn't stuck on the tracks.
- 19 MR. BRAGG: Okay. Detectives, do you have anything you
- 20 want to ask?
- 21 BY UNIDENTIFIED SPEAKER:
- 22 Q. Just one thing. When you talk about when you saw the
- 23 crossing lights flash and you said you didn't hear, you know, the
- 24 bells, did you have the radio on in the car?
- 25 A. Probably.

- 1 Q. Okay.
- 2 A. Yeah.
- 3 Q. That's -- I just wanted to (indiscernible) --
- A. Yeah, I don't want you to interpret that I absolutely
- 5 listened for them and I didn't hear it.
- Q. No, no, that's what I'm saying, that's usually the case
- 7 a lot of times, people are listening to music or something, you
- 8 know --
- 9 A. I usually (indiscernible). Because those bells, the --
- 10 I didn't hear anything, but I don't remember any sound --
- 11 Q. Okay.
- 12 A. -- you know, just because my mind's processing what's in
- 13 front of me maybe and I blocked that out, but yeah, I didn't --
- 14 BY UNIDENTIFIED SPEAKER:
- 15 Q. Would you recall if you heard the train horn at all
- 16 (indiscernible)? You don't recall that?
- 17 A. But I wasn't listening for that.
- 18 Q. Yeah.
- 19 A. I wasn't -- I can't even tell if the radio was on
- 20 because I don't remember. I -- the hearing part just didn't
- 21 register. But it was just -- and if I'm the engineer, as fast as
- 22 he was coming, I would imagine he would see the tracks clear,
- 23 because that's how fast she came across. She came across and then
- 24 he was there. It was that -- you know what I mean, it's almost
- 25 like if you're driving your car and somebody steps in front of

- 1 you, you don't have time to react. Well, he would -- if even, and
- 2 I know you're going to talk to him, that's the only reason I'm
- 3 saying, but he did not -- if he saw -- the tracks would have been
- 4 clear and there's a car like right on the edge.
- 5 And I remember looking, saying how close, and I'm sure
- 6 you guys measured and everything, but she -- it was so close to --
- 7 I think she came up -- I think we were just inching along -- and
- 8 you know what, I'm pretty aware of my situation. I really am. I
- 9 mean, I knew what kind of car that was before anybody else. You
- 10 know, they even printed that was a Cherokee and it wasn't. And I
- 11 said right away it was a Mercedes. I'm aware -- and even I wasn't
- 12 aware I was that close to those crossing gates. Because I'm right
- 13 behind -- I'm where she should have been, and it struck me as,
- 14 wow, I'm that close? And then, oh, yeah, you know.
- And so, I don't know if because I was driving slow and
- 16 we were just inching along and -- or I didn't expect it, but it
- 17 was dark and that's -- that's what sticks out now, that I didn't
- 18 think I was that close to the tracks. So I'm thinking -- she's
- 19 inching along and then as she came up, then she saw the tracks and
- 20 she stopped. But I didn't see her stop short, I have to admit,
- 21 you know. But that she stopped and she -- where she stopped tells
- 22 me that, uh-oh, train tracks, stop. And then -- and it was like
- 23 at the same time that the gates are coming down, so --
- 24 But it could have been -- I think that could have been
- 25 me up in there. And I would have went through the gate, but it

- 1 was just that kind of situation where because you were inching
- 2 slow and wasn't -- I wasn't paying attention. Normally, I do. So
- 3 I don't know if the way it was -- it was just dark, too dark for
- 4 me, or --
- 5 BY MR. BRAGG:
- 6 Q. Do you -- and here's the question that I have in my
- 7 mind. I don't -- I'm not sure why she would have stopped where
- 8 she was at when the gate hit her car. I'm not sure if there was a
- 9 car in front of her or what caused her to stop right there?
- 10 A. I mean, I can't tell, because I saw -- but the cars --
- 11 there was absolutely cars in front of her. I mean, that's why
- 12 everybody was going -- that's why everybody was going slow.
- Now, whether -- I actually -- I remember thinking for a
- 14 split second, when I said, oh, I'm here, and I said, is there a
- 15 car on the tracks? Because I didn't think she was, but I said she
- 16 can't go forward because there's a car in front of her. I think
- 17 -- I thought that to myself. And maybe she would have been
- 18 following along when it -- but then she -- that's what I was
- 19 thinking to myself, go forward. And I said, oh, maybe there's
- 20 somebody in front of her. Holy cow, somebody's on -- you know,
- 21 and then she gets out, and then all the other stuff happened.
- 22 Q. Is her car completely stopped when the gate hit it?
- 23 A. Yes.
- Q. And so it didn't hit it as she was inching forward --
- 25 A. No.

- 1 Q. -- it was completely stopped? Okay.
- 2 A. No, because, because what I -- I mean, at least from my
- 3 proximity, I mean, I guess, like I said, the way the gate hit the
- 4 car -- can we use this? The way the gate hit the car like this
- 5 and then slipped down, could she have been inching forward and
- 6 that's why it slipped down? I don't know. Maybe it's just the
- 7 way the -- maybe -- I don't know how much pressure the gate had,
- 8 but it was right at the edge, and then it slipped, and then it
- 9 almost went -- it didn't go all the way down because it was
- 10 rubbing against the car.
- 11 Q. Okay.
- 12 A. So, I mean, that would be a speculation that I don't
- 13 know.
- 14 Q. Okay.
- UNIDENTIFIED SPEAKER: Do you guys have any questions?
- MS. KIRSCH: Yes. Just a few, if you don't mind.
- 17 BY MS. KIRSCH:
- 18 Q. So when you describe that, so that was the passenger
- 19 side gate arm that came down on her car?
- 20 A. Correct.
- Q. Okay. When you came around the corner, did you see the
- 22 lights flashing first and then the --
- 23 A. No.
- Q. Only when you got there?
- 25 A. Only when I was stopped.

- 1 Q. Okay.
- 2 A. I'm stopped and I'm just waiting, and then all of a
- 3 sudden, the gate started coming down.
- 4 Q. But she was stopped first?
- 5 A. Yes.
- 6 Q. And you saw the lights and then the gates came down?
- 7 A. I don't know. The first thing I saw was the gate coming
- 8 down.
- 9 Q. Okay.
- 10 A. Because it has the flashing lights on it. And the gate
- 11 came down and hit her car. I mean, did I look up at the other
- 12 lights? No, I didn't look -- I didn't notice them, but I didn't
- 13 look for them either.
- 14 Q. Okay.
- 15 A. I was too -- now I'm concentrating on the gate, holy
- 16 cow, it's going to hit her car. It hit her car, now what? Now, I
- 17 said, okay, back up. So that was just my mindset. I wasn't
- 18 looking for the other lights. I don't --
- 19 MR. BRAGG: And you didn't hear the bells either?
- MR. HOPE: No.
- 21 BY UNIDENTIFIED SPEAKER:
- 22 Q. And that was -- that -- what was your very first
- 23 recollection of -- or acknowledgment, oh, there is -- you know,
- 24 that there is a train coming or the gates are coming down? Was it
- 25 while you were still inching forward? Like how far would you

- 1 estimate you were from the -- your final -- you know, from the
- 2 actual gates that you first noticed that something was happening
- 3 with the signal crossing?
- 4 A. How close was I --
- 5 Q. Like when you --
- 6 A. -- to her car or to where the gate --
- 7 Q. No, no, on the road. Where were you on the road when
- 8 you first noticed that the crossing's becoming active? Were you
- 9 already basically watching her at the intersection or were you
- 10 approaching the intersection?
- 11 A. No, I was stopped.
- 12 Q. Okay.
- 13 A. I was stopped. She was stopped. In my mind, because I
- 14 -- yeah, I stopped and then we're just sitting, waiting for a
- 15 second or two and then the gate came down.
- 16 Q. Okay.
- 17 MS. KIRSCH: When she got out of the car to look at the
- 18 gate arm, did she go behind the car or in front of the car --
- 19 MR. HOPE: She got out the driver's door, walked down
- 20 that side of the car, and went to the back and looked at it, and
- 21 then that's when she spun, looked at me, turned around, and got
- 22 back in the car on the same side.
- MR. BRAGG: But you guys never had any conversation,
- 24 correct?
- MR. HOPE: No.

- 1 BY MS. KIRSCH:
- 2 Q. So it came down behind the car or in front of the car,
- 3 her gate -- the gate arm when it came down on her car?
- 4 A. Behind the car.
- 5 Q. So she was -- she was still moving when that happened
- 6 and the gate came down --
- 7 A. No.
- 8 Q. -- or she was stopped?
- 9 A. She was sitting right in the crossing.
- 10 Q. So she was stopped in the crossing when the gate arm
- 11 came down?
- 12 A. She was stopped in front of the arm, right.
- 13 Q. Okay.
- 14 A. But in front of the tracks.
- 15 Q. Okay.
- A. But it's on an angle, so on her side --
- 17 Q. Yeah.
- 18 A. -- when she gets out, it might look like more room than
- 19 what she really had. My two cents.
- 20 UNIDENTIFIED SPEAKER: I just had a quick question, more
- 21 or less about your experience. Do you travel those roads often
- 22 where you cross those tracks and use those crossings?
- MR. HOPE: No.
- 24 UNIDENTIFIED SPEAKER: You don't do that on a normal
- 25 basis?

- 1 MR. HOPE: No. It was only because of the backup on the
- 2 parkway.
- 3 UNIDENTIFIED SPEAKER: Oh, so you -- so the reason you
- 4 took this route this was because you were trying an alternative
- 5 route instead?
- 6 MR. HOPE: I'm familiar with the route, but I know that
- 7 when the parkway's backed up, you can cut through this road.
- 8 UNIDENTIFIED SPEAKER: Okay.
- 9 MR. HOPE: And it's not very well-known, but usually it
- 10 works out, you know.
- 11 BY MR. BRAGG:
- 12 Q. So how much traffic was on the road when you turned on
- 13 it?
- 14 A. On this road?
- 15 O. Yes.
- 16 A. On Commerce?
- 17 Q. Yes.
- 18 A. Coming towards me, the other way, it was all backed up
- 19 from I think it's Legion Drive, pretty far back because I remember
- 20 how slow I was going because between the snowplows and the cars, I
- 21 was maneuvering very slowly to go down. But it opened up quite a
- 22 bit at Lakeview, Lakeside, and then going down the hill, which is
- 23 surprising to me now that I have -- be able to look back, that
- there wasn't anybody behind me initially.
- Q. Okay. And that's how you were able to back up.

- 1 A. You know, that I was able to back up, and I'm thankful
- 2 for that because I would feel guilty if I --
- 3 BY UNIDENTIFIED SPEAKER:
- 4 Q. So did you -- so how -- you hadn't taken this
- 5 alternative route very often. Like, how many times would you
- 6 estimate you've gone through this intersection before or drove
- 7 over this crossing?
- 8 A. Once.
- 9 Q. Oh, this is your first time?
- 10 A. You would -- normally, because the accident was at
- 11 Lakeview, Lakeside -- does anyone know the real name?
- 12 UNIDENTIFIED SPEAKER: Lakeview.
- 13 MS. KIRSCH: Lakeview.
- MR. HOPE: Lakeview. Lakeview. At Lakeview, normally
- 15 that's where you would get off to make the shortcut.
- 16 UNIDENTIFIED SPEAKER: Okay.
- MR. HOPE: But because the accident was at Lakeview,
- 18 then -- and I didn't know when I was coming, I thought -- I've
- 19 always gone to Lakeview. I've never gone this way before because
- 20 I was able to get back on at Lakeview, so I never took that extra
- 21 -- this one, I looked down at Lakeview and I said, there's the
- 22 mess. And I said I think I can go straight, I'm pretty sure I
- 23 can. And so, I did, and that's -- I really do think that's the
- 24 only time I ever went that way on that road.
- UNIDENTIFIED SPEAKER: Okay.

- 1 BY UNIDENTIFIED SPEAKER:
- 2 Q. I'm just trying to get it clear, you were on the Bronx
- 3 River Parkway?
- 4 A. It's the -- no, I didn't get on any parkway.
- 5 Q. Well -- well, where was the accident that --
- 6 A. The Taconic Parkway.
- 7 Q. So --
- 8 A. I called -- I used to call it the Bronx River too, but
- 9 it's a part of the highway there --
- 10 Q. Well, I know that there's two.
- 11 A. Yeah.
- 12 Q. So you were on the Taconic?
- 13 A. No. All right, you want to know how I got there?
- 14 Q. Yeah. How did you get there?
- 15 A. I left work. I work in downtown White Plains.
- 16 Q. Yeah.
- 17 A. I got on the Bronx River Parkway going north. I got to
- 18 Kensico Dam and saw that it was all backed up. There's a loop
- 19 there, a circle there.
- 20 Q. Um-hum.
- 21 A. I went through, I started to go around the circle, I see
- 22 it's all backed up over there. Everything's backed up, even the
- 23 side roads in Valhalla. So I continued around the loop, went back
- 24 south on Bronx River Parkway, got off the first exit at Virginia
- 25 Road, made a right on Virginia Road, went up Virginia Road, merged

- 1 into whatever road that is, and going up by Westchester Community
- 2 College. Because I'll cut across -- going that way, I can go up,
- 3 over, and get on the Sprain over by 100 C or whatever, 100.
- 4 Q. Right.
- 5 A. So I get up there. The hill's all backed up. I turn
- 6 into Westchester Community College, turn around, come out, and go
- 7 back down, go back down, turn left on Legion Drive, make a left
- 8 through the cemetery.
- 9 Q. Right. And it was backed up on the Taconic?
- 10 A. Yes.
- 11 Q. And so Lakeview was closed or it was just backed up?
- 12 A. Lakeview was closed.
- 13 Q. It was closed. Okay. So that's what forced you to go
- 14 through the cemetery to go into Commerce?
- 15 A. No. I'm on Legion. Legion is further down. Legion,
- 16 turn left onto Commerce, Commerce winds through, then crosses
- 17 Lakeview, and then merges into -- and then crosses the Taconic
- 18 there. And that's where I was going to go.
- 19 Q. Okay.
- MR. BRAGG: Okay, well, if no one has anything else,
- 21 we'll end the interview.
- 22 All right. Thank you for talking with us.
- 23 (Whereupon, the interview was concluded.)
