FEDERAL BUREAU OF INVESTIGATION

Date of transcription 11/16/99

[REDACTED] date of birth [REDACTED] was interviewed at the Pennsylvania Hotel, located at 401 7th Avenue, NY, NY. After being advised of the identity of the interviewing agents and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] is current employed as the Front Office Manager for the Pennsylvania Hotel. [REDACTED] stated that part of his employment duties include receiving reports from the Security Director at the hotel concerning incidents involving guests. [REDACTED] confirmed he would also be the individual who received security complaints concerning EgyptAir staff.

[REDACTED] was verbally contacted approximately three (3) times by Security Director BILL LYE about incidents involving GAMIL ELBATOUTY. [REDACTED] believed these incidents occurred during the last year but was unsure of the exact time frame. [REDACTED] stated that all the incidents involved alleged sexual impropriety. However, [REDACTED] was unable to recall the exact specifics of the incidents and did not recall any written documents being given to him or prepared by him. [REDACTED] stated that any incident reports prepared would remain in the custody of Security Director BILL LYE who maintains a complaint file.

[REDACTED] stated that to the best of his knowledge EgyptAir was never contacted in writing by the Hotel Pennsylvania concerning ELBATOUTY's behavior. However, [REDACTED] did recall one (1) telephone conversation he had with an EgyptAir employee named [REDACTED]. [REDACTED] received this call from [REDACTED] regarding an incident involving ELBATOUTY approximately four (4) months ago. During this incident, ELBATOUTY had been questioned by the Hotel Pennsylvania Security after he was suspected of having exposed himself to some female guests in the hotel. In response, ELBATOUTY contacted [REDACTED] at EgyptAir and complained about the hotel's treatment of him. [REDACTED] believed that ELBATOUTY was present in the room with [REDACTED] when she called [REDACTED]. [REDACTED] called [REDACTED] and asked why the Hotel Pennsylvania

was harassing one of their pilots. [REDACTED] responded that the hotel was not harassing ELBATOUTY but was instead simply investigating an incident involving ELBATOUTY. [REDACTED] told [REDACTED] that ELBATOUTY was an outstanding pilot of good moral character. Moreover, she noted that ELBATOUTY was scheduled to retire in approximately four (4) more months and requested that the hotel leave ELBATOUTY alone. [REDACTED] did not believe any documentation was prepared concerning this conversation nor could he recall any additional contact with EgyptAir regarding ELBATOUTY. [REDACTED] did not believe any actions were taken by the hotel against ELBATOUTY.

On November 17, 1999, SA David Walker (FBI/JTTF) and SA James M. Murray (USSS/JTTF) met with and interviewed [REDACTED] at the Hotel Pennsylvania, 401 Seventh Avenue, New York, NY. After he was advised as to the identities of the interviewing agents and the purpose of this interview, [REDACTED] voluntarily provided the following information:

[REDACTED] explained that he has been employed as a security officer at the Hotel Pennsylvania [REDACTED]. Throughout his employment there, [REDACTED] has worked the third shift (1600-2400) as a House Security Officer.

During that time, [REDACTED] and other Hotel Pennsylvania security officers had repeated dealings with an Egypt Air crew member and Hotel Pennsylvania guest named EL BATOUTY due to his questionable behavior and misconduct.

In particular, [REDACTED] related two (2) incidents concerning EL BATOUTY that he had direct knowledge of:

In the first instance, two (2) teenage females contacted hotel security and reported that a middle-aged man, who had been following them in the hotel, later exposed himself through a hotel window. Further investigation by hotel security officers revealed that the middle-aged man was more than likely EL BATOUTY. Security Officers determined that EL BATOUTY had apparently followed these females from the lobby up to their

room, obtained the room number and then proceed back to his own room. [REDACTED] noted that the windows of each room faced each other across a courtyard.

According to the female complainants, EL BATOUTY telephoned their room and told them to look out their window. When the females did so, they claimed that they saw a man exposed from the waist down, through a window with a curtain half-drawn.

According to [REDACTED], security officers determined that the room in question was registered to EL BATOUTY, however, when they questioned him about the incident EL BATOUTY denied all knowledge. [REDACTED] could not recall if an incident report was prepared concerning this matter.

Concerning the second instance, [REDACTED] remembered receiving reports that EL BATOUTY was harassing female members of the Hotel Pennsylvania housekeeping staff. Specifically, [REDACTED] told interviewing agents EL BATOUTY was suspected of trying to lure female housekeepers into his room, at which point he would offer them wine, chocolate or money in exchange for sex. While [REDACTED] could not recall writing incident reports concerning this matter himself, he was confident that someone else in the security department would have done so.

[REDACTED] described EL BATOUTY as a introverted, loner who always hung around the hotel lobby, overtly leering at women. [REDACTED] noted that the only time EL BATOUTY did not exhibit that type of behavior was in April/1999, when the Egypt Air crew member brought his wife and daughter with him to New York.

In regards to other Egypt Air crew members, [REDACTED] reported that he knew of nothing unusual or suspicious regarding their activities in and around the hotel. Moreover, [REDACTED] could not recall any other Egypt Air crew member being the subject of a complaint to the security department.

[REDACTED], [REDACTED], residing at [REDACTED], was interviewed at the Pennsylvania Hotel, located at 401 7th Avenue, NY, NY. After being advised of the identity of the interviewing agents and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] is currently employed as a security guard at the Pennsylvania Hotel during the four (4) PM to twelve (12) AM shift. [REDACTED] has been employed as a security guard at the Pennsylvania Hotel for approximately [REDACTED] and noted that he was aware of only one (1) individual from EGYPTAIR who security had encountered. [REDACTED] stated that this individual was named GAMIL ELBATOUTY and confirmed that this was the individual that he had recently seen on the television news regarding the crash of EgyptAir 990.

[REDACTED] stated that ELBATOUTY was a constant problem at the hotel and was not surprised to see on television that he may have been involved in the crash of EgyptAir 990. [REDACTED] recalled that complaints had been filed against ELBATOUTY on at least a couple occasions alleging that ELBATOUTY was stalking female guests. [REDACTED] questioned ELBATOUTY regarding these incidents but ELBATOUTY repeated stated he did not do anything. [REDACTED] believed incident reports were created documenting these events. These reports would have been forwarded to the Security Director, who maintains a complaint file.

[REDACTED] was also able to recall several incidents in which he believes ELBATOUTY exposed himself to some female guests. During these incidents, security would received complaints from female guests alleging that a male was exposing himself and masturbating while looking out the window at them. Security (to include [REDACTED]) would respond to the floor the alleged conduct was occurring on and would always find ELBATOUTY on the floor. However, Security was never able to catch ELBATOUTY in the act. When questioned on the above conduct, ELBATOUTY would always repeatedly claim his innocence and deny

any knowledge. Moreover, [REDACTED] often witness ELBATOUTY leering at female guest while his hands were hidden in his pockets ([REDACTED] believed that ELBATOUTY may have been masturbating).

[REDACTED] also heard that ELBATOUTY was harassing the housekeeping staff. [REDACTED] had been approached on several occasions by a Pennsylvania Hotel maid named [REDACTED]. During these conversations, [REDACTED] stated that ELBATOUTY had repeatedly tried to lure her into his hotel room and constantly followed her around the hotel. [REDACTED] was unsure of what, if any, actions were taken against ELBATOUTY and was unsure if any incident reports were created.

[REDACTED] stated that he never witnessed ELBATOUTY in an obvious intoxicated state and noted he often kept to himself in the hotel. [REDACTED] described ELBATOUTY as "vicious" in nature and believed that ELBATOUTY was a tragedy waiting to happen. [REDACTED] added that he always paid special attention to watch ELBATOUTY while he was in the hotel and was afraid he might attack a female when security was not around.

[REDACTED] is currently employed as a security guard at the Pennsylvania Hotel during the four (4) PM to twelve (12) AM shift. [REDACTED] has been employed as a security guard at the Pennsylvania Hotel for approximately [REDACTED] and noted that he was aware of only one (1) individual from EGYPTAIR who security had encountered. [REDACTED] stated that this individual was named GAMIL ELBATOUTY and confirmed that this was the individual that he had recently seen on the television news regarding the crash of EgyptAir 990. [REDACTED] stated that he participated in three (3) separate incidents involving ELBATOUTY.

The first of these incidents occurred approximately two (2) years ago. Security responded to this incident after some teenage girls ([REDACTED] estimated their age at around fifteen years old) complained to the front desk. The teenage girls stated that they had received a phone call asking them to look out their window and across the courtyard to the adjacent hotel window. The girls looked across the courtyard and witnessed a male with the window shade pulled down so as to obscure his face looking at them and masturbating. [REDACTED] and several others responded to the floor the masturbating male was believed to be on and saw ELBATOUTY exiting the room. [REDACTED] questioned ELBATOUTY on the incident but ELBATOUTY repeated proclaimed his innocence. ELBATOUTY stated he was on the floor visiting a friend from EgyptAir and the room that the girls witnessed the male in was not registered to ELBATOUTY but instead to another EgyptAir crew member. [REDACTED] stated that no report of the incident was ever made due to the fact that the girls could not identify the perpetrator's face nor was there any direct evidence implicating ELBATOUTY. However, [REDACTED] repeatedly stated that he believed ELBATOUTY was responsible for the above behavior and

[REDACTED] appeared on floors and ELBATOUTY wa

[REDACTED] responded to a second (2) incident involving ELBATOUTY a few months after the above incident. During this incident, security received a complaint from a female guest and her male significant other. This female alleged that ELBATOUTY was sitting down by the elevator and began to follow her through the hotel. ELBATOUTY then got on the elevator with the female and followed her to her room. [REDACTED] was unable to recall the exact specifics of the incident but believed that ELBATOUTY may have lurked outside the female's room for some time after she entered the room. After drafting an incident report, [REDACTED] approached ELBATOUTY and questioned him about his actions. ELBATOUTY immediately apologized for the incident and chalked it up to a big misunderstanding. [REDACTED] confirmed that an incident report was drafted on the above complaint. [REDACTED] stated that this report would have been forwarded to the Security Director, who maintains an incident report file. [REDACTED] was unsure of what, if any, actions were taken by the hotel or EgyptAir.

The third incident regarding ELBATOUTY that [REDACTED] was aware of involved alleged harassment of the housekeeping staff. [REDACTED] had heard that several members of the housekeeping staff had been repeatedly followed by ELBATOUTY. Moreover, ELBATOUTY would often call the housekeeping office and request maids come to his room at unusual hours. [REDACTED] was unsure of what actions, if any, were taken against ELBATOUTY but believed some incident reports were created. Moreover, [REDACTED] recalled that a Polaroid photograph may have been taken of ELBATOUTY and retained as part of the incident reports.

[REDACTED] was advised of the identity of the interviewing agents and the purpose of the interview. [REDACTED] then furnished the following information:

[REDACTED] is a [REDACTED]
[REDACTED]. From March 1974 to January 1979 he worked for EgyptAir in Egypt. In 1979, he emigrated to the U.S. [REDACTED] is divorced and has three children.

[REDACTED] first met Gamil EL-BATOTY on 03/27/1999 at a birthday party at Mohsen HAMZA'S house (a cousin to [REDACTED] in Santa Monica, California. EL-BATOTY's wife and Mohsen HAMZA's wife's mother are cousins. Mohsen HAMZA, a neurologist, and his younger brother Mansour HAMZA, are both medical doctors.

Most marriages in Egypt are arranged. [REDACTED] told EL-BATOTY that he was interested in finding an Egyptian wife. EL-BATOTY had a friend in Egypt, Dr. Ahmed MOGHN (PHD), who had a female neighbor who was interested in finding a husband. EL-BATOTY invited [REDACTED] to Egypt to confer with MOGHN and see if [REDACTED] and MOGHN's female neighbor would be compatible. On 08/31/1999, [REDACTED] flew to Cairo, Egypt, for this purpose. [REDACTED] returned to the U.S. on 09/25/1999. During this period, [REDACTED] accompanied by his fifteen year old nephew [REDACTED] from Cairo who acted as a driver/guide, met with EL-BATOTY once (at MOGHN's residence) and exchanged a few phone calls with him.

While at MOGHN's residence, [REDACTED] noticed that EL-BATOTY seemed "really down, not upbeat" like he usually acted. [REDACTED] felt EL-BATOTY was not himself. EL-BATOTY questioned why [REDACTED] wanted to get married again. This seemed odd to [REDACTED].

[REDACTED] repeatedly urged the FBI to interview MOGHN. MOGHN is a retired Egyptian Army general who has previously lived in Australia but now resides in Heliopolis, an affluent suburb of Cairo. EL-BATOTY told [REDACTED] that he (EL-BATOTY) spent much of his free time in Egypt with MOGHN. EL-BATOTY and MOGHN were very close. HAMZA believes MOGHN could provide answers regarding EL-

BATOTY's demeanor.

Either the day of or day before [REDACTED] arrival in Egypt, there was an attempt on Egypt's President Hosni MUBARAK's life. [REDACTED] BATOTY and MOGHN discussed this event though BATOTY and MOGHN did not really want to talk much about it around [REDACTED]. [REDACTED] did not believe this was unusual since it was a sensitive subject and [REDACTED] was not close to MOGHN. [REDACTED] was not aware of any strong political views by either EL-BATOTY or MOGHN.

After returning from Egypt on 09/25/1999, [REDACTED] may have exchanged a few phone calls with EL-BATOTY; however, after finding a fiancee here in the U.S. he did not pursue his search for a wife in Egypt.

On 10/31/1999, after hearing of the loss of EgyptAir Flight 990 on the news, [REDACTED] tried to call EL-BATOTY's (Cairo phone: [REDACTED]) wife but could not reach her. He then called his cousin [REDACTED] to find out if EL-BATOTY was on that flight. [REDACTED] later confirmed that EL-BATOTY had been on the flight.

On or about 11/17/1999, [REDACTED] current fiancee told [REDACTED] that EL-BATOTY was being implicated in the media. [REDACTED] is not sure whether EL-BATOTY is responsible for the loss of Flight 990, or not.

[REDACTED] was interviewed at [REDACTED] place of employment, the Hotel Pennsylvania, 401 7th Avenue, New York, NY, telephone [REDACTED]. [REDACTED] provided the following information:

[REDACTED] who has been interviewed on two previous occasions by investigators from the New York FBI office, advised [REDACTED] has been employed at the hotel for the [REDACTED]. As [REDACTED] speaks fluent Arabic [REDACTED] is assigned to the airline check-in desk. [REDACTED] assists airline employees, including pilots, as they arrive and depart the hotel. [REDACTED] also assists with their needs while staying at the hotel. Egypt Air (EA) employees have been staying at the hotel during layovers in New York City for the past three years. Over the three years [REDACTED] has developed friendships with many of the EA pilots.

[REDACTED] was familiar with EA pilot Gamil El Batouty. [REDACTED] does recall that he was involved in at least one incident wherein he was questioned by hotel security. [REDACTED] was advised of the incident by co-workers upon her arrival at work the following morning after the incident. The incident took place several weeks prior to the crash of EA Flight 990. El Batouty was observed on several different floors of the hotel listening through hotel room doors. It was also alleged El Batouty had followed a female guest of the hotel to her room and was observed listening at the door to her room.

[REDACTED] recalls speaking to El Batouty the day following his being questioned by hotel security concerning this incident. He advised [REDACTED] he had been intoxicated the previous evening. He had met a woman in the hotel lobby after having drinks in his hotel room alone. After meeting the female hotel guest El Batouty returned to his hotel room to retrieve a bottle of wine and attempted to locate the woman's room. He alleged to [REDACTED] that he could not locate her room and searched the hallways of the hotel listening for her voice through various hotel room doors. It was at that time he was confronted by hotel security. [REDACTED] recalls El Batouty telling her "I think I may be in

[REDACTED] trouble". He stated he was going to go see [REDACTED] at the EA office in Manhattan, NY to ask [REDACTED] help with the situation.

[REDACTED] further recalls receiving a telephone call at the airline desk that same day from [REDACTED] Front Office Manager, also spoke to [REDACTED] El Batouty was with [REDACTED] at the EA office when she placed the call. [REDACTED] inquired as to why hotel security was picking on El Batouty for no reason. [REDACTED] recalls responding to [REDACTED] "you know how he is". Bhoudagian stated that [REDACTED] was not aware of "how he is". [REDACTED] does not recall discussing the details of the incident with [REDACTED] [REDACTED] does remember advising her that El Batouty was retiring in a month or two therefore the problem would go away.

[REDACTED] did discuss the incident earlier the same day with [REDACTED]. He advised [REDACTED] that the hotel was considering banning El Batouty from staying at the hotel. [REDACTED] repeated to him that El Batouty was retiring soon and in [REDACTED] opinion he (El Batouty) was harmless. El Batouty was not barred from the hotel. [REDACTED] does not believe any formal complaint was written and forwarded to the EA office concerning El Batouty's behavior. [REDACTED] further stated [REDACTED] is not aware of anyone blocking or attempting to block a complaint filed against El Batouty by hotel staff.

[REDACTED] stated [REDACTED] was also familiar with EA Chief Pilot Hussein Roushdy. [REDACTED] was aware that he was not scheduled to return to Cairo on Fl 990 the night of the crash. [REDACTED] was not aware of why the schedule was changed and he departed on that evening.

[REDACTED] does recall being approached by Roushdy the day following the incident involving El Batouty and hotel security. He advised [REDACTED] that El Batouty had been avoiding him all day. He was aware of the details of the incident but appeared concerned as to why El Batouty was avoiding him. [REDACTED] advised Roushdy that El Batouty was most likely embarrassed about what occurred and did not want to discuss it with him.

[REDACTED] advised that Captain Hussein Roushdy was the senior pilot and commanded respect from the other EA pilots. The other pilots "listened" when Roushdy talked to them. [REDACTED] believes El Batouty, besides being embarrassed by the incident, may have been somewhat fearful of Roushdy's reaction to his being questioned by hotel security regarding his alleged inappropriate behavior.

[REDACTED] did not discuss El Batouty's conduct with Captain Roushdy at any other time. From the time of the incident, which occurred several weeks before the crash of FL 990, [REDACTED] does not recall El Batouty having any additional contact with hotel security concerning his behavior.

[REDACTED] was not aware of any dissension between any of the EA pilots. As far as [REDACTED] was aware, El Batouty had a friendly relationship with all of his fellow pilots and co-workers.

Further, [REDACTED] was not aware of a meeting which may have taken place between Captain Roushdy, Gamil El Batouty, and possibly other EA pilots, concerning El Batouty's conduct while staying at the Hotel Pennsylvania.

[REDACTED] is familiar with EA pilot Mohammed Badrawy. [REDACTED] does not believe he has returned to stay at the hotel since the crash of EA Flight 990.

[REDACTED] is not familiar with EA pilots Captain Wegden Fadeel or Captain Hanafy Hamdy.

[REDACTED] advised that since the crash of Flight 990 EA employees and pilots have not spoke of the crash to her. [REDACTED] has not overheard them discussing the tragedy among themselves. [REDACTED] stated that within the hotel it is as if the crash never occurred.

[REDACTED] was interviewed at the EgyptAir New York Corporate Office, located at 720 5th Avenue, NYC, NY, telephone number [REDACTED]. After being advised of the identity of the interviewing agents and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] has been employed at EgyptAir for approximately twenty (20) years and is current involved in handling the EgyptAir crews' hotel arrangements in NYC. [REDACTED] stated that currently the EgyptAir crews are housed at the Hotel Pennsylvania (hereinafter Pennsylvania) while laying over in NYC. [REDACTED] described the accommodation at the Hotel Pennsylvania as less than ideal and noted the crews had expressed some dissatisfaction with the Pennsylvania. [REDACTED] noted that in other EgyptAir cities, EgyptAir was able to utilize respected national chains like the Sheraton or the Hilton. Unfortunately, due to the hotel shortage in NYC, EgyptAir was forced to contract with the Pennsylvania. [REDACTED] was unsure of the exact specifics of the EgyptAir-Pennsylvania Hotel contract but described it as "significant" and believed EgyptAir reserved approximately fifty (50) rooms per night at \$110 per room.

[REDACTED] stated that she often received complaints from the EgyptAir crew concerning the Pennsylvania and conversely, handled complaints from the Pennsylvania concerning EgyptAir employees' behavior. The vast majority of these complaints concerned the quality and availability of room assignments. [REDACTED] noted that EgyptAir employees often try to get upgraded to suites and have engaged in arguments with the Pennsylvania staff when this is not possible. In response, the Pennsylvania Front Office has often called the EgyptAir Executive Offices to complain about the EgyptAir crews' treatment of the Pennsylvania's staff.

[REDACTED] confirmed that she had received a complaint from GAMMI ELBATOUTY concerning his treatment at the Pennsylvania. Approximately six (6) months ago, ELBATOUTY

In response, [REDACTED] telephoned [REDACTED] at the Hotel Pennsylvania. [REDACTED] told [REDACTED] that ELBATOUTY had been seen wandering the floors by security. During these visits ELBATOUTY would get a cup of coffee and spend time socializing with people in the office. [REDACTED] described ELBATOUTY as a pleasant individual who was always willing to work. Moreover, [REDACTED] believed ELBATOUTY was extremely "nice" and a dedicated family man. [REDACTED] was unaware of any negative information regarding ELBATOUTY.

[REDACTED] is current employed as the nighttime housekeeping manager for the Pennsylvania Hotel. [REDACTED] stated that [REDACTED] duties include supervising the cleaning and stocking of the hotel rooms and adjacent areas. [REDACTED] stated that part of this supervision would have included overseeing the cleaning of the Egyptair crew area as well as their hotel rooms.

[REDACTED] described the Egyptair staff as an overall nice crew but noted that at times they could be demanding. [REDACTED] stated that she was familiar with one member of the Egyptair crew who had harassed members of her housecleaning staff on multiple occasions. [REDACTED] identified this individual as GAMIL ELBATOUTY.

[REDACTED] stated that ELBATOUTY would often call the housekeeping department at unusual hours and request his room be cleaned. On these occasions, the housekeeping staff would often send two (2) maids since none of the women wanted to be alone with him. [REDACTED] noted that ELBATOUTY would often contact the housecleaning department and specifically request a particular maid named [REDACTED]

[REDACTED], telephone number [REDACTED], clean his room. [REDACTED] recalled [REDACTED] complaining about ELBATOUTY's behavior during these encounters. [REDACTED] would say things like he is "annoying me" and actually went so far as to make multiple complaints to security. [REDACTED] believed that ELBATOUTY had offered [REDACTED] gifts to include wine, etc.. in an effort to lure [REDACTED] into his room.

[REDACTED] stated that [REDACTED] had complained to [REDACTED] on the night before the crash of Egyptair 990 (October 30, 1999) that ELBATOUTY had offered [REDACTED] \$100 if she would go into his room with him. [REDACTED] was extremely upset by this question and

[REDACTED] recalled that he [REDACTED] spoke with an EA employee named [REDACTED] (sp) who asked [REDACTED] why the Hotel Pennsylvania was "harassing" BATOUTY. [REDACTED] offered that evidently, BATOUTY had gone to [REDACTED] (sp) because when [REDACTED] spoke with [REDACTED] on the telephone, [REDACTED] had BATOUTY in her [REDACTED] office.

[REDACTED] was interviewed at the Radisson Huntley Hotel, 1111 Second Street, Santa Monica, California. After being advised of the identity of the interviewing agents and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] was questioned about how he knew Gameel El Batouty. [REDACTED] has known El Batouty since 1991 when he invited him over for dinner. [REDACTED] had invited Captain Nour, who was a long time friend of [REDACTED], over for dinner and El Batouty was invited as a courtesy. They had been friends since that time.

El Batouty was described as a calm and collected person. [REDACTED] stated that El Batouty dealt with problems in a calm manner, giving an example of how he calmed an upset passenger at a departure gate on a previous flight.

[REDACTED] stated that El Batouty loved his daughter. [REDACTED] had been invited to go to Disneyland with El Batouty and his wife and daughter in September or October of 1998. [REDACTED] had constant contact with El Batouty when he visited Los Angeles, California as he would call him almost every time.

El Batouty had no financial problems that [REDACTED] was aware of and said that he had dreams for his family like everyone else did. El Batouty wanted to purchase things for his family and especially wanted to buy a house for his son who is a police officer in Egypt. El Batouty already had two homes in Egypt. El Batouty was not close to the poverty level, and being a pilot is a top paid profession in Egypt, excluding business professionals.

[REDACTED] was unaware of the specific illness that El Batouty's daughter had, but knew that she had seen a Doctor [REDACTED] (unsure of spelling) at the University of California, Los Angeles (UCLA) Medical Center. They were introduced to Doctor [REDACTED] by Dr. Hanza, who is a family relative. [REDACTED] thought that Doctor

[REDACTED] was a Neurologist. Hanza's wife is related to El Batouty's wife.

El Batouty's daughter was last treated January of 1999 and was here for one week. [REDACTED] knew that El Batouty had good insurance that covered his family world-wide. Muslims do not typically have life insurance and having this type of insurance could be perceived as a cultural insult. Muslims believed it would invite death. Any insurance that El Batouty had would be minimal.

The prayer of "Give all my faith and trust to God" conflicts with someone intending to take their own life. This type of prayer is a positive prayer.

[REDACTED] [REDACTED] died in a plane crash in 1972 while employed as an Egypt Air pilot.

[REDACTED] is a [REDACTED] at the Double Tree Guest Suites and has been employed there for approximately [REDACTED]. [REDACTED] typically works [REDACTED] from 6:30 a.m. to 3:00 p.m. [REDACTED] regularly checks in and checks out the EgyptAir flight crews which stay at the Double Tree. [REDACTED] recognized GAMBEL EL-BATOUTY from a copy of a photograph and recalled that EL-BATOUTY had stayed at the Double Tree as a flight crew member approximately four or five times. [REDACTED] recalls checking in EL-BATOUTY on 10/23/1999.

EL-BATOUTY frequently spoke with [REDACTED] because he, and other flight crew members, recognized [REDACTED] first name as Arabic in origin. EL-BATOUTY was always friendly and presented a happy demeanor. When checking in on 10/23/1999, EL-BATOUTY approached the front desk with approximately two other flight crew members. EL-BATOUTY and these associates were jovial, and the associates commented that EL-BATOUTY was retiring soon and that the current visit may be his last visit to Los Angeles with EgyptAir. The associates requested that EL-BATOUTY be given a "good room."

Neither EL-BATOUTY nor any EgyptAir flight crew members ever caused problems at the Double Tree. Occasionally, a flight crew member would request an upgrade to a nicer room than is contracted for under the agreement between the Double Tree and EgyptAir. To the best of RICHARDS' recollection, EL-BATOUTY did not frequent the hotel bar and did not have guests visit him at the hotel.

[REDACTED] checked out [REDACTED] flight crew member on 10/28/1999 but does not specifically recall checking out EL-

[REDACTED] was contacted by telephone and denied calling the FBI, but [REDACTED] gave consent to have an interview at his employment address.

[REDACTED] is a member of the Islamic Center of Southern California located at Vermont and Wilshire Boulevard. [REDACTED] stated that [REDACTED] never called the FBI for an interview but had been contacted by several news agencies due to [REDACTED] friendship with the co-pilot, Gameel El Batouty.

[REDACTED] had dinner with El Batouty on the Tuesday and Wednesday prior to the plane crash. El Batouty came over to [REDACTED] on Tuesday night, 10/26/1999, at 5:30 p.m. and left at 11:00 p.m. On Wednesday night, 10/27/1999, El Batouty again [REDACTED] for dinner from 5:30 p.m. to 9:45 p.m. The last time that [REDACTED] talked to El Batouty was Thursday, 10/28/1999, around 10:30 a.m. The conversation was described as normal.

[REDACTED] had known El Batouty since the late 1980's when Egypt Air first started flying to Los Angeles, California. The flight crews stayed at the Radisson Hotel that first year. [REDACTED] has maintained a close friendship with El Batouty since that time.

In July of 1999, [REDACTED] had a niece on the plane flown by El Batouty. The plane had arrived early and El Batouty took

care of [REDACTED] niece. [REDACTED] has visited El Batouty at his home in Egypt, giving a 1994 date that they [REDACTED] had dinner together.

El Batouty was described as a good pilot. He was a teacher in the Egyptian Air Force prior to working for Egypt Air.

When El Batouty visited [REDACTED], no problems were ever discussed as this would not be normal in Egyptian culture. El Batouty was described as a pleasant person constantly telling jokes. His son had just graduated from a police academy in Egypt. El Batouty was a Muslim.

[REDACTED] had El Batouty over to [REDACTED] often, and [REDACTED] discussed how [REDACTED] had Captain Habashi [REDACTED] 2 1/2 months ago when he was with El Batouty. The conversation on that date was normal.

El Batouty's daughter has Lupis and is getting treated in Egypt. This did not discourage him. He loved to travel and buy things for his family. He traveled all over the world. El Batouty was well paid compared to the average Egyptian.

[REDACTED] described Muslim prayers that appear on the television monitors prior to take-off. The messages describe how God gave man the ability to fly and how it is useful in society.

The name of El Batouty's daughter is Jeannette. El Batouty has brought his wife and daughter to Los Angeles on previous occasions. [REDACTED] remembered a 1998 date and one after that where his daughter came to Los Angeles for diagnosis. His daughter's primary care is in Egypt, and she was brought to Los Angeles for a second opinion to verify that the treatment in Egypt was proper. His wife was described as loving of El Batouty.

A rumor of El Batouty's family being in Los Angeles was asked. [REDACTED] stated that if the family was in Los Angeles, he would know about it. [REDACTED] would be shocked if EL Batouty's wife was in Los Angeles, and he did not know about it.

[REDACTED] had called Providence Island looking for El Batouty's wife and son Emr after the crash. [REDACTED] had called the Double Tree Hotel and was not successful in contacting El Batouty's family. When [REDACTED] called the hotel, [REDACTED] asked for any Egyptian name and contacted Mohamed El Badrawi who is a Captain of a 777 for Egypt Air. [REDACTED] called El Badrawi and wanted him to get in touch

with El Batouty's wife, Umayma. This was on the Tuesday after the crash. El Badrawi did not call [REDACTED] back right away. Later, El Badrawi called [REDACTED] back, but El Batouty's wife had left the United States on the Thursday after the crash with her son. She was back in Egypt on Friday.

[REDACTED] again stated that [REDACTED] would know if El Batouty's family was back in Los Angeles. She had called [REDACTED] last week on Thursday from Cairo, Egypt. She had called [REDACTED] using a cellular phone.

[REDACTED] says that the medical records of El Batouty's daughter was in the briefcase that he was carrying when the plane crashed. Umayma El Batouty is still interested in bringing the daughter to the United States for treatment for her disease. The family had been seeking advice from Doctor Hanza. Additionally, Doctor Hanza knows doctors at the University of California, Los Angeles Medical Center who can assist El Batouty's daughter.

When the crash occurred, the news media went to the Islamic Center of Southern California looking for individuals who may have known El Batouty. At the center, NBC news representative Belal Khatib found Doctor Hanza and was given [REDACTED] name.

Belal Khatib was persistent in trying to interview [REDACTED] about [REDACTED] friendship with El Batouty. [REDACTED] finally gave an interview to Khatib which lasted about 10 minutes, but [REDACTED] was upset because the news only played the part where [REDACTED] was driving over [REDACTED] friend's death. This interview was done in [REDACTED].

[REDACTED] described El Batouty as not being depressed and looking forward to retirement. [REDACTED] did not know of any insurance coverage that El Batouty had obtained, but [REDACTED] was aware that Egypt Air provided coverage for the daughter. [REDACTED] stated this because the rumor in Egypt was that she did not have any medical coverage.

El Batouty was at the highest pay scale and had the advantage of his family flying for free. He had no financial troubles. His behavior with [REDACTED] was normal. They never talked politics or religion with each other. El Batouty was a Muslim, but he was not a religious fanatic. El Batouty has three sons and two daughters.

MEDHAT HAMED ELKADDAH, Captain, Egypt Air, date of birth [REDACTED], was interviewed at the Pennsylvania Hotel, 401 7th Avenue, New York, New York. Present at this interview were Special Agent [REDACTED] and Detective [REDACTED] both of the FBI-NYPD Joint Terrorist Task Force, and Detective [REDACTED] of the Port Authority of New York and New Jersey. ELKADDAH was advised of the identities of the interviewing agent and Detectives and of the nature of the interview. The following information details the outcome of this interview.

ELKADDAH arrived at the Pennsylvania Hotel at approximately 9:00am on Thursday 11/11/1999. SA [REDACTED] met ELKADDAH in the lobby of the hotel as he arrived from John F. Kennedy International Airport (JFKIA). ELKADDAH was cordial and receptive when SA [REDACTED] requested some of his time to discuss issues surrounding the crash of Egypt Air (EA) Flight 990. SA [REDACTED] and a hotel security representative escorted ELKADDAH to his room so that he could put down his luggage. ELKADDAH agreed to meet with SA [REDACTED], DET. [REDACTED], and DET. [REDACTED] in [REDACTED]. No hotel representatives were present at this meeting.

ELKADDAH, although tired from being in the air for 13 hours, was personable and gregarious towards the interviewers. ELKADDAH was specifically asked about statements he made to representatives of the National Transportation Safety Board (NTSB) while being interviewed on Tuesday 11/02/1999. These statements indicated that ELKADDAH received a sum of money from EA First Officer (FO) El BATOTY, who was a crew member on EA Flight 990 which departed JFKIA on 10/30/1999. ELKADDAH explained that the money in question was only \$35 (U.S. currency). This was money that El BATOTY had received from EA for food. ELKADDAH added that this is the normal sum of money which EA gives it flight crews to purchase food when there is any sort of delay in departure. ELKADDAH was questioned about the relationship of the money that he received from El BATOTY to the supposed statement by El BATOTY that "if anything should happen to me give the money to my son". On this issue ELKADDAH

explained that he did not want to accept the \$35 only because it is his nature to not hold other people's money. ELKADDAH believes that El BATOTY made this statement "in passing" because of the repeated attempts by him (ELKADDAH) to refuse the money. El BATOTY had to approach ELKADDAH and physically hand him the money. ELKADDAH did not think much of this at the time and in a somewhat joking manner made reference to El BATOTY's wife controlling his finances thus making him (ELKADDAH) feel that perhaps El BATOTY wanted to keep this money for himself. ELKADDAH stated that this interaction with El BATOTY was their last conversation.

ELKADDAH was asked to explain the issue of El BATOTY having some sort of premonition that something bad was going to happen to him. ELKADDAH explained that El BATOTY never stated this fact to him but this was something that he (ELKADDAH) was just wondering about while mourning the loss of his friend. ELKADDAH added that while thinking about the death of his friend he "naturally" began to wonder if El BATOTY had any foresight, or premonitions, about something happening. According to ELKADDAH he was just trying to think to himself of what El BATOTY may have been thinking, feeling, etc. ELKADDAH reiterated that this was just something that he was "thinking" about since his friend's death.

At this point the interviewing agents began to query ELKADDAH to obtain some background information on El BATOTY. ELKADDAH was receptive to this line of questioning and provided the following information:

ELKADDAH stated that he and El BATOTY had been friends since 1965 and that their families were originally from the same state in Egypt. El BATOTY was the son of a Mayor of a city outside Cairo. Growing up ELKADDAH thinks that El BATOTY may have been somewhat of a spoiled child because his family had money. Eventually El BATOTY became a flight instructor and someone who would eventually train most of the current EA Captains. However El BATOTY himself never got higher than the FO position because he did not have enough ATP's (ph) or ATD's (ph) to make Captain. El BATOTY was 59 years old and was going to

retire in February 2000 and move to a farm outside Cairo. ELKADDAH added that international law dictates that you can not fly commercially after age 60. El BATOTY was married with five children, three sons and two daughters. ELKADDAH spoke specifically of one of El BATOTY's sons who was going to be a Police Officer in Cairo. Apparently El BATOTY spent a lot of money on this son because he wanted him to have a good appearance. ELKADDAH stated El BATOTY's other son is in college and that of El BATOTY's two daughters, one is married with a family and one is twelve years old and has what ELKADDAH could only best describe as "red mercury poisoning". ELKADDAH added that El BATOTY had taken this daughter to a Los Angeles hospital last year for some treatment. ELKADDAH could not provide any more details on El BATOTY's family. According to ELKADDAH, El BATOTY earned \$2,000 (U.S. currency) a month as a FO while he ELKADDAH, earned \$4,000 to \$5,000 (U.S. currency) a month as a Captain. ELKADDAH maintained that El BATOTY only had the type of financial problems that anyone else would have with five children and related expenses. ELKADDAH did recall that around 10/17/1999 he and El BATOTY went to a Sears store near Hoboken, New Jersey where he used his VISA to purchase a car tire for himself and El BATOTY. ELKADDAH willingly displayed his VISA card for SA [REDACTED] and offered to allow SA [REDACTED] to copy the number. ELKADDAH's VISA card number was [REDACTED] and it expires in [REDACTED]. According to ELKADDAH the cost of the tires was over \$100 (U.S. currency).

ELKADDAH remembered that while at the Pennsylvania Hotel on Saturday 10/30/1999 he telephoned El BATOTY, who arrived at the hotel after flying as a passenger from Los Angeles International Airport (LAX) to JFKIA on another flight. ELKADDAH had just flown in as the take off and landing Captain of Flight 989 from Cairo to JFKIA (which was diverted to Newark International Airport due to fog at JFKIA). ELKADDAH had to leave a message for El BATOTY to see if he wanted to go back to Sears because El BATOTY was not in his room. Later that night El BATOTY telephoned ELKADDAH and said that he had been out earlier. El BATOTY was scheduled to be the FO of the "cruise" crew for EA Flight 990 departing JFKIA later that evening for Cairo. While still at the hotel ELKADDAH and El BATOTY spent some time

together in a lounge before El BATOTY returned to his room to get his luggage together. When El BATOTY telephoned ELKADDAH from his room to talk some more ELKADDAH told him that he had some "sweets" (candy) and to come and get some. El BATOTY declined this offer. A short while later while he was checking out of the hotel El BATOTY telephoned ELKADDAH to try and get him (ELKADDAH) to take his \$35 food money. Eventually ELKADDAH met with El BATOTY before El BATOTY's departure from the hotel. This final meeting was where El BATOTY handed ELKADDAH the money and made the statement about giving it to his son if something happened.

ELKADDAH could only add that El BATOTY was a man with a sense of humor and no health problems. ELKADDAH claimed that El BATOTY was not on any medications and was a strong man. However in thinking back ELKADDAH at times had a feeling that El BATOTY was somewhat quiet lately and thought at times that something may have been on his mind. El BATOTY never mentioned to ELKADDAH that anything was wrong or that something was troubling him. ELKADDAH stated that he believed that El BATOTY's family would receive \$240,000 (U.S. currency) due to El BATOTY's death. ELKADDAH in no way believes that El BATOTY had anything to do with deliberately causing EA Flight 990 to crash.

ELKADDAH was then asked to offer an opinion as to what may have happened to EA Flight 990. As best he could in English ELKADDAH stated that he believed that a "runaway stabilizer" could have been at fault. When asked to explain ELKADDAH provided that at 33,000 feet, if there was a problem with a runaway stabilizer, this could have contributed to either the Automatic Pilot (AP) disengaging mechanically, or the pilots having to "rough handle" the controls thus causing the AP to be disengaged by the pilots. At any rate this could have caused the nose of the aircraft to drop. ELKADDAH asserted that if the pilot(s) reactions were not quick enough they would lose control of the aircraft. Consequently as the aircraft's nose dropped its speed would increase and it would take a strong and quick-thinking man to regain control. ELKADDAH claimed that if the pilot(s) were able to gain control by reducing speed and bringing the nose up it could be possible to bring the nose up to far and, due to lack of speed, stall the aircraft. ELKADDAH stated that

the aircraft would then descend into the ocean. ELKADDAH claims that this type of scenario would be captured on the aircraft's data recorder. ELKADDAH has never seen this problem on a 767 but remembers it happening when he flew the 737 200 series.

ELKADDAH claims that he did not inform the first individuals that interviewed him of the El BATOTY issue because of fatigue and the upsetting events that had taken place. ELKADDAH claimed that he had been awake since 3:30am on 10/31/1999 and received a call around 5:00am from another EA pilot at the hotel informing him that they had lost an aircraft. By 6:00am ELKADDAH and the rest of the crew at the hotel went to JFKIA before returning to the hotel later that day. ELKADDAH stated that after arriving back at the hotel on that Sunday afternoon he slept for a while before hotel employees informed him around 4:30pm that people from the FBI were there to speak to him.

ELKADDAH subsequently stated that he offered all that he could think of with regards to the issues surround El BATOTY and the aircraft. At that point the interview ended cordially.

The next time [REDACTED] recalls contact with Elbatouty was August 23, 1999 at approximately midnight. At that time [REDACTED] was contacted by hotel [REDACTED]. [REDACTED] stated that this individual was named GAMIL ELBATOUTY and visual confirmed that a photocopy of ELBATOUTY's Egyptair identification badge was the individual he was referring to.

[REDACTED] noted that [REDACTED] had witnessed ELBATOUTY engaged in what [REDACTED] believed to be indecent behavior on only one occasion. [redacted] stated that this individual was named GAMIL ELBATOUTY and visual confirmed that a photocopy of ELBATOUTY's Egyptair identification badge was the individual he was referring to.

[redacted] stated that there had been several complaints from [redacted] concerning ELBATOUTY. According to [redacted] ELBATOUTY was constantly following her around and harrassing her [redacted] During these encounters, ELBATOUTY would offer [redacted] wine, chocolate, and other gifts in an effort to get her alone. In addition, on mulple occasions, ELBATOUTY would call [redacted] and specifically request [redacted] [redacted] stated that on the night prior to the EGYPTAIR crash, [redacted] had told him that she had been approached by ELBATOUTY and offered \$100 to go to ELBATOUTY's room with him.

[redacted] stated that on several occasions he witnessed ELBATOUTY following female guests around the hotel. On many of these occasions, ELBATOUTY would stake out the lobby area and wait for females to pass by in route to the elevators. ELBATOUTY would then follow these females into the elevator and watch them enter their rooms. ELBATOUTY would then often lurk outside their doors in an attempt to spy on the women. [redacted] stated whenever he visited a floor that ELBATOUTY was on, ELBATOUTY immediately exited the floor.

[REDACTED] confirmed that on one occasion, he and [REDACTED] confronted ELBATOUTY. On this night, security had received a report from one of the bell hops that ELBATOUTY was attempting to spy on some guests on the 6th floor. In response, security dispatched [REDACTED] to intercept ELBATOUTY. However, soon after [REDACTED] left, [REDACTED] saw ELBATOUTY walking through the lobby. [REDACTED] approached ELBATOUTY and asked him to step into the security area.

Once in the security area, ELBATOUTY was asked to produce some identification (he subsequently produced his Egyptair identification badge which was photocopied by security) and questioned as to what he was doing on the sixth floor. ELBATOUTY stated that members of the Egyptair flight crew were on the sixth floor and he was trying to find them. However, after checking hotel records, it was confirmed that no members of the Egyptair staff had rooms on the sixth. Throughout security's questioning, ELBATOUTY was unable to provide explanations for his conduct and appeared visually amused by the whole situation. In fact, [REDACTED] stated that ELBATOUTY continued to smile and laugh during much of their questioning. ELBATOUTY was told that his conduct was going to be reported to Egyptair and was subsequently released.

[REDACTED] stated that a full incident report was provided to [REDACTED] is employed in the [REDACTED] and told security that he was faxing a letter documenting ELBATOUTY's conduct to Egyptair. [REDACTED] never actually saw [REDACTED] letter and was unsure of what, if any, disciplinary measures were taken by Egyptair.

resided in New York and offered to introduce [REDACTED] to him. [REDACTED] agreed and Farouk introduced [REDACTED]

[REDACTED] stated that Farouk was a quiet, kind man who loved his family. As far as she is aware he had no personal problems and never appeared depressed. Farouk was a very religious person but did not appear radical or extremist in any way.

[REDACTED] was also a friend of Abdel Anwar. [REDACTED] was particularly distraught by his death as they had spoken on the afternoon of 10-30-99 prior to the ill-fated flight. Anwar was extremely excited about his upcoming marriage in Cairo the following week. He advised [REDACTED] he was bringing his new wife to New York with him upon his return the next Saturday. They most often called him by his first name of Gamil. [REDACTED] recalls that El Batoty usually did not accompany his colleagues on shopping or sightseeing trips. [REDACTED] described him as "too cheap" to spend the money. [REDACTED] liked El Batoty but described him as a "dirty old man", although he never said anything inappropriate to [REDACTED]. [REDACTED] stated that during most days he sat in the hotel lobby for hours looking at the woman who entered the hotel. El Batoty, like most of the Egypt Air flight crew, drank alcoholic beverages on occasion. They did not frequent bars or clubs but socialized in their rooms. El Batoty would have a few drinks in his room and return to the hotel lobby to "people watch". [REDACTED] further described El Batoty as "harmless" with a good sense of humor. On occasion El Batoty may have approached female hotel guests in the lobby attempting to obtain their company for the evening. [REDACTED] does not believe El Batoty was ever successful in obtaining a date for the evening.

Batoty had been involved in an incident the previous night wherein he was questioned by hotel security. El Batoty had allegedly been observed on several floors of the hotel listening through hotel room doors. [REDACTED] was further advised that the hotel was considering barring him from the hotel for his behavior.

The day following the incident involving El Batoty [REDACTED] spoke to him as [REDACTED] has on numerous occasions. During their conversation [REDACTED] asked him what had happened the previous night at the hotel. El Batoty advised [REDACTED] that last evening he came to the hotel lobby after having drinks in his room. While in the lobby he met a woman of Chinese or Japanese decent. The woman furnished El Batoty with her room number. [REDACTED] is unsure if El Batoty advised [REDACTED] if the woman invited him to her room. El Batoty admitted to [REDACTED] that he was intoxicated that evening. He stated he returned to his room to retrieve a bottle of wine and then attempted to locate the woman's room. El Batoty advised [REDACTED] that he could not remember her room number or on which floor she was located. He stated that he then searched the hotel for her room, walking down several hotel hallways and listening for her voice. He was searching for her room when he was approached by hotel security. [REDACTED] admonished El Batoty for his actions and asked him "what if your wife found out". He reiterated that he was intoxicated at the time.

[REDACTED] was not positive but thought [REDACTED] recalled one other incident involving El Batoty where his actions were deemed inappropriate by hotel security. [REDACTED] was unable to provide any additional information regarding a possible second incident.

[REDACTED] further stated that El Batoty has a daughter approximately twelve years of age who suffers from cancer. [REDACTED] did not recall the type of cancer or the girl's prognosis. [REDACTED] most recently spoke to El Batoty about his daughter approximately two weeks prior to the crash of flight 990. He was always sad when speaking of his daughter and her illness but did not appear to be overly distraught. He did mention that his daughter's doctor was located in Los Angeles, California and he would soon be taking her back to Los Angeles to see her doctor.

[REDACTED] further stated that [REDACTED] believed El Batoty to be a religious person who was like "a kid in a candy store" when in New York City. He, as well as the other Egyptians, were not accustomed to seeing women in shorts and other revealing clothing. [REDACTED] repeated that [REDACTED] liked El Batoty and believed he was a harmless "dirty old man". [REDACTED] advised that El Batoty never appeared extremist or radical in any way. He never spoke of suicide or made statements which [REDACTED] would consider self-destructive or threatening in nature. [REDACTED] does not believe that El Batoty was capable of intentionally causing the crash of flight 990.

[REDACTED] advised that [REDACTED] was also familiar with and considered [REDACTED] a friend of El Habashy. [REDACTED] described him as being very quiet and an extremely nice person. He was known to his fellow pilots as a no nonsense captain who followed the rules explicitly. [REDACTED] was not aware of any personal problems he may have had. [REDACTED] had met his wife on at least one occasion and knew him to be a loving family man.

[REDACTED] volunteered that [REDACTED] was aware that Abdel Anware and El Habasha should have been the only members of the flight crew in the cockpit at the time of the crash. [REDACTED] was adamant that Habashy would not have consented to or have willingly allowed El Batoty or any other personnel to enter the cockpit until their scheduled time.

Present were SAs Luizzi, Murray, Nygaard, Walker and Detectives Calimine and Magro, along with SA Grathwohl. After being advised of the identities of the interviewing agents and the purpose of the interview, [REDACTED] provided the following information:

[REDACTED] is [REDACTED] which services the nine airlines which have contracts with the hotel. [REDACTED] estimated that at any given time between 350 and 500 of the hotel's 1704 rooms are reserved for the use of these airlines and that 40-60 EgyptAir employees are at the hotel during any given week, often for four or five days at a time, due to the airline's semi weekly schedule.

[REDACTED] knows many of the EgyptAir crew personnel who stay at the hotel by name and face but was friendly with only one, EL HABASHY. He knew HABASHY as extremely friendly to the hotel's employees and a devoted family man. [REDACTED] could offer no information on HABASHY or any of the other crew personnel except for rumors that another crew member, EL BATOTY had been involved in several incidents of a sexual nature at the hotel. He referred investigators to Hotel Security for further information.

[REDACTED] provided three names of hotel personnel who had interacted with the crew on or around October 30, 1999 or who did so on a regular basis and who could offer information as to their habits. The first two, [REDACTED] had checked the crew out and moved their baggage on 10/30 on their way to JFK to board Flight 990. Dr. Bernard Loeb, Chief of Aviation Safety, National Transportation Safety Board (NTSB), requested that the FBI forward any remaining FBI interview reports (FD-302) to the NTSB that specifically pertain to Egypt Air First Officer, Gamil El-Batouty. The enclosed documents are redacted copies of ten (10) FD-302s which document interviews conducted by the FBI pertaining to El-Batouty. The minimal redactions have been taken to protect privacy interests, and do not detract from the substance of the FD-302s.


Due to the extraordinary level of cooperation between the FBI and NTSB in the Egypt Air investigation, the FBI has already provided the NTSB with copies of FD-302s which document in our investigative files other pertinent interviews conducted in connection with its investigation. To date, the FBI has provided NTSB with copies of twenty-nine (29) FD-302s, and in combination with the enclosed, the total number of FD-302s provided to the NTSB is thirty-nine (39). As you know, the substance of the FD-302s and substantial other information has previously been provided to NTSB.

The FD-302s are being provided to NTSB to assist NTSB in documenting its findings. Future matters pertaining to the provision of FD-302s will be decided on a case by case basis. The NTSB can utilize the enclosed, redacted FD-302s in any manner deemed necessary. However, it is requested that those FD-302s pertaining to the interviews of Egypt Air Captain Hanafy Mahmoud Hamdy not be disclosed outside of the NTSB, as he did not provide any information concerning the cause of the Egypt Air 990 disaster, but did provide other unrelated information which raises significant privacy concerns.

He further stated that the owners of "Elashamwy Clothing" also own two other stores located in Manhattan. Both stores are located in downtown Manhattan, first one is located on Broadway and Chambers and the other is located on Church and Chambers Street. [REDACTED] recalls it being a Thursday when the three had gone on this shopping trip.

[REDACTED] further stated that when ever his friends would come into New York he would take them to the Roosevelt Field Mall area and dine in fancy restaurants such as the Ponedrosa and Pizza Hut. He further stated that he had on occasion taken Al-Batouti there.

Mustafa El Fiomvy, who grew up with [REDACTED], informed him that he believed Al-Batouti did not have enough time to become a Captain. [REDACTED] further stated that the pilots of Egypt Air are very good because they have training every 6 months. First Officer ADEL ANWAR ate lunch and drank tea with [REDACTED] at around 2:15 before checking out of the hotel on October 31st. ANWAR mentioned that he was getting married once he returned to Egypt and would be bringing his new wife to the United States and would see [REDACTED] the following Saturday.

[REDACTED] had known First Officer HESHAM FAROUK for one and a half years. FAROUK had a friend in Patterson, New Jersey. WASEF and FAROUK were good friends and FAROUK's children had stayed at [REDACTED] home on one occasion last summer.

[REDACTED] offered that "t'cat allah" (ph), a statement uttered by Muslims, is used quite often to express such sentiments as appreciation for meals - among other things. In addition, [REDACTED] said that generally, Egyptian men love women and are able to have more than one (1) wife. [REDACTED] did not seem to understand why the media was portraying GAMIL EL BATOUTY as a person who may have bothered or harassed women.

[REDACTED] said that he had known AHMED AL-HABASHI and GAMIL EL BATOUTY for approximately three (3) years. [REDACTED] described AL-HABASHI as being an "in charge" person who would not leave the cockpit for any significant period of time. [REDACTED] said that when EgyptAir crew members stayed at the Hotel Pennsylvania in New York City, they often went shopping or stayed in the hotel's airline lounge. [REDACTED] stated that said crew members were not spenders, did not go to bars, and did not explore the general New York area to take in sites. According to [REDACTED], EL BATOUTY would contact him while laying over in New York. Occasionally, [REDACTED] would meet up with him for dinner at restaurants in Manhattan, Hoboken, NJ or Weehawken, NJ. At other times, [REDACTED] would meet EL BATOUTY and his fellow pilots at various New York City clubs, although he could not recall the names of these clubs.

Earlier in 1999, EL BATOUTY made a trip to [REDACTED] residence to pay his condolences after one of the [REDACTED] sons was killed in an automobile accident. At other times, [REDACTED] would send a livery car to bring EL BATOUTY to Northern New Jersey where he would meet with [REDACTED] and [REDACTED] family.

During the course of his friendship with EL-BATOUTY, [REDACTED] met and became familiar with several other Egypt Air pilots. He provided the last names of two (2) of these individuals: Captain (FNU) YUSRI and Captain (FNU) EL BADRAWIE. While [REDACTED] claimed he was not comfortable providing their contact information at this time, he agreed to contact both of these individuals in an effort to arrange an interview with each pilot in the future.

It should be noted that, while EL BATOUTY never discussed his own medical or psychological health with [REDACTED], the pilot did occasionally speak to the [REDACTED] about his daughter's poor health.

According to [REDACTED], EL BATOUTY's pre-teenage daughter suffers from a condition called "disseminated lupus." [REDACTED] explained that he tried to help EL BATOUTY's family by locating prescription drugs at wholesale prices here in the United States. [REDACTED] related that although her condition could be fatal, overall, EL BATOUTY seemed pleased with his daughter's improving health as of late.

[REDACTED] insisted that GAMIL EL BATOUTY gave no indication that he suffered from depression or had suicidal tendencies. Concerning EL BATOUTY's supposed references to God yielded by the Egypt Air flight 990 (EA990) cockpit voice

recorder, [REDACTED] viewed this as a common Muslim custom. In sum, [REDACTED] described EL BATOUTY's alleged statements as a normal prayer that Muslims may offer before beginning a trip or starting a task.

According to [REDACTED], EL BATOUTY was in no way a religious fanatic, and noted that he occasionally enjoyed a glass of wine when they were out together socially. Moreover, [REDACTED] told investigators that EL BATOUTY never expressed any anti-United States or Anti-Western sentiments, adding that he seemed to truly enjoy his visits to this country.

In closing, [REDACTED] refuted the theory that EL BATOUTY could have intentionally crashed the EA990 aircraft, and related another theory put forward by the aforementioned Captain (FNU) YUSRI. Specifically, Captain (FNU) YUSRI told [REDACTED] that it is likely that the plane crashed due to a sequence of mechanical problems that ultimately resulted in the aircraft's tail being broken. If that happened, Captain (FNU) YUSRI insisted that aircraft would be unable to remain airborne.

[REDACTED] described EL BATOUTY as a positive, light-hearted person, with a good sense of humor. He further stated that he considered EL BATOUTY a friend of the [REDACTED] family.

In addition, [REDACTED] stated that [REDACTED] EL BATOUTY with [REDACTED] the pilot did occasionally speak to the doctor about his daughter's poor health. According to [REDACTED], EL BATOUTY's pre-teenage daughter suffers from a condition called "disseminated lupus."

[REDACTED] explained that he routinely tried to help EL BATOUTY's family by locating prescription drugs at wholesale prices here in the United States. Specifically, [REDACTED] would contact various pharmaceutical companies in an effort to get the best price on two (2) prescription drugs used in the treatment of this illness: PLAQINEO and IMURAN.

According to [REDACTED] EL BATOUTY spoke often about his daughter's condition. Generally, EL BATOUTY seemed pleased with his daughter's gradually improving health.

It should also be noted that [REDACTED] stated that he [REDACTED] to EL-BATOUTY. However, [REDACTED] related that EL BATOUTY had [REDACTED] of the drug Viagra. He added that EL BATOUTY, who claimed that he did not need Viagra himself, was interested in acquiring [REDACTED] as it is considered a novelty in Egypt. EL BATOUTY told him he planned to trade these pills for his benefit or simply just give them to friends.

During this interview, [REDACTED] stated that he gave he EL BATOUTY [REDACTED] vials of the drug on two or three occasions in the year before his death. [REDACTED] recalled the last time he did so was in the early Summer of 1999.

It should be noted that, while EL BATOUTY never discussed his own medical or psychological health with him, the

[REDACTED] that GAMIL EL BATOUTY gave no indication that he suffered from depression or had suicidal tendencies. In addition, [REDACTED] suggested that it was absurd to theorize that EL BATOUTY intentionally crashed that aircraft because he did not fit the profile of someone who would do such a thing.

According to [REDACTED] EL BATOUTY was in no way a religious fanatic, and noted that he occasionally enjoyed a glass of wine when they were out together socially. Moreover, [REDACTED] told investigators that EL BATOUTY never expressed any anti-United States or Anti-Western sentiments, adding that he seemed to truly enjoy his visits to this country.

[REDACTED] explained that he had invited EL BATOUTY to come to dinner at his home on the Friday evening prior to the crash. However, EL BATOUTY, who had initially accepted this invitation, later called [REDACTED] to cancel. According to [REDACTED] EL BATOUTY told him that he'd decided to stay at his New York hotel to console a colleague, whose son had been in an automobile accident back home in Egypt. [REDACTED] noted that he had intended to give EL BATOUTY more [REDACTED] for his daughter to take back with him to Egypt. Since EL BATOUTY did not arrive that night, [REDACTED] had this medication sent to his hotel in New York.

Regarding his own travel plans, [REDACTED] stated [REDACTED] had intended to fly to Egypt at or about the time of the Egypt Air Flight 990 crash. Moreover, [REDACTED] adamantly denied that EL BATOUTY ever warned him or any member of his family not to fly on any Egypt Air flight. [REDACTED] added that he and his family always fly on Egypt Air when they return home, and that on many occasions EL BATOUTY would try to upgrade their tickets.

[REDACTED] went on to say that, while he had met a number of Egypt Air pilots through his friendship with EL BATOUTY, he does not recall ever meeting a pilot named HANFY HANDY.

Finally, [REDACTED] indicated he would be willing to speak with investigators again, but requested that an appointment

[REDACTED], date of birth [REDACTED], address [REDACTED], Los Angeles, California, phone number [REDACTED], was interviewed at his place of employment, the Doubletree Guest Suites, 1707 Fourth Street, Santa Monica, California. After being advised of the identity of the agents, and the nature of the interview, [REDACTED] provided the following information.

[REDACTED] works in the housekeeping department at the Doubletree Guest Suites. After being shown a photograph of Gameel El Batouty by interviewing agents, [REDACTED] stated that he was familiar with the individual in the photograph. [REDACTED] described the individual (Batouty) as 48-50 years of age, weighing approximately 210 pounds, and approximately 187 centimeters tall (approximately 6 foot 2 inches tall).

[REDACTED] knows Batouty as a pilot for Egypt airlines. [REDACTED] believes that the last time he saw Batouty was approximately October 29 or 30, 1999. On two different days, just one or two days before Halloween, 1999, [REDACTED] recalls seeing Batouty in the hotel wearing a brown plaid shirt and brown pants on one day, and a blue shirt and black pants the other day.

[REDACTED] has no memory of any specific interactions he has ever had with Batouty, nor does he have any information regarding interactions between other hotel employees and Batouty.
