3	DET. JUMPER: We're just going to talk about what you saw.
4	I'm with the State Police. I'm a detective.
5	MR. REID: Did you just try to call me.
6	DET. JUMPER: I did just try to call you.
7	MR. REID: Well, how come I saw that.
8	DET. JUMPER: Um-hum.
9	MR. REID: It's like it had no number to call back.
10	DET. JUMPER: Well, I it's probably because I
11	MR. REID: I think either that or I'm doing it wrong.
12	DET. JUMPER: called from the Sheriff, from the phone. I
13	ended up giving you the number to that desk, and I just sat there.
14	MR. REID: Oh.
15	DET. JUMPER: But then I was told you might still be out
16	there. So I thought, well
17	MR. REID: Yeah, we were in getting a drug test.
18	DET. JUMPER: Did you get that?
19	MR. REID: Yeah, I already did.
20	DET. JUMPER: For the CDL? For your
21	MR. REID: Well, for the accident, CDL.
22	DET. JUMPER: Was it for the
23	MR. REID: It's just because I had an accident. They always
24	want a drug test after you have an accident.
25	DET. JUMPER: So that's where you've been.

MR. REID: Yeah. Because they were going back and forth. I guess at first they wanted me to stay at the bus garage because Kosciusko County wanted me, to talk to me.

DET. JUMPER: Really.

MR. REID: Well, I -- they said because Tippecanoe Valley is in Kosciusko County.

DET. JUMPER: Oh, yeah. I understand.

MR. REID: But the accident happened in Fulton County.

DET. JUMPER: Right.

10 MR. REID: Where the Meiser Trailer Park is.

11 DET. JUMPER: Um-hum. Yeah.

14 Q. All right.

A. It was just like a normal day. I mean, I pull up to my stop, put my stop sign on. There was headlights way in the distance. I mean, for me to say, okay, I'll weigh -- because sometimes they come close, and you kind of slow down and don't put anything on, the reds on. You've got the yellows on, let them know you're slowing down, but you wait until they pass before you put your reds on so nobody goes anywhere, everybody just stays out of the way. But he was way back there, and I mean I don't know how many feet. Let's put it this way. In the dark, it seemed like it was way back there. They had plenty of time to see them. And the reds are out and I'm sitting there. I stop. Looked at him. He's

- 1 still far enough away. So I said, go ahead. And he just kept
- 2 | right on going. I mean I even had time, because I usually don't
- 3 think that fast, to honk my horn, too, which, you know, hey, you
- 4 know, what are you doing? Because a lot of guys will come on
- 5 | within, well, maybe this -- the space of this room, to where they
- 6 stop finally --
- 7 Q. Right.
- 8 A. -- you know. It's like -- and from what I could tell, I mean
- 9 it's pitch black out. There's no lights except for, you know, my
- 10 bus lights and stuff.
- 11 O. Um-hum.
- 12 A. But there's no, you know, overhead lights, you know,
- 13 telephone pole lights or whatever at, at the stop.
- 14 Q. So it was completely dark.
- 15 A. Yeah, it's dark.
- 16 Q. Except for your lights.
- 17 A. Yeah, except for my lights are on and I, you know.
- 18 Q. Is that spot in a curve or is it kind of straight where you
- 19 were?
- 20 A. It, it -- that part's straight, but the curve comes like
- 21 this.
- 22 O. Um-hum.
- 23 A. So -- and, you know, he -- and I'm over -- he's coming south,
- 24 and I'm going north. So I'm way over here to where he has a good
- 25 plain view from what, from what I could tell but, you know, I mean

- 1 -- when I realized he wasn't going to stop, I'm even honking my
- 2 | horn and it was over. And I'm going, what did I do? What did I
- 3 do wrong? You know, so I mean --
- 4 Q. I don't think you did anything wrong.
- 5 A. -- it's like 10 kids and how did they not see them. Even
- 6 with the headlights on, you know.
- 7 Q. Why don't you draw me a picture of what it looks like right
- 8 there, where everyone was standing and stuff.
- 9 A. Okay. I'm going to say this is --
- 10 Q. The road.
- 11 A. My hand's shaking.
- 12 Q. That's okay.
- 13 A. This is like where the trailers are all right in here, here,
- 14 here, here, here. And there's another -- I think there's another
- 15 entrance -- no, not -- I don't remember if there is an entrance.
- 16 Q. Where's 25 at on there?
- 17 A. Right here. It kind of goes -- I'm going to go like this.
- 18 Q. Okay.
- 19 A. But it's more sweeping than that I guess, you know, like
- 20 that. And I'm right here, you know, stopped. So it's not like
- 21 I'm over here to where, you know, he would be running -- he's
- 22 | coming towards me the whole time, and I had -- I mean he was way
- 23 back here. I mean I'm going to say over 100 feet or 100 yards or
- 24 something, not yards, but it just seemed like a real long time.
- 25 | It's hard to, you know, I can't describe how far --

- 1 Q. This is the trailer park.
- 2 A. Well, there's another driveway up here that goes -- this was
- 3 one trailer, goes down here and, you know, because I go to that
- 4 one next, and they're pretty close together, and he was way up
- 5 here.
- 6 Q. Okay.
- 7 A. I mean it's not a -- I still take my stop sign off when I go
- 8 to that one because --
- 9 BY DET. LORONA:
- 10 Q. You said you pick kids up here, too?
- 11 A. Yeah, pick up here, kids here and here.
- 12 Q. And kids there, too.
- 13 A. And then 500 I get off.
- 14 Q. Okay. Were there kids there today? Were there kids --
- 15 A. I don't know. I never got that far.
- 16 Q. Okay.
- 17 A. Yeah, I mean it's right here where I stopped. I pick up
- 18 three kids back here on 25.
- 19 Q. Okay.
- 20 A. One right there by that bridge, going over. There's a kid on
- 21 this, this side here, and then there's one here and then 400. I
- 22 | come out 400. There's a kid right here, and then I make -- and
- 23 then there's another kid here and then her, she's right here, and
- 24 then a long way, you go down that hill and kind of round and it's
- 25 Meiser. You know Meiser Trailer Park.

- 1 Q. I don't know the trailer park.
- 2 A. Okay. It's Meiser Trailer Park, and it's right there, and I
- 3 mean I've, you know, put my sign up and I said, well, he'll stop.
- 4 It's way back there. My sign's out. So I -- and he just kept
- 5 going. When I realized he kept going, I mean like I said, I could
- 6 wait, I could have waited for him to go by but then I didn't know
- 7 | if somebody else was going to go by, and he was way back there.
- 8 When do you stop? When do you stop telling, you know --
- 9 BY DET. JUMPER:
- 10 Q. Well, you expect people to stop.
- 11 A. Yeah, I mean it's like --
- 12 Q. Everyone stops for --
- 13 A. -- he was way, way back there.
- 14 Q. Right.
- 15 A. I mean --
- 16 Q. It's my --
- 17 A. My concern, I mean my thinking is he was way back there, he
- 18 should have been able to have no problem stopping but most of
- 19 them, I mean sometimes they stop way back here. Sometimes they'll
- 20 stop right there.
- 21 O. Sure.
- 22 A. I mean they'll just slow down until I get right close.
- 23 Q. How many kids did you have on the bus that morning?
- 24 A. There's like 8 or 10. Oh, three.
- 25 Q. Coming up to this point --

- 1 A. Three today.
- 2 Q. -- you've got three.
- 3 A. If one kid rides, it's four, but she's not on. She wasn't on
- 4 today.
- 5 Q. So there's three passengers.
- 6 A. Three passengers.
- 7 Q. And when you stop here, how may kids --
- 8 A. I think there's 10.
- 9 Q. Up to 10.
- 10 A. Yeah.
- 11 Q. Were they all 10 there today?
- 12 A. I don't now.
- 13 Q. You didn't know.
- 14 A. I can't see them all in the dark.
- 15 Q. Sure.
- 16 A. That's just -- there was no street light is what I'm trying
- 17 to think of right here. There's nothing.
- 18 Q. So we've got three on the bus.
- 19 A. We've got three on the bus. We've got -- well, I can give
- 20 you -- Aden, Emma and John --
- 21 Q. Aden, Emma and John.
- 22 A. -- are all on the bus.
- Q. Okay. And you're picking up, up to 10.
- 24 A. Yeah, and I mean there's --
- 25 \mathbb{Q} . Are there adults out here waiting with them or --

- 1 A. Sometimes, but they're all -- they sit back here and it's
- 2 real dark.
- 3 Q. Okay.
- 4 A. I mean they sit back there and then when they see me wave
- 5 them on, then they come out. Half the time you can't see them.
- 6 0. Sure.
- 7 A. And, you know, and that's pretty much it and, you know --
- 8 Q. How long do you think you were there? I mean --
- 9 A. A few seconds.
- 10 Q. -- my kids' bus, as they're even getting close to the
- 11 driveway, they turn on the yellow lights and then they --
- 12 A. Yeah, I did all that and stopped. And they wait for me to
- 13 wave me. So when I stop, and I looked at him, well, he's way back
- 14 there, I went ahead and waved them over.
- 15 Q. Um-hum.
- 16 A. Because they was so far back.
- 17 O. Sure.
- 18 A. I mean it's not like he was like, you know, the next -- even
- 19 where these other kids are right here, they wasn't even there --
- 20 Q. Okay. Yeah.
- 21 A. -- that I could see.
- 22 Q. Okay.
- 23 A. But, you know, like I said, in the dark, it's, you know, kind
- 24 of hard to judge that, and it seemed, you know --
- 25 Q. How long do you think the stop sign was out?

A. 10 seconds.

- 2 Q. You don't think you sat there for a long time.
- 3 DET. LORONA: Before you waved -- how long were you stopped
- 4 | with the stop light arm out before you waved them?
- 5 MR. REID: Oh, a couple of seconds. I mean, you know, I
- 6 stop, put the sign out. I mean I already had the sign out because
- 7 I always put it out as I'm --
- 8 BY DET. JUMPER:
- 9 Q. Right.
- 10 A. -- stopping. So first the yellows come on before that. So
- 11 everybody knows I'm coming. And then the stop sign comes out just
- 12 before I stop. And then I look down there and I saw the car
- 13 coming, but he was way far away, and I -- at the time I was
- 14 thinking, he's going to stop way back there and he just kind of
- 15 never did. By that time, I had already waved them to come on and
- 16 | then I realized he hadn't stopped, and then I hit my horn. That's
- 17 | the way I remember it.
- 18 Q. Okay.
- 19 A. I mean, I mean after that, I just kind of went --
- 20 Q. Because they're all already out there waiting.
- 21 A. They're all there in a big group.
- 22 Q. You don't have to sit and wait for a couple of minutes.
- 23 A. No, that's two stops up, I've got to do that.
- 24 Q. Some places, yeah, every day.
- 25 A. There's one family in Talma or two, but --

- 1 Q. That you just sit.
- 2 A. I haven't done any of them yet. This was my fourth stop. I
- 3 usually have another one but she rides sometimes and today wasn't
- 4 one of them because I'll actually go down 650 from 9 -- well, 650
- 5 to 400 and then down, all the way down to 25 and then around, all
- 6 the way to 500 and then back out. I'm only one -- that's the only
- 7 part on 25 in there, from 400 to 500.
- 8 Q. Back east on 500 North.
- 9 A. Back east on 500.
- 10 Q. Okay.
- 11 A. So from 400 to 500, I pick up, I pick up John and Emma and
- 12 them and then Brandon and Karena Stiles (ph.) and then I get off.
- 13 But I only had Aden, Brent -- or Aden, John and Emma on.
- 14 Q. Okay.
- 15 A. But, you know, it's one of those things. You look at them
- 16 and you say, yeah, he's, yeah, he's got to see -- I mean he'll
- 17 stop.
- 18 Q. Well, if it's pitch dark and there's no lights or anything,
- 19 and you've got yellows and then you've got reds and you're sitting
- 20 there.
- 21 A. Yeah. I mean it was plenty of time. I mean -- because a lot
- 22 of times if I see somebody coming up this way and I'm coming up
- 23 this way, and I know they're going to hit at almost the same time
- 24 I do or close to it, I will slow down and just leave my yellows on
- 25 and just wait until he passes before I actually stop and, you

- 1 know, do it.
- 2 Q. Right.
- 3 A. And that's --
- 4 Q. Okay. So what is your -- your full name is -- is it Robert?
- 5 A. Robert -- do you want my driver's license.
- 6 Q. No, that's only.
- 7 A. Robert Gifford --
- 8 Q. O-r-d.
- 9 A. Yep. Reid, R-e-i-d.
- 10 Q. What's your address?
- 11 A. address, even though it's
- 12
- 13 Q. What's the zip code there?
- 14 A.
- 15 Q. And I have your number. What's your birth date?
- 16 A.
- 17 Q.
- 18 A. Yeah, I just want to know, did I do -- they've found
- 19 that I've done something wrong? I mean that I forgot to do or --
- 20 Q. No, not --
- 21 DET. LORONA: Not that we're aware of.
- MR. REID: I mean that's what's bothering me the most. What
- 23 | did I do wrong?
- 24 BY DET. JUMPER:
- 25 Q. I don't -- I mean to my knowledge, you've stopped and put all

- 1 the lights out.
- 2 A. I mean all the people behind me were stopped, you know, and
- 3 of they'd have to stop if you're, you know, in front of them,
- 4 but --
- 5 Q. I think you're going to second guess yourself no matter what.
- 6 A. Well, you're probably right about that.
- 7 Q. I can probably tell you 10 times that to me --
- 8 A. Well, I mean --
- 9 Q. -- you haven't done anything wrong, and you're probably going
- 10 to second guess yourself.
- 11 A. You know, I'm just thinking, you know, I should have waited,
- 12 | you know, long enough to see if he's going to stop or --
- 13 Q. Well, I know we do --
- 14 A. He was far enough back and I'm like how many times, you know.
- 15 Q. Right.
- 16 A. It wasn't like he was -- to me it didn't seem like he was
- 17 | close --
- 18 0. Sure.
- 19 A. -- and why wouldn't he stop.
- 20 Q. Right. Well, that's what we're supposed to do.
- 21 A. And like -- it's like, you never know. I mean some -- like
- 22 some truck drivers will stop 100 feet or way back there.
- 23 O. Um-hum.
- 24 A. And then other guys will get within 30 feet and stop. So I
- 25 | just, you know, I don't know. I mean --

- 1 Q. You say you work for Tippecanoe Valley --
- 2 A. Yeah.
- 3 Q. -- School Program.
- 4 A. Two years -- well, I came in '16. I can't -- there's people
- 5 | that's been driving there for 18 years and never had a problem.
- 6 O. Well --
- 7 A. But I guess the girl that drove this bus before me, because I
- 8 used to drive the one to go to west end of the state, up on the
- 9 | west end of Warsaw, and she said somebody run into the back of
- 10 her.
- 11 Q. Really.
- 12 A. Because 25 is -- I mean it's 55 unless you get into Talma.
- 13 Then it drops down to 30.
- 14 Q. That spot is 55.
- 15 A. As far as I know.
- 16 Q. I didn't drive up there today but -- and it's been a --
- 17 A. As far as I know, you know, it might be less than that now.
- 18 Q. Is it -- could you even tell in the dark, could you estimate
- 19 how fast the car like that was doing or is just dark and you could
- 20 see that it was --
- 21 A. All I could see was it was coming. I couldn't tell how fast
- 22 he was going. Somebody said he was going -- because he didn't
- 23 even put his brakes on.
- 24 Q. Um-hum.
- 25 A. I mean there was no skid to stop, no nothing. And like you

- 1 say, in the dark, you know, it's kind of -- I don't know if it's
- 2 | an illusion or what, but you think, you know, you're looking at
- 3 these headlights and you think he's going to stop and you really
- 4 | can't judge like how fast he's actually going, and he just kept on
- 5 going, but when I realized he was going to keep going, he hadn't
- 6 even gotten to the bus yet.
- 7 Q. Um-hum.
- 8 A. But that's when I remember -- I can't even believe I did that
- 9 | because usually I don't think that fast. You know, it's like I
- 10 kind of panic, you know, and oh --
- 11 Q. Right.
- 12 A. -- and by that time, it's done --
- 13 Q. You did what you could do.
- 14 A. -- you know, and he just kept, you know, like I said, kept
- 15 going. He stopped after the bus.
- 16 Q. Um-hum.
- 17 A. I mean he didn't run or anything. I didn't even talk to him
- 18 or saw him or anything.
- 19 Q. It's actually a female.
- 20 A. Oh, it was.
- 21 Q. The driver is a young female.
- 22 A. Oh, I had no idea.
- 23 Q. A 24-year-old young lady, um-hum. Yep.
- 24 A. But, you know, it's like -- you know, I don't know what else
- 25 to say.

- 1 Q. Well, I appreciate it.
- 2 A. I mean --
- 3 DET. LORONA: Is there anything else you can think of?
- 4 BY DET. JUMPER:
- 5 Q. I always think there's questions I'm forgetting to ask.
- 6 A. I mean I had my --
- 7 0. Sure.
- 8 A. -- like I said, I had my lights out. I come up to stop with
- 9 my yellows, and before I even stop, I've got my reds out because
- 10 | it's -- because the traffic is so bad or not bad, or they're going
- 11 fast. So I want to give them time and he had plenty of time.
- DET. LORONA: You did -- you do the same thing you do every
- 13 day. You did --
- MR. REID: Yeah, it's the same stop every day. I mean some
- days there's cars. Some days there's nothing.
- DET. LORONA: Yeah, but you do it the same. Regardless, you
- 17 do it the same way --
- 18 MR. REID: Yeah.
- 19 DET. LORONA: -- every day.
- 20 MR. REID: Same way every time.
- 21 DET. JUMPER: Okav.
- MR. REID: -- you know. And, you know. I don't. I don't
- 23 know what to say. I mean that's --
- 24 BY DET. JUMPER:
- 25 Q. So it was your fourth stop. You said one child you didn't

- 1 get today.
- 2 A. Yeah, she's on, she's on 650, and she only rides some -- one
- 3 day she'll ride in the morning and not in the afternoon, or she'll
- 4 ride in the morning and the afternoon.
- 5 Q. Would that have been your fifth stop?
- 6 A. That would have been the fifth stop.
- 7 Q. But today it was your fourth stop.
- 8 A. Yeah.
- 9 Q. Got it.
- 10 A. Because I have -- it would have been --
- 11 Q. Two, three.
- 12 A. -- if it would have been everybody, it would have been like
- 13 Kaden (ph.)'s first, then Aden which is on 400, not on 25 --
- 14 O. Um-hum.
- 15 A. -- but he's right there at the corner. And then the next one
- 16 is John who is on the right side. Emma's on the left side just a
- 17 | little bit further than that, and then you go down the hill,
- 18 | around past the bridge, and down in Meiser Trailer Park is right
- 19 there. And they're kind of in the back, and you've got to kind of
- 20 look real hard to see them.
- 21 O. Um-hum.
- 22 A. And I stopped, you know, I had my lights and everything on,
- 23 and I looked out there, and I saw the car coming, but at the time,
- 24 | it was way back there, and I waved -- went ahead and waved them
- 25 across thinking, you know, I mean when do you decide not to stop.

- 1 Q. So this is the driveway to another stop that you didn't make
- 2 it to, and it was --
- 3 A. Yeah, and that's -- this is going north.
- 4 Q. Do you know if this person --
- 5 A. He was somewhere in here.
- 6 Q. Somewhere before or somewhere --
- 7 A. I think he was somewhere in here.
- 8 Q. Okay.
- 9 A. I mean it's hard to tell for sure.
- 10 Q. I know. And you're not -- it's a guess.
- 11 A. I'm guessing. Let's put it this way. It just seemed like it
- 12 | was plenty of time.
- 13 Q. Sure.
- 14 A. Way, you know, it's like it's enough time to where, you know,
- 15 he wasn't close to where you would think, you know, he has to see
- 16 my yellows and reds.
- 17 DET. LORONA: How long --
- 18 MR. REID: I'm thinking --
- DET. LORONA: How much time do you think it was from the time
- 20 you stopped until the time that car got there?
- 21 MR. REID: Ten seconds I quess. I mean because I looked at
- 22 | him and thought, oh, yeah, he's way back there. He's going to
- 23 stop, he's going to slow down. So I went ahead and waved them. I
- 24 | mean I actually looked at him. Looked at the car, he's way back
- 25 there, yeah, he'll stop, and he sees my lights and he just kept

on. I had a guy on 700 which is, you know, kind of a side street,

I mean they're country roads there.

DET. LORONA: Yeah.

MR. REID: This is in the middle of the day, and I thought he was going to stop, but I held the kid back because -- and he didn't even look like he even saw me, and just went whizzing right by me. I went, damn, but, you know, you've got all these flashing lights. It's almost -- that's even better than daytime in a way.

DET. JUMPER: Yeah.

MR. REID: But they're blinking right in your face. And, you know, you've got your headlights, too, and I'm not -- and all these other people are behind me. They're stopped and somebody mentioned behind me that there's a truck driver said, yeah, we were stopped and, you know, that guy just went -- he was going fast. Well, I thought it was a man. I don't know. You said it was some woman.

DET. JUMPER: It's a young girl.

MR. REID: But I mean, you know, I want to know from the Sheriff's Department whether I did something wrong.

DET. JUMPER: I just don't see where you did anything wrong.

MR. REID: Where did I go wrong because --

DET. LORONA: You did --

MR. REID: I mean what else I did. I mean, you know, I know the lights were out. I saw them, you know, because there's times when people, you know, they think they've got their light on and

- 1 they look up, oh, no, my lights, you know, because --
- 2 DET. LORONA: Everybody said you had your lights on.
- 3 MR. REID: Okay.
- 4 DET. LORONA: Yeah, everybody, yeah.
- 5 MR. REID: That's -- I mean --
- 6 BY DET. JUMPER:
- 7 Q. Well, just because you waved someone across the street
- 8 | doesn't mean -- I mean it's my understanding there were adults
- 9 that were out there.
- 10 A. I don't even know. I mean you can't -- because they hide
- 11 | them back there in a way.
- 12 O. Yeah.
- 13 A. There's no street light there that I remember.
- 14 Q. Well, I mean we all are taught, you know, it's a school bus,
- 15 you stop for the school bus. So, you know, it's --
- 16 A. I mean it's, it's an every day deal that somebody runs
- 17 | through -- I mean I had one the other day, just the other day, and
- 18 | it was during the day on 25.
- 19 Q. Really.
- 20 A. Yeah. I mean I don't know how you can fix that. The only
- 21 safe way to do it is -- I mean they're, they're on the left side
- 22 going home or picking up in the morning but they're on the right
- 23 side going home, you know, so if you could -- unless they made a
- 24 law where the parents have to be on the right side of the street
- 25 all the time to pick up the kids, you know, and some people say,

- 1 you know, they tell you in the schools, they said, you know, you
- 2 | shouldn't pull out in front of other traffic going the other way,
- 3 you know, to stop -- get them to stop. You stay in your lane.
- 4 Q. Yeah, I've seen bus drivers that cross --
- 5 A. Yeah, because that could cause, you know. I mean, you know,
- 6 | like I said, I just, you know, I don't -- I just want to know if I
- 7 done something wrong, you know, to cause this, you know.
- 8 Q. I mean the black and white of it is, is your lights are out,
- 9 that person didn't yield to the red lights and the stop arm.
- 10 A. Yeah.
- 11 0. And that's --
- 12 A. As far as -- I mean -- yeah.
- DET. LORONA: Don't beat yourself up over it because it's --
- MR. REID: Well, it's -- I mean it's kind of hard not to.
- 15 mean --
- 16 DET. LORONA: I know it.
- 17 MR. REID: -- three or four that are gone.
- 18 DET. LORONA: Yeah, but you can't --
- MR. REID: And there was -- those were the nicest kids right
- 20 there, those. I mean they helped me out all the time, and how am
