MS. HENDRICKS:

10 MR. COLLINS: Okay. And we're talking to Ms. Hendricks

11 because her husband was the driver of the bus involved.

INTERVIEW OF KATHLEEN HENDRICKS

- 2 BY MR. COLLINS:
- 3 Q. And, Ms. Hendricks, would you just tell me about your husband
- 4 and his work as a bus driver for the school district? Just in
- 5 general, general things about him, and how he enjoyed his job, how
- 6 he got into driving for the school district.
- 7 A. He liked driving the bus, I know that. He's been driving for
- 8 20 years, I believe, for the school system.
- 9 Q. Okay.

- 10 A. Approximately. He drove for athletic, or for -- what do you
- 11 | call it? Athletic events for a lot of years too.
- 12 Q. How did he get into that line of work?
- 13 A. Well, before he retired, he drove for a rock and sand company
- 14 in California. He drove those big trucks with the big trailers
- 15 that are attached to the truck all over California. He did that
- 16 | for -- how many years?
- 17 UNIDENTIFIED SPEAKER: 30 years.
- MS. HENDRICKS: 30 years.
- 19 BY MR. COLLINS:
- 20 Q. And, I guess, as a colleague of mine says, he failed
- 21 retirement?
- 22 A. I guess, yeah.
- 23 Q. And you said he really enjoyed, he really enjoyed his job?
- 24 A. Yeah. Most days.
- 25 Q. Okay. In general, do you know -- let's talk about that

- 1 particular bus. In general, did he say anything to you about any
- 2 issues he was having with that bus?
- 3 A. No. I never heard anything.
- 4 Q. And it's our understanding from the school district, and you
- 5 may or may not know, that was his regular bus. He usually drove
- 6 | the same bus?
- 7 A. Yeah.
- 8 Q. Okay. On Tuesday -- actually, let's back up. Let's go back
- 9 to Saturday. Do you know what time he woke up Saturday morning?
- And I didn't say this before. It's okay to say I don't know.
- 11 There aren't any wrong answers in this. We're just looking for
- 12 information, and if it's not there, it's not there.
- 13 A. Yeah.
- 14 Q. If it is there, we just need to know it.
- 15 A. I have to think what we were -- I don't remember what we did
- 16 Saturday.
- 17 UNIDENTIFIED SPEAKER: Saturday was the wrestling tournament.
- 18 MS. HENDRICKS: Oh, yeah. So we went up to -- yeah. So --
- 19 | well, he didn't get up, he probably didn't get -- I -- he probably
- 20 didn't get up till between 8 and 9 Saturday.
- 21 BY MR. COLLINS:
- 22 Q. Okay. And just in general, what did you guys do that day?
- 23 A. Then we went to the wrestling tournament at the high school.
- Q. Okay. And when was the tournament running from? What times
- 25 | was that?

- 1 A. It started at 10 --
- 2 UNIDENTIFIED SPEAKER: You guys probably left about 3 maybe.
- 3 MS. HENDRICKS: Yeah.
- 4 BY MR. COLLINS:
- 5 Q. Okay. And do you remember what you did after that?
- 6 A. Yeah, we came home. Had my granddaughter that's 5 with us.
- 7 | She came home with us, didn't she? And she stayed all night with
- 8 us, yeah.
- 9 Q. Okay. Do you know what time he went to bed Saturday night?
- 10 A. I want to say between 10 and 11.
- 11 Q. Okay. And then Sunday morning, what time would he have
- 12 gotten up?
- 13 UNIDENTIFIED SPEAKER: That's when we went to Lincoln.
- 14 MS. HENDRICKS: Huh?
- 15 UNIDENTIFIED SPEAKER: That's when we went to Lincoln. So he
- 16 | would have gotten up fairly early.
- MS. HENDRICKS: Yeah. He probably was up, yeah, between 8
- 18 and 9.
- 19 BY MR. COLLINS:
- 20 Q. Okay. And you went to Lincoln that day?
- 21 A. I didn't. Denton and him went to Lincoln.
- MR. COLLINS: You and your grandfather did. Okay. And how
- 23 long were you -- when did you leave to head out to Lincoln?
- GRANDSON: We left around 10:30.
- MS. HENDRICKS: No. You left later.

- 1 GRANDSON: No, we left at 11:30.
- 2 MS. HENDRICKS: Yeah.
- 3 GRANDSON: We went to church for the first half of it.
- 4 MR. COLLINS: Okay. And how long were you in Lincoln?
- 5 GRANDSON: We probably were there till like 3 or 4.
- 6 MR. COLLINS: And then came back home?
- 7 GRANDSON: And then came back.
- 8 MR. COLLINS: Okay. Anything unusual happen in Lincoln? And
- 9 I'm asking here did he have -- did your grandfather have anything
- 10 -- say anything about not feeling well or did he hurt himself any
- 11 way?
- 12 GRANDSON: (No audible response.)
- 13 BY MR. COLLINS:
- 14 Q. Okay. And then, Ms. Hendricks, what time would you say he
- 15 | went to bed Sunday evening?
- 16 A. Between 9 and 10 probably.
- 17 Q. Okay. And Monday, did he drive Monday?
- 18 A. (No audible response.)
- 19 Q. So what time would he have gotten up?
- 20 A. He usually gets up around 4:30, 4:30 and 5.
- 21 Q. Okay. And do you know what time he usually leaves the house
- 22 to go get the bus and start?
- 23 A. About 6:15, 6:20.
- 24 Q. Okay. And on Monday, in particular, between the morning set
- of routes, what does he usually do? Does he come back home?

- 1 A. Yeah. He might hang out at the bus barn for a while.
- 2 Q. I met several of the drivers and Nick, and I can see that it
- 3 | might be a draw to hang out there a little while and sit in
- 4 | chairs, and maybe have a donut and shoot the breeze for a little
- 5 bit.
- 6 A. Yeah. Sometimes I never know when he was going to come home
- 7 | because he's hanging out at the bus barn. So --
- 8 Q. Do you remember when he came home on Monday?
- 9 A. Yeah. He came home by 9 or so because we go to a Bible study
- 10 at 10:00 at church.
- 11 Q. Okay.
- 12 A. And he was home.
- 13 Q. And you did that on Monday?
- 14 A. Yeah.
- 15 Q. You went to the Bible study? And how long does that run?
- 16 A. Hour.
- 17 Q. Hour. And then what did you do after that?
- 18 A. Came home, had lunch. He was here until it was time to go
- 19 drive his bus again, and he leaves about quarter till 3 to go
- 20 drive the bus in the afternoon.
- 21 Q. Okay. And he's -- and when does he return home usually from
- 22 that?
- 23 A. Usually after 5 normally.
- 24 Q. And do you recall if that was -- it was about normal on
- 25 Monday?

- 1 A. Um-hum.
- 2 Q. Okay.
- 3 A. On Monday night he had a city council meeting
- 4 Q. Oh, he did. Okay. And how late did that keep him out and
- 5 about?
- 6 A. It wasn't late. It was between 8 and 9 he got home.
- 7 Q. And do you know what time he went to bed?
- 8 A. Between 8 and 9.
- 9 Q. Got home, went to bed. Okay. And on Tuesday, the day of the
- 10 crash, his day would have looked a lot like Monday? About the
- 11 same time getting up, the same --
- 12 A. Um-hum.
- 13 Q. Okay. On Monday after driving the bus, did he mention
- 14 | anything unusual happening that day particularly with the bus?
- 15 A. Uh-uh.
- 16 Q. Okay. In general, would you say that he usually slept pretty
- 17 | well? If he got the sleep he was looking to get, he would be
- 18 refreshed in the morning?
- 19 A. Somewhat, but he -- he was scheduled to have back surgery
- 20 | yesterday because --
- 21 Q. Okay.
- 22 A. So lately he's been having a hard time getting comfortable in
- 23 bed because he has to lay a certain way for his -- because of his
- 24 back.
- 25 Q. I can understand that. Do you know what he did to his back

- 1 or was it -- did he do something or was this an issue that had
- 2 been going on?
- 3 A. It's a degenerated --
- 4 UNIDENTIFIED SPEAKER: Disk.
- 5 MS. HENDRICKS: Disk.
- 6 MR. COLLINS: Okay.
- 7 MS. HENDRICKS: Disk was -- he had surgery in January of this
- 8 year where they put bars in, and put some things to raise the
- 9 disk.
- 10 UNIDENTIFIED SPEAKER: Because they were rubbing on each
- 11 other. Right?
- 12 MS. HENDRICKS: Yeah. I could show --
- 13 MR. COLLINS: Okay.
- MS. HENDRICKS: Actually, and then the one above where they
- 15 | did it --
- 16 UNIDENTIFIED SPEAKER: Pinched.
- 17 MS. HENDRICKS: -- it came down and pinched.
- 18 BY MR. COLLINS:
- 19 Q. Okay. So they did -- he had had a problem, they went and
- 20 | fixed in January, and as a result or somehow after that, now the
- 21 problem has moved up so we have to go in and fix it again.
- 22 A. Yeah, that --
- 23 Q. I do understand. I did something, grabbed something with my
- 24 left arm 10 years ago working a case, and twisted my neck, and
- 25 they ended up having to do the same sort of thing, just higher up.

- 1 And I understand -- it was my arm, but I couldn't move my arm into
- 2 | a comfortable position. So I imagine he had trouble. It's not
- 3 good when you get in there. So --
- 4 A. Yeah.
- 5 Q. I'm sorry that he had to go through that.
- 6 Okay. Was he taking any medication for the back or for any
- 7 other reason?
- 8 A. He was not on any pain medication because he was going to
- 9 have surgery. So only thing he took was Tylenol.
- 10 Q. Okay. How long had he been not on any pain medication?
- 11 A. Since December 7th.
- 12 Q. Okay. So since the 7th. Okay. Was he taking any
- 13 prescription medication for anything else?
- 14 A. Yeah.
- 15 Q. Do you know what those were by any chance?
- 16 A. I can show you the paper. Don't ask me what they're for
- 17 | though because I --
- 18 Q. Okay. I promise I won't.
- 19 A. I'll give you these. So they actually put --
- 20 Q. And I have actual cards. If you don't want to -- I have a
- 21 photocopy. I'm happy to give you one of those too. I don't need
- 22 to be stingy.
- 23 A. This is -- I think these are all on that --
- 24 Q. Instead of just either writing them down or reading them out
- 25 loud, would you mind if we just took a picture of this?

- 1 A. Sure.
- 2 UNIDENTIFIED SPEAKER: I can give you a photo. She made a
- 3 copy of it too.
- 4 MR. COLLINS: That would be, that would be great too, if you
- 5 | wouldn't mind.
- 6 UNIDENTIFIED SPEAKER: I wouldn't.
- 7 MR. COLLINS: And what we'll do is -- it's rare for us to
- 8 find, but we do make -- we do look at medications people are
- 9 taking because some of them can affect your ability to drive.
- 10 Again, the majority of our cases, that's to tell the armchair
- 11 quarterbacks, no, that wasn't an issue. But it is one of the
- 12 things we look at. We have a doctor on board, and he'll just take
- 13 a quick look and -- or she; we have two -- will take a quick look
- 14 and just let me know, no, that's -- I don't even need to know
- 15 | what's going on, but they'll take a look, say, no, that medication
- 16 does this and it doesn't worry about driving or, yeah, it might.
- 17 But we'll dig into that.
- 18 MS. HENDRICKS: And, you know, and I'm not sure if he -- some
- 19 of these they had him stop taking, too, because of his --
- 20 BY MR. COLLINS:
- 21 O. Because of the --
- 22 A. -- surgery.
- 23 Q. -- procedure?
- 24 A. Yeah.
- 25 Q. Okay. And you said -- was the only over-the-counter thing he

- 1 | took, that would be Tylenol, you said, and that was for pain.
- 2 A. He took vitamins but --
- 3 Q. Vitamins, okay. And how was he -- do you know, in general
- 4 | how would you describe how he was feeling Monday, Tuesday? Was he
- 5 | feeling okay or was -- had he -- did he have a cold? Was he
- 6 | having any short-term health issues? I think Iowa has gotten to
- 7 | me. My voice is getting husky and I keep coughing. So --
- 8 A. Yeah. He had a little allergy. He had a little coughing,
- 9 but nothing real bad.
- 10 Q. It didn't seem bad to you? Okay.
- Going back to sleep. Did he ever have any problems falling
- 12 asleep, waking up, that sort of thing?
- 13 A. He could fall asleep real easy.
- 14 Q. Would he do it almost too easily or was it just if nothing
- 15 | else was going on he could relax enough that he'd take a little
- 16 nap?
- 17 A. Yeah, he would.
- 18 Q. Okay. Do you know if he -- would he wake up frequently
- 19 during the nights or would he generally kind of sleep straight
- 20 through if he was asleep?
- 21 A. No. He's had to wake up to go to the bathroom a lot.
- 22 Q. Okay. Couple times a night?
- 23 A. (No audible response.)
- 24 Q. Okay. Other than his back, did he have any other health
- 25 issues? And the allergies that day. Were there any other health

- 1 | concerns for him?
- 2 A. No. Not that I know of, you know.
- 3 Q. Okay.
- 4 UNIDENTIFIED SPEAKER: He just had a history and physical,
- 5 | right?
- 6 MS. HENDRICKS: Yeah. He had his physical on the 7th for his
- 7 surgery.
- 8 UNIDENTIFIED SPEAKER: For his surgery, so --
- 9 BY MR. COLLINS:
- 10 Q. Okay. Do you guys have a family doctor you prefer to go to?
- 11 A. He goes to Dr. Johannes.
- 12 Q. Okay.
- 13 A. Is the doctor's name.
- 14 Q. Okay. And the doctor that was going to do the back surgery?
- 15 A. Dr. Music.
- 16 Q. Music. Okay. His vision, in general how do you think he
- 17 | would describe his vision?
- 18 A. Good. He had cataract surgery last year, and so he never had
- 19 to wear glasses after that. He only wore glasses just to read
- 20 close up. Otherwise, he didn't wear his glasses anymore.
- 21 Q. And the surgery helped him? The surgery for cataracts helped
- 22 him?
- 23 A. Yeah.
- 24 Q. Good. How about his hearing? Other than my wife always
- 25 | telling me I have selective hearing, I can't hear her, would he

- 1 describe his -- how would he describe his hearing?
- 2 A. He had trouble hearing some.
- 3 UNIDENTIFIED SPEAKER: He had the TV pretty loud.
- 4 BY MR. COLLINS:
- 5 Q. But that was it? He didn't think he needed to seek anything
- 6 like a hearing aid or use any -- normal conversations he could do
- 7 okay?
- 8 UNIDENTIFIED SPEAKER: Yeah. I think in normal conversations
- 9 he was fine.
- 10 MS. HENDRICKS: He would tell me what --
- 11 UNIDENTIFIED SPEAKER: He would always just turn the TV up
- 12 because she'd be making a racket in the kitchen, I think.
- MS. HENDRICKS: And he would tell me, look at me when you're
- 14 talking to me.
- 15 MR. COLLINS: Yeah.
- 16 MS. HENDRICKS: And I don't speak loud sometimes.
- MR. COLLINS: I don't know that I blame you for that. I have
- 18 to tell my children to do that. One of them loves to talk to me
- 19 when he's facing the other way, and I just can't hear him when he
- does that. All the sound's going that way, son, turn around.
- 21 But --
- 22 BY MR. COLLINS:
- 23 Q. Okay. Did your husband drink alcohol?
- 24 A. No.
- 25 Q. Never? Okay.

- 1 A. He did 20, back 20 some years ago, but he --
- 2 UNIDENTIFIED SPEAKER: 25 years ago.
- 3 MS. HENDRICKS: 25 years ago, he stopped and never took
- 4 another drink.
- 5 MR. COLLINS: Okay.
- 6 UNIDENTIFIED SPEAKER: Drinking and smoking.
- 7 MS. HENDRICKS: Yeah.
- 8 MR. COLLINS: And he smoked 25 years ago, but hasn't since
- 9 then, too?
- 10 UNIDENTIFIED SPEAKER: Yeah.
- 11 BY MR. COLLINS:
- 12 Q. Okay. This one always makes people laugh. We've talked
- 13 about alcohol. We've talked about prescription drugs. We've
- 14 talked about over-the-counter drugs. There's one more class of
- 15 drugs. It's the kind that are illegal. Did he --
- 16 A. (No audible response.)
- 17 Q. No. Okay. I wouldn't have guess so, but I'm supposed to
- 18 ask, so I did.
- 19 When he went out to drive the bus, did he take his cell phone
- 20 | with him?
- 21 A. Um-hum.
- 22 Q. Do you know if the school district had any policies on
- 23 whether or not he could use it while he was driving?
- 24 A. I'm sure -- no, I'm sure he wasn't supposed to be using it.
- 25 Q. And generally speaking, he wouldn't use it while he was

- 1 driving?
- 2 A. If they -- you know, they have the things on the bus, they
- 3 can call in if they need something.
- 4 Q. The radios?
- 5 A. Yeah, so they don't use their phones normally.
- 6 Q. Okay.
- 7 A. They use their radios.
- 8 Q. And to the best of your knowledge, he didn't report any
- 9 problems with the bus Monday or Tuesday?
- 10 A. Not that I know of.
- 11 Q. Had he ever mentioned having any issues with that particular
- 12 driveway, that particular stop?
- 13 A. Uh-uh.
- 14 Q. Okay. Had he had any issues with any of the students on the
- 15 | bus or in particular the student that he was picking up at that
- 16 stop?
- 17 A. No. She was one of his favorites.
- 18 Q. I had the chance to talk to -- oh, I'm sorry. I've met so
- 19 many people, I lose names. But the gentleman substitute driver up
- 20 at the bus barn yesterday, and he said -- first he had very nice
- 21 things to say about your husband, but he also said the same thing,
- 22 that when they drove those routes, the drivers got to know the
- 23 kids, the kids got to know all the drivers, and everybody, you
- 24 know, were close in that way. Which in my kids' school district,
- 25 | yeah, that doesn't happen. It's much bigger and much drivers,

- 1 so --
- 2 A. Yeah, and when the kids would see Donnie, the kids, little
- 3 kids that drive his bus, they would call, waving him or holler at
- 4 him. So --
- 5 MR. COLLINS: Sheryl, I'm sure I'm forgetting something, but
- 6 I'll stop. And if you have a few questions, I will think real
- 7 hard about all the things I've forgotten to ask.
- 8 BY MS. HARLEY:
- 9 Q. Just one question. Bob Wright, who is Mr. Wright? Is he a
- 10 | neighbor of yours?
- 11 A. Bob Wright?
- 12 O. Yeah.
- 13 A. I don't know that name.
- 14 Q. All right. One of the reasons I'm asking is someone that --
- 15 | someone was talking, and I'm just trying to figure out who he is.
- 16 He actually may be a neighbor of the little girl's, but they had
- 17 | actually spoken with a neighbor. And so I was just wondering if
- 18 | it was your neighbor or if it was their neighbor. So --
- 19 UNIDENTIFIED SPEAKER: I don't even know that name. I mean,
- 20 | we pretty much know everyone here and I don't --
- MS. HARLEY: Yeah.
- 22 UNIDENTIFIED SPEAKER: That name doesn't sound familiar at
- 23 all.
- MS. HARLEY: It's probably their neighbor that --
- 25 UNIDENTIFIED SPEAKER: But even, even out there we would

- 1 know. I mean, we know -- we just pretty much know everyone here.
- 2 | So that name doesn't sound -- I mean there's Wrights out there,
- 3 but I don't know Bob.
- 4 MS. HENDRICKS: I don't know a Bob Wright.
- 5 UNIDENTIFIED SPEAKER: I know Marion and Donna and --
- 6 MS. HARLEY: Do you know Mr. Cooper?
- 7 UNIDENTIFIED SPEAKER: Yeah.
- 8 MS. HARLEY: Yeah, okay. All right. Mr. Cooper was the one
- 9 that was saying a lot of very nice things.
- 10 MS. HENDRICKS: He's a very nice guy.
- MS. HARLEY: Yeah. I guess he was a very good friend. So he
- 12 | had a lot of really nice things to say.
- 13 BY MS. HARLEY:
- 14 Q. So I understand that yesterday he was supposed to have this
- 15 surgery. I know that he was having some discomfort because of
- 16 this disk. Did it require him to actually need something to help
- 17 him walk? Did he walk with a cane?
- 18 A. If he had to walk very far.
- 19 Q. Yeah. Okay. But if he was walking around the house, he
- 20 | wouldn't need a cane?
- 21 A. No.
- 22 Q. No. Okay. Did he use a walker by any chance?
- 23 A. When he walked a long way.
- 24 Q. A long time. Or a long way.
- 25 A. And he could sit a long time, but he couldn't stand a long

- 1 time.
- 2 Q. Okay. So it was more like for his weight bearing issues if
- 3 he was standing up?
- 4 A. Yeah. But when he was sitting it was okay. He always said
- 5 the bus seat was comfortable.
- 6 Q. Oh, okay.
- 7 Q. So if he was walking around, and he's walking for a long time
- 8 and he didn't have his cane or his -- or the walker, would he have
- 9 trouble walking? Would he sometimes -- would he lose his balance?
- 10 A. (No audible response.)
- 11 Q. And all of this is actually because of the back?
- 12 A. Um-hum.
- 13 Q. Okay. All right. How long ago did that start with this new
- 14 issue with the back started?
- 15 A. I'm guessing it's been going on 3 or 4 months.
- 16 Q. Three or 4 months?
- 17 UNIDENTIFIED SPEAKER: Yeah, I think something like that.
- 18 MS. HENDRICKS: And it just got, it just got worse.
- 19 GRANDSON: Back surgery is what really messed him up.
- MS. HENDRICKS: Well, he was --
- 21 UNIDENTIFIED SPEAKER: He was real good there for --
- 22 GRANDSON: He said it was better but he said that that's what
- 23 made it worse.
- MS. HENDRICKS: Yeah.
- 25 UNIDENTIFIED SPEAKER: He was good. I mean, he walked --

- 1 gosh, he came home from the hospital after his last back surgery
- 2 and went to her volley ball game. I mean, he was feeling pretty
- 3 good for quite a long time, and then -- and then I think it took a
- 4 while to get back in to Dr. Music to have him finally figure out
- 5 what was going on with the -- with why it was almost reverting
- 6 from --
- 7 MS. HENDRICKS: Yeah.
- 8 UNIDENTIFIED SPEAKER: -- where he had been, so -- but as
- 9 soon as he got in, they scheduled the surgery, and it didn't take
- 10 long for him to figure it out and --
- 11 BY MS. HARLEY:
- 12 Q. Did he -- in addition to the pain, was there any kind of
- 13 numbness as far as his legs were concerned?
- 14 A. He never said it.
- MS. HARLEY: Okay. All right. Okay.
- 16 BY MR. COLLINS:
- 17 | Q. I understand that he would have used the cane and the walker
- 18 for long distance walking. Sitting was okay. The transition from
- 19 sitting to standing, and I'm asking specifically whatever happened
- 20 on the bus happened, would his back have given him any trouble
- 21 trying to get out of the seat and get out of bus or -- to the best
- 22 of your knowledge, or no or how would the problems he was having
- 23 affected that?
- 24 (Coughing) And I apologize. It's the -- either I'm allergic
- 25 to Iowa or --

- 1 A. Where's your home?
- 2 Q. Virginia.
- 3 A. Oh.
- 4 Q. Unfortunately, I have to work in D.C., but I live in
- 5 Virginia. But --
- 6 A. He wouldn't have -- he wouldn't -- well, in a emergency case
- 7 he probably would have moved fast, but normally he wouldn't move
- 8 real fast getting --
- 9 UNIDENTIFIED SPEAKER: It would have taken him a little bit
- 10 longer to get steady on his feet, I think, I mean, than you or I.
- MS. HENDRICKS: But the bus seat sits higher, so it's easier
- 12 to -- you know, it wasn't -- he didn't have to come up and down.
- 13 MS. HARLEY: Got it.
- 14 BY MR. COLLINS:
- 15 Q. So he, you don't -- you think, just based on observing him
- 16 and the problems he was having, that he would've been able to get
- 17 out of the bus seat pretty well? It might have taken him a few --

- 7 Q. I apologize. I normally bring a cheat sheet with me because
- 8 I never remember all the questions, and I've forgotten it. So I'm
- 9 trying to picture it in my head, and make sure I haven't forgotten
- 10 anything because I do want to minimize the disruption that I'm
- 11 | causing. I think -- and I'll also rely on my partner --
- 12 MS. HARLEY: All right.
- MR. COLLINS: -- to help me remember things. But we -- you
- 14 were kind enough to provide some medication information. We
