### 1 INTERVIEW

- (2:00 p.m.)
- 3 MR. FOX: Today is June 30th. The time is approximately
- 4 2 p.m. We are located at Cool Runnings in London, Kentucky. This
- 5 is the motor carrier that was involved in a crash on June 25th.
- 6 I'm an investigator with the National Transportation Safety Board
- 7 from the Washington D.C. office. I'm a highway accident
- 8 investigator.
- 9 We will go around the room. We have many parties here.
- 10 We're going to identify each person's name and spell their last
- 11 name and they're going to identify their title. So, I'm going to
- 12 go clockwise from my position.
- Go ahead, Sean.
- MR. ANDERSON: Sean Anderson, Federal Motor Carrier
- 15 Safety Administration, Kentucky Division.
- MR. FOX: And spell your last name, please.
- 17 MR. ANDERSON: A-N-D-E-R-S-O-N.
- 18 MR. BRAGG: My name is Kenny Bragg, NTSB, Office of
- 19 Highway Safety, Human Performance Investigator. My last name is
- 20 spelled B-R-A-G-G.
- 21 MR. LaPONTE: Michael LaPonte. I'm an investigator with
- 22 the National Transportation Safety Board. My last name is spelled
- 23 L-A-P-O-N-T-E.
- MR. FOX: Go ahead, Benjamin.
- MR. BREWER: Benjamin Brewer, last name spelled B-R-E-W-

- $1 \quad E-R.$
- 2 MR. FOX: Okay.
- 3 MS. PENNINGTON: Charity Pennington, passenger. My last
- 4 name is P-E-N-N-I-N-G-T-O-N.
- 5 MR. FOX: Okay, we have two other people I'm going to
- 6 move the microphone to.
- 7 MS. RICE: Pamela Rice. I'm the Division Administrator
- 8 for the FMCSA Division Office in Kentucky, and last name is
- 9 spelled R-I-C-E.
- 10 MR. JOHNSON: Michael Johnson. I'm an attorney for
- 11 Benjamin Brewer and Cool Runnings Express, Inc. Last name J-O-H-
- 12 N-S-O-N.
- MR. FOX: Okay, thank you. Thank you all for that.
- So the purpose of this interview is to speak to the
- 15 driver and the passenger that were involved in this accident. And
- 16 we wanted to start off with some introductions about who you are.
- 17 INTERVIEW OF BENJAMIN BREWER
- 18 BY MR. FOX:
- 19 Q. So, Mr. Benjamin, why don't you tell us your name and
- 20 your title and your employer?
- 21 A. I am Benjamin Brewer. I work for Cool Runnings Express
- 22 and that's --
- Q. What's your position there?
- 24 A. I'm a driver.
- Q. A driver. Okay.

- 1 MR. FOX: And then, ma'am, your --
- MS. PENNINGTON: I am Charity Pennington. I am
- 3 Benjamin's fiancée. I was a passenger.
- 4 MR. FOX: A passenger. Okay. Are you currently
- 5 employed?
- 6 MS. PENNINGTON: No.
- 7 MR. FOX: No. Okay.
- 8 BY MR. FOX:
- 9 Q. Benjamin, how did you start off in the business? Did
- 10 you -- when did you get your CDL?
- 11 A. I got them when I was 21.
- 12 Q. Okay. And did you go through a training program, a
- 13 driver education program or school?
- 14 A. No. I've been around trucks about all of my life.
- Okay. So can you approximate when that happened?
- A. What's that? Approximate?
- 17 Q. When did you start driving?
- 18 A. When I was 21.
- 19 Q. So you were -- started --
- 20 A. So, that'd be 18.
- Q. And how old are you today?
- 22 A. Thirty-nine.
- Q. You're 39? So you started approximately what year,
- 24 would you say, you got your CDL? Do you remember?
- 25 A. Yeah. Yeah, it'd be -- let's see -- about '97, '98,

- 1 probably.
- 2 Q. '97, '98?
- 3 A. Yeah, somewhere around in there, if I'm not mistaken.
- Q. Okay, 1997, 1998, and you got a CDL. How did you get
- 5 your CDL? Did you --
- A. I had to take a state test.
- 7 Q. And what state was that?
- 8 A. Kentucky.
- 9 Q. Kentucky? Have you been a resident your whole life here
- 10 in Kentucky?
- 11 A. Yeah.
- 12 Q. Okay. How did you prepare to get your CDL license?
- 13 A. I studied for them.
- Q. Okay. Did you have any formal training? Did you go to
- 15 truck driver school?
- 16 A. No, but I've been around trucks all my life.
- 17 Q. And how is that -- how did you get to be around trucks
- 18 all your life? Did you --
- 19 A. That's what -- family.
- Q. Was it in the family?
- 21 A. Family thing, yeah.
- 22 Q. Yeah. So did your parents drive or --
- 23 A. My dad did, yeah.
- 24 O. Your dad drove? Who did he drive for?
- 25 A. Hisself.

- 1 Q. He drove for himself? He was a -- what -- do you
- 2 remember what company? Did he have a --
- 3 A. I can't remember.
- Q. You can't remember what company it was? So, your dad --
- 5 did your dad, you know, give you some training? Do you remember?
- 6 A. Um-hum, just like any other dad does with their kid
- 7 around when they get their driver's license, I guess.
- 8 Q. Okay. All right, very good. So when you first got your
- 9 CDL, did you seek employment? Did you get a job working as a --
- 10 A. Yes.
- 11 Q. -- a truck driver?
- 12 A. Yeah.
- 13 Q. And do you recall who you first started working for?
- 14 A. Gerald Gregory.
- 15 Q. Gerald Gregory? Is that the name of a company or a
- 16 person?
- 17 A. He owns London Auto Sales.
- 18 Q. London Auto Sales? And what did you do while you were
- 19 employed there?
- 20 A. I delivered -- I hauled his vehicles, wrote his checks,
- 21 stuff like that.
- 22 Q. Were you operating a commercial motor vehicle --
- 23 A. Yeah.
- Q. -- a truck, at the time?
- 25 A. His, yeah.

- 1 Q. What kind of truck was it?
- 2 A. It was a, it was a -- I had several different ones. I
- 3 had a rollback with a three -- or two-car hauler on it, which you
- 4 had to have CDLs for. Then I had a three-car hauler -- four-car,
- 5 I believe it was, four-car hauler, and that's about it.
- Q. Okay.
- 7 MR. FOX: Mike, do you have the driver application?
- 8 When you get a second, if you could give it to me?
- 9 BY MR. FOX:
- 10 Q. So, this is approximately 1998 you got your license,
- 11 somewhere around in there?
- 12 A. I think so, yeah.
- Q. And you got this job with Gerald Gregory, and how long
- 14 were you employed there doing these different jobs?
- 15 A. I can't remember how long I was employed for him,
- 16 probably 8 years, 7 years -- 7.
- 17 Q. Eight or 7 years?
- 18 A. I can't really remember. It might have been a shorter
- 19 time than that.
- 20 MR. JOHNSON: We don't have a printed copy of it.
- MR. FOX: Yeah, it's here somewhere, I thought.
- MR. JOHNSON: It was here yesterday. I think the --
- 23 unless it's in this file. I think --
- MR. FOX: We're looking for the driver application, so
- 25 that's the background noise here.

- 1 BY MR. FOX:
- 2 Q. So how long were you employed for Gerald Gregory?
- 3 A. I really can't recall.
- Q. Okay. Do you remember getting another job after that?
- 5 A. Um-hum.
- 6 Q. What was that?
- 7 A. I believe I went to Bulkmatic.
- 8 Q. Bulkmatic?
- 9 A. Yeah.
- 10 Q. When you were working for Gerald Gregory, did he put you
- 11 through any kind of training program at all?
- 12 A. Uh-uh.
- Q. And were you operating a Class A license at the time?
- 14 A. Yes.
- 15 Q. Okay.
- MR. JOHNSON: Pull up his application from that -- it's
- 17 in the email I sent you about --
- 18 MR. FOX: We have a hardcopy of it somewhere in that,
- 19 but it's -- I don't know where it is right now.
- 20 MR. JOHNSON: The carrier took it back. It's not here
- 21 at the moment.
- MR. FOX: All right. We'll move along.
- 23 BY MR. FOX:
- Q. So the second job that you had was bulk something?
- 25 A. Bulkmatic. It was --

- 1 Q. Bulkmatic? And do you remember what time frame that
- 2 was?
- 3 A. No, I can't recall what time it -- what time frame it --
- 4 I think I worked for them maybe a year.
- 5 Q. Maybe a year?
- A. Yeah.
- 7 Q. S, that's around the '98/'99 time frame?
- 8 A. No, it'd be after that.
- 9 Q. After that, do you think?
- 10 A. Yeah, because I started for Gerald in that year, so --
- 11 Q. Okay. So you don't know when you worked for Bulkmatic?
- 12 A. No, I can't remember the year I started exactly.
- Q. And you were there approximately a year?
- 14 A. Somewhere around a year, yeah.
- Q. And what was your position there? What did you do?
- 16 A. Truck driver.
- 17 Q. Truck driver? What kind of equipment were you
- 18 operating?
- 19 A. Tankers.
- Q. Hazmat?
- 21 A. No.
- Q. Was it -- what were you hauling?
- 23 A. Flour, whatever, you know, they put in them.
- 24 Q. Okay.
- 25 A. It's for food products or --

- 1 Q. Food, poultry?
- 2 A. -- animal products --
- 3 Q. Gotcha.
- 4 A. -- you know, in some, you know.
- Q. Okay.
- 6 A. Plastics in some.
- 7 Q. Gotcha. Did you have a tanker endorsement --
- 8 A. Um-hum.
- 9 Q. -- at that time?
- 10 A. Yeah.
- 11 Q. Did you pull doubles or just singles?
- 12 A. Just single.
- Q. Okay. Where were you running when you were hauling this
- 14 product? Do you remember?
- 15 A. I think from Lexington to -- it was going back and forth
- 16 from Lexington to Cleveland, Cleveland, Tennessee maybe? Or not
- 17 Cleveland -- it's right outside of Knoxville, I was going every
- 18 day or every couple days, every other day or something.
- 19 Q. Okay. And do you remember how long you were working
- 20 there? Or you can't recall?
- 21 A. I can't recall how long I worked for Bulkmatic.
- 22 Q. I see. What was the next position after Bulkmatic?
- 23 A. Hilltop Transportation.
- Q. Hilltop Transportation? Do you remember approximately
- 25 what year that was?

- 1 A. I worked for him for around 12 or 13 years.
- Q. Wow, you were there a long time.
- 3 A. Yeah.
- Q. Thirteen years. And what were you doing there, Billy --
- 5 I mean, Benjamin? I'm sorry.
- A. I was hauling sugar, oil, and flour products.
- 7 Q. Sugar?
- 8 A. Yeah.
- 9 Q. Was that also a tanker?
- 10 A. Yes.
- 11 Q. A tanker. And so you were there a pretty long time?
- 12 A. Um-hum.
- 13 Q. And do you think -- do you remember what years that
- 14 might have been approximately?
- 15 A. I'm trying to remember.
- Q. So it had to be maybe the 2000s, right, maybe, or into
- 17 there?
- 18 A. I'd say -- I probably started for him around '01 or '02,
- 19 I quess.
- 20 Q. I'm sorry?
- 21 A. It was around 12 years, I guess, I worked for him.
- 22 O. Around 2001 or so?
- 23 A. Yeah, I guess so.
- Q. All right, I found -- we've located your application.
- 25 I'm just going to pull it out here and see if we can -- help us

- 1 recall. Maybe you have it written down here. No, I just have
- 2 these three -- these couple here.
- 3 MR. FOX: I'm showing the driver his application to help
- 4 refresh his memory.
- 5 BY MR. FOX:
- 6 Q. So I don't see Hilltop on your resume there. So when
- 7 you were at Hilltop Transport, we're going to say it's in the 2000
- 8 time frame to somewhere in there. That would be fairly recent, I
- 9 would guess. And you said you were hauling tanks, and did you
- 10 receive any training while you were there? Did you guys have any
- 11 kind of training program?
- 12 A. No.
- 13 Q. They didn't train you guys?
- 14 A. To drive trucks or --
- 15 Q. Yes, sir.
- 16 A. No.
- 17 Q. Did you do any kind of driver training the whole time
- 18 you were there?
- 19 A. I can't remember. I mean, that's -- I don't think we
- 20 did.
- 21 Q. Safety meetings at any --
- 22 A. Yeah, we had a few safety meetings.
- Q. They did have safety meetings?
- 24 A. Yeah.
- Q. Okay. All right. So where did you work next?

- 1 A. Circo.
- 2 Q. Circo?
- 3 A. Um-hum.
- 4 Q. Circo.
- 5 A. No, Greer's is where I worked next. I worked for
- 6 Greer's Construction.
- 7 Q. Greer's?
- 8 A. Yeah.
- 9 Q. Okay. Because we have HT Warehouse on here, and then
- 10 you have Circo above it.
- 11 A. Yeah, I worked for Greer's.
- MS. PENNINGTON: HT was -- he was just talking about
- 13 Hilltop.
- MR. BREWER: Yeah, HT is Hilltop.
- 15 BY MR. FOX:
- Q. Oh, that's Hilltop?
- 17 A. Yeah.
- 18 Q. Okay, I got you.
- 19 A. Yeah.
- Q. And then the next one was this Cinco [sic]?
- 21 A. Circo.
- MS. PENNINGTON: Circo.
- BY MR. FOX:
- 24 Q. Circo.
- A. Well, the next one would have been Greer's, Greer's

- 1 Construction.
- 2 Q. Greer's Construction?
- 3 A. Um-hum.
- 4 Q. And what did you do there, sir?
- 5 A. I drove trucks and labor.
- 6 Q. And what kind of equipment were you operating?
- 7 A. Six -- well, just whatever type of trucks they needed me
- 8 to drive, I mean.
- 9 Q. Was it dump truck or tractor trailer?
- 10 A. Anything. Whatever they needed me to do, that's what I
- 11 done.
- 12 Q. I see. And were you driving local or across the road?
- 13 A. Just -- nothing way out of town. I mean, it stayed
- 14 within the state.
- Q. Okay. And let's see. You -- your resume says or your
- 16 application says from October to December of 2014 -- I mean --
- 17 yeah, 2014. So then that brings us up to Ryder, I guess, is your
- 18 next one.
- 19 A. Yeah.
- 20 Q. Correct?
- 21 A. Um-hum.
- Q. And then how long were you employed at Ryder?
- 23 A. Eight months, Louisville.
- Q. Ryder Transportation. Now --
- 25 A. Right.

- 1 Q. -- is the same -- is this Ryder Logistics or --
- 2 A. Ryder Logistics, yes.
- 3 Q. Ryder Logistics? And where -- let's see. Where are
- 4 they out of?
- 5 A. They was based out of Alabama, I guess, it is, or their
- 6 -- my boss -- but my boss then was out of Alabama.
- 7 MS. PENNINGTON: Miami (indiscernible).
- 8 MR. BREWER: Huh?
- 9 MS. PENNINGTON: Miami is the --
- MR. BREWER: Miami is their main hub, I believe.
- BY MR. FOX:
- 12 Q. Okay. And what did you do while you were employed
- 13 there?
- 14 A. Drove a truck.
- 15 Q. Okay. What kind of truck did you drive?
- 16 A. Eighteen-wheelers and dry box and -- hauled car parts
- 17 more than anything.
- 18 Q. It was dry van operation?
- 19 A. Um-hum.
- Q. Did you drive any tanks while you were there?
- 21 A. Uh-uh.
- 22 Q. No? Okay. Transport tanks. I notice on your
- 23 application it says reason for leaving and it says a road rage
- 24 driver.
- 25 A. Uh-uh.

- 1 Q. Can you elaborate on that incident?
- 2 A. I had a road rage driver run over into my -- come over
- 3 at me in my lane of traffic with two kids with him. So I took the
- 4 other path and went out of the lane, then he come in at -- he come
- 5 in at me and I went out of the lane --
- Q. I see.
- 7 A. -- because of the two children.
- 8 Q. Oh, my. So, let me get this straight. You were
- 9 traveling in your lane of traffic and another 18-wheeler, did you
- 10 say, a car?
- 11 A. It was a car, another road rage -- he's -- the car --
- 12 what do you want to know now? Excuse me.
- 13 Q. I was saying we're just -- I'm trying to refresh your
- 14 memory on the accident here that's here, that you wrote in here.
- 15 I was just trying to get some clarification.
- 16 A. Right.
- 17 Q. You said that there was a driver who was in your lane --
- 18 A. In a -- he was in a vehicle.
- 19 Q. He was in a car?
- A. He was in a car, yes.
- 21 Q. And he came over into your lane?
- 22 A. Yes.
- 23 Q. And then you moved over into the other lane --
- A. Um-hum.
- 25 Q. -- to avoid hitting him?

- 1 A. Yeah, from avoid -- yeah, to keep from him hitting me,
- 2 yeah.
- 3 Q. I see. And what were the consequences of this accident?
- 4 A. The consequences was that -- the consequences was the
- 5 two children got to live, I guess, and I ended up clipping the
- 6 back of a tanker and they said that it costed them over \$30,000
- 7 and that they no longer needed me. So they --
- 8 Q. This is Ryder talking to you?
- 9 A. Yes.
- 10 Q. So Ryder terminated you because of that?
- 11 A. Yes.
- 12 Q. Okay. All right. Were you charged in that accident?
- 13 A. No.
- 14 Q. You did not receive a ticket or a citation?
- 15 A. Uh-uh.
- 16 Q. Okay.
- MS. PENNINGTON: They've starved us, haven't they?
- MR. BREWER: Yeah.
- 19 BY MR. FOX:
- 20 Q. Since your employment with the -- so when did you start
- 21 with Cool Runnings?
- 22 A. And with Ryder, 2 weeks later, another driver up in
- 23 Indiana done the same thing. Another road rage driver had a
- 24 incident with me, and I got a hold of a cop's attention and he
- 25 tried to run him down and, you know, it was just one of them

- 1 things.
- Q. Yeah, I see. And just for clarification, when did you
- 3 start working for Cool Runnings here? When was your first day?
- 4 A. The first trip out would have been --
- 5 MS. PENNINGTON: Tuesday.
- 6 MR. BREWER: Hum? I think --
- 7 MS. PENNINGTON: Was it Tuesday?
- 8 MR. BREWER: Tuesday, I guess it was, yeah.
- 9 BY MR. FOX:
- 10 Q. Okay. So, for clarification, you filled out this
- 11 application on 6/16, June the 16th. Who did you interview with
- 12 the company?
- 13 A. Billy Jack Sizemore.
- Q. Okay, Billy Sizemore? How did you hear about the
- 15 company?
- 16 A. I just kept looking and kept looking and a friend of
- 17 mine recommended me.
- 18 Q. A friend? Okay.
- 19 A. Yeah.
- 20 Q. And so you came and filled out the application. Walk me
- 21 through the sequence of events. After you fill out the
- 22 application, what happened next in the process before you start --
- 23 you got your truck? Did you have to do a pre-employment drug
- 24 test?
- 25 A. Yes. Yes, I did.

- 1 Q. Okay. When was that? Do you recall?
- 2 A. It was the day before. It's a couple of days before I
- 3 left out, I guess.
- Q. Okay. And then when you came here to the company, did
- 5 you get any training on the vehicle, the equipment, the tractor
- 6 trailer? Was there any introduction to the equipment?
- 7 A. I can't recall.
- 8 Q. You can't recall?
- 9 A. No. I've been a little fuzzy lately.
- 10 Q. Okay. Well, did -- before you were hired, did Billy
- 11 Sizemore, the owner, did he take you out for a road test to see if
- 12 you could drive the vehicle?
- 13 A. No. I figured I'd be -- no.
- Q. No. So he did not take you out and -- when you came
- 15 into the company approximately on Monday of that week, did he give
- 16 you any kind of training at all? Did you come in -- do you
- 17 remember coming in here and did he provide you any videos or
- 18 safety briefings or anything?
- 19 A. No.
- 20 Q. No. So did he -- can you walk me through the
- 21 arrangement? What did -- how did you get the truck?
- 22 A. He -- we sit down and had lunch together. He told me,
- 23 pretty much, a little bit about his company and what he done and
- 24 asked me if I wanted the job. And I said, yeah, I'd love to have
- 25 it because I've been having a hard time finding work and I need a

- 1 job.
- Q. Okay. And was that on Monday, the 22nd, I believe?
- 3 A. I can't recall exactly what day it was.
- 4 Q. Okay.
- 5 MR. FOX: Do you remember when he got the truck? When
- 6 did he take possession of the truck?
- 7 MS. PENNINGTON: I think we -- I think it was on that
- 8 Monday. We cleaned it --
- 9 MR. BREWER: We started cleaning it, yeah.
- MS. PENNINGTON: -- a day or two because it was nasty on
- 11 the inside.
- 12 BY MR. FOX:
- 13 Q. Yeah, you were telling me there were dog hairs and
- 14 everything. So, from what I believe I understood, I think maybe
- 15 you got the truck on the Monday. He probably gave you the keys
- 16 and said here you all go and then we're going to have a load for
- 17 you. Is that the way you can recall it to be?
- 18 A. Yeah, I think so, yeah.
- 19 Q. And then you -- yeah, I think that you, like you said,
- 20 you --
- 21 MS. PENNINGTON: We cleaned for several days.
- MR. BREWER: Yeah.
- MR. FOX: You cleaned for several days. So did you get
- 24 it before Monday, do you think?
- MS. PENNINGTON: Didn't you get it later in the week the

- 1 week before? Because we were like, oh, my gosh, we need to go
- 2 then.
- 3 MR. BREWER: Yeah, it seems like it -- well, it seems
- 4 like it was, yeah.
- 5 BY MR. FOX:
- Q. Okay.
- 7 A. It seemed like it was coming up on a weekend or
- 8 something.
- 9 Q. Yeah, it was coming up on a weekend.
- MS. PENNINGTON: It was a weekend, yeah.
- BY MR. FOX:
- 12 Q. The 22nd, I think, was Monday.
- 13 A. Yeah.
- 14 Q. So --
- MS. PENNINGTON: We didn't really take the truck
- 16 anywhere.
- MR. BREWER: No, we never took it out.
- MR. FOX: No.
- MS. PENNINGTON: It was actually sitting in the lot, but
- 20 we would just go clean.
- MR. FOX: Right. You had keys to it. You could open it
- 22 up --
- MR. BREWER: Yeah.
- MR. FOX: -- and you could go in there, put your stuff
- 25 in there, and clean it out or start to prepare it for your

- 1 journey, for you trip?
- 2 MS. PENNINGTON: Yeah. We took the truck, when we left
- 3 for Horse Cave.
- 4 MS. BANKS: Um-hum. That was the first -- yeah, that's
- 5 the first time I had it on the road. And then, when I took it,
- 6 took it to the car wash and washed it off and --
- 7 MR. FOX: Okay. All right. So we're going to get into
- 8 that here in a few minutes. So what we want to do -- I know it
- 9 may be uncomfortable, but we're going to separate the two of you
- 10 and I need to speak to just Benjamin right now and talk to him
- 11 about the trip, and then I'll bring you back in a few minutes and
- 12 then we'll talk about that. So I don't know where you can go.
- 13 There's seating out there.
- MS. PENNINGTON: I'll find somewhere.
- 15 MR. FOX: So --
- 16 UNIDENTIFIED SPEAKER: Yeah. She can go over in the
- 17 office with --
- MR. FOX: Yeah, you can --
- 19 UNIDENTIFIED SPEAKER: -- Preston and Billy, upstairs.
- 20 MR. FOX: Yeah. If you want, you can go up there with
- 21 Preston and Billy.
- MR. BREWER: Okay. I love you.
- Why does she have to be separated from me? I mean, is
- 24 this something that's going to be happening or -- I mean, you
- 25 know, we've been separated for 15 hours down in Chattanooga. I

- 1 mean --
- 2 MR. BRAGG: It won't be long.
- 3 MR. BREWER: I mean, you know, it's kind of --
- 4 MR. BRAGG: Here's the thing. We value both of you
- 5 all's perspective about what happened, but, I mean, it's just a
- 6 human thing that sometimes your perspective is to kind of lean on
- 7 each other and we want your independent perspective. So that's
- 8 why we're going to have you all separated.
- 9 MR. FOX: Right. And to be --
- MR. BRAGG: It won't be long.
- MR. FOX: Right. And to be -- you know, you were
- 12 driving the truck, so --
- MR. BREWER: Um-hum.
- MR. FOX: -- we need to really talk to you. And like
- 15 Kenny is saying, if she's saying, no, you turned left, and you're
- 16 saying, no, I turned right, it creates a conflict. So it's just
- 17 better just to hear your perspective --
- MR. BREWER: Okay.
- 19 MR. FOX: -- and -- it will be very easy. So --
- 20 All right, so at this time, Ms. Charity is going to
- 21 depart the room and we're going to continue on with the interview.
- 22 We're going to take a break for a second. The interview is going
- 23 to stop for a moment so that we can make arrangements.
- 24 (Off the record.)
- 25 (On the record.)

- 1 MR. FOX: We are back. This is the second part of the
- 2 interview with Cool Runnings. We are with the driver involved in
- 3 the accident. The time now is 2:37.
- 4 BY MR. FOX:
- 5 Q. So, Benjamin, I wanted to go over the trip and the
- 6 different aspects of it. So going back to what we did before our
- 7 intermission, we were asking about when did you get the trip --
- 8 excuse me -- when did the truck --
- 9 A. Yeah.
- 10 Q. -- when did you get the truck. So can you recall when
- 11 you were first dispatched? When -- you had the truck and you were
- 12 doing some collection of items and putting things in there, and
- 13 that was probably over the weekend --
- 14 A. Yeah.
- 15 Q. -- maybe up through Monday?
- 16 A. Yeah, I think that was -- yeah.
- Q. Does that sound about right? That's the about the way
- 18 we understand it.
- 19 A. Yeah.
- 20 Q. Up through Monday, you were probably putting in personal
- 21 effects in the vehicle?
- 22 A. Yeah.
- Q. This is the way we understand. You got your first
- 24 instructions to pull a load. Did it come through a text message?
- A. Um-hum.

- 1 Q. Does that refresh your memory?
- 2 A. Yeah.
- 3 Q. So Mr. Sizemore texted you and said, hey, we got a load.
- 4 He gave you the information --
- 5 A. Um-hum.
- 6 Q. -- and the truck, and he granted you permission to drive
- 7 the vehicle. Is this what I'm looking at correctly? So you have
- 8 permission to -- image -- no, this is not it.
- 9 A. No, that ain't it.
- 10 Q. This is another thing. I think you showed me another
- 11 one. I have -- he didn't that forward that to me. But did -- you
- 12 got a text message?
- 13 A. Yeah, I got a text message with the load number on it
- 14 and stuff.
- 15 Q. Load number, right. And can you recall -- do you have
- 16 the paperwork on the load?
- 17 A. Um-hum.
- Q. What was your instructions from Mr. Sizemore about your
- 19 load? What was your first load you were going to pull for Cool
- 20 Runnings?
- 21 A. Salad dressing.
- 22 Q. Salad dressing?
- 23 A. Yeah, from -- I can't say the name of the company,
- 24 but --
- MR. FOX: This is a copy of a bill of lading -- excuse

- 1 me. Let me just reference it. It's bill of lading 4319434, is
- 2 the bill lading number and I'm passing it over to the driver to
- 3 see if I can -- if he remembers that this is the load that he
- 4 picked up.
- 5 MR. BREWER: Yep, that's it.
- BY MR. FOX:
- 7 Q. That's the load? When did you -- so this load was to be
- 8 picked up in Haines -- correction -- is to be delivered to Haines
- 9 City, Florida and it was supposed to be picked up at Horse Cave,
- 10 Kentucky; is that correct?
- 11 A. Um-hum.
- 12 Q. Okay. What day did you get in the truck and pick up the
- 13 load?
- 14 A. I started the day on Monday.
- 15 Q. Started on Monday.
- 16 A. Yeah.
- 17 Q. And when did you gain possession of the load?
- 18 A. Probably -- well, I went over on Monday to load it that
- 19 evening.
- 20 Q. You loaded it that evening?
- 21 A. Actually, I loaded it early morning Tuesday.
- 22 Q. Early morning Tuesday.
- 23 A. I think it was.
- Q. Morning, Tuesday. All right, so Monday -- correct me if
- 25 I'm wrong, anyone -- June 22nd is Monday, correct?

- 1 UNIDENTIFIED SPEAKER: Yes.
- 2 MR. FOX: Yes.
- 3 BY MR. FOX:
- Q. And then Tuesday is June 23rd, of course, and then we
- 5 have June 24th being Wednesday. So you believe you went early
- 6 morning Tuesday to pick up the load and picked it up?
- 7 A. I was already sitting on their lot.
- 8 Q. You were already -- you were --
- 9 A. I was already on their lot Monday evening.
- 10 Q. Monday evening, you were there sitting?
- 11 A. Yeah.
- 12 Q. Okay. And then you were waiting for them to open up or
- 13 whatever --
- 14 A. Um-hum.
- 15 Q. -- the load to be ready?
- 16 A. Get -- yeah.
- 17 Q. And what kind of company is this there at Horse Cave,
- 18 Kentucky? Is it a big plant or something?
- 19 A. Yeah, it's a pretty good-sized place.
- 20 Q. And when you drove in, you were waiting. So was the
- 21 load not ready or was it -- the gate secured and you were waiting
- 22 for people to come on board or -- can you recall?
- 23 A. I was just waiting on the load.
- 24 O. So it was not ready? So did you go to a supervisor or a
- 25 dock person and say, hey, I'm here to pick up such and such and

- 1 they said it wasn't ready?
- 2 A. I had a little trouble with the truck. It was -- I
- 3 pulled into the place to load and the air pressure leaked out from
- 4 it and --
- 5 Q. And what did you do then?
- 6 A. I called Billy and he had a mechanic come out.
- 7 Q. He had a mechanic come out? Who -- do you recall who
- 8 the mechanic was?
- 9 A. I can't recall.
- 10 Q. And did he give you paperwork on that? I don't believe
- 11 we have paperwork on that one. So do you recall what the mechanic
- 12 did? Did he, like --
- 13 A. No.
- 14 Q. -- hook up hoses or anything or --
- 15 A. I just let him do his job.
- Q. Okay. And were you with your fiancée at the time?
- 17 A. Um-hum.
- 18 Q. Was she there with you?
- 19 A. Yeah.
- Q. She was there in the truck with you? So you got there
- 21 Monday. Do you recall approximately what time that was?
- 22 A. It was 2:00, I guess.
- Q. 2:00 in the morning or --
- A. No. Monday evening, I was there about 2.
- 25 Q. 2 p.m.?

- 1 A. Yeah. Yes.
- Q. All right. So you were there at approximately 2 p.m.,
- 3 as you can recall. And then you got loaded, like, early, early
- 4 Tuesday morning. Is that what you think?
- 5 A. Yeah, it was -- yeah, it was early. Yeah.
- 6 Q. So early Tuesday morning. So you took possession of the
- 7 load. Was it skids or was it paletted or what?
- 8 A. I think it was palettes. I never did look. They shut
- 9 the trailer doors and put the seal on it.
- 10 Q. Did you load the trailer yourself?
- 11 A. No.
- 12 Q. They loaded it for you? Okay. How many skids was it;
- 13 do you remember?
- 14 A. I don't recall.
- 15 Q. I think it says 20 palettes. Does that sound about
- 16 right? Was it -- from bulkhead to the end, was it --
- 17 A. Yeah.
- 18 Q. -- loaded pretty good? Twenty palettes is --
- 19 A. Yes. It was even across.
- 20 Q. Yeah, 20 palettes, so it'll be a full truck.
- 21 A. Yeah.
- 22 Q. Yeah. Okay. So it looks like it was olives and salad
- 23 dressing and everything. That looks good. Okay.
- 24 When you received the load -- and you went in, they
- 25 loaded it for you, is there any kind of security? Do you have to

- 1 show ID? What's -- can you explain what the process is? Is it a
- 2 guard shack and they waive you in, or how does that work?
- 3 A. They have somebody come out and make sure that's where
- 4 the load -- the person, you know, taking that load and make sure
- 5 it was the right truck for the load, yeah.
- 6 Q. I got you. And was that a security guard or a
- 7 supervisor or somebody?
- 8 A. I quess it was a -- the first time I had ever been
- 9 there. I guess it was supervisor.
- 10 Q. Okay. And they came -- all right. So someone came down
- 11 and verified you and then you got loaded. When you received the
- 12 load, did you go ahead and depart for the trip, or what happened
- 13 next?
- 14 A. I came towards London and --
- 15 O. You came towards London?
- 16 A. Yeah.
- 17 Q. And then what did you do?
- 18 A. I stopped here at BP and went and took a shower.
- 19 Q. Took a shower?
- A. Um-hum.
- Q. Okay. And that -- you said that was the BP?
- 22 A. Yeah.
- 23 Q. Did you get fuel at the time or --
- 24 A. No.
- 25 Q. -- did you scale out?

- 1 A. No.
- 2 Q. You did not scale?
- 3 A. No.
- Q. No? So you got the load and you took a shower. Do you
- 5 recall about what time this is?
- A. I really can't recall.
- 7 Q. Okay. But this -- we're talking early Tuesday morning?
- 8 A. Yeah, it was Tuesday morning.
- 9 Q. It was immediate. You left from picking up your load
- 10 and then you came back here to London, Kentucky, went to the BP,
- 11 and then you got your shower?
- 12 A. Um-hum.
- Q. And you don't recall if you got fuel or you did not get
- 14 fuel?
- 15 A. I did not get fuel.
- 16 Q. You did not? No fuel. Okay. All right. And then what
- 17 happened next?
- 18 A. The tractor had acted like it lost power and I think
- 19 Billy had took it over to Martin's.
- 20 Q. So you had a conversation -- you called Billy and
- 21 said --
- 22 A. Yeah.
- 23 Q. -- it was having problems?
- 24 A. Yeah. It seemed like -- I think the injectors was out.
- Q. Called Billy, okay. And you had to get the injectors --

- 1 A. It seemed like it was an injector to replace and --
- Q. Were you getting a fault code in the truck? What drove
- 3 your attention -- how did you know it was an injector problem?
- 4 A. Just -- I've been around trucks all my life and --
- 5 Q. So it was acting funny and you felt like it that's what
- 6 it was?
- 7 A. Yeah, I just -- yeah.
- 8 Q. So when you were -- you were here at the BP and you
- 9 said, hey, man, it's acting funny, or how did that work? Do you
- 10 recall?
- 11 A. Yeah. He just -- I came in and he take it -- took it,
- 12 you know, over to Martin's.
- 13 Q. So, Martin's, is that a repair place?
- 14 A. Yeah.
- Q. Okay. Did he -- y'all drove over there -- he came and
- 16 met you and said let's go over?
- 17 A. No. He took it --
- 18 Q. How did that work?
- 19 A. He took it on over there.
- Q. He took it over there?
- A. Um-hum.
- Q. So you're at the BP, you're parked, it's acting funny,
- 23 you call him, he comes out, and then did you all ride with him
- 24 or --
- 25 A. No. I took a shower, got in my car, and me and her

- 1 left.
- 2 Q. Oh, you guys left?
- 3 A. Um-hum.
- Q. Okay. And what happened next? You guys left --
- 5 A. I waited on him to call for me to come back and pick the
- 6 tractor up.
- 7 Q. So it went and got repairs, okay. Can you recall when
- 8 he called you and said it's been fixed?
- 9 A. No. It was -- I can't recall when it was.
- 10 Q. So we're well into Tuesday now. So it had to get
- 11 repairs. Do you remember when he said it's finished and you
- 12 received the truck?
- 13 A. No, I can't remember exactly what time it was.
- Q. Can you recall when you actually left to go out on your
- 15 trip with the load, with this to go down --
- 16 A. It would have been Tuesday.
- 17 Q. Tuesday? Can you remember when it was?
- 18 A. I quess it was --
- 19 Q. Was it morning or night or --
- 20 A. Oh, it was -- I mean, it was Tuesday when --
- Q. Tuesday, midday or afternoon or something?
- 22 A. Yeah, midday or somewhere around in there. I can't
- 23 really recall.
- 24 O. Okay. Did Billy drive the tractor back over or did a
- 25 mechanic drive it back over to the BP?

- 1 A. I went to the -- or I went to Martin's myself.
- 2 Q. You went to Martin's yourself and you picked it up?
- 3 A. Um-hum.
- Q. Did you have to sign for the repair order?
- 5 A. No.
- 6 Q. It just -- it was just parked and the keys were in it
- 7 and you said I got it?
- 8 A. Yeah, I know them very well, you know.
- 9 Q. Okay, so he -- you just picked it up and you didn't have
- 10 no sign any paperwork. And can you recall what happened next?
- 11 Did you go over -- bobtailed over to BP, right?
- 12 A. Um-hum, yeah. I bobtailed to the --
- 13 Q. You bobtailed --
- 14 A. -- bobtailed to the BP, picked up the trailer.
- 15 Q. Right. You bobbed over -- so you bobbed over to BP.
- 16 And then do you remember -- you hooked up the load. Was your
- 17 fiancée with you? Did she say, okay, we're ready to go or --
- 18 then?
- 19 A. Yeah.
- 20 Q. Yeah. So at some point, you hooked it up. Did you
- 21 check the truck out then and make sure it -- because it had been
- 22 repaired. Was it -- did you do a pre-trip on it? Can you recall?
- 23 A. Yeah. I always do pre-trips.
- Q. Yeah. So you're at BP. You did -- you conducted a pre-
- 25 trip, and then did -- your girlfriend got with you, and then -- or

- 1 your fiancée --
- A. Me and her was -- yeah, she -- I bobtailed over -- yeah,
- 3 she got with me there at BP and --
- 4 Q. And then did you finally take off at some point, right?
- 5 A. Yeah.
- 6 Q. I mean, you left from the BP?
- 7 A. Yeah.
- 8 Q. Okay. And then can you recall where you went next?
- 9 A. I went to Corbin.
- 10 Q. You went to Corbin?
- 11 A. Um-hum.
- 12 Q. All right, so you went to Corbin. And then -- that's
- 13 Kentucky?
- 14 A. Um-hum.
- 15 Q. Okay. And then in Corbin, what did you do?
- 16 A. Got fuel.
- 17 Q. You did get fuel? Okay. And then do you recall what
- 18 time of day? What day are we into now?
- 19 A. It's still Tuesday.
- 20 Q. This is still Tuesday day, afternoon perhaps? How far
- 21 is it? It's not far, right, to Corbin?
- 22 A. No.
- Q. What, 12 miles or something?
- A. Not far at all.
- Q. I think it's like 12 or 14 miles, right? So we're still

- 1 on Tuesday. All right. And you got fuel. Did you do anything
- 2 else there? Did you get any --
- 3 A. I think --
- 4 Q. Did you get scaled out at all or --
- 5 A. Yeah, I made sure it scaled out for --
- 6 Q. Was that -- that was a requirement, to get your load
- 7 weighed, right?
- 8 A. Yeah.
- 9 Q. Okay. So you did get a scale. And then what happened?
- 10 Did you start your trip?
- 11 A. Yep.
- 12 Q. You guys got on -- what, get on --
- 13 A. Got on the interstate and started towards Florida.
- Q. Got on the -- started towards Florida. So can you
- 15 recall about when you really officially got in there and said,
- 16 okay, we're underway? It was still Tuesday day, do you think?
- 17 A. It was still Tuesday, yeah.
- 18 Q. Tuesday sometime. It was not night? It wasn't --
- 19 A. No, no, it was not night.
- Q. You still had daylight?
- 21 A. Um-hum.
- 22 Q. All right. All right, and then can you recall next?
- 23 Did you stop along the way or get any fuel or, you know, stop to
- 24 go the restroom or any of that stuff?
- 25 A. It seemed -- I can't remember. It seemed like we

- 1 stopped and went to the restroom and --
- 2 Q. Do you know when --
- 3 A. -- stopped and got some food down at Knoxville.
- 4 O. Knoxville?
- 5 A. Yeah. We got something to eat and used the bathroom
- 6 and --
- 7 Q. Knoxville, Tennessee, you stopped. Okay. And that's
- 8 still -- that would still be --
- 9 A. Tuesday.
- 10 Q. -- Tuesday, yeah. And then, so continue on with your
- 11 trip. What happened next? Do you remember stopping anywhere
- 12 or --
- 13 A. Just headed down to Florida, like any other trip.
- 14 Q. Like any other trip? And did you -- you filled out a
- 15 logbook for the trip?
- 16 A. Um-hum.
- 17 Q. Okay.
- 18 A. Yeah.
- 19 Q. And do you -- can you recall when you got to Florida,
- 20 did you stop along the way at all? Did you go straight on to
- 21 Florida from Knoxville?
- 22 A. No, I stopped in Jackson, Georgia and --
- 23 Q. You stopped in Jackson, Georgia?
- 24 A. Yeah, just to lay down for a few -- for a little bit
- 25 and --

- 1 Q. Jackson, Florida?
- 2 A. No, Jackson, Georgia.
- 3 Q. I'm sorry. Jackson, Georgia, you stopped and you took a
- 4 rest?
- 5 A. Yep.
- Q. Do you know how long you were there?
- 7 A. Not really.
- Q. Okay.
- 9 A. A couple hours, I would think, maybe, or maybe 30
- 10 minutes. I can't really recall.
- 11 Q. So you did take some kind of a rest there?
- 12 A. Took a break there, yeah.
- 13 Q. Took a break there. Okay. And then what happened next?
- 14 You were there for a short period of time, you say, and then you
- 15 continued on?
- 16 A. I was there for a little bit of time. I don't recall if
- 17 it was a short period of time or --
- 18 Q. But it wasn't like a DOT break? I mean, you didn't bed
- 19 down for the night?
- 20 A. No. No, I didn't bed down for the night, no.
- 21 Q. Yeah, so you just -- you took a short break for --
- 22 A. Yeah.
- 23 Q. -- an unknown period of time and then you carried on
- 24 with the trip?
- 25 A. Yeah.

- 1 Q. Now, this whole time your fiancée is running with you.
- 2 This -- is this her first trip with you?
- 3 A. Yes.
- Q. Okay. And she had never been a truck before?
- 5 A. With me, no.
- 6 Q. Not with you anyway.
- 7 A. No.
- 8 Q. Okay. So you stopped in Georgia, and do you -- can you
- 9 recall what time that was, maybe?
- 10 A. I really can't.
- 11 Q. So that's a pretty good distance from Knoxville,
- 12 Tennessee, I would imagine.
- 13 A. Six hours.
- 14 Q. Yeah.
- 15 A. It's 6 hours from here to Jackson.
- Q. Yeah, that's a pretty good long clip, in my opinion.
- 17 And then you kept going?
- 18 A. Yeah, I went down to Jasper, Florida.
- 19 Q. You went to Jasper, Florida? Okay.
- 20 A. Took a break.
- Q. You took a break there. And how long do you think that
- 22 took you?
- A. About however long it needed to -- at least 8 hours, I'd
- 24 say.
- Q. Eight hours?

- 1 A. I guess -- I really can't recall.
- 2 Q. Something like that? Okay.
- 3 A. Somewhere around in there.
- Q. All right. So you got to Jasper, Florida, and then what
- 5 happened?
- 6 A. I went to the Haines -- went on down to deliver the
- 7 load.
- 8 Q. And then from there you went to deliver the load? Okay.
- 9 And that would be going on to this Haines City?
- 10 A. Yeah, Haines, yeah.
- 11 Q. How do you think -- how far do you think it is from
- 12 Haines to -- from Jasper to Haines City?
- 13 A. I can't recall.
- 14 Q. You don't recall?
- 15 A. That's the first time I'd been to Haines.
- Q. Was it far or anything?
- 17 A. It was probably middle ways to Florida, so --
- 18 Q. Hey, are those -- are the interstate roads toll roads?
- 19 I don't know. I think some of them are. Did you guys go through
- 20 tolls?
- 21 A. Yeah.
- Q. Okay. Did you keep your toll -- how did you pay for
- 23 your tolls? Did you pay cash or get receipts for them or
- 24 anything?
- 25 A. I should have receipts.

- 1 Q. You have receipts?
- 2 A. I should have. I don't really recall if -- no, I don't
- 3 know if I did or not. I really can't remember.
- 4 Q. What road were you on? Can you recall?
- 5 A. The turnpike.
- 6 Q. You were on the -- so is that 95 or --
- 7 A. No. I took 75 down to the turnpike.
- 8 Q. 75 to the turnpike. Okay. And that is a toll road, if
- 9 I can remember. And you think you, maybe, paid cash for that
- 10 or --
- 11 A. I think they're all cash.
- 12 Q. Cash? Okay.
- 13 A. Change mostly.
- 14 Q. Yeah. Oh, change. Okay.
- 15 A. Yeah.
- Q. All right. And so you made it all the way down from
- 17 Corbin -- excuse me -- yeah, from Corbin -- no, no, before that.
- 18 When you picked up the load from Horse Cave all the way down to
- 19 Haines City. And did you -- I haven't heard it, but did you stop
- 20 and take an overnight break?
- 21 A. Yeah, I got to Haines and took a overnight break, yeah.
- 22 Q. So you took your rest after you made your load?
- 23 A. I took -- yeah, more than a rest. I was there for that
- 24 evening all the way up to the next morning. It was -- I can
- 25 remember it was before dark.

- Okay, you were there for a while. After you --
- 2 A. There for a while, yeah.
- 3 Q. So, just for clarification, you picked up the load; you
- 4 made it on down; you got -- Corbin, Kentucky, you got fuels, and
- 5 then you got scaled; and then you made it to Knoxville for a short
- 6 break; and then Jackson, Georgia, you had a short break; and then
- 7 you pushed on to Jasper, Florida, and then you made your delivery
- 8 in Haines City, Florida, correct?
- 9 A. Um-hum.
- 10 Q. Okay. Okay. When you made your delivery, can you
- 11 describe what that process was like? It looks like someone signed
- 12 for the load here. So is this a big facility there in Haines
- 13 City?
- 14 A. It's a pretty big facility, yeah.
- 15 Q. Do they have a security thing there?
- 16 A. Yeah, yeah.
- 17 Q. Did you have to check in with a guard shack or
- 18 something?
- 19 A. Um-hum.
- 20 Q. And you presented the bill of lading and he said, okay,
- 21 park over here --
- A. Um-hum.
- Q. -- or something like that?
- 24 A. Yeah.
- Q. Did you have to sign anything or get in there?

- 1 A. I can't recall.
- 2 Q. You can't recall? But there was some kind of a guard
- 3 there?
- 4 A. Yeah.
- 5 Q. All right. Okay. Well, that's a lot of driving right
- 6 there that we're talking about, so, you know, you do need to --
- 7 you know, you can only drive 11 hours in a day. So we do have
- 8 your logs here, that I just wanted to show you what you have here.
- 9 You have this log here for the 25th and then you have another set
- 10 of logs for the 25th here. So if we can move your bottle over
- 11 here for a second. So you have two different logs that have two
- 12 different entries on here. Now, 6/25 is the day of the crash.
- 13 A. I must have messed up on the dates then.
- 14 Q. Yeah. So --
- 15 A. This one's wrong.
- Q. So these are, yeah, wrong. And then you have two here
- 17 that are the same conflicting things.
- 18 A. Yeah, I see that now.
- 19 Q. Yeah. So you've got --
- 20 A. I just messed up on the dates.
- 21 Q. Yeah, you got -- all these dates are wrong, so --
- 22 A. I don't know why I thought that.
- Q. Yeah. And then also, you have -- we have you running on
- 24 the 26th, which, you know, that was Friday, so --
- 25 A. Yeah. So I messed upon the dates, yeah.

- 1 Q. Yeah, with the dates and -- yeah. And then from what
- 2 I'm hearing, you tell me -- I don't know -- you know, like, this
- 3 is Jasper, Florida and you went into a sleeping berth and you told
- 4 me that you went to Haines City. So, I'm here to tell you all
- 5 these logs are false as far as we're concerned. None of these
- 6 times or anything match with what you've been telling us. So, I
- 7 really -- I can't follow this with what even you just told me
- 8 because your story matches what we basically have come up with.
- 9 We've reconstructed your logs also and we've come up with a graph
- 10 or a table, so to speak, and this basically matches --
- 11 MR. BRAGG: Other than the load time in Horse Cave --
- 12 MR. FOX: Yeah.
- MR. BRAGG: -- in Horse Cave, yeah.
- 14 BY MR. FOX:
- 15 Q. Yeah. So this, I think, is almost identical to what you
- 16 told me. So what you told me is factual. It's a little off here
- 17 or there, but what you said is exactly correct.
- 18 A. Um-hum.
- 19 Q. Okay. So I don't know what my other colleagues would
- 20 say, but it's -- you know, to me, these logs would just -- these
- 21 are just a distraction because they're so off that we'll have to
- 22 put them to the side. And what we have is GPS data and fuel
- 23 reports that show what your activity actually was. So these are
- 24 all off. So I think that Michael LaPonte and Sean can ask you
- 25 some questions about the load now that we have a little bit of a

- 1 framework.
- MR. BRAGG: Well, a couple --
- MR. FOX: And if you want to go ahead, Kenny, ask a
- 4 question?
- 5 BY MR. BRAGG:
- Q. Yeah. Before we get to (indiscernible), a couple
- 7 questions I have about your time table. And, look, you're going
- 8 through something difficult. I mean, it is. I mean, it don't get
- 9 no harder than this, all right? And that's just the reality of
- 10 it. But at the end of the day, this is something you've got to
- 11 deal with, and by dealing with it, that's the best way for you to
- 12 handle it, because it's not going to go away. I mean, we're
- 13 talking about an age of technology. Every time you pull in to get
- 14 fuel, every time you go a toll, like cameras, you know, we're
- 15 going to do all this research to build your timetable. So what
- 16 we're trying to do is we're trying to get an understanding from
- 17 your perspective because what that can't tell us, that can't tell
- 18 us what you were doing in your truck, it can't tell us how you
- 19 were feeling, and that's what we're trying to get at. All right?
- 20 So let's talk about Monday evening, when you were --
- 21 when you arrived at -- to pick up the load. So you got there
- 22 about 2:00; is that correct?
- 23 A. I would think so, yeah.
- Q. And how long were you there before you realized you had
- 25 an air leak?

- 1 A. I don't know. I -- just as soon as I pulled into the
- 2 lot, I guess, because I got ready to back -- or I backed up and --
- 3 Q. Describe the air leak.
- A. It just -- well, I know I parked and got ready to pull
- 5 off and it wouldn't build air after that.
- 6 Q. Okay. And so, you contacted the owner. How did you
- 7 contact the owner?
- 8 A. I can't remember if -- I had to borrow somebody's phone.
- 9 Q. Okay. So you don't have a cell phone?
- 10 A. My phone didn't have service over there.
- 11 Q. I'm sorry?
- 12 A. My phone did not have any service.
- 13 Q. But you do have a cell phone?
- 14 A. Yeah, a temporary one, yes.
- Q. What's your cell phone number?
- 16 A. Let's see. Well, I just got a new one. I can't
- 17 remember. It was -- I have one that's and then I
- 18 had a number. I can't remember the last four digits on it.
- 19 Q. You had both of these on Monday?
- A. Um-hum.
- 21 Q. So the number, where did you get that phone from?
- 22 A. I've got two phones. That was one my older numbers
- 23 because I -- that was one of my numbers, yeah.
- Q. Who's the service provider?
- 25 A. It was a prepaid.

- 1 Q. Prepaid?
- 2 A. Um-hum.
- 3 Q. Was that the -- as to the Verizon prepaid card that was
- 4 in the truck?
- 5 A. Um-hum.
- 6 Q. Okay. How about the other, the
- 7 A. I guess that was my number, yeah, the prepaid
- 8 service was.
- 9 Q. All right.
- 10 A. Yeah, when I started for Billy, I had the number.
- 11 Q. Okay. So you borrowed somebody's phone and you called
- 12 Billy?
- 13 A. Um-hum.
- Q. And he sent a truck out -- and he sent a mechanic out to
- 15 fix the truck; is that correct?
- 16 A. Um-hum.
- 17 Q. What time did the truck get there?
- 18 A. I really can't recall. I mean --
- 19 Q. Was it dark?
- 20 A. -- I had been there for a while.
- 21 Q. Was it -- did he fix the truck in the dark or --
- 22 A. No.
- Q. So it was still daylight?
- 24 A. It was daylight, yeah.
- Q. And he was able to get the truck -- did he --

- 1 A. To go on, yeah.
- Q. What did he do to fix it?
- 3 A. I don't know. I never got up under the hood; never
- 4 looked at it.
- 5 Q. And so you got the truck loaded Tuesday morning? What
- 6 time was that? About what time?
- 7 A. I couldn't --
- Q. I mean, was it dark out or was it --
- 9 A. It was early Tuesday morning when I loaded up --
- 10 Q. Tuesday morning.
- 11 A. -- because I was back here, I guess, so --
- 12 Q. Was it dark out?
- 13 A. When I got the load?
- 14 Q. Yeah.
- 15 A. Yeah, I guess it was.
- 16 Q. So from the time the mechanic left until you picked up
- 17 the load Tuesday, what did you do?
- 18 A. I slept.
- 19 Q. You slept?
- 20 A. Yeah.
- Q. And Charity was in --
- 22 A. Actually, I slept -- yeah.
- Q. Charity was in the truck with you?
- 24 A. Yeah.
- Q. And she slept as well?

- 1 A. Yeah.
- 2 BY MR. FOX:
- 3 Q. All right, just while we're all -- while you're thinking
- 4 about it -- we're going to talk more about your logs and all that
- 5 kind of stuff in a minute, but you -- just to continue on with the
- 6 whole process here. You got to Haines City and you did -- I agree
- 7 with you, from what we understood, you took a long break there.
- 8 You were there like -- what do you -- can you recall?
- 9 A. A long time. It was pretty long.
- 10 Q. Yeah, it was like about a good 10 hours or more?
- 11 A. More, probably.
- 12 Q. Yeah, more. Yeah, I think you were there between 10 and
- 13 12 hours off the top of my head.
- 14 A. Um-hum.
- Q. We have it over here on this chart, if you wanted to
- 16 follow along. But you were -- from what we saw from the GPS, you
- 17 were there a substantial amount of time there. Did you get rest
- 18 when you were there --
- 19 A. Um-hum.
- 20 Q. -- in Haines City?
- 21 A. I slept the whole time.
- Q. Okay, great. And then you got up the next morning.
- 23 Were you dispatched for any other load or anything?
- 24 A. Uh-uh.
- Q. So did Billy call you and say, hey, come back home? How

- 1 did that --
- 2 A. My air conditioner quit and it was hot.
- 3 Q. Your air conditioner quit?
- 4 A. Yeah.
- 5 Q. Okay. And did you get a mechanic to fix it?
- 6 A. No, I was -- I just asked -- said I was coming on back,
- 7 and I --
- 8 Q. You said you would come on back?
- 9 A. I said I was coming -- I said I'm headed back. I can't
- 10 remember exactly what I said. I said back -- I was headed back
- 11 and, you know, I figured he would text me if he wanted another
- 12 load he wanted me to pick up or if he just wanted me to have the
- 13 A/C fixed up here or whatever. I know that I couldn't stay up in
- 14 the -- stay out in my truck for 2 weeks with no air.
- 15 Q. Gotcha. So I'm sure maybe your fiancée was weighing
- 16 into that conversation --
- 17 A. I'd say so, yeah, yeah.
- 18 Q. -- you know, saying, oh, I need some air conditioning.
- 19 A. Yeah.
- Q. Okay, I understand that.
- 21 A. No, I need it too, so --
- Q. Yeah, it's boiling too, especially in Florida. I'm sure
- 23 it's --
- A. Yeah, it gets hot.
- 25 Q. -- hot as firecracker in there.

- 1 So you texted Billy and you said I've got to come back.
- 2 Can you recall what day that was maybe? We're talking -- it
- 3 was --
- 4 A. It was after I delivered the load there.
- 5 Q. After you delivered the load, and you spent a long time
- 6 -- so that would be Thursday morning early, early, probably, that
- 7 you left, according to what we can recollect. Does that sound
- 8 about right? You guys got up early and probably were moving
- 9 around maybe. Did you get fuel?
- 10 A. Uh-uh.
- 11 Q. Didn't need to get fuel. And then at some point you
- 12 guys decided, like you said, it's got no air, we're coming home.
- 13 Can you recall what time that was?
- 14 A. It was after I delivered the load. I can't recall
- 15 exactly what time.
- 16 Q. Yeah, after you delivered the load, you spent a long
- 17 time in the sleep -- got lots of sleep. The air conditioner went
- 18 out, and then at some point you say we're leaving --
- 19 A. Um-hum.
- 20 Q. -- and you headed back. So you headed back early? It
- 21 was probably darkness on Thursday? Can you recall?
- 22 A. I can't recall. It's getting --
- Q. Fuzzy?
- 24 A. Yeah.
- Q. All right. Well, at some point along the way, you got

- 1 into an accident, right?
- 2 A. Um-hum.
- 3 Q. Can you recall that?
- 4 A. I had a -- as I hit the turnpike, I was going around a
- 5 curve and a Mexican driver come over on top of me and hit me.
- 6 Q. Actually then, I have to stand corrected. That was
- 7 before you delivered the load?
- 8 A. That was -- yeah, it was before I delivered the load,
- 9 yeah, yeah.
- 10 Q. I stand corrected. You got in an accident -- was it
- 11 Wildwood, Florida?
- 12 A. Right outside. Somewhere around Wildwood, yeah.
- Q. Wildwood, Florida, you got a traffic ticket?
- 14 A. Yeah.
- 15 O. You were cited for that?
- 16 A. Yeah. I did not know -- the driver told me that he know
- 17 that he come over and hit me, and I figured it was pretty cut and
- 18 dry. I never -- it took the officer 40 minutes to get there. It
- 19 was a hot day. I remember that, almost so hot that -- I mean, it
- 20 was just unbearably hot. Because it had messed the hose up on the
- 21 bottom of the radiator and it was -- it leaked all the water out
- 22 of it. It was leaking water, so I just -- I had to turn it off.
- 23 I couldn't let the motor run and no water in it, so --
- Q. Um-hum. Well, you did the right thing, I guess, yeah.
- 25 A. Yeah.

- 1 Q. Um-hum. So, you -- did you get that repaired then?
- 2 Did --
- 3 A. Yeah, the guy come out and fixed the hose.
- 4 Q. You had a repairman? Was it --
- 5 A. Yeah.
- Q. Who arranged that, you or Billy?
- 7 A. Billy did.
- 8 Q. Billy called the roadside mechanic? And what kind of
- 9 repair -- did you watch him do any repairs or -- did you get
- 10 towed?
- 11 A. Uh-uh.
- 12 Q. You were on the --
- A. No, I didn't watch him do the repairs. I tried to stay
- 14 -- opened the doors from the cab of the tractor and tried to sit
- 15 there because there was no shade, and what shade there was, I
- 16 wasn't walking to it in Florida.
- 17 Q. Now, you were on the shoulder, you say --
- 18 A. Yeah.
- 19 Q. -- and the mechanic came out, made the repairs, and then
- 20 you were you able to get underway. You went and you delivered
- 21 your load, and then you spent the night?
- 22 A. No, I would have been late for the load, so I spent --
- 23 right after the repairs, I went down and stopped and had -- cause
- 24 -- and spent that whole evening and the rest of that day and up to
- 25 the next morning.

- Q. Right, up to the next morning, taking a long break?
- 2 A. Yeah.
- 3 Q. And then you -- at some point you took off Thursday
- 4 morning to come back because you were upset the air conditioning
- 5 was not working --
- 6 A. Yeah, and he --
- 7 Q. -- and you had come on back?
- 8 A. Yeah.
- 9 Q. And can you recall -- do you remember what time that
- 10 was?
- 11 A. I really can't.
- 12 Q. You can't remember? And how was the truck behaving now?
- 13 Was everything working okay?
- 14 A. The A/C wasn't.
- Q. Aside from the A/C, did you do a pre-trip that day, on
- 16 Thursday?
- 17 A. I should have.
- 18 Q. You should have? You checked it out and everything was
- 19 okay?
- 20 A. No, no, the A/C wasn't working, but --
- Q. Aside from the A/C, was the mechanical operation of the
- 22 vehicle okay?
- 23 A. Yeah.
- Q. Okay. And did you --
- 25 A. The mirror was a little loose on the passenger's side.

- Q. Okay. And do you remember stopping along the way on the
- 2 trip?
- 3 A. Which way now?
- Q. We're coming back home. We're coming back here.
- 5 A. Um-hum?
- 6 Q. Do you remember coming --
- 7 A. Oh, I stopped and got some lunch and --
- 8 Q. You stopped and got lunch?
- 9 A. Yeah.
- 10 Q. It was Arby's, I think --
- 11 A. Yeah.
- 12 Q. -- you stopped and got lunch? And was that -- what city
- 13 was that? Do you recall?
- 14 A. It was up close to Jasper.
- 15 Q. It was close to Jasper?
- 16 A. Um-hum.
- 17 Q. And you all got food --
- 18 A. Yeah, took a break.
- 19 Q. -- took a break -- and then from there, you headed on
- 20 back here to Chattanooga?
- 21 A. Um-hum.
- 22 O. Yeah.
- 23 A. And getting ready to take another break to Chattanooga.
- Q. You were getting ready to take a -- what was your plan
- 25 there?

- 1 A. I was actually going to -- I wished I could have stopped
- 2 at the first rest area there at Chattanooga. I was going to stop
- 3 there and couldn't get over and I said, well, the only other place
- 4 I can stop is up at the 30, so -- or whatever that mile marker
- 5 there. I think there's a little rest area there. Or there might
- 6 have been -- I know there might have been a truck stop. I
- 7 couldn't remember because it been a while since I had been down
- 8 through there. I know there was a truck stop, maybe. I couldn't
- 9 remember exactly where it was at, you know.
- 10 Q. Yes.
- 11 A. I didn't know if it was before the rest area or after
- 12 the rest area.
- 13 Q. Okay.
- 14 A. So whichever one I was coming up on first, that's where
- 15 I was going to stop.
- Q. Okay. All right, well -- so, we're in -- you're driving
- 17 in Tennessee, right, and you were thinking that you would get a
- 18 break? That's what you were hoping for?
- 19 A. Yeah, that's what -- I was hoping to take one before I
- 20 got to Jasper then.
- Q. Were you tired at -- you were tired at that point; you
- 22 wanted to take a break?
- 23 A. No. I just know it was time to, you know, take a little
- 24 break and I was tired.
- 25 Q. Okay.

- 1 A. I mean --
- 2 Q. Well --
- 3 A. -- anybody's driving like that couldn't --
- Q. Okay. So, to the best of your ability, let's just --
- 5 we're driving; we're already on the highway; we're heading back
- 6 and we're in the vicinity coming up on the interstate onto -- into
- 7 Chattanooga. Can you recall the sequence of events?
- 8 A. I wasn't bad tired.
- 9 Q. You were not bad tired?
- 10 A. I wasn't bad tired, no.
- 11 Q. Okay.
- 12 A. Because I had slept all the night before --
- 13 Q. Okay.
- 14 A. -- for a very good distance and come up through there
- 15 and ate and took another break. So, I was -- I didn't -- I was
- 16 not very bad tired when I come through Chattanooga.
- 17 Q. Okay. So when you came up --
- 18 A. I mean, I wasn't exhausted, you know.
- 19 Q. Okay. When you came up into the vicinity of the crash,
- 20 did you notice any kind of markings or that there was construction
- 21 or a work zone or anything like that?
- 22 A. We was coming around a bend -- this is what happened.
- 23 We was coming around a bend. I heard something about construction
- 24 on the radio. I did not never see no signs lit up.
- Q. What radio? Do you mean the radio station or --

- 1 A. The CB radio. Somebody said something about some
- 2 construction. And about that time I seen a few cars spin out in
- 3 front of me and the car in front of me stopped.
- 4 Q. The car in front of you stopped?
- 5 A. Um-hum.
- 6 Q. Okay. And do you remember what lane you were in?
- 7 A. I was probably in the -- it seemed like I had -- was not
- 8 in the far left lane, but was in the second lane.
- 9 Q. Okay, so you were in the middle lane?
- 10 A. Middle lane.
- 11 Q. Yeah, so that sounds about right. And then you were
- 12 saying that some car stopped in front of you?
- 13 A. Yeah, there was traffic braking in front of me.
- Q. And then -- now, where is your fiancée when this is
- 15 going on?
- 16 A. She was in the bunk.
- 17 Q. Your fiancée was in the bunk?
- 18 A. Um-hum.
- 19 Q. Okay. Can she drive at all?
- 20 A. No. She was not driving the truck. She has never drove
- 21 that truck.
- 22 Q. All right. Did she ever --
- 23 A. I don't know if she can drive or truck not. I mean,
- 24 I've never -- it's the first trip she'd been on with me.
- 25 Q. Sure. Absolutely.

- 1 A. I mean --
- 2 O. So --
- 3 A. -- I'm sure she probably could if she wanted to, but she
- 4 did not never drive that truck.
- 5 Q. Okay. So, if you can recall back, the steps that were
- 6 going on, she was taking a break in the sleeper berth and you were
- 7 driving in the second lane.
- 8 A. Um-hum.
- 9 Q. And can you recall what you saw ahead? Were you --
- 10 A. I seen two or three vehicles spin out in front of me, or
- 11 spin out a little distance up there, and then the vehicle in front
- 12 of me -- I mean, it happened so quick. The vehicle in front of me
- 13 just stopped. And it was a small vehicle.
- 14 Q. Okay.
- 15 A. And I remember I said I -- there's no way I could stop,
- 16 you know, because it happened -- I mean, they just stopped.
- 17 Q. Right.
- 18 A. And I said there's no way I'm hitting those people, and
- 19 I took it -- I jerked it as hard as I could towards the wall.
- 20 Q. So, you jerked it to the left?
- 21 A. I looked in my mirror and made sure there was nobody on
- 22 my left side and went to the left towards the wall.
- 23 Q. So you pulled a hard left and then you -- did you jam on
- 24 the brakes or --
- 25 A. Yeah, I hope I did. I mean --

- 1 Q. Well, did you apply your brakes or not?
- 2 A. I can't recall. It happened so fast.
- Q. Okay.
- 4 A. That's all I can remember is the vehicles up there
- 5 wrecking, them people in front of me just -- because we was coming
- 6 around the bend and it just kind of -- everything was just bam,
- 7 bam, bam and they just -- it seemed like everybody across
- 8 them whole lanes was just stopped and the vehicles in front of
- 9 them was stopped.
- 10 Q. Oh, okay.
- 11 A. And I just said that -- I'll just take my -- I'll take
- 12 the hard way, you know, and I jerked it towards the wall.
- Q. Okay. And was -- what was the lighting like? Was the
- 14 sun in your eye or anything?
- 15 A. No, the sun wasn't in my eye.
- Q. Okay, was -- now, do you wear glasses to drive?
- 17 A. Yeah.
- 18 Q. Oh, you do wear glasses to drive?
- 19 A. If I drive, I wear glasses, yes.
- 20 Q. You were -- were you wearing your glasses at the time?
- 21 A. Yes.
- 22 Q. You were? Okay. And you are required to wear glasses
- 23 when you drive?
- A. My driver's license, I think they said it didn't require
- 25 me to have my glasses on, but my medical certificate did.

- 1 Q. Okay. So are you nearsighted? I mean, can you --
- 2 A. I've got a little bit of -- I have perfect eyesight in
- 3 one eye and I've got just a little bit of astigmatism in the
- 4 other. So about the edge of dark or something that I have a hard
- 5 time seeing.
- 6 Q. Okay. So, I mean, do you need glasses to read, like,
- 7 the newspaper or to see the TV, to drive, the distance?
- 8 A. No.
- 9 Q. So you do or you don't need your glasses to drive?
- 10 A. I do need them to drive. I wear them all the time when
- 11 I'm driving.
- Q. Okay. I haven't seen you wear your glasses today. Do
- 13 you still have them?
- 14 A. I'm not driving, so --
- 15 Q. Okay. Well, I -- look, you can see me. Actually, I
- 16 have two pair, so I understand completely.
- 17 A. Um-hum.
- 18 Q. So -- but, you were wearing your glasses.
- 19 A. Um-hum.
- 20 O. Now, I understand from police when I interviewed them
- 21 that your glasses were maybe knocked off.
- 22 A. Um-hum.
- 23 Q. Is that correct?
- 24 A. Yeah.
- Q. And were you injured in the crash?

- 1 A. I had a bad pump knot. I could -- I don't know what it
- 2 was. I know that I had a bad place on the top of my head.
- 3 Q. Where you had -- you were bruised on your head?
- 4 A. I had a pretty good pump knot is what the -- figured
- 5 out, yeah.
- Q. Where was -- can you show me where it was approximately?
- 7 A. It was about right in here.
- 8 Q. Okay. Did you get medical attention?
- 9 A. I asked for medical attention. I never did get it.
- 10 Q. Is that right? Wow. Did you go to your doctor or
- 11 anything after the crash?
- 12 A. No, but I'm probably going to before today is out, yeah.
- 13 Q. Now, was your fiancée injured in the crash at all?
- 14 A. She was complaining about whenever -- I don't know. She
- 15 -- they separated us. You know, I asked her if she was all right,
- 16 and she just said, you know -- I made sure she was -- didn't have
- 17 nothing broke on her or -- you know, I made sure she was
- 18 breathing, you know, made sure she was all right, asked if she was
- 19 all right, and she said, yeah. You know, best I could tell, she
- 20 was.
- 21 Q. So she was in the sleeper berth sleeping, resting?
- 22 A. She was laying back there, yeah.
- 23 Q. She was asleep --
- 24 A. Yeah.
- 25 Q. -- or awake?

- 1 A. I don't know if she was awake or asleep. I mean --
- Q. I gotcha. And you were driving and you say the
- 3 visibility was okay?
- 4 A. Um-hum.
- 5 Q. Can you recall how fast you were going?
- 6 A. I really can't.
- 7 Q. So you were -- up until the crash, you were going
- 8 highway speed, so -- and then you just said that all of the
- 9 sudden, boom, the vehicle in front of you stopped?
- 10 A. They just stopped, yeah.
- 11 Q. Okay. All right. Well, I have more questions, but I
- 12 think we'll switch it around. We've kind of gone through the
- 13 sequence of events and the hours of service situation.
- MR. FOX: And then why don't we go over the hours of
- 15 service. Mike and Sean, you can continue with your questions
- 16 about the hours of service and the logbook, et cetera.
- MR. ANDERSON: Okay. This is Sean with FMCSA for the
- 18 recorder.
- BY MR. ANDERSON:
- 20 Q. So, really, I think we've pretty much nailed down a good
- 21 timeline just with the interview so far. I've got a couple
- 22 questions, but I'm going to start with this one, then I'll defer
- 23 to Mike and see if he wants to do anything else. But on the 25th,
- 24 that was the day that you -- you dropped the load on the 24th in
- 25 Haines City, correct?

- 1 A. I guess whatever the paperwork says. I mean, I -- I was
- 2 a little -- apparently, I made the wrong dates on the logbooks.
- 3 So I was wrong on the dates for some reason. I don't know what --
- 4 if I was looking at a different year or what it was. I must have
- 5 just messed up on the dates.
- 6 Q. Okay. Now, I'm trying to just make sure I understand
- 7 the timeline from the evening of the 24th through the morning of
- 8 the 25th, okay? So on the 25th, which was Friday -- or, excuse
- 9 me, Thursday -- the 25th is Thursday -- what time did you wake up?
- 10 That's after that long break in Haines City, Florida. What time
- 11 did you leave Haines City, or just talk to me a little bit about
- 12 that morning in Haines City.
- 13 A. I really can't recall what time it was I left. It was
- 14 early.
- 15 Q. Okay. Do you know if you moved the truck at all in
- 16 Haines City or did you just stay in the same spot or --
- 17 A. I stayed there right down from the place that -- by the
- 18 loop at, from that evening till -- from before dark till that next
- 19 morning for a very long time. And after I delivered the load, I
- 20 came and started back.
- Q. Okay. Did you stay on the property where you delivered
- 22 the load or --
- 23 A. No. I mean, it was just -- it wasn't very far from the
- 24 place where I stayed.
- 25 Q. Was it a truck stop or --

- 1 A. It was a truck stop. It was a Pilot. Because she got
- 2 -- she was hungry, she went and got some food. And I think she
- 3 brung me back some, but I had stayed in the truck sleeping.
- 4 Q. Okay.
- 5 MR. ANDERSON: Go ahead, Mike. I'm okay right now.
- BY MR. LaPONTE:
- 7 Q. Okay, so the reason we're asking is that the GPS -- my
- 8 name is Michael LaPonte with the National Transportation Safety
- 9 Board. The reason we're asking is the GPS shows truck movement.
- 10 So what we're trying to -- I mean, they show a 10-mile, a 6-mile,
- 11 a 10-mile, and what we're trying to determine is when you, you
- 12 know, started your day, if you will.
- 13 A. I don't why it would have done that.
- 14 Q. Hum?
- 15 A. I don't know why it would have showed that.
- Q. Well, that's why we're trying to see if you can recall
- 17 your movements, so --
- 18 A. That was my movement. I went to that truck stop and
- 19 stopped; stayed that evening all the way up to the next morning.
- 20 MR. FOX: What was that truck stop again?
- MR. BREWER: It was a --
- MR. LaPONTE: Pardon me?
- MR. BREWER: It was Pilot, I think.
- MR. FOX: Pilot?
- MR. BREWER: Yeah, right up from Haines. It wasn't 5

- 1 minutes from the delivery place.
- BY MR. LaPONTE:
- 3 Q. Okay. And so then, did you have an appointment time at
- 4 the delivery site, at the warehouse? Did they --
- 5 A. I think they wanted it there by -- I can't -- they
- 6 wanted it there early that morning, I remember that.
- 7 Q. Okay. So they didn't give you a specific time like, you
- 8 know, truck driver be at door 51 or --
- 9 A. They wanted me to be, I think, the first one through the
- 10 gate, but -- I think they was needing their product.
- 11 Q. Okay. Do you recall when the gate opened there at that
- 12 facility for receiving?
- 13 A. He told me that he'd open it up whenever the other
- 14 workers got there.
- 15 Q. The other workers got there. Okay. All right.
- 16 A. I said, when's that?
- Q. When someone showed up to unload you?
- 18 A. Yeah. That's pretty much what he said.
- 19 Q. Yeah, I don't doubt that. Do you recall how long it
- 20 took them to unload the truck?
- 21 A. Not very long.
- MR. FOX: Yeah, it doesn't take long.
- MR. BREWER: Yeah.
- MR. FOX: Was it a fork truck or palette or jack?
- MR. BREWER: Yeah, they was palettes and they was fork-

- 1 lifting up.
- MR. FOX: Yeah, it don't take that long.
- 3 MR. BREWER: It don't take long.
- 4 MR. LaPONTE: Oh, okay.
- 5 MR. FOX: Ten minutes.
- BY MR. LaPONTE:
- 7 Q. All right. So, then once you got the load off, you got
- 8 the paperwork signed, they signed for it and they circled the case
- 9 count and all that, and then did you immediately start your trip
- 10 home from Haines City at that point or did you go back to the
- 11 truck stop and freshen up or have breakfast or --
- 12 A. I had done been there all night and so I had eaten --
- 13 they had coffee there at that place where I unloaded -- donuts and
- 14 coffee, some pop, and I think I might've had some pop in the
- 15 cooler. And I just started back home.
- 0. Okay. On the trip down, right, you had the accident or
- 17 the crash or the side-swipe accident, and you mentioned earlier
- 18 that it took the police officer 40 minutes to arrive to --
- 19 A. At least. I was just guessing at that. It took him a
- 20 long time to get there --
- 21 Q. Okay.
- 22 A. -- it seemed like. I can't recall what -- exactly the
- 23 length of time it took him to get there, and then by the time the
- 24 guy fixed -- I can't recall all that.
- 25 Q. Okay. Did the other truck stay there the whole time

- 1 until the officer showed up as well?
- 2 A. Until he told him to leave. He left while I was still
- 3 sitting there and the officer was, you know, there with me --
- 4 Q. Okay.
- 5 A. -- you know. I didn't think it was going to -- you
- 6 know, that guy told me, he said, I'm sorry, you know, I hit you,
- 7 and I said, well, you know -- which the roads in Florida,
- 8 everybody knows they're a little watered out too, I mean. So he
- 9 just hit them grooves and I think he just -- I kept trying to get
- 10 away from him and he kept coming over on me, so --
- 11 MR. FOX: Benjamin, can you recall -- I'm sorry to
- 12 interrupt -- what kind of truck that was that hit you?
- 13 MR. BREWER: It was a taller truck. It wasn't a semi-
- 14 truck, but it was like a flatbed six-wheel truck or something. I
- 15 never -- I think I must --
- MR. FOX: Okay.
- 17 BY MR. LaPONTE:
- 18 Q. Okay, so did the other driver give a statement to the
- 19 police officer?
- 20 A. I don't know. I -- the way -- me talking to him, I
- 21 mean, he talked a lot of Spanish, so it was hard. You know, he
- 22 said -- right after that, he said he was sorry, you know, he just
- 23 (indiscernible). Then he said something else and then I said,
- 24 well -- you know, it's hard for me. I don't speak Spanish. He
- 25 spoke a little bit of English and that's how I understood him.

- 1 Q. Okay. So then -- so the officer, 40 minutes to get
- 2 there. He takes the information. He releases the other truck,
- 3 and then --
- 4 A. No, he -- I think he even -- that officer even left a
- 5 couple of times. I don't know what all. I remember it was very
- 6 hot and I was very hot.
- 7 Q. Yeah. So right after -- what was damaged, when you had
- 8 the contact with the other vehicle, on your vehicle?
- 9 A. The fender, the right fender, the radiator. I mean, it
- 10 mashed up the right side just a little bit. I remember the fender
- 11 had to maybe -- maybe beat the fender out on it so I couldn't
- 12 continue with it.
- Q. And what -- you mentioned a fluid leak, a radiator leak.
- 14 A. Um-hum.
- Q. Which hose was that? Did you ever find out --
- 16 A. It was the main hose.
- 17 Q. Up above, on the top, or on the bottom?
- 18 A. It was on the bottom, I think.
- 19 Q. Okay. So it was the bottom return hose?
- 20 A. Yeah. I never got that out with him, but I remember the
- 21 fluid on the bottom, so --
- Q. Okay. And did -- was there any damage to the right-hand
- 23 passenger side mirror on the truck --
- 24 A. Yeah.
- Q. -- because of that contact? Okay. All righty. And

- 1 then how long -- do you have a rough idea how long it took for the
- 2 repair service to come out to where you were?
- 3 A. No, I do not. It took him a little -- he -- it took him
- 4 a little while, but I was sleeping on and off too while he was
- 5 waiting on him and --
- 6 Q. Okay. All right. Okay, then so you get repaired, you
- 7 get up and running, and then you went straight from Wildwood or
- 8 Lake City, Florida, on into Haines City?
- 9 A. Yeah. I was trying to find a place to stop to rest in
- 10 between there and -- I didn't know if the load would make it on
- 11 time, so --
- 12 Q. Did you originally have an appointment time for that
- 13 load or a delivery appointment for the load?
- 14 A. I think it was supposed to be a 6:00 a.m. appointment.
- 15 Q. I'm sorry?
- 16 A. I think it was supposed to be like a -- originally, it
- 17 was supposed to have been a 6:00 a.m. appointment.
- 18 Q. 6:00 a.m. --
- 19 A. Yeah.
- 20 Q. -- on the 24th?
- 21 A. I can't -- apparently, I made the dates wrong on that,
- 22 so I can't -- I'm going to say I can't answer what --
- Q. Okay, that's fine. All right. So you get to Haines
- 24 City, you take your rest. The next morning you get up, you
- 25 deliver the load, and then you start heading back?

- 1 A. Um-hum.
- Q. Okay. All right. That pretty much matches what I have.
- 3 MR. FOX: Yeah. It matches the whole thing, right?
- 4 MR. LaPONTE: Um-hum. Yeah. I mean, with his
- 5 clerical --
- 6 MR. ANDERSON: Yeah. I think the question we had was
- 7 that little bit of movement in the morning and that was -- well --
- 8 MR. BREWER: Yeah. I don't know why it showed that.
- 9 MR. ANDERSON: Well, it sounds to me like that was the
- 10 delivery on Thursday morning.
- MR. LaPONTE: Yeah, it could have been.
- MR. FOX: Yeah, so he -- your recollection is pretty
- 13 close --
- MR. ANDERSON: Yeah.
- 15 BY MR. FOX:
- Q. -- to exactly as we know it. So your memory is good.
- 17 A. Yeah.
- 18 Q. Yeah. I know you were questioning --
- 19 A. I feel like I --
- 20 Q. I know you were questioning yourself --
- 21 A. Yeah.
- Q. -- but I'm here to tell you, you did very well and you
- 23 remembered very good. So good job.
- MR. FOX: Does -- Sean, do you have any hours of service
- 25 type questions to ask?

- 1 MR. ANDERSON: I don't think so.
- 2 MR. FOX: Are you okay with everything?
- Mike LaPonte, do you have any questions on hours of
- 4 service type stuff?
- 5 MR. LaPONTE: Not at this --
- 6 MR. FOX: Not right now? Not at the moment?
- 7 MR. LaPONTE: Not right now.
- 8 MR. FOX: Okay. So, I'll defer to Kenny.
- 9 MR. BRAGG: I don't have any hours of service questions.
- 10 MR. FOX: Okay, so we can --
- MR. BRAGG: Just some of the HP stuff.
- MR. FOX: Yeah. So, we're done the crash sequence.
- BY MR. BRAGG:
- Q. So some of the stuff I'm going to talk to you about,
- 15 it's general stuff, like how do you sleep, your medical history,
- 16 and stuff like that. So the first time I'm really interested in
- 17 is Sunday night going into Monday. I know you got the truck
- 18 sometime Monday and you ended up at the rest stop. Where did you
- 19 stay Sunday night?
- 20 A. I stayed asleep in bed.
- Q. Where? Where did you sleep, at home or in your truck?
- 22 A. At home.
- Q. What time did you --
- A. Or, actually, I stayed in the truck.
- Q. And what time did you go to bed; do you know?

- 1 A. It was early, way before -- I had a good night's rest
- 2 before I left out.
- 3 Q. Did you --
- 4 A. Because I finished putting all my stuff in there and
- 5 just said the heck with it; we'll just stay here and that'll be
- 6 it, you know. I'm about -- I've had a hard time finding a job.
- 7 I'm practically broke and I've --
- 8 Q. Got it hard. What time did you get going on Monday
- 9 morning?
- 10 A. To go get the load?
- 11 O. Yeah.
- 12 A. It was -- well, I think it was -- I didn't have to pick
- 13 the load up till Monday evening, supposedly, I think. So I didn't
- 14 leave till 12:00, I think, around Monday, or it might have been
- 15 after 12. I can't recall.
- 16 Q. What time did you get out of bed?
- 17 A. Oh, it was 10:00, I think. I can't -- I mean, it was --
- 18 Q. How did you sleep? I've never been in -- how does it
- 19 sleep in the back of the truck?
- 20 A. It's pretty good. I mean, I put my -- I put the
- 21 mattress off of my bed at home on it and I can sleep just as good
- 22 there as I can anywhere.
- Q. What do you do for the temperature?
- A. The A/C was working in the bunk, yeah.
- 25 Q. So do you -- you run a truck engine or you run some type

- 1 of --
- 2 A. It runs off a inverter.
- 3 Q. Okay.
- 4 A. You know, like a --
- 5 Q. All right, so -- and what time did you go to bed Monday
- 6 night? And this is while you're at the --
- 7 A. I can't -- it was pretty earlier. I mean, I can't
- 8 remember exactly.
- 9 Q. And Charity is with you, right?
- 10 A. Yeah.
- 11 Q. So what are you all doing? Do you all play cards? I
- 12 mean, what do you all do in the truck?
- 13 A. We just talk, rest, whatever.
- Q. Okay. What time did you get up on Tuesday morning?
- 15 A. Actually, I just had -- I don't recall what time it was
- 16 I got up. I had woken up, and which made me use the restroom, and
- 17 stepped out of the bunk, and the guy was standing directly at my
- 18 driver door. And he said, are you this truck? And I said yeah.
- 19 Q. Okay. When did the air conditioning first break? Were
- 20 you in Haines City?
- 21 A. I can't recall. It seemed like it -- it seemed like I
- 22 was having trouble with it a little bit, but I could -- it was
- 23 running --
- 24 O. Um-hum.
- 25 A. -- but when it finally shut down completely, I was in

- 1 Florida.
- Q. So how did you sleep night? That had to be hard.
- 3 A. No, actually, I slept pretty good. I just opened the
- 4 windows up. It was a cool night in Florida and cool nights in
- 5 Florida, so pretty good.
- 6 Q. Okay. You got windows on the side of the sleeper or
- 7 something?
- 8 A. Um-hum.
- 9 Q. Okay.
- MR. FOX: Um-hum, he does.
- 11 BY MR. BRAGG:
- 12 Q. Yeah. And as far as sleep, do you ever -- did you take
- 13 anything -- do you take anything to help you sleep?
- 14 A. No.
- 15 O. No?
- 16 A. I have taken stuff in the past to sleep, but --
- 17 Q. Nothing --
- 18 A. I didn't take nothing, no.
- 19 Q. Does Chastity [sic] ever complain about you snoring?
- 20 A. I don't know. She never complains to me, but --
- 21 Q. Okay.
- 22 A. She probably will. Maybe she's just being kind to me; I
- 23 don't know. I don't think she would hurt my feelings anyway.
- 24 O. She's not like my wife. She'd hurt my feelings. My
- 25 wife would hurt my feelings.

- 1 MR. FOX: Oh, my wife would poke me and punch me and get
- 2 -- turn on your side.
- MR. BREWER: No, she wouldn't do me that way. I've
- 4 never -- I know I snore and she has never poked me or punched me
- 5 the first time, and I've been with her for a while now.
- 6 MR. FOX: It's a love tap. I stand corrected.
- 7 BY MR. BRAGG:
- 8 Q. So what about your health, generally speaking? Any
- 9 health problems?
- 10 A. I do have problems with my back. I've had problems for
- 11 a while with it.
- 12 Q. What kind of problems?
- 13 A. I think the last MRI I had on it said I had few -- a
- 14 slipped disc, a lot bulging discs.
- 15 Q. Lower back or upper back?
- 16 A. Huh?
- 17 Q. Lower back or upper back?
- 18 A. Lower back, a bulging disk all the way up through.
- 19 Q. Do you take anything for pain?
- 20 A. I used to did, but I kind of quit it and just deal with
- 21 it.
- Q. What did you take when you were taking medication?
- 23 A. Just whatever the doctor prescribes me. It's been a
- 24 long time ago.
- Q. Okay. How about blood pressure? Any problems with

- 1 that?
- A. Actually, I had taken some blood pressure medicines in
- 3 the past and my -- actually, when I got with her, my blood
- 4 pressure had got so low that -- actually, I couldn't afford to buy
- 5 my blood pressure medicine, so -- my blood pressure, I could tell
- 6 when it was high. And I had a lot of stress in my previous
- 7 marriage, so --
- 8 Q. Where did you go to the doctor? What doctor do you see?
- 9 A. I can't remember my doctor's name.
- 10 Q. How about -- is it Dr. Bunch (ph.)?
- 11 A. Yeah.
- 12 Q. Yeah, Dr. Bunch.
- 13 A. That's him.
- Q. When's the last time you've seen him?
- 15 A. I can't recall.
- 16 Q. I mean, has it been 10 years, 1 year?
- 17 A. No.
- 18 Q. This year?
- 19 A. I mean, it's not been 10 years, I don't think.
- 20 Q. Now, you had some type of outpatient procedure at the
- 21 hospital. What was that about? It was in 2010, I believe.
- 22 A. In 2010?
- 23 Q. Yeah.
- A. Probably my broken nose. I had a broke nose. I had my
- 25 nose redone.

- 1 Q. And Dr. Bunch, is he your primary care?
- 2 A. Yeah, but I've been looking for a new doctor.
- 3 Q. How long have you been dealing with him?
- 4 A. I haven't dealt with him in a while. I haven't seen him
- 5 in a while.
- 6 Q. How about health insurance? Do you have health
- 7 insurance?
- 8 A. No.
- 9 Q. No? So how do you normally -- and I don't -- not
- 10 getting in your business or anything, but how do you normally, you
- 11 know, deal with the cost associated with going to the doctor?
- 12 A. I don't go to the doctors.
- Q. You don't go to the doctor? Where do you go get your
- 14 prescriptions filled?
- 15 A. I quit taking my prescriptions.
- 16 Q. Well, when you were taking them, where did you go?
- 17 A. At that time I had insurance, so I could -- you know,
- 18 when I worked previously, some of the jobs I had, I had insurance
- 19 and I let my insurance pay for it.
- 20 O. Okay, but don't know what pharmacy you went to?
- 21 A. Uh-uh, I -- no. They went out of business, so --
- 22 Q. Now, at some point, according to what we've developed
- 23 about your driving, you drove about 33 hours. That's a long time.
- 24 And I'm a little bit older than you, so there ain't nothing I can
- 25 do for 30 hours without taking a nap. So how did you stay up?

- 1 A. I took a nap.
- 2 Q. You took a nap?
- 3 A. Yeah, I take naps.
- 4 O. You'd have to take (indiscernible)?
- 5 A. If I got tired, I'd pull over.
- 6 Q. Now, I've also got some -- got information that you -- I
- 7 guess you're going through a custody dispute with your ex-wife?
- 8 A. Yeah.
- 9 Q. Tell me about that. Tell me about that.
- 10 A. I'm not -- look, I'm not getting into my custody dispute
- 11 with my kids in this right here.
- 12 Q. No, I'm not --
- 13 A. This has nothing to do with that wreck.
- 14 Q. Okay. Well --
- 15 A. My kids are staying out of this.
- Q. Well, let me ask you this. You took a drug screen test
- 17 and --
- 18 A. I also have a hair follicle test from November that was
- 19 clean. I also have another test for Ryder that was clean. I also
- 20 have another test for Billy that was clean. I have 6 months of
- 21 testing that was clean.
- Q. Okay. But the most recent one that was in May didn't
- 23 come back clean.
- 24 A. Yeah, and I was -- I had taken some allergy medicine and
- 25 I had a asthma attack and I had taken inhalers.

- 1 Q. Okay.
- 2 A. I know where this is leading, so --
- 3 Q. All I'm trying to do is get a picture of your health.
- 4 I'm not accusing you of anything. And if that's the reason you
- 5 tested positive, then that's good for us to know.
- A. Um-hum, that's the reasons.
- 7 Q. Okay.
- 8 A. But it's funny that, you know -- her family has a lot of
- 9 pull. It's funny that I can take all these tests and pass them,
- 10 but when it comes to her -- this one time, you know, they had to a
- 11 hair follicle test and I had just had a hair follicle test in --
- 12 just a few months back and I passed it, but she doesn't -- then it
- 13 come up like that and, you know -- but I had been taking, like --
- 14 I have problems with allergies and I take allergy medicine and
- 15 I'll get my -- you know, whatever I can to deal with it. But I
- 16 did have asthma attack and used one of the -- an inhaler to get my
- 17 breath because of --
- 18 Q. Yeah. Have you ever used illicit drugs or illegal
- 19 drugs?
- 20 A. No.
- Q. Okay. If I was to offer you the opportunity to take a
- 22 hair follicle test now, would you take one?
- 23 A. I'm not taking no more tests.
- Q. Okay, okay, it was just a question.
- 25 A. I'm done with tests. I -- I'm -- my ex-wife's about

- 1 ruined me on this one.
- Q. Now, how do you -- when you're in the truck, how do you
- 3 navigate? I mean, how do you find your way? You use a map, use a
- 4 GPS, or --
- 5 A. Most places, I get pretty used to where I have to go to.
- 6 That way, I found it -- I think I pulled it up on my phone and it
- 7 told me the directions to go.
- 8 Q. What kind of phone is that?
- 9 A. It's a iPhone.
- 10 Q. Is that the one with the cracked back?
- 11 A. I can't remember if the back is cracked or not.
- 12 Q. Well, it has tape on it, like, electrical tape.
- 13 A. I don't know.
- 14 Q. Does --
- 15 A. Because I got -- I have got several phones.
- 16 Q. Does Charity have an iPhone too?
- 17 A. I don't know what -- I don't -- actually, I don't know
- 18 the difference in them. I don't get that text savvy in them.
- 19 Q. Okay.
- 20 A. I even took another test for Billy when I got back.
- 21 Q. Okay.
- MR. FOX: Right, right, we know.
- BY MR. BRAGG:
- O. What kind of test was that?
- 25 A. It was a urine test.

- 1 Q. A urine test?
- 2 MR. BRAGG: Well, that's all I have for him.
- 3 MR. FOX: That's all?
- 4 MR. BRAGG: The bulk of what I want is in the
- 5 (indiscernible) and the other stuff I have.
- 6 MR. FOX: I'm basically done what I want to do.
- 7 MR. BRAGG: Oh, I do have one other question for him.
- 8 UNIDENTIFIED SPEAKER: Go ahead.
- 9 MR. BRAGG: All right. Real quick.
- 10 BY MR. BRAGG:
- 11 Q. When we were itemizing some of the belongings in the
- 12 truck, there was a notebook with a bunch of GPS recordings in it.
- 13 Do you know anything about that?
- 14 A. Oh, that's my lake coordinates. I had -- used to -- I
- 15 used to love to fish and I'd marked -- I had written down, I
- 16 guess, the coordinates for places like for humps marked in lakes
- 17 and stuff like that, I guess, is what I had started the GPS
- 18 coordinates for.
- 19 Q. Oh, okay, okay.
- 20 A. Yeah.
- MR. FOX: The book is here.
- MR. BRAGG: Yeah.
- MR. BREWSTER: I mean, I don't know why I would've been
- 24 writing down GPS coordinates.
- BY MR. BRAGG:

- 1 Q. I don't either; that's why I asked.
- 2 A. That's the only thing I could figure it would be is --
- Q. Okay.
- A. -- one of my GPSs I had, I would -- I was -- it seemed
- 5 like I was transferring one of my -- one GPS onto the other, and
- 6 it was one of the first GPSs that came out and it wouldn't
- 7 transfer over to my new GPS. So I went down through there writing
- 8 them coordinates down so I could have it on my new GPS; that's
- 9 what it was.
- 10 Q. Okay.
- 11 MR. FOX: Is that what's in that little notebook?
- MR. BREWER: I would say that's what that is, yeah.
- MR. FOX: And that's your handwriting?
- MR. FOX: I don't, I don't know. Some of it might be
- 15 and some of it might not be; I don't know.
- MR. FOX: Okay.
- 17 MR. BRAGG: All right.
- 18 BY UNIDENTIFIED SPEAKER:
- 19 Q. Yeah, I have one more question. You said you took a
- 20 urine test for Billy --
- 21 A. Um-hum.
- Q. after the accident. Did you do did he do an
- 23 alcohol test as well or is just --
- A. Yeah, he done an alcohol test too.
- Q. Okay. I was just wanted to clarify. Thanks.

- 1 MR. BRAGG: And he also gave a sample for Tennessee
- 2 State Patrol, right?
- 3 MR. BREWER: Um-hum. Yeah.
- 4 MR. BRAGG: Okay.
- 5 BY UNIDENTIFIED SPEAKER:
- 6 Q. What day did you go take the post-accident test for
- 7 Billy? Do you remember what day it was? Do you remember what
- 8 physical day it was that you did that?
- 9 A. You mean then?
- 10 Q. Obviously, it was -- after the accident.
- 11 A. I can't recall what day it was. It was as soon as I
- 12 could get up there. I got back, had no keys to get into my
- 13 vehicle, and as soon as I got a ride to get up there, I got up
- 14 there.
- 15 Q. Okay.
- 16 BY MR. BRAGG:
- Q. Did you take any pills on the way?
- 18 A. No.
- 19 Q. No? Because we also found some prescriptions in the
- 20 truck.
- 21 A. I don't know. They wasn't mine.
- 22 Q. Okay.
- MR. BRAGG: That's it.
- MR. FOX: How about some of those other items, like the
- 25 -- that acrylic --

- 1 BY MR. BRAGG:
- 2 Q. Yeah. The -- here's one of the things that we want to
- 3 know about. Let me show you a picture here in my phone. What do
- 4 you use this for?
- 5 A. I don't know whose that is.
- Q. It's not yours?
- 7 A. Uh-uh.
- 8 Q. Okay. How about this?
- 9 A. That looks like one of them inhalers.
- 10 Q. It's one of yours?
- 11 A. It's not mine. It's one of Charity's kids', I believe.
- 12 Q. Okay. There's also, in the back of the truck, there's a
- 13 glass plate; like a little glass cutting board.
- 14 A. Um-hum.
- 15 Q. Is that yours?
- 16 A. I think Charity -- it probably is. I mean --
- 17 Q. It's about the size of the notebook, about the size of
