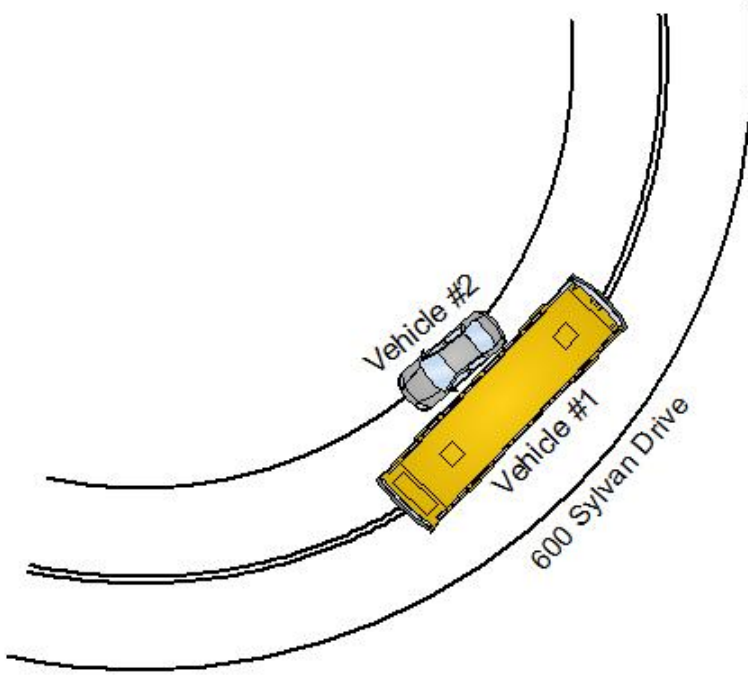

Narrative
