1	<u>INTERVIEW</u>
2	DET. BENDER: Okay. Good afternoon. This is Detective
3	Thomas Bender of the Baltimore City Police Department. I'm a
4	member of the crash team.
5	We're here in reference to a fatal accident that occurred on
6	November the 1st, 2016 at approximately 6:30 in the morning. It
7	happened in the area of 3900 block of Frederick Avenue, which is
8	within the City of Baltimore.
9	Present with me are several investigators who are party to
10	this investigation. And at this time this is just simply an
11	interview because you were an alleged occupant of one of the
12	involved vehicles. So we'll do a couple things here. So present
13	is counsel for the witness.
14	Sir, if you could identify yourself and just identify this
15	location for us where we're at.
16	MR. GREENBERG: Sure. Harvey Greenberg. My office, that's
17	where we're at, 29 West Susquehanna Avenue, and it's in Towson,
18	the ZIP is 21204.
19	DET. BENDER: And the suite number again is?
20	MR. GREENBERG: 700.
21	DET. BENDER: Fantastic. Okay.
22	So the other parties that are present with us for this
23	interview that are with me, the police and other investigators,
24	one is a sergeant with the Baltimore Police Department. Sir, for
25	the sake of the tape, I'm going to ask that everybody speak

1 loudly. SGT. McMILLIN: Sergeant Paul McMillin, Traffic Division. 2 3 DET. BENDER: Okay. And the other two investigators present 4 in the room? 5 DET. NAGLIERI: Detective Ryan Naglieri, MTA Police, Criminal 6 Investigations Unit. 7 DR. MARSHALL: Rafael Marshall with the National 8 Transportation Safety Board. 9 INTERVIEW OF ROBIN SIMMONS BY DET. BENDER: 10 11 Okay. Most importantly, ma'am, if you could just for the Q. 12 sake of the tape give us your full name, spell it out. 13 Robin, R-o-b-i-n, Simmons, S-i-m-m-o-n-s. Α. 14 Okay. Ma'am, what is your current address? Ο. 15 Α. 16 I'm sorry. What is that street? Ο. 17 Α. 18 Q. 19 Yes. Α. 20 Ο. Can you spell that, please? 21 Α. 22 No problem. Ma'am, what is your date of birth? Q. 23 Α. 24 No problem. And what is your Social Security number? Q. 25 Α.

1 Q. No problem. Ma'am, do you have a good contact phone number? 2 Α. Yes. 3 What's that phone number, ma'am? Ο. 4 Α. 5 No problem. Can you say that just one more time, because I'm Ο. 6 a little low of hearing? 7 Α. And is that your cell phone number? 8 Ο. 9 Α. Um-hum. 10 Okay. So a couple things first off. We notice that if you Ο. 11 can describe for us how you're seated today, because I notice it 12 appears you're still suffering some injuries from this incident. 13 So --14 I'm sitting in two chairs, my left leg in one due to my Α. Yes. 15 ankle and my hip, and the rest of my body in the other. 16 Okay. Are you currently under any medication? Ο. 17 Α. Yes. 18 Can you describe that medication you're taking right Ο. Okav. 19 now? It is ibuprofen, oxycodone, and a baclofen. 20 Α. 21 Okay. Now you've mentioned several medications you're Ο. taking. Now have you -- you have taken them today, correct? 22 23 Yeah. Α. Okay. Now you are present here, and do you feel that any one 24 Ο. 25 of those would prohibit you from thinking clearly?

1	Α.	No.

Q. Okay. Just a simple question. Now have you taken them the other days prior to this already?

4 A. Yes.

5 Q. Okay. So you're aware of how it kind of affects you, so you 6 do feel that you're able to think clearly and respond and talk 7 with us, ma'am?

8 A. Yes.

9 Q. Okay. Describe for us the injuries that you were treated for10 on the date of this crash, ma'am?

A. It starts at the top of my head, my forehead, and the side of my face, my neck, my shoulders, my back, my hip, and my ankle and my foot.

14 Q. Can you just -- forgive me, because we're just recording

15 this. You pointed to a hip. Can you describe which hip that was? 16 A. My left hip.

17 Q. Okay. And you said your ankle, which ankle was that?

18 A. My left ankle.

19 Q. Okay. And you pointed to something else, what was that?

20 A. My left hip, back. I think it was like my ankle and my

21 foot -- the top of my foot, my left foot.

Q. Okay. Now -- no problem. These injuries, are they -- is it just strains or do you have any broken bones that you're aware of?

24 A. Not that I'm aware of.

25 Q. On the date of the crash, you received medical treatment; is

- 1 that correct?
- 2 A. Correct.
- 3 Q. Do you remember which hospital they took you to?
- 4 A. University of Maryland.
- 5 Q. And do you remember how you got to that hospital from the 6 scene?
- 7 A. In an ambulance.
- 8 Q. Ambulance. Were you the only patient in that ambulance, if 9 you recall, ma'am?
- 10 A. In the ambulance?
- 11 Q. Yes, ma'am.
- 12 A. No.
- 13 Q. You don't --
- 14 A. No, I was not.

Q. Okay. So I guess the first thing is, we'll let you explain what you remember from that date. If you can just start from where you feel comfortable and we'll kind of pick and poke from there, fair enough?

And if -- most important thing here, ma'am, is I recognize you are the one that suffered the injuries the other day, so --I'm not going to sit here and be all sweet, but if we have to stop for a moment, by all means, please, because you're the one that did -- is obviously -- I'm sure you'd probably rather be at home as well. So, (a) I thank you for this. And if you get to a point where you just say, hey, I want to stop, please speak up and we'll

1 accommodate that, okay, ma'am?

A. Okay. It start like any normal other day. We actually had came from one child's house. We were -- that child did not come out. So that being said, I was marking my paperwork accordingly, which means that my head was down.

6 Now in the morning we have to fill out all the names of the 7 kids that are on our sheet, so it was down for quite some time, I 8 quess; there were no children, though. So I felt -- the bus is 9 normally -- you know the city streets are, like, not really good, 10 so to bump and stuff is normal. So at that particular time I felt 11 a bump. Not -- it wasn't a bump that pushed us from left to right 12 or forward or backwards, but it was kind of abnormal. But it was 13 just only abnormal enough for me to turn around. Being as though 14 the seats are higher than me, I can't look straight.

So I look out the back of the MTA -- I mean, out of the yellow bus. And we have like a little window in the back where you can see kind of the ground, and I didn't see anything, like, so -- but they're saying that we hit a Mustang. So that could've very well been it, but we were just too strong to make a significant feel. But I did -- while I was looking back I was, like, oh, I don't see anything.

But I felt us like kind of accelerating. So protocol says if anything is wrong with the bus, you got to like plant your foot and get up -- you got to get up, plant your foot, and slide -like slide the bus driver over. But anyway, it wasn't an

1	emergency in my mind at the time, but I did get up to plant my
2	foot and we crashed.
3	But I didn't tell you where I was sitting at. I was sitting
4	behind the bus driver. So honestly to be with me getting up, I
5	think that saved my life. Like, just in an instance but I
6	couldn't get up to do any nothing. Like I don't even remember
7	nothing after that, like.
8	Q. Okay.
9	A. I just remember a big crash.
10	Q. A little history. Have you ever been in a car accident
11	before, before this?
12	A. Um-hum, yes.
13	Q. Were they violent or were they just kind of minor fender
14	benders?
15	A. Minor fender benders.
16	Q. So when you were driving down the road well, more
17	importantly, so when you recalled this first bump you said you
18	were seated behind the driver, or
19	A. Behind the driver, the exact seat behind him. And how that
20	goes is, his seat is taller I guess it would be like the back
21	of the seat is taller than me, but then his seat, it goes all the
22	way up to his head, so that's even taller. So I cannot see out.
23	I would have to lean to look either forward or backwards.
24	Q. Okay. So earlier you were leaning. So when you said this
25	initial, I guess, impact to the bus you felt enough that it drew

1	your concern. So you had to look out to your over your right
2	shoulder
3	A. Yes.
4	Q to look through the back of the bus?
5	A. Yeah.
6	Q. Okay. After the crash, do you remember how you got out of
7	the vehicle?
8	A. I remember getting up, seeing smoke, hurting. I looked up at
9	my driver and then I got out the back. I went out the back.
10	DET. BENDER: Could you see if your secretary could bring
11	some tissues in, sir?
12	MR. GREENBERG: Sure.
13	MS. SIMMONS: I think he was dead right then. Just like kind
14	of
15	MR. GREENBERG: Take your time. Take a drink.
16	SGT. McMILLIN: Yeah, just take a drink. Just calm down,
17	yeah.
18	MR. GREENBERG: Take a breath. Just calm down.
19	DET. BENDER: Again, Mr. Greenberg, if you feel that in the
20	interest of your client if we should stop let us know.
21	MR. GREENBERG: You okay?
22	MS. SIMMONS: I'm fine. I mean, it's normal, not I want
23	you to know, but I can't help it.
24	BY DET. BENDER:
25	Q. Yes, ma'am. So prior to these collisions, so you were in the

i	
1	seat immediately behind the driver and you said there was nobody
2	on the bus because you'd gone
3	A. He didn't come out.
4	Q. Do you remember the address for that first stop, ma'am?
5	A. No, I don't remember it, but I might, I might have a paper in
6	here.
7	MR. GREENBERG: You're pointing to that one, the first one?
8	MS. SIMMONS: Um-hum.
9	DET. BENDER: Okay.
10	MR. GREENBERG: What is this?
11	MS. SIMMONS: This? A route sheet. This is that's
12	something we have to take the information on that paper and
13	transfer it onto another piece of paper.
14	DET. BENDER: Okay.
15	MS. SIMMONS: And that's what I was doing at the time
16	while
17	MR. GREENBERG: I'll need a copy of that.
18	DET. BENDER: I'm sorry?
19	MR. GREENBERG: I'll need a copy, and you'll want a copy of
20	that?
21	DET. BENDER: Yes, yes.
22	MS. SIMMONS: That's something old, though. But
23	MR. GREENBERG: That's old?
24	MS. SIMMONS: Yeah, that's old.
25	BY DET. BENDER:

1	Q. It's an old one? But it's the same addresses?
2	A. Yes.
3	Q. So I'm looking at a document here, it's titled the Baltimore
4	City School System.
5	A. Yeah.
6	Q. And it's got the contractor's name. It says Affordable
7	Transportation.
8	A. Yep.
9	Q. And just for the sake of the tape, forgive me, I'm just going
10	to point out that you produced this document and you presented it
11	for us to review.
12	A. Um-hum.
13	Q. So the address here it says the first stop was
14	And I'm assuming it's probably Baltimore City?
15	A. Yes.
16	Q. Now have you this route, have you is this a route that
17	you normally ride on the same day?
18	A. No, no. I have ridden on it more than once, but
19	Q. Okay. So you are partially familiar with the route then?
20	A. Yes.
21	Q. Okay. Fair enough. So again, for the sake you said that
22	I guess you said you went to the first stop and you said
23	there was that the child was not there or wasn't ready to go to
24	school that day?
25	A. We only give them 3 minutes. So, no.

Q. Okay. Do you get off the bus or you just remain seated?
 A. No. I remain seated. If a child is disabled, I can't -- I'm
 not supposed to get off of the bus but I can meet them at the
 steps.

Okay. And actually that kind of goes on to one thing, can 5 Ο. 6 you kind of describe your role as being an employee -- or at least 7 for this date, what was your role working for the bus company? My role is to maintain safety on the bus so that the bus 8 Α. 9 driver can safely drive to and from his -- where he needs to take 10 the children. Now, being as though they're special needs 11 children, they need someone to -- you know, sit down, be quiet. 12 Also some of them are nonverbal, they can't speak. Some of them 13 need to be in seat belts, car seats, harness, and that's my job to 14 make sure that they are safe enough to be transported.

15 Q. Okay. Now your seat, do you know -- recall if it's equipped 16 with a seat belt or not?

- 17 A. My seat?
- 18 Q. Yes.

A. No. We don't have -- you only get a seat belt if you aredisabled and are required one, like by an IEP or something.

21 Q. Okay. And that would be something that you would --

22 A. Baltimore City School.

Q. -- you would fasten around that specific child then?
A. Yes. Yes.

25 Q. Okay. Ma'am, would it be a problem at the end of this

1	interview if we if your lawyer provides us with a copy of this
2	document?
3	A. I don't
4	Q. Or you're saying this one this is an old
5	A. That's old. That's outdated. Yeah.
6	MR. GREENBERG: But you can have a copy.
7	BY DET. BENDER:
8	Q. No problem.
9	A. Okay.
10	Q. Now will you so I guess at the start of each, each day do
11	you get a brand new route sheet?
12	A. When there are new changes.
13	Q. Okay.
14	A. Only when there's a change.
15	Q. Okay. So
16	A. And there has been changes since that.
17	Q. Okay. So you mean that that day when you guys were
18	driving or that day when you left, there was an addition to the
19	route?
20	A. No. That's not that's an old paper.
21	Q. That's an old paper?
22	A. No. There was no differences in the route that day.
23	Q. Okay. Let's back up a little further then. So when you come
24	to work that day, do you respond to the bus facility there?
25	A. I come in. I clock in. I look to see if there are any

2	Ω.	Okay.

I

3	A. I take my folder. I wait if my driver is there, we both
4	leave out of the building and we get on our bus and proceed to our
5	route. If my bus driver is not there, I'll just have to wait a
6	little bit.

- 7 Q. Okay. And the address of the office, do you know what that8 is, or where you guys report to in the morning?
- 9 A. 46 Franklin Town Road.

10 Q. Okay. So this morning -- or that -- the morning of the

11 incident, describe for us -- so do you remember what time you got

- 12 to work that day
- 13 A. Like 5:45.
- 14 Q. Do you know if -- do you have to sign into like a log sheet, 15 or how --
- 16 A. They can scan. They can scan.
- 17 Q. At the facility there, they scan you in?
- 18 A. Yes.
- 19 Q. Okay. And you said you got there about 5:45?
- 20 A. Yes.
- 21 Q. Do you remember if your driver was already there at that
- 22 point? If not, just say you don't remember, that's perfectly
- 23 fine.
- 24 A. He was there.
- 25 Q. So you went in, and part of getting ready was getting your

1	route sheet, ma'am; is that correct?
2	A. Yeah, there wasn't we didn't have any new route sheets.
3	We didn't have an update. So I just grabbed it's a case, you
4	know, so that we can be able to write on and put the information
5	inside.
6	Q. Like a clipboard or something?
7	A. Yeah.
8	Q. Okay. Now you said there's something else you write on for
9	your tour, during your tour of duty.
10	A. No. That's a guide so that we know what to do.
11	Q. Okay.
12	A. The piece of paper that we transfer the information on is a
13	guide for the city so they know what we did.
14	Q. Okay.
15	A. Because not every day do those kids come to school, not every
16	day do we have to pick them up. So that's like our "result for
17	the day" paper.
18	Q. Okay. And is that something you turn in at your
19	A. At the end of the week.
20	DET. BENDER: At the end of the week. Okay.
21	SGT. McMILLIN: You turn back into the company?
22	MS. SIMMONS: Yes, to the company. And I believe they turn
23	it into Baltimore City.
24	BY DET. BENDER:
25	Q. Okay. But that's not this document?

	1	
1	Α.	No.
2	Q.	This is your guide?
3	Α.	Yes.
4	Q.	And then you have the results page that, you know
5	Α.	Yes.
6	Q.	hey, we picked up
7	Α.	This person came, this person didn't come.
8	Q.	Fair enough. So when you guys left the facility that
9	morn	ing, it was just you and the driver on the bus at that point?
10	Α.	Yes.
11	Q.	Okay. And typically, like, is there any requirements of you
12	to prepare the bus or anything, or is that on the responsibility	
13	t	o the best of your knowledge, is that the responsibility of
14	the	driver?
15	Α.	Yeah. It's not much that we have to do, that we have to
16	prep	are for a run because pretty much everything is done in the
17	morn	ing, except for like your basic bus driver check the bus, you
18	know	
19	Q.	Now do you remember if this morning you guys had to stop and
20	fuel	up the bus or not?
21	Α.	No, we didn't.
22	Q.	Okay. So basically when you left the facility you guys went
23	dire	ctly to your first stop on, was it ?
24	Α.	Yes.
25	Q.	Okay. And after that stop, do you remember if between that

1	point and the accident, did you just stay on one road or were
2	there multiple turns between there and when the crash occurred?
3	A. No. Like I said, my head was down once we pulled off so that
4	I can mark absent
5	Q. No problem.
6	A and then I just completed the rest of the filled in the
7	rest of the people's names.
8	Q. Okay. So again you go to the first stop, the child is not
9	there. You continue down the road.
10	A. Um-hum.
11	Q. And then you just remember
12	A. Like a
13	Q an impact. Does you, does your driver make any comments
14	or do you hear anything from him?
15	A. No, no, and that's that also like once I looked back,
16	I'm saying, hey, what was that? You know, normally somebody be
17	like, oh, that was just a pothole or, you know, just some kind of
18	response. So then I looked back, I didn't hear anything, and then
19	I'm like, hum. But then I'm like, hold up. You know, I kind of
20	was battling my own thoughts at the time. It was fast, so
21	Q. Hey, listen, we understand it. Don't second guess yourself
22	at this point.
23	A. Right.
24	Q. There was just that was a lot for you to go through, so,
25	you know, don't

1 So I get up. I brace my -- I mean, that's kind of like Α. 2 common sense knowledge, you kind of get what you were taught with. 3 But I brace my foot to prepare if anything was wrong. And vou're 4 supposed to put your foot at the -- there's a line that you're not supposed to come across. You're supposed to put your foot there 5 6 to brace. That's just in case (a) you don't fly out the window, 7 and in case you got to put your -- force to move a bus driver over, you know, push him out of the way so I can pull the 8 9 emergency brake. I didn't even get that far. 10 BY SGT. McMILLIN: Did you have -- just so, so you've been trying --11 Q. 12 I didn't even -- yeah, but I didn't expect -- I prepared Α. 13 myself but I didn't think that nothing was really wrong, you know. 14 And even before my brain got to switch to even -- we was crashed. Well, I'm glad you -- I'm glad you're well, okay. 15 Ο. You're 16 sitting here with us today. 17 Well, Ms. Simmons, Ms. Simmons, let me ask you this question. 18 Did you speak -- did you -- I mean, do you know, do you know your 19 driver? What type of relationship do y'all have? He was a -- he was a really nice guy to me. 20 Α. 21 Ο. Can you tell me, tell me about --22 Yeah, like, how our conversations go? Good morning. I mean, Α. 23 we have some very intelligent children on our bus and, you know, 24 they give us laughs. We laugh together. We talk about, oh, wow, 25 I didn't expect that conversation to go that way. And he's like,

1	yeah	, these kids these days are an older guy, just I got to get
2	home	to my wife, I owe her some money, you know.
3	Q.	Oh, so he
4	Α.	My lady doesn't have to do a thing as long as she takes care
5	of me	e at home. You know
6		SGT. McMILLIN: Okay. So
7		DET. BENDER: So, is
8		SGT. McMILLIN: Go ahead.
9		BY DET. BENDER:
10	Q.	So is it fair to say that you worked with him other times
11	befo	re enough to build a relationship up with him?
12	Α.	Even in the office, though, Like I don't have to go out on a
13	run '	to mingle with my co-workers. You know, during the morning
14	time	a couple minutes, we're all waiting. Yeah.
15	Q.	So then
16		SGT. McMILLIN: Go ahead, go ahead
17		BY DET. BENDER:
18	Q.	In the times that you more importantly, I guess, how long
19	have	you been with the company?
20	Α.	Since late August/early September.
21	Q.	So I guess
22	Α.	When school start.
23	Q.	I'm sorry?
24	Α.	When school started.
25	Q.	When school started, okay. So was there like a lag time of

2	A. Um-hum.
3	Q. Do you recall if it was a couple days or a couple weeks?
4	A. Like it's tricky because we go to class held by Baltimore
5	City. So I guess the company decides whether they're going to
6	hire you or not hire you, and then they send you to the class
7	before they can actually hire you. So that's certification class.
8	Q. Okay. And what
9	A. I went there probably a week before I started.
10	Q. Okay. And where was that held at, ma'am?
11	A. Asquith. I do not have an exact number, but they know.
12	Q. But it's a city school property?
13	A. Yeah. Citywide or something on Asquith.
14	Q. Okay. And I see your
15	A. That's the certificate right there.
16	DET. BENDER: lawyer has produced a document here.
17	MR. GREENBERG: It gives you the time.
18	DET. BENDER: I'm sorry?
19	MR. GREENBERG: It gives you a date, August.
20	DET. BENDER: Okay. So I see it says certificate of
21	completion. It's Baltimore City Public Schools, Office of Pupil
22	Transportation and it's you, Robin Simmons.
23	MR. GREENBERG: Are you okay?

1 when you applied and when you started working or --

24 MS. SIMMONS: It's just beating hard.

25 BY DET. BENDER:

1 Q. Again, would you have a problem with when we leave we get a
2 photocopy of this document?

3 A. No.

4 Q. Okay. Thank you.

5 So you went to this training. How many days was that, ma'am?
6 A. One day, 8 -- 1 day, 8 hours.

7 Q. Eight-hour training. And do you remember if it was like a
8 test or basically just a --

9 Α. Oh, yeah. We go in, we get our ID, our fingerprints. We're 10 given paperwork. We fill out -- like they give us case scenarios 11 of problems that they have had within the years, and they let us 12 figure out how we would -- you know we fill it out. And then they 13 will go over with the whole group and say that was right, you were 14 right, why did you pick that. Like they were really -- you know, 15 they really (indiscernible).

16 Q. So when you were saying these were special need students,

17 describe that a little bit. Does it mean they're unruly or a far 18 range --

19 A. They -- it's a far range.

20 Q. It's a very broad word?

A. You have children that people say are bad or rowdy or unruly; they're called Level 5, behavioral students. And then you have mentally, physically, like it's disabled children. It's a wide variety.

25 Q. Okay. Now with that in mind, what protocols were in place, I

1	guess, if you know, on behalf of the company that you work for or
2	the school that so, say, you're en route and you have an issue,
3	what was the way to seek help, if you know?
4	A. Depending on the issue, but generally we have like write-up
5	sheets. First
6	Q. I mean, more importantly, like if you need immediate help,
7	like there's a
8	A. The bus driver will pull over. We will call the we would
9	call the police and the company.
10	Q. Okay. Now do they provide you with a phone or is that
11	expected you just use your phone?
12	A. They they actually give us a choice. They have phones for
13	us.
14	Q. Okay. Now on the day of this crash, do you remember if you
15	had your personal phone?
16	A. My personal.
17	Q. Oh, you didn't have a work phone with you that day?
18	A. No.
19	Q. Okay.
20	A. That's just what happened that day.
21	Q. Okay. I see, I see you holding up your phone. It looks like
22	it survived a little war there.
23	A. We came out the same, just a little bit broken.
