3	SGT. FRITCH: Today's date is April the 5th, 2017. It is
4	10:39 a.m. My name is Aaron Fritch, sergeant with the State Crash
5	Reconstruction Team, Texas Department of Public Safety. In the
6	room with me is Trooper James D. Jones with the State Crash
7	Reconstruction Team, Texas Department of Public Safety, and
8	also
9	MR. MARSHALL: Rafael Marshall, human performance
10	investigator, with the National Transportation Safety Board.
11	SGT. FRITCH: The purpose of this interview is to speak with
12	a passenger in the bus from a crash that occurred on March the
13	29th, 2017 in Uvalde County.
14	INTERVIEW OF ROSE M. HARRIS
15	BY SGT. FRITCH:
16	Q. Ma'am, if I could get you to state your name for me.
17	A. My name is Rose, middle name Mary, last name Harris.
18	Q. Okay. And, Ms. Harris, what is your date of birth?
19	A
20	Q. Okay. And just so everybody's clear that may listen to this
21	recording later, do you voluntarily give this statement to us
22	without any kind of coercion or promises or anything of that
23	nature?
24	A. Yes, sir. I voluntarily give you the information. I will
25	answer your questions to the best of my ability.

1	Q. Thank you, ma'am. So like I stated, we're investigating the
2	crash that occurred in Uvalde County March the 29th, 2017. I
3	understand you were a passenger within one of those vehicles?
4	A. Yes, sir.
5	Q. Okay. And were you a passenger in the Ford bus owned by the
6	First Baptist Church of Uvalde?
7	A. Yes, sir.
8	Q. Okay. Do you recall where within that bus that you were
9	seated?
10	A. Yes, sir.
11	Q. Okay.
12	A. I was sitting in the last row of the bus. I was sitting at
13	the right passenger window.
14	Q. Okay. In the far back of the bus
15	A. The last seat. You couldn't go no farther.
16	Q the last seat, and you were on the, on the out
17	A. I was at the window. I was sitting at the window.
18	Q. You were on the window. Okay. And was anybody sitting
19	beside you in that seat?
20	A. Yes, sir. Ms. Cristie Moore was sitting next to me.
21	Q. Okay.
22	A. Husband and wife, Jo and Jo was the wife's name. Give me
23	my church book, I can tell you the husband's name.
24	Q. Well, we'll worry about that
25	A. Okay.

1	Q.	That's a question I'll get to later and, and
2	Α.	Joe and Harold were sitting next to them.
3	Q.	Okay. Okay.
4	Α.	Harold was sitting next to Cristie, and his wife was sitting
5	at tl	ne driver's side window.
6	Q.	Okay. Yeah, now, I actually have a diagram for the bus.
7	Α.	Okay.
8	Q.	We think that we have everybody's position correct, but I'll
9	get	that
10	А.	Okay.
11	Q.	we'll look at that at the end.
12	А.	Okay, yeah.
13	Q.	So where had your all's bus left from that day?
14	А.	We had just left from the religious retreat place, Alto Frio.
15	Q.	Alto Frio, yes, ma'am.
16	А.	And they voted on going that route because they wanted to go
17	to M	cDonald's.
18	Q.	And McDonald's, where at?
19	А.	I don't know. I'm new here in Texas. But if they go that
20	way,	they pass McDonald's that they go to.
21	Q.	Probably in Uvalde, I would imagine.
22	А.	I can't tell you because I don't know the cities that well
23	beca	use I've only lived in Texas for 2 years.
24	Q.	I understand.
25	Α.	This was my first retreat.

1 Q. Okay.

2	A. They have they go to on the way up there, we stopped at
3	the Dairy Queen, where they like to go, we went one way. And you
4	go a different way if you're going that's all I know, is you go
5	a different way for them to go to McDonald's.
6	Q. Okay. How long had you been out at the retreat?
7	A. I went out to the retreat from Monday is that the 26th, 26
8	and oh, wow, I'm getting my numbers mixed up. We went there
9	well, we did go that Monday
10	Q. Okay.
11	A to the retreat and we left coming back that Wednesday, the
12	29th.
13	Q. Okay. So it would have been Monday would have been the
14	27th.
15	A. Okay. 27th, 28, 29. Okay, those are the dates. I'm sorry.
16	Q. Okay. So you all were there Monday through Wednesday?
17	A. Yes, sir.
18	Q. Okay.
19	A. We had lunch and left.
20	Q. Had lunch there at the retreat, then left?
21	A. Yes.
22	Q. Okay. About what time do you think it was when you all left?
23	A. Somewhere around the noon, the noon hour. Because we was
24	had worship service that morning, and we done with worship service
25	and we got to got to lunch early, because I think lunch was

1	scheduled for like 11:15 but I think we got there got finished
2	with worship service, they got us to lunch, and we was able to eat
3	a little earlier.
4	Q. Okay.
5	A. And the people some people stayed for lunch and some
6	people left because they was in their personal vehicles, and they
7	just left before us.
8	Q. Okay.
9	A. And some people left in their vehicles when we left, but
10	because they wasn't going to McDonald's, we were not in no
11	where you all following each other, we wasn't doing that.
12	Q. Okay.
13	A. The other vehicles, nobody wasn't we wasn't following, you
14	follow his car, his car, we wasn't doing that.
15	Q. How many people did you all have at the retreat?
16	A. Oh, man, we had, oh, about 80 people.
17	Q. Oh, wow. Okay. Were they all from your all's church or
18	from different churches?
19	A. Yes, sir. Except for one lady, I think one lady I think
20	wasn't from our church, she used to go there, and she was sitting
21	in front of me on the bus. She was going to the Oakwood Church in
22	New Braunfels.
23	Q. Okay.
24	A. I think that's the name of the church. I'm uncertain. But
25	she still sang in the choir. A lot of the members that were

1	there	e, they sing in the senior choir. They call it the Sunshine
2	Sing	ers.
3	Q.	Okay.
4	Α.	And she still would sing with the Sunshine Singers, although
5	she d	didn't come to our church every Sunday.
6	Q.	Okay. So you all had multiple busses that were
7	Α.	No, sir.
8	Q.	No?
9	Α.	One bus.
10	Q.	It was only one bus?
11	Α.	But other people drove their private vehicle.
12	Q.	Okay. So there was
13	Α.	Be it a car, van, or truck.
14	Q.	Okay.
15	Α.	Because my luggage was in another Sunday school teacher truck
16	he ha	ad.
17	Q.	Okay.
18	Α.	He had my, he had my luggage.
19	Q.	Okay.
20	Α.	Because our van didn't hold luggage.
21	Q.	Okay.
22	Α.	That I could tell. We just had our personal needs with us in
23	that	bus.
24	Q.	Yes, ma'am.
25	Α.	You know, how the white women have them purses and them other

2	Q. Okay.
3	A. You know, but that was it. Were no place for really luggage.
4	Q. Okay. I understand. So you rode out to the camp in the bus
5	and you were returning on the same bus?
6	A. Right. Right.
7	Q. And do you recall who the bus driver was?
8	A. Mr. Murray.
9	Q. Mr. Murray, okay. And was he the same driver that drove you
10	all out there?
11	A. He took us and he brought us back.
12	Q. Okay. And did he stay out at the retreat with you all the
13	whole time?
14	A. Yes, sir. He did, because he was part of the Sunshine
15	Singers.
16	Q. Okay.
17	A. He sang with them. He worshipped with us.
18	Q. Okay. Did you have any concerns at all about him driving?
19	A. No, sir, I didn't. They used it was my understanding that
20	he been used to driving them before, before that.
21	Q. I see. So my next question was where you all were heading
22	after you all left, and I'm assuming when you say to McDonald's it
23	and you all were heading south on 83, that that would have
24	probably been the one in Uvalde.
25	What was your all's final destination where you all were

1	going to be going?
2	A. Church. To pick up our suitcases and our vehicles was at
3	church.
4	Q. And that would have been the First Baptist Church in New
5	Braunfels?
6	A. Yes, sir, on Cross Street. Yes, sir.
7	Q. Okay.
8	A. And I think we was scheduled to be back no later than around
9	3:00.
10	Q. Okay. And when you all left, you said it as around the noon
11	hour. Do you recall how long you all had been driving prior to
12	the crash happening?
13	A. Sir, we wasn't driving long enough we had not driven long
14	enough for this person to think about repositioning her body.
15	Q. Okay.
16	A. Right. So we was only driving about 10 I feel like we
17	just got on the doggone thing.
18	Q. Yes, ma'am. Okay. So you said you were sitting in the far
19	back seat next to the window on the passenger side. Is that seat,
20	was it equipped with a seatbelt?
21	A. Every seat had a seatbelt.
22	Q. Okay. And did you have yours on?
23	A. Every last one of us had it on.
24	Q. Okay.
25	A. Because Ms. Cristie sitting next to me, she had pulled out

1 the seatbelts for the four of us, because the other two people 2 sitting on that seat was older than us --3 Ο. Yes, ma'am. -- and she said when they get in, their seatbelt will be 4 Α. right there. So she had their seatbelt so all they had to do, 5 6 instead of trying to look and find, know how they fall down and 7 stuff, she had pulled them all out and then made sure everybody was fastened. Even Ms. Cristie reached up to Ms. Martha and made 8 9 sure her seatbelt was fastened because she could pull it that 10 way --11 Yes, ma'am. Ο. 12 -- and everybody made sure everybody had their seatbelt on, Α. 13 and they talked to each other about it. 14 Okay. Good. And strictly if you want to answer or not, I'm Q. 15 just curious, did you receive any injuries around your hip area 16 from the seatbelt? 17 Yes, sir. I have my pelvic is fractured. Α. 18 Ο. Okay. 19 And I have my -- some seatbelt burns on my body here and Α. 20 across -- I have the proof of seatbelt. 21 Now you say up here. Was your seat in the back equipped with Ο. 22 a shoulder and lap belt --23 Α. No. 24 -- or just the shoulder --Ο. 25 Α. I pulled it --

1	Q or just the lap belt? Sorry.
2	A. I pulled it from I pulled it from there down. You know,
3	like on the wall
4	Q. Okay.
5	A I pulled it from up. I didn't pull it from here, here. I
6	pulled mine from here to here.
7	Q. Okay. So you you remember it being over your right shoulder?
8	A. I pulled my seatbelt like this here.
9	Q. Okay.
10	A. To do it.
11	Q. Okay.
12	A. Now the two seats right here, theirs was just straight out,
13	like you sitting in the chair
14	Q. Yes, ma'am.
15	A doing it.
16	Q. Okay.
17	A. I don't know how them other seats, I don't know how theirs
18	pulled out. I don't know if they because I could only really
19	see Ms. Martha's, and I could only see her connection. So if it
20	came straight across or up/down, that I can't tell you.
21	Q. Okay. So you said it wasn't that long after you all had left
22	the camp when the crash occurred. In that time frame, do you
23	remember what you were doing in the vehicle?
24	A. Um-hum. I was looking out the window. I wasn't looking
25	straight.

1 Q. Okay.

2	A. I was looking out the window like where he is, looking out
3	the window, and my ears heard noises from the people in the van.
4	What they said, I can't tell you that part. But it was the kind
5	of noises like watch out, look up, oh wow, stuff like that. Ah.
6	And when I turned my head from here to here, the truck was in the,
7	in the was in the van. And my, and my I felt myself juggle
8	and stuff like that, and when I opened my eyes again, it was
9	messed up.
10	A. I see.
11	Q. The bodies were thrown around. You half out the window, you
12	laying over, and my best friend made me think of watching
13	television when a hand grenade get somebody, and her whole back
14	was exploded in my face. So I knew she was gone. And so all I
15	could do was call the names. I couldn't remember I couldn't
16	even remember the people names. I was saying the names I know.
17	Jo, you all right? Ms. Martha, you okay? Harold and then when
18	I said Harold, I knew he wasn't okay because I could see the truck
19	inside the van.
20	Q. I see.
21	A. And so I knew wasn't need calling his name no more, no use
22	calling his name. And I only heard three people groan. It was

24 moaning. I heard Ms. Martha saying, help me, help me. And I 25 heard Donna groan. Nobody else said a word.

Ms. Eddie -- Effie, who did not go to my church. I heard her

1	And I could see Ms. Sue, because just before Ms. Sue and I
2	had a conversation before I started looking out that window about
3	going to choir rehearsal. There was choir rehearsal that night.
4	Well, we'll be in time for choir rehearsal, ha, ha. We ain't
5	going to be able to get out of choir rehearsal, you know, one of
6	those kind of deals. We laughed and talked about that.
7	And next to her, sat her friend, Rhonda. And Rhonda I could
8	see that her body looked like it was hanging out the window. In
9	the front, I couldn't I couldn't see the people that was
10	sitting in front of them, I couldn't see them because the truck
11	was like where they were supposed to be.
12	Q. Yes, ma'am.
13	A. So that's all I know, baby.
14	Q. Okay. So I see you're wearing glasses. I saw on your
15	driver's license
16	A. These aren't my glasses.
17	Q. Speaking of. Since I said that, I have your driver's
18	license
19	A. I lost my glasses.
20	Q back in (indiscernible).
21	A. These are not the glasses that I had on the trip.
22	Q. Okay. But at the time of the crash were you wearing your
23	glasses?
24	A. Oh, yeah. I saw my glasses on the floor.
25	Q. Okay.

A. I saw them down there but when -- when I come to, I was leaning almost like I'm leaning now, but this arm here was hanging and I couldn't move it, but it was hanging like behind me on the back of the seat.

5 Q. I see.

A. And this one was turned up some kind of weird way, but I couldn't maneuver it because if I moved it -- I was trying not to move it because I was in some weird position. If I moved it, I would have been touching stuff I didn't want to touch.

10 Q. I see.

11 A. And I already could see, because in my face and on my body, I12 could see skin and pieces of somebody else on me.

13 Q. I see.

14 So I saw myself covered with my best friend, because Cristie Α. 15 was my best friend up in there, and her body was wide open 16 exposed, like she was -- I never saw her head. I just saw her 17 back opened up. I didn't even know your body parts had different 18 -- kind of different colors inside. I saw that stuff -- I never 19 -- I didn't know that. And then I look and I said, which is her 20 skin? Oh, God. And all I could say is just oh, God, I sure hope 21 they'll come.

And then I heard a guy, heard a man's voice come over to the window on that side of the vehicle, and he say, oh, there ain't nothing in here but old people. And then I heard -- it sound like the same voice to go back and say, "Man, you ran into that, you

1 ran into that van. You ran into a van full of old people. You
2 done kill everybody. You've been driving stupid. I've been
3 watching you. I had my wife call the police."

I could hear everything because I didn't lose conscious from that time on. I never lost conscious once I woke up and saw the situation. I was conscious from that moment on and have been woke since then.

But I heard that guy, whoever he was -- I don't know what he 8 9 looked like. The only thing else, I just saw the people that come 10 to help stepping over people. And then one guy was just looking 11 at me and just say, keep your eyes on me. Keep your eyes on me. 12 Keep your eyes on me. Even though he was trying to help other 13 people, he was telling me keep your -- and so I just kept my eyes 14 on him like he told me. And that's all I could do is just keep 15 eyes on him.

And I was just spitting my teeth out my -- my mouth started to feeling funny. I spit my teeth out. And the lady behind me took my, took my teeth. And then I told her, I said put them in my pocket. And she said, no. She said I got you. I got your teeth.

I said, well, where are my glasses? And I saw my glasses, they was trying -- oh, they put a sheet over me and they covered up Ms. Cristie. They covered Ms. Cristie up so I could -- didn't have to look at her anymore. And when they pulled my body out the vehicle, I saw my glasses on the floor. And they put me in a

helicopter and took me to that other hospital, and now I'm at this
 hospital.

Q. Okay. So after you all had left the camp, in that short distance, do you recall anything out of the ordinary with the bus or how the bus was being operated at the time? Was it -- did you have any indication that there was anything maybe mechanically wrong with the bus or -- you said you were looking out the window of the bus --

9 A. I was just looking at the --

10 Q. -- (indiscernible)?

11 -- I was just looking at the scenery at the time. I was just Α. 12 looking out because I never been there before. And I was looking 13 at the trees and stuff. And even though I was looking out the 14 window, I was still talking, saying stuff about, wow, what a 15 mighty God we serve; look, I say, he got the -- even though it 16 rain a few days, it don't rain always. And the green is still 17 green. That's the kind of conversation having with my friend. 18 That's the kind of conversation I was having with her.

19 Q. Okay.

A. We were talking about how powerful and how mighty God is
because of the scenery, and I had not seen that scenery before.
Q. Okay.

23 A. It's cool, baby.

Q. So from where you were sitting in that back seat, were youable to see the front of the bus before the crash --

- 1 Α. Before the --2 -- before the bus -- where the driver would have been? Ο. 3 I -- yeah, I saw the driver. I couldn't see Harold that Α. 4 good, the passenger --Yes, ma'am. 5 Ο. 6 -- because the bus had two seats at the -- the four people --Α. 7 that side got two seats all the way up; this side got one seat all 8 the way up. 9 Ο. Yes, ma'am. 10 And Harold was sitting on the front row with the driver. Α. 11 In that front passenger seat? Q. 12 I could see the driver even though -- and I could see dials Α. 13 on the dashboard, you know, but could I tell you what they was? 14 What the speed and all that stuff, I couldn't tell. No. 15 The only thing that diverted my attention from looking out on 16 the scenery was -- and I don't know exactly what they were. Thev 17 were just those kind of noises that make you say -- when people 18 are saying stuff like, ah, and watch out, and ooh, and stuff like 19 that. So it turned my -- so as soon as I turned my head from here 20 to here, the bus -- that truck looked like it was in my face. 21 Ο. Yes, ma'am. 22 That's how close it was. So it's like, ah -- and I think Α. 23 maybe just have I lost my teeth.
- Q. Okay. At any time did you see anything where you could see
  the driver of your -- of the bus -- at any time did you see

1	anything that would have distracted him from the road?
2	A. I didn't, I didn't
3	Q. A cell phone or anything like that?
4	A. Oh, no.
5	Q. Okay.
6	A. I didn't even if he and, if he and Harold was talking, I
7	wasn't hearing it.
8	Q. Okay.
9	A. I'm sure they were I'm almost sure they was engaged in a
10	conversation or two. But sir, I didn't see, because I never, I
11	never looked behind me but I never observed a vehicle in front of
12	us either. The only vehicle I ever observed was when that thing
13	moved, and I do know the bus went tu-tu-tu (makes noise).
14	Q. Yes, ma'am.
15	A. That was (indiscernible).
16	Q. So do you remember, when that happened, what lane your all's
17	bus was in? Was it in your all's proper lane, other side of the
18	road, maybe your all's shoulder?
19	A. I couldn't have told you I can't tell you.
20	Q. That's fine.
21	A. Because it's like to me, it seemed like it was all in the
22	air.
23	Q. Yes, ma'am. I
24	A. I don't know if he was ducking and dodging, but to me it just
25	seemed like we met in the air.

1 Q. Yes, ma'am.

2 A. You know.

Q. And did you feel any steering movements or hard braking or anything by the bus before the impact happened? Do you remember anything like that?

A. All I know when I, when I look up, baby, all I know (makes noise) the bus going backwards and forth, and see -- in my mind I don't know if that's a cliff on the side --

9 Q. Yes, ma'am.

10 A. -- it's just a straight drop off. I don't know. Because I 11 didn't know where we were going to land. When I opened my eyes, I 12 didn't have any idea what I was going to see. And I, and I don't 13 know right now where we was.

14 Q. Okay. That's fine.

A. I don't know if we was on the right lane, the left lane. I don't know if there was really a cliff over there. I really don't know because I don't know the lay of the land.

18 Q. That's fine. I understand. I understand.

So you said you saw -- when you turned and looked forward, you saw the truck, it was almost, almost on you all.

- 21 A. It was there.
- 22 Q. Do you --
- 23 A. It look like he was there or he was like, he was boom.

24 Q. Yes, ma'am.

25 A. He was in my face.

1 Do you recall anything, description about that truck? Q. Color, 2 what kind of truck it was, or anything like that? 3 Man, I just couldn't -- my mind wasn't realizing the fact Α. 4 that we was being crashed. 5 I see. Ο. 6 It was like I didn't know what my brain was thinking. And Α. 7 even when everything stopped, I didn't know what the hell had happened. 8 I understand. 9 Yes, ma'am. Ο. 10 I don't know if we dangling in a tree, hanging off a cliff. Α. 11 But I heard that -- the first thing I heard was that voice. 12 Somebody, somebody was there immediately, and that was the voice I 13 heard of a man saying what he was saying. And that made me 14 realize. And then I couldn't see nothing, but when I look up 15 there, but that truck in the windshield. 16 Yes, ma'am. Ο. 17 Looked like, looked like he was on -- look like his -- look Α. 18 like when you seen them, I don't know, big trucks, they have them 19 great big old tires, and they'd be like -- I know the -- they'd be 20 like climbing up on stuff. That's what I thought it was. Ι 21 thought, oh, that's a transformer mess to me. 22 Okay. I understand. Q. 23 Do you have anything else that I didn't cover? SGT. FRITCH: 24 TROOPER JONES: No. You did an excellent job, Ms. Harris. 25 MS. HARRIS: Thank you. God has given me woe for a minute

1 now. And I was just so busy wondering like why? Why? What in 2 the -- I had some curse words.

3 TROOPER JONES: Well, we don't always know the answers to 4 those questions.

5 MS. HARRIS: And what, what -- and what has just happened? 6 This is unbelievable. And then to recognize you ain't moving, 7 they ain't moving, they groaning; then I find out those who 8 groaned didn't make it. It has not been a happy time, you know.

9 So I just have to say, what now, Lord? What, what is it that 10 you've got for me to do? I was -- I'm glad I'm spared, but what 11 is it that I'm -- what am I spared for? You know, is there 12 something you want me to do? Something you want me to say? You 13 know, and I could only offer those people who come to visit who 14 family members didn't make it, I can only tell them the truth. 15 They didn't suffer.

Like what I told Richard, Cristie's husband, I know she didn't suffer, but I can't tell you no more than that. You know, because I don't want to -- it was ugly. Like I said, I didn't know parts in your body be colors other than red. Shit, I saw stuff that I don't want to ever see in life. And I love my police pictures, but I don't know -- I have not been able to watch them.

I find it very difficult to get in a vehicle. In the ambulance that brought me here, I was a nervous wreck. Man, I kept my eyes closed the whole time, and if the thing would jump a little bit, I was like, oh, you know. So it was like more than,

1	more than a notion. I told my son, I said, baby, momma don't know
2	how she's going to even get in a vehicle anymore. I don't know
3	when I'll drive. Because I I'm a little scared right now. You
4	know, so
5	SGT. FRITCH: Do you have anything else that okay.
6	BY SGT. FRITCH:
7	Q. The only other thing that we were wanting to look at was the
8	seating chart.
9	A. Okay.
10	Q. To see if we couldn't pinpoint where everybody was at in the
11	vehicle. If you don't mind doing that.
12	A. I don't mind.
13	Q. Okay.
14	A. I might have to, I might have to I don't know if I can
15	move.
16	Q. No, you don't have to move. No, ma'am. You don't have to
17	move.
18	A. Okay.
19	Q. I'm just going to turn this around here, okay? So this is
20	basically just a rough sketch of the bus. If this is the front
21	so we have Murray that's driving and we had Howard up in the
22	front, correct?
23	A. Right.
24	Q. Okay. And you would have been
25	A. That's me.

	11	
1	Q.	right here.
2	Α.	Yes, sir.
3	Q.	And I wrote backwards, but that's okay.
4	Α.	That's all right.
5	Q.	Okay. And then you said
6	А.	Cristie Moore.
7	Q.	Cristie was next to you?
8	А.	Uh-huh.
9	Q.	Okay.
10	А.	Harold.
11	Q.	And then Harold?
