B. GROUP IDENTIFICATION:

No group was formed for the development of this report.

C. DETAILS OF INVESTIGATION

Purpose

This investigation was performed to document the injuries to the occupants of Amtrak Train 91. There were 141 passengers and 8 crewmembers on board at the time of the collision and derailment.

Methods

Amtrak provided NTSB with a list of occupants and the hospitals they visited. Medical records for the injured were requested from the hospitals and reviewed. Narrative descriptions of the injuries are provided in the following tables. NTSB injury levels are coded in accordance with Title 49 *CFR* 830.2 which defines *fatal injury* as "any injury which: results in death within 30 days of the accident" and *serious injury* as "an injury which: (1) requires hospitalization for

more than 48 hours, commencing within 7 days from the date the injury was received; (2) results in a fracture of any bone (except simple fractures of fingers, toes, or nose); (3) causes severe hemorrhages, nerve, muscle, or tendon damage; (4) involves any internal organ; or (5) involves second- or third-degree burns, or any burn affecting more than 5 percent of the body surface." The *minor injury* category includes all other people, not cited in the other injury categories, who were diagnosed with a symptom or specific injury during their hospital visit in the first 24 hours after the injury. Those coded as "None" were evaluated at a hospital but not diagnosed with any injury. Occupants coded as "Unknown" were believed to have been evaluated at a hospital but records of the visit were not able to be obtained by NTSB. This typically occurs when there is a discrepancy in the spelling or completeness of a name, when the date of birth was unknown or if there was an error in the date of birth, or when the hospital uses a pre-coded "disaster name" for a patient and does not then re-code the record with the person's real name.

Results

The overall injury levels are provided in table 1. A total of 91 surviving occupants from Train 91 were evaluated at local hospitals; 3 of these were found to be uninjured.

According to interviews with hospital personnel and first responders, decisions about how many patients were taken to individual hospitals were made mutually, generally with communication by cell phone about available hospital capacity. Hospitals received very different numbers of patients but the numbers were believed to be appropriate by those involved. Table 2 documents the injury severity by hospital. Of note, a single adult with serious injuries was initially evaluated at the VA hospital and transferred to the trauma center (Parkland). He was counted in the Parkland group. The uninjured or those who refused medical care were transferred to an assistance center.

Table 3 on the following pages documents the individual injuries for the occupants of Train 91 who visited the hospital. Included is the type of seat the individual was seated in, based on their ticketing. Hospital data is not included in this table. The injured are grouped by their injury severity but there is no other order to the listing. Passenger numbers were simply assigned in order. In some of the cases among the unknown injury severity, the age and sex are blank because they were not known.

Overall, 90 of the 149 (60.4%) occupants of Train 91 were injured in this accident. This included 2 fatally injured train crew riding in the locomotive. Among the 6 crewmembers riding in the passenger cars, 1 was seriously injured and 3 had minor injuries.

Seven of 32 (21.9%) passengers ticketed in roomettes or bedrooms and 77/109 (77.6%) of passengers ticketed in coach seats were taken to hospitals and found to be injured. None of the passengers ticketed in roomettes or bedrooms were seriously injured. According to the medical records, most of the passengers reported having been asleep or resting; those in seats were thrown out of their seats and against the furniture in front of them. The majority of skin injuries (lacerations and contusions) were to the face, head, and knees or shins. Two people had broken teeth, one had a broken nose, and one had a facial fracture. Of those seriously injured, 3 reported falling against the edge of a table and one reported falling out of an upper bunk.

D. SUMMARY

Overall, 90 of the 149 (60.4%) occupants of Train 91 were injured in this accident. Both the crew on the locomotive died. Those ticketed in coach seats were more likely to seek immediate medical attention than those in roomettes or bedrooms. None of the passengers ticketed in roomettes or bedrooms were seriously injured. According to many passenger reports documented in the medical records, the seated occupants were thrown out of their seats during the crash sequence. The majority of skin injuries (lacerations and contusions) were to the face, head, and knees or shins. Two people had broken teeth, one had a broken nose, and one had a facial fracture. Of those seriously injured, 3 reported falling against the edge of a table and one reported falling out of an upper bunk.
