- 2 MR. DOWNS: Okay. Today's date is July 22nd, 2015, and
- 3 the following is an interview being conducted in reference to NTSB
- 4 investigation number DCA-15-FR-004, which relates to an accident
- 5 involving a heavy smoke release and train evacuations that
- 6 occurred in and near the L'Enfant Plaza Station of the WMATA
- 7 Metrorail System in the District of Columbia on the afternoon of
- 8 January 12, 2015. This interview is being conducted with an
- 9 employee of WMATA Metrorail as conducted by the NTSB Survival
- 10 Factors Technical Working Group of the investigation.
- 11 My name is Richard M. Downs, Jr., and I'm a survival
- 12 factors investigator with the NTSB, which I also serve in the role
- 13 as the Survival Factors Technical Working Group chairperson. I
- 14 will preside over this interview, which is being recorded for the
- 15 record, which a transcript may also be compiled of the recording
- 16 as a permanent docketed record of the interview.
- 17 Additionally, I'd like to mention that the purpose of
- 18 the investigation is to increase safety and not to assign fault,
- 19 blame, or liability, and that the NTSB cannot offer any guarantee
- 20 of confidentiality or immunity from legal or certificate actions.
- Further, pursuant to the criteria under 49 C.F.R. 831.7,
- 22 the interviewee may have one representative of the interviewee's
- 23 choice accompany him or her at this interview, and which the
- 24 representative may not testify for the interviewee. It's also
- 25 requested that comments of the interviewee's representative be

- 1 limited and objections expressed by the interviewee's
- 2 representative are not on the -- grounds for the NTSB to refrain
- 3 from asking questions.
- Now, to the witness, I'll ask that you please identify
- 5 yourself, your employment affiliation and job position title for
- 6 the record.
- 7 MR. WHITLEY: My name is Deon Whitley. I am a storeroom
- 8 clerk with Washington Metropolitan Transit Authority.
- 9 MR. DOWNS: Thank you, sir, for joining us today. And
- 10 if you are accompanied in this interview today by an individual,
- 11 I'd like to ask that this individual please identify themselves
- 12 and their affiliation.
- So you have no representative today; is that correct?
- MR. WHITLEY: That's correct.
- MR. DOWNS: Thank you.
- 16 I'll now ask that the participants of this interview who
- 17 will have an opportunity to present questions to the witness to
- 18 please individually identify themselves, their employment
- 19 affiliation, and job position title for the record.
- 20 MR. BUCHER: Dave Bucher, B-U-C-H-E-R, NTSB
- 21 investigator.
- 22 MR. GORDON: Joe Gordon, G-O-R-D-O-N, NTSB investigator-
- 23 in-charge.
- 24 MR. ROURKE: Good morning. I'm Denton Rourke, R-O-U-R-
- 25 K-E. I am the operations manager in the Office of Emergency

- 1 Management of the Metro Transit Police Department, and I'm a
- 2 member of the Survival Factors Group.
- MR. HAWKINS: Good morning. Derron Hawkins, Deputy Fire
- 4 Chief, D.C. Fire EMS, Homeland Security Division. Last name is H-
- $5 \quad A-W-K-I-N-S$.
- 6 MR. GOOD: Good morning. George Good, G-O-O-D, Federal
- 7 Transit Administration, accident investigator.
- 8 MR. DOWNS: Thank you.
- 9 And as my first question for the -- oh, sorry.
- 10 MR. HOLDCROFT: Does it matter?
- MR. DOWNS: You're present. Go ahead.
- MR. HOLDCROFT: Forest Holdcroft, H-O-L-D-C-R-O-F-T,
- 13 NTSB summer intern.
- MR. DOWNS: Thank you.
- 15 INTERVIEW OF DEON WHITLEY
- BY MR. DOWNS:
- 17 Q. And my first question for the witness, would you please
- 18 briefly describe for us your role or involvement in the event?
- 19 A. On the day of January 12th, I reported to work at 8 a.m.
- 20 Q. Excuse me; role in the event. You're a storeroom clerk,
- 21 I believe?
- 22 A. I am a storeroom -- I'm sorry -- I am a storeroom clerk
- 23 with the Transit Authority.
- 24 Q. And you work in the L'Enfant Plaza Station?
- 25 A. In Room S200, yes.

- 1 Q. Thank you. And could you please describe for us, in
- 2 your own words and to your best recollection, what occurred on the
- 3 day of the event relative to your actions and involvement at the
- 4 L'Enfant Plaza Station commencing at the time you were alerted to
- 5 respond to the site?
- 6 A. I reported to work at 8:00 a.m. that morning. All was
- 7 well until approximately 3:45. I decided to walk outside.
- 8 Q. 3:45 p.m.?
- 9 A. That's correct. I decided to walk outside. When I
- 10 opened the door at S200, Room S200, that's when I saw the station
- 11 filled with smoke.
- 12 Q. So you had no indication prior to 3:45 that there was
- 13 anything -- any unusual occurrences in L'Enfant Plaza Station?
- 14 A. None at all, no.
- 15 Q. Okay. Please proceed.
- 16 A. Then at about approximately 3:45, when I saw the smoke,
- 17 I then, in turn, turned around and ran to the back room to alert
- 18 Bonnie Moore because she was back there alone.
- 19 Q. A colleague who works in a different office area in that
- 20 same room --
- 21 A. That is correct. She's an --
- 22 Q. -- workroom?
- 23 A. She's an automatic fare collection parts runner, is what
- 24 she does. But she was in the back room, so I went back to alert
- 25 her what was going on. So when we got back up to the front door,

- 1 we saw the smoke and, of course, we had to try the best as we
- 2 could to get out of there. So I took off running immediately.
- 3 When I turned to look behind me, Ms. Moore was stuck, so I had
- 4 t.o --
- 5 Q. Stuck?
- 6 A. She couldn't move.
- 7 Q. She could not move?
- 8 A. Yeah. She froze.
- 9 Q. She froze. Okay.
- 10 A. I had to turn around --
- 11 Q. And where exactly were you when this occurred?
- 12 A. In front of S200, Room S200.
- 13 Q. You had gone out of the room and you were on the
- 14 mezzanine level?
- 15 A. That's correct.
- 16 Q. Please proceed.
- 17 A. So once -- I went back and grabbed her by the arm and we
- 18 just commenced to run out of the station as fast as we could.
- 19 Q. So you escorted her out of the station?
- 20 A. Yes.
- Q. And correct me if I'm wrong, your work area, workroom
- 22 area is on the mezzanine level of the station.
- 23 A. That is correct.
- Q. Is that at the south end of the station opposite the
- 25 Maryland Avenue --

- 1 A. That is correct.
- 2 Q. -- entrance/exit to the station?
- 3 A. Yes, sir.
- 4 Q. Okay. So you proceeded to exit the station. Which
- 5 direction did you go?
- A. Well, there was a police officer coming up the escalator
- 7 on the Greenbelt side of the mezzanine.
- 8 Q. That would be to your right as you're facing north?
- 9 A. That is correct, uh-huh. And he just said continue on,
- 10 just go straight, and that's what we did.
- 11 Q. Please continue.
- 12 A. So we continued straight until we got over to the
- 13 Maryland Avenue side. We go out of the escalator coughing, of
- 14 course, and that's when we see all of AFC's management, which no
- 15 one had alerted us on.
- Q. AFC's management?
- 17 A. Yes.
- 18 Q. AFC is the automatic fare --
- 19 A. Fair collection.
- 20 Q. -- collection management?
- 21 A. Yes.
- Q. Do they work in L'Enfant Plaza Station?
- 23 A. Their office is on the side of Maryland Avenue.
- Q. So basically the exact opposite end of the mezzanine
- 25 that you're located, they have a workroom area there?

- 1 A. That is correct.
- 2 Q. So you saw these management folks there --
- 3 A. Um-hum.
- 4 Q. -- and you work basically as their employees?
- 5 A. That is correct.
- Q. And you encountered those management personnel. What
- 7 then happened?
- 8 A. Well, once we encountered them, I then contacted SRML,
- 9 which is storeroom personnel.
- 10 Q. How did you contact --
- 11 A. On my cell phone.
- 12 Q. You placed a call to the storeroom personnel office?
- 13 A. That's correct.
- 14 Q. Okay.
- 15 A. Over in Alexandria, Virginia. I called Nicole Williams,
- 16 which is my immediate supervisor --
- 17 Q. Okay.
- 18 A. -- and just alerted her to what was going on and that I
- 19 was going to the hospital to get checked out.
- Q. At that point you mentioned that there was a lot of
- 21 smoke --
- 22 A. Yes.
- 23 Q. -- and you were coughing?
- 24 A. Yes.
- 25 Q. You were still on the mezzanine level --

- 1 A. Yes.
- 2 Q. -- when you made that call?
- 3 A. No, no, no, no. This is once we got out of the
- 4 station.
- 5 Q. You were able to get up the escalator there and get out
- 6 of the station; you then made that call?
- 7 A. That's when I made the call, yes.
- 8 Q. Okay. And you alerted the supervisory people in
- 9 Alexandria of the problem.
- 10 A. That is correct.
- 11 Q. Did they have an indication to you that they were at all
- 12 aware of a problem in L'Enfant Plaza?
- 13 A. No, they did not.
- 14 Q. So it was news to them?
- 15 A. It was news to them.
- 16 Q. Okay. And do you have, by chance, the time when you
- 17 were able to make that call?
- 18 A. I don't -- give or take, I would say approximately 4:00.
- 19 Q. So it was about 4:00. So you indicated you were first
- 20 alerted to the smoke in the station when you exited your door at
- 21 3:45.
- 22 A. Um-hum.
- Q. And you went back and got your colleague, Ms. Moore, and
- 24 then you went out of the station and worked your way up to the
- 25 opposite end and up the escalator and outside. So that took about

- 1 15 minutes --
- 2 A. Yes, sir.
- 3 Q. -- plus or minus 5 minutes --
- 4 A. That is correct.
- 5 Q. -- approximately?
- A. Now, also, please, I need for, I guess, someone maybe in
- 7 safety to be advised that the alarms were going off, bells were
- 8 ringing --
- 9 O. In the station?
- 10 A. -- but we couldn't hear nothing in that room.
- 11 Q. Well, that -- I'm going to get to that line of
- 12 questioning shortly.
- 13 A. Okay.
- 14 Q. So let's hold that thought for a moment.
- 15 A. Okay.
- 16 Q. So you placed a call to Alexandria office?
- 17 A. Um-hum.
- 18 Q. How long did the call last roughly, a minute or so?
- 19 A. Yeah, maybe roughly a minute or so, and that's when
- 20 Nicole Williams told me to go to the hospital.
- Q. So your supervisor instructed you to go to the hospital?
- 22 A. That is correct.
- Q. What happened next?
- A. Well, actually, it was all-out chaos.
- Q. It was your impression outside, you're saying to us,

- 1 that there was chaos --
- 2 A. Yes.
- 3 Q. -- occurring in that general area?
- 4 A. Back when I --
- 5 Q. What did you see?
- A. When I say it was all chaos, for starters, I tried to
- 7 catch a bus to get home or get out of here.
- 8 Q. A bus? What kind of bus?
- 9 A. Metrobus.
- 10 Q. A regular Metrobus?
- 11 A. Yes.
- 12 Q. This is after you were told to go to the hospital?
- 13 A. Yes.
- Q. Why were you thinking to take the bus to go home?
- A. Well, actually, I live in P.G. County, so I was going to
- 16 go to P.G. County's hospital.
- 17 Q. Okay. So your thinking at that moment --
- 18 A. To go --
- 19 Q. -- correct me if I'm wrong -- was to take a bus to
- 20 P.G. and proceed to a hospital proximate to your home.
- 21 A. That is correct.
- 22 Q. Would that be a fair characterization?
- 23 A. Yeah, that would be fair.
- 24 Q. Okay.
- 25 A. Yes.

- 1 Q. Did you actually take a bus?
- 2 A. No, sir, I couldn't get one.
- 3 Q. What happened? Did you not see any buses or --
- 4 A. Yes, sir, I saw them. The buses were overcrowded.
- 5 Q. Overcrowded. So there weren't enough buses --
- 6 A. No --
- 7 Q. -- at least the bus that you wanted to take to P.G.?
- 8 A. Exactly.
- 9 Q. Okay.
- 10 A. So I ended up walking from L'Enfant Plaza all the way up
- 11 to Eastern Market.
- 12 Q. You walked from L'Enfant to Eastern Market?
- 13 A. Yes.
- Q. So you immediately left L'Enfant Plaza Station entrance
- 15 there by Maryland Avenue --
- 16 A. Um-hum.
- 17 Q. -- where you characterize it as chaos --
- 18 A. Yes.
- 19 Q. -- basically gave up on the bus scenario, and your idea
- 20 was to walk to Eastern Market?
- 21 A. Um-hum.
- Q. And what were you going to do there?
- 23 A. Well, Eastern Market, I was hoping to get train service
- 24 out of the District.
- Q. And that's a different line?

- 1 A. No, no, that's the same line.
- 2 Q. The same line?
- 3 A. I was hoping to get services --
- 4 Q. Okay.
- 5 A. -- and I did get service from there.
- 6 Q. So you did successfully walk to Eastern Market?
- 7 A. Yes, absolutely.
- 8 Q. Okay. What happened then when you got Eastern Market?
- 9 A. When I got to Eastern Market, I got on the train and I
- 10 went to Cheverly Station, to my car, and drove myself to P.G.
- 11 Plaza Hospital.
- 12 Q. Okay. And the hospital folks did a medical assessment
- 13 there?
- 14 A. Yes.
- 15 Q. We won't get into the medical scenario, but suffice to
- 16 say, you spent some time at the hospital?
- 17 A. Yes, I did.
- 18 Q. Did you get admitted to the hospital?
- 19 A. No, I did not get admitted.
- 20 Q. So you were discharged at some point that --
- 21 A. The same day.
- Q. -- same day? Okay, very good. Is that the end of the
- 23 activities for that day or were there follow-up activities the
- 24 next day or anything?
- 25 A. No, that was the end of it that particular day.

- 1 Q. The end of that day. Okay, very good.
- 2 MR. DOWNS: I'm going to pause for your question right
- 3 now. You've addressed that question very well. Thank you. We're
- 4 going to start to go around the room and I'm going to get back to
- 5 that question regarding the alarm system.
- 6 So we're going to start first with Mr. Bucher.
- 7 BY MR. BUCHAR:
- Q. Mr. Whitley, Dave Bucher. Do you have any established
- 9 protocols for evacuating your work area in an emergency?
- 10 A. I have not seen any evacuation plan at all, but I am
- 11 told that AFC does have something in place. I have not seen it.
- 12 Q. Okay. And how long have you worked in the storeroom?
- 13 A. I've been a storeroom clerk about 8 years.
- Q. Eight years. Okay. Have you ever or recently
- 15 participated in an emergency drill in L'Enfant Plaza Station?
- 16 A. No, sir.
- 17 Q. So it's safe to say, in the 8 years, they never had a
- 18 drill that you participated in?
- 19 A. Now, also be advised now, my 8 years as a clerk was not
- 20 at L'Enfant Plaza.
- 21 Q. Okay.
- 22 A. I've been at L'Enfant Plaza approximately 4 years.
- Q. Four years?
- 24 A. Yes, sir.
- Q. All right. Thank you.

- 1 A. But, no, sir, I have not participated in any evacuation
- 2 plan at all.
- 3 Q. Okay. Have you ever had any training from WMATA that
- 4 relates to fire drills or anything like that, emergency --
- 5 A. I have had some type. That was when I was back in a
- 6 custodial -- as a custodian, I had training as -- with emergency
- 7 evacuation.
- 8 Q. Okay. And could you elaborate a little bit, tell us
- 9 what that might have -- what that was?
- 10 A. Well, it's been a long time, but I do remember the -- I
- 11 believe it was the orange bag with the bloodborne pathogen,
- 12 something like that, but that was years ago.
- MR. BUCHER: Okay. Okay, I'm going to pass it off to
- 14 Mr. Gordon.
- 15 BY MR. GORDON:
- 16 Q. Joe Gordon, NTSB. I don't want to -- I know Mr. Downs
- 17 is going to follow up on the question of, you know, what took
- 18 place in the room. I don't want to get into that lane. But you
- 19 mentioned that at 3:45, you went out of the S200 room --
- 20 A. Um-hum.
- 21 Q. -- into the station and that's when you noticed the
- 22 smoke. Was there anything inside the room where you were that --
- 23 outside of the normal as far as noises or anything like that?
- A. The only thing out of the norm was most of the time when
- 25 they turn the fans on, I guess, the fans to clean the tunnels out,

- 1 I guess they do, the noise, that's what prompt me to go out.
- 2 Q. Okay.
- 3 A. Those fans turned on and that's when I was just going to
- 4 walk out --
- 5 MR. DOWNS: And Downs here. Question: Those fans are
- 6 located in your workroom area in a cordoned-off, screened-off
- 7 area, fenced off area, those --
- 8 MR. WHITLEY: Yes, sir, they are.
- 9 MR. DOWNS: -- the fan equipment?
- 10 MR. WHITLEY: Yes. Yes, sir, they are.
- MR. DOWNS: Thank you.
- 12 BY MR. GORDON:
- 13 Q. Okay. So you did notice those prior to noticing the
- 14 smoke? You heard the fans ramping up and then --
- 15 A. Absolutely, yes.
- 16 Q. -- that's when you went outside?
- 17 A. Absolutely. But, I mean, it's not highly unusual. The
- 18 fans will come on any time --
- 19 Q. Right.
- 20 A. -- but I just get away from the noise.
- 21 Q. Right. Okay.
- 22 A. So that prompted me to go out.
- Q. Okay. All right. I have nothing further right now.
- MR. GORDON: Pass it, let's pass it on down.
- MR. DOWNS: Mr. Rourke?

- 1 MR. ROURKE: Yeah, thanks.
- 2 BY MR. ROURKE:
- 3 Q. Denton Rourke from Metro. Were you and Ms. Moore the
- 4 only two people in S200?
- 5 A. Yes, sir.
- 6 MR. ROURKE: And you're going to ask about fire alarms,
- 7 so I'll just come back to that in case I got anything on that.
- 8 BY MR. ROURKE:
- 9 Q. In your office, do you all monitor the rail radio, rail
- 10 radio channels?
- 11 A. We don't have one, no.
- 12 Q. Does that -- you don't have a radio?
- 13 A. No, sir.
- 14 Q. Does Alexandria? Your Alexandria office, do they
- 15 monitor the rail radios?
- 16 A. I'm not sure. I don't know.
- MR. DOWNS: I got a -- Downs -- question. I'm going to
- 18 interject here.
- 19 BY MR. DOWNS:
- Q. Is a radio assigned to you in that work area at all? So
- 21 you have no radio capability at all?
- 22 A. No, sir.
- 23 Q. Okay.
- 24 A. No, sir.
- 25 Q. Thank you. And you only have a telephone?

- 1 A. That's it.
- 2 Q. And your normal -- your Alexandria office would be the
- 3 normal communication on a daily basis, work orders and things like
- 4 that?
- 5 A. No, no. I -- all of my communication was with the AFC
- 6 management here.
- 7 Q. At the other end of the mezzanine level?
- 8 A. That's correct.
- 9 Q. And that'd be by telephone routinely?
- 10 A. Yes. Um-hum.
- 11 Q. Thank you.
- MR. DOWNS: Go ahead, Denton.
- MR. WHITLEY: And I'm sorry; I stand corrected. I do
- 14 have a monitor of the door, that's it.
- BY MR. DOWNS:
- Q. A monitor of the door, meaning --
- 17 A. A camera.
- 18 Q. -- meaning a TV camera view of the door --
- 19 A. That's correct.
- 20 Q. -- that shows you the image outside the door?
- 21 A. That is correct.
- Q. So you can see who's knocking at the door, for example?
- 23 A. Right at the door only. I can't see out in the
- 24 mezzanine.
- 25 Q. At the door only. So it's a security measure to make a

- 1 determination if the person outside --
- 2 A. Absolutely.
- 3 Q. -- should be admitted? Would that be a correct
- 4 characterization?
- 5 A. That is correct, yes.
- 6 Q. Thank you.
- 7 MR. DOWNS: Go ahead, Denton.
- 8 BY MR. ROURKE:
- 9 Q. When you -- after you evacuated the station, did you
- 10 tell anybody from Transit Police or the fire department that you
- 11 were -- had been exposed to the smoke and needed to go to the
- 12 hospital?
- 13 A. No, sir.
- MR. DOWNS: Question. Downs.
- BY MR. DOWNS:
- 16 Q. Did the fire department approach you or EMS approach you
- 17 when you were coming up out of the station, did they approach you
- 18 in terms of asking you if you needed medical assistance?
- 19 A. No. The only approach we had was, as I said, on the
- 20 Greenbelt side mezzanine -- I mean, on the platform, the --
- 21 Q. That officer that came up to you --
- 22 A. -- the transit police officer. I don't know who he was.
- 23 Q. That came up and first approached you as you left your
- 24 office area?
- 25 A. That is correct. Yes.

- 1 Q. Very good. Thank you.
- 2 MR. DOWNS: Go ahead.
- 3 BY MR. ROURKE:
- Q. And I just want to make sure we have you captured in the
- 5 people that were exposed. You filled out the standard WMATA
- 6 paperwork?
- 7 A. No, sir, I have not filled out anything.
- 8 Q. For the on-the-job injury, you didn't fill nothing out?
- 9 A. No, sir, I have not.
- 10 Q. Okay. But you did notify your supervisor --
- 11 A. I did notify --
- 12 Q. -- that you were involved in the incident --
- 13 A. That is correct, yes.
- 14 Q. -- and exposed to smoke?
- 15 A. Yes, sir.
- 16 Q. But you never filled out an injury package?
- 17 A. No, sir.
- 18 Q. Okay. You answered my question about how long you
- 19 worked there. Metro had a training program 3, 4 years ago called
- 20 MERT, or Managing -- Metro Emergency Response Training, Metro
- 21 Emergency Response Training. It could have been at Carmen Turner;
- 22 it could have been anywhere else. Did you attend that?
- A. No, sir, I did not.
- Q. You did not. Okay, thanks very much. That's all I've
- 25 got right now.

- 1 MR. DOWNS: Chief?
- 2 BY MR. HAWKINS:
- 3 Q. Okay, Derron Hawkins. A couple of questions have been
- 4 asked already. So you mentioned that when you came outside there
- 5 was chaos. Can you explain a little bit more the chaos? Can you
- 6 explain to me what exactly that you saw when you came outside?
- 7 A. Well, when I say the chaos, I mean people were coughing,
- 8 just running around in circles, to be quite honest. Nobody knew
- 9 which way to go and nobody knew which way to direct you. Even as
- 10 far as when we came out of the station, we ran into AFC's
- 11 management, which they didn't know anything either.
- MR. ROURKE: Rourke. This was the Maryland side,
- 13 Maryland and --
- MR. WHITLEY: That is correct, 7th and Maryland.
- 15 MR. DOWNS: The Maryland Avenue exit to the station?
- MR. WHITLEY: That is correct.
- 17 MR. ROURKE: Thanks.
- BY MR. HAWKINS:
- 19 Q. Start from the evacuation plan. So tell me a little bit
- 20 about the room, Storeroom S200.
- 21 A. Okay.
- Q. You said you're in there, that you pretty much didn't
- 23 hear any notification system that was going on until you stepped
- 24 outside.
- A. Um-hum.

- 1 Q. Tell me -- describe an environment of that room that
- 2 you're in there, in terms of --
- 3 A. Honestly, the room is pretty much -- I guess you can say
- 4 it's soundproof, to be honest with you. We really can't hear
- 5 anything on the outside. And even if -- when I look at the
- 6 camera, I can only see the door. But there was no smoke at the
- 7 door, so that's why I didn't see the smoke until I opened the
- 8 door.
- 9 Q. Okay. So regarding the ventilation system, is there any
- 10 time that you may be in the room and smell smoke, something comes
- 11 through the ventilation system that you --
- 12 A. Oh, absolutely, yes. Yes, sir. That particular day, we
- 13 smelled nothing.
- 14 Q. You smelled nothing?
- 15 A. No, sir.
- 16 Q. But the fans kicked in and that prompted you --
- 17 A. The fans kicked in, the noise, and that's when I stepped
- 18 out.
- 19 MR. DOWNS: Downs here. A follow-up question, Chief.
- 20 BY MR. DOWNS:
- Q. Has there been prior events where you've smelled smoke
- 22 in your work area; have you -- in the past?
- 23 A. Oh, absolutely. Yes, sir.
- Q. And to what degree of smoke? Is it real heavy smoke or
- 25 just a minor --

- 1 A. Just a mild smoke.
- 2 Q. Mild smoke that just enough to say, oh, there's
- 3 something --
- 4 A. Yeah.
- 5 Q. -- unusual here?
- 6 A. Exactly.
- 7 Q. Did you investigate those prior events as to what was
- 8 the cause of the smoke?
- 9 A. I did not investigate. The majority of the time, I know
- 10 what it is.
- 11 Q. And what would that be?
- 12 A. That would be either the technician is repairing the
- 13 fans --
- 14 Q. In your work area?
- 15 A. In my work area.
- 16 Q. Okay.
- 17 A. Or -- I don't know what you call the area, but there's
- 18 an area where the guys go down the steps onto the tracks, and it
- 19 may be something that they're doing there.
- Q. So there is a stairway and steps that go from your work
- 21 area directly downstairs --
- 22 A. To the tracks.
- 23 O. -- to the track area.
- 24 A. That is correct.
- Q. And your experience has been that somebody would be

- 1 working down there on the track area which would be the cause of
- 2 the smoke?
- 3 A. That would be the cause, yes.
- 4 Q. And it would not be a particular degree of smoke that
- 5 would be so much of an alarm as a maintenance activity?
- 6 A. Absolutely. Yes, sir.
- 7 Q. Would that be a correct way to say it?
- 8 A. That is correct, yes, sir.
- 9 Q. Very good.
- 10 BY MR. HAWKINS:
- 11 Q. Okay, Derron Hawkins here again. So once you realized
- 12 there was smoke outside the room, is there a fire alarm inside the
- 13 room (indiscernible)?
- 14 A. No, sir, absolutely not. No, sir. When I opened the
- 15 door, that's when I heard the fire alarms.
- 16 Q. There's no way to alert for a force -- fire force
- 17 station inside the rooms? You're saying there's not one inside
- 18 the room?
- 19 A. If memory serves me correctly, I believe I saw like an
- 20 intercom or something in there, but it's not working.
- 21 Q. Okay, I'm finished. I have no further questions.
- MR. DOWNS: Name?
- BY MR. GOOD:
- Q. George Good, Federal Transit Administration. Let me ask
- 25 a two-part question.

- 1 A. Okay.
- 2 Q. You said that in Room S200, there was just you and one
- 3 other person in there?
- 4 A. That's correct.
- 5 Q. Now, how would you know that it was only those two
- 6 people or -- and the second part, are people in and out of that
- 7 room?
- 8 A. Well, the bond that we have is close knit. Most of the
- 9 time, I'm in there by myself. When Bonnie Moore comes back in or
- 10 any other, they'll knock on my door and say, hey, I'm back. That
- 11 way, we know, hey, she's back there. So we have the close knit,
- 12 as such.
- 13 BY MR. DOWNS:
- Q. Downs. Question: So there's normally only two of you
- 15 in that workroom area?
- 16 A. No, sir.
- 17 Q. There are other employees?
- 18 A. It's me and, I believe, it's four or five parts runners.
- 19 Q. Four or five total parts runner, of which Ms. Moore is
- 20 one of the parts runners?
- 21 A. That is correct. Yes.
- Q. And on the particular day of the event, there was only
- 23 Ms. Moore present in her work area, which is a little bit
- 24 separated from your work area?
- 25 A. That's correct.

- 1 Q. Would that be a correct way of saying it?
- 2 A. That is correct.
- 3 BY MR. GOOD:
- 4 Q. So that -- George Good again. So that is just something
- 5 you do amongst that work area is let each other know, but it's not
- 6 a written policy to --
- 7 A. No, sir, it's not a written policy. No, sir.
- 8 Q. -- account for who's in the room?
- 9 A. Exactly.
- MR. GOOD: Okay.
- MR. DOWNS: End of questions?
- MR. GOOD: I mean, we were going to do a couple of
- 13 rounds or we just keep going?
- MR. DOWNS: You may continue your questions until you
- 15 run out of questions. You'll have an opportunity to ask more
- 16 questions later.
- 17 BY MR. GOOD:
- 18 Q. When you start your work shift with the group that's in
- 19 the room, do you have any kind of toolbox or safety talk at the
- 20 beginning of the shift?
- 21 A. No, sir. I don't --
- BY MR. DOWNS:
- Q. Downs here. I think maybe a better way to phrase that
- 24 would be, are you given a safety briefing at the end of each
- 25 workday?

- 1 A. No, sir.
- 2 Q. So there is no safety activity between yourself,
- 3 Ms. Moore, and your supervisory folks at the other end of the
- 4 station?
- 5 A. Not with me. On every Wednesday, the automatic fare
- 6 collection supervisor comes over and they have a safety briefing.
- 7 Q. So it's a weekly safety briefing rather than a daily
- 8 safety briefing?
- 9 A. That's correct.
- 10 Q. And that supervisor would come over for a few minutes to
- 11 your work area and give you that briefing?
- 12 A. Yes, sir.
- 13 BY MR. GOOD:
- 14 Q. In that work location, do you have landlines telephones
- 15 and do cell phones work in there?
- 16 A. I have landline. Cell phones are sometimes. It depends
- on where you are. If you're in the back room where Ms. Moore was
- 18 located, no service at all; no cell phone service, that is. My
- 19 phone, because I'm up closer to the front door, mine will work
- 20 sometime if I step outside of my room.
- Q. Within your workgroup and in that environment there, do
- 22 you have an emergency contact list where in case of emergency who
- 23 you should be contacting and in which order?
- 24 A. There is a list there. Yes, sir, there is.
- MR. DOWNS: Is that a posted list on the wall or on the

- 1 phone? Exactly how is that list set up?
- 2 MR. WHITLEY: That list was on the wall.
- 3 MR. DOWNS: On the wall near the phone?
- 4 MR. WHITLEY: Yes, it's -- what do you call it? Not a
- 5 chalkboard -- bulletin board.
- 6 MR. DOWNS: Bulletin board?
- 7 MR. WHITLEY: It's on a bulletin board.
- 8 MR. DOWNS: Thank you.
- 9 BY MR. GOOD:
- 10 Q. That bring up a -- is there -- I'm just curious. Is
- 11 there also a -- some type of safety bulletin board in that
- 12 location?
- 13 A. There are some safety things on there, but they're -- I
- 14 can't remember what they were, to be quite honest with you.
- 15 MR. GOOD: That's all I have right now.
- BY MR. DOWNS:
- 17 Q. Okay, Downs again. Let's get back to my line of
- 18 questioning. Mr. Whitley, in your work area, you indicated that
- 19 you had absolutely no indication by sound that there was an
- 20 emergency occurring in the station proper outside of your office,
- 21 correct?
- 22 A. That is correct.
- Q. In your work area, are there any fire alarm indicators,
- 24 such as we're showing here on the wall, where you have a strobe
- 25 that flashes when there's a fire event and there's also a speaker

- 1 that will announce there's a fire in progress, et cetera, et
- 2 cetera, evacuate the building. Is there any feature in your work
- 3 area at all?
- 4 A. There is a speaker in there. If it made an
- 5 announcement, we didn't hear it because of the fans were on.
- Q. So it may be a case that because the fans were on, you
- 7 couldn't hear it?
- 8 A. Absolutely. It could have been that.
- 9 Q. Has there been prior events where that has gone off and
- 10 the fans were not activated where you could hear an announcement?
- 11 A. It's very faint.
- 12 Q. Very faint?
- 13 A. The speaker, the speaker is very faint.
- Q. Does a speaker have a capability of adjusting the
- 15 loudness?
- 16 A. Now, that I don't know. Because it's high up, I really
- 17 can't see any of that.
- 18 Q. So it's out of reach --
- 19 A. Yes.
- 20 Q. -- it's out of reach to make any kind of adjustment --
- 21 A. Yes.
- 22 Q. -- if there were an adjustment?
- A. Exactly.
- Q. Okay. That addresses the speaker part, but there's no
- 25 strobe that would be flashing in the event --

- 1 A. Now, I've seen some of those red things in there, but
- 2 they didn't work, so --
- 3 Q. And clearly -- I think what you're saying here is --
- 4 correct me if I'm wrong -- on the particular day of the event, you
- 5 saw no flashing strobe whatsoever in your work area?
- 6 A. No, sir.
- 7 Q. Very good.
- 8 A. No, sir, not in S200. There was nothing.
- 9 Q. Nothing.
- 10 MR. DOWNS: Okay, I'm going to continue on, let the
- 11 questioning move around.
- 12 Mr. Buchar?
- BY MR. BUCHAR:
- 14 Q. Dave Buchar again. I have one more question.
- 15 Mr. Whitley, are you aware of any other storeroom type locations
- 16 around WMATA like yours that would be set up the same way? In
- 17 other words, not being -- I'm not familiar with how you store your
- 18 parts or how the stations are totally arranged, but are there
- 19 storerooms at other locations that are --
- 20 A. Similar to L'Enfant Plaza?
- 21 O. Yes.
- 22 A. No, sir. No, sir.
- Q. This is the only one that is, like, above the station?
- A. This is the most antiquated one, yes.
- 25 Q. Okay.

- 1 A. The other ones are pretty nice.
- Q. Okay. And you're not aware of any other similar
- 3 positions as yours around that would have, like, offices in other
- 4 stations that might be separated --
- 5 A. I'm not --
- 6 Q. -- I guess, is where I'm looking.
- 7 A. I'm not really totally sure, but I do believe there's
- 8 another one at Mt. Vernon Square, I believe, similar to this one a
- 9 little bit.
- 10 Q. Okay. Mt. Vernon, okay.
- 11 A. I believe Mt. Vernon Square is. I have not been there
- 12 in a long time now.
- 13 Q. Okay, that's all I have.
- MR. BUCHER: Mr. Gordon?
- 15 BY MR. GORDON:
- 16 Q. Joe Gordon, NTSB. In the S200 room, the unit, so to go
- 17 from the main door coming into the location, is there another
- 18 emergency evacuation route from that room that wouldn't require
- 19 you to come out the door and into the station that you're aware
- 20 of?
- 21 A. Yes, sir. There is another exit. We were supposed to
- 22 have been taking a trial run to see where it will exit, but we
- 23 never did.
- MR. DOWNS: Let's go off the record for a moment.
- 25 (Off the record.)

- 1 (On the record.)
- 2 MR. DOWNS: All right, back on the record. Downs here.
- For the record, we're displaying a photograph that was
- 4 taken yesterday in the S200 room. This is a photograph. It's
- 5 identified as IMG_0590. We may have this docketed later on. But
- 6 suffice to say, it is a photograph showing what appears to be a
- 7 metal door, and it's one of these what we call a smoke lock door,
- 8 meaning the door actually rotates within its doorframe, okay? And
- 9 the door itself sits up on a platform that appears to be maybe
- 10 three steps high. There's a railing next to the door.
- 11 BY MR. DOWNS:
- 12 Q. Mr. Whitley, is that particular door the door that
- 13 you're referring to, the exit door?
- 14 A. Yes, sir.
- 15 Q. Please tell us about that door.
- 16 A. That particular door, of course, the rotating door, if
- 17 you go through it, make sure you're aware of what you're doing
- 18 because you can't get back.
- 19 Q. It's a one-way door?
- 20 A. Yes, sir. If it closes, you're in there.
- Q. Have you been through that door before?
- 22 A. Yes, sir.
- 23 Q. I'm looking at the picture here and it does not say
- 24 emergency exit anywhere in the picture.
- 25 A. No, sir.

- 1 Q. So the only way to understand the function of that door
- 2 is to have prior instruction in the use of the door?
- 3 A. That's correct.
- 4 Q. Would that be correct?
- 5 A. Yes, sir.
- 6 Q. All right. When did that prior instruction occur
- 7 approximately? Do you remember?
- 8 A. I really don't. But I've always known that door was
- 9 there, and once you go in there, there's a stepladder that takes
- 10 you up to the street.
- 11 Q. Stepladder or a ladder built into the wall?
- 12 A. Built into the wall, yes.
- Q. Okay. And it takes you up to the street somewhere?
- 14 A. Somewhere, yes, sir.
- 15 Q. Have you -- you've not been up through there?
- 16 A. No, sir.
- 17 Q. So you've never been on the other side of the door. How
- 18 do you know there's a ladder on the other side?
- 19 A. No, I've been on the other side of the door --
- 20 Q. Okay.
- 21 A. -- but you make sure that door don't close on you.
- 22 Q. So you rotated it halfway open, is what you're saying
- 23 here?
- A. Exactly. Yes, sir. Yes, sir.
- 25 Q. Which allowed you to visualize the other side and the

- 1 ladder going up to the surface?
- 2 A. That is correct, yes, sir.
- 3 Q. But you never went up the ladder?
- 4 A. No, sir.
- 5 Q. And you were accompanied by some WMATA management that
- 6 showed you this particular door function?
- 7 A. No, sir. Actually, that was just the employees. We
- 8 were being nosey.
- 9 Q. Just on your own level of curiosity?
- 10 A. Absolutely.
- 11 Q. That would be a correct way of saying it?
- 12 A. Absolutely.
- 13 Q. Okay. Please continue describing about the door in
- 14 terms of your familiarity, to finish your question.
- 15 A. We were -- and that's just what we're familiar with. We
- 16 know about it just by hearsay or just what we visualized.
- 17 BY MR. GORDON:
- 18 Q. Okay, but there has been no actual training on how to
- 19 use that or where that takes you --
- 20 A. No, sir.
- 21 Q. -- and a planned emergency evacuation?
- 22 A. We've all discussed that we're only -- in that room,
- 23 there's one way in and one way out. So the life we save may be
- 24 our own.
- Q. Right.

- 1 BY MR. DOWNS:
- 2 Q. Downs here. Question: If you had discovered when you
- 3 went out the main entrance door of your S200 office area that the
- 4 station was actually full of smoke where you could not have
- 5 proceeded, would you have utilized that door as a --
- 6 A. Absolutely.
- 7 Q. -- second option --
- 8 A. Absolutely. Yes, sir.
- 9 Q. -- of escape?
- 10 A. Yes, sir.
- 11 Q. Yes?
- 12 A. Yes, sir, I would.
- 13 Q. Thank you.
- 14 BY MR. GORDON:
- 15 Q. Okay. And aside from the door that's being shown -- and
- 16 I think you answered this with one way in/one way out. Aside from
- 17 that door that's being shown, there's no other emergency route out
- 18 of that S200 room that you're aware of?
- 19 A. Well, there's another door to the left that will go out
- 20 on the tracks.
- Q. Okay. Okay, so the door to the left would take you out
- 22 track level?
- 23 A. It will take --
- MR. DOWNS: Downs with a question here. Correct me if
- 25 I'm wrong, but does that door have an emergency exit sign on it?

- 1 MR. WHITLEY: No, sir.
- 2 MR. DOWNS: It does not?
- MR. WHITLEY: No, sir. No, sir. But we're aware that
- 4 if we go down on those tracks, we have a chance of getting back to
- 5 the platform.
- 6 MR. DOWNS: I see. Thank you.
- 7 BY MR. GORDON:
- 8 Q. So, I guess, to summarize -- and we've talked a lot
- 9 about different doors and everything to come in and out of that
- 10 room. The big takeaway that I would like to understand from that
- 11 is there has been no planned evacuation route to say, if you're in
- 12 an event that you can't exit this room through the plaza, this is
- 13 the way that you go?
- 14 A. After that event, I was told by one of the AFC
- 15 supervisors that why didn't we use the plan of evacuation, which I
- 16 had never seen.
- 17 Q. Okay.
- 18 MR. DOWNS: So -- Downs here. There's no -- again, to
- 19 clarify, there's no posted copy available to you --
- MR. WHITLEY: No, sir.
- MR. DOWNS: -- in your work area?
- MR. WHITLEY: No, sir, not at all.
- MR. DOWNS: Thank you.
- MR. GORDON: Okay, I have no further questions.
- MR. DOWNS: Mr. Rourke?

- 1 MR. ROURKE: No further questions.
- 2 MR. DOWNS: Chief?
- 3 MR. HAWKINS: Yes, I have a question. Derron Hawkins
- 4 here.
- 5 BY MR. HAWKINS:
- 6 Q. So you mentioned the door, door that's on the post --
- 7 the door that goes to the street, the ladder goes to the street
- 8 somewhere. How do you know that? Did somebody tell you that?
- 9 A. Well, one of the supervisors did mention that.
- 10 Q. They mentioned that?
- 11 A. They said that that door leads up to a manhole. Now, I
- 12 don't know whether when you get to the top are you going to be
- 13 able to lift that manhole up or not. I don't know. That's what I
- 14 was told.
- 15 Q. Okay. So someone told you that?
- 16 A. Yes, sir.
- 17 Q. Okay. All right.
- 18 MR. DOWNS: Mr. Rourke, do you have a question?
- 19 MR. ROURKE: I can provide some clarification if you
- 20 want it, otherwise, I don't have a question.
- MR. DOWNS: Well, we don't allow testimony at this
- 22 step --
- MR. ROURKE: Okay.
- MR. DOWNS: -- of the process.
- 25 Chief, anything further?

- 1 MR. HAWKINS: Yeah, one more question. Derron Hawkins
- 2 here.
- 3 BY MR. HAWKINS:
- 4 Q. Is there a fire extinguisher in the room?
- 5 A. Yes, sir, there is a fire extinguisher.
- 6 Q. Okay. Are you aware of any fire sprinklers in the room?
- 7 MR. DOWNS: Sprinkler heads like we have in the ceiling
- 8 here?
- 9 MR. WHITLEY: I can't lie. I'm not sure right off.
- 10 BY MR. HAWKINS:
- 11 Q. You're not sure?
- 12 A. Right. I don't --
- Q. But there is a fire extinguisher in the room?
- 14 A. There is an extinguisher, yes, sir.
- 15 Q. Do you know, is it charged or is it out of service? Do
- 16 you know the date on --
- 17 A. No, I know it is in service.
- 18 O. It's in service?
- 19 A. Every so many months I have to update it or get the
- 20 safety to approve something on that, I guess.
- MR. DOWNS: Downs here. Question: The safety
- 22 department will come around and inspect the tag and everything --
- MR. WHITLEY: Right, exactly.
- MR. DOWNS: -- is that what you're saying?
- MR. WHITLEY: Absolutely.

- 1 MR. DOWNS: Thank you.
- 2 MR. HAWKINS: Okay, I have no further questions.
- 3 MR. DOWNS: Mr. Good?
- 4 BY MR. GOOD:
- 5 Q. George Good, FTA. I just have two more questions. One,
- 6 again, might have a few parts to it.
- 7 To your knowledge, does the station attendant kiosk or
- 8 the booth, do they have the number to your office where they could
- 9 call you? And you also mentioned an intercom. Do you know if
- 10 that intercom was an intercom from the station attendant to
- 11 contact you in emergencies?
- 12 A. I'm not exactly sure -- I'm sorry; I didn't mean to cut
- 13 you off -- where the intercom comes from because we get all kinds
- 14 of crazy messages over it. Like, one message comes on and says
- 15 abort, evacuate the station. I don't know who that is or where
- 16 it's coming from, but that is one of the messages I hear on it.
- 17 And majority of the time, we hear MOC over that intercom.
- 18 MR. DOWNS: Downs here. Question: MOC, what's that?
- 19 MR. WHITLEY: Central control.
- MR. DOWNS: MOC is your central control, and they will
- 21 have a message, a general announcement for employees?
- MR. WHITLEY: Yes, um-hum.
- MR. DOWNS: Thank you.
- MR. WHITLEY: A lot of times, they'll come on and say,
- 25 "Train operator, contact central," or something like that.

- 1 BY MR. GOOD:
- 2 Q. And to the first part of the question, do you know if
- 3 the station attendants know your number to contact you by
- 4 landline?
- 5 A. I know one of them do. I don't know if the others do or
- 6 not. I don't know.
- 7 Q. And you don't know if that's their procedure?
- 8 A. I know nothing's posted in the kiosk.
- 9 Q. Okay. And my other question, you say there's a door
- 10 that exits directly to the tracks.
- 11 A. $Um-h_{11}m$.
- 12 Q. Are you required to have RWP training, knowing when --
- 13 you know, the protocols to --
- MR. DOWNS: RWP training is what?
- MR. GOOD: Roadway worker protection.
- MR. WHITLEY: Um-hum. Yes, sir.
- 17 BY MR. GOOD:
- 18 Q. So you're qualified? You know the protocols to enter
- 19 that area?
- 20 A. Well, honestly, I am a Level 2. In order to go on the
- 21 tracks, I need to be escorted. So I don't think anybody in AFC is
- 22 above this --
- BY MR. DOWNS:
- Q. Downs with a question here. You say in order for you to
- 25 go to the track you have to be escorted.

- 1 A. That's correct.
- 2 Q. You have to exit emergency exit that you would have to
- 3 go down in the event that your normal egress would be blocked. Is
- 4 that correct?
- 5 A. That is correct.
- Q. So I don't want to make judgments, but, in theory, you
- 7 would have to wait for an escort for you to make that exit.
- 8 A. That is correct.
- 9 O. Would that be a fair assessment?
- 10 A. Yes, sir.
- MR. GOOD: Because one of the requirements is to have a
- 12 radio, and you know that you need a radio and to call OCC and --
- MR. WHITLEY: Yes, sir.
- 14 BY MR. DOWNS:
- 15 Q. Downs. Question: Do you have radio?
- 16 A. No, sir, I do not.
- 17 Q. So how would you then be able to get an escort?
- 18 A. I wouldn't.
- 19 Q. Thank you.
- 20 A. I wouldn't, to be quite honest.
- MR. GOOD: That was the last questions I had.
- MR. DOWNS: Any further questions?
- MR. GOOD: No.
- MR. DOWNS: No further questions. Okay.
- BY MR. DOWNS:

- 1 Q. Downs again. Let's divert a little bit here,
- 2 Mr. Whitley. How long have you been with WMATA roughly?
- 3 A. That'll be 11 years.
- 4 Q. Roughly, 11?
- 5 A. Um-hum.
- Q. And you've worked in your current job about 4 years, you
- 7 said?
- 8 A. Well, I've been at L'Enfant Plaza 4 years --
- 9 O. L'Enfant for --
- 10 A. -- but I've been a storeroom clerk about 8 years.
- 11 Q. About 8 years of the 11?
- 12 A. That's correct.
- Q. What did you do previous to the storeroom clerk?
- 14 A. Previous, I was a custodian.
- 15 Q. Custodian. Okay. Tell me, were you issued a respirator
- 16 mask when you started your work at L'Enfant Plaza? Do you know
- 17 what I'm talking about, respirator mask?
- 18 A. With the things on it?
- 19 Q. A breathing device --
- 20 A. No, sir.
- 21 Q. -- that allows you to escape through smoke?
- 22 A. No, sir.
- 23 Q. You were not issued one. Thank you.
- We already covered a radio. You don't have a radio --
- 25 A. No, sir.

- 1 Q. -- you just have a landline telephone that's reliable
- 2 and you can connect with whomever is necessary?
- 3 A. That's correct, yes.
- Q. Let me ask you this. Were there any -- do you have any
- 5 medical issues that might preclude you from evacuating in an
- 6 emergency? In other words, you're -- you have normal walking
- 7 capability and so on?
- 8 A. Oh, yes.
- 9 Q. You're not in a wheelchair or anything like that, right?
- 10 A. No, sir. No. No, sir.
- MR. DOWNS: Okay. I'm going to continue on with
- 12 Mr. Bucher.
- MR. BUCHAR: Buchar. I have no more questions.
- 14 BY MR. GORDON:
- 15 Q. Joe Gordon. One more question and it goes back to the
- 16 other exit door that takes you down to the track level. When that
- 17 takes you down to track level, does that -- do you come out on a
- 18 catwalk adjacent to the track that has like hand railing
- 19 separating you from the tracks?
- 20 A. Yes, sir, it does.
- Q. Okay. So, your understanding, would you be required to
- 22 have an escort to go to that catwalk level?
- 23 A. Yes, sir, I would. Yes, sir.
- Q. Okay. Not just to go into actually the track bed, but
- 25 to go to that catwalk level, you would need an escort?

- 1 A. Yes, sir. Anywhere past that gate --
- 2 Q. Okay.
- 3 A. -- I would need an escort.
- 4 Q. Based on your Level 2 --
- 5 A. That's correct.
- 6 Q. -- RWP certification? Okay. I have no further
- 7 questions.
- 8 MR. DOWNS: Mr. Rourke?
- 9 BY MR. ROURKE:
- 10 Q. Denton Rourke Metro, OEMD. I want to ask you about the
- 11 announcements that you hear during the course of the day in the
- 12 S200 room. Are those the general station announcements? For
- 13 instance, we are -- we apologize, but we're experiencing delays up
- 14 the line?
- 15 A. The majority of them are, yes, sir.
- Q. All right. So that -- do you think that's just a normal
- 17 station speaker?
- 18 A. Yes, sir, I think so.
- 19 Q. Okay, thanks.
- 20 BY MR. DOWNS:
- Q. Downs here. And you had testified to the effect that
- 22 the sound of that speaker was really low sometimes and you had a
- 23 hard time hearing it, particularly when the fan equipment had
- 24 engaged?
- 25 A. That is correct. Yes, sir.

- 1 Q. And when the fan equipment is not engaged, you can hear
- 2 it okay?
- A. It's still a little faint.
- 4 Q. A little faint?
- 5 A. Yes, sir.
- 6 Q. But you can still make out what they're saying?
- 7 A. I can still make out what they're saying.
- 8 Q. Thank you.
- 9 MR. DOWNS: Mr. Rourke?
- 10 MR. ROURKE: I don't have anything further. Thank you
- 11 MR. DOWNS: Let's go off the record for a moment.
- 12 (Off the record.)
- 13 (On the record.
- MR. DOWNS: Back on the record.
- 15 Mr. Rourke, do you have a further question?
- 16 MR. ROURKE: No, sir, no further questions. Thank you.
- 17 MR. DOWNS: Chief?
- 18 MR. HAWKINS: Yes.
- 19 BY MR. HAWKINS:
- 20 Q. Derron Hawkins here. I have a question. Regarding
- 21 Ms. Moore, you mentioned that you ran back to the room to notify
- 22 her and she froze; she got stuck. Can you explain exactly what
- 23 you meant by that?
- A. Well, basically, even right there at that door, when you
- 25 come around -- everything was fine; there was no smoke in that

- 1 particular room. But when we got to the door at S200, that's when
- 2 you see all the smoke. She panicked.
- 3 Q. She panicked?
- 4 A. Yes, sir.
- 5 Q. Okay. Okay, I have no further questions.
- 6 MR. DOWNS: Mr. Good, questions?
- 7 MR. GOOD: Yes.
- 8 BY MR. GOOD:
- 9 Q. Both the -- for your -- from you or to your knowledge,
- 10 any of your fellow co-workers, did anyone ever bring up to
- 11 management or a supervisor a concern over not knowing where to
- 12 assemble in an emergency or going over the emergency procedures?
- 13 To your knowledge, did anybody ever, you know, raise that issue?
- 14 That was just --
- 15 A. To my knowledge, no, sir.
- 16 Q. Okay. And the other question, the door that we're
- 17 looking at, the rotating door that goes up to the ladder, have you
- 18 ever been told that that door is just to keep, like, a swing type
- 19 door from slamming because of the piston effect of the train or is
- 20 it for smoke? Have you ever been told one way or the other?
- 21 A. No, sir, we haven't been told anything regarding that.
- 22 We know that on the other side of that door it's dangerous. So
- 23 it's one of the situations where we know the door is there and we
- 24 don't bother it.
- Q. Okay, that's all I had.

- 1 BY MR. DOWNS:
- 2 Q. Okay, Downs here. Question: Going back to this
- 3 rotating door. In looking at the picture, there is no indication
- 4 that it's an emergency exit. Mr. Whitley, your understanding is
- 5 that it's dangerous on the other side --
- 6 A. Absolutely. Yes, sir.
- 7 Q. -- okay, and you believe there may be a manhole cover or
- 8 something at the top end that might not easily be opened --
- 9 A. Yes, sir.
- 10 Q. -- in the event that you needed to escape. The only
- 11 other escape path you have from the room there would be the
- 12 emergency exit that goes down --
- 13 A. To the tracks, yes, sir.
- Q. -- to the track level and the safety walk, the catwalk,
- 15 which you --
- 16 A. Off limits.
- 17 Q. -- you're basically off limits, you need an escort for.
- 18 So, tell me, is there any other way to escape from this room, any
- 19 other emergency exit other than these two pathways we've just
- 20 described?
- 21 A. No, sir, there is not.
- 22 Q. There is none. Okay, thank you.
- As part of my closing questions, I typically ask the
- 24 witness if there's any retrospective thoughts. In other words,
- 25 knowing what you know now, is there anything you'd like to add to

- 1 your testimony that might help our understanding in terms of the
- 2 safety features and such? Would you have done anything
- 3 differently knowing what you know now that you had done, that kind
- 4 of thoughts? This is your chance to bring it forth and tell us
- 5 about it.
- 6 A. No. Honestly, I'm very happy with the way we handled
- 7 things that particular day, to be honest with you.
- 8 Q. Very happy?
- 9 A. I am very -- we got out safely.
- 10 Q. You got out safely --
- 11 A. Yes, sir.
- 12 Q. -- "without injury," quote/unquote?
- 13 A. Without injury, that is correct.
- Q. Even though you sought medical attention later on?
- 15 A. Um-hum. We've gone over it and over it again because,
- 16 once I opened that door, I could have very well took off and left
- 17 Ms. Moore. But I decided to go back and get her. So that's what
- 18 I say I'm happy about. I didn't leave her there to die. But
- 19 other than that, there wasn't much else we could have done
- 20 differently.
- Now, I was told by one of the AFC managers that when we
- 22 come down on the Greenbelt side, we should have gone right. I've
- 23 never seen an evacuation plan.
- Q. Right would have taken you where?
- 25 A. Right would have taken me to -- what is that street?

- 1 UNIDENTIFIED SPEAKER: 9th and D.
- MR. WHITLEY: 9th and D, yes, sir.
- 3 MR. DOWNS: To 9th and D exit --
- 4 UNIDENTIFIED SPEAKER: No, the other one, 7th and D.
- 5 BY MR. DOWNS:
- Q. 7th and -- that's the 7th and D exit?
- 7 A. That's correct, yes.
- 8 Q. That's basically the side direction from the -- that
- 9 would be the opposite end of the L'Enfant Plaza exit of the
- 10 station; would that be correct?
- 11 A. No --
- 12 Q. In other words, directly opposite your office door is
- 13 Maryland Avenue.
- 14 A. That's correct.
- 15 Q. If you were to make a left out of your office door, that
- 16 would be to L'Enfant Plaza --
- 17 A. That's correct, but --
- 18 Q. -- and if you made a right, that would be the --
- 19 A. The 7th and D.
- 20 Q. -- 7th and D exit?
- 21 A. Yes, sir.
- Q. Okay, very good. Let me ask you this, sir. Did it
- 23 occur to you to call 911 or call somebody when you went back to
- 24 get Ms. Moore and get direction as to what to do?
- 25 A. No, sir.

- 1 Q. Your first thought was simply just get out of there --
- 2 A. Yes, sir.
- 3 Q. -- the two of you, as fast as you could?
- 4 A. Absolutely. Yes, sir.
- 5 Q. I see. Thank you.
- 6 MR. DOWNS: Okay, that concludes my questions. Now
- 7 we'll go around the room one more time.
- 8 MR. BUCHAR: Buchar. No more questions.
- 9 MR. GORDON: Nothing further.
- MR. ROURKE: Rourke. No questions.
- MR. DOWNS: Chief?
- MR. HAWKINS: Derron Hawkins. No further questions.
- MR. DOWNS: Mr. Good.
- 14 BY MR. GOOD:
- 15 Q. George Good, FTA. I have one question or -- for point
- 16 of clarification. You mentioned that you spoke to your supervisor
- 17 and he mentioned that the evacuation plan said you should have
- 18 gone this way or took that Green Line way. So since that time
- 19 when you discussed the evacuation plan, have you received and been
- 20 trained on it?
- 21 A. No, sir.
- 22 UNIDENTIFIED SPEAKER: I'm sorry, what was his answer?
- MR. WHITLEY: No, sir.
- 24 UNIDENTIFIED SPEAKER: No? Okay, thanks.
- 25 MR. DOWNS: All right, if there are no further questions
