2	MR. WALSH: This is an interview concerning
3	the SS Norway explosion on 25 May 2003. It's now
4	approximately 4:00 on the 5th of June and we're
5	Interviewing Security Guard Bir Ray.
6	EXAMINATION
7	BY MR. WALSH:
8	Q Sir, would you give us your full name,
9	please?
10	A My name is Bir Ray, SS Norway security guard.
11	My crew number is 035, my safety number is 026. I
12	live in Biscayne Deck, 150 cabin.
13	Q One five zero?
14	A One five zero.
15	Q On Biscayne Deck?
16	A Biscayne Deck.
17	Q As a security guard, what do you do on board?
18	A As a security guard, I have to do all in ship
19	were able, some incident or something happen, like
20	Alpha and everything is some of the fighting or like
21	argument, something like that, the crew or the guest
22	members, everybody, what happen and who is the guilty,
23	who is the right. We go there and investigate the
24	things, then we report according to the (inaudible).
25	Q Your normal working hours are what, sir?

1	A	Normal working hours time and other time in
2	case we n	eed necessary manpower, we will get in.
3	Q	So you work from when to when every day?
4	А	Means when to when?
5	Q	From what time do you start to what time do
6	you finis	h?
7	А	Oh. I have to start some time we have a
8	schedule,	according to the schedule. Sometime that
9	ship 6:00	or tomorrow 6:00 or that one is a port day
10	and somet	ime we work 7:00 to 8:00 port day and sea day
11	we work n	ormal ten hours, 8:00 to evening, 9:00, 10:00.
12	Sometime	we work overtime.
13	Q	Sir, how long have you been with Norwegian
14	Cruise Li	nes now?
15	A	I finish first contract, seven months. There
16	is anothe	r seven months contract and this is second
17	contract	mine with Norwegian Star and I am now on board
18	two month	S.
19	Q	Two months?
20	A	Yes.
21	Q	You first contracted with the Star?
22	A	I was before SS Norway.
23	Q	SS Norway?
24	А	First contract, yes. The same ship.
25	Q	Prior to working for Norwegian Cruise Lines,

- 1 were you on any other ships?
- 2 A Yes. I was before in the Star Cruises
- 3 Company.
- 4 One more time, slowly?
- 5 A Yes. I was before in the Star Cruises
- 6 Company.
- 7 Q Star Cruises?
- 8 A Yes.
- **9** Q How many ships?
- **10** A The Star Cruise Company I work many, many
- 11 ship. Not many ship, but many kinds of ship. I work
- first time in Japan with (inaudible) and I transfer
- 13 from there in Singapore for some time Mega Star is in
- 14 dry dock.
- 15 Q Mega Star was in dry dock?
- 16 A Mega Star Aries. After three or four weeks,
- I transferred again in Diego. Diego is big ship.
- 18 Q When did you start with Star Cruises?
- 19 A I start Star Cruises in 2000, August 18.
- **20** Q August of 2000?
- 21 A Yes, August 18 I joined ship in Japan.
- 22 Q And prior to August of 2000, did you work on
- any other ships before that?
- 24 A Before that I did not work on a ship.
- 25 Q Where did you work before that?

1	Α	In	Hong	Kong.

- 2 Q In Hong Kong as?
- 3 A In Hong Kong as a supervisor. I worked two
- 4 years. First contract I work as a security guard.
- $\mathbf{5}$ Q As a security guard?
- **6** A Yes. After that, again I work as a
- 1 supervisor. My company give me the supervisor promoted
- **8** to me. Two years.
- **9** Q So as a private security guard?
- **10** A Yes. In the land.
- 11 Q On land.
- 12 A In company, not private. Wilson Packing
- 13 Company.
- 14 Q Wilson Packing Company?
- 15 A Yes.
- 16 Q When you went to Star Cruises, did they train
- you to be a security guard for a ship?
- 18 A Yes. First I had a course in the
- 19 Philippines, so big ideas as the school, internal
- 20 government shipping school.
- 21 Q What did you do in that course?
- 22 A I had a course on basic fire fight, SSR and
- 23 survival and something more.
- 24 Q What day did you start your first contract on
- 25 the Norway? What year and date?

1	А	Last 2002, June 23 I join in Miami wi SS
2	Norway.	
3	Q	When you came on the Norway did you get any
4	special d	training to be a security guard?
5	А	I did not have any. I get a course, but I
6	the most	necessary course I had finish in the Star
7	Cruises (Company.
8	Q	So you had the necessary courses in Star
9	Cruises?	
10	А	Yes, in the Star Cruises, something like boat
11	course a	nd everything else.
12	Q	When you came on board the Norway, what
13	training	did you receive?
14	А	In here training like the drug, how do we
15	handle i	f we found, like that, and that's all.
16	Q	So how to handle crowds?
17	А	How to handle crowds, we had that one too.
18	Q	And how long was that course?
19	А	And crisis management training also that I
20	had to do	o.
21	Q	How long was that course?
22	A	That course I normally had one day a week,
23	like one	day for lecture or training would go with this

and then training like that.

2	A We had a training like safety drill every
3	week we having.
4	Q On a safety drill, what are your duties?
5	What are the duties of Safety Number 026?
6	A Again, that's actually my tax is the crowd
7	control and on scene commander we assist the on
8	scene commander.
9	Q You assist the on scene commander?
10	A Yes.
11	Q Is that for all security guards?
12	A Yes. We all serve that or practice that.
13	Q So if you heard a Code Bravo for a drill,
14	report to the engine control room, all security guards
15	would go there for the drill?
16	A No. We have a mustering location for
17	mustering, then we listen we will report to the on
18	scene commander, then (inaudible) the on scene
19	commander will go to the place.
20	Q Where do you muster?
21	A Normal our muster is the 404 of the Olympic
22	Deck, but when we heard the Code Bravo at that time,
23	the nearest place where we say, like the nearest place
24	they located the place on the PA system. Like if
25	galley, we will be near by galley, nearby, like a

- 1 little bit separately from galley, then we will report
- to our on scene commander, then on scene commander will
- give us tasks what we do.
- 4 Q So for the drill, Code Bravo main galley.
- 5 Now what happens?
- **6** A Now we go into our mustering station.
- 7 O Which is?
- 8 A According to -- okay, the Code Bravo main
- galley, we go to the aft nearby alleyway or where our
- 10 assemble area, that place we go and assemble with our
- 11 commander.
- Q So where you muster, is it with the fire
- 13 teams?
- 14 A Near the fire team.
- **15** Q Near the fire team?
- 16 A Yes.
- 17 Q And you muster with your boss?
- 18 A Yes, with my supervisor coming there, then
- 19 also to the on scene commander.
- 20 Q So you're very close?
- 21 A Yes.
- 22 Q Your boss talks to the on scene commander?
- 23 A We will be not close. We will be far away.
- Our on scene commander will be little bit far away than
- 25 us.

1	Q The on scene commander is who?
2	A On scene commander is according to the fire
3	chief, our on scene commander and the on scene
4	commander is like a group leader, one who is visit that
5	place. That is the on scene commander.
6	Q But it's not a security guard?
7	A Not security guard.
8	Q Staff chief engineer?
9	A We have located one person, that one is not a
10	staff chief engineer, not other person. They like one
11	person, like our
12	Q On the Norway, is the staff chief engineer
13	the on scene commander?
14	A Yes.
15	Q He is. You receive your tasking from the on
16	scene commander?
17	A Yes. We receive the task from the on scene
18	commander, yes, then normally we give the staff
19	captain will give the report, then the staff captain
20	tell us okay, crowd control, you go Norway Deck
21	forward, then crowd control there or okay, one group go
22	Atlantic Deck forward, then alleyway, then instruct the
23	people there. It will be like that.
24	Q The staff captain tells you what to do or the
25	on scene commander tells you what to do?

A Staff captain will say that things.
Q I just need to be clear. Earlier you said it
was the on scene commander. Is the on scene commander
and the staff captain the same person?
A No. On scene commander will be the
actually report what is to happen, who will be there.
Then on scene commander will be engaged with all our
departings. Then all the places on scene commander
give to the staff captain to report, the staff captain
will give us tasks where we go, what we do, that
things.
Q So it's not the on scene commander, it's the
staff captain that gives you the tasking.
A No.
Q So who gives you your tasking?
A The staff captain give us tasks.
Q So the staff captain on the drill is going to
tell you to do what and that's every drill, right?
A No, according to the not every drill,
according to if they call this one is little bit
different from things. The staff captain call us
normally when the accident happen. That time the staff
captain will give us tasks what we do, where we go.
And other fire team, on scene commander is
the (inaudible) the staff captain.

1		Q	What were you doing on Saturday? What were
2	your	hours	s on Saturday?
3		A	Saturday?
4		Q	The 24th. The day before the accident.
5		A	That day we have private island.
6		Q	You were on the private island?
7		A	Yes.
8		Q	Do you go to the private island?
9		A	That day I was not I was on duty that day.
10		Q	You were on duty on the ship?
11		A	Yeah. On gangway, yes, on the ship.
12		Q	On the gangway?
13		A	Yes.
14		Q	What do you do at the gangway?
15		A	Normally we will use our x-ray machine and
16	check	the	unnecessary items, things on board coming,
17	passe	enger	bringing, like those things.
18		Q	Were you trained on the x-ray machine?
19		A	Yes, we have.
20		Q	How were you trained?
21		A	What I tell you. Normally, sir, when we
22	havin	ng the	e training, that time normal thing we will put
23	insid	le and	d how does it look at things and if we put the
24	knife	thin	ngs or the drug not drug, other, pistol or
25	like	weapo	on things, how does it look. Physically we

1	get the e	experience that way also, then we learn like
2	that.	
3	Q	When do you finish work on Saturday?
4	А	That day I was until 8:00.
5	Q	Until 8:00 at night?
6	А	Yes.
7	Q	When did you go to bed?
8	А	Normally I went to bed around 10:30 or 11:00.
9	Q	Around 10:30 or 11:00 you went to bed and on

12	Q	And you know that because your alarm goes off
13	at 6:20?

16	А	Yes. I got a watch alarm, I put the alarm

18	Q	So at 6:20 you wake up?
19	А	Yes.
20	Q	When did you notice something was wrong with
21	the ship?	
22	А	I woke up 6:20, then I went inside bathroom
23	and I hav	ring long toilet and meantime I heard just
24	banging l	ike this, banging sounding and later on,
25	slowly li	ght was suspended. Then I checked on my time,

1	time	was 6:35.
2		Q At 6:35 you saw the lights go off?
3		A Yes. Slowly goes out.
4		Q It slowly goes out.
5		A When I heard the banging and light was going
6	slow	ing, suspend light, blackout, so then that time was
7	righ	t 6:35.
8		Q Now what happened?
9		A Then quickly I dress out in my trouser and go
10	radi	o on.
11		Q Radio on?
12		A Yeah, radio on, then I heard meantime,
13	this	call over system Code Alpha and Code Bravo
14	toge	ther. Then I dress up quickly in my uniform and
15	pick	up the radio. Then I go from the starboard
16	port	side and Miami the gangway.
17		Q Why did you go to the Miami gangway?
18		A Miami gangway is actually my main gangway.
19	That	was the main gangway.
20		Q Miami gangway is on what deck?
21		A That was the Biscayne Deck.
22		Q Miami gangway is on the Biscayne Deck and
