1	PROCEEDINGS
2	MR. JONES: Okay. This is an interview with
3	Second Officer Enrico Rillera, who was on the bridge at
4	the time of the incident. And this is June 6, and I
5	would just like to get some background on your first,
6	Enrico. Your crew number?
7	MR. RILLERA: Seven, seven, five.
8	MR. JONES: And your safety number?
9	MR. RILLERA: Seven, one, three.
10	MR. JONES: And you are employed with, on the
11	Norway, in what position?
12	MR. RILLERA: Second officer.
13	MR. JONES: Okay. And what are your emergency
14	duties?
15	MR. RILLERA: My emergency duties is co pilot.
16	MR. JONES: Co pilot.
17	MR. RILLERA: On the bridge, yes.
18	MR. JONES: So you are on the bridge when the
19	emergency station bell is rung?
20	MR. RILLERA: Yes.
21	MR. JONES: Okay. Thanks.
22	Could you tell me how long you have been
23	working on the Norway?
24	MR. RILLERA: This is my second contract on
25	the Norway.

1	MR. JONES: Okay.
2	MR. RILLERA: And this is my three month,
3	third month.
4	MR. JONES: Third month on that contract.
5	MR. RILLERA: Yes.
6	MR. JONES: Okay.
7	MR. RILLERA: On my contract.
8	MR. JONES: And how long have you been second
9	mate on the Norway?
10	MR. RILLERA: The second time.
11	MR. JONES: The second time.
12	MR. RILLERA: Yes.
13	MR. JONES: Okay. And if you could tell me
14	that morning what happened or where you were when the
15	incident occurred?
16	MR. RILLERA: I was raising the mast,
17	because after finished, preparing for the next
18	place, going to St. Martin.
19	MR. JONES: The next time maybe erase a little
20	slower so I can get some information next time.
21	Okay. And then what were you doing next?
22	MR. RILLERA: Yeah, I hope nothing will happen
23	again.
24	MR. JONES: No, that is okay.
25	MR. RILLERA: Yeah. Then I haven't finished

- 1 my work, when I heard the explosion.
- MR. JONES: And where were you at the time
- 3 when you heard the explosion?
- 4 MR. RILLERA: -- table.
- 5 MR. JONES: On the bridge?
- 6 MR. RILLERA: Yes.
- 7 MR. JONES: Okay. On the forward part of the
- 8 bridge?
- 9 MR. RILLERA: Yes.
- MR. JONES: Up by the window?
- MR. RILLERA: Yes.
- MR. JONES: Okay. Okay. And what did you do
- 13 next?
- MR. RILLERA: I, I -- and the gangway pulled
- down.
- MR. JONES: Okay.
- MR. RILLERA: Then I heard the alarm.
- MR. JONES: Okay.
- MR. RILLERA: Then all the lights go off, I
- don't have a chance to go to the Master, because all
- the alarms came out. I don't know what to do, because
- I am alone there.
- MR. JONES: Okay. And you said you didn't have
- 24 a chance to call the Master.
- MR. RILLERA: Yes.

1	MR. JONES: Okay. What happened, what happened
2	next, the alarms were going off and
3	MR. RILLERA: No, continue, continue alarm.
4	MR. JONES: That is what I mean, they were
5	going off, they were sounding.
6	MR. RILLERA: Yes.
7	MR. JONES: You continued to hear the alarms.
8	MR. RILLERA: Yes. But, the Captain comes up.
9	MR. JONES: Okay. And what were your duties
10	then, what happened after the Captain comes on the
11	bridge and then what were you doing after that?
12	MR. RILLERA: No, we heard only and then we
13	announced Code Bravo.
14	MR. JONES: Okay. And who announced the Code
15	Bravo? Was that one of your duties, was it another
16	officer on the bridge?
17	MR. RILLERA: Another officer.
18	MR. JONES: And who was that?
19	MR. RILLERA: I don't remember because I am,
20	on the side, the navigation room.
21	MR. JONES: Okay.
22	MR. RILLERA: And is on the front.
23	MR. JONES: Okay. And what happened next,
24	Enrico? You were silencing the alarms, you were back
25	in the navigation chart room, behind the bridge.

MR. RILLERA: No, I kept listening to the 1 walkie talkie and writing all the details on what 2 happened. 3 MR. JONES: Okay. MR. RILLERA: Because I don't know we have 5 explosion. The boiler that exploded. 6 MR. JONES: And where were you writing those 8 details? MR. RILLERA: On a piece of paper. MR. JONES: Okay. How about, what was going 10 on next? Just kind of try to take me through, through 11 what you did next. You were keeping track of the 12 events on a scrap piece of paper, you were silencing 13 the alarms, and --14 15 MR. RILLERA: Yes, and listening to, listening to the walkie talkie. 16 17 MR. JONES: Okay. MR. RILLERA: And I am assisting because the 18 19 officer is also in microphone. He is doing, for 20 example, --MR. JONES: Okay. 21 MR. RILLERA: I am assisting him. 22 23 MR. JONES: Okay. You were assisting the first

MR. RILLERA: Yeah.

officer?

1	MR. JONES: Of staff captain or
2	MR. RILLERA: Yes.
3	MR. JONES: Or, so all your superior officers,
4	you were just up there assisting.
5	MR. RILLERA: Yeah.
6	MR. JONES: Okay. And about how long do you
7	think this process last? Were you on the bridge the
8	entire time and
9	MR. RILLERA: Yes, I was there until 11 or 11
10	or 12 o'clock.
11	MR. JONES: Okay. And if this incident hadn't
12	occurred, what were your normal duties that morning?
13	What was your normal watch that day?
14	MR. RILLERA: Yeah, I am four to eight.
15	MR. JONES: You were the four to eight.
16	MR. RILLERA: Yes.
17	MR. JONES: So you were on the bridge while
18	the vessel was docking.
19	MR. RILLERA: Yes.
20	MR. JONES: Okay. And then you would have been
21	relieved and gone off watch at eight o'clock.
22	MR. RILLERA: Yes.
23	MR. JONES: Okay.
24	MR. RILLERA: This really my duty, I do my

25 and then I go up --

1	MR. JONES: Yes, okay.
2	All right, anything else that you did on the
3	bridge that morning besides what you described right
4	now? Taking the scraps of log, silencing the alarms,
5	assisting with the phones and the walkie talkie.
6	Anything you remember? Did you look out the bridge
7	windows and see anything from the stack?
8	MR. RILLERA: Yes, I am, I am going around and
9	I was seeing the bridge wing.
10	MR. JONES: And what did you see out on the
11	bridge wing?
12	MR. RILLERA: Yeah, because the helicopter
13	is
14	MR. JONES: Was that a Coast Guard helicopter,
15	news helicopter?
16	MR. RILLERA: I think it was
17	MR. JONES: What did it look like?
18	MR. RILLERA: A helicopter.
19	MR. JONES: Did it have a flashing light?
20	MR. RILLERA: Yes.
21	MR. JONES: Was it white?
22	MR. RILLERA: I don't know, I don't remember.
23	MR. JONES: Was it white? Was it orange?
24	MR. RILLERA: I don't remember the color.
25	MR. JONES: Okay. Did you see anything else

1	about the vessel, itself?
2	MR. RILLERA: No, I see the, the fire fighters
3	and the ambulance.
4	MR. JONES: Down
5	MR. RILLERA: The ambulance.
6	MR. JONES: Down on the dock.
7	MR. RILLERA: Yes.
8	MR. JONES: So you were on the starboard
9	bridge wing at that time?
10	MR. RILLERA: Yes.
11	MR. JONES: Did you go out on the port bridge
12	wing at all?
13	MR. RILLERA: Yes.
14	MR. JONES: Look out over the harbor.
15	MR. RILLERA: Yes.
16	MR. JONES: Did you notice anything out there?
17	MR. RILLERA: Yeah, because we are checking if
18	somebody goes to the water.
19	MR. JONES: Okay. On the outboard side, on the
20	port side.

### MR. JONES: Okay. Anything else, did you see any of the smoke coming out of the stacks, anything

MR. RILLERA: Yes.

MR. RILLERA: Yes, port side.

MR. JONES: So you checked both sides.

- unusual there? Were you out there at that time?
- MR. RILLERA: I did not see the smoke coming
- out of the, I didn't see, I didn't see that.
- 4 MR. JONES: Okay. Okay. So you saw the medical
- 5 teams or the fire fighters arriving down on the dock.
- 6 MR. RILLERA: Yes.
- 7 MR. JONES: Anything else on the dock, were
- 8 there a lot of people down there?
- 9 MR. RILLERA: Yeah. There are a lot of people
- there.
- 11 MR. JONES: Any crew members? Did you see any
- of your own crew members down there?
- MR. RILLERA: I didn't see the hospital team
- taking out to the from ship to shore. I did not see
- 15 them.
- 16 MR. JONES: Okay. So the injured, you didn't
- see them remove the injured.
- MR. RILLERA: No.
- MR. JONES: Okay. Do you remember how many
- 20 passenger gangways were along side the ship at that
- time? The elevated ones that will be up on Norway
- 22 Deck?
- MR. RILLERA: Yes. I remember one forward,
- 24 aft and the Norway Deck was.
- MR. JONES: Okay. Just one right now.

MR. RILLERA: No, one forward, one aft and one 1 Norway forward is open. 2 3 MR. JONES: Okay. So, three, three passenger --5 MR. RILLERA: No, one passenger. MR. JONES: One passenger. 6 MR. RILLERA: And Norway, and Norway Deck. MR. JONES: And Norway Deck. 8 MR. RILLERA: Yeah. MR. JONES: And the other ones you are 10 describing, were those the ones on the dock, go right 11 up to the dock? 12 MR. RILLERA: Yes. Forward and aft. 13 MR. JONES: Okay. 14 15 MR. RILLERA: And the mid ship gangway because 16 we had, taking fresh water. 17 MR. JONES: Okay. MR. RILLERA: Every time we go to Miami. 18 19 MR. JONES: So that is three ramps to the dock 20 from --MR. RILLERA: Not the mid ship, no, no ramp. 21 MR. JONES: Okay. All right. Okay. 22 MR. RILLERA: I think that is starboard also 23 because we were taking -- We usually open that one, 24

starboard, eight o'clock.

- MR. JONES: Okay. On the port side? 1 MR. RILLERA: Yes, the port side. 2 MR. JONES: Okay. When you were up on the 3 bridge, did you see the bumping barge coming at all? MR. RILLERA: No. Because it was coming 5 eight, nine o'clock, something like that. 6 MR. JONES: Not until eight or nine o'clock. 7 MR. RILLERA: Yes. 8 MR. JONES: So, it wasn't even in your view at the time. 10 MR. RILLERA: No. 11 12 MR. JONES: Were any calls made to the bumping barge or did they call you? 13 MR. RILLERA: No. I don't, I don't receive 14 15 any. MR. JONES: All right, so they weren't really 16 in the area at all at the time. 17 MR. RILLERA: Yes. 18 19 MR. JONES: Okay. Enrico, just, where did you 20 get your training, where did you get your license? MR. RILLERA: In Philippines. 21 MR. JONES: Philippines. 22 MR. RILLERA: Yes.

MR. JONES: And how long have you had that

1	MR. RILLERA: Since 1994.
2	MR. JONES: Okay. Have you sailed second mate
3	on other ships before?
4	MR. RILLERA: Yes.
5	MR. JONES: Okay. With cruise lines or
6	MR. RILLERA: This is my second time in cruise
7	lines, but my experience is container, cargo ships.
8	MR. JONES: Okay.
9	MR. RILLERA: And boats.
10	MR. JONES: Okay. Enrico, I am just going to
11	open it up to the Coast Guard and, if they have
12	anything.
13	UNIDENTIFIED SPEAKER: U.S. Coast Guard.
14	I just wanted to ask you, what are your
15	duties on evacuation drill?
16	MR. RILLERA: Yeah, my duties are co pilot.
17	UNIDENTIFIED SPEAKER: Excuse me, can you say
18	that again?
19	MR. RILLERA: Yeah, my duties, my duties?
20	UNIDENTIFIED SPEAKER: Yes.
21	MR. RILLERA: Yeah, I am co pilot.
22	UNIDENTIFIED SPEAKER: What do your duties
23	consist of?
24	MR. RILLERA: Excuse me?
25	UNIDENTIFIED SPEAKER: What do they consist

1	of? What do you have to do during assisting the
2	MR. RILLERA: Assist watch officer on the
3	bridge.
4	UNIDENTIFIED SPEAKER: What do you do to
5	assist him? Assist him in what?
6	MR. RILLERA: Giving orders, or if he is busy
7	for other things, he is telling me what to do.
8	UNIDENTIFIED SPEAKER: So, have you practiced
9	evacuation drills before, during the time that you have
10	been on the Norway?
11	MR. RILLERA: Evacuation, no.
12	UNIDENTIFIED SPEAKER: Have you done any
13	drills?
14	MR. RILLERA: Oh, yeah, we are practicing.
15	UNIDENTIFIED SPEAKER: You have practice.
16	When you practice these drills, what do you do?
17	MR. RILLERA: Yeah, I am only on the bridge.
18	UNIDENTIFIED SPEAKER: You are on the bridge.
19	MR. RILLERA: Yes.
20	UNIDENTIFIED SPEAKER: You just stay on the
21	bridge.
22	MR. RILLERA: Yes.
23	UNIDENTIFIED SPEAKER: And what do you do on
24	the bridge during these drills? You observe anything?
25	MR. RILLERA: Yeah, I am

1	UNIDENTIFIED SPEAKER: Do you make radio
2	calls?
3	MR. RILLERA: Yes. Mostly I am getting the
4	passenger crew and giving to the radio communication
5	account and the position. Then I was the one who make
6	announcement
7	UNIDENTIFIED SPEAKER: So you make
8	announcements on the radio?
9	MR. RILLERA: No, the PA system.
10	UNIDENTIFIED SPEAKER: PA system.
11	MR. RILLERA: And also on the radio. After
12	that I was the one who closed down the ventilation,
13	ventilation system, if there is any fire.
14	UNIDENTIFIED SPEAKER: When you say closed the
15	ventilation system, what do you do to close the
16	ventilation system? How do you close it?
17	MR. RILLERA: There is, the release button.
18	But, I am not doing because only drill.
19	UNIDENTIFIED SPEAKER: Okay. What else do you
20	do? What are you other responsibilities?
21	MR. RILLERA: Staff Captain will take
22	over, if he is on the bridge.
23	UNIDENTIFIED SPEAKER: Doing this particular
24	incident, did you hear an evacuation sound or an
25	emergency call?

1	MR. RILLERA: Yes, I heard. Captain said that
2	the passengers must go to one, I think International,
3	Olympia, because, to get themselves there, put in one
4	place.
5	UNIDENTIFIED SPEAKER: To Olympia Deck?
6	MR. RILLERA: I think Olympia.
7	UNIDENTIFIED SPEAKER: Do you remember if he
8	said on the PA or on the radio?
9	MR. RILLERA: On the PA, the PA system.
10	UNIDENTIFIED SPEAKER: Did they, did you hear
11	any emergency signal?
12	MR. RILLERA: Yes.
13	UNIDENTIFIED SPEAKER: What was the signal,
14	what did it sound like? Well, what is the signal for
15	ship?
16	MR. RILLERA: Seven short and one long. But,
17	the crew is ashore at that time.
18	UNIDENTIFIED SPEAKER: Okay.
19	MR. RILLERA: Is ashore, that is why Master
20	to Master, crew members, but it is difficult because
21	the other crew is ashore. We cannot count which is
22	missing or who is present.
23	UNIDENTIFIED SPEAKER: Okay. What time more or
24	less was that emergency signal given?
25	MR. RILLERA: Between nine, nine to ten,

1	10:10.
2	UNIDENTIFIED SPEAKER: Do you want to clarify
3	whether this is during the drill or whether this was
4	the morning of the incident?
5	UNIDENTIFIED SPEAKER: He specified that it
6	was during the morning of the incident.
7	MR. RILLERA: Yes.
8	UNIDENTIFIED SPEAKER: Okay.
9	UNIDENTIFIED SPEAKER: What time did you see
10	the other crew ashore? That you physically see them.
11	MR. RILLERA: I heard through the radio
12	because we cannot check on the starboard mostly,
13	especially, nobody is there. And I heard the other crew
14	members, they cannot come in, because, I don't know
15	who, the police or they don't want them to allow them
16	to come in, coming back.
17	UNIDENTIFIED SPEAKER: When they mustered, did
18	you hear by any chance, recall any of the numbers back
19	to the Captain?
20	MR. RILLERA: Yeah, there is one in charge and
21	one is stationed, who is the missing, then the other,
22	but, it is, because there are, there is an crew
23	number, not safety card. That is why it is mixed.
24	UNIDENTIFIED SPEAKER: Okay. Did they say more
25	or less how many persons were missing on that muster?

1	MR. RILLERA: No. Because it is hard to
2	count. They are ashore. And the Captain decided to
3	put in one, inside the We all go there, after that
4	mustering, because they said, he said all the crew must
5	report to Saga theater to
6	UNIDENTIFIED SPEAKER: Excuse me, report to
7	where?
8	MR. RILLERA: Saga theater.
9	UNIDENTIFIED SPEAKER: Okay. Yes.
10	What is your muster station?
11	MR. RILLERA: Muster station
12	UNIDENTIFIED SPEAKER: Do you have a muster
13	station?
14	MR. RILLERA: Yes. Five, station, it was
15	number five.
16	UNIDENTIFIED SPEAKER: After everyone
17	mustered, what, was there another announcement made
18	that told everyone else to go back, go somewhere else
19	or what happened?
20	MR. RILLERA: No, because, because they did
21	not say anything because it is difficult to count on
22	that time. The crew is, and he make announcement
23	again, don't leave your post, the Captain said.
24	UNIDENTIFIED SPEAKER: Did he say this on the
25	radio or on the PA?

1	MR. RILLERA: Yeah, the PA.
2	UNIDENTIFIED SPEAKER: The PA.
3	Afterwards, after the muster station, where
4	did you go next?
5	MR. RILLERA: Yeah, because it is difficult on
6	the, because our station is Olympia, we are taking all
7	the crew there. Then he said that, they decided to
8	assemble in one place, that is where we go to Saga
9	theater.
10	UNIDENTIFIED SPEAKER: So, after the Saga,
11	after you went to the Saga Theater, where did you go
12	after everything was controlled or what happened?
13	MR. RILLERA: Yes, after they dismissed our
14	crew.
15	UNIDENTIFIED SPEAKER: They dismissed the
16	crew.
17	MR. RILLERA: Yeah.
18	UNIDENTIFIED SPEAKER: Who dismissed the crew?
19	The Captain or
20	MR. RILLERA: Yes.
21	UNIDENTIFIED SPEAKER: Did he do this on the
22	PA, on the PA system?
23	MR. RILLERA: Yes, he said under control, the
24	fire is under control.
25	UNIDENTIFIED SPEAKER: And after he dismissed,

1	where did you go?
2	MR. RILLERA: Me?
3	UNIDENTIFIED SPEAKER: Yes.
4	MR. RILLERA: I stayed on the bridge, I wait
5	for my relief.
6	UNIDENTIFIED SPEAKER: That is all the
7	questions I have. Thank you very much.
8	UNIDENTIFIED SPEAKER: Good morning. Your
9	last name is Rillera, R-I-L-E-R-A?
10	MR. RILLERA: Yes.
11	UNIDENTIFIED SPEAKER: What is your license,
12	what sort of licenses do you have?
13	MR. RILLERA: As second officer.
14	UNIDENTIFIED SPEAKER: You have second office
15	license.
16	MR. RILLERA: Yes.
17	UNIDENTIFIED SPEAKER: Do you have an DMBS
18	license?
19	MR. RILLERA: Yes.
20	UNIDENTIFIED SPEAKER: And you said you went
21	through school in 1994. You took your exam in 19
22	MR. RILLERA: Yes.
23	UNIDENTIFIED SPEAKER: Before that, how many
24	years altogether have you been at sea?
25	MR. RILLERA: I started sailing since 1982.

1	UNIDENTIFIED SPEAKER: 1982.
2	MR. RILLERA: Yes. But, of course, I had
3	UNIDENTIFIED SPEAKER: Of course.
4	MR. RILLERA: Yeah, maybe 15 years.
5	UNIDENTIFIED SPEAKER: Okay. When you heard
6	the explosion, how long from the explosion until the
7	Captain came to the bridge, approximately?
8	MR. RILLERA: Less than 30 seconds.
9	UNIDENTIFIED SPEAKER: Less than 30 seconds.
10	In that time, how many was on the bridge at
11	that time?
12	MR. RILLERA: I am alone, but I am not sure if
13	the first officer is, maybe he is working on computer.
14	UNIDENTIFIED SPEAKER: But, you are not sure,
15	perhaps the first officer was there.
16	MR. RILLERA: Yes.
17	UNIDENTIFIED SPEAKER: Which will be the
18	pilot.
19	MR. RILLERA: Yes.
20	UNIDENTIFIED SPEAKER: And you are the co
21	pilot.
22	MR. RILLERA: Yes.
23	UNIDENTIFIED SPEAKER: So, you two guys are
24	two on duty.

MR. RILLERA: Yes.

1	UNIDENTIFIED SPEAKER: And then the Captain
2	comes in.
3	MR. RILLERA: Yes.
4	UNIDENTIFIED SPEAKER: When did the staff
5	captain come in?
6	MR. RILLERA: Less than one minute.
7	UNIDENTIFIED SPEAKER: Less than one minute.
8	MR. RILLERA: Yes. Everybody came because it
9	is a big, big
10	UNIDENTIFIED SPEAKER: Yeah.
11	MR. RILLERA: Big alarm.
12	UNIDENTIFIED SPEAKER: Yes. I understand
13	that.
14	And you are mainly, what you did then was to
15	execute order that the Captain gave you.
16	MR. RILLERA: Yes.
17	UNIDENTIFIED SPEAKER: Like answer the
18	telephone, if the telephone was ringing.
19	MR. RILLERA: Yes.
20	UNIDENTIFIED SPEAKER: You did not announce
21	yourself at any time, anything on the PA system?
22	MR. RILLERA: No.
23	UNIDENTIFIED SPEAKER: Okay. That is all I
24	have. Thank you.

MR. JONES: I am all done.

1	MR. WALSH: Jim Walsh, NTSB. Enrico, from the
2	time from the explosion to the Captain was 30 seconds
3	on the bridge.
4	MR. RILLERA: Yes, yes.
5	MR. WALSH: And 60 seconds from the explosion
6	is when the first officer approximately.
7	MR. RILLERA: Staff captain.
8	MR. WALSH: Staff captain.
9	MR. RILLERA: Yes.
10	MR. WALSH: So 60 seconds.
11	MR. RILLERA: Yes.
12	MR. WALSH: The first announcement for Alpha
13	and Bravo were they doing this time that you heard on
14	your radio?
15	MR. RILLERA: Yeah. After they came.
16	MR. WALSH: After they came.
17	MR. RILLERA: Yes.
18	MR. WALSH: Then you heard the, on the radio,
19	when was the first time you heard Alpha, Code Alpha
20	called?
21	MR. RILLERA: Because thinking, I think
22	after one minute, we announced Code Alpha, first
23	because we heard there were some injuries.
24	MR. WALSH: And you heard that how?
25	MR. RILLERA: Yeah, in, in walkie talkie.

1	MR. WALSH: So, you heard it walkie talkie.
2	MR. RILLERA: Yes.
3	MR. WALSH: Did you hear it by telephone at
4	all?
5	MR. RILLERA: No, only on walkie talkie,
6	because I cannot leave my post.
7	MR. WALSH: Okay. So you heard it over the
8	radio.
9	MR. RILLERA: Yes, the radio. And they make
10	announcement in PA system, through PA system.
11	MR. WALSH: And that was the Captain that made
12	the announcement on the Code Alpha and Code Bravo?
13	MR. RILLERA: I think the staff, the first
14	officer.
15	MR. WALSH: The first officer. From the bang.
16	MR. RILLERA: Yeah, I think one or two
17	minutes.
18	MR. WALSH: Okay. I was a little confused in
19	listening when I was taking some notes. When the
20	Alpha, how many Alphas do you recall being sent out
21	through the ship, through the public address system?
22	MR. RILLERA: How many calls they made? I
23	heard Code Alpha and then heard man overboard.
