Investigation Report

N31743 (DOA-5/24/2013@ 1710 local time)

On Sunday, May 26, 2013, this inspector interviewed Joan Dudley concerning the above referenced accident. According to Mrs. Dudley, she was outside her place of business at "Granny's Ice Cream Parlor" located at 2948 State Highway 29, Johnstown, NY 12095 which is actually positioned in the town of Ephratah, when at approximately 5:15pm she observed a twin engine airplane at a low altitude heading in a southwesterly direction toward the Garoga Reservoir. She indicated that the plane was missing the left wing and was banked with the missing wing toward the ground. She stated that she was able to identify the missing wing because the aircraft was at a steep bank. While observing the aircraft from her driveway, she heard a loud noise that sounded like an explosion that sounded like a "pop, pop" as she watched it disappear behind the tree line at the rear of the neighbor's house across the street owned by Mr. Scott Orr. After observing the aircraft disappear behind the trees, she motioned for one of the workers in the ice cream parlor to call 911 and immediately ran across highway 29 to render aid to any possible victims. She mentioned that she is an EMT and thought she would be able to render assistance. Once across the road, she indicated she paused behind Scott Orr's house and yelled if anybody needed help. She stated that she thought she heard a female's voice, but could not be sure. Within a few minutes, first responders arrived on site and she returned to her business location.

Mrs. Dudley remembers that the aircraft was about 1000 feet above the ground and observed the missing wing on the left side of the airplane because of the unusual attitude of the aircraft. She further stated that she initially thought the aircraft was circling her business-Granny's Ice Cream Parlor.

Ans/ DC: Yes, I was there with Randy Cossellman fishing from a canoe.

Ques/BPN: Did you witness anything while you were on the dam?

Ans/ DC: Yes, the plane blowing up.

Ques/BPN: What do you mean by "blowing up"?

Ans/ DC: It wasn't an actual explosion, there were no flames or smoke. We heard a loud whining noise like an engine at full throttle. I looked up and I could see an airplane. It looked like it was flying level at a constant height. At first we thought it was a radio controlled plane because it looked so small. As we were watching the plane, there was a loud bang and I saw the plane break apart. We were watching the plane and as it got closer, I knew it was a real plane. We reeled in our gear and I started rowing towards where the plane was going to come down. I saw the fuselage coming down but not where it landed. I saw an engine coming down and it hit land. Bolts and other small parts started falling near us so I rowed in the opposite direction to get out of the area so we wouldn't be hit by falling parts. Once the small parts finished hitting the ground, I could still see the fuselage still coming down so I rowed back towards where it was going to hit. We were in the area of the dam and were rowing back towards the point. The fuselage sounded like it hit the water around the point but we didn't see it hit. When we got around the point, we didn't see the plane or any bubbles in the water. There were about four kids on the bank across from the point. I told them to call 911 and then I heard the sirens.

Ques/BPN: Did you see anyone falling from the airplane?

Ans/ DC: No.

Ques/BPN: Did you see anyone in the fuselage as it got closer to you?

Ans/ DC: No, but it looked pretty much intact.

Ques/BPN: Is there anything else you can tell be about the plane crash.
